The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

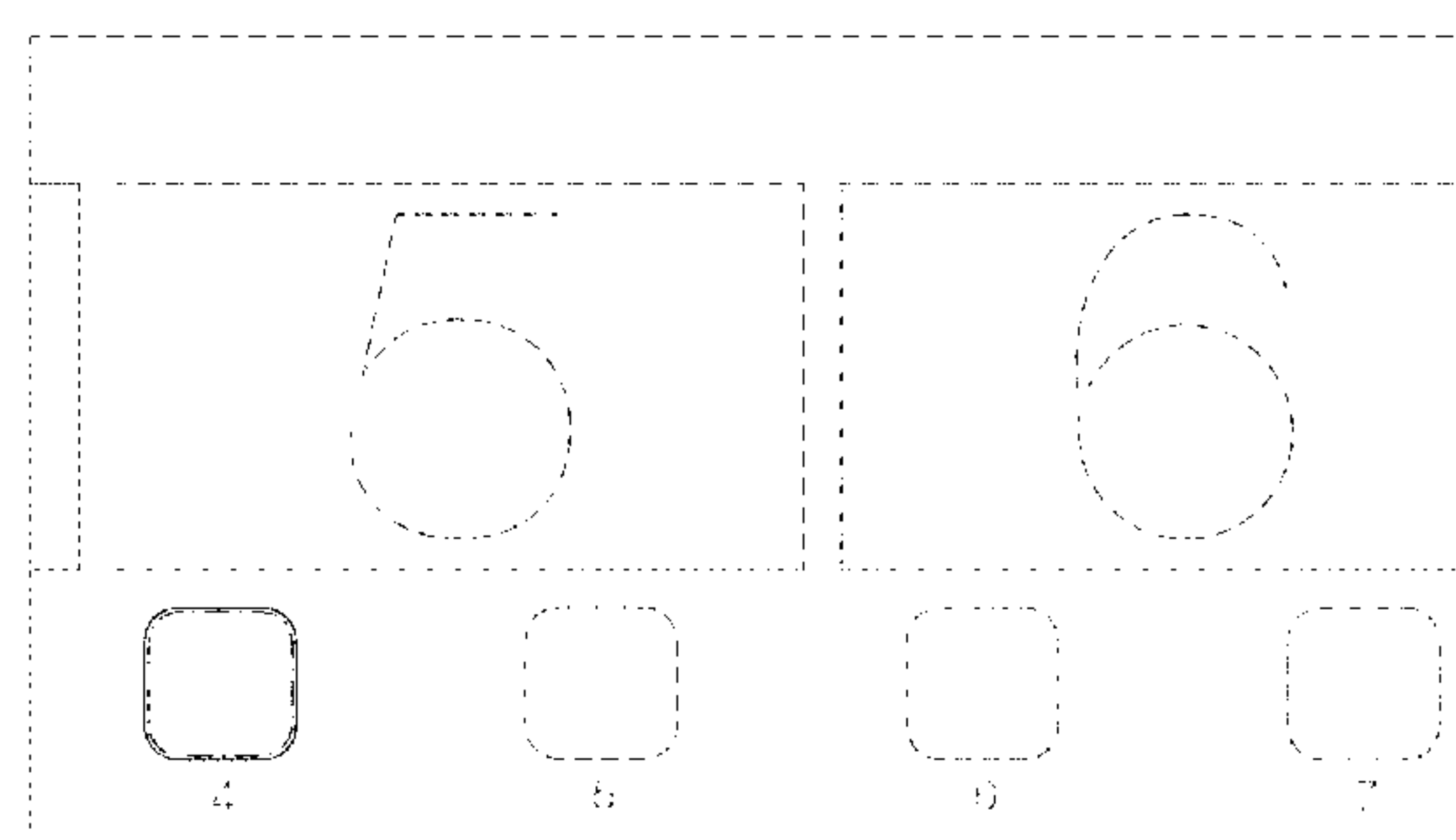
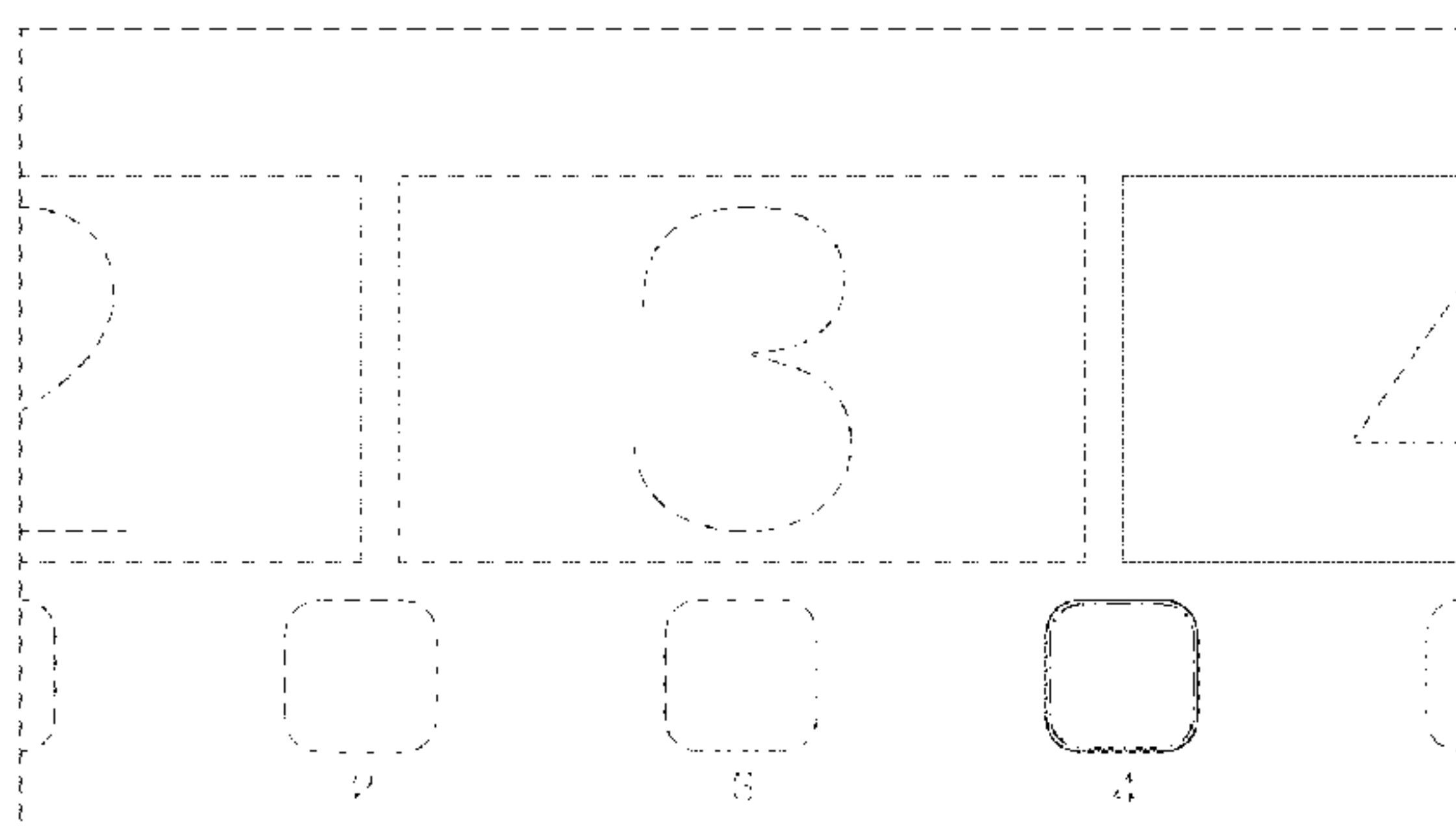
DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image in the sequence showing our new design;
FIG. 2 is a second image thereof;
FIG. 3 is a third image thereof; and,
FIG. 4 is a fourth image thereof.

The outermost broken lines in the figures show a display screen or portion thereof, and form no part of the claimed design. The other broken lines in the figures show portions of the animated graphical user interface that form no part of the claimed design. The dot-dash lines in the figures and the areas within show portions of the animated graphical user interface that form no part of the claimed design.

The appearance of the animated images sequentially transitions between the images shown in FIGS. 1-4. The process or period in which one image transitions to another forms no part of the claimed design.

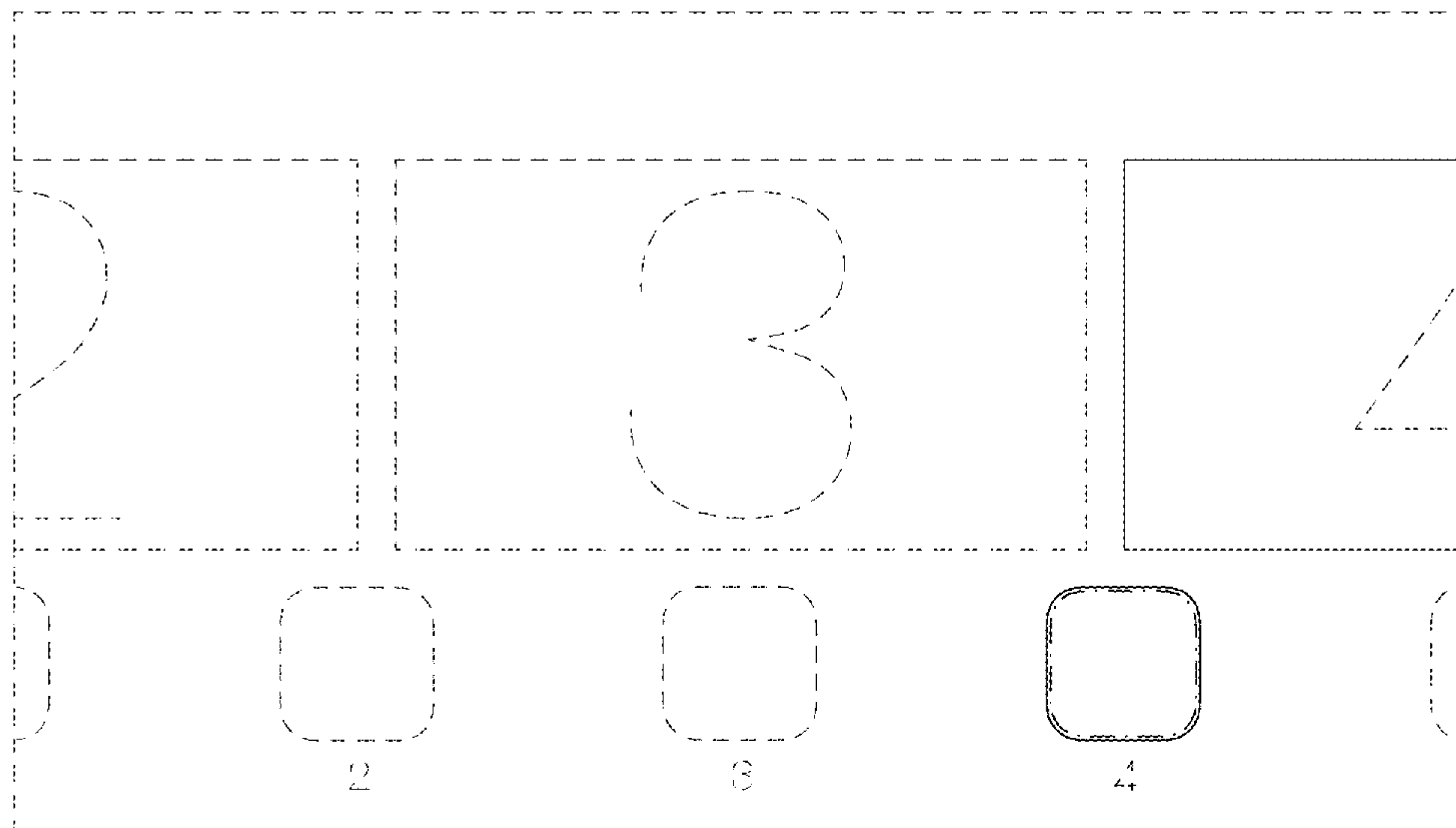

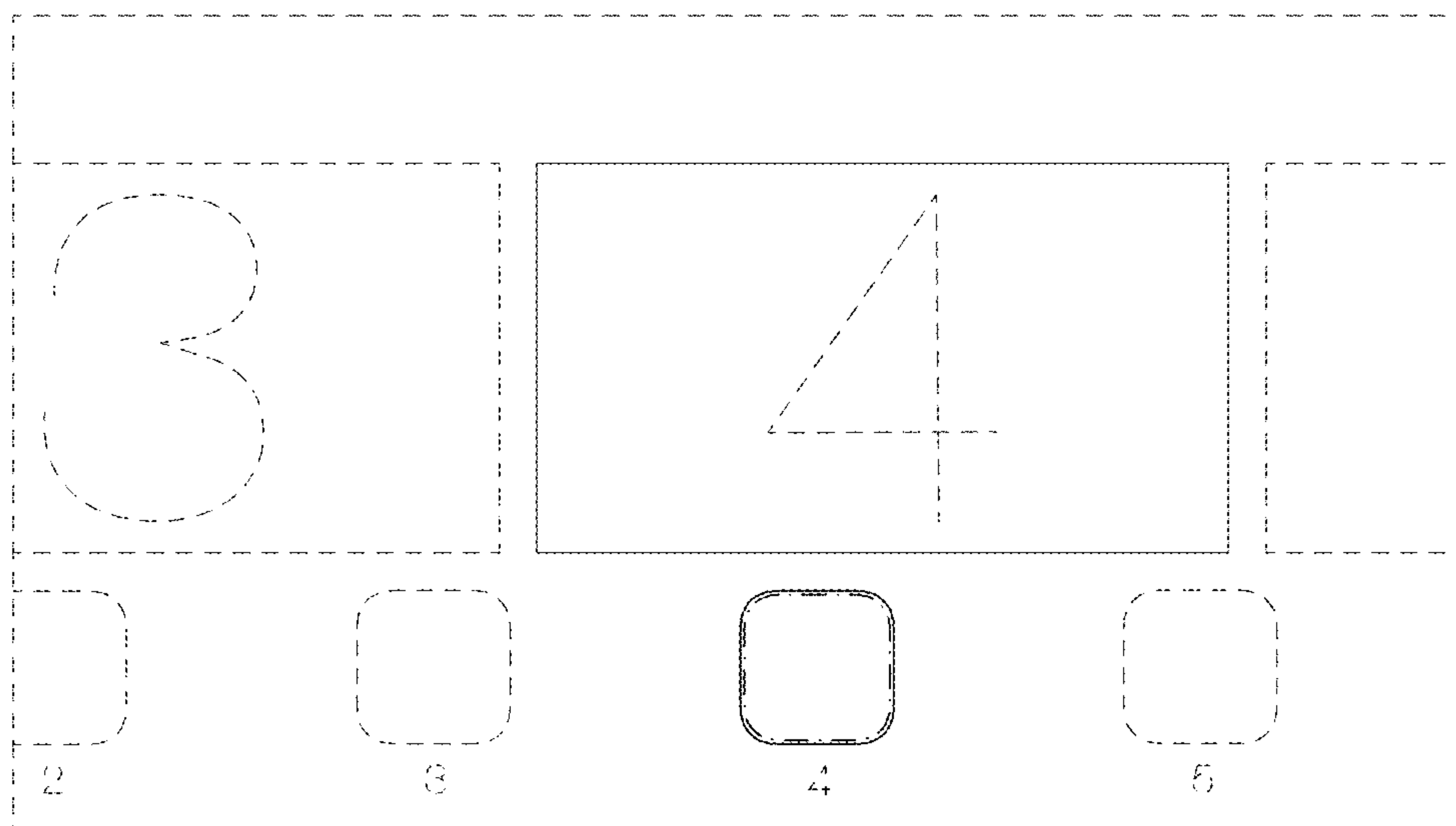

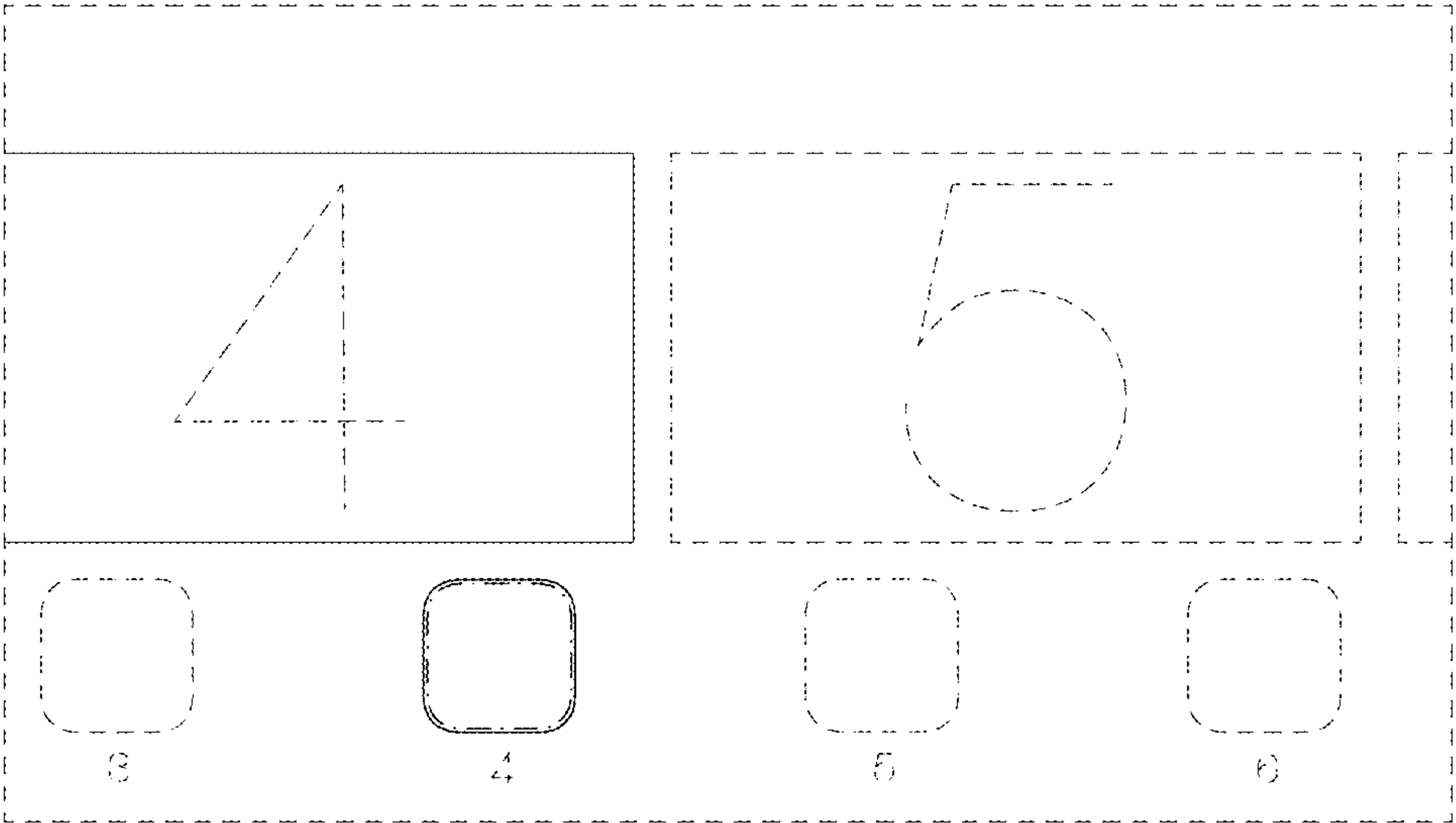

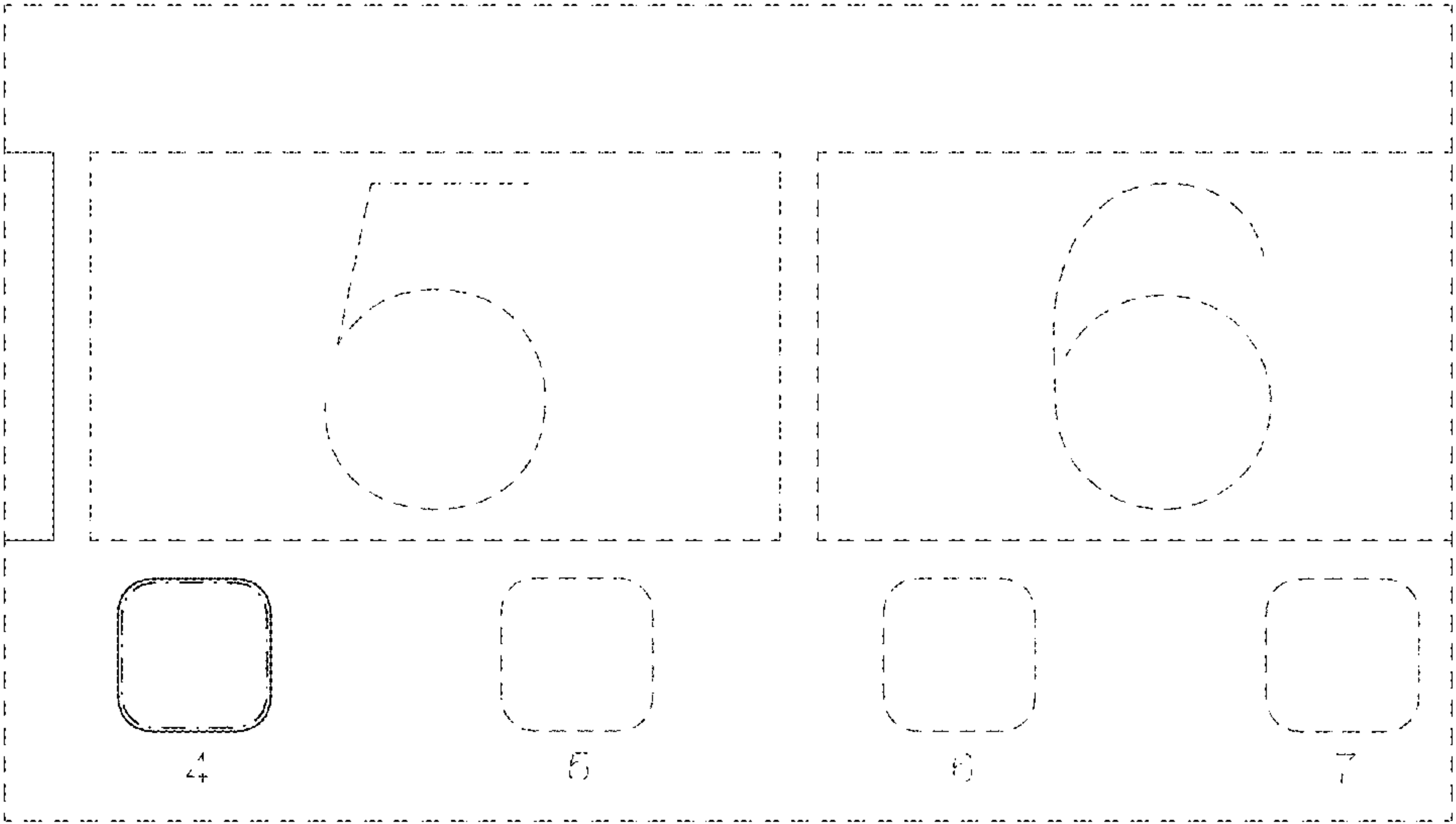
