The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

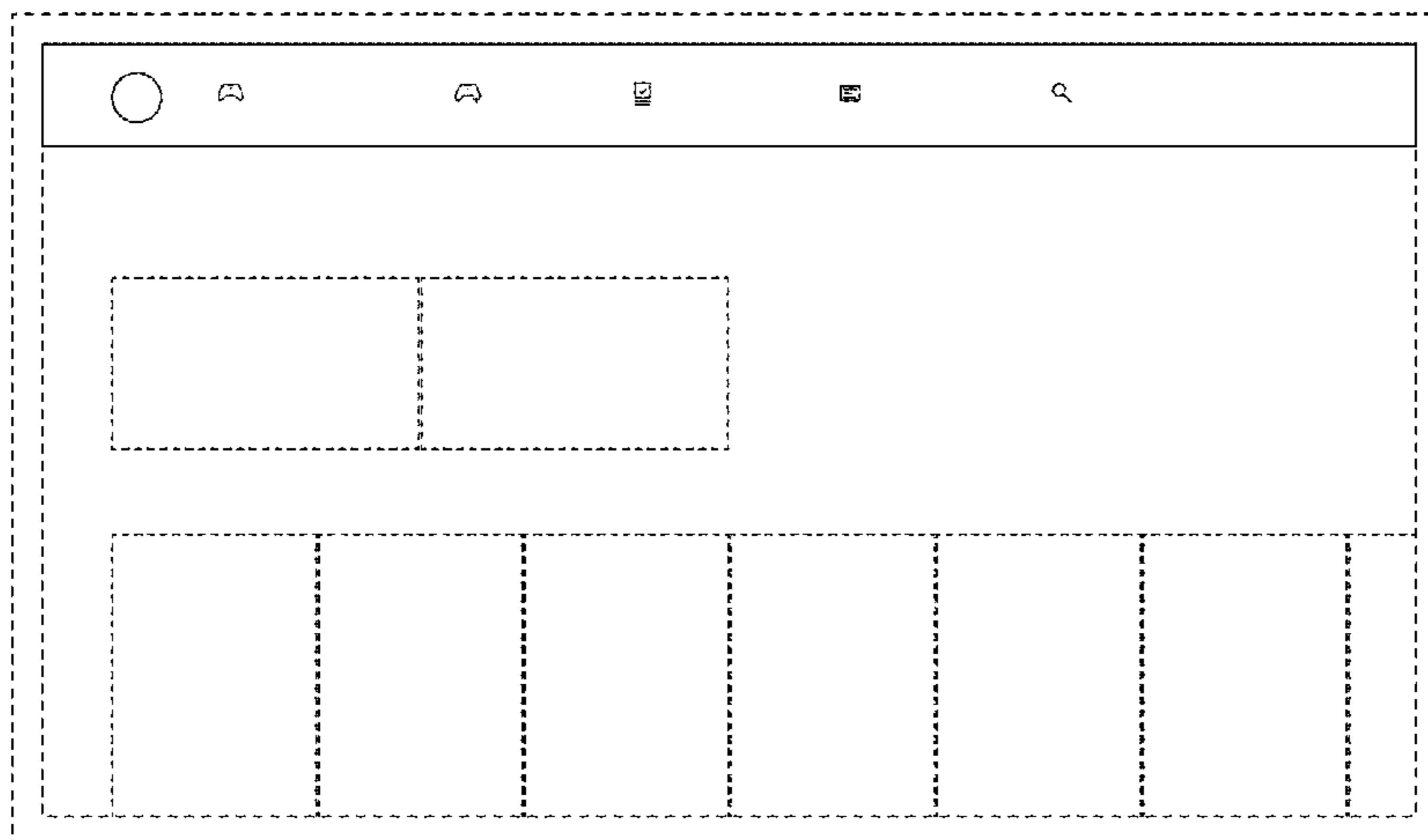
FIG. 1 is a front view of a display screen with graphical user interface showing our new design;

FIG. 2 is an enlarged view of the left half of the solid-line portions shown in FIG. 1; and,

FIG. 3 is an enlarged view of the right half of the solid-line portions shown in FIG. 1.

The broken line showing of the display device illustrates environment. The remaining broken lines illustrate portions of the graphical user interface. The broken lines form no part of the claimed design.

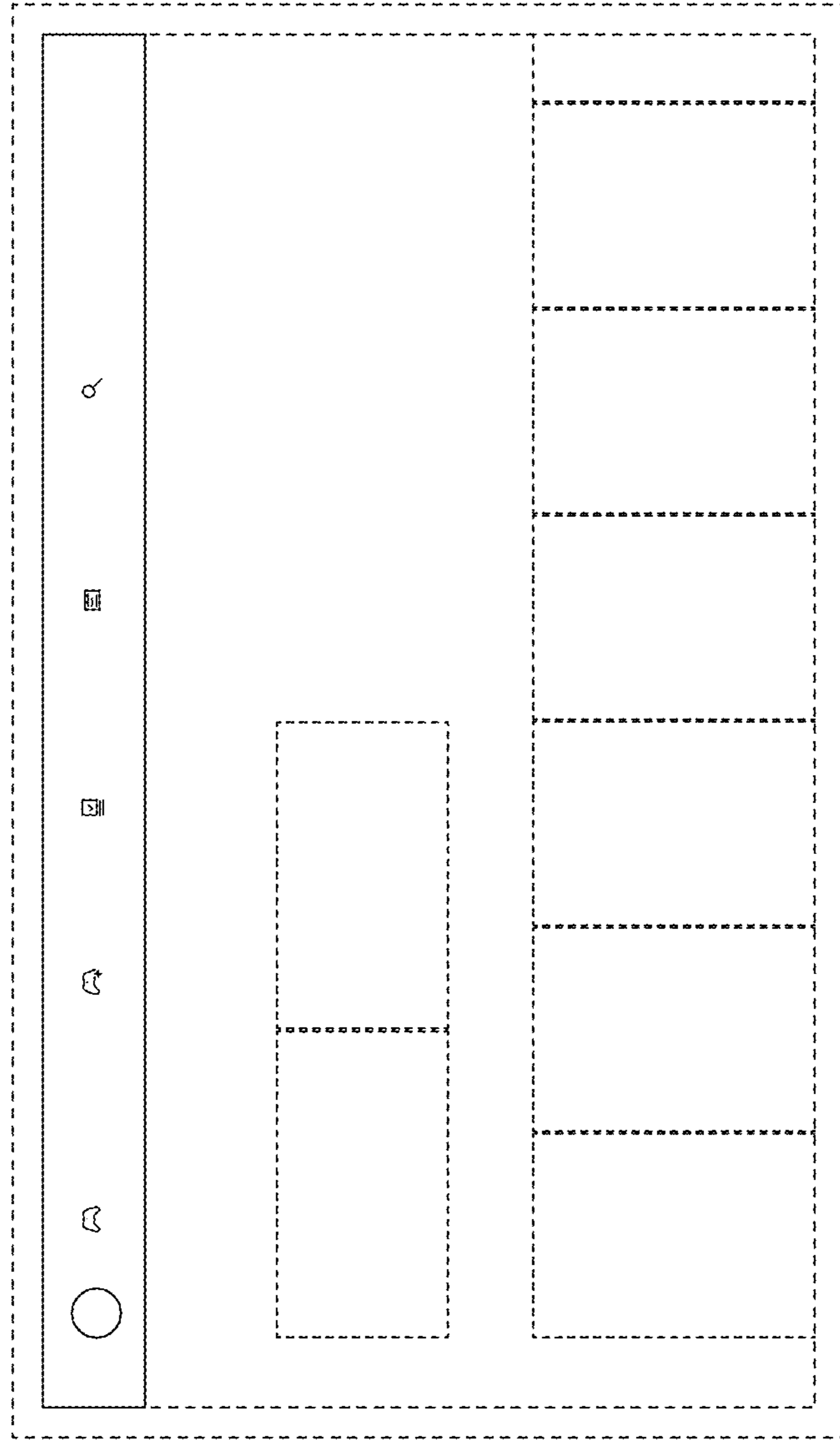

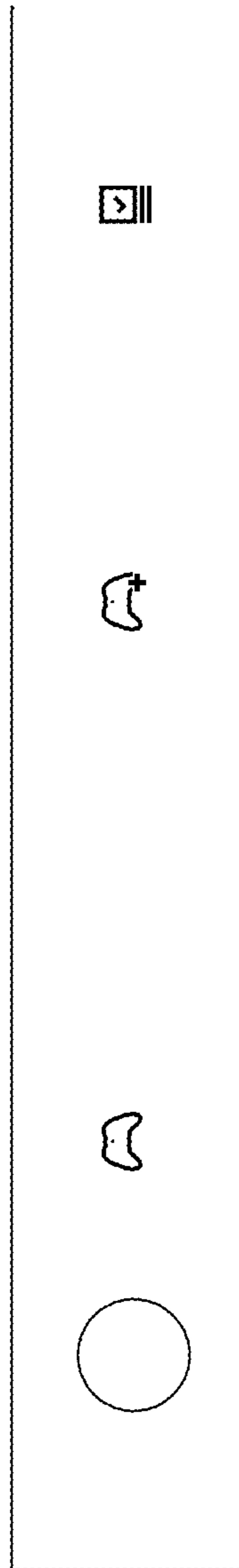

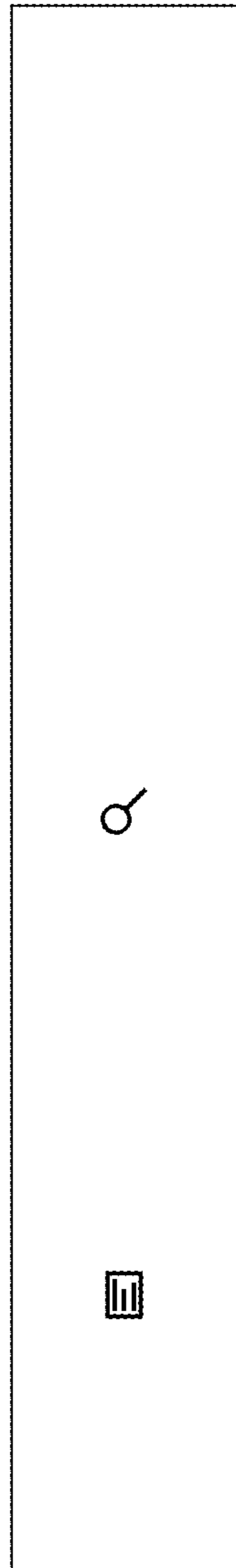
