(57) **CLAIM**

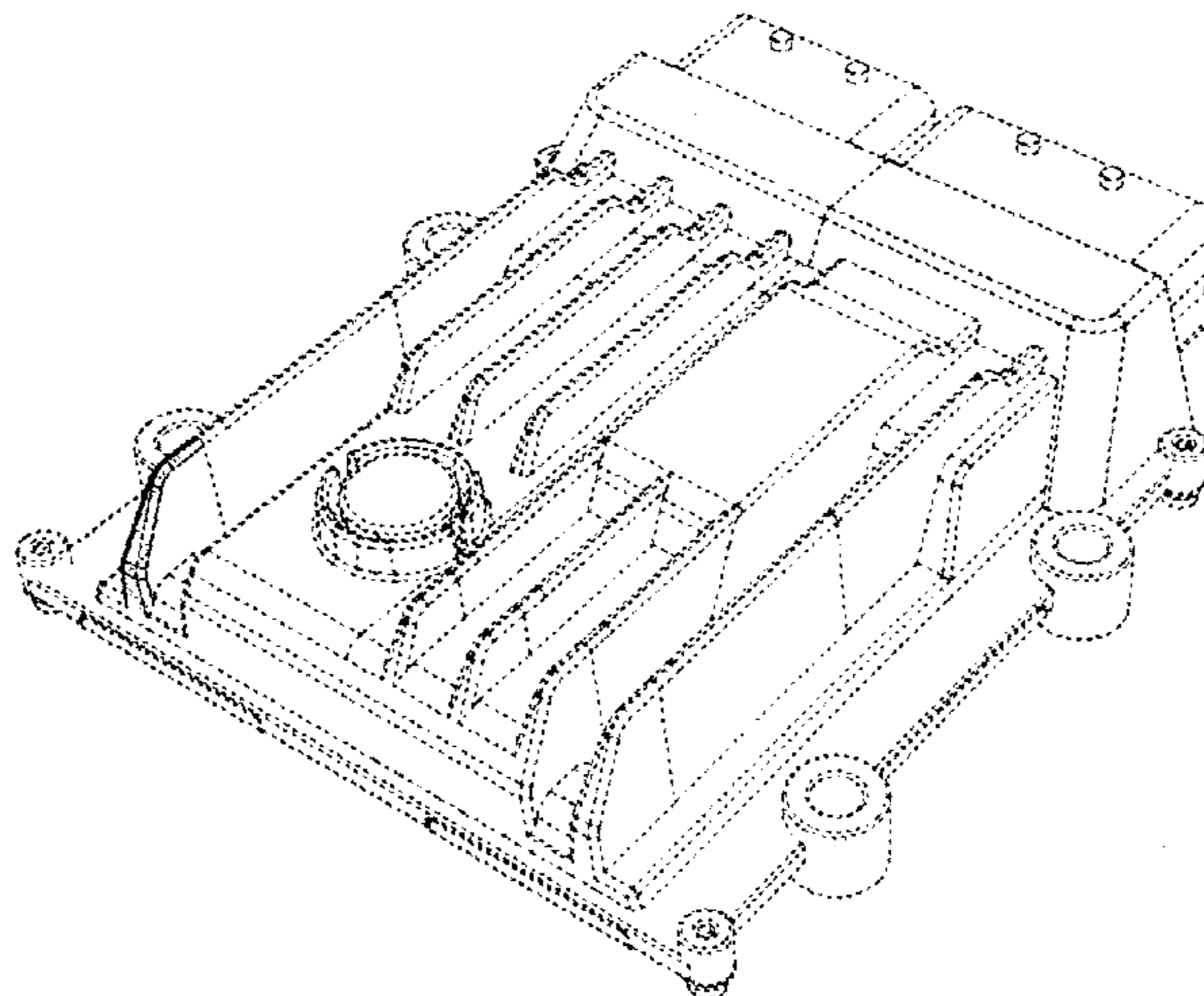
The ornamental design for an automotive engine computer unit cover, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an automotive engine computer unit cover, showing our new design;

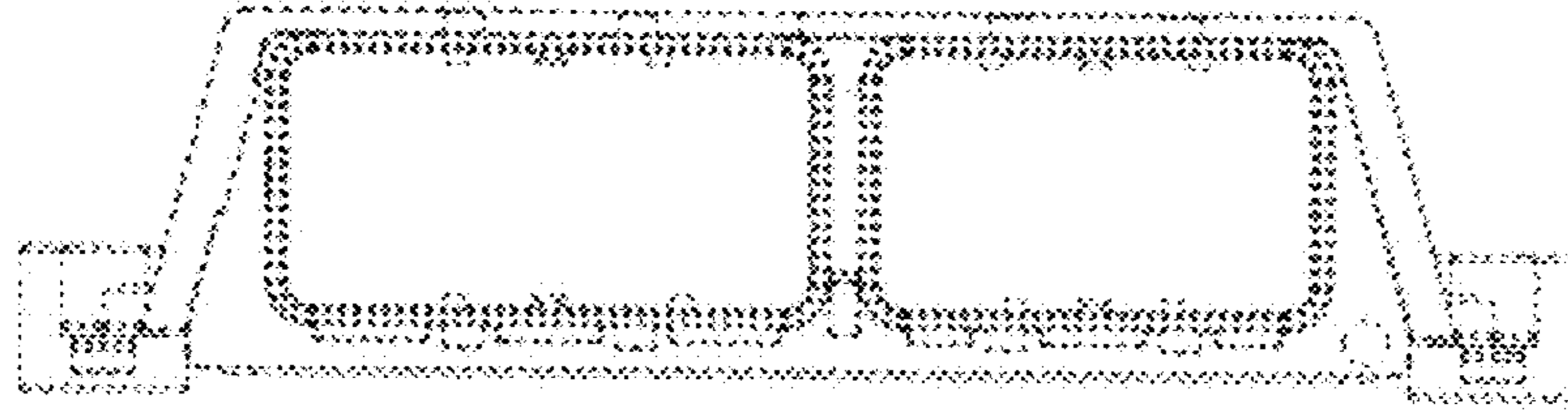

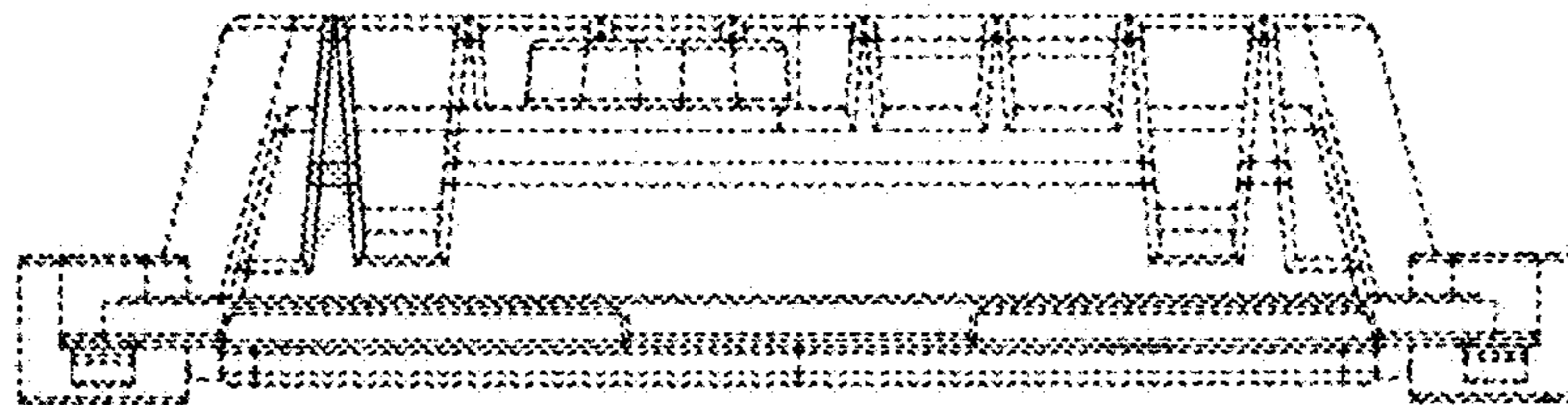

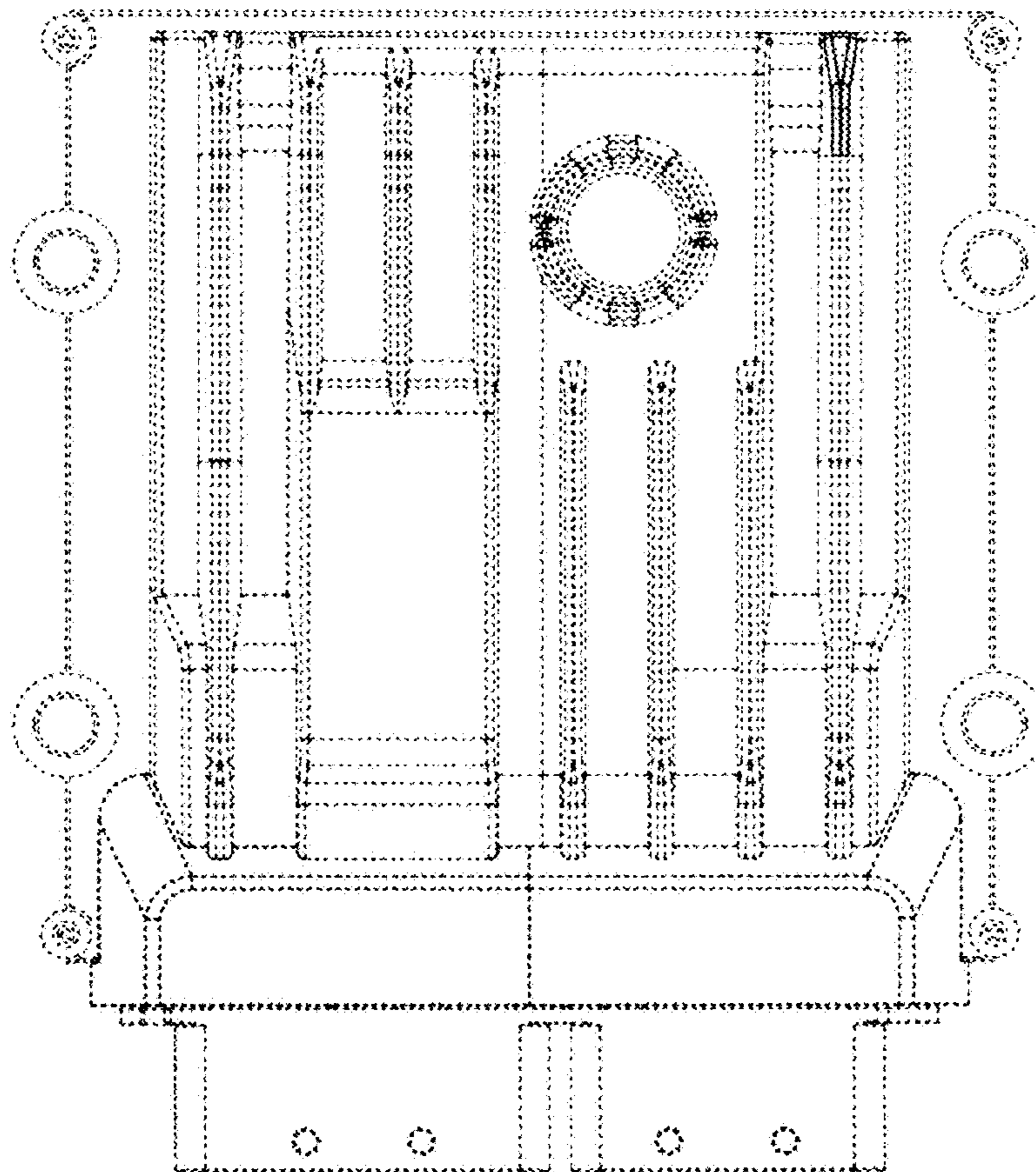

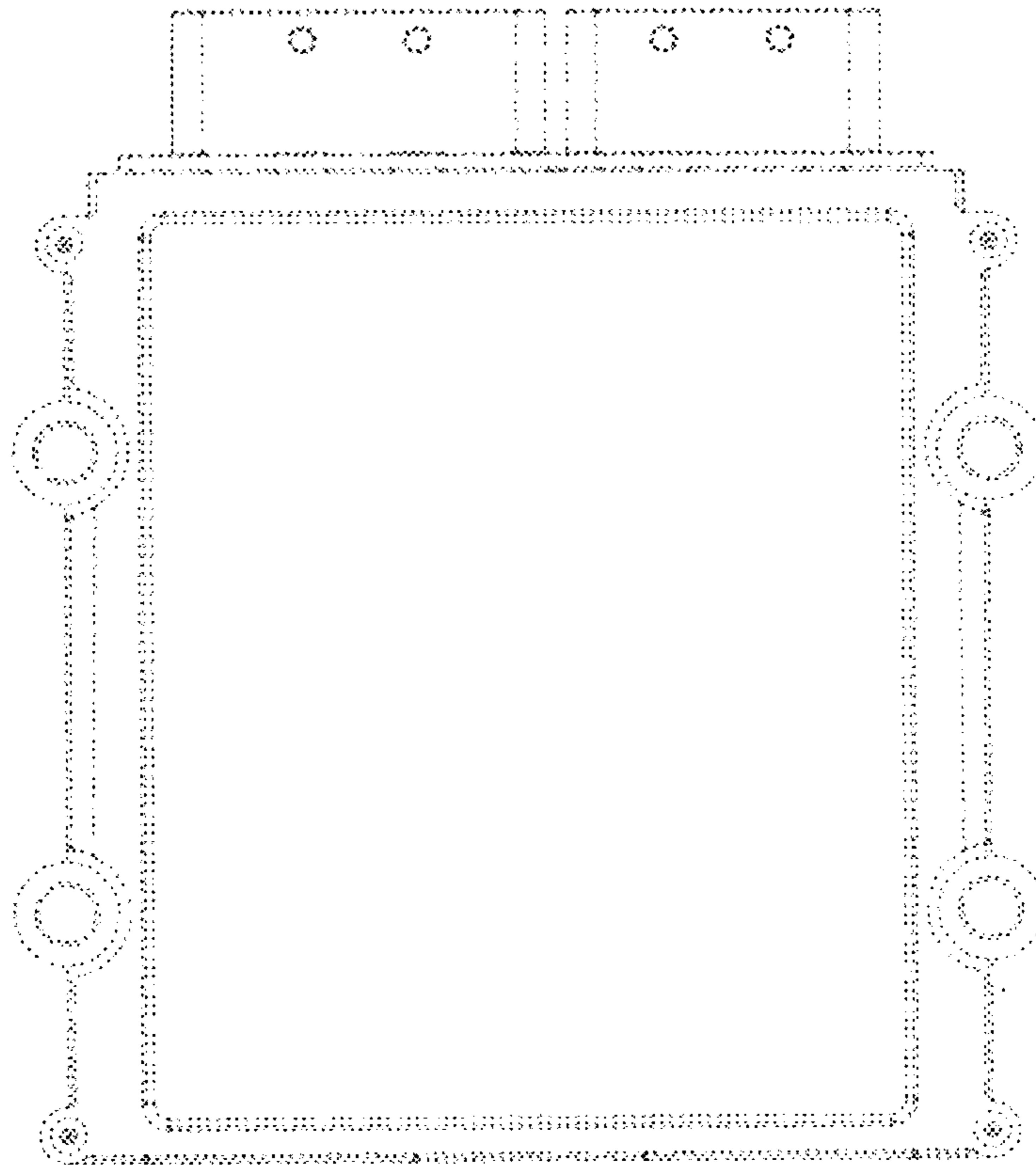

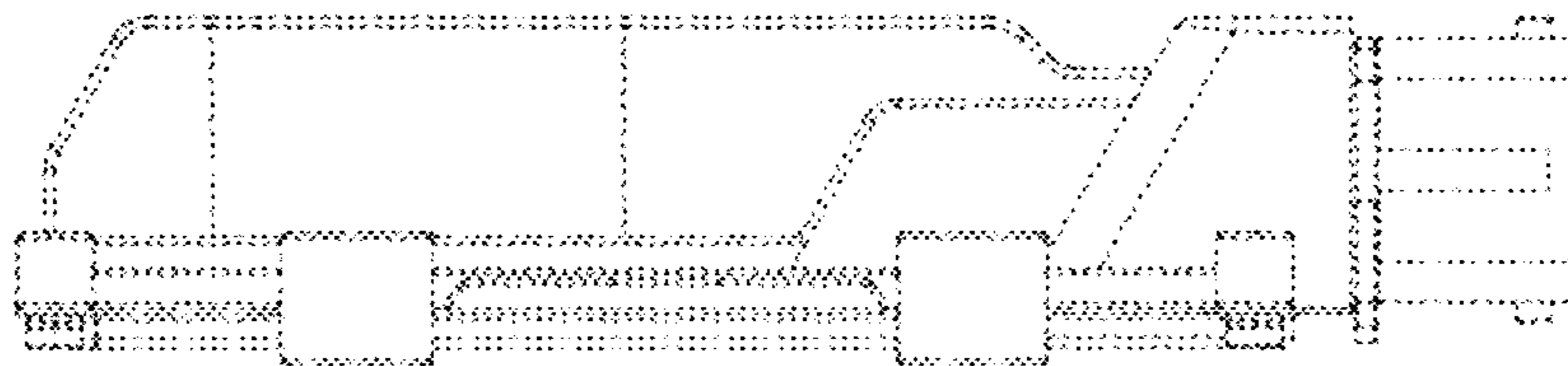

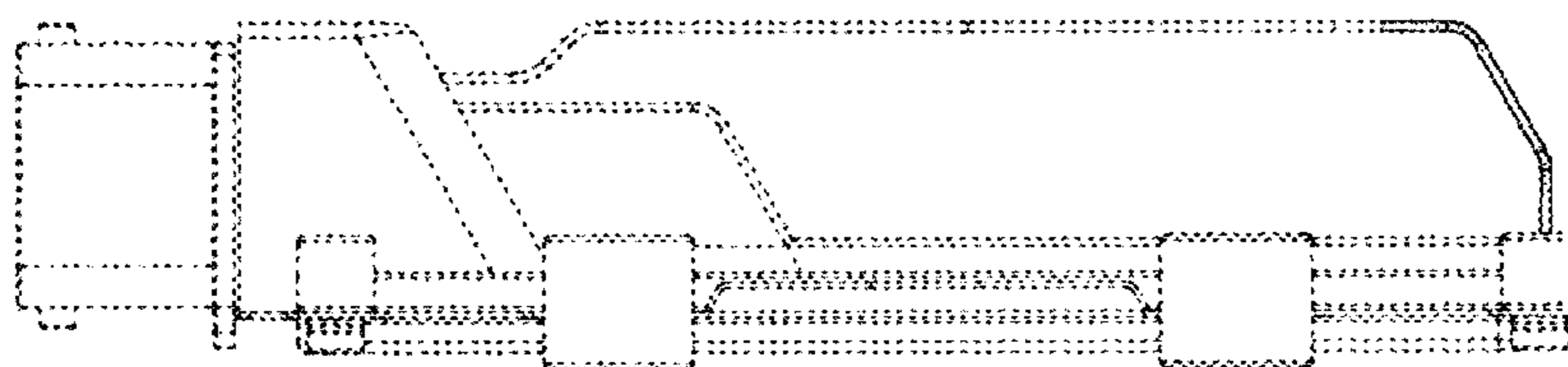
