DESCRIPTION

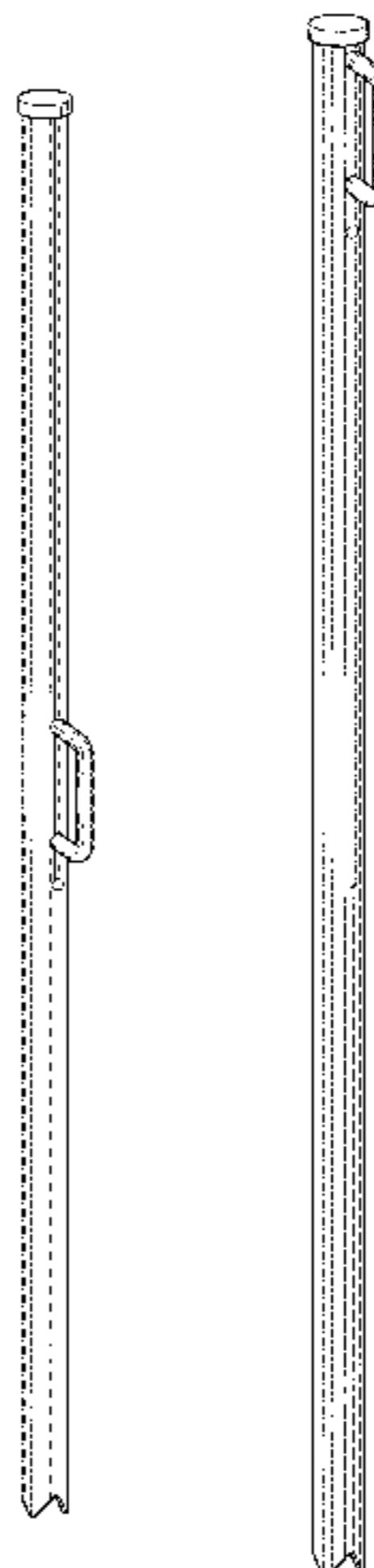

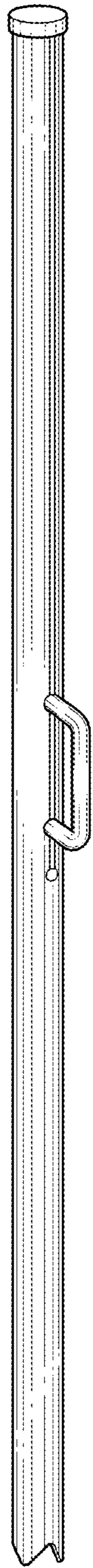

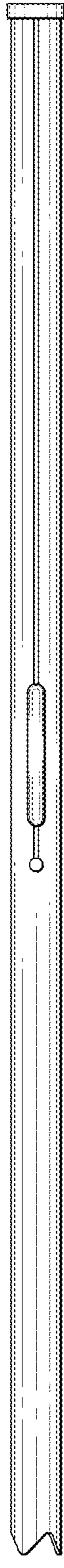

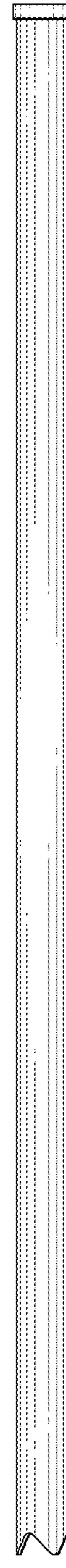

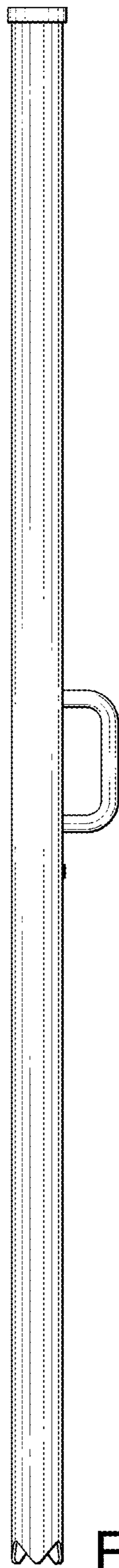

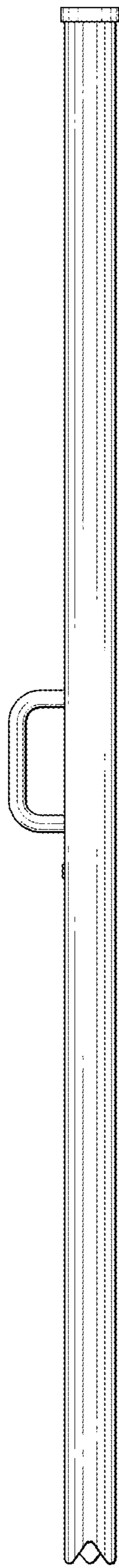

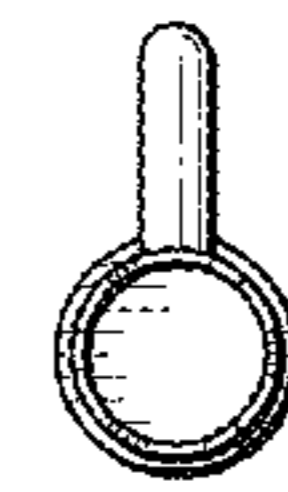

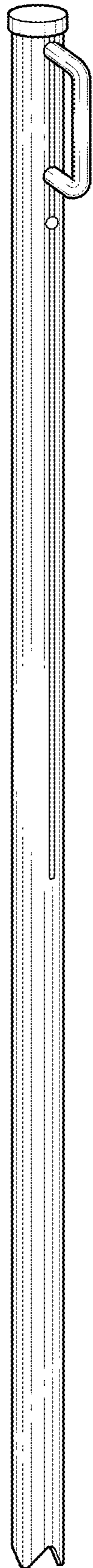

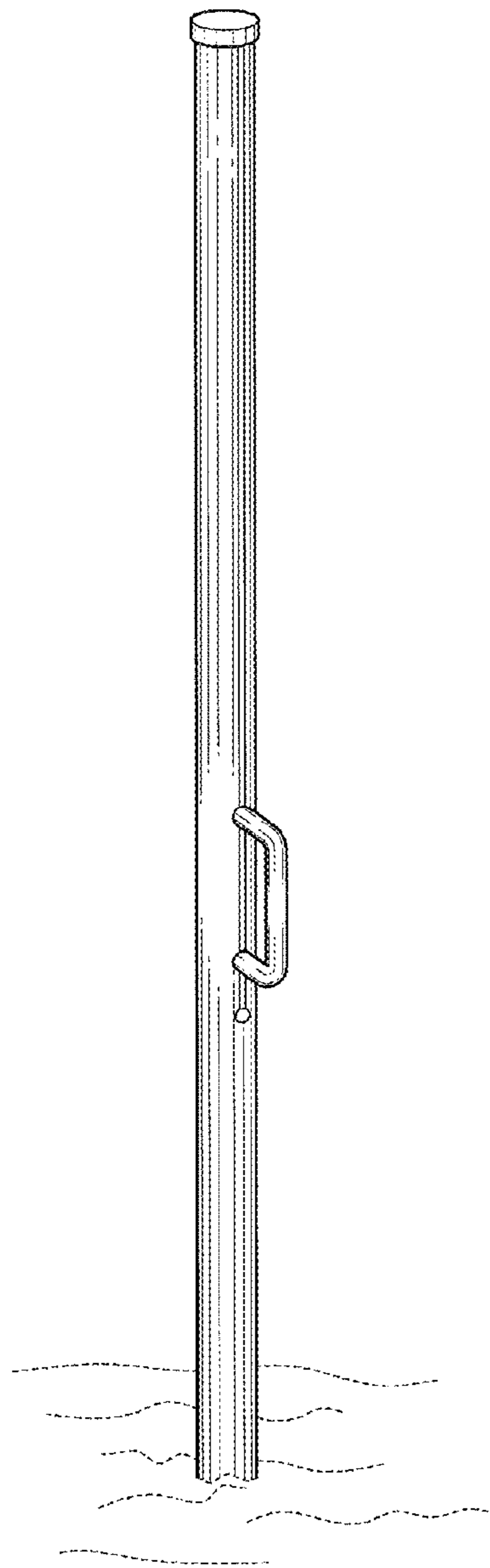

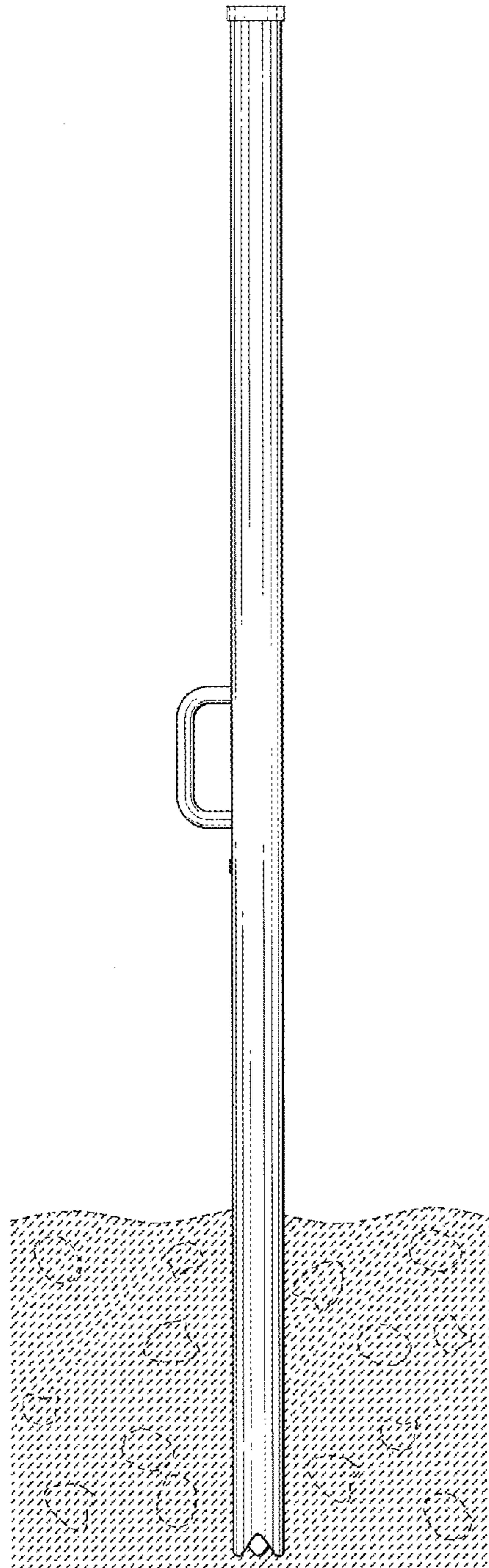
