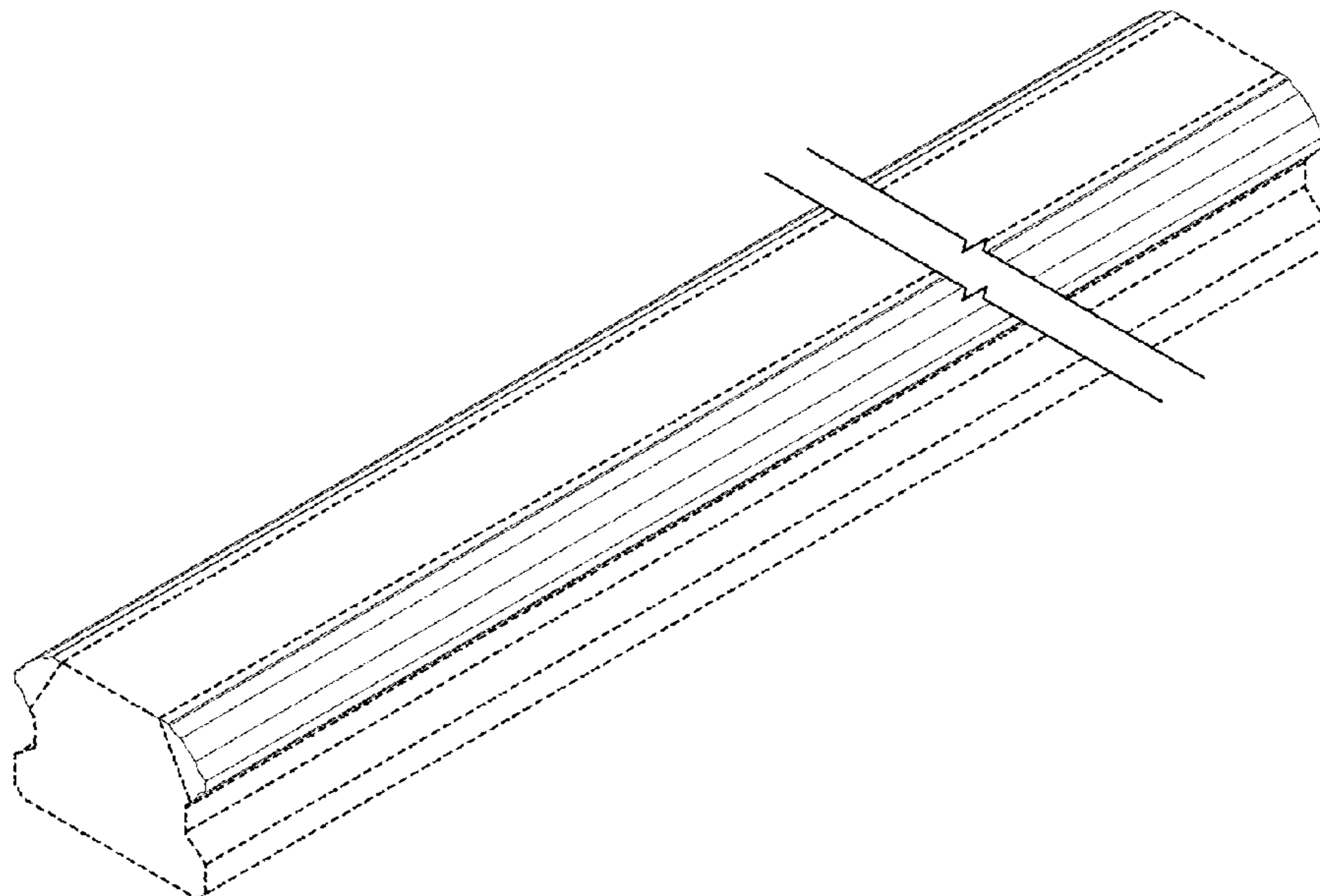
(57) **CLAIM**

The ornamental design for a track rail for linear motion guide device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a track rail for linear motion guide device showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;

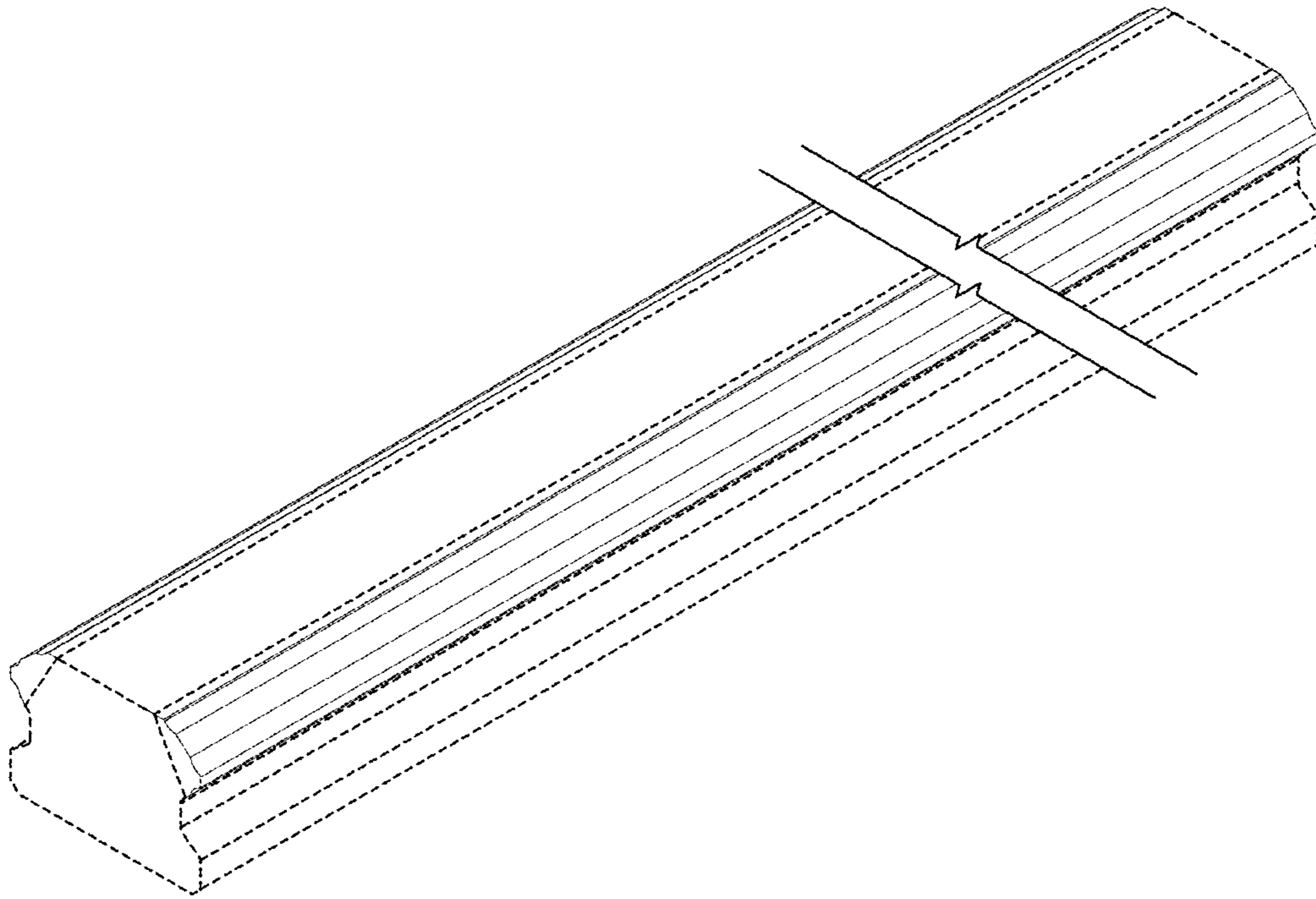

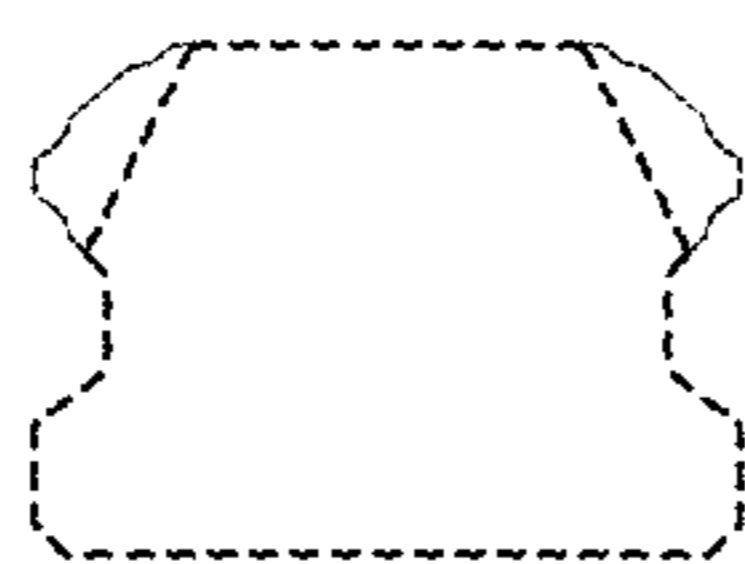

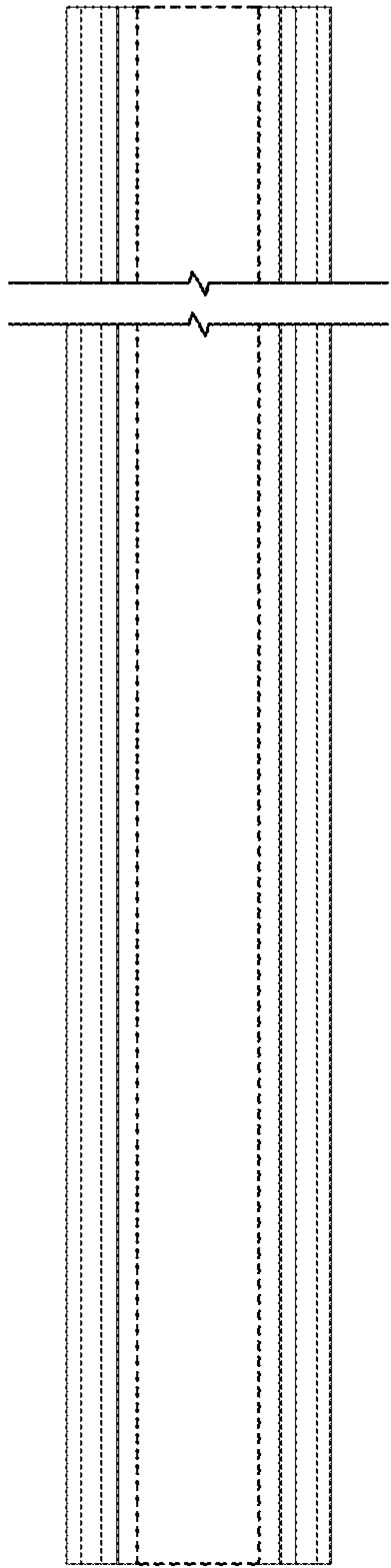

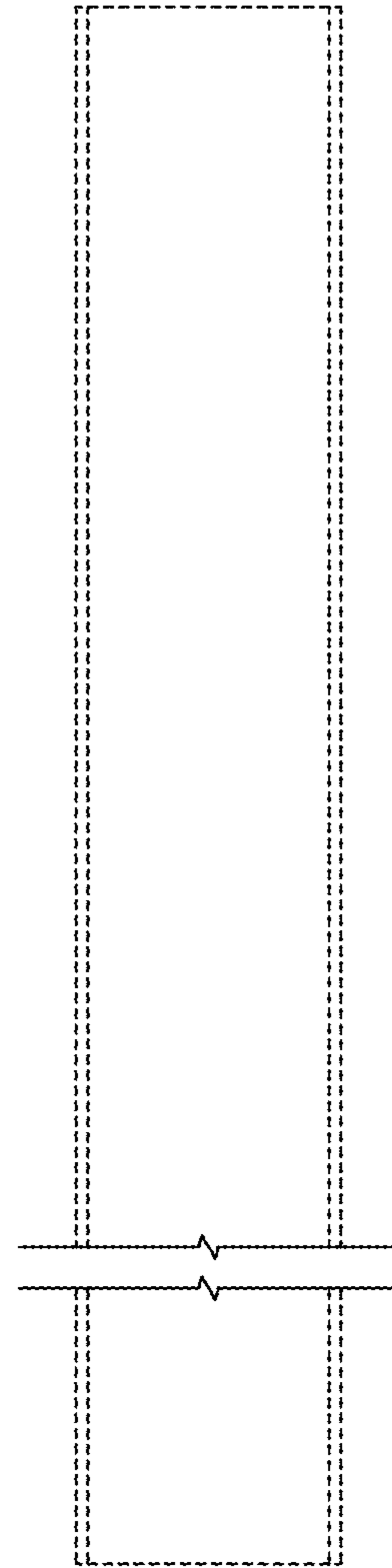

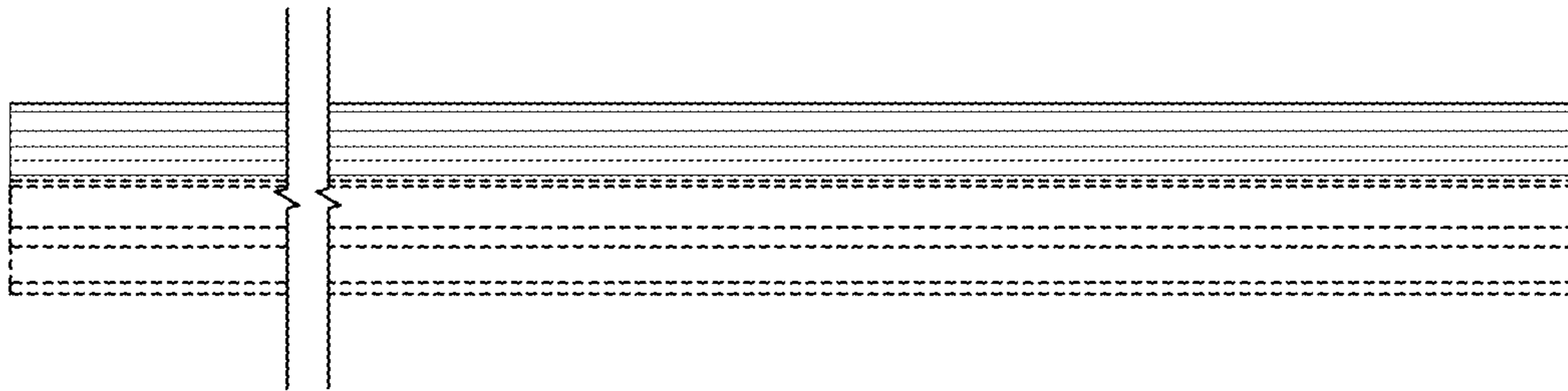

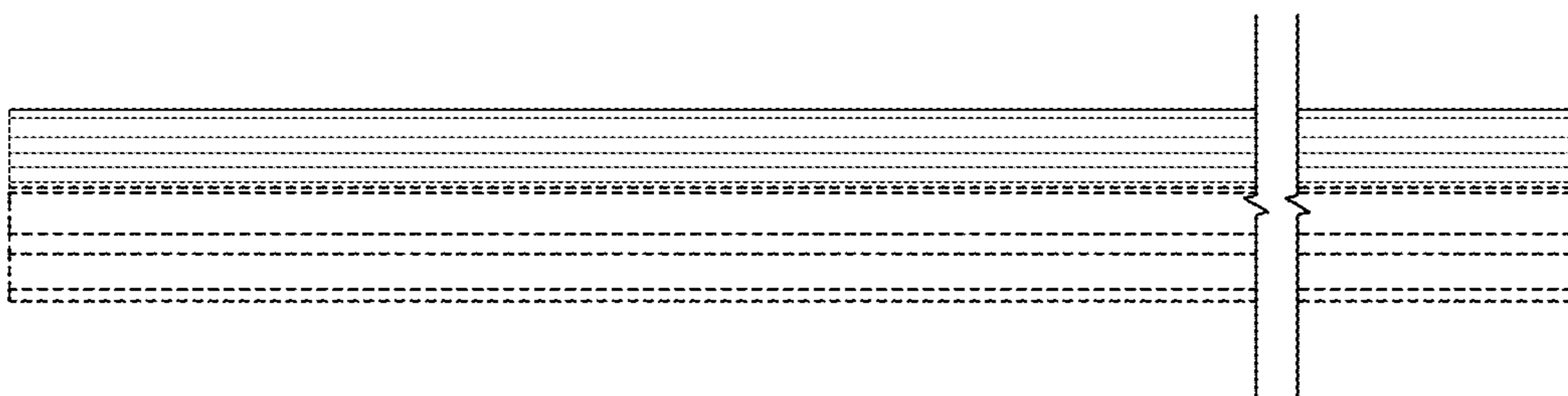
