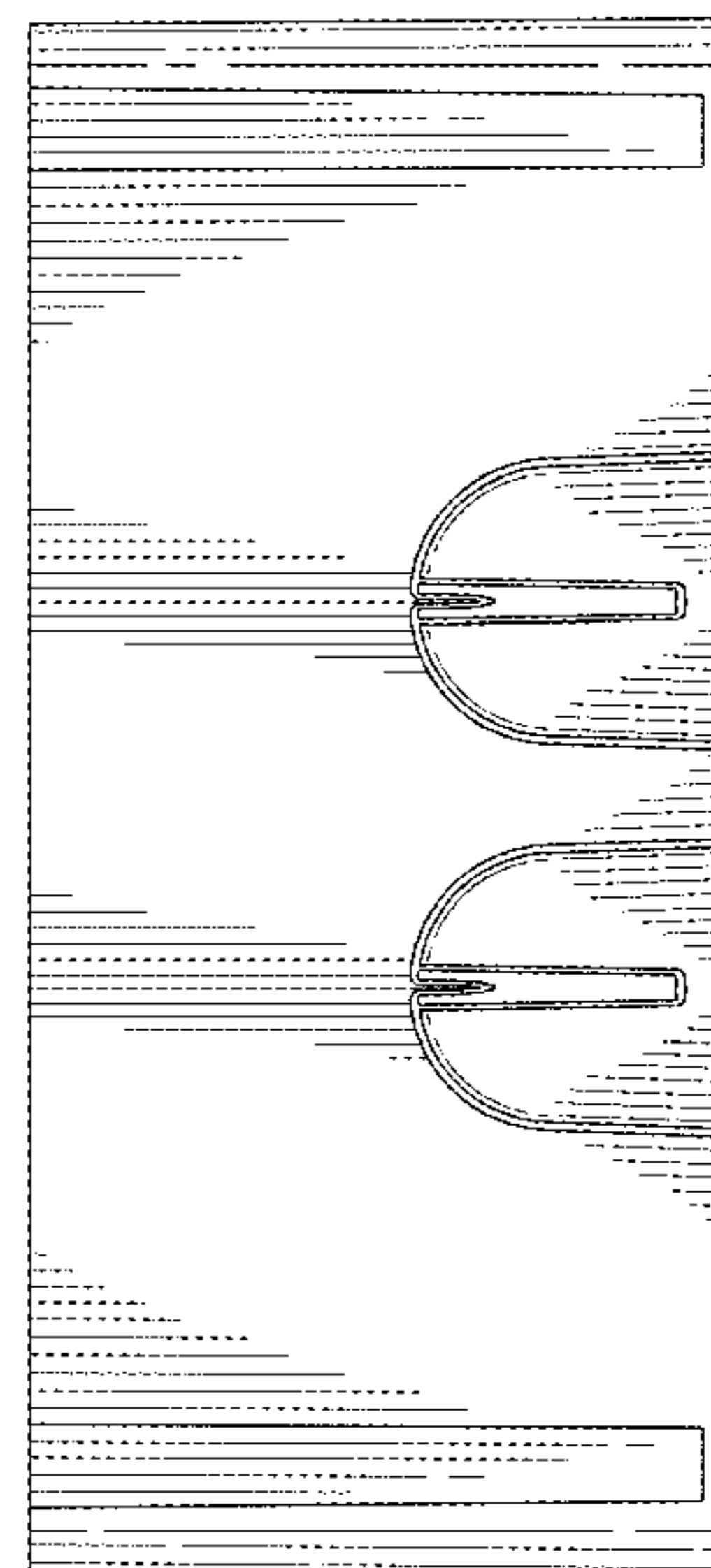
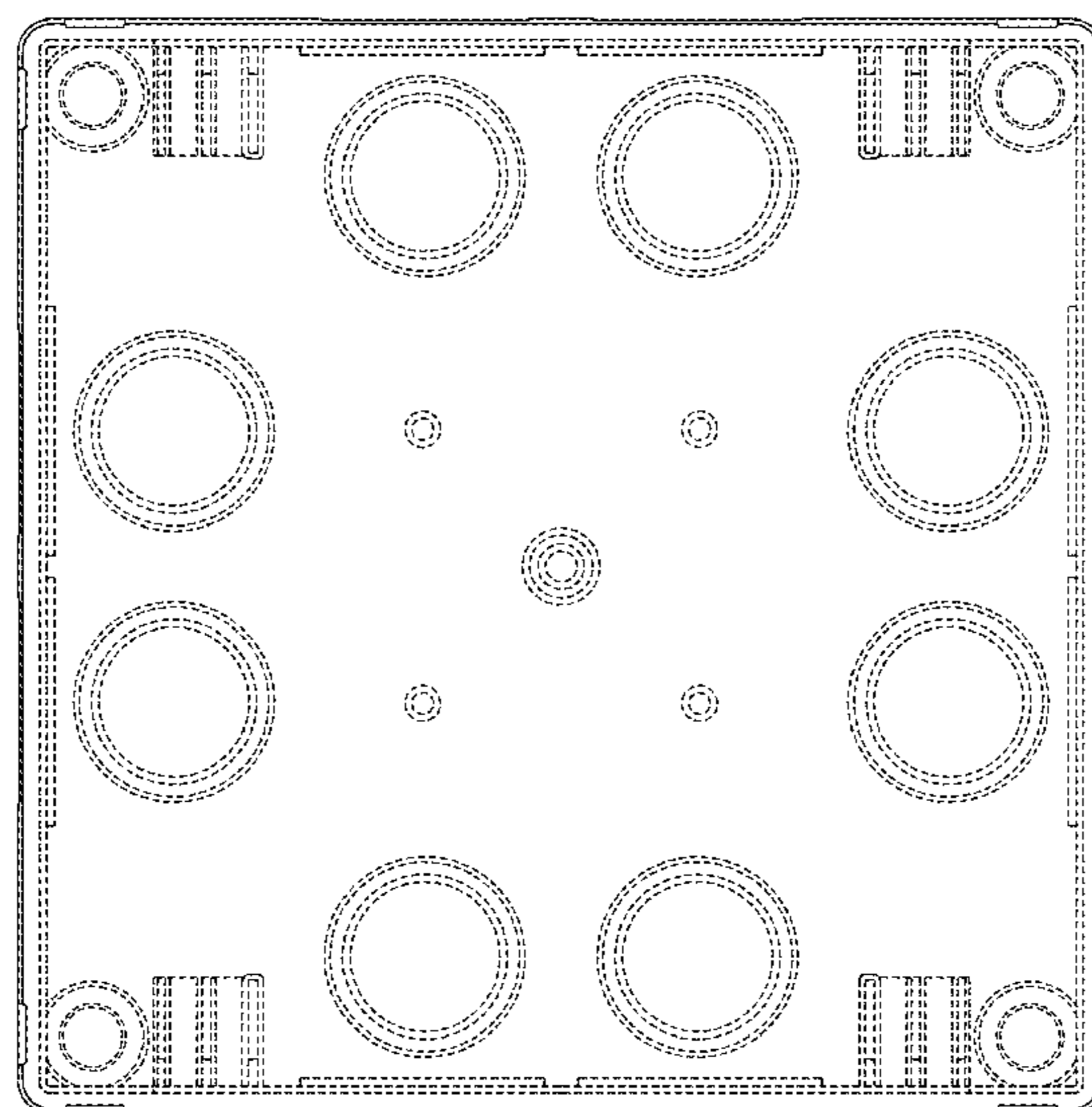
(57) **CLAIM**

The ornamental design for a camera housing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a camera housing; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a rear elevational view thereof. The broken lines depict portions of a camera housing in which the design is embodied and form no part of the claimed design.

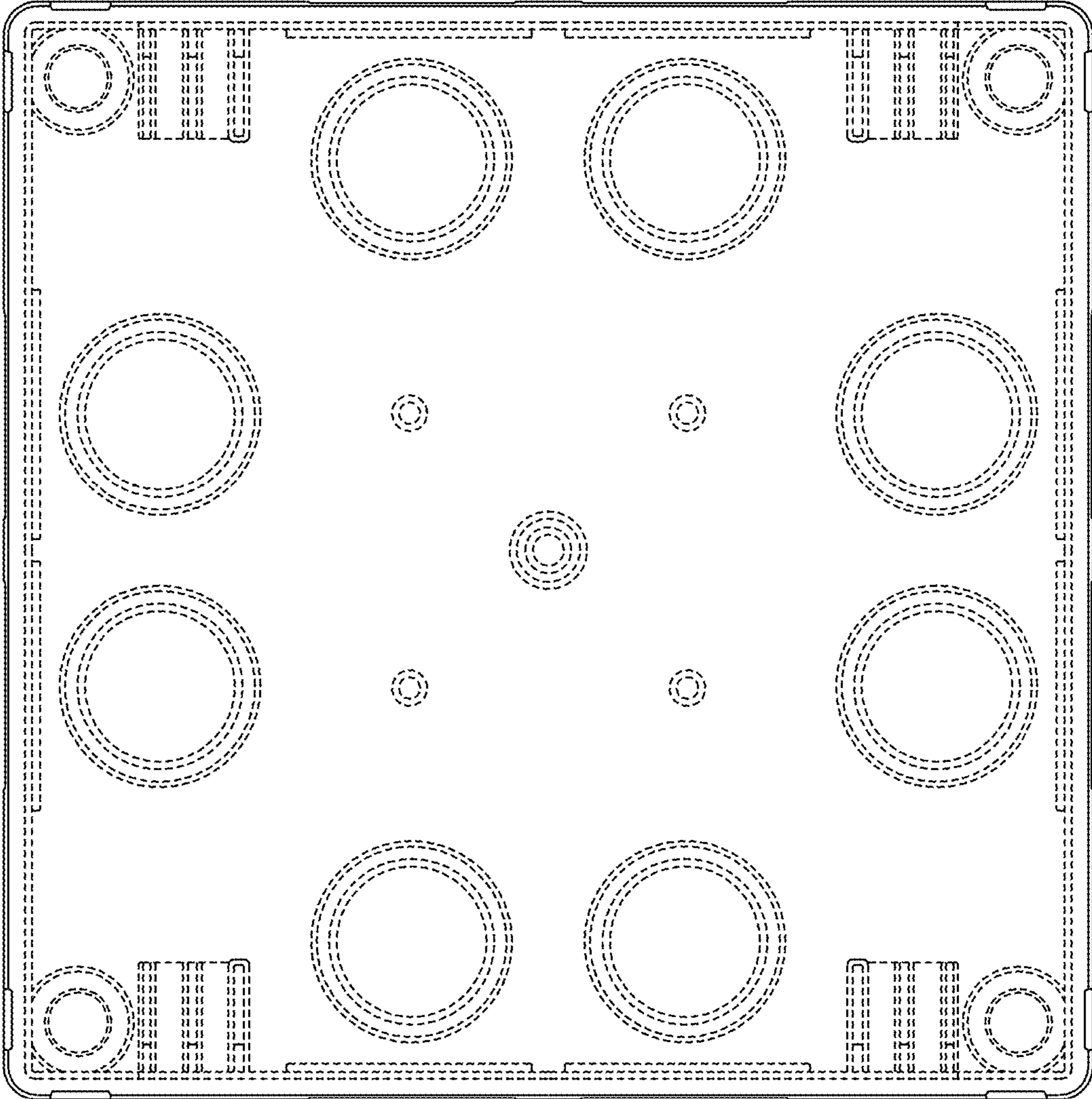

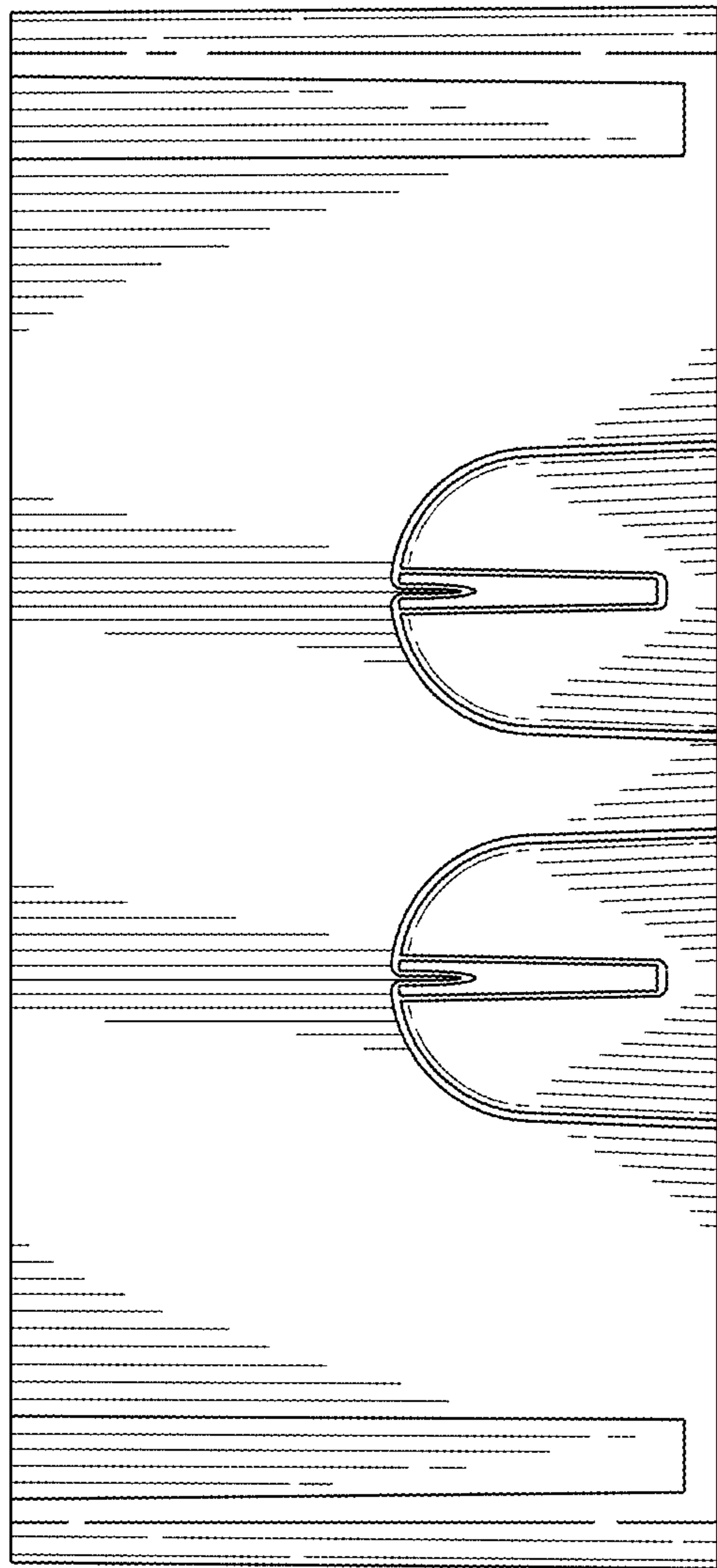

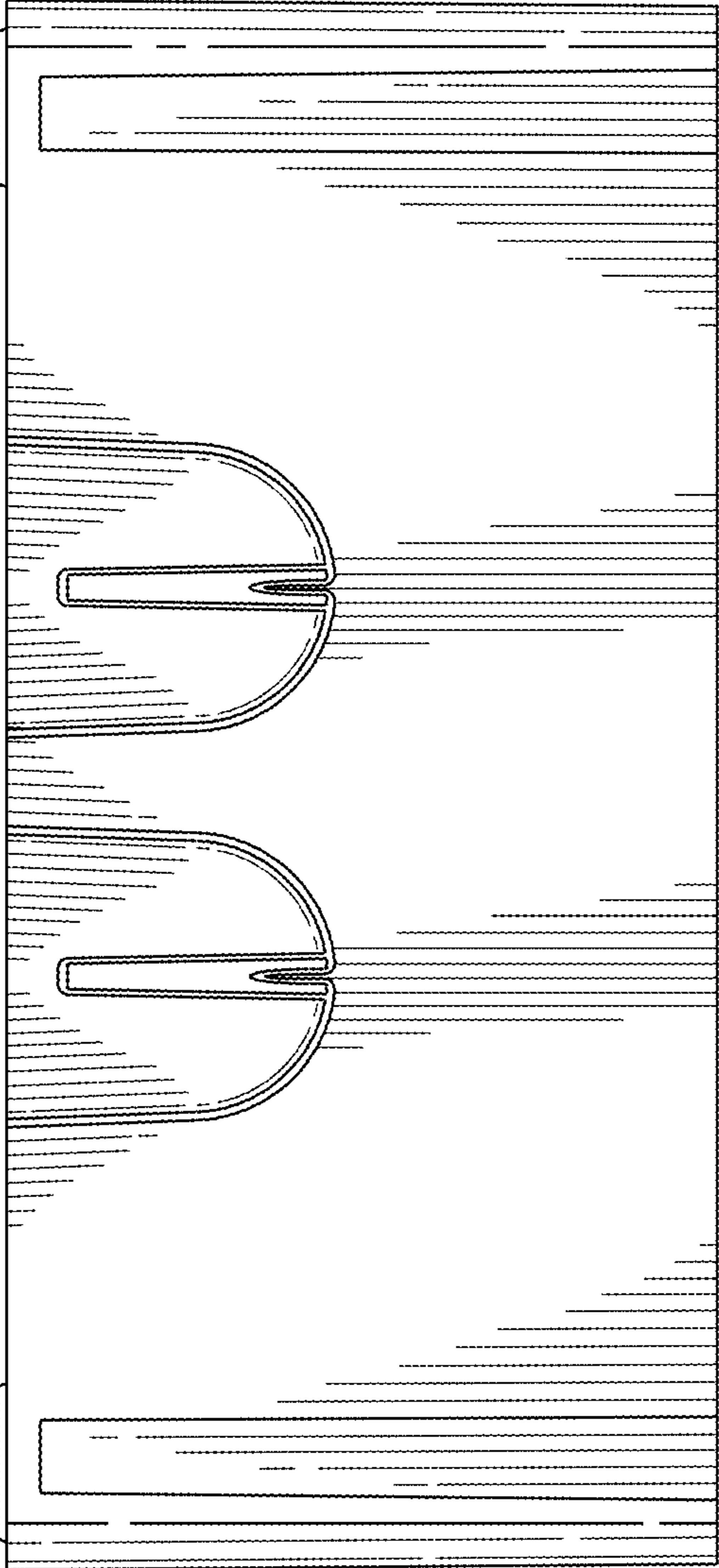

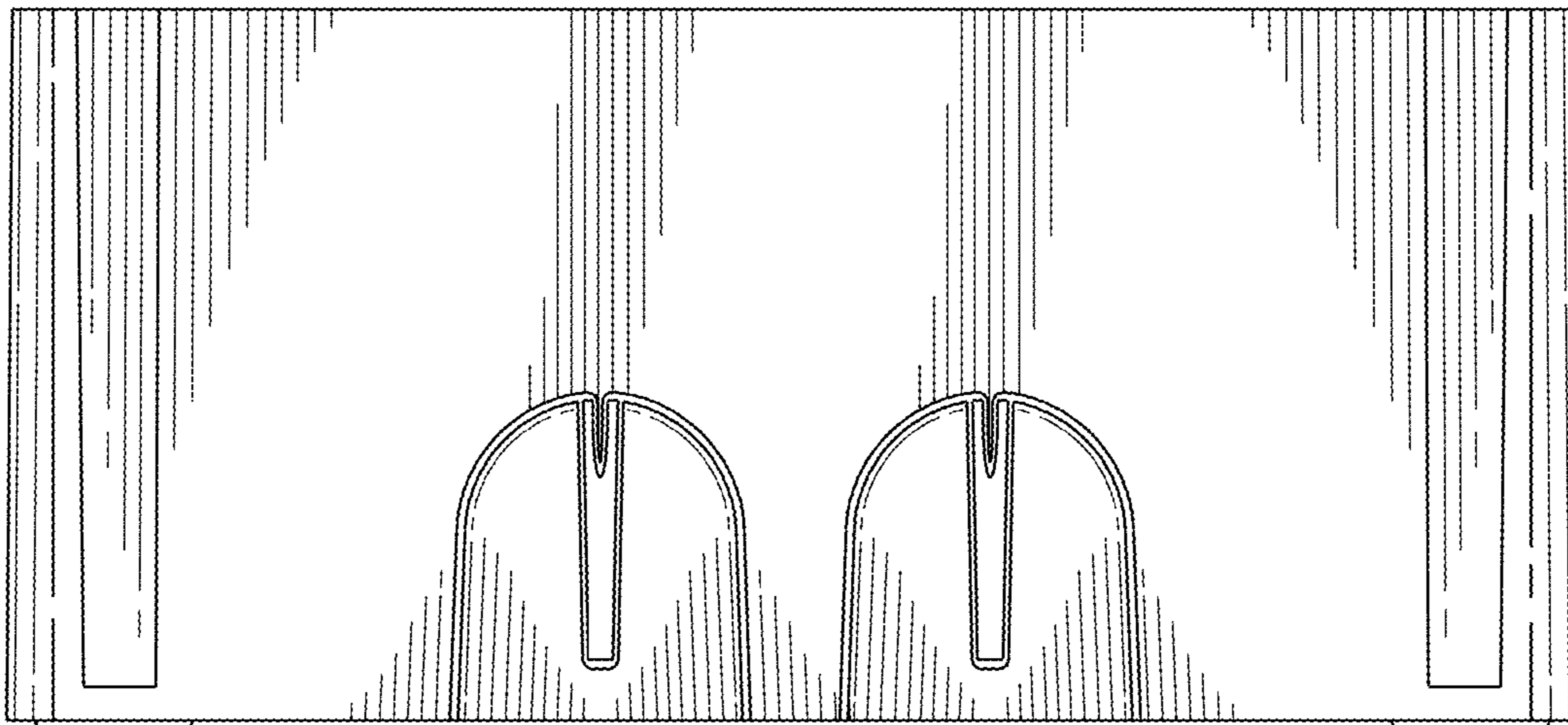

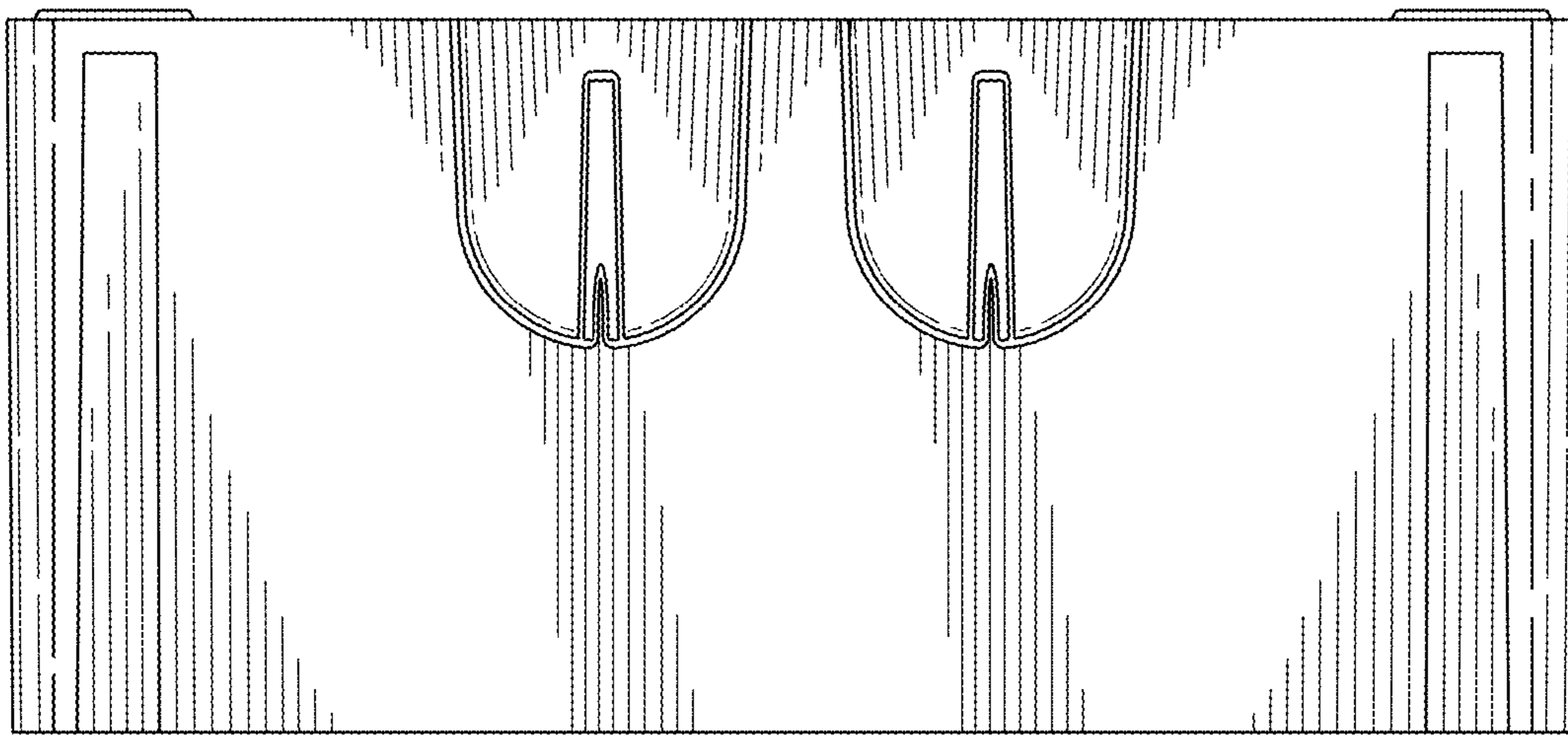

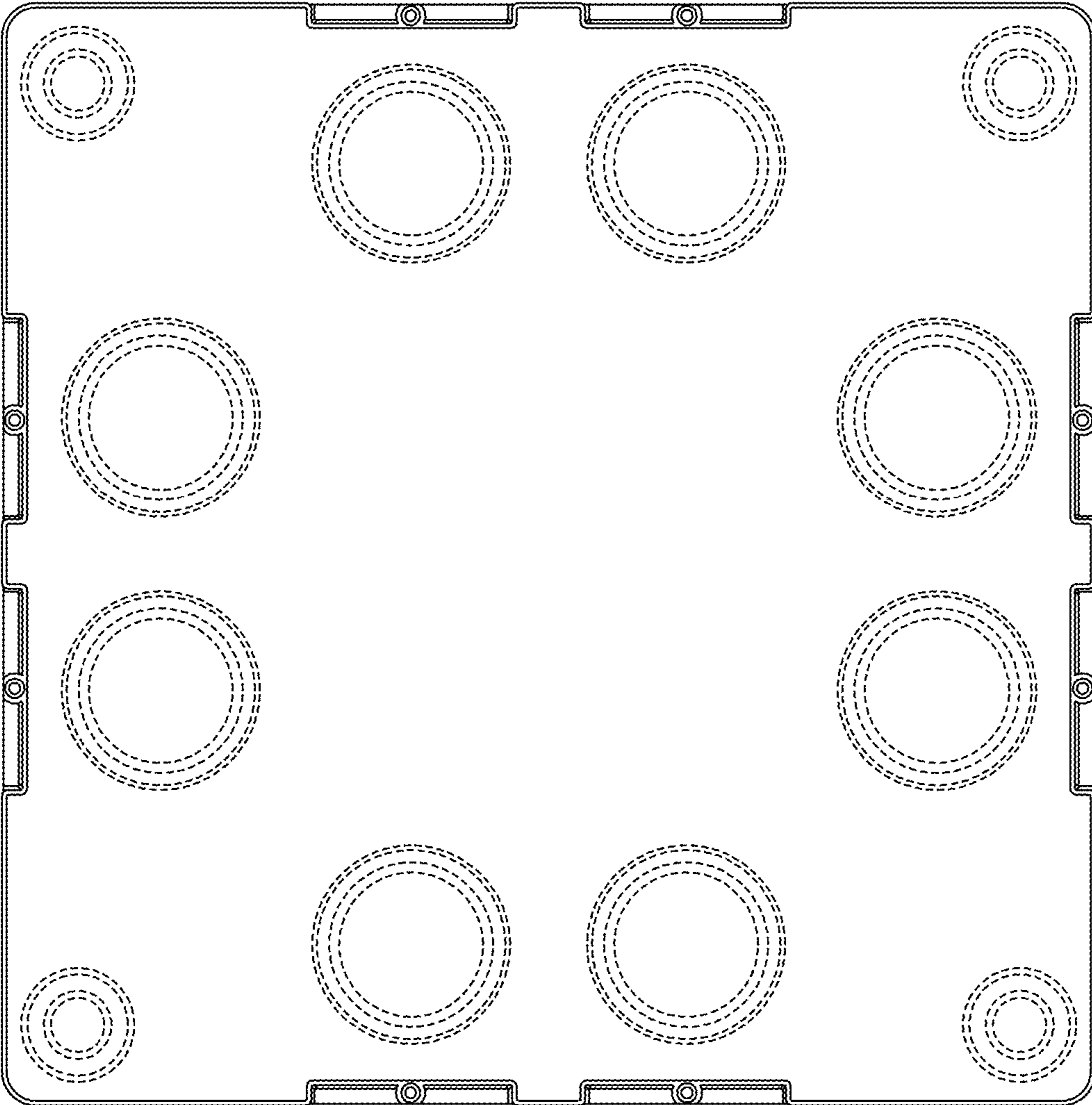
