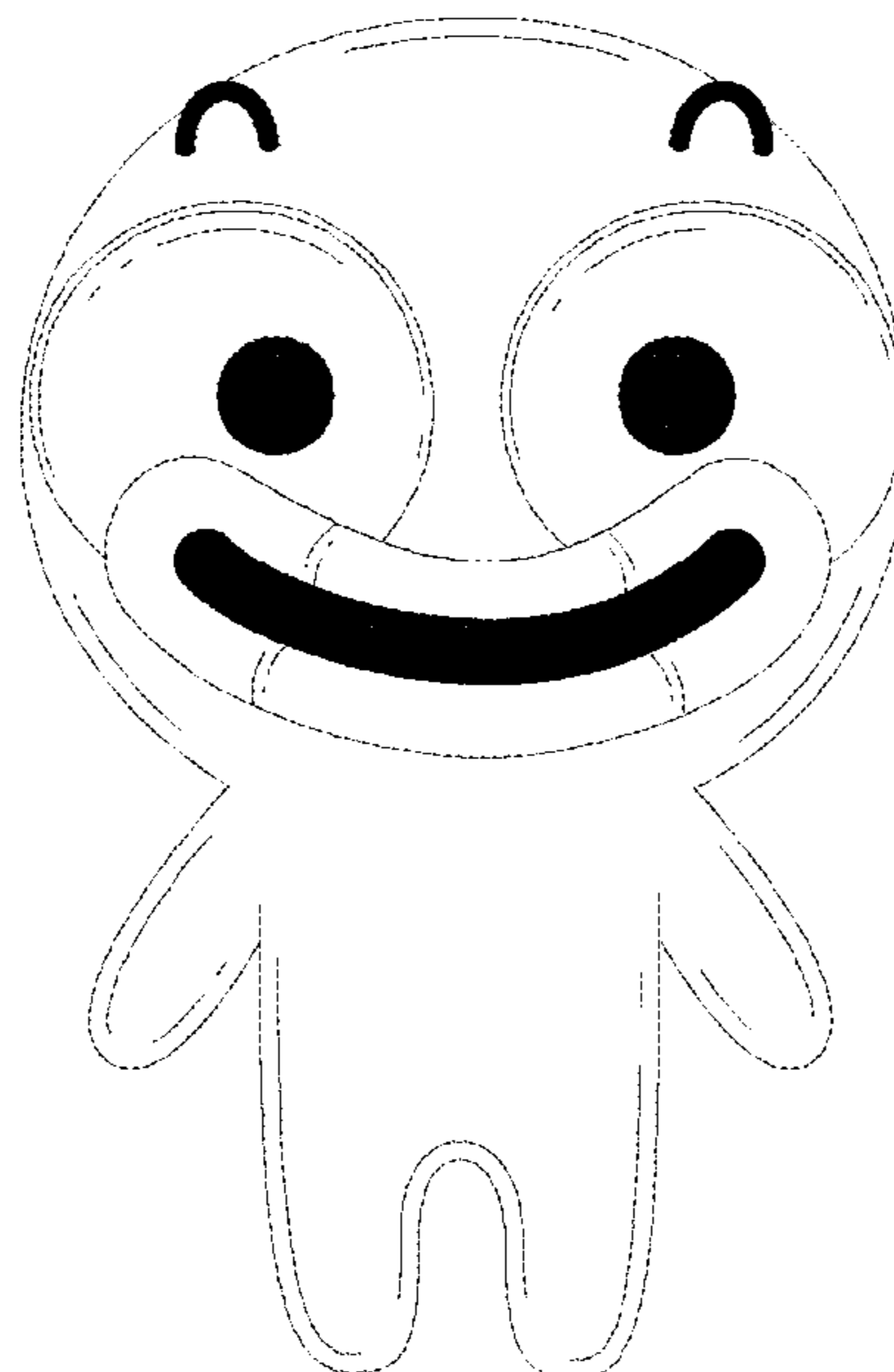
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a toy figure showing my new design;

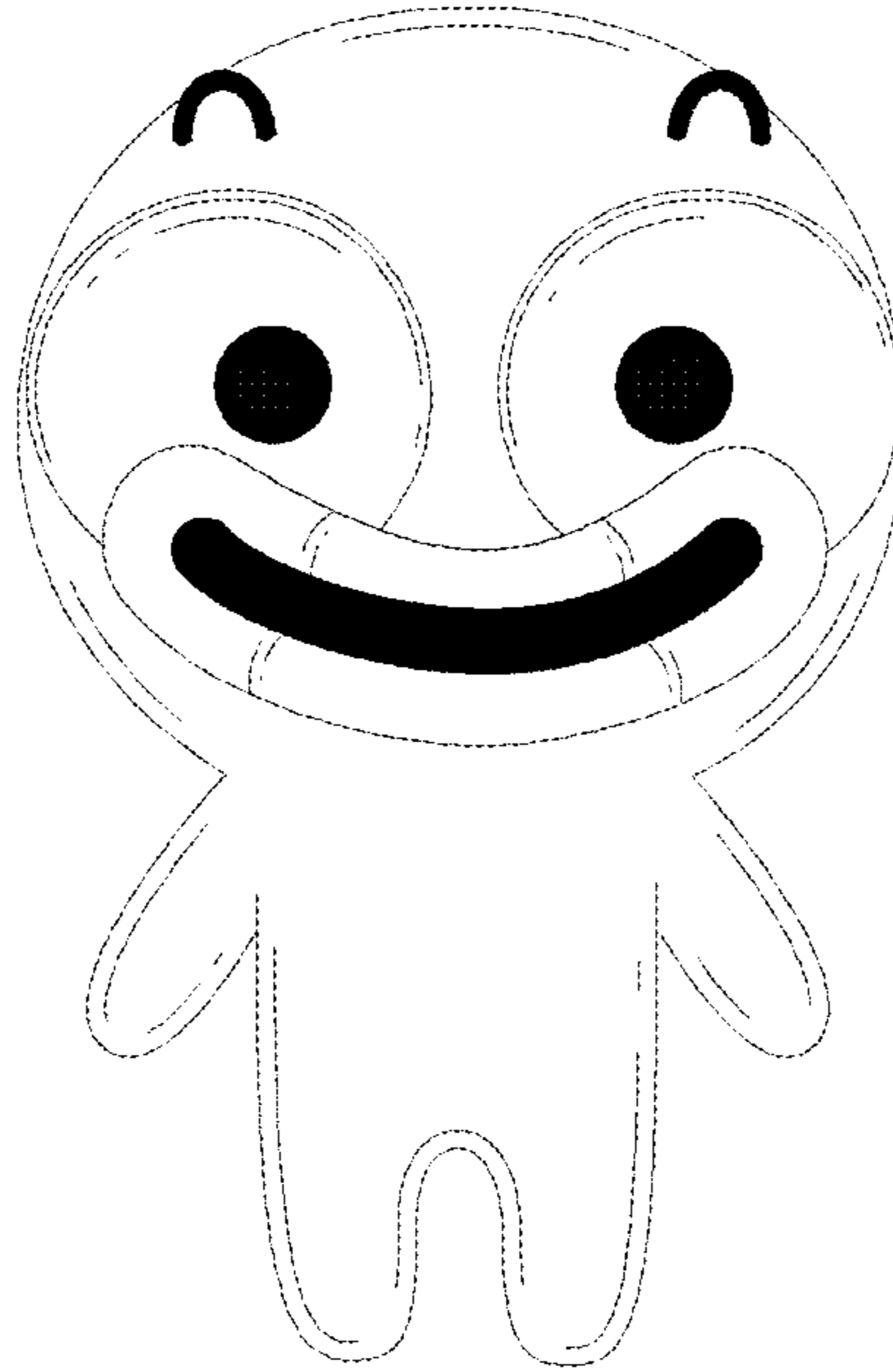

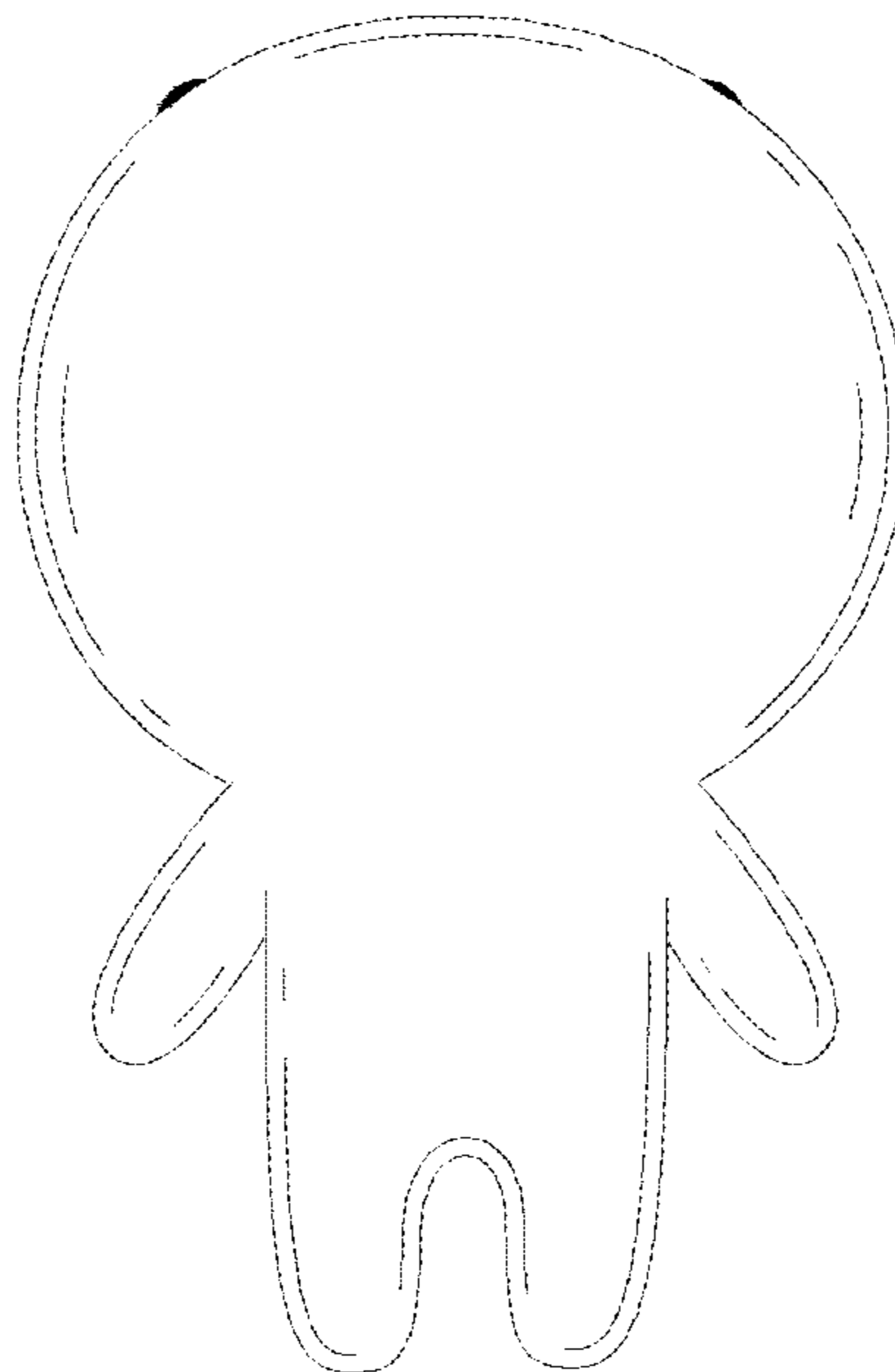

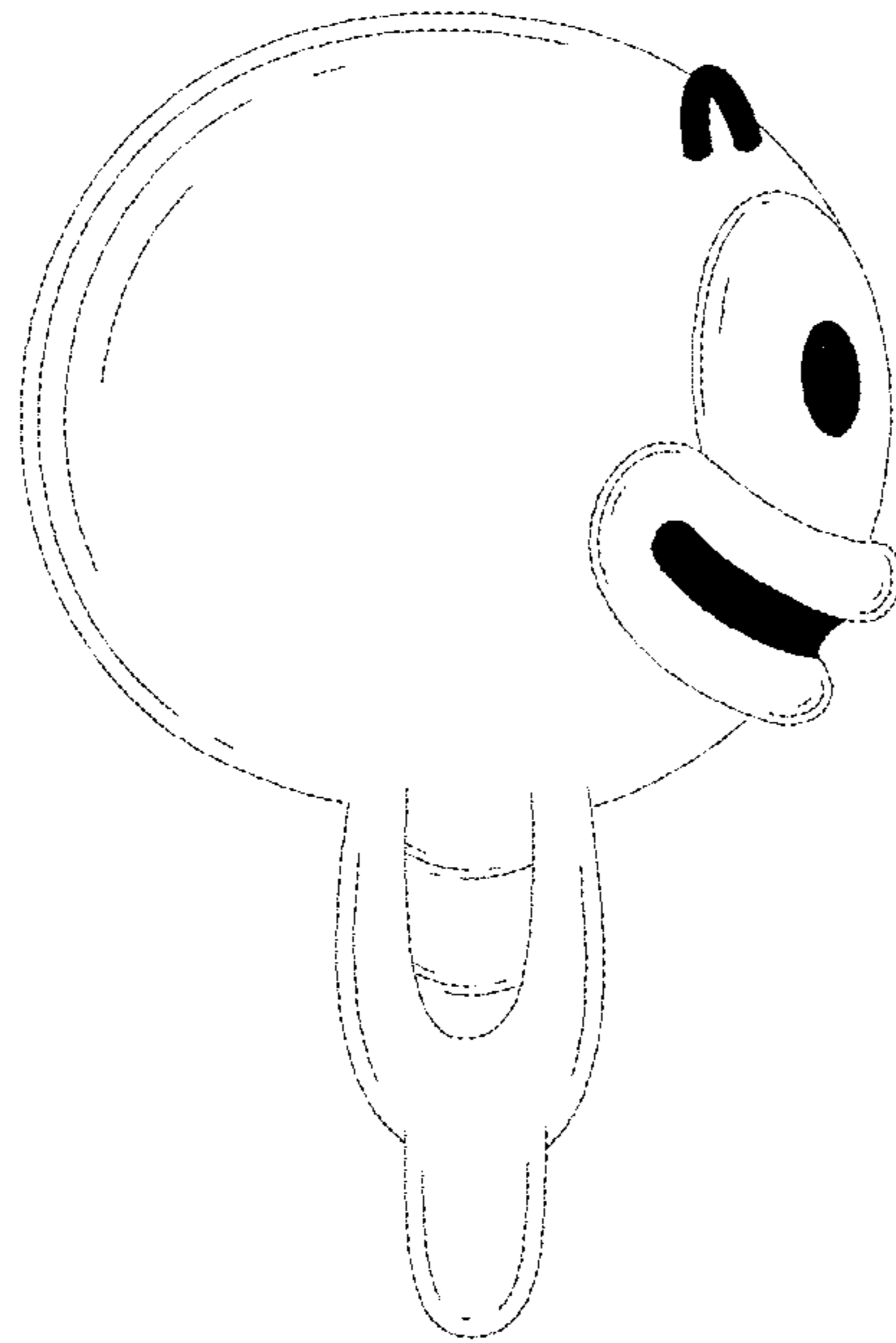

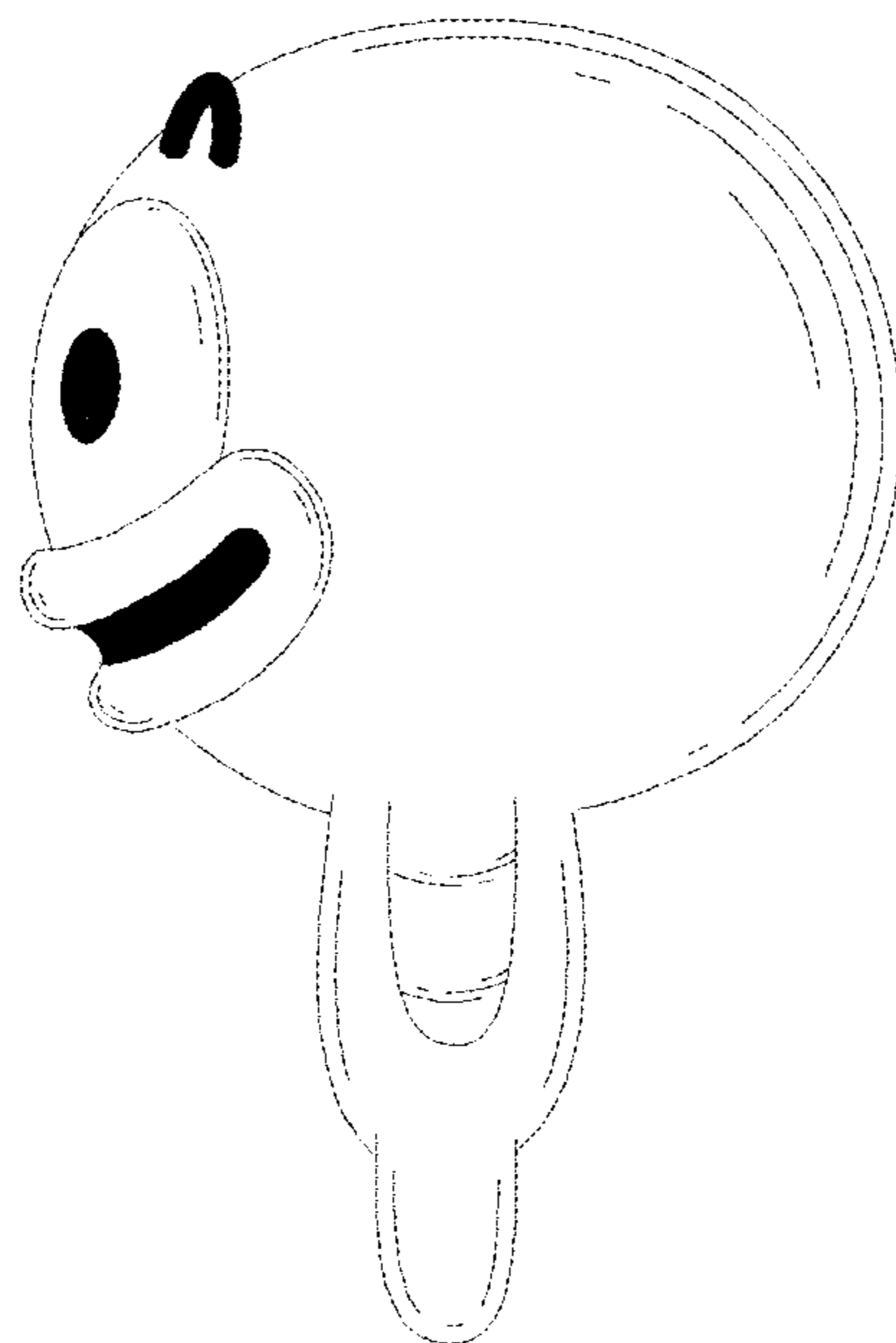

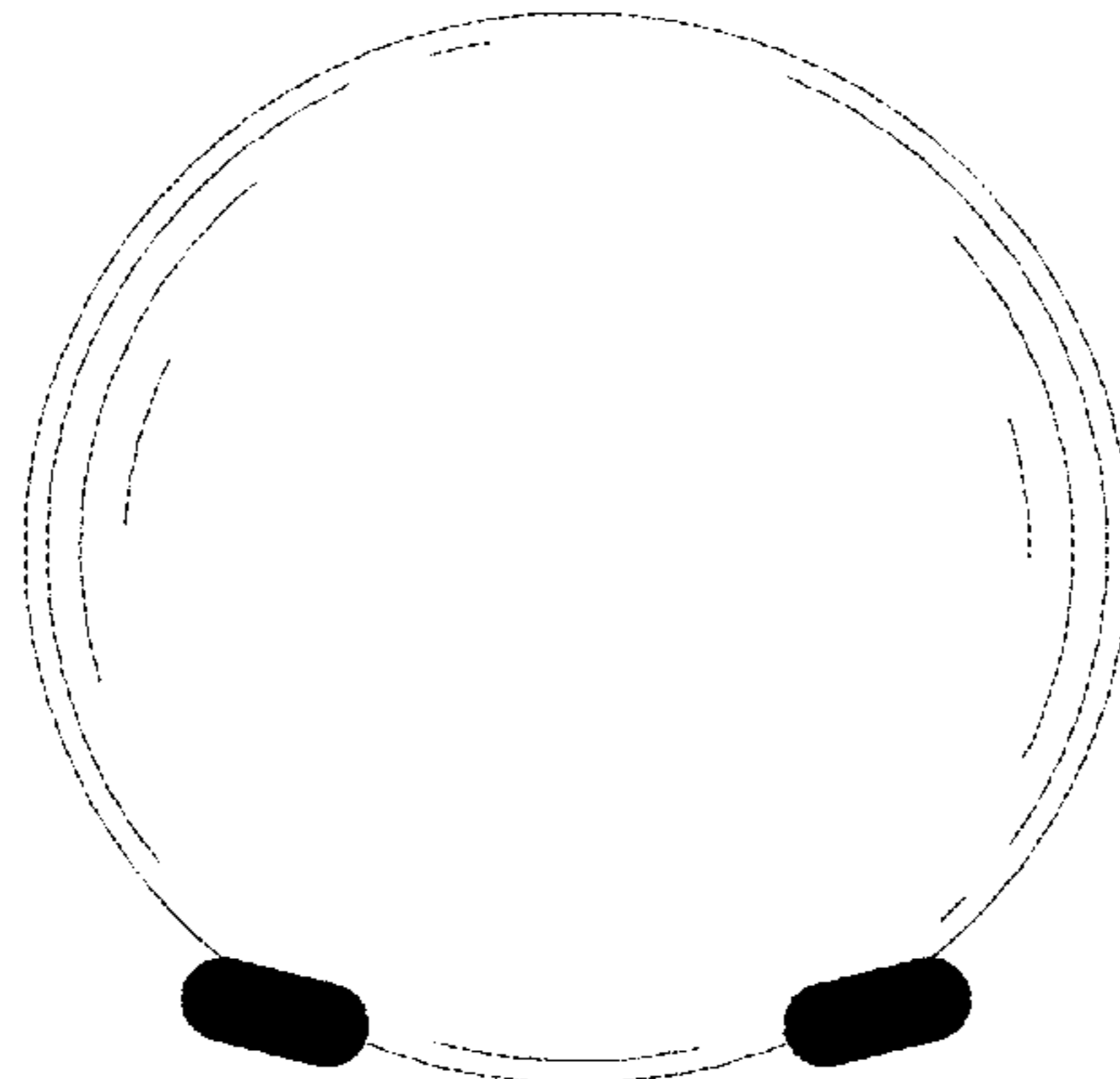

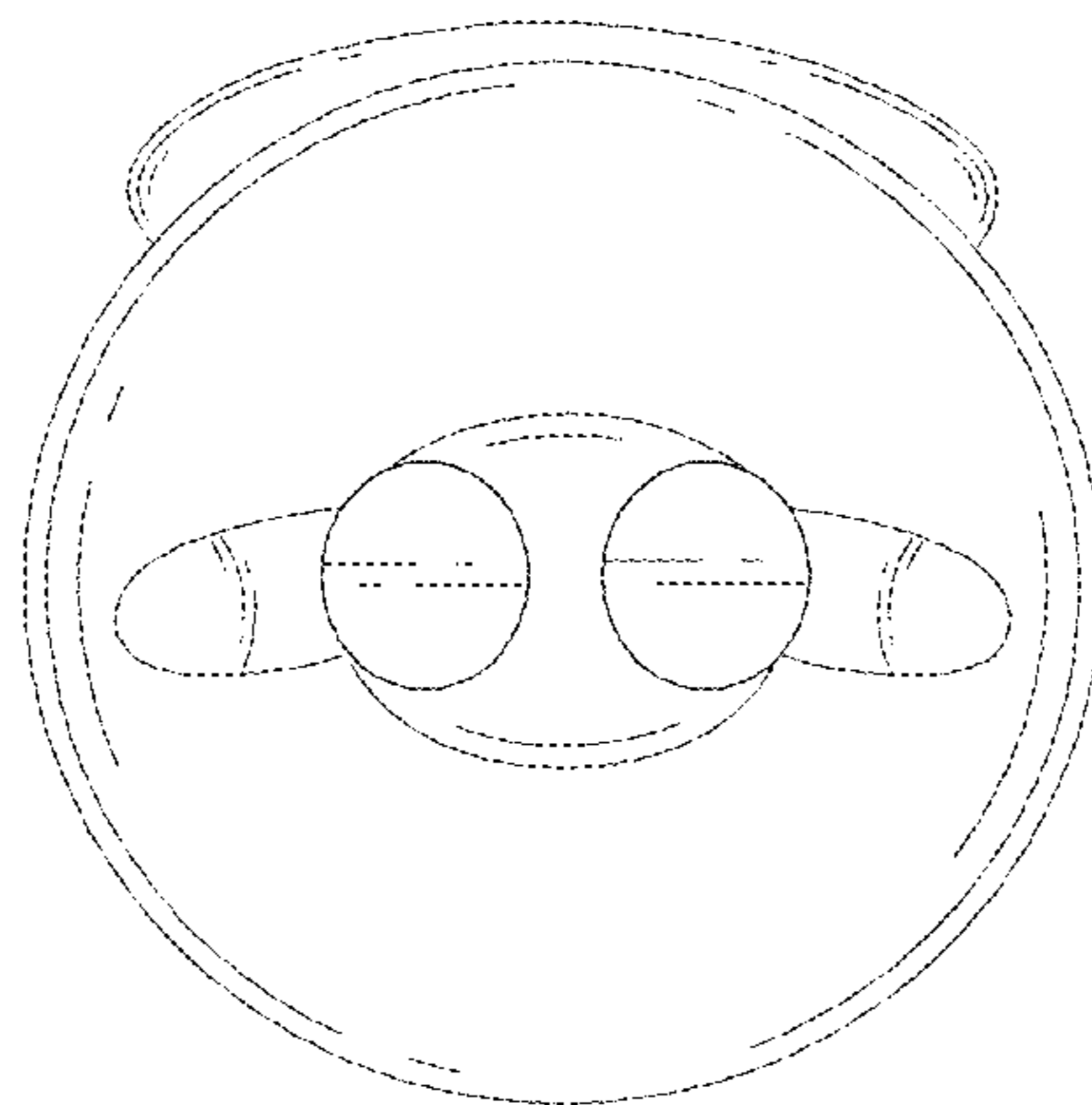

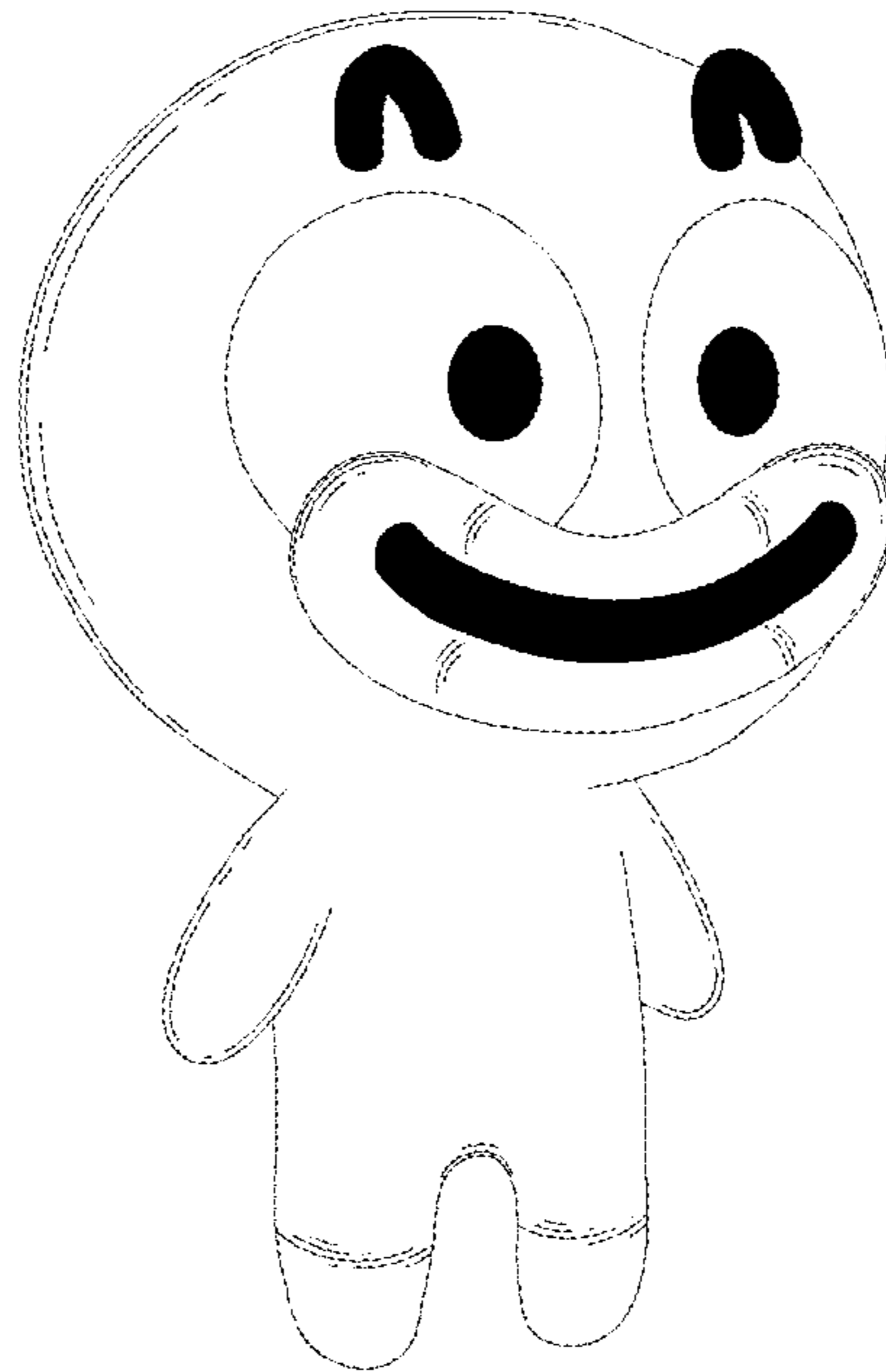

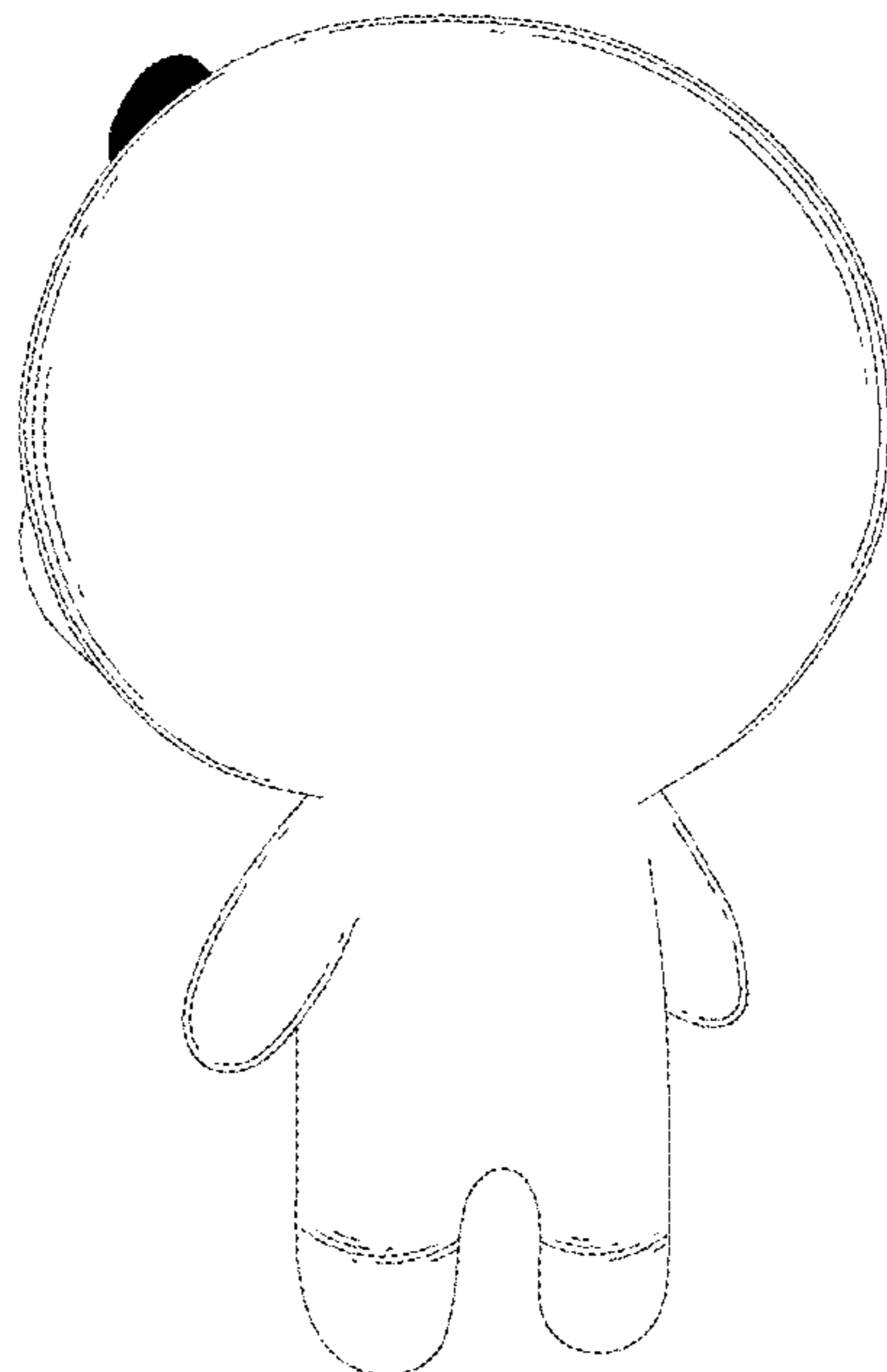
