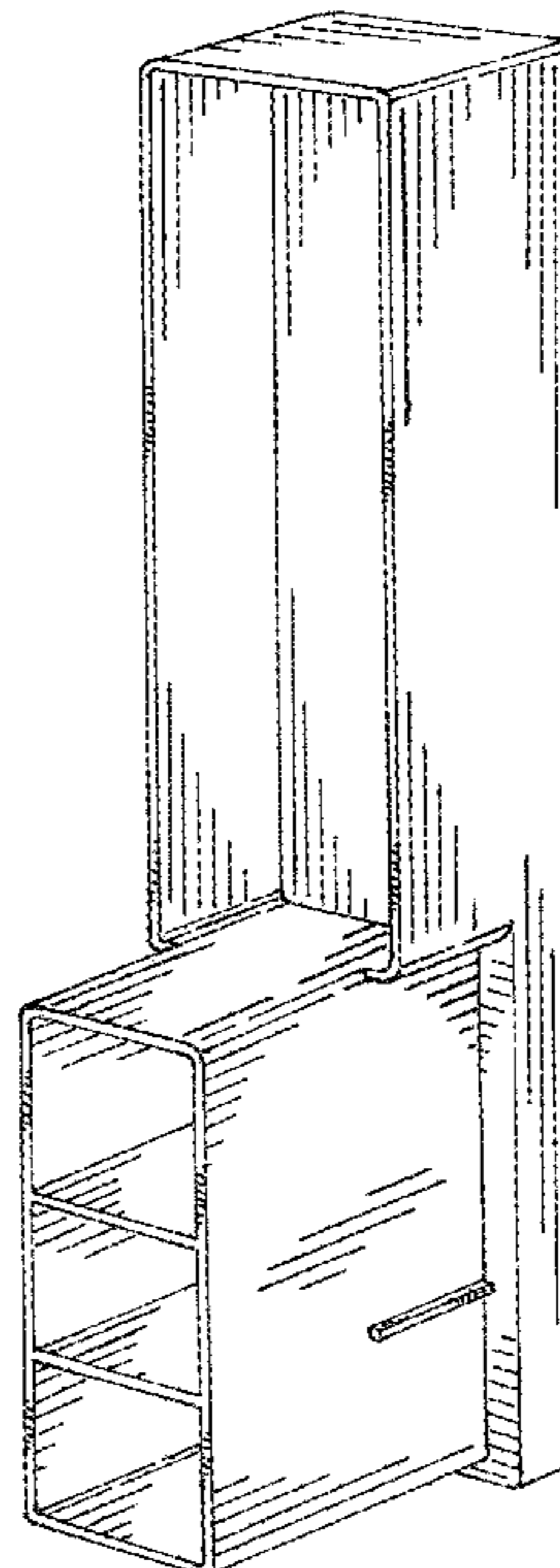
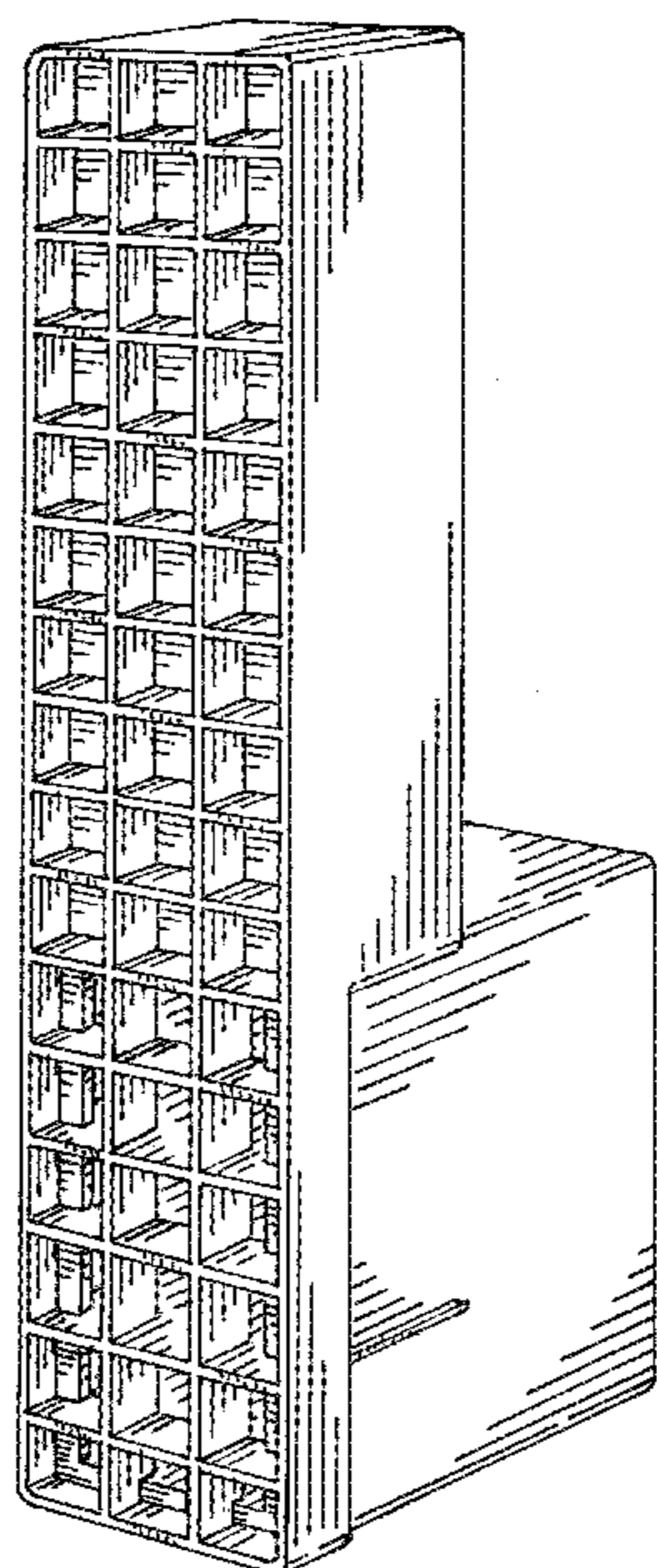
(57) **CLAIM**

The ornamental design for a drainage fitting for a retaining wall, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a drainage fitting for a retaining wall showing my design;
FIG. 2 is a rear perspective view thereof;

FIG. 4 is a right side view thereof;

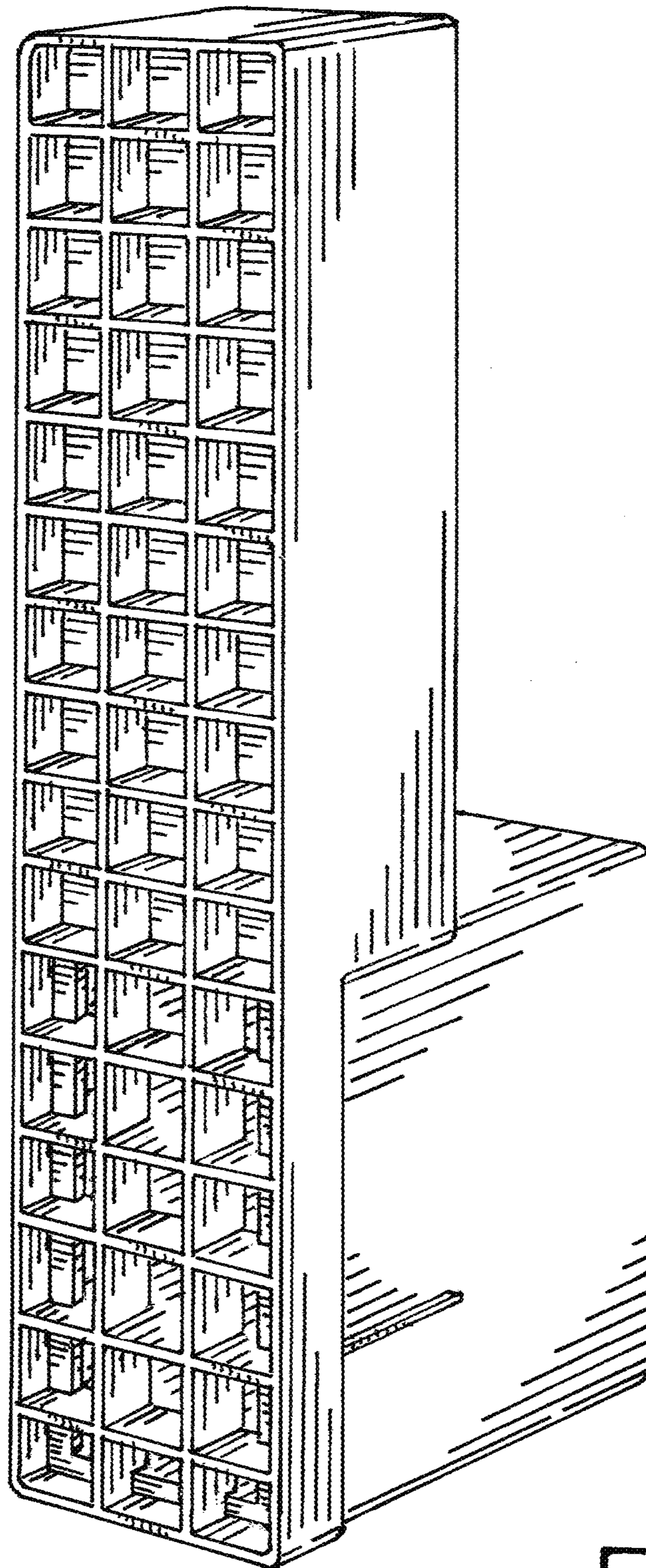

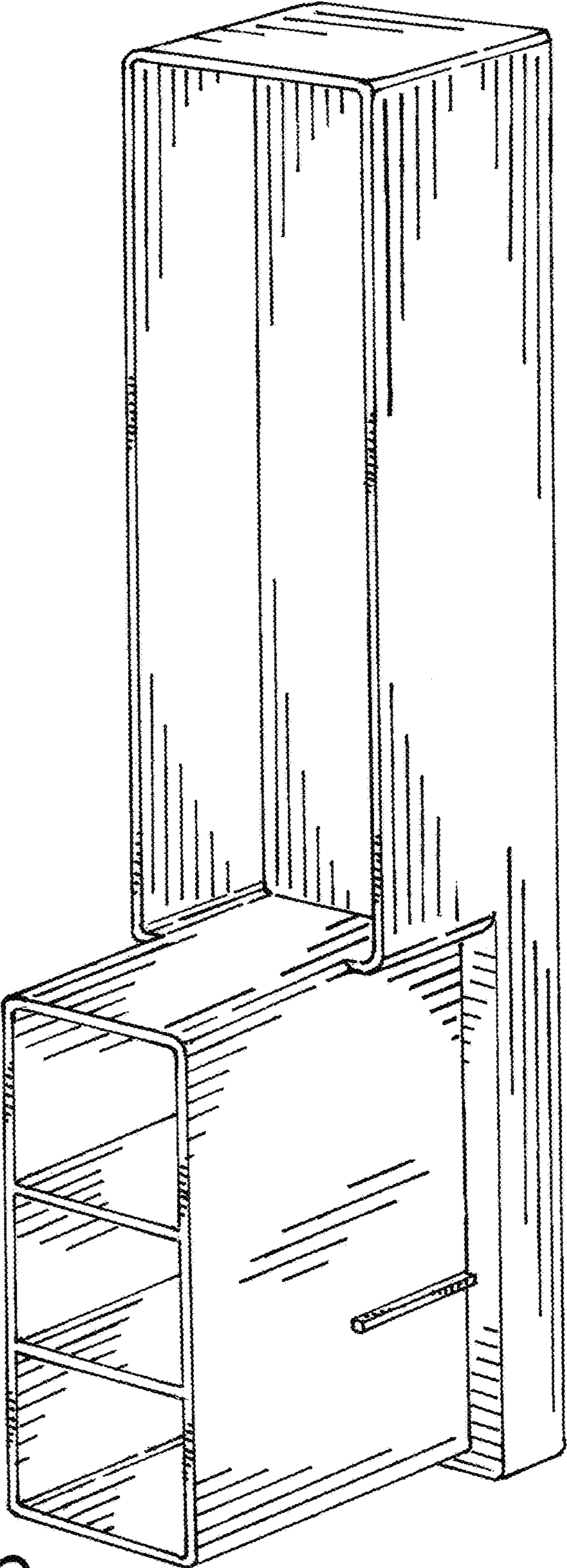

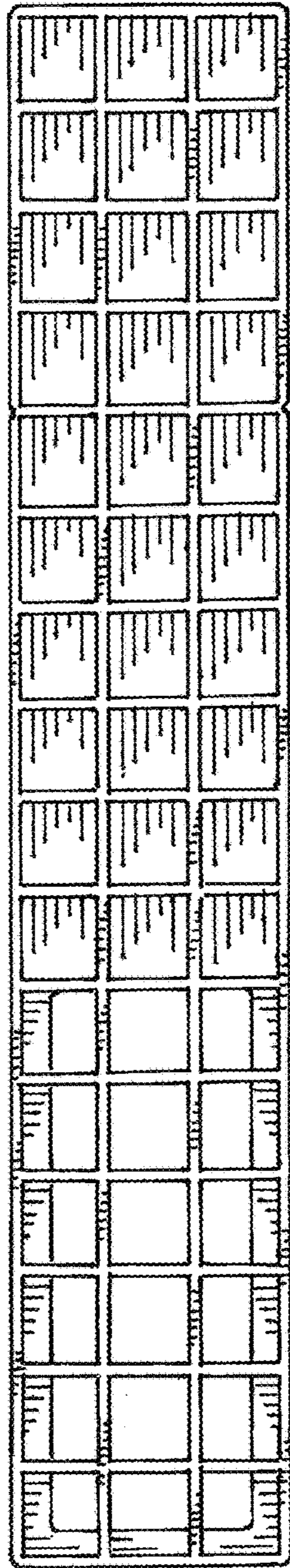

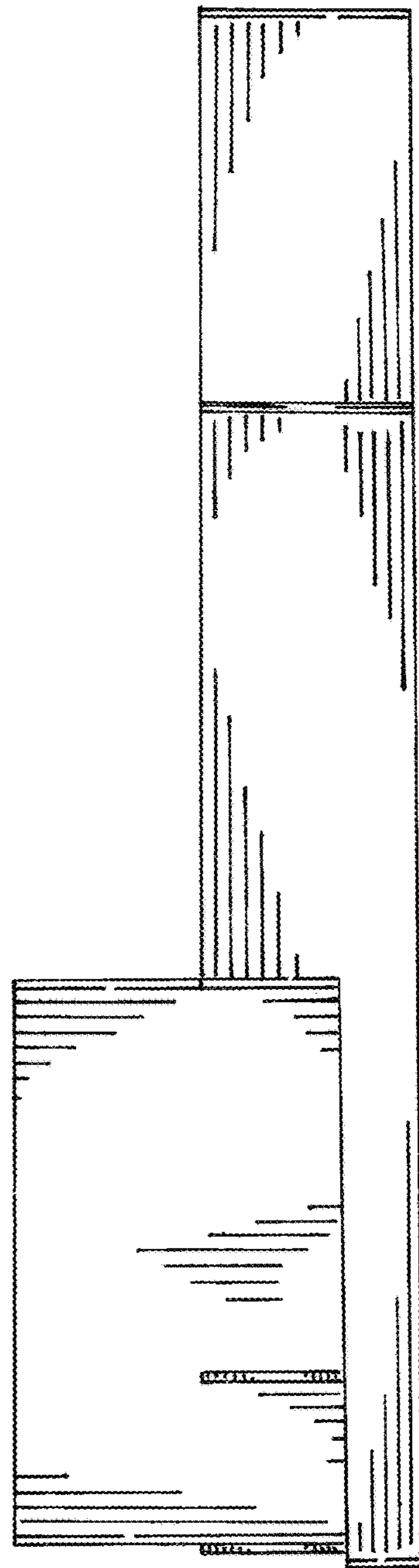

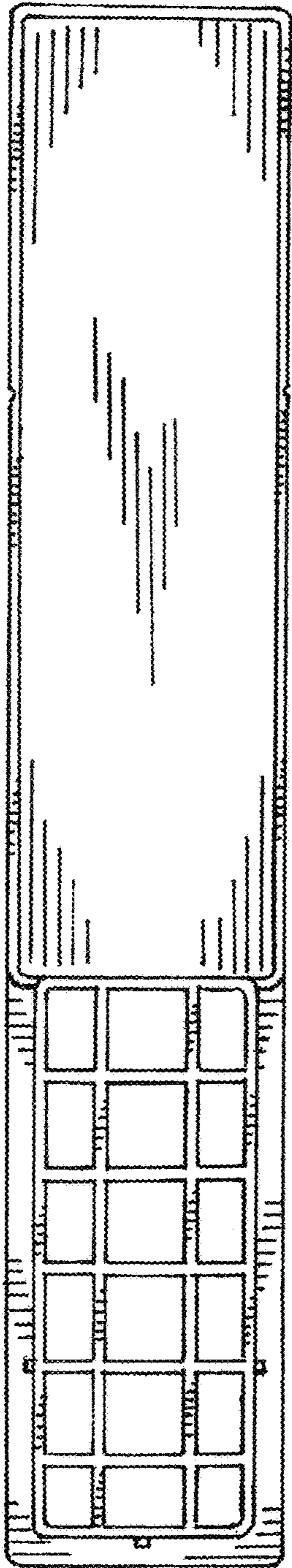

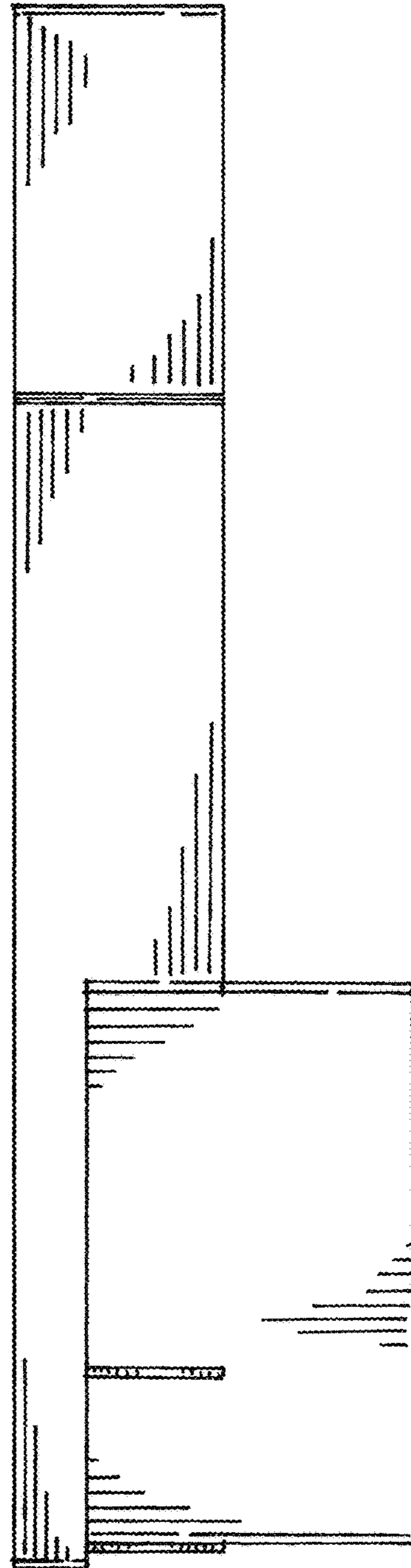

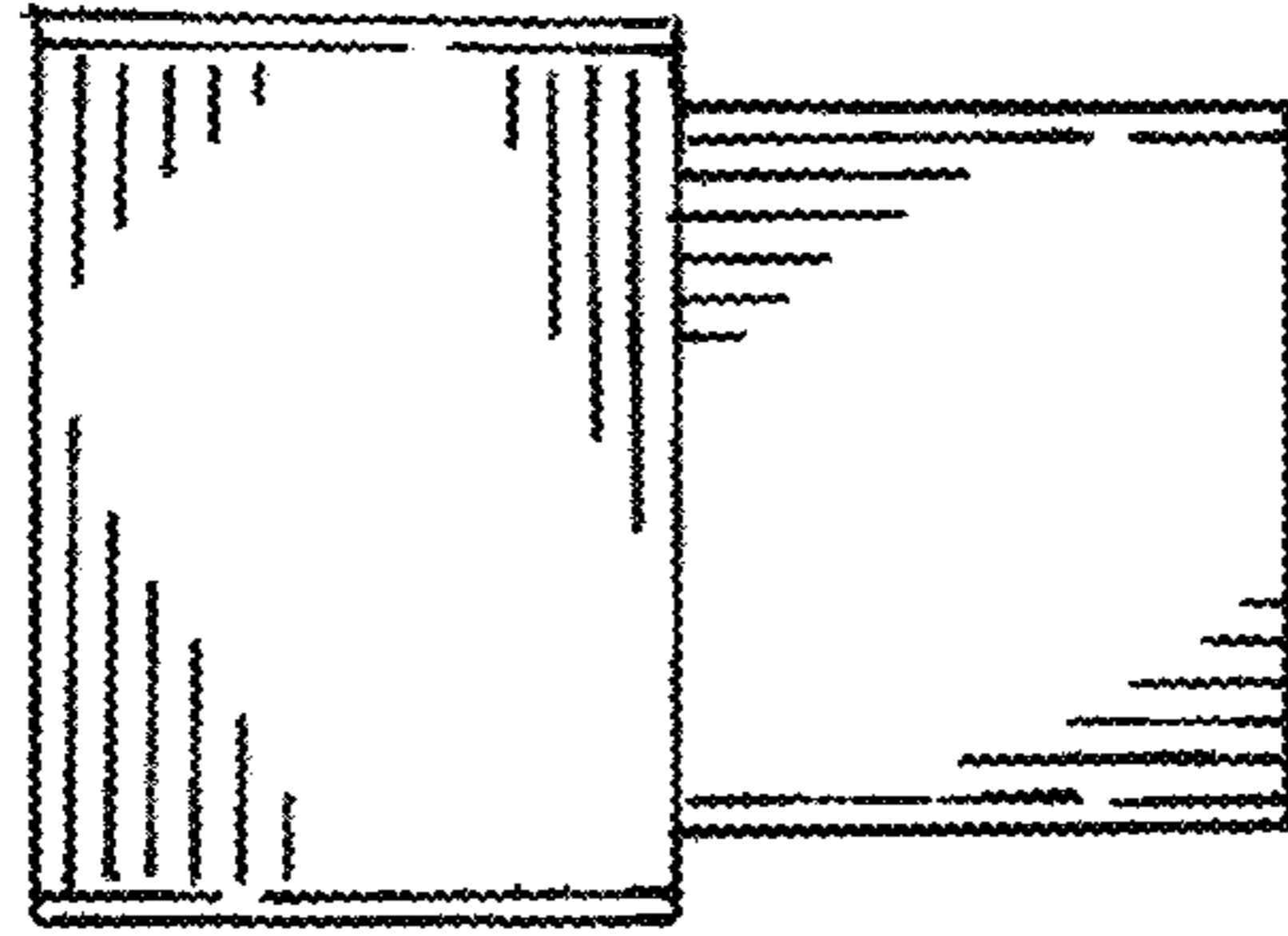

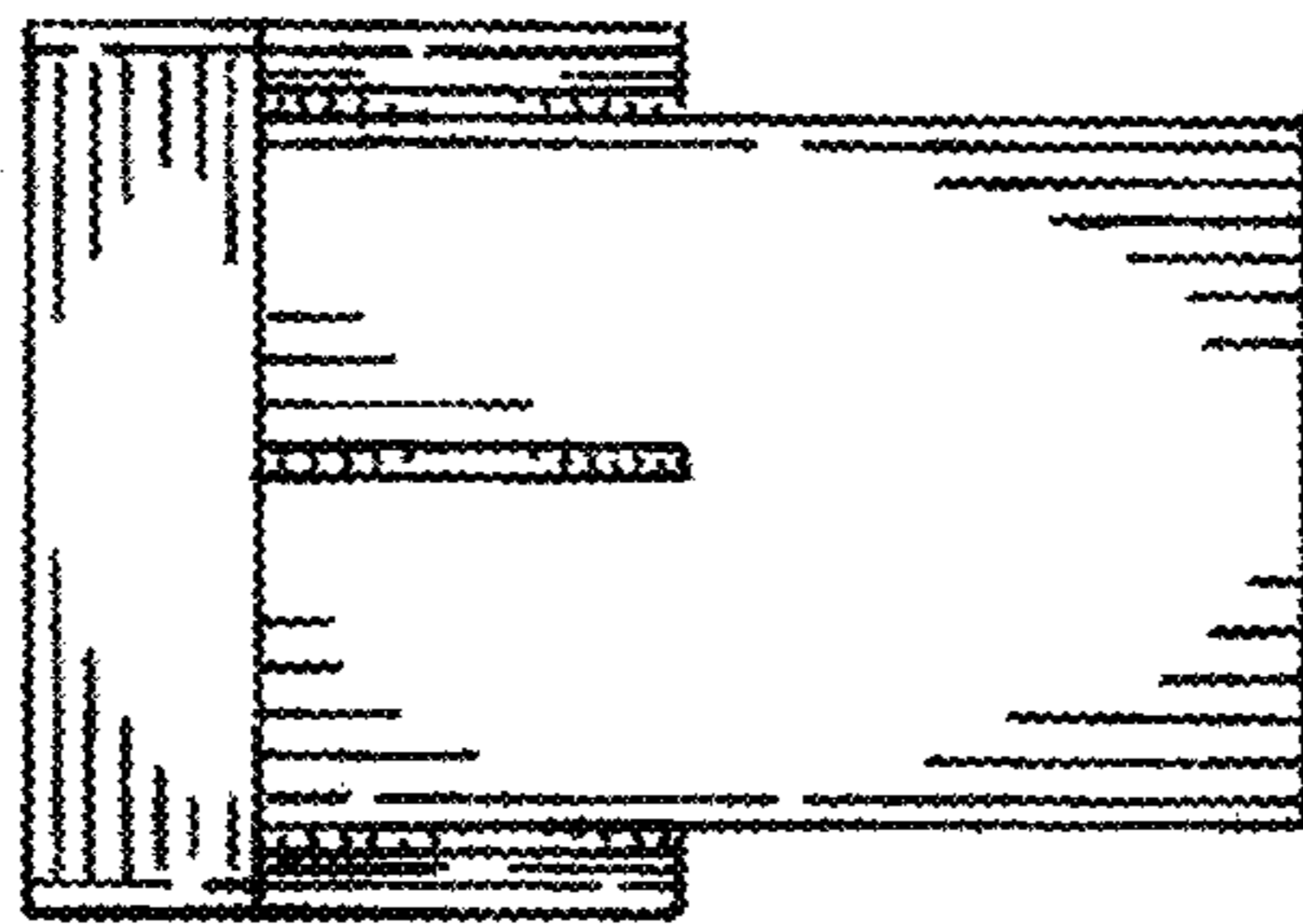

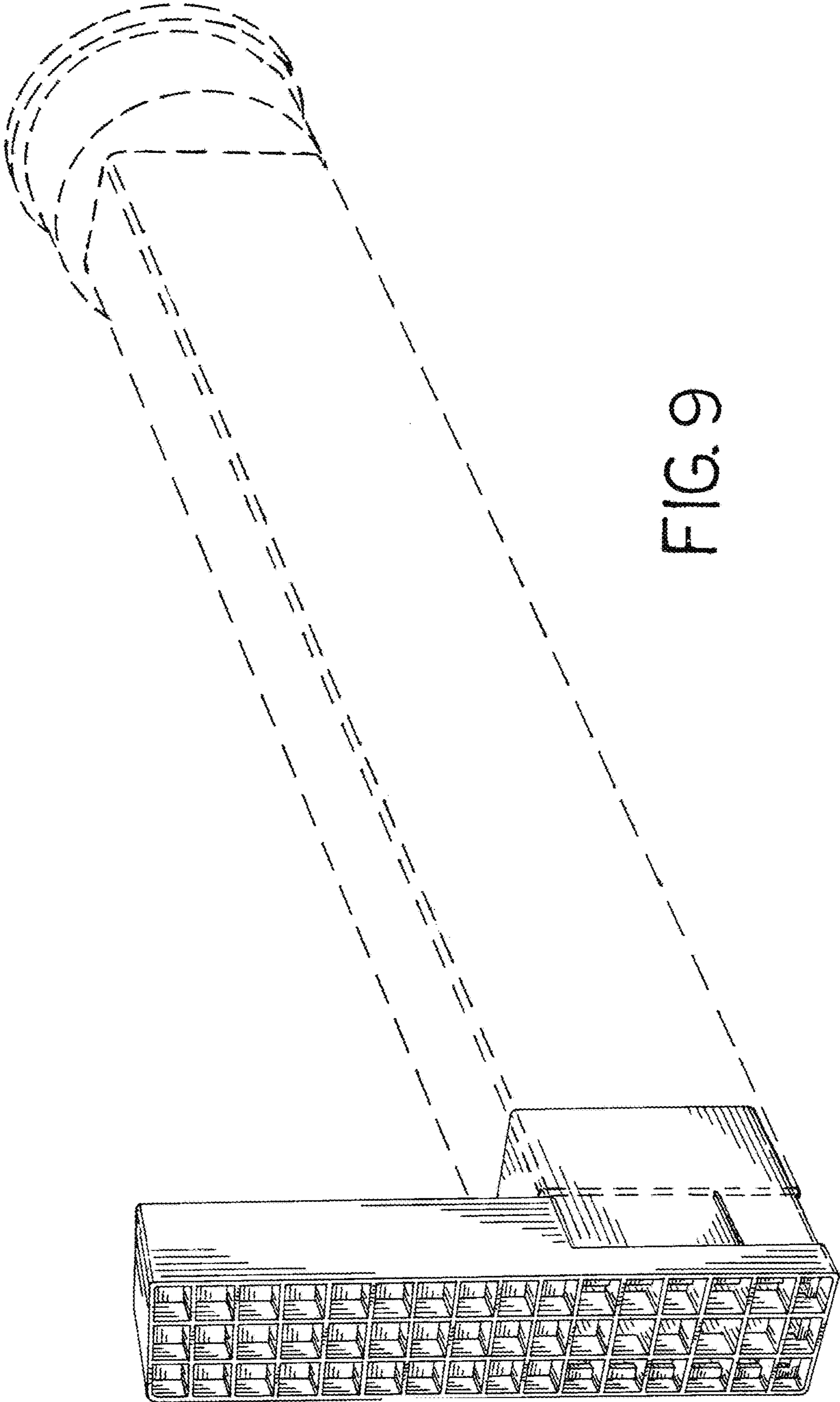
