**DESCRIPTION**

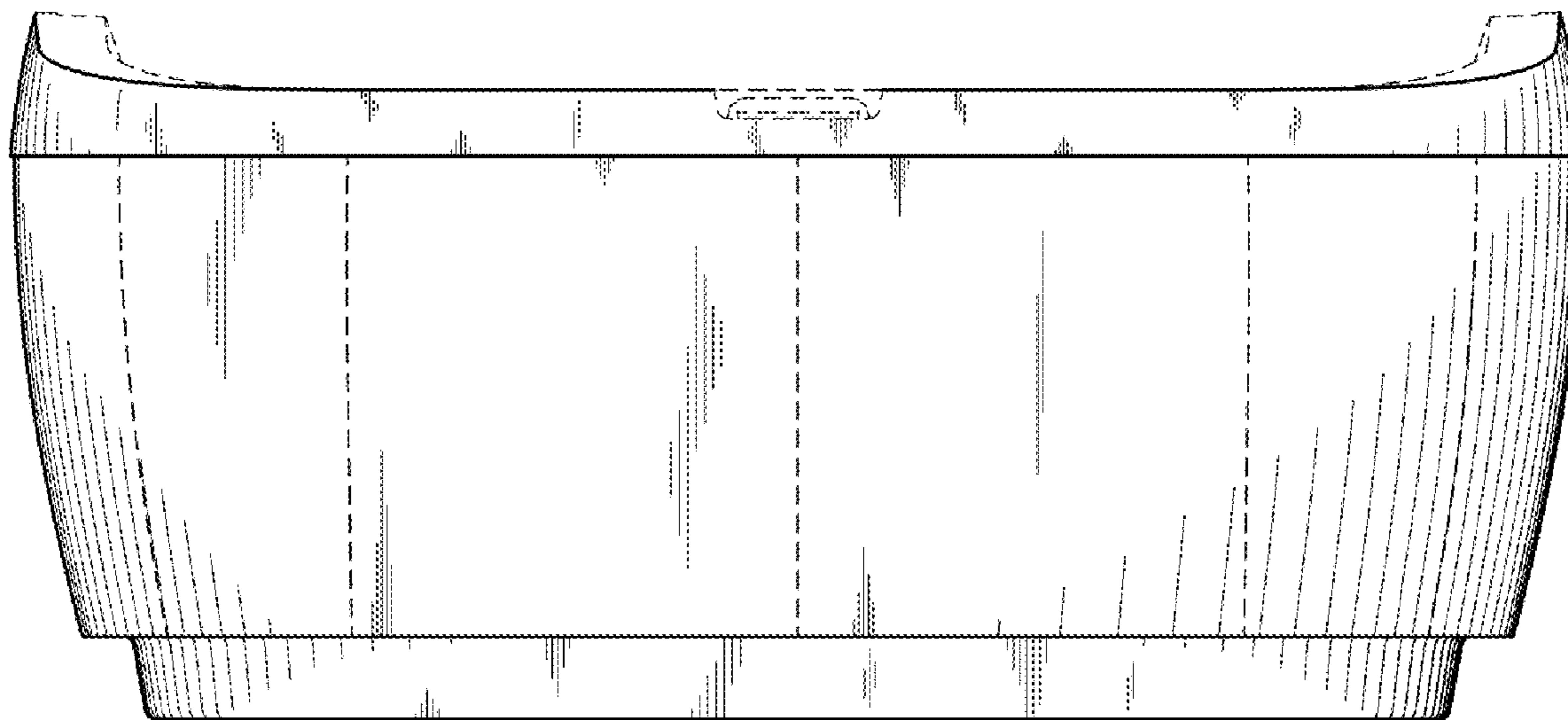
FIG. 1 is a right side view of a Spa showing our new design;

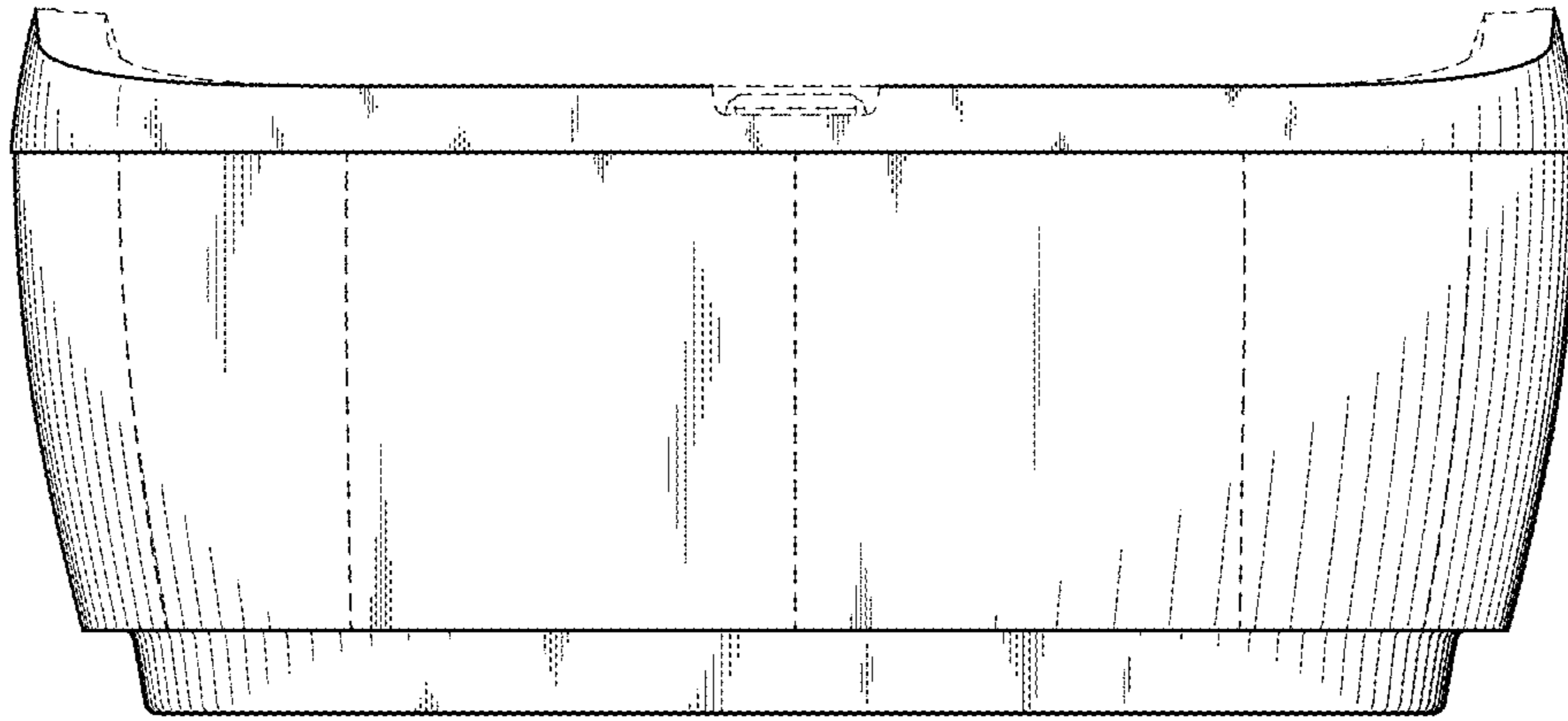

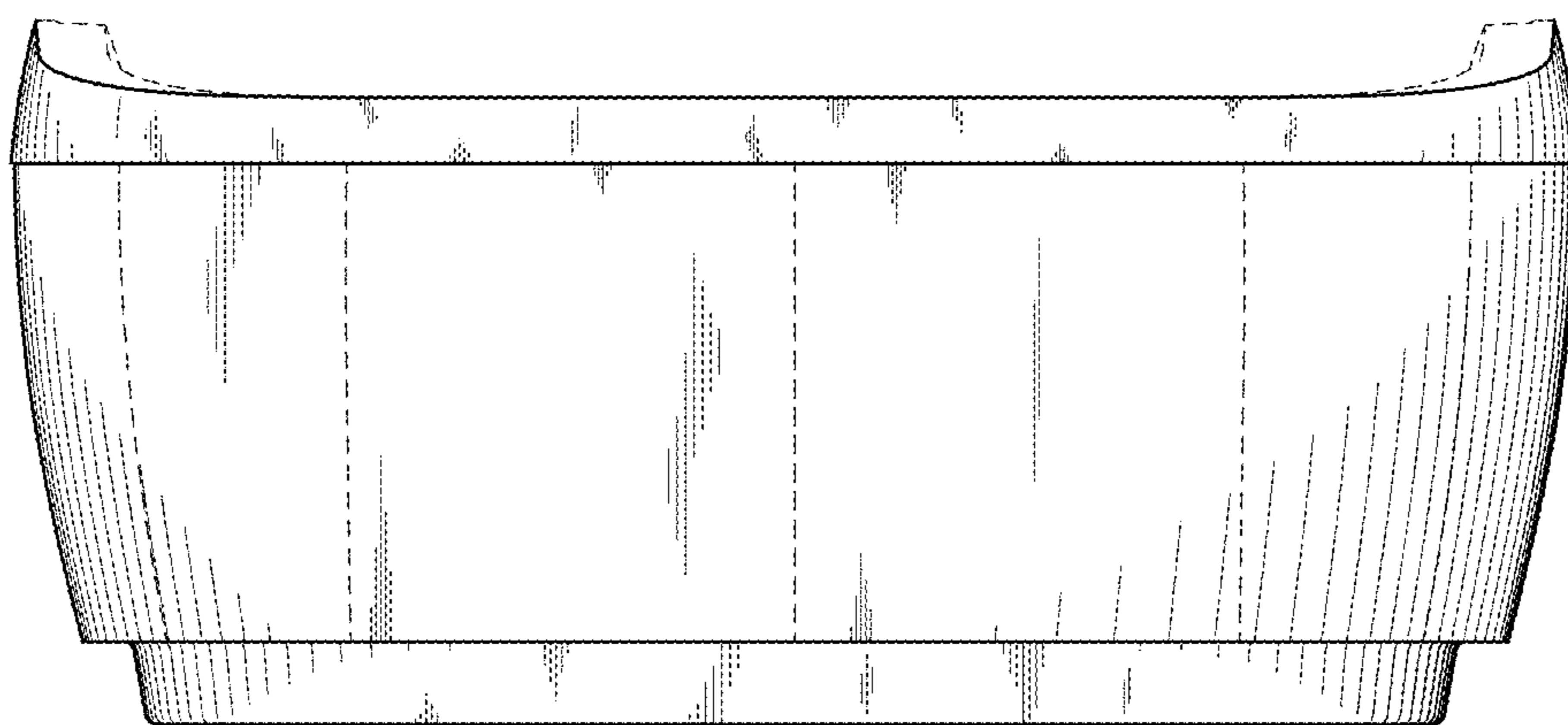

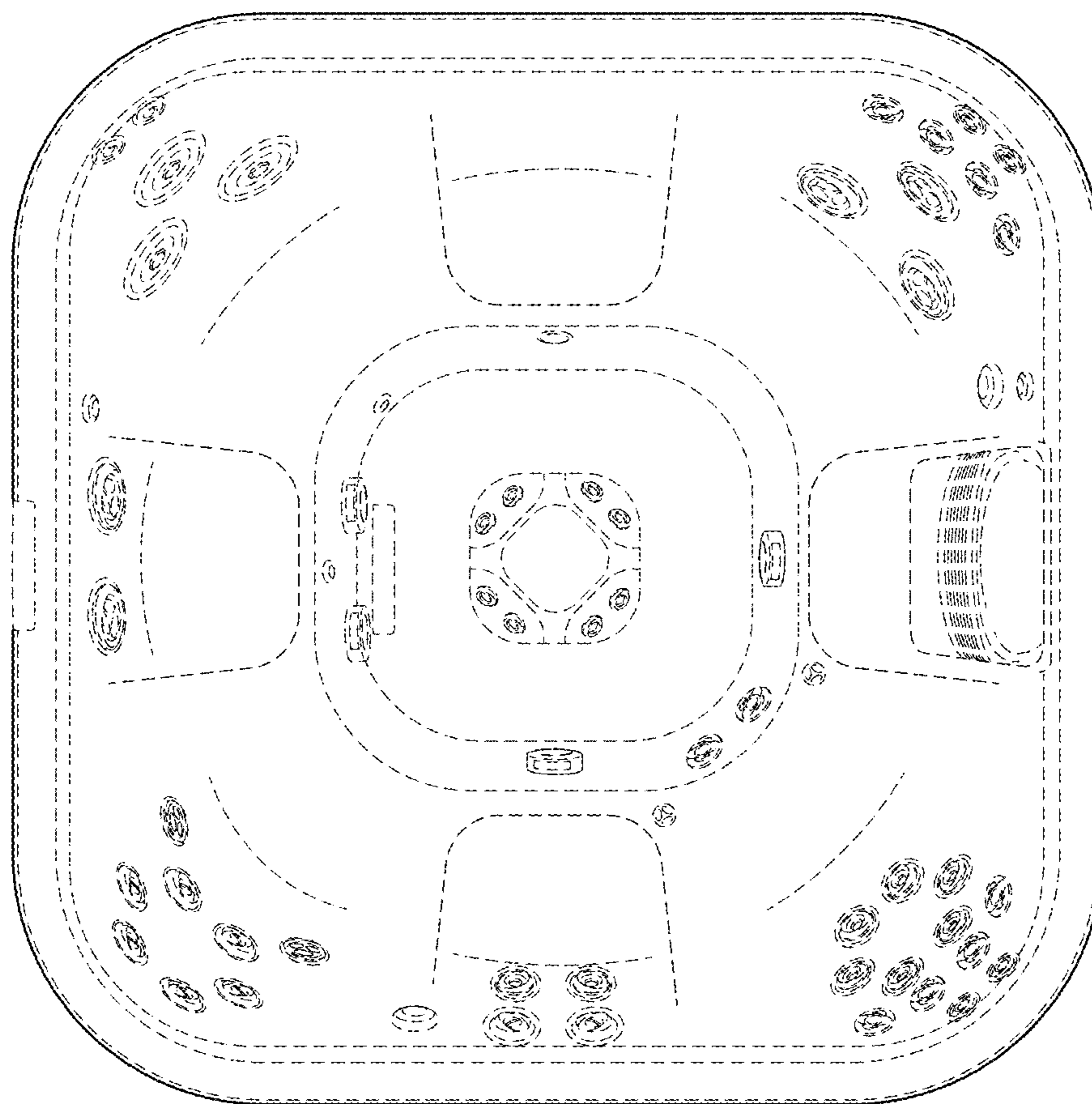

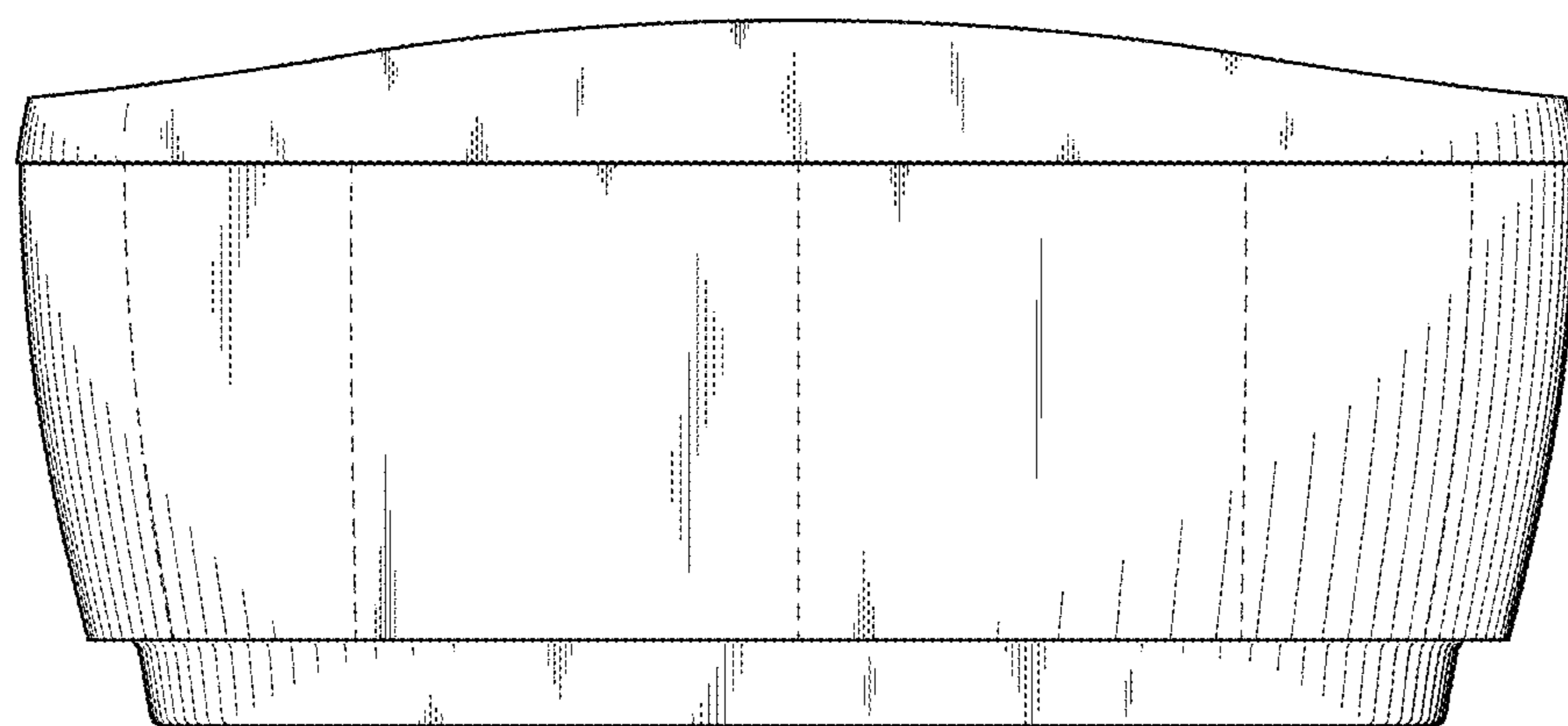
