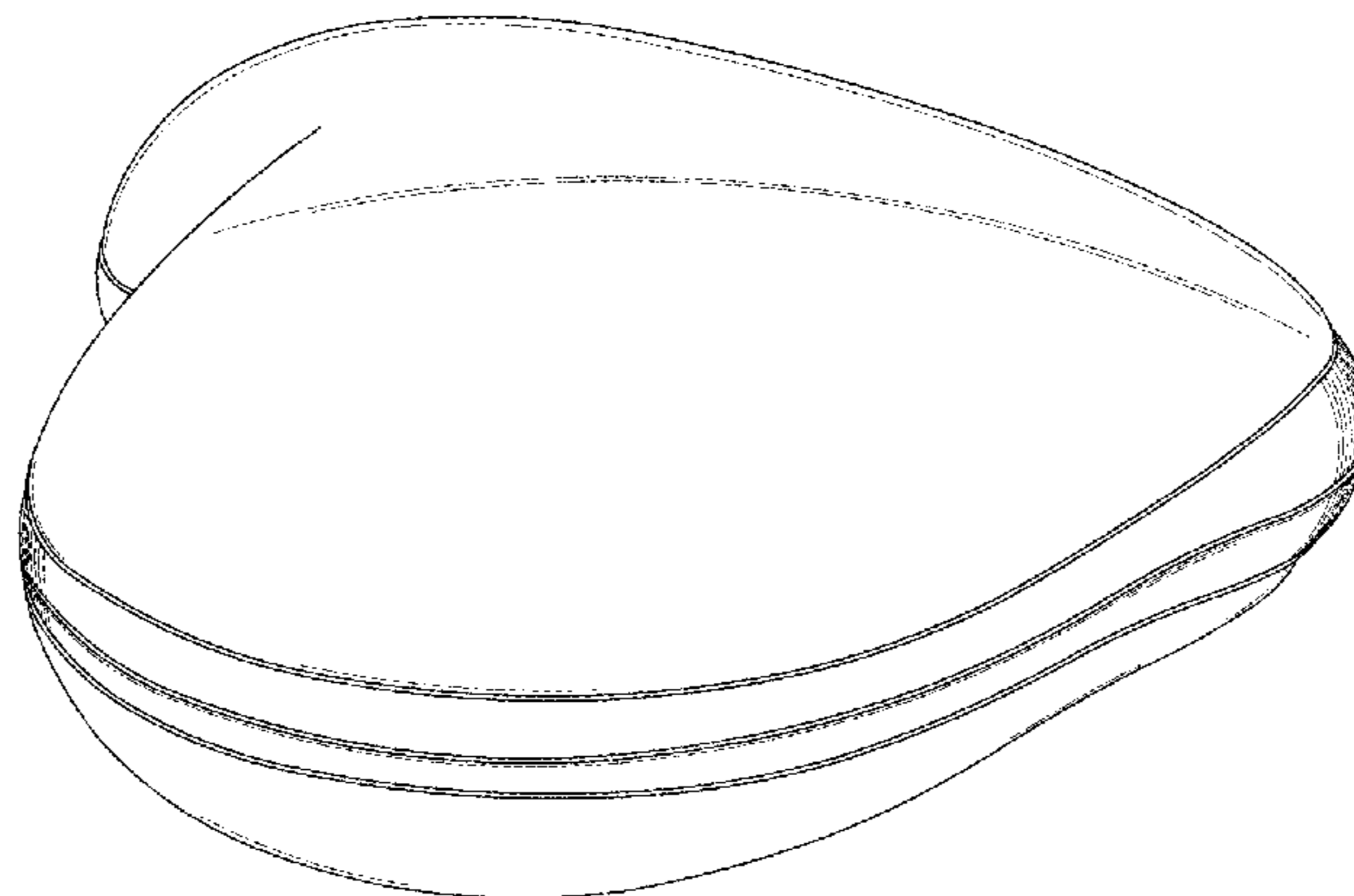
(57) **CLAIM**

The ornamental design for a heart shaped vibrator, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view for a heart shaped vibrator showing our new design;
FIG. 2 is a front elevational view thereof;

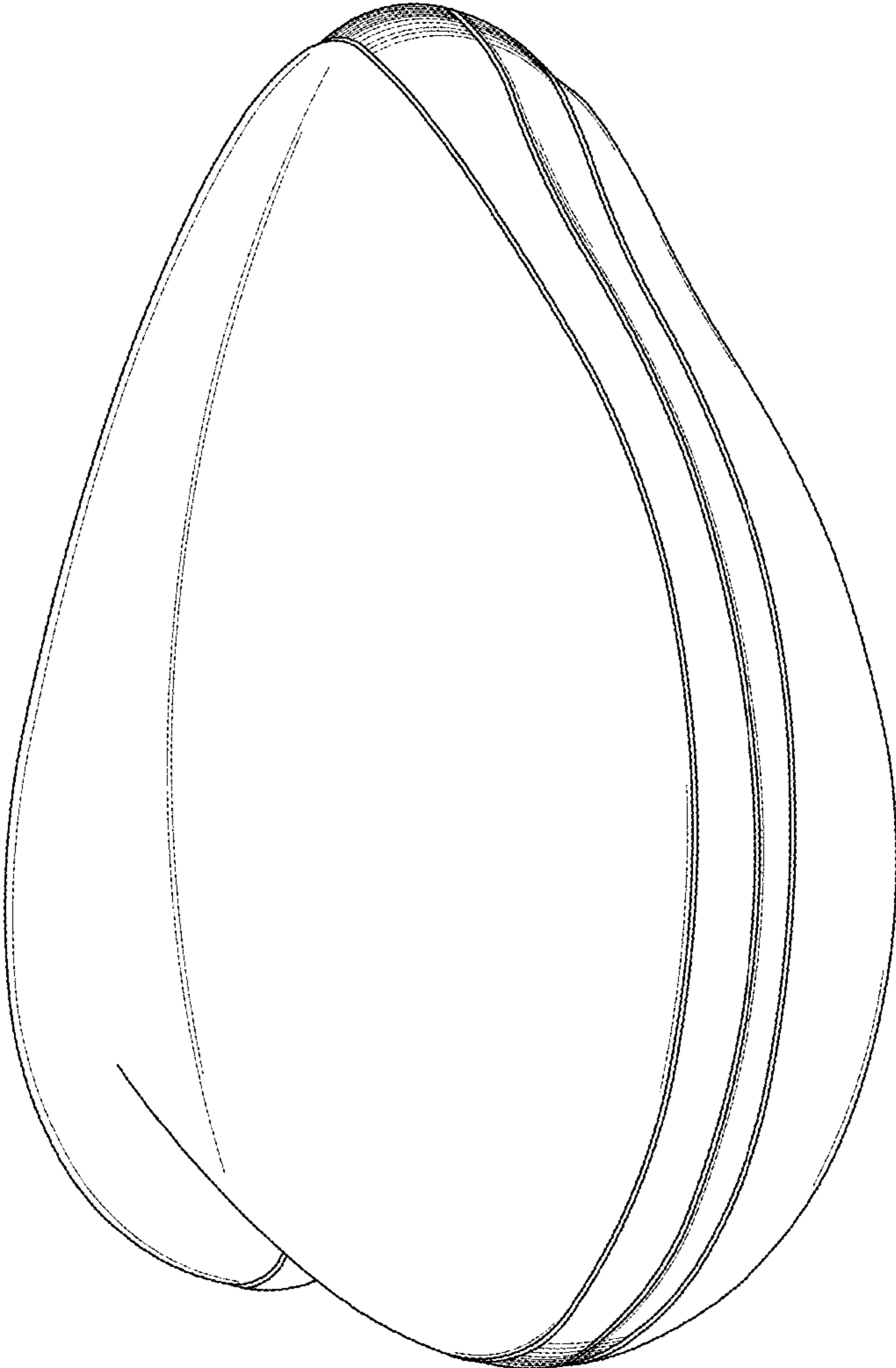

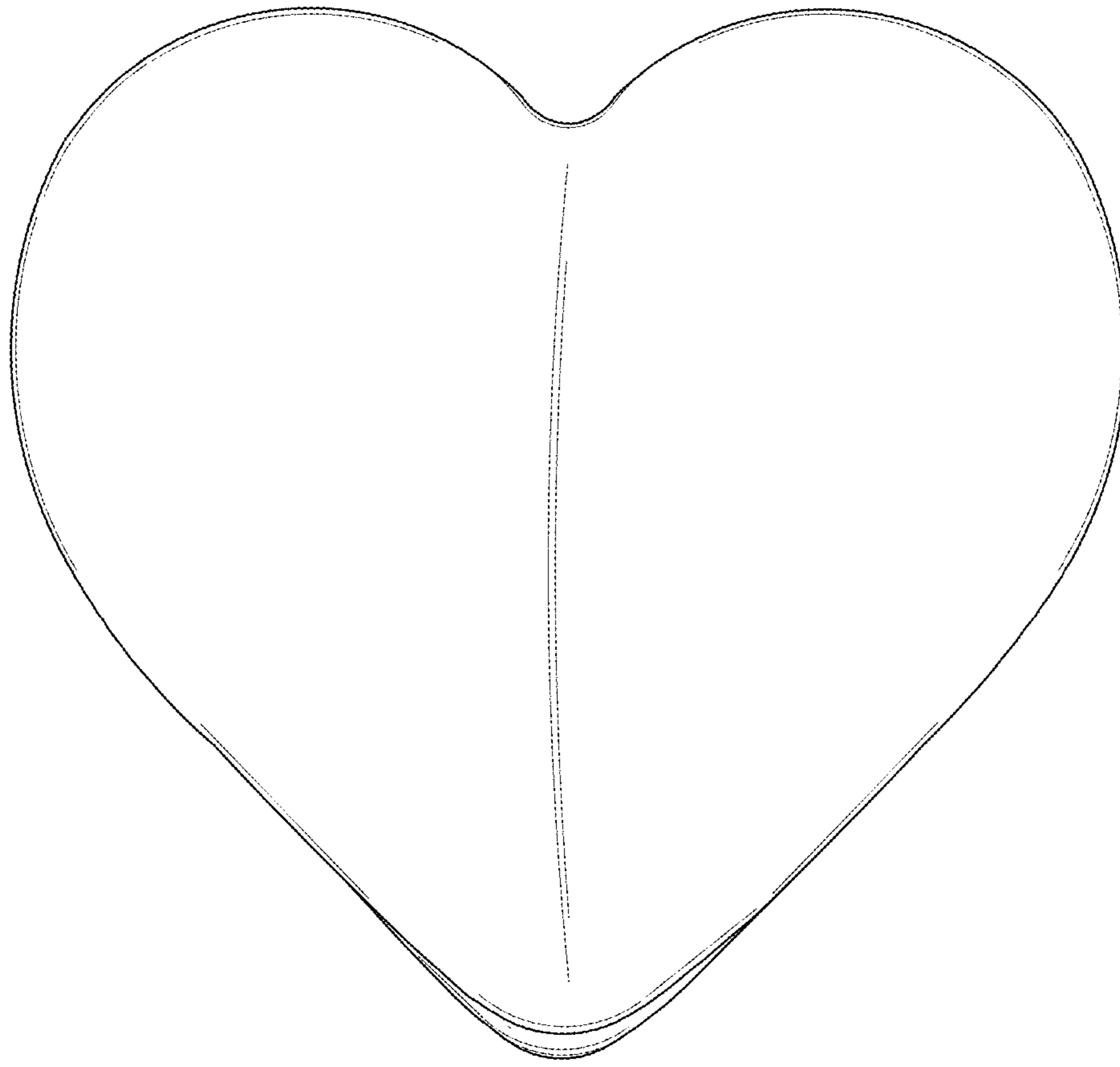

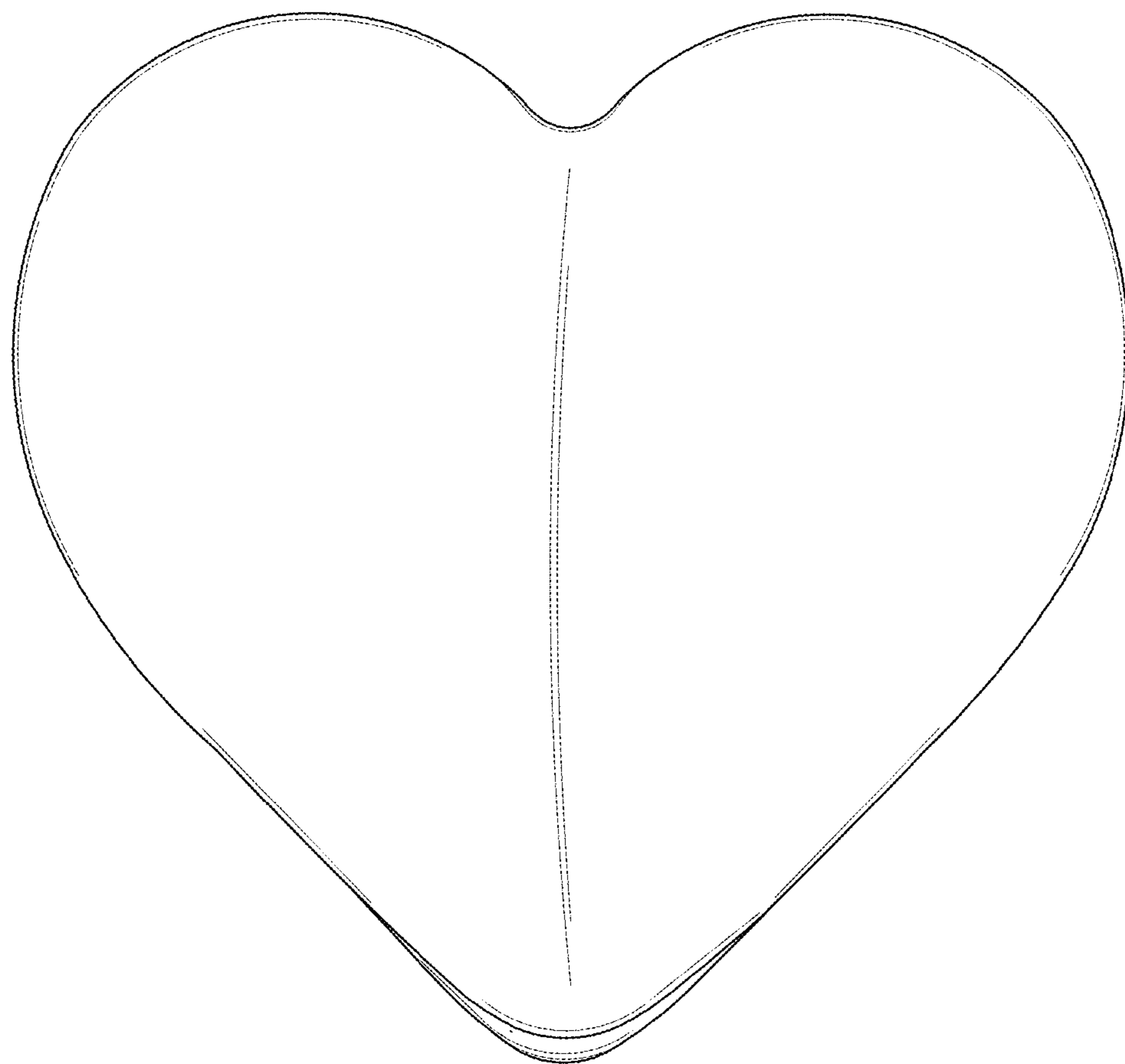

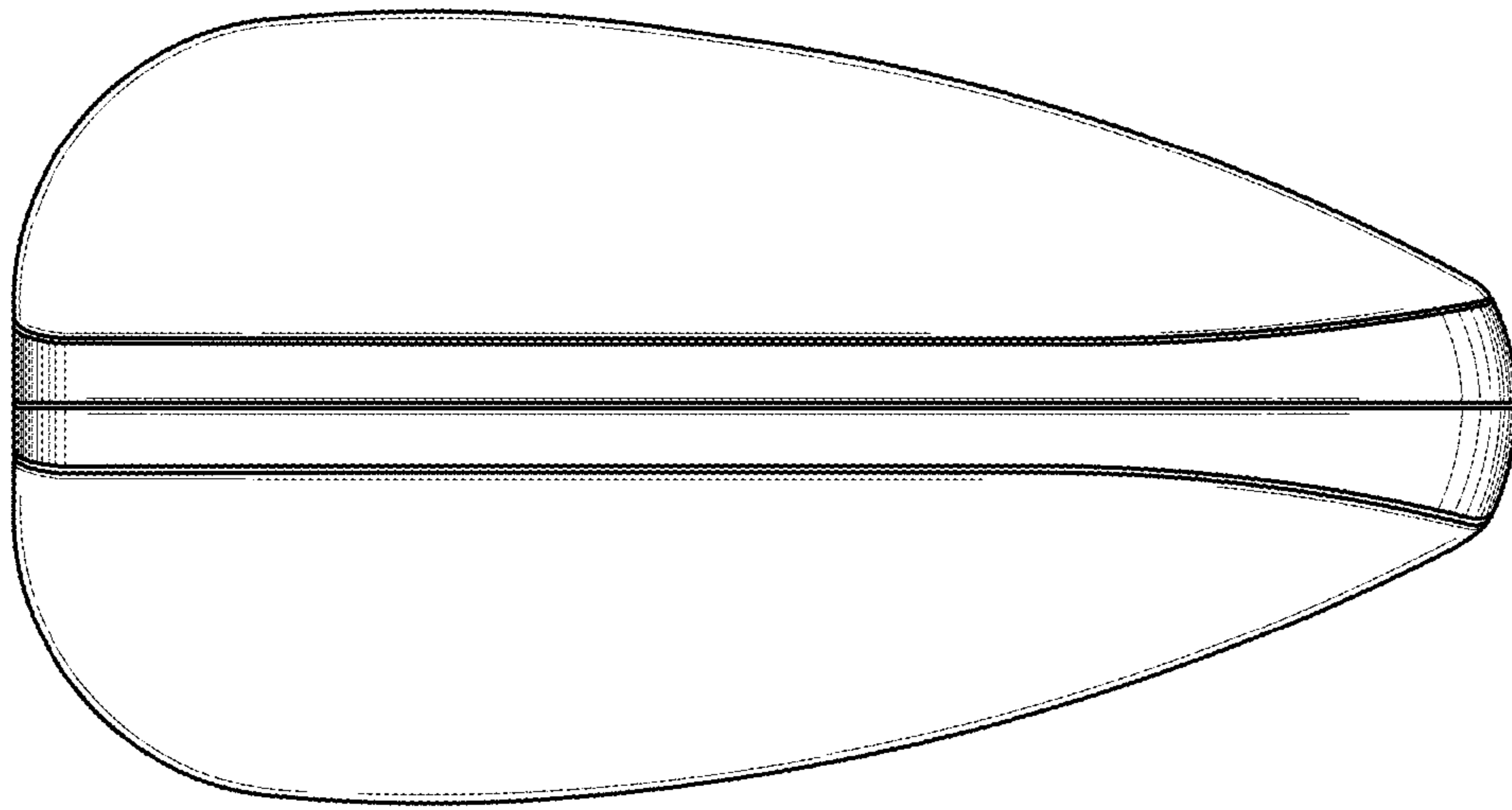

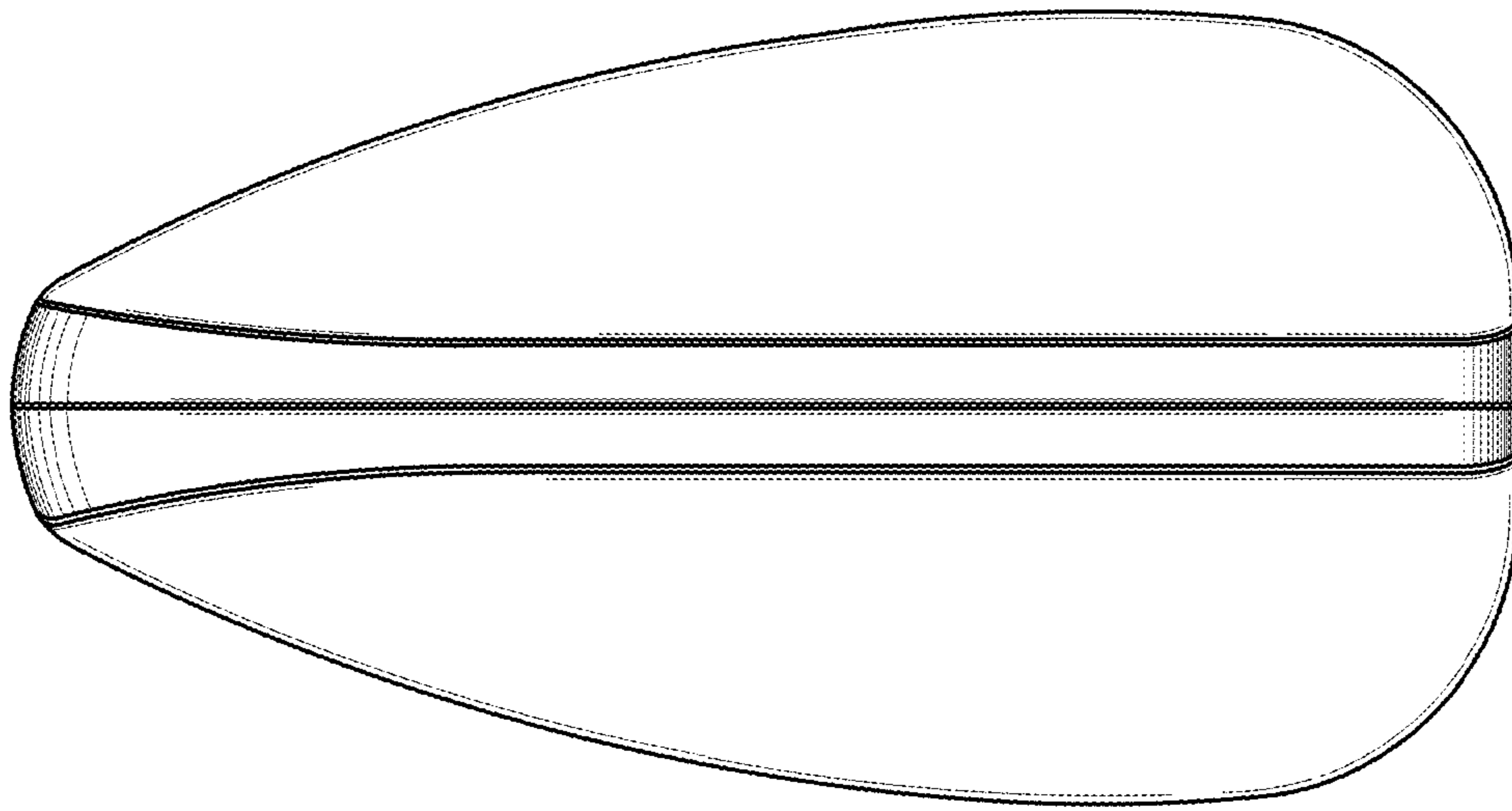

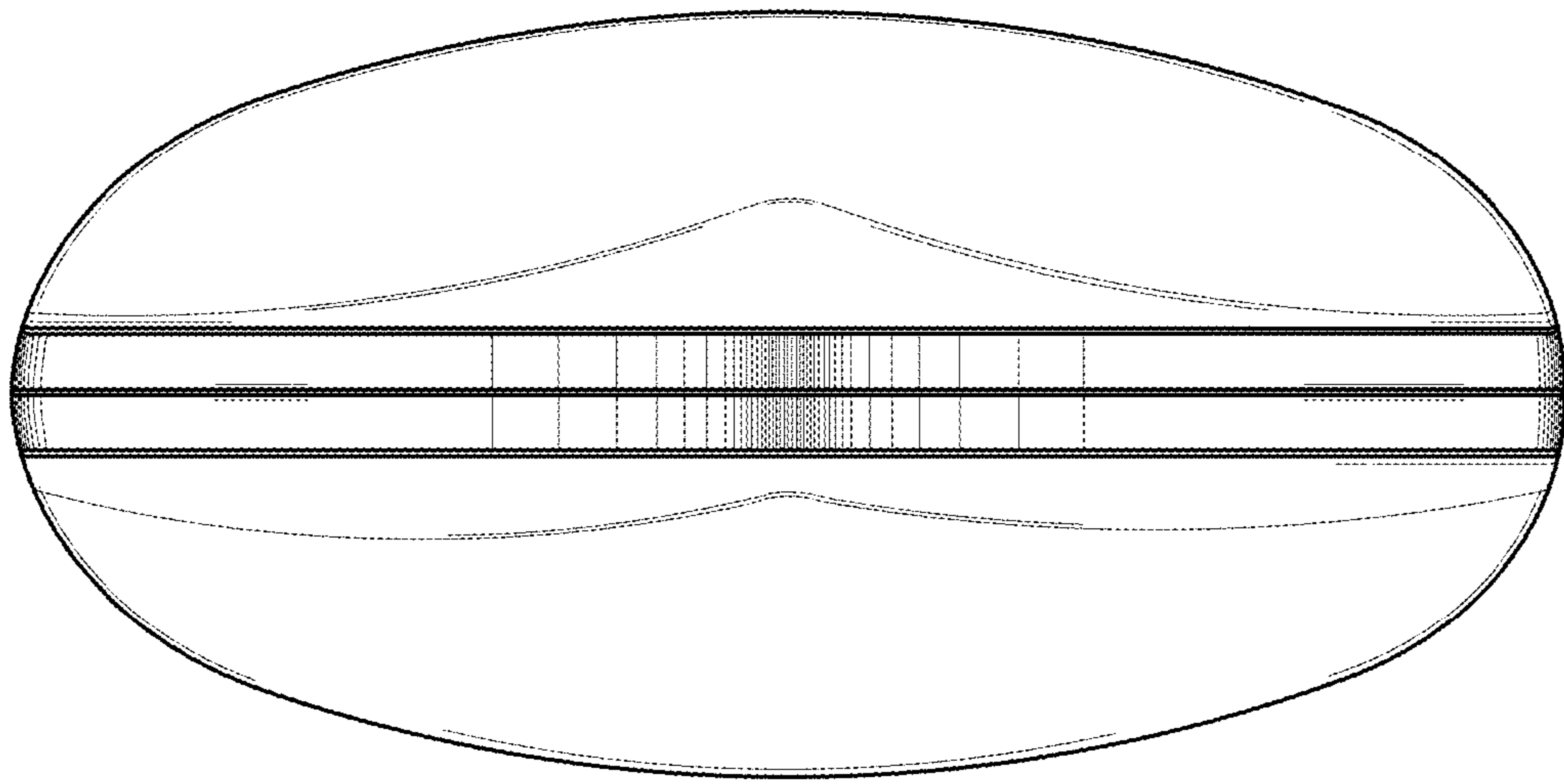

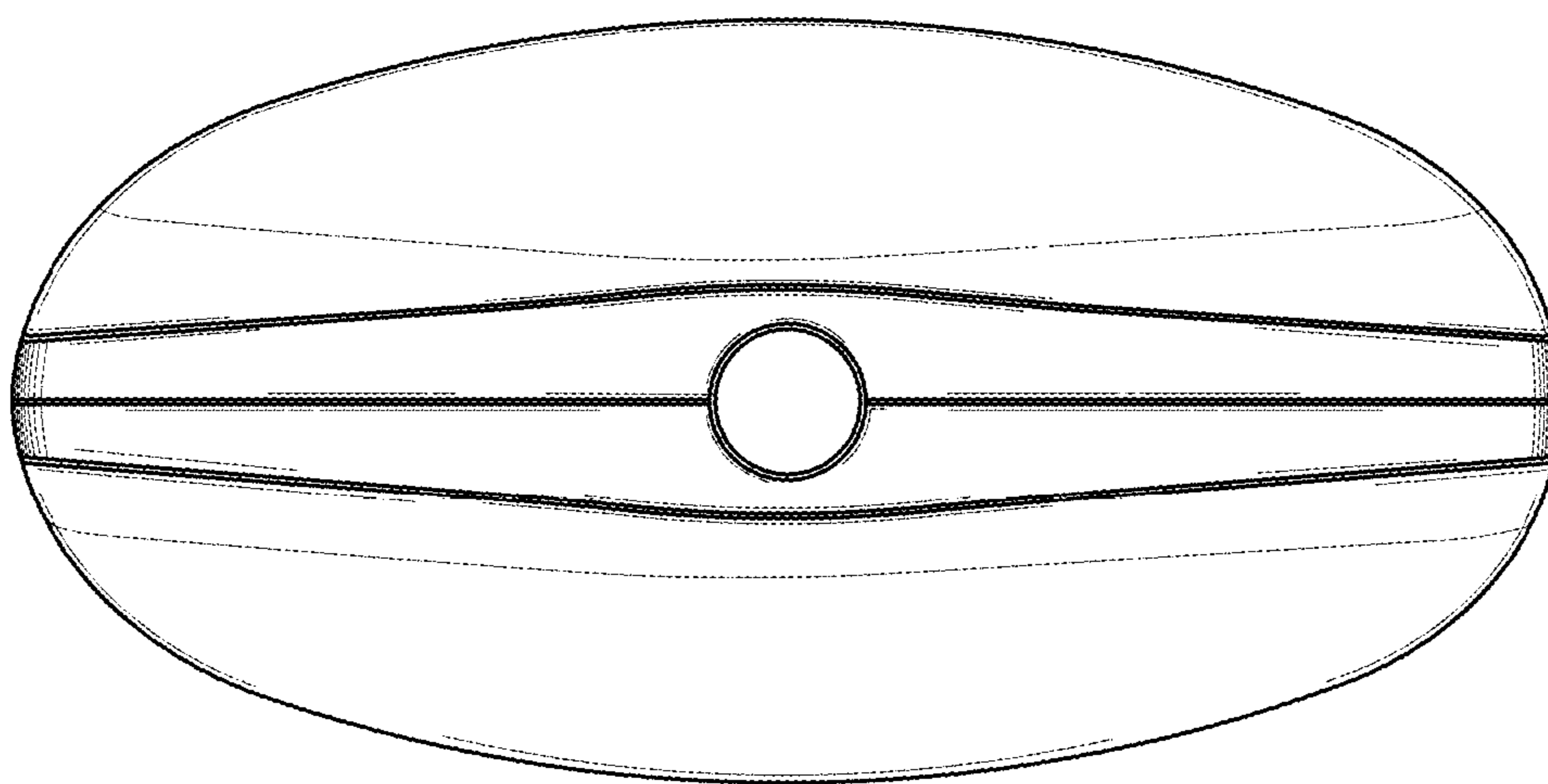
