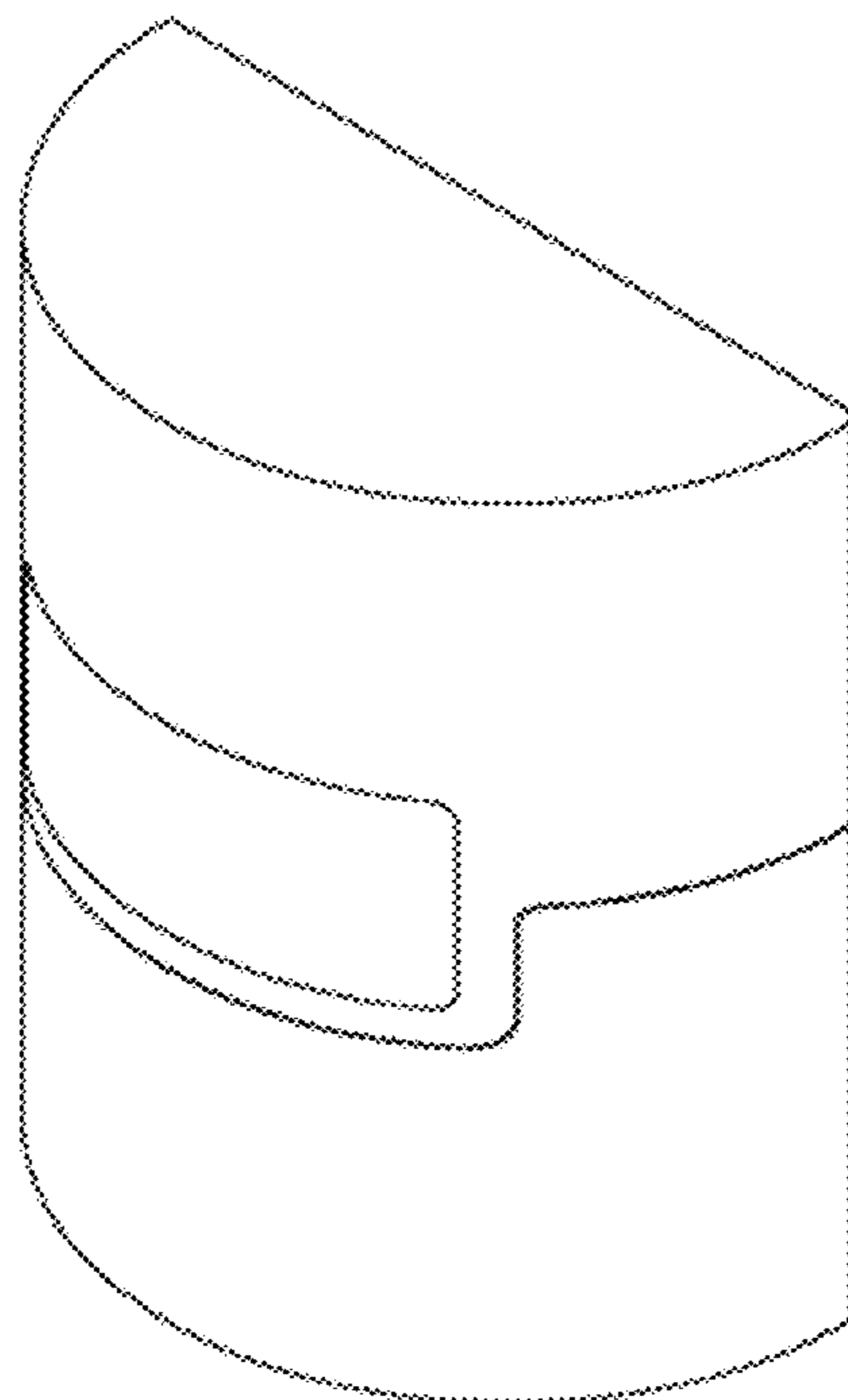

DESCRIPTION

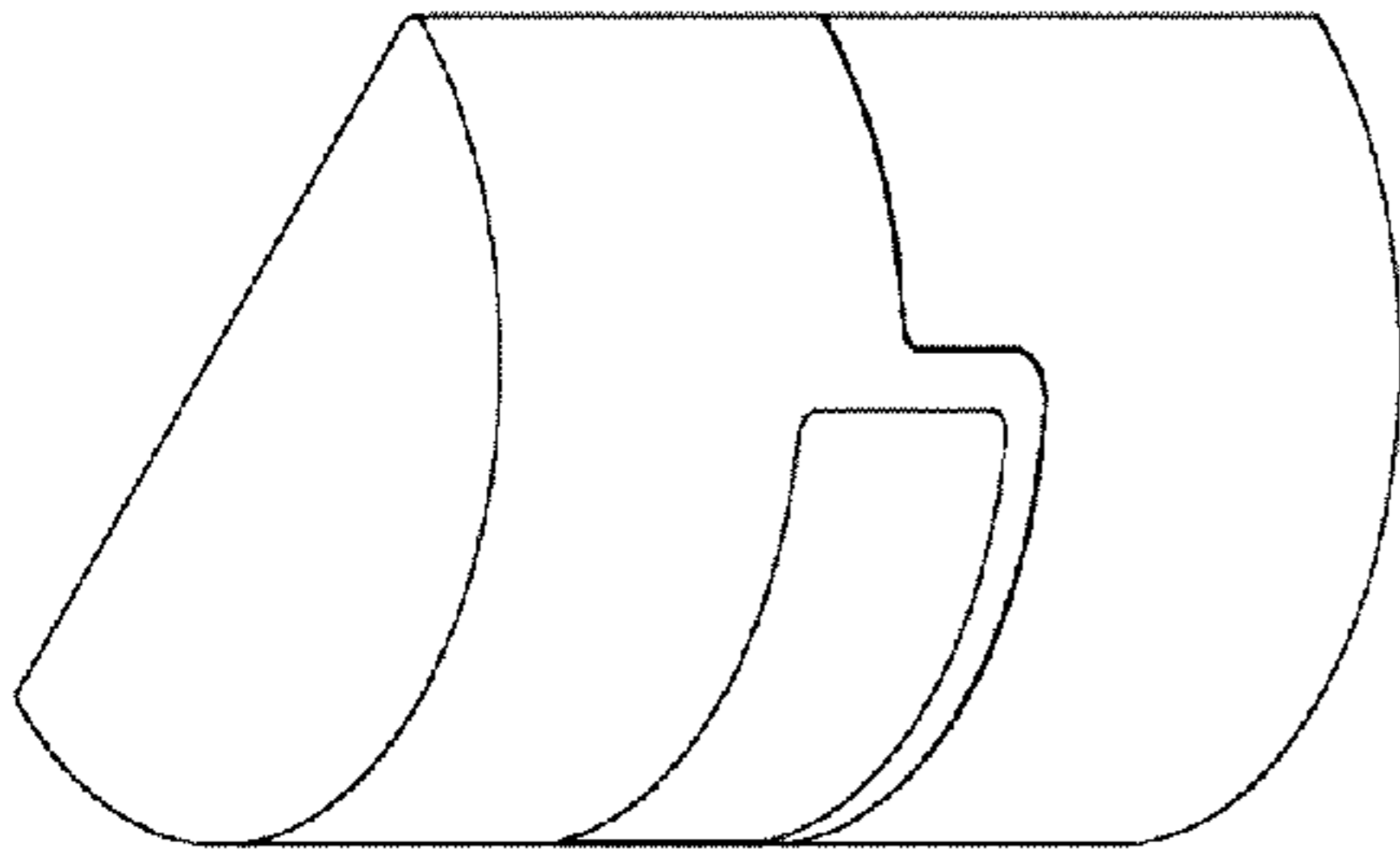

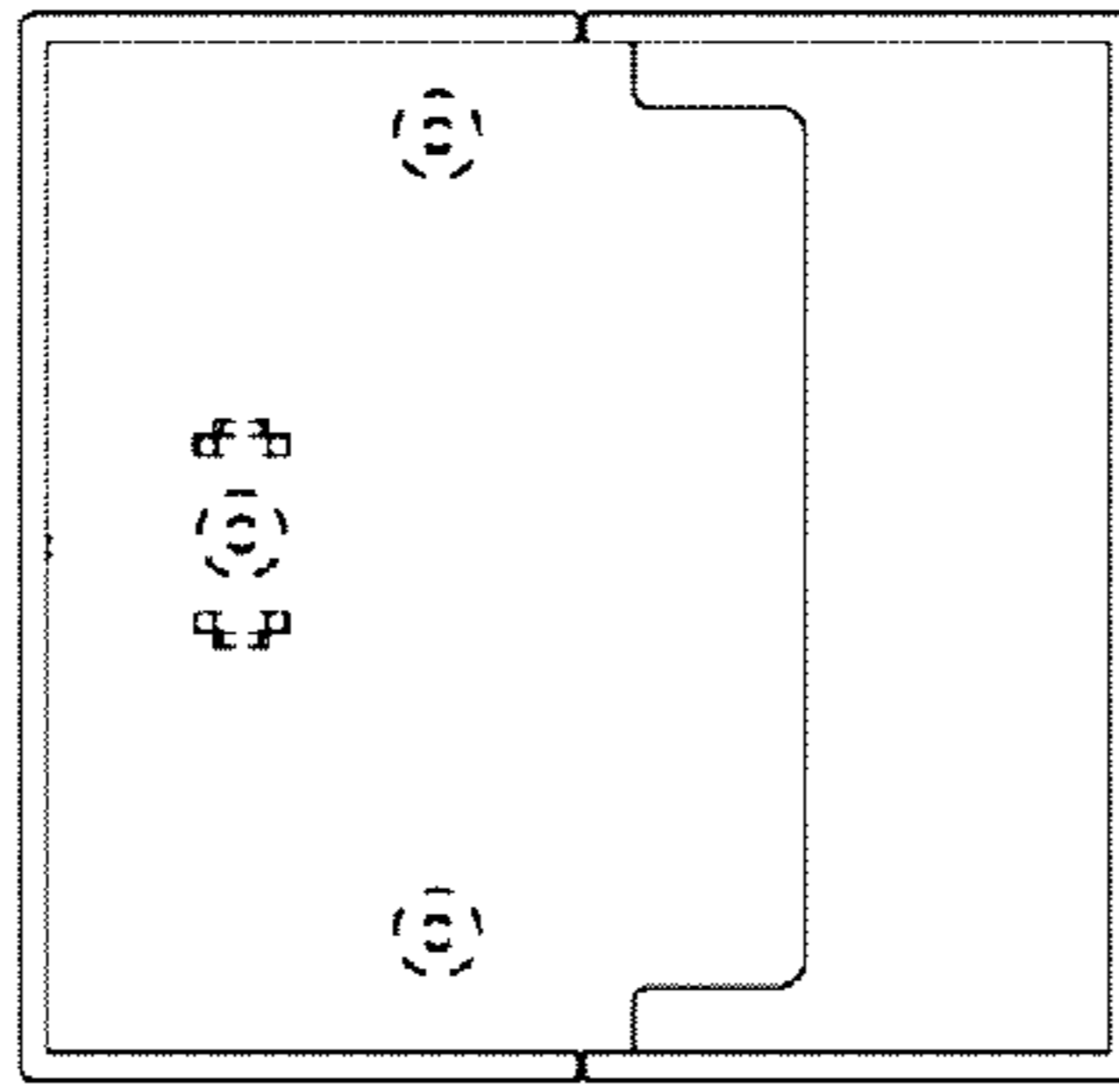

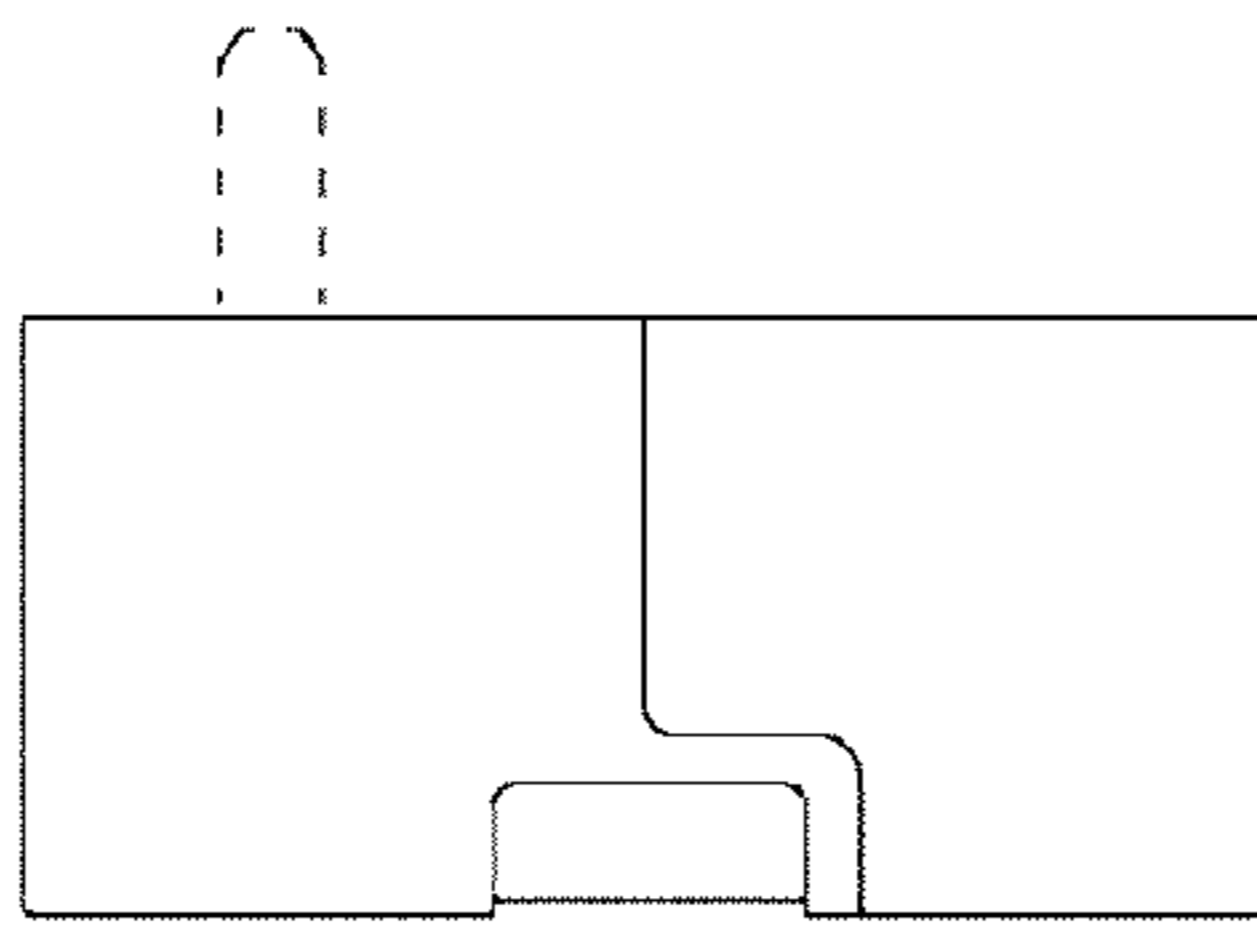

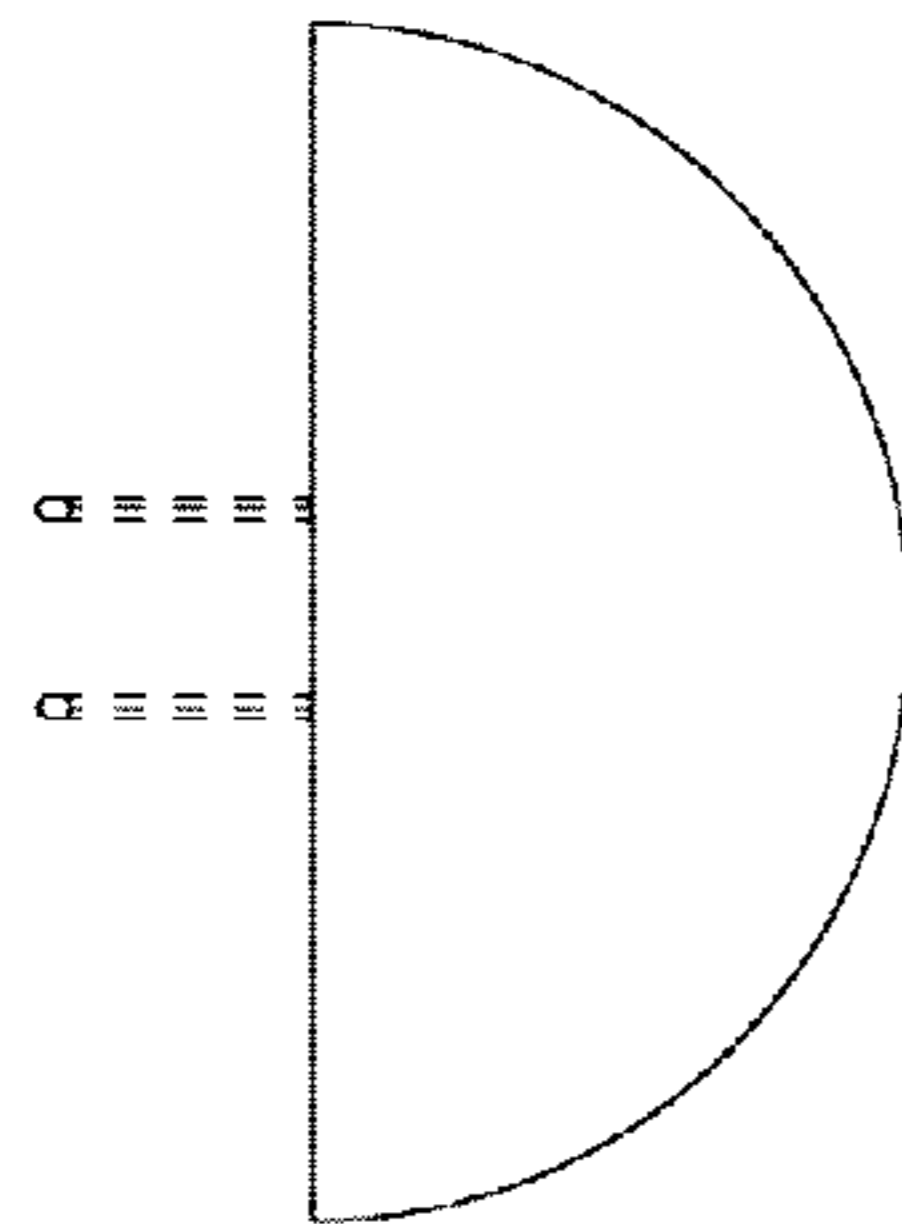

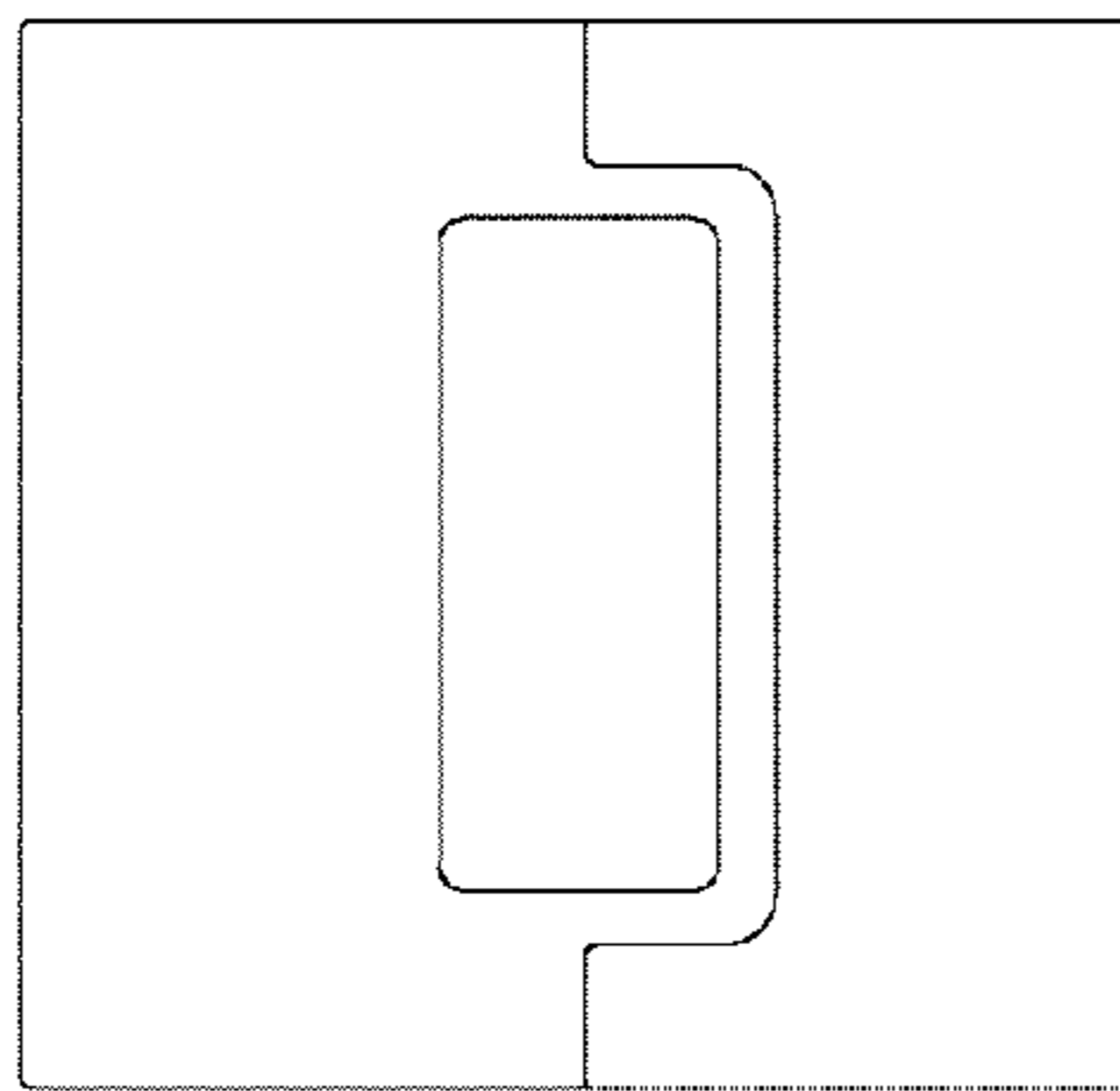

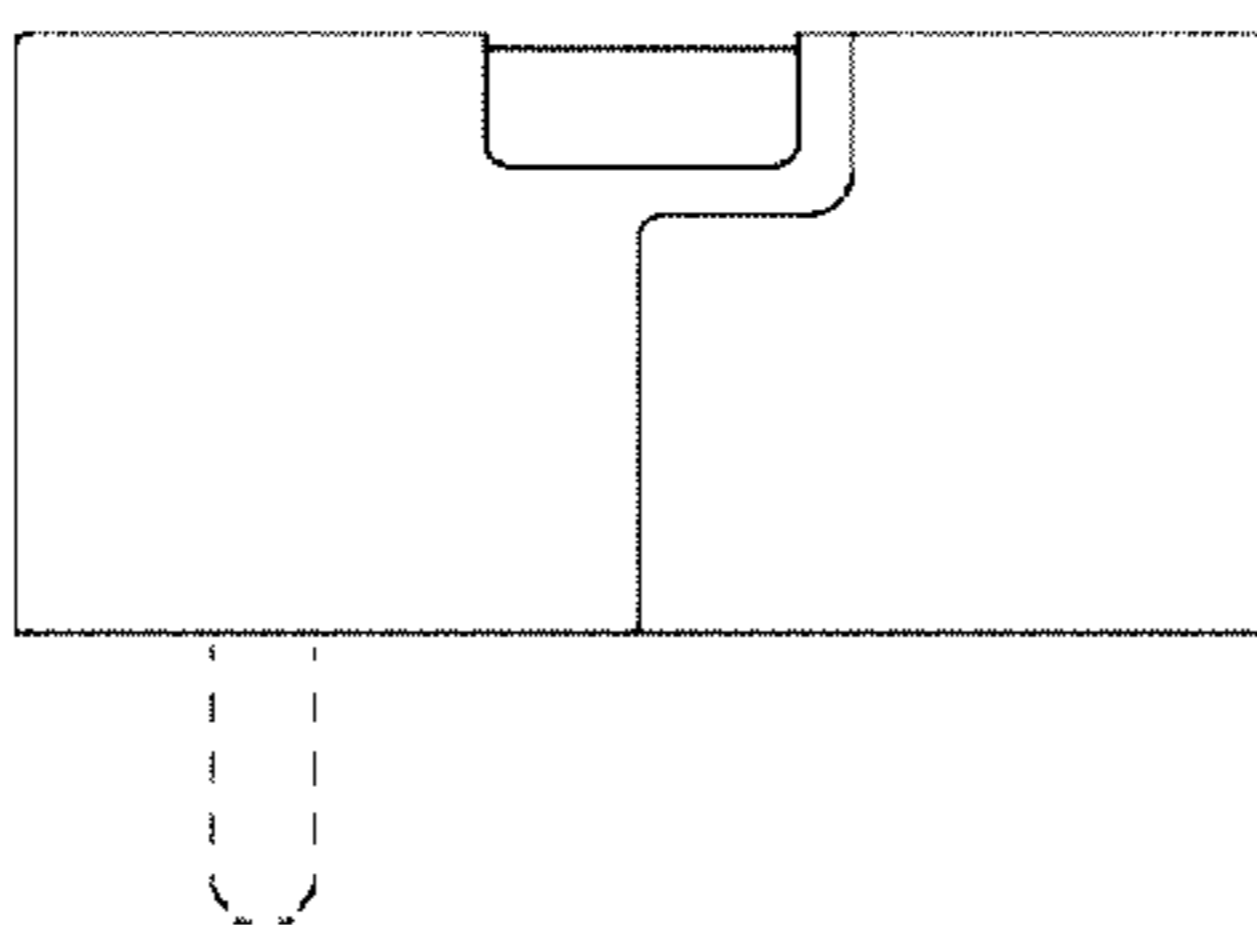

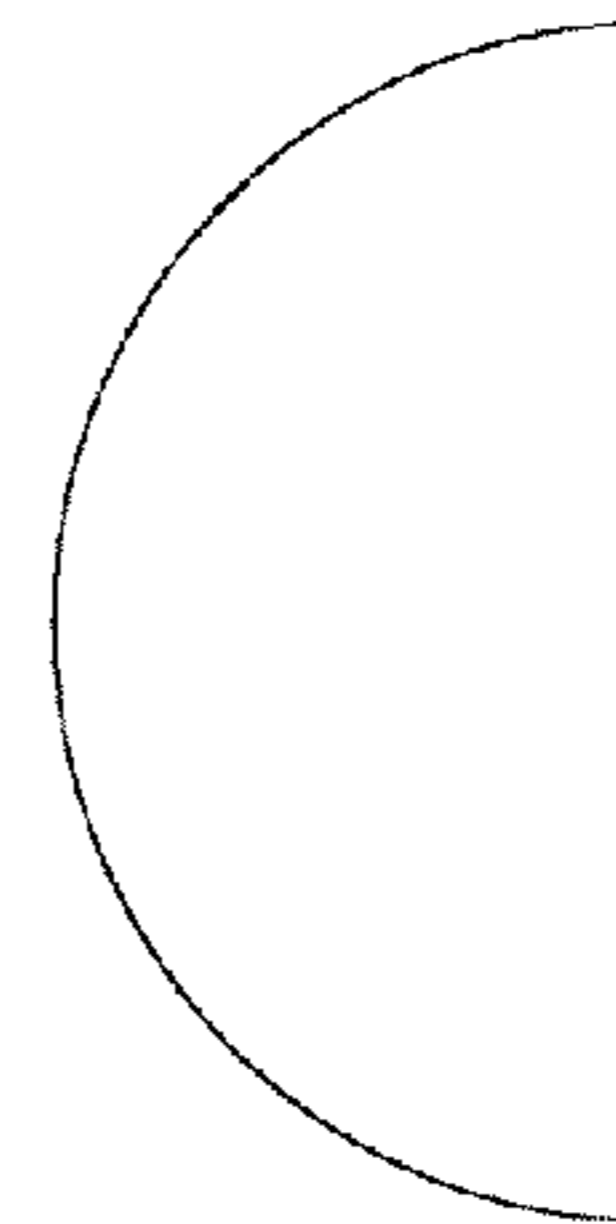
