DESCRIPTION

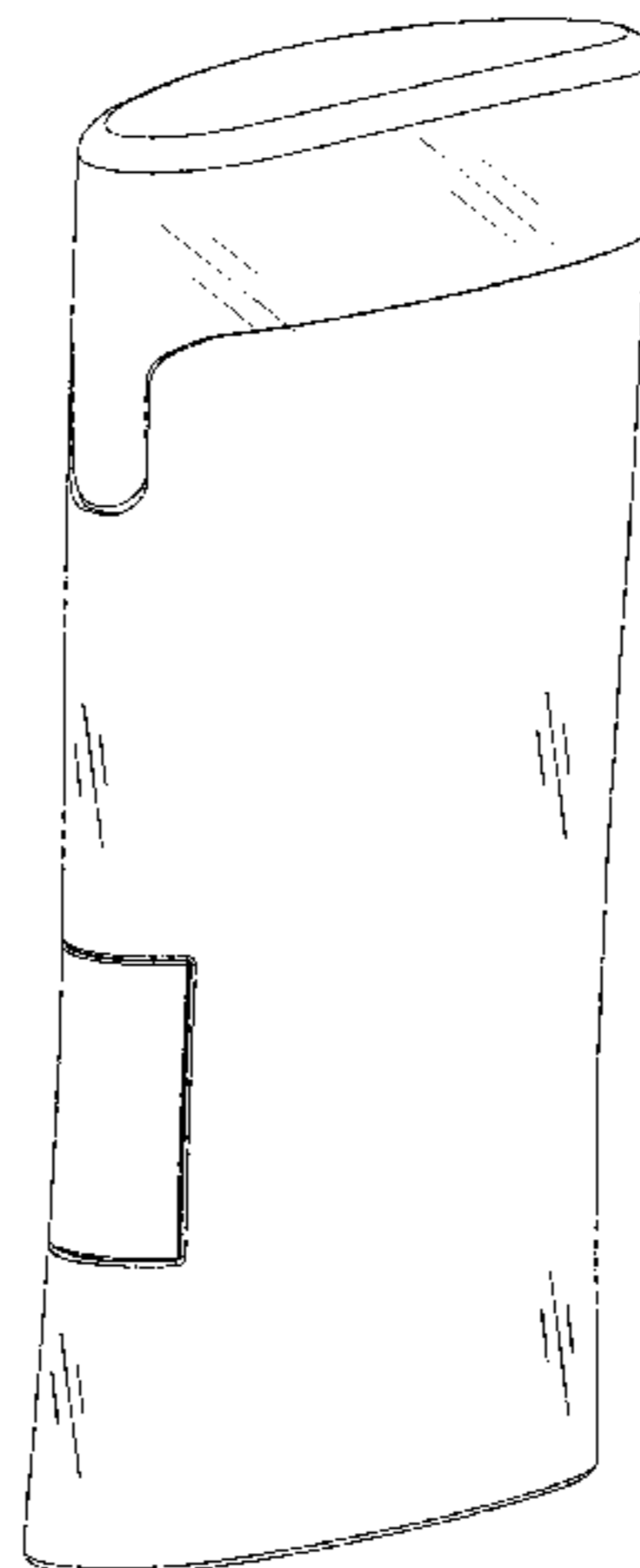
FIG. 1 is a perspective view of an E-cigarette case showing my new design.

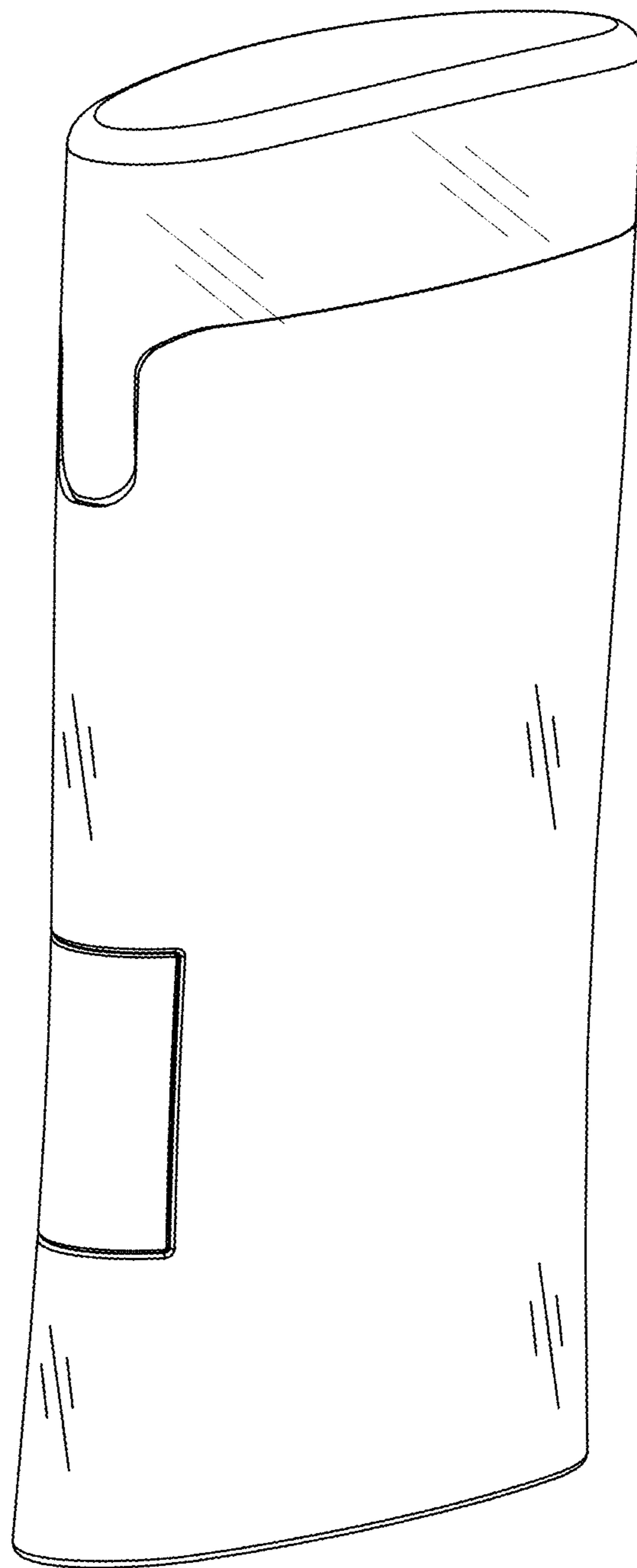

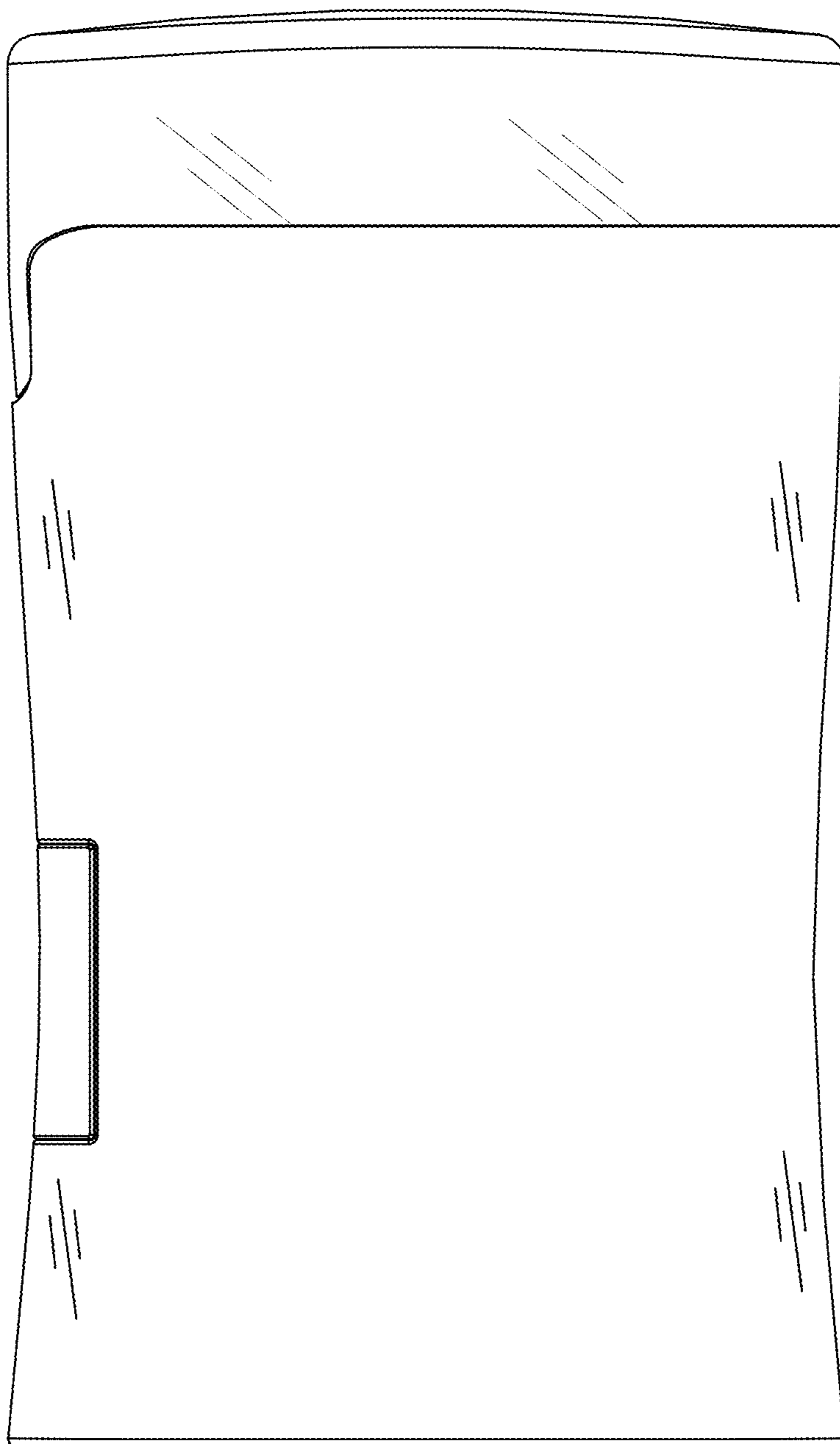

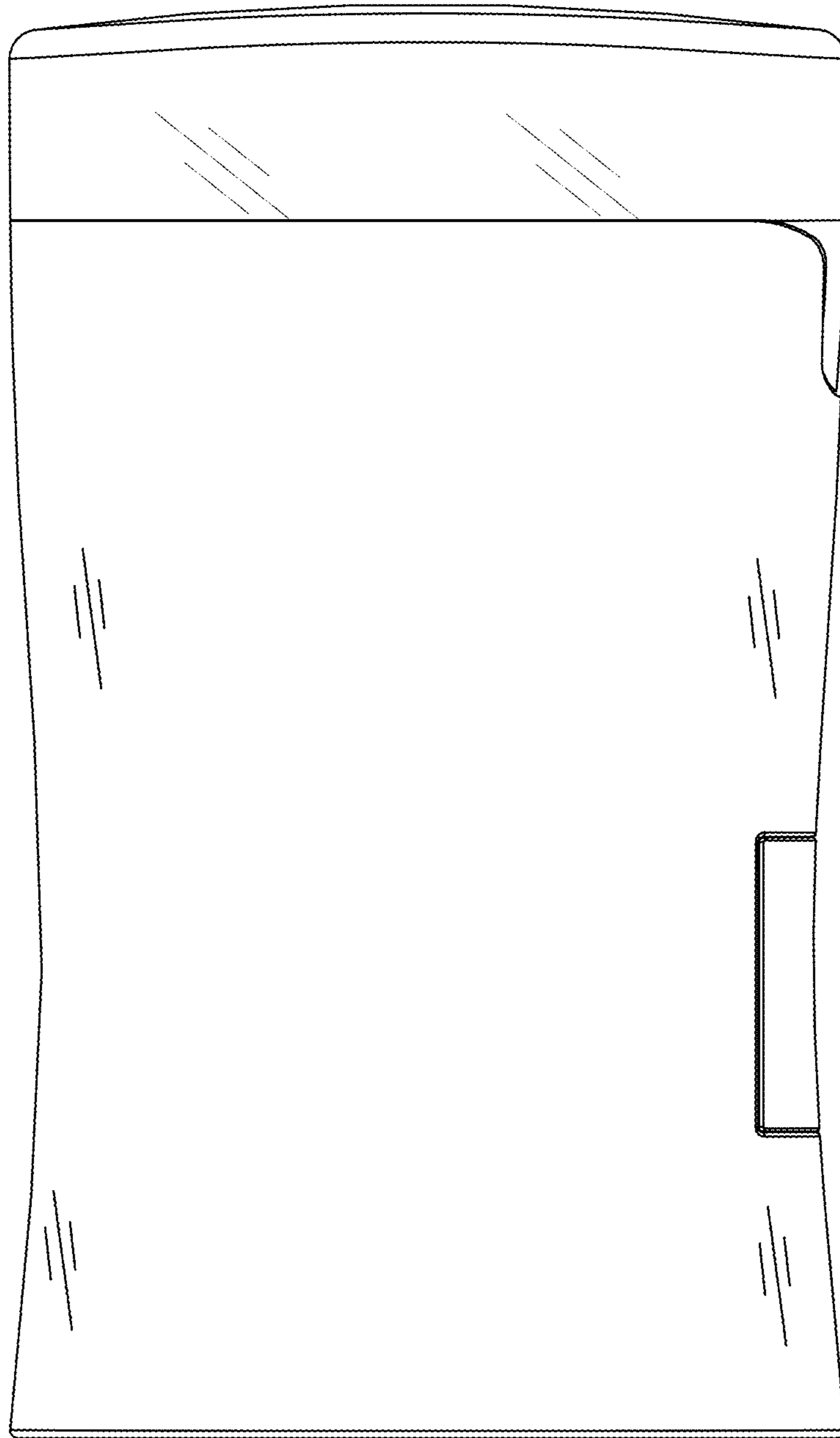

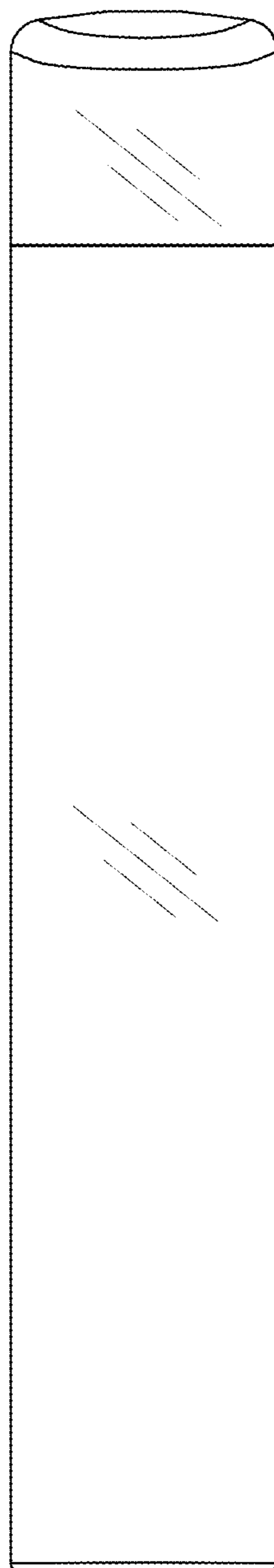

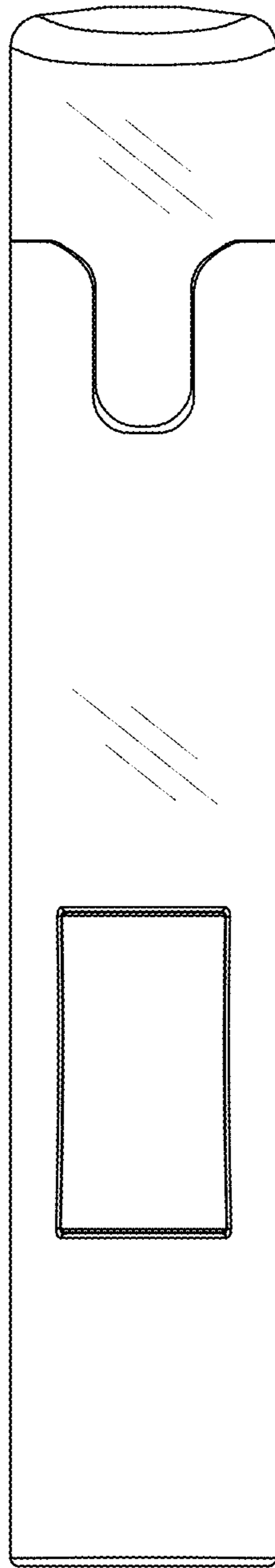

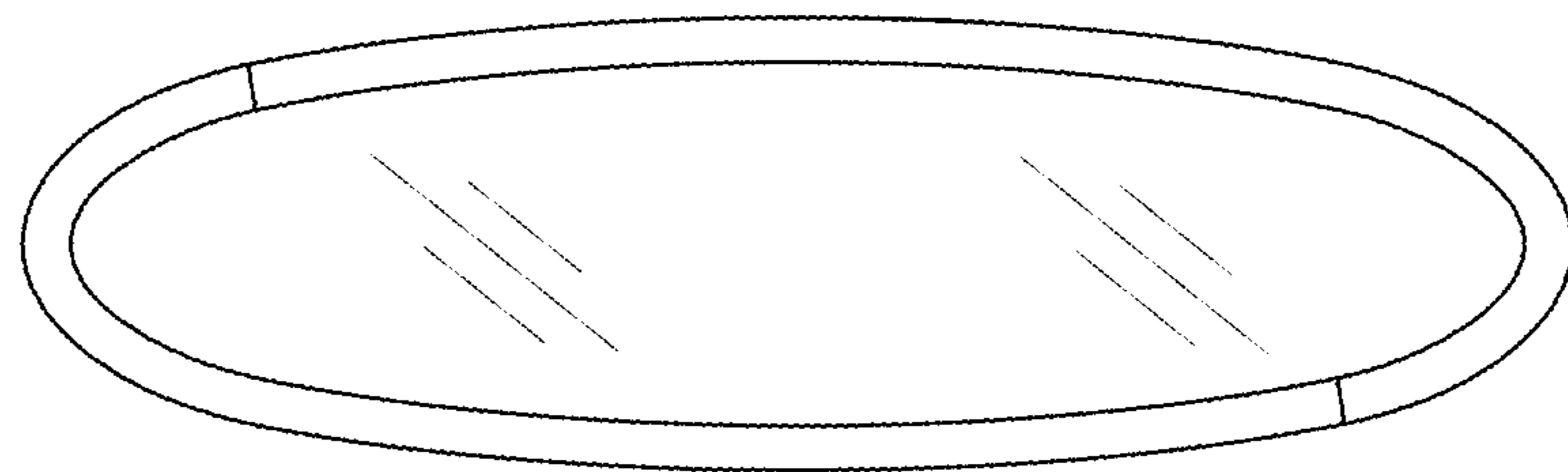

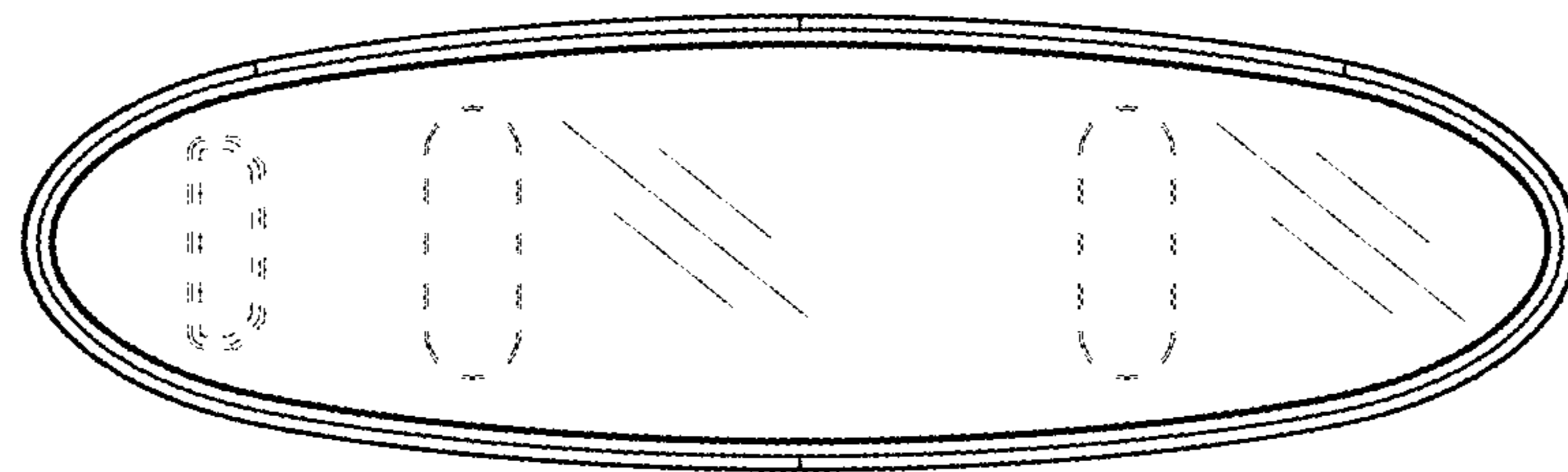

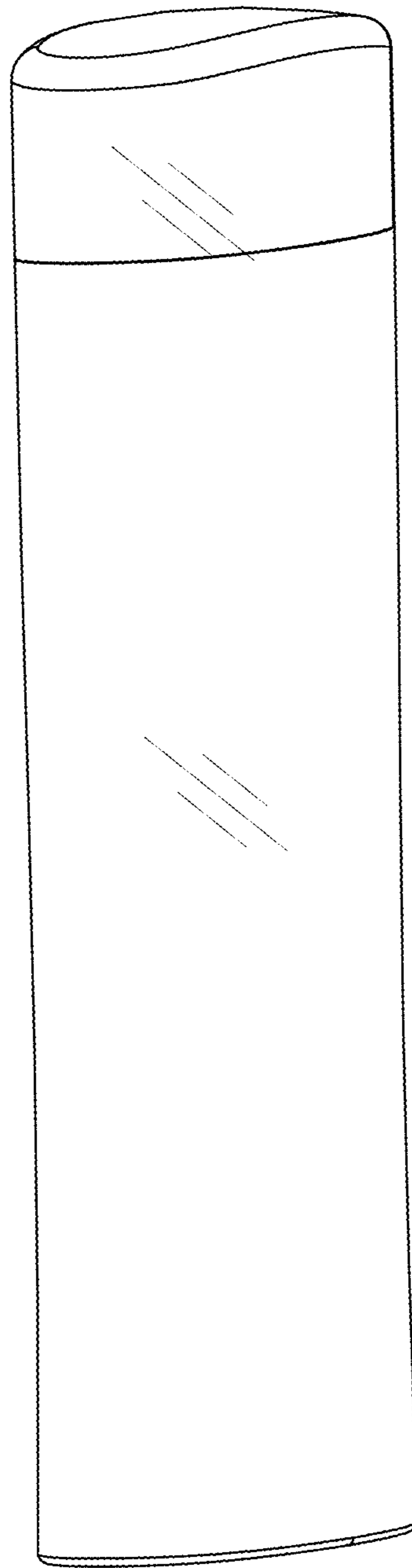

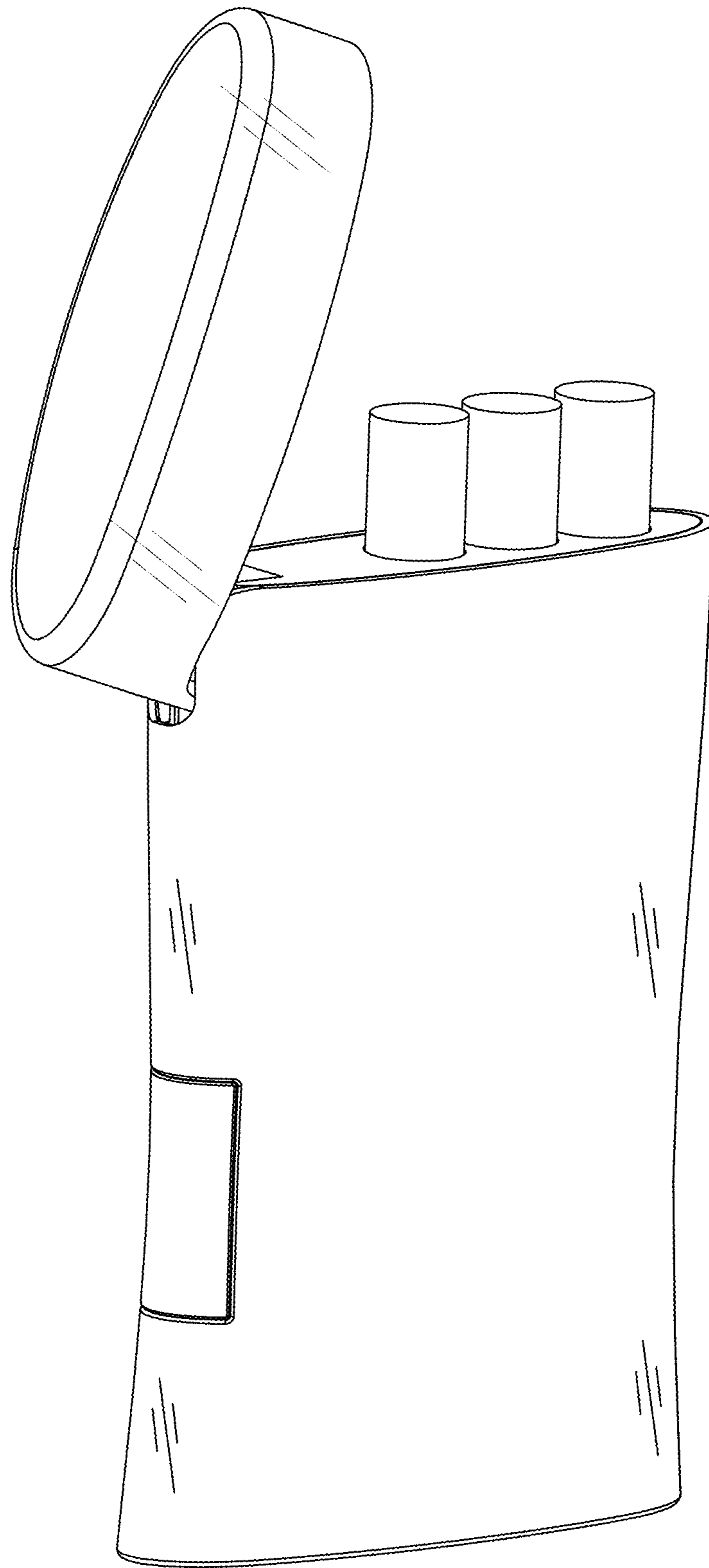

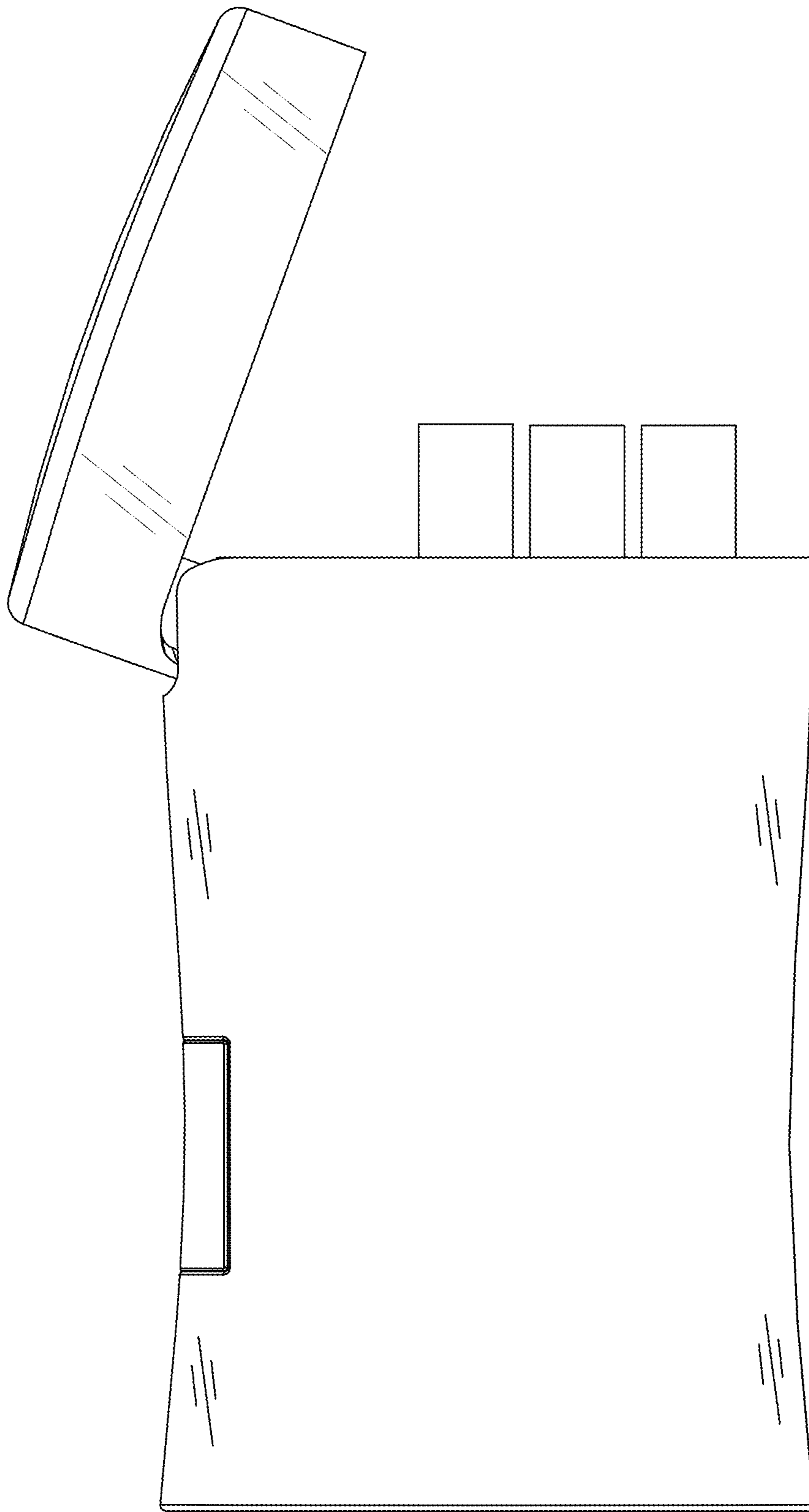

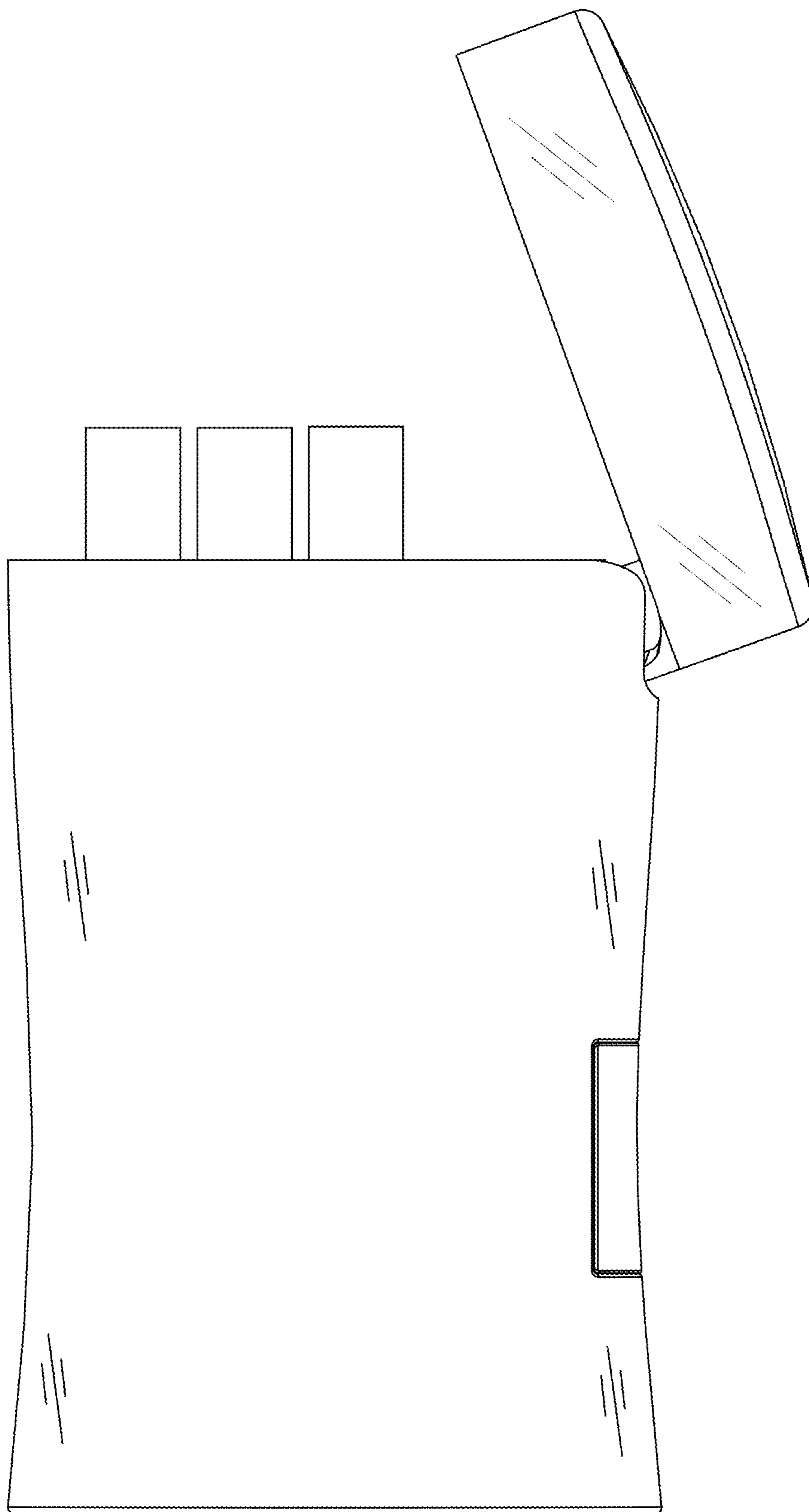

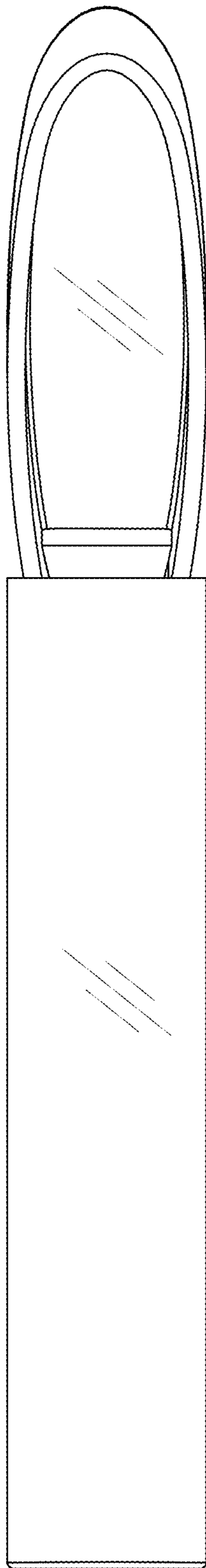

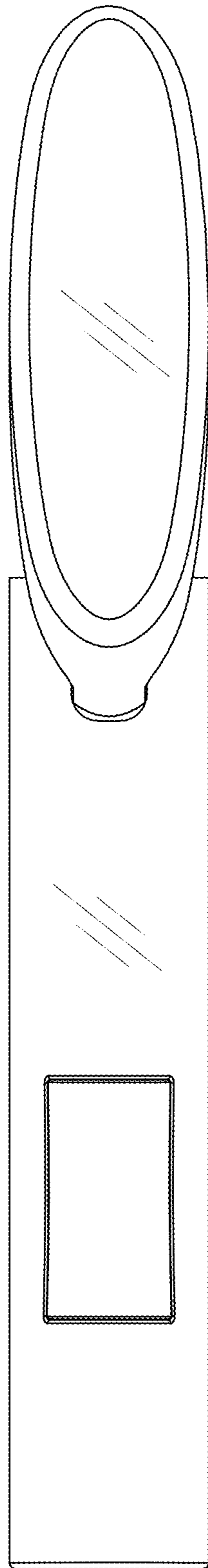

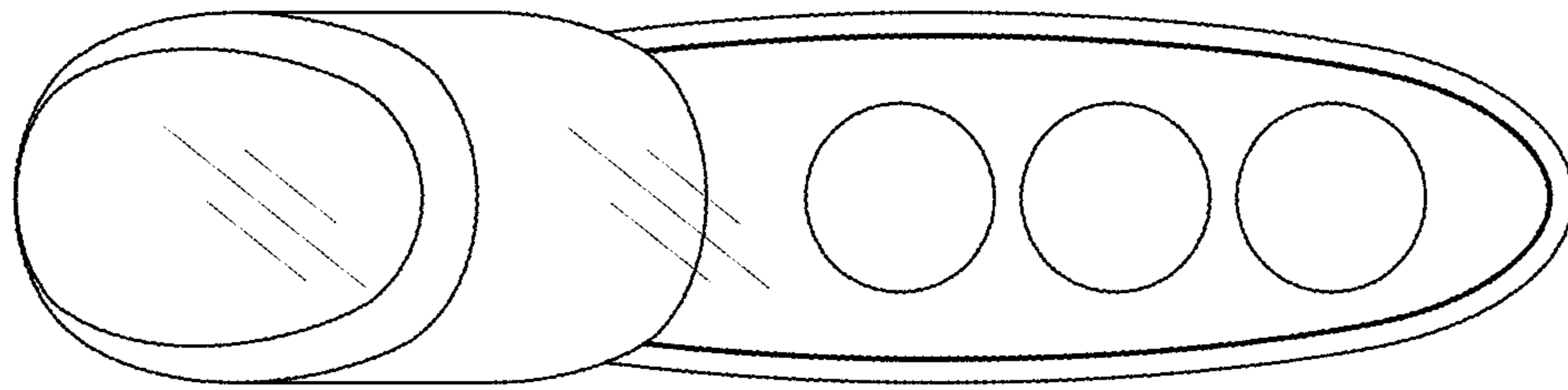

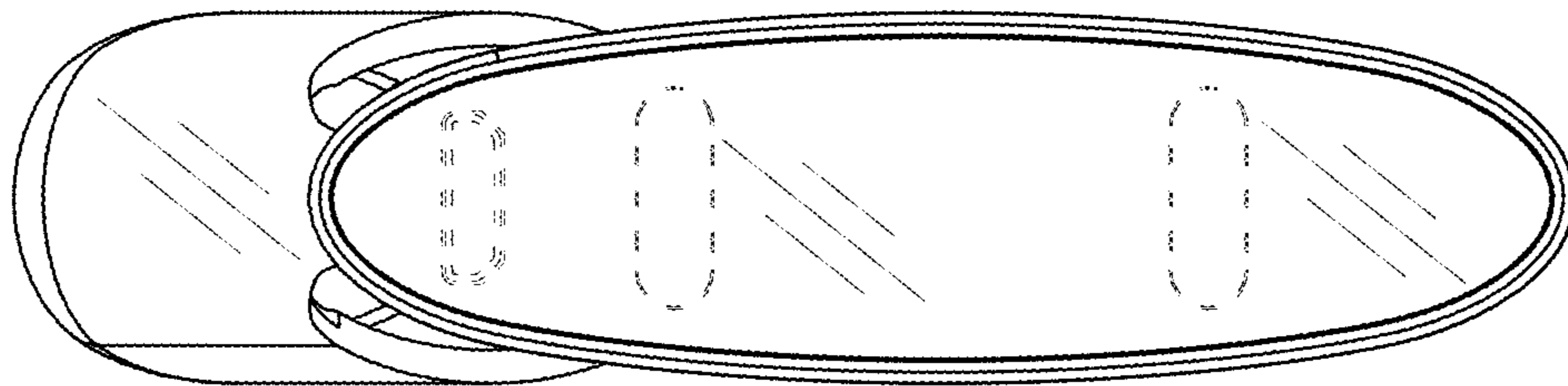

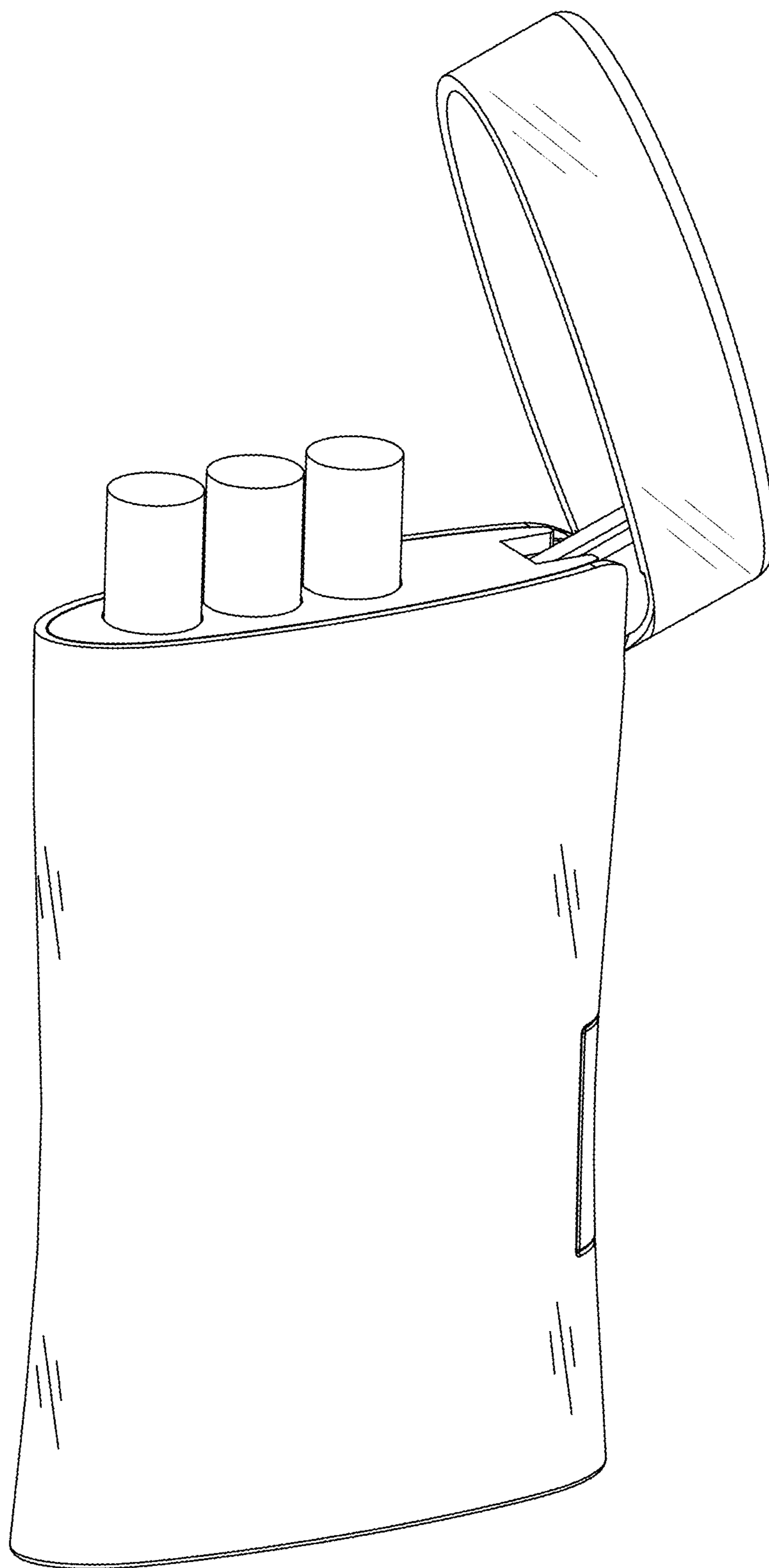
