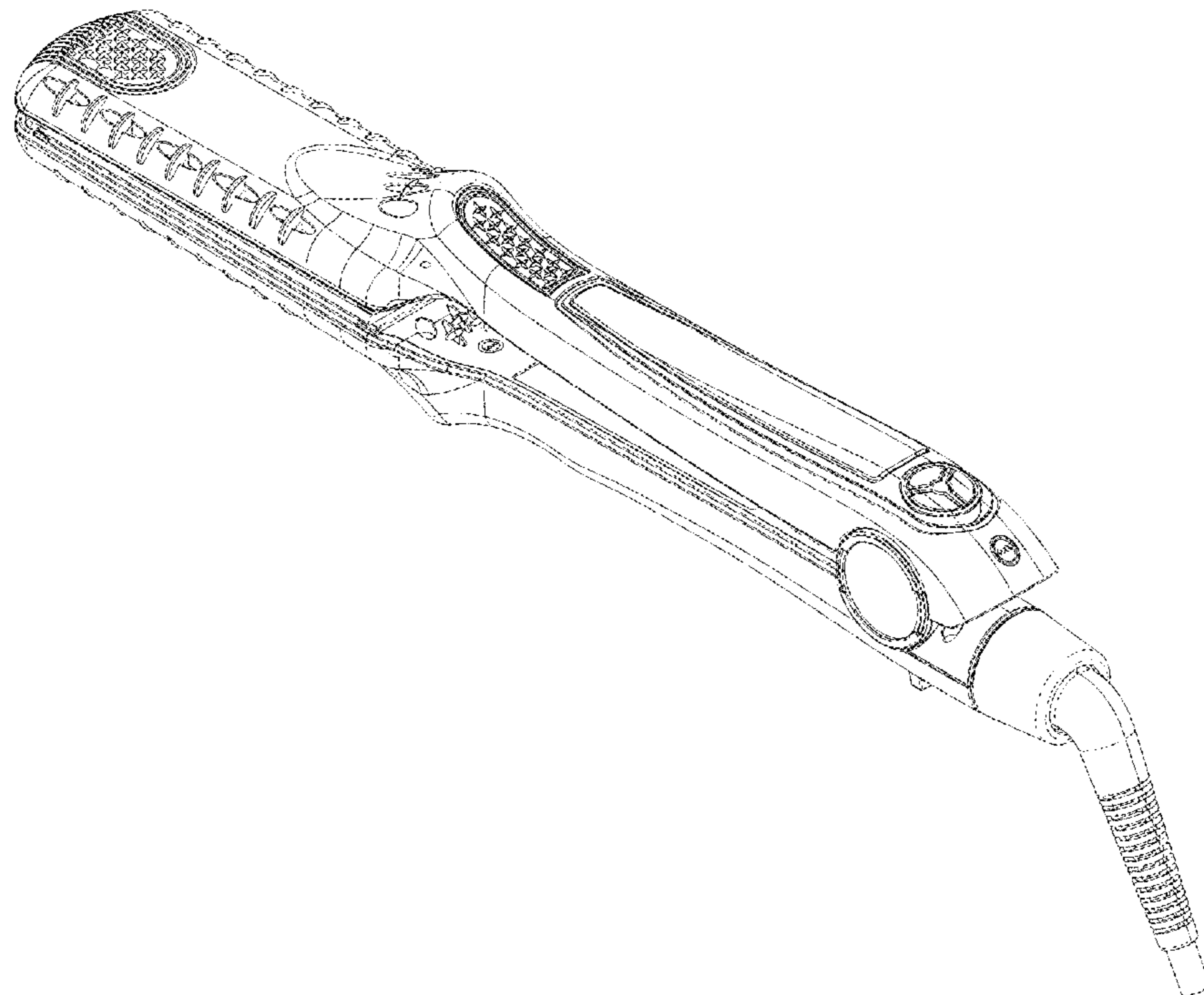
(57) **CLAIM**

The ornamental design for an electronic hair iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top view of an embodiment of an electronic hair iron showing the new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a front view thereof;  
FIG. 5 is a frontal perspective bottom view thereof;  
FIG. 6 is a frontal perspective top view thereof;

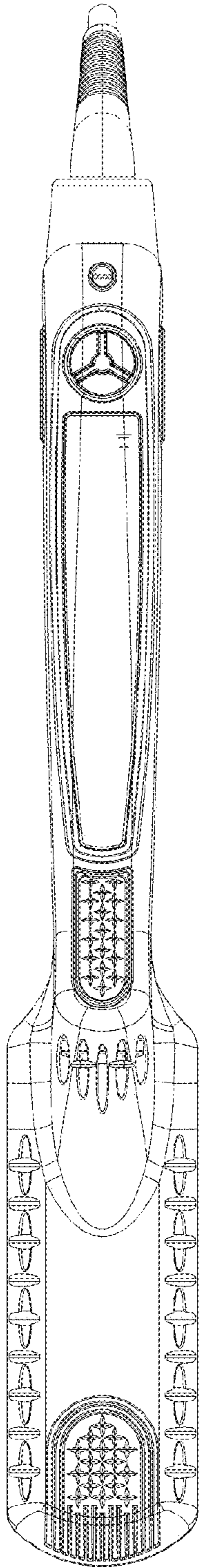

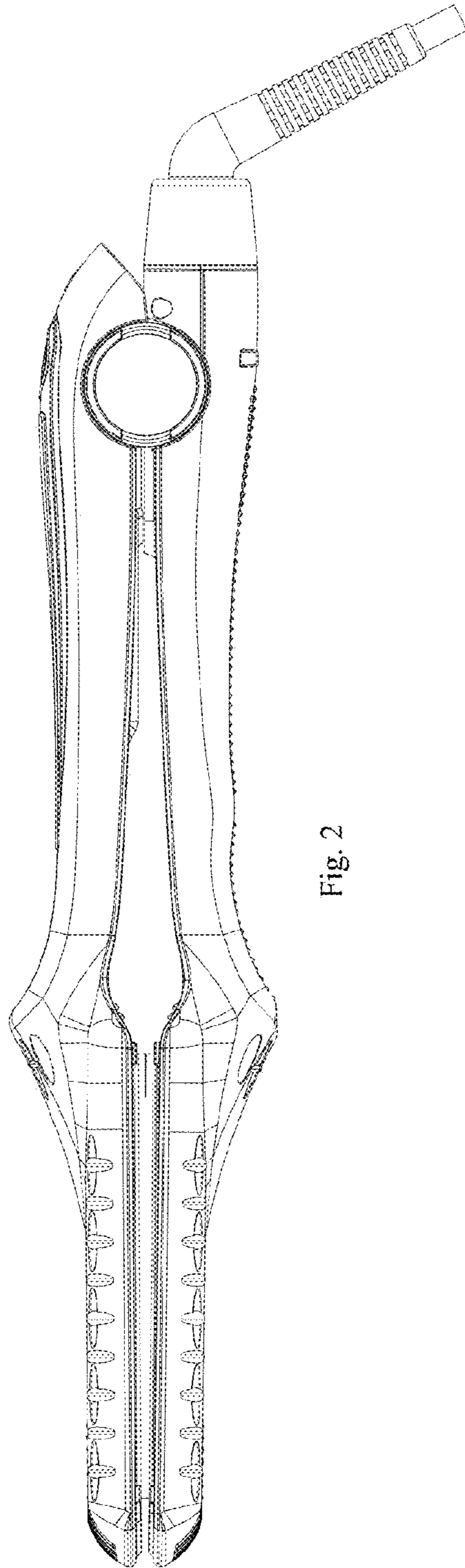

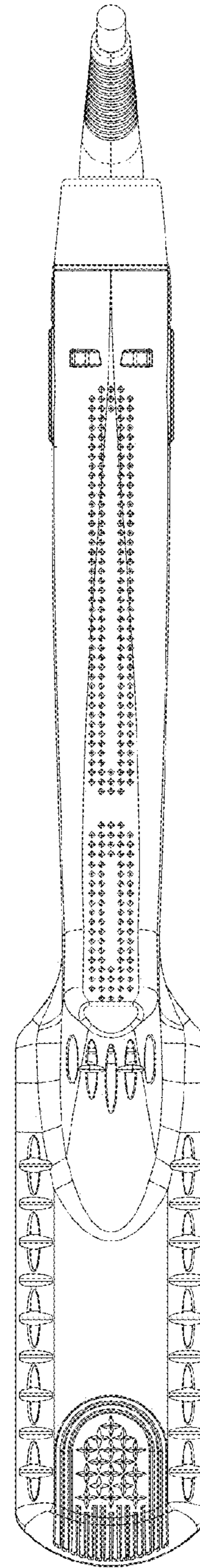

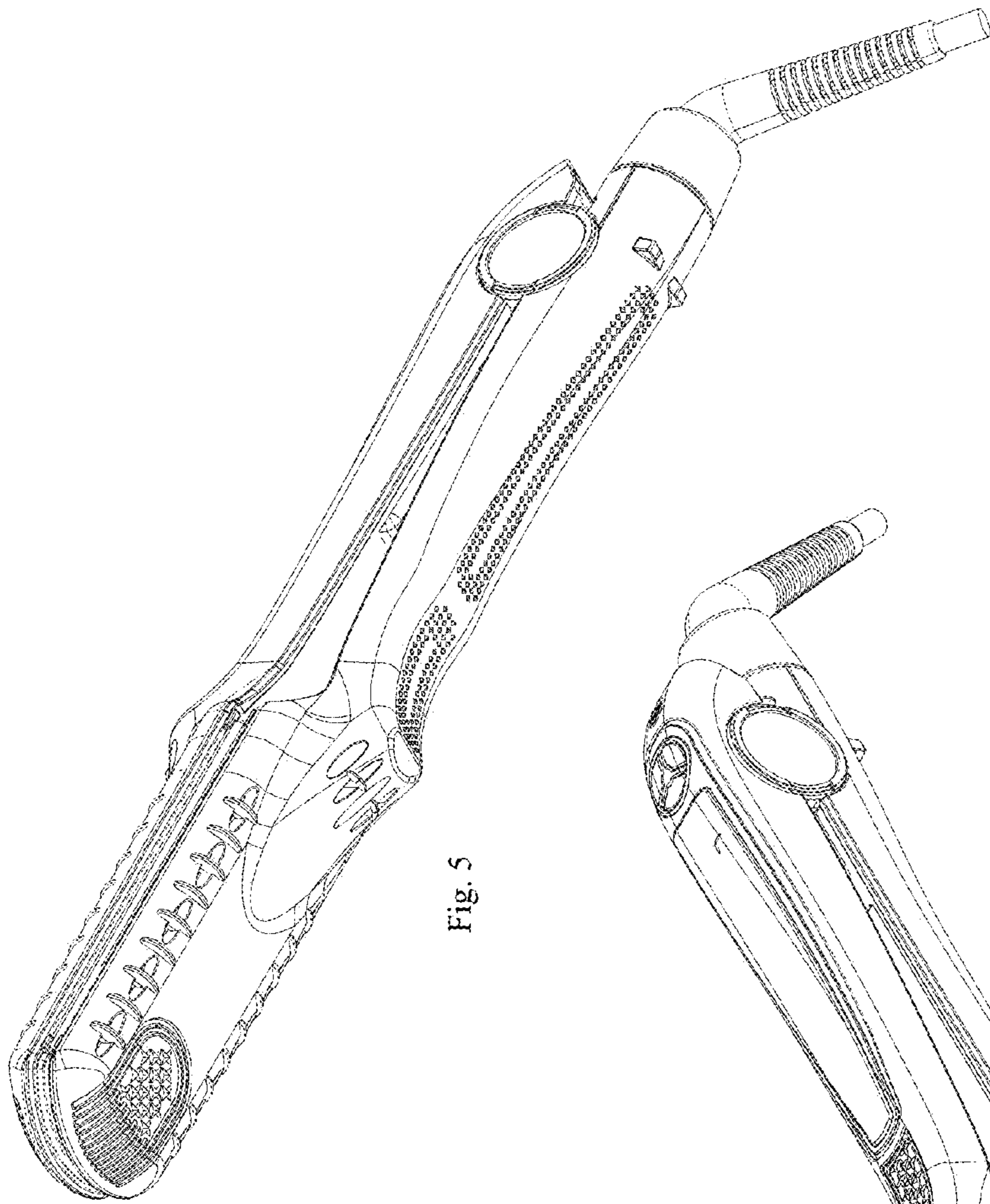

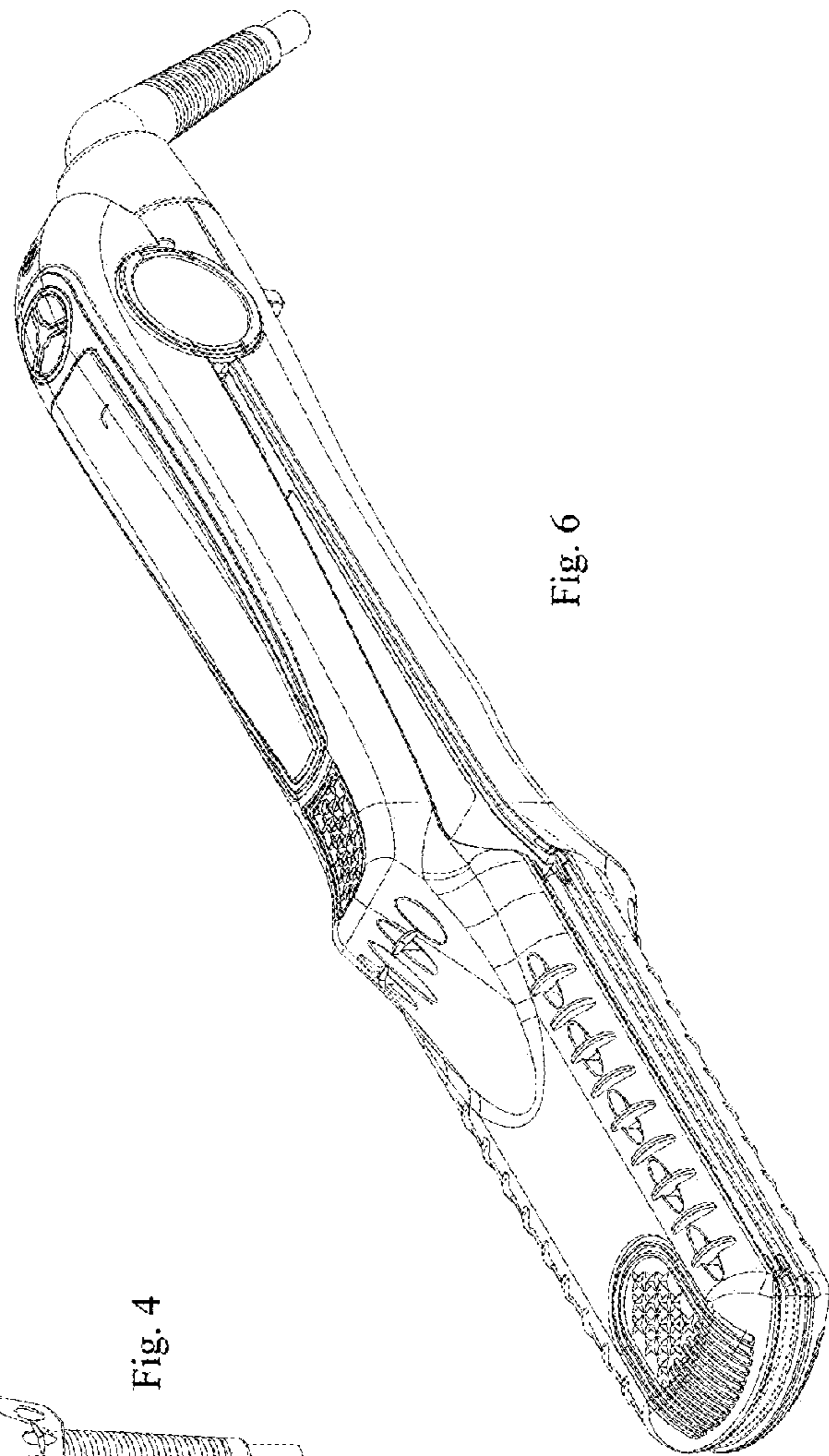

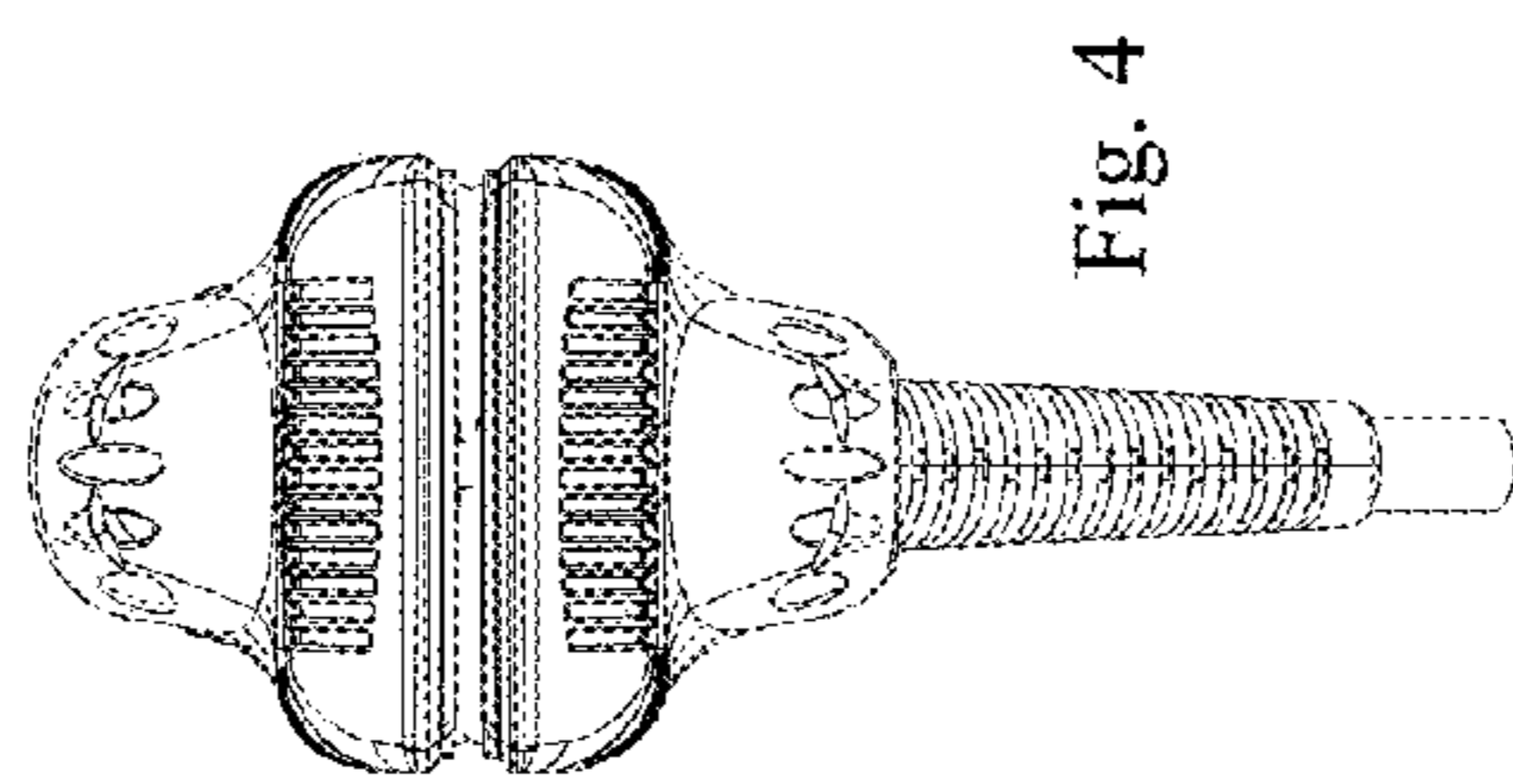

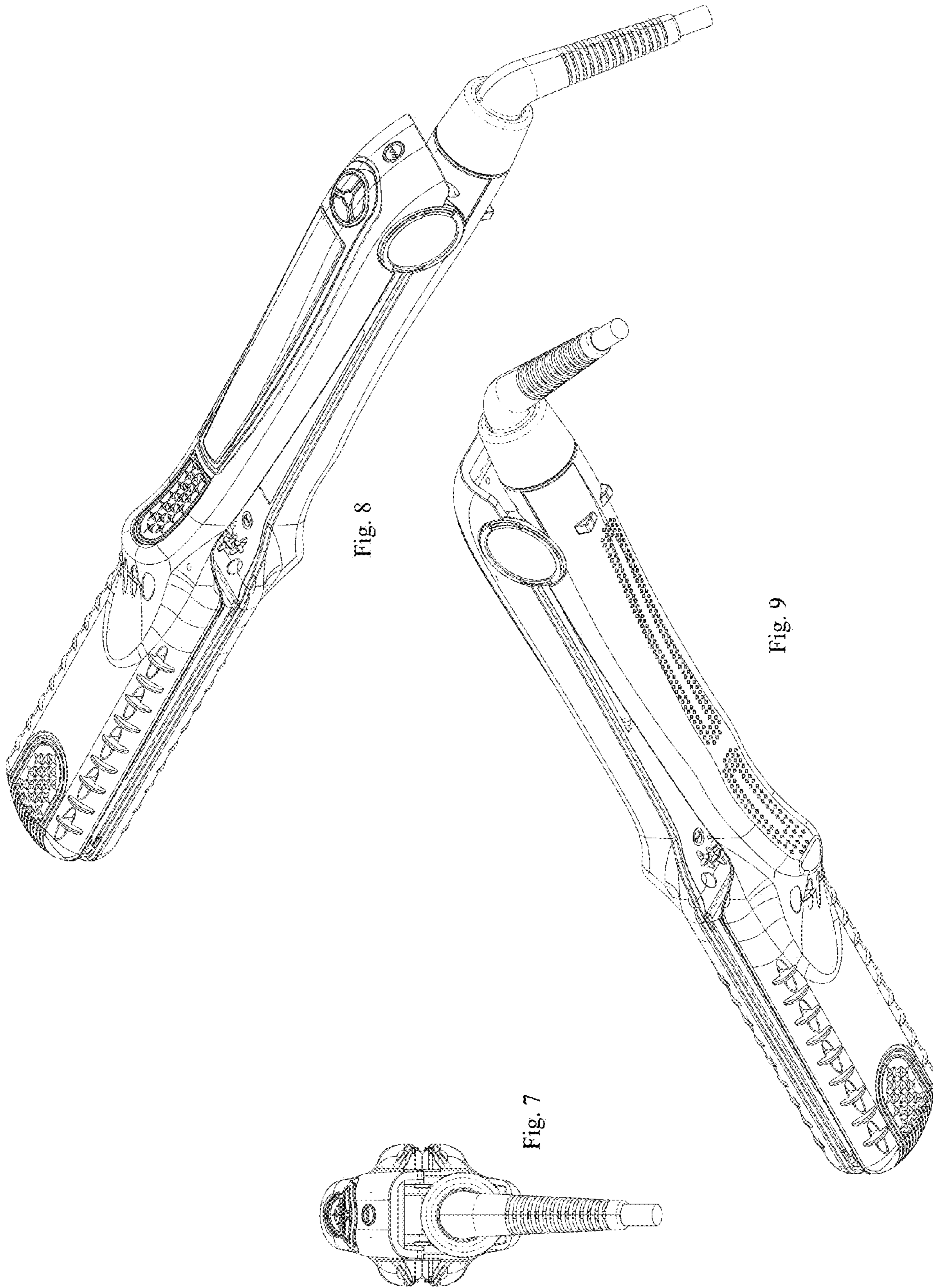
