The ornamental design for a passport holder and organizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a passport holder and organizer showing my new design, shown in an open condition;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a second perspective view thereof, shown in a folded condition.
The broken lines on the wallet represent unclaimed stitching.

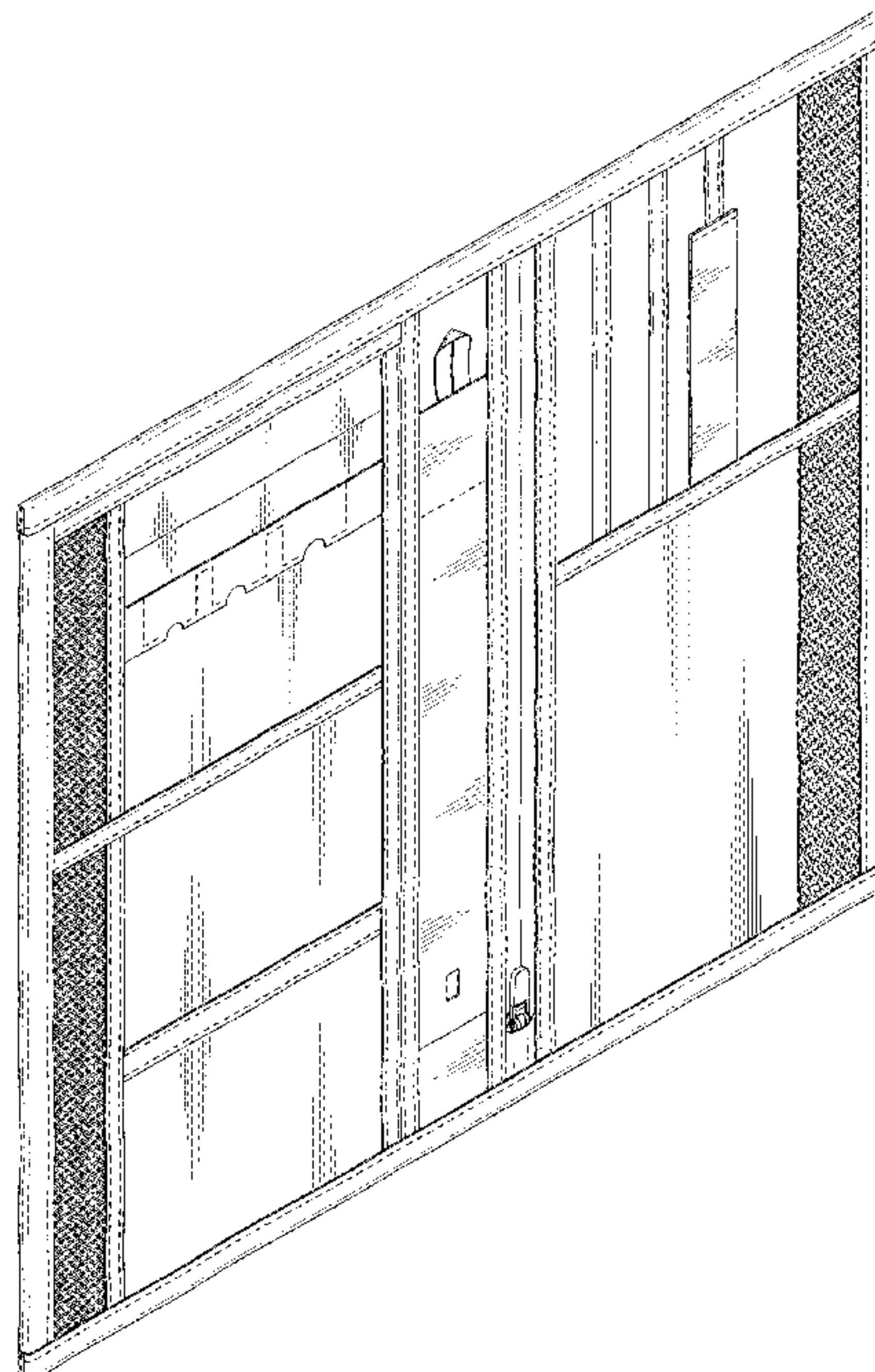
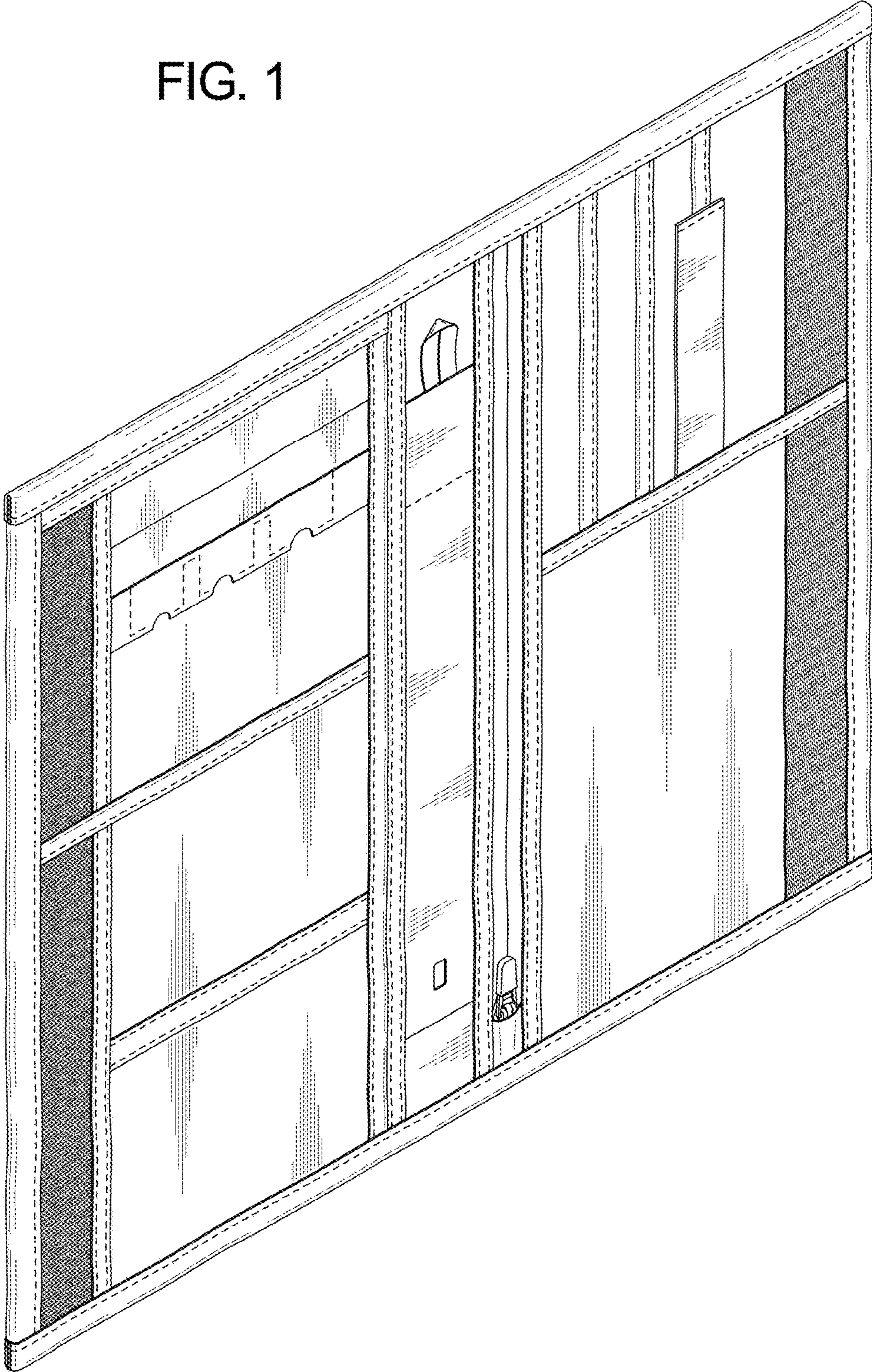

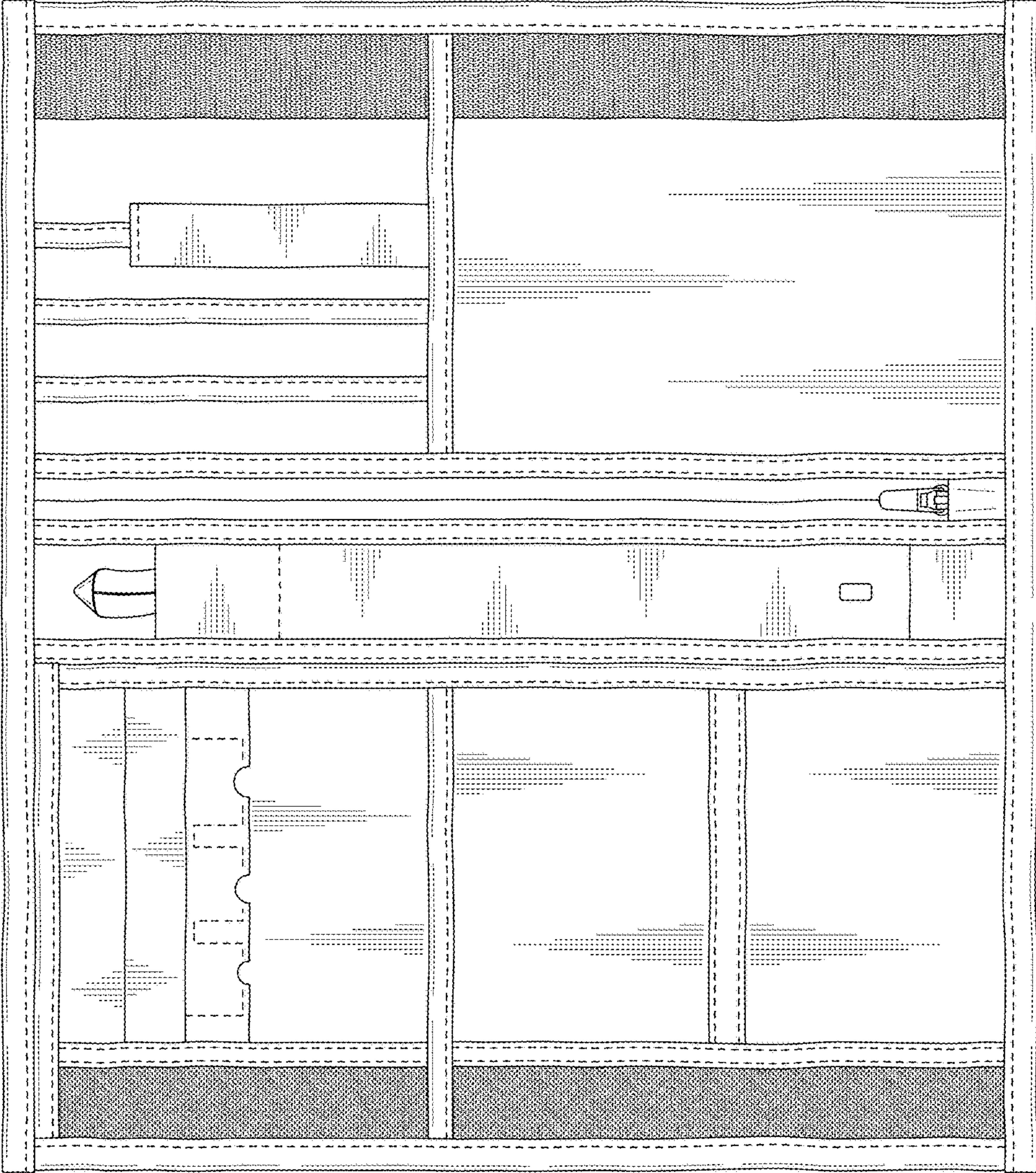

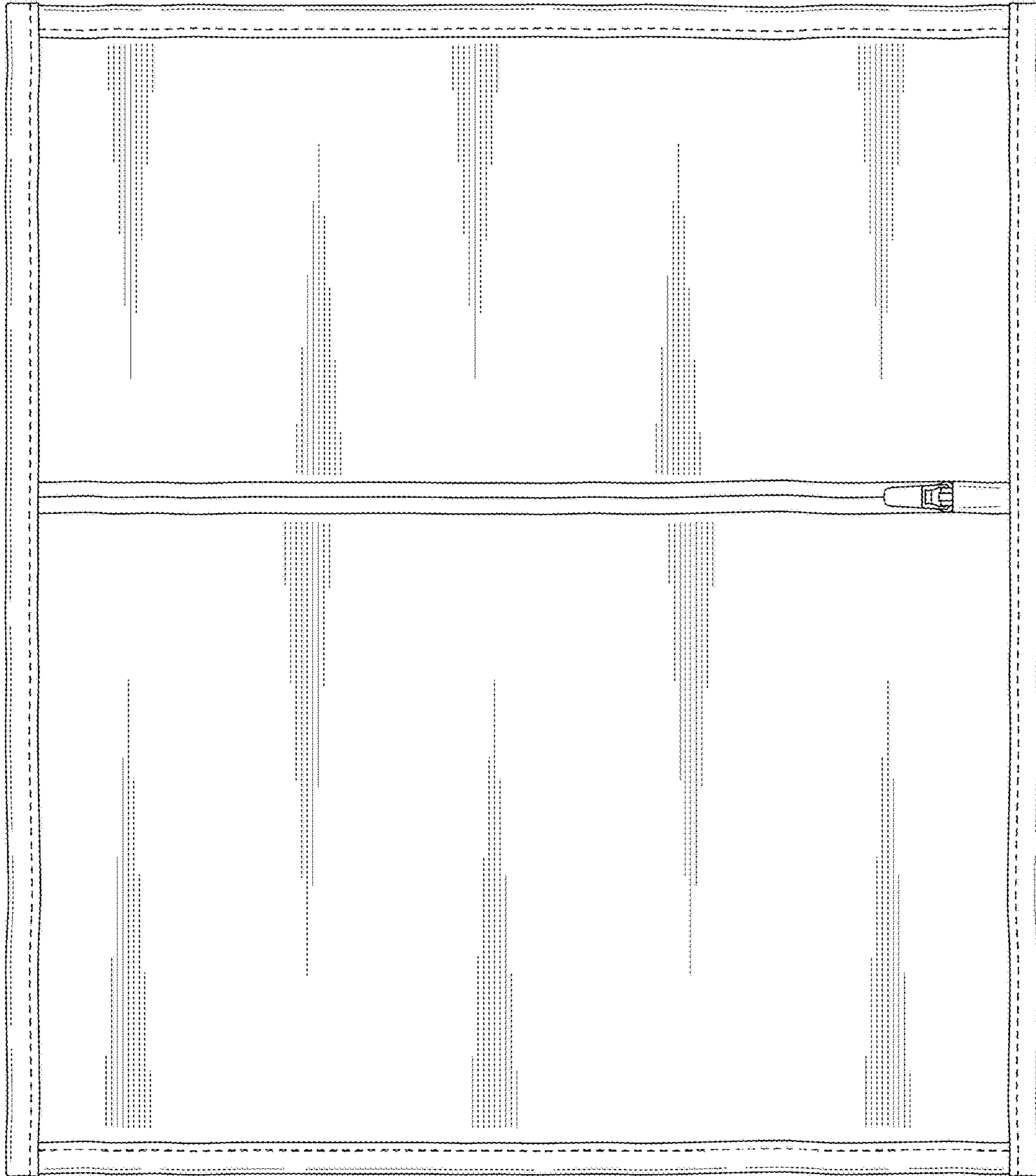

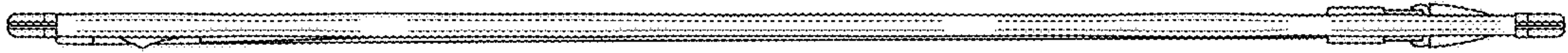

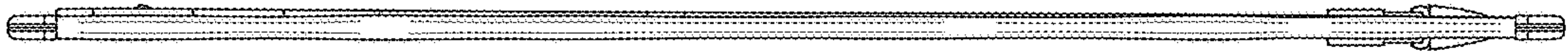
