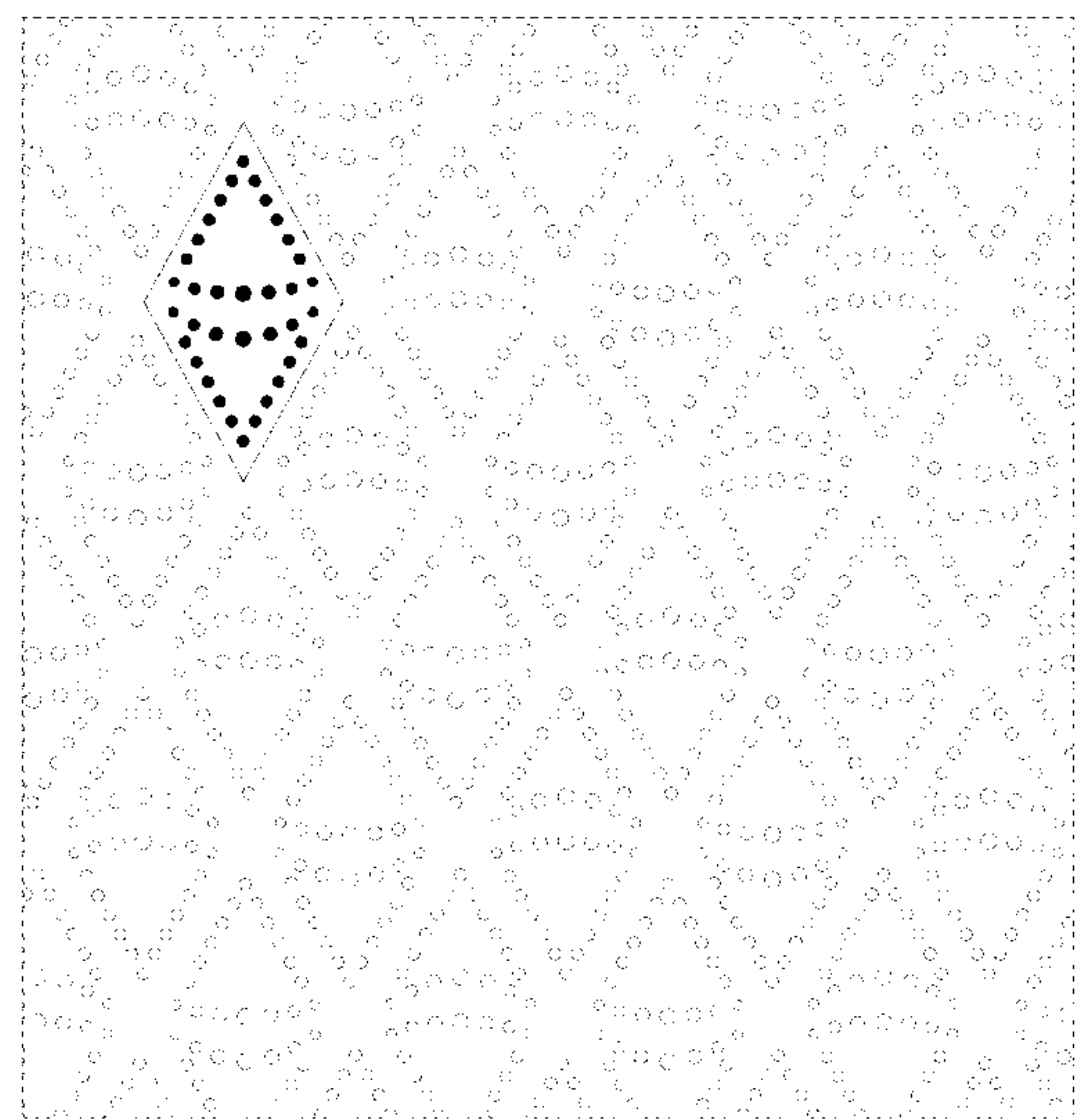

**DESCRIPTION**

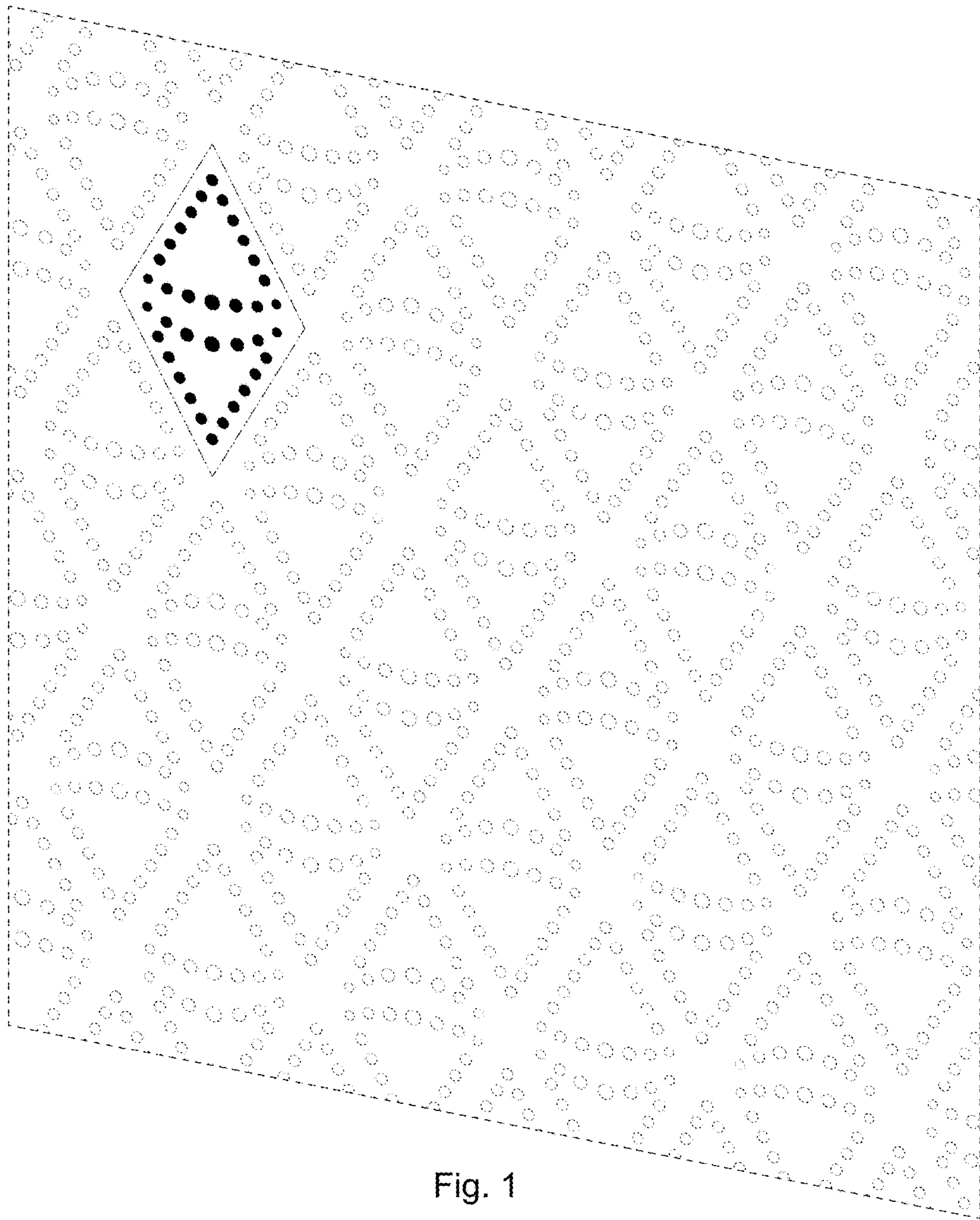

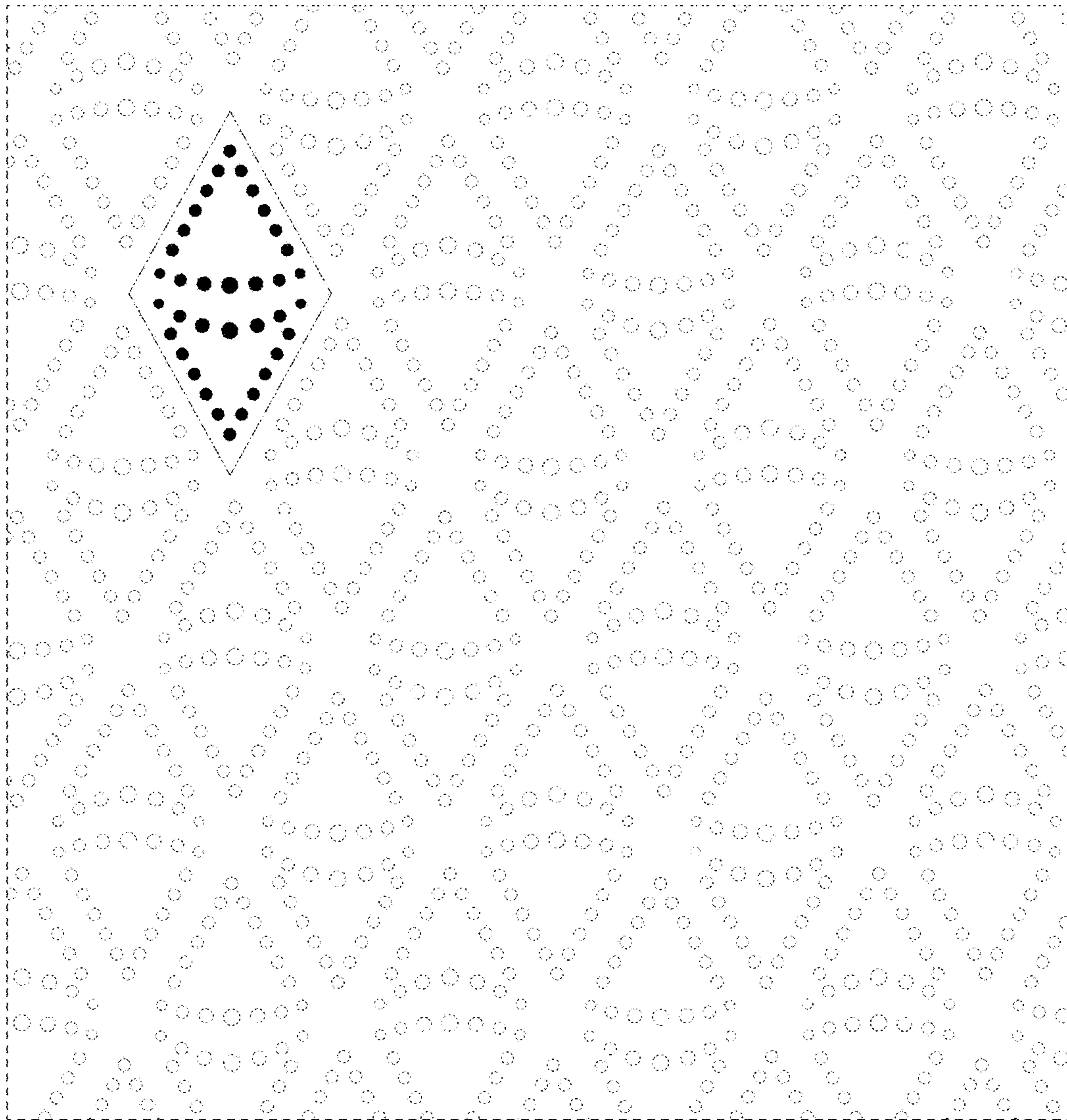

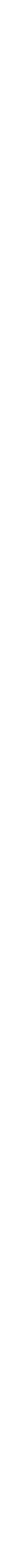

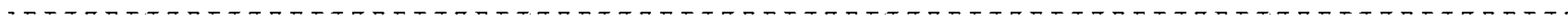
