The ornamental design for a counter stool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the stool showing a round seat, five point lower form, and five legs;

FIG. 2 is a rear elevation view;

FIG. 3 is a front elevation view;

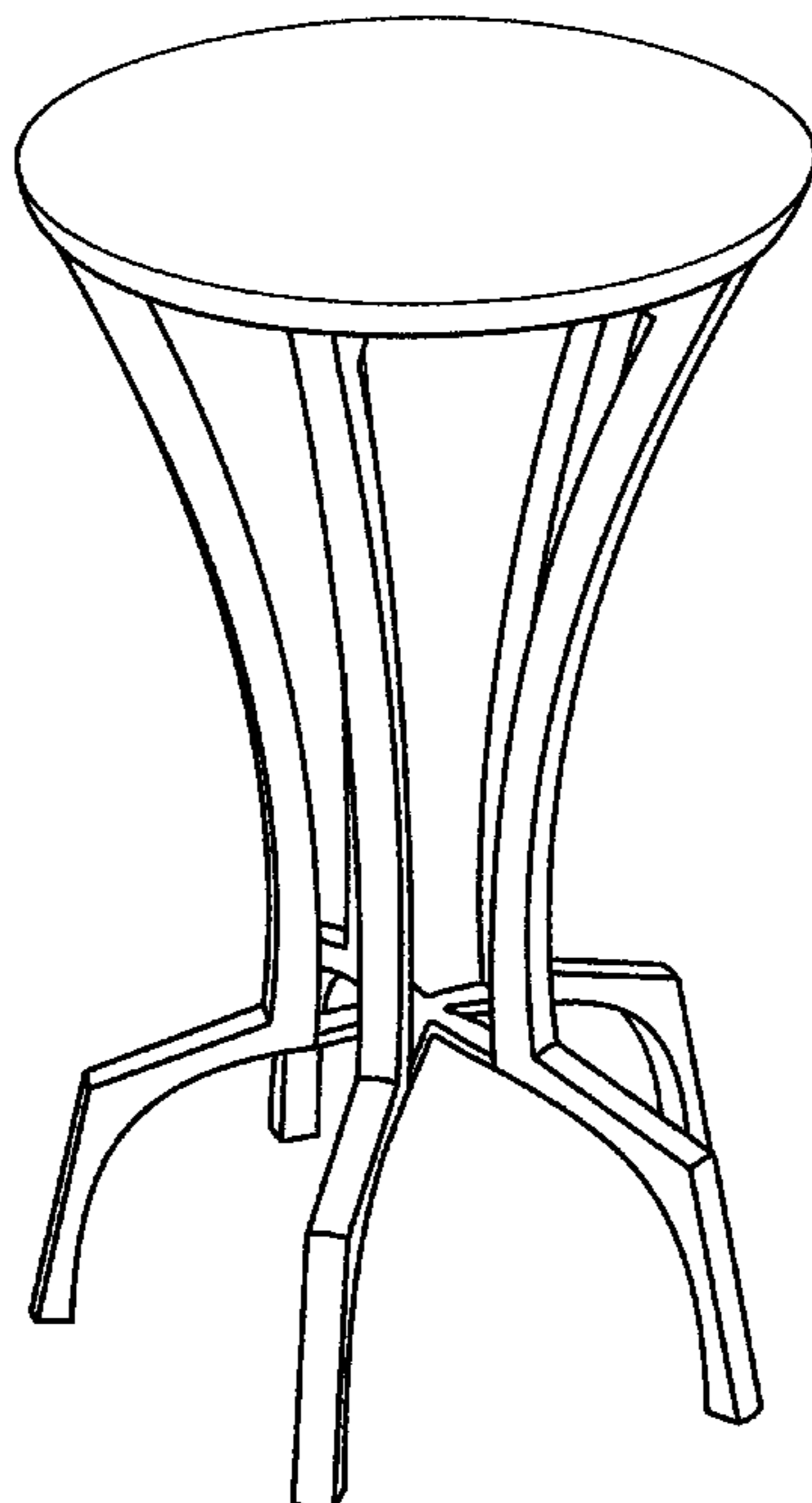
FIG. 4 is a cross-sectional view of the right elevational view taken on the line 4-4 seen in FIG. 7;

FIG. 5 is a cross-sectional view of the left elevational view taken on the line 5-5 seen in FIG. 7;

FIG. 6 is a top view; and,

FIG. 7 is a bottom view showing five legs, a five point lower form and round seat.

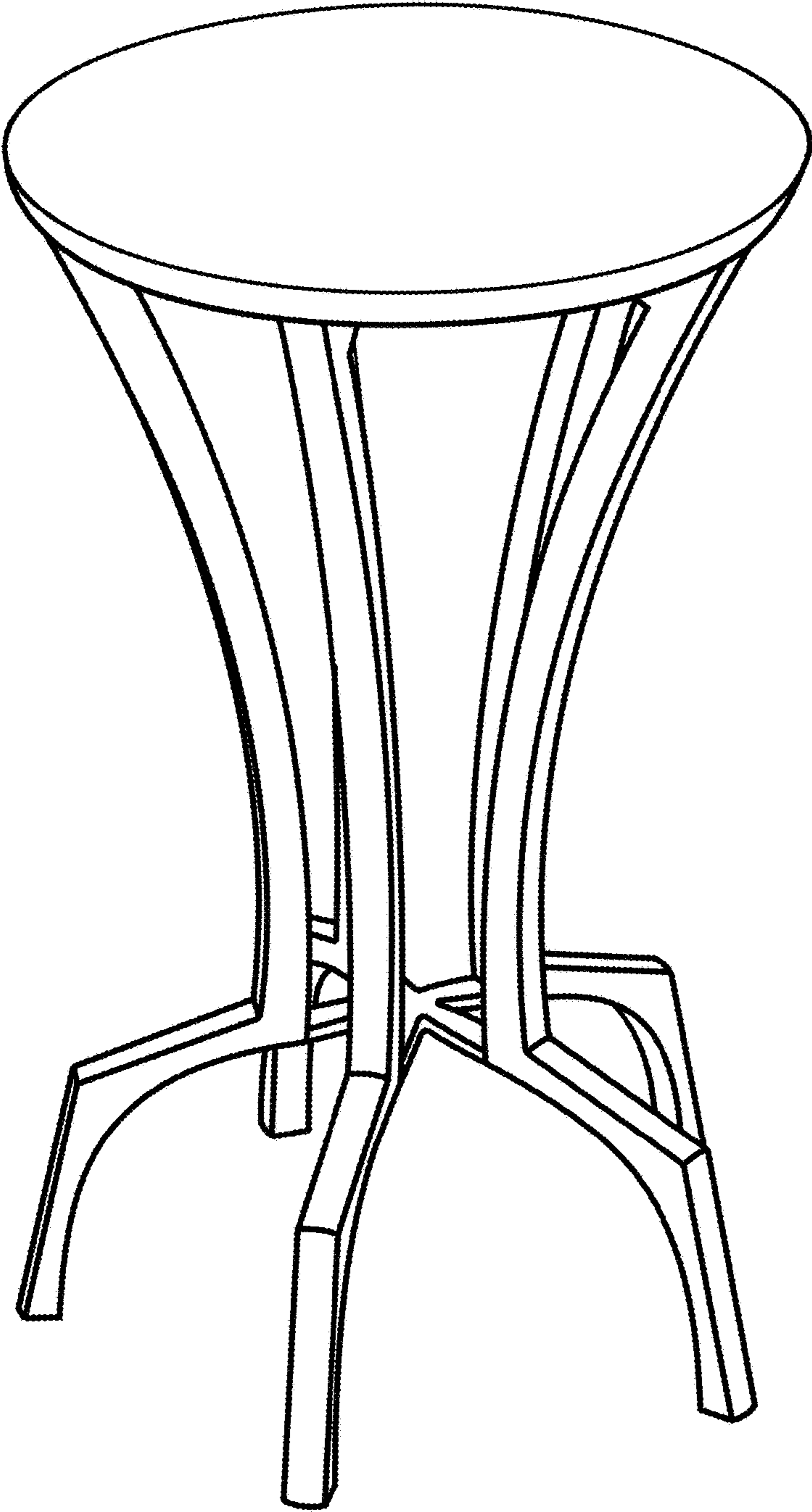

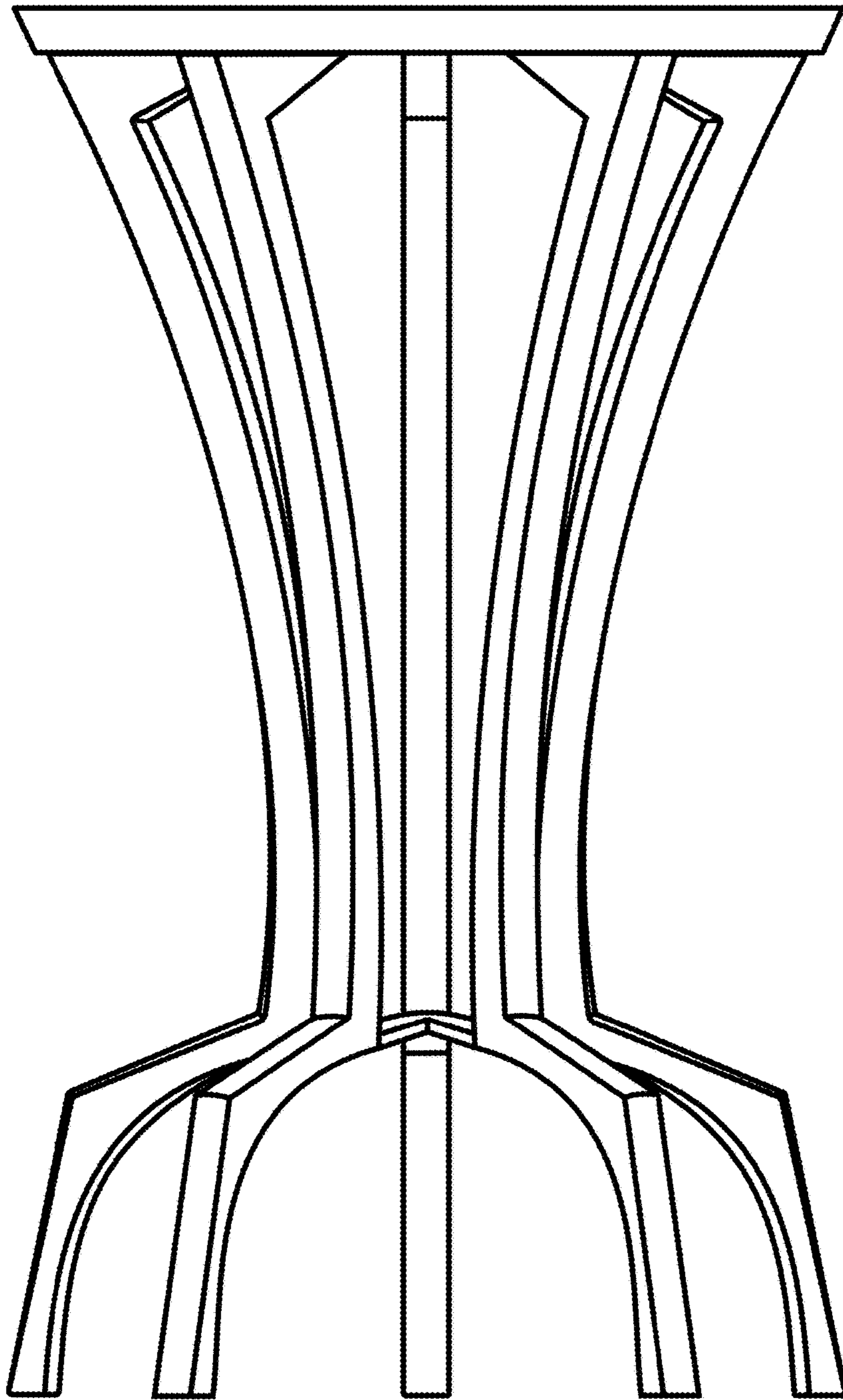

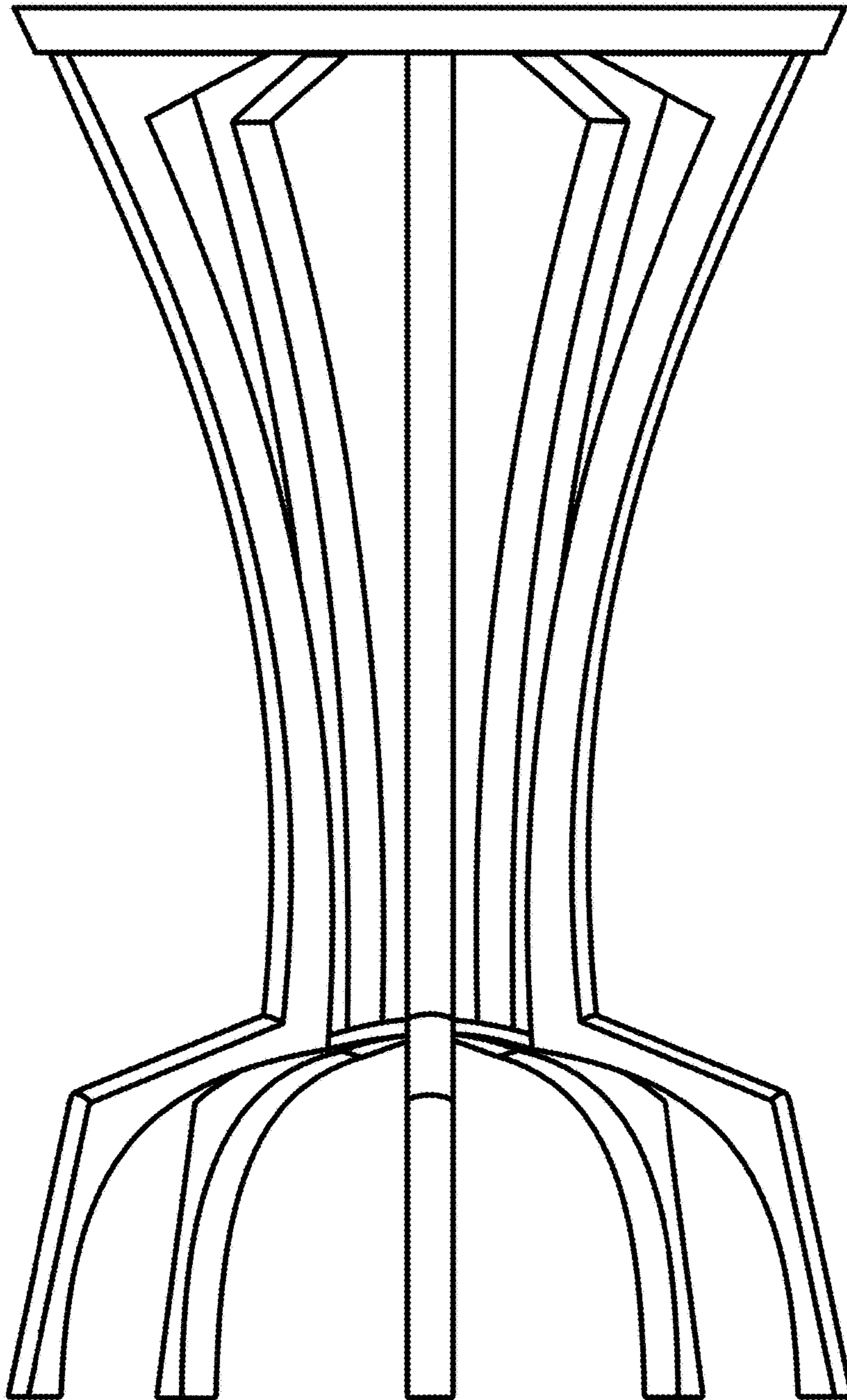

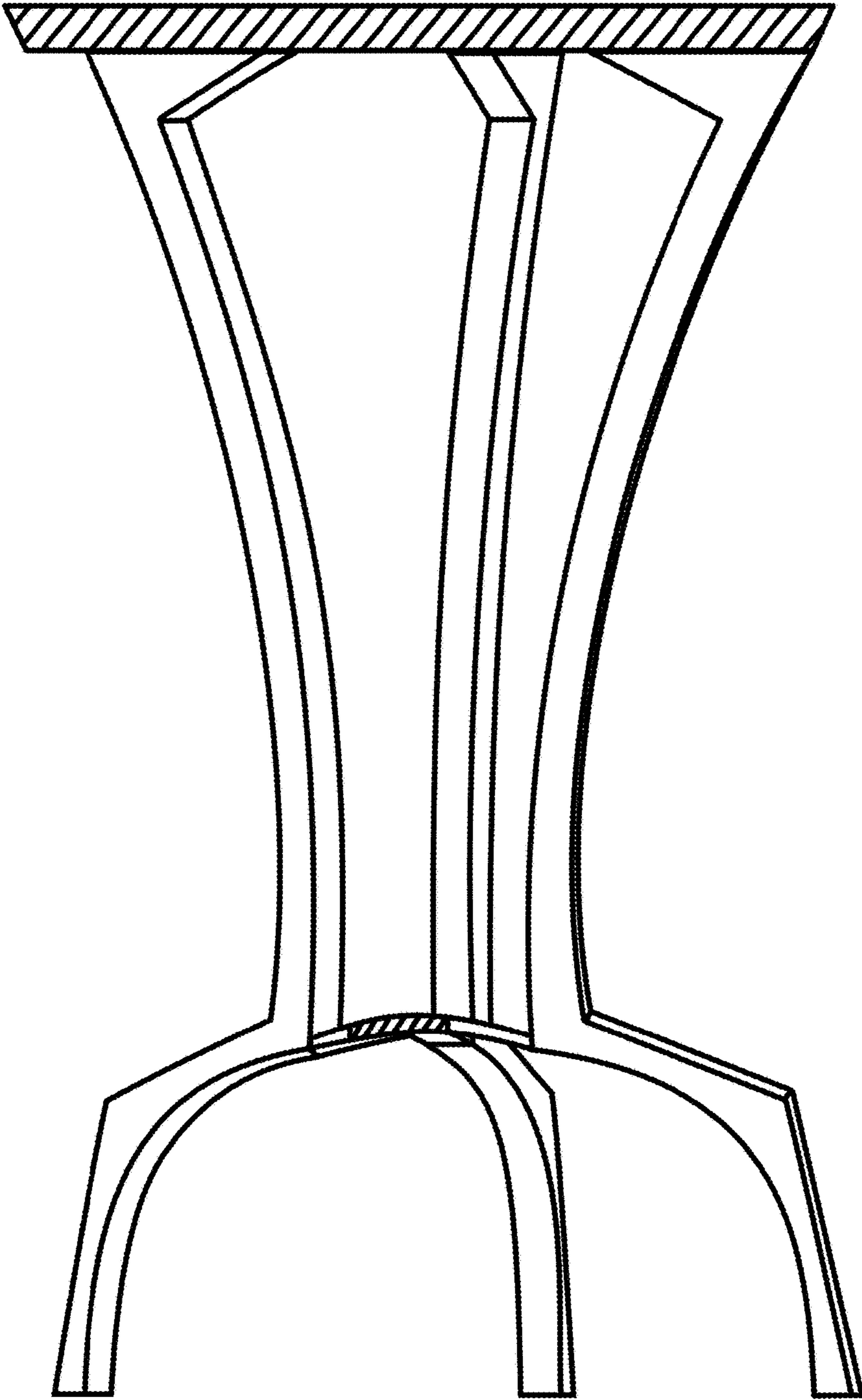

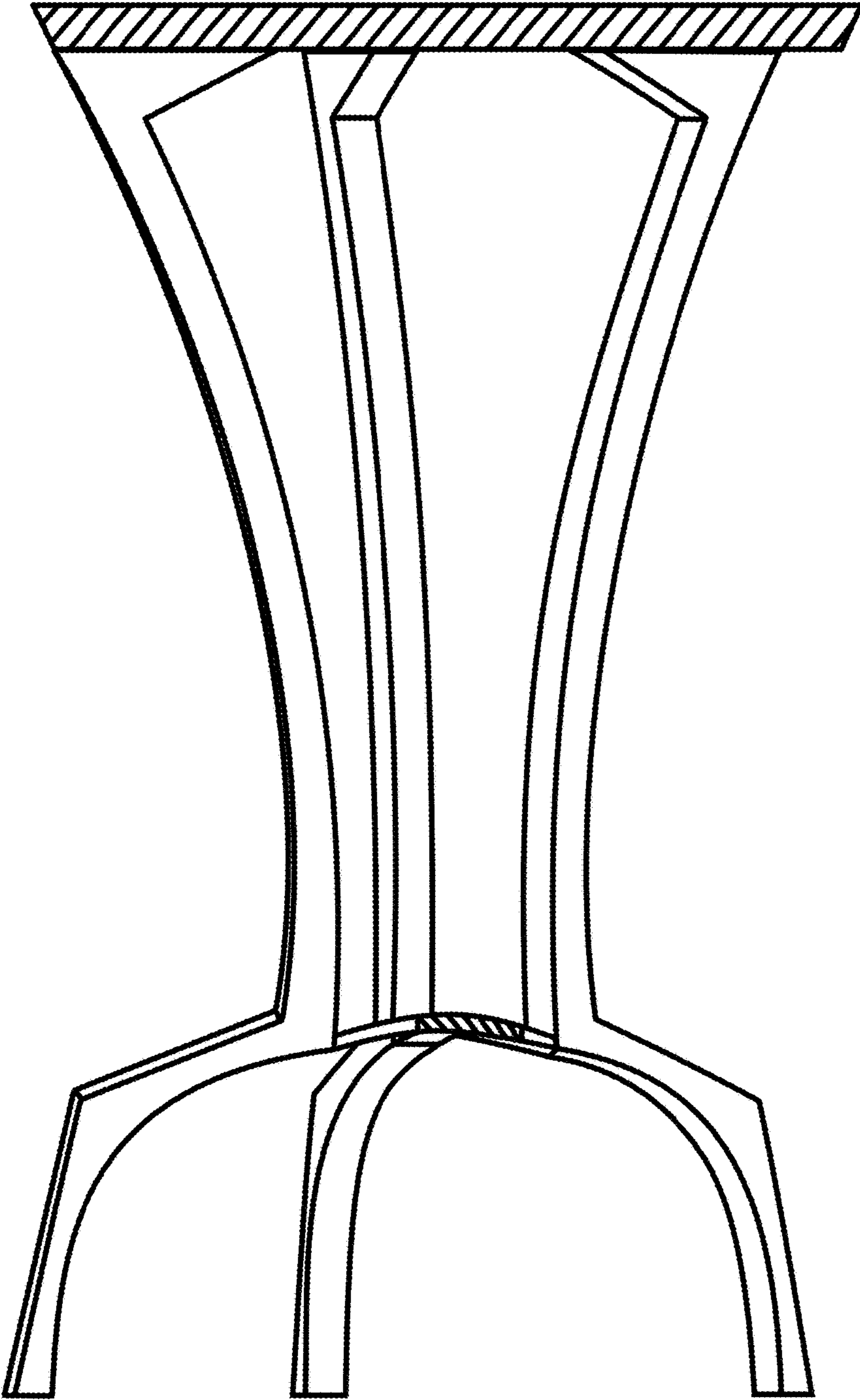

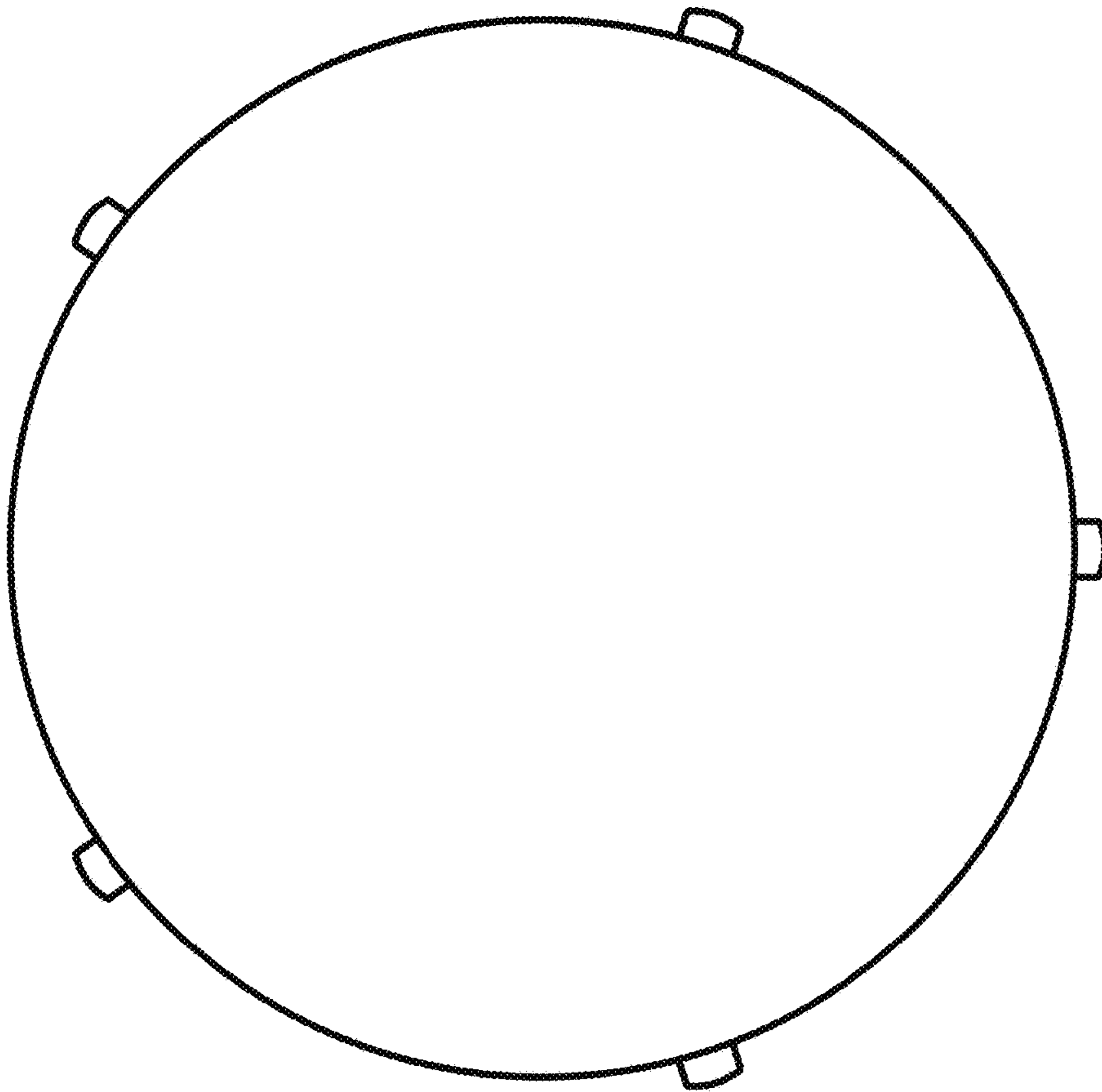

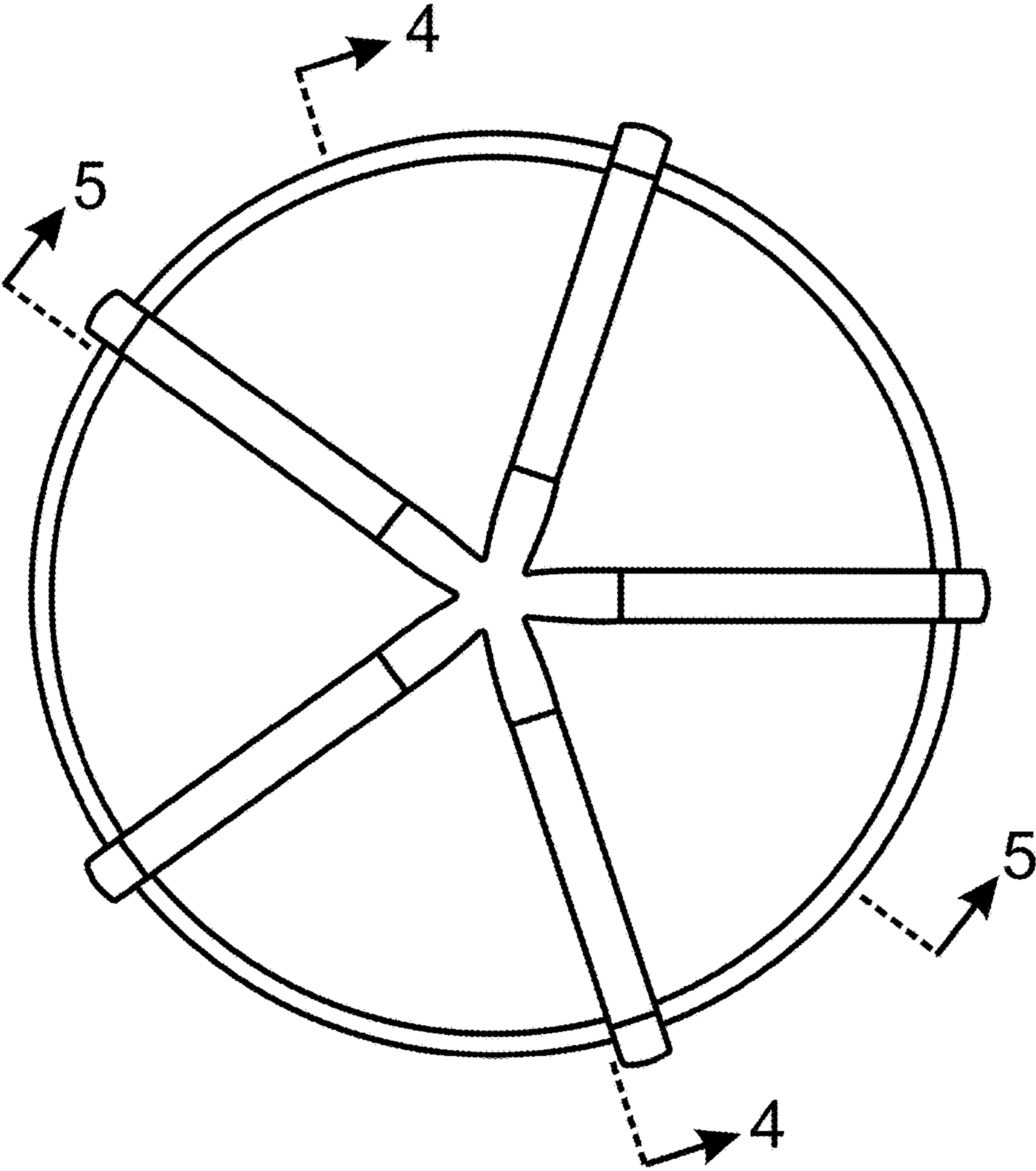
