The ornamental design for a set of chair components, as shown and described.

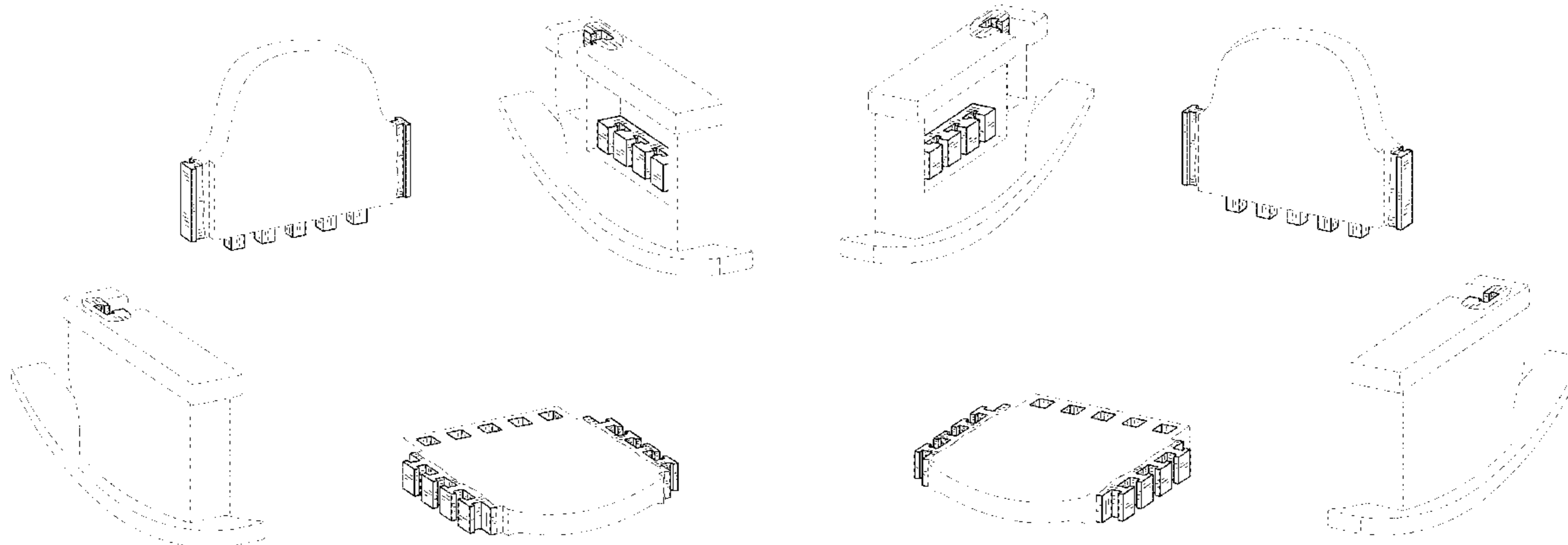
DESCRIPTION

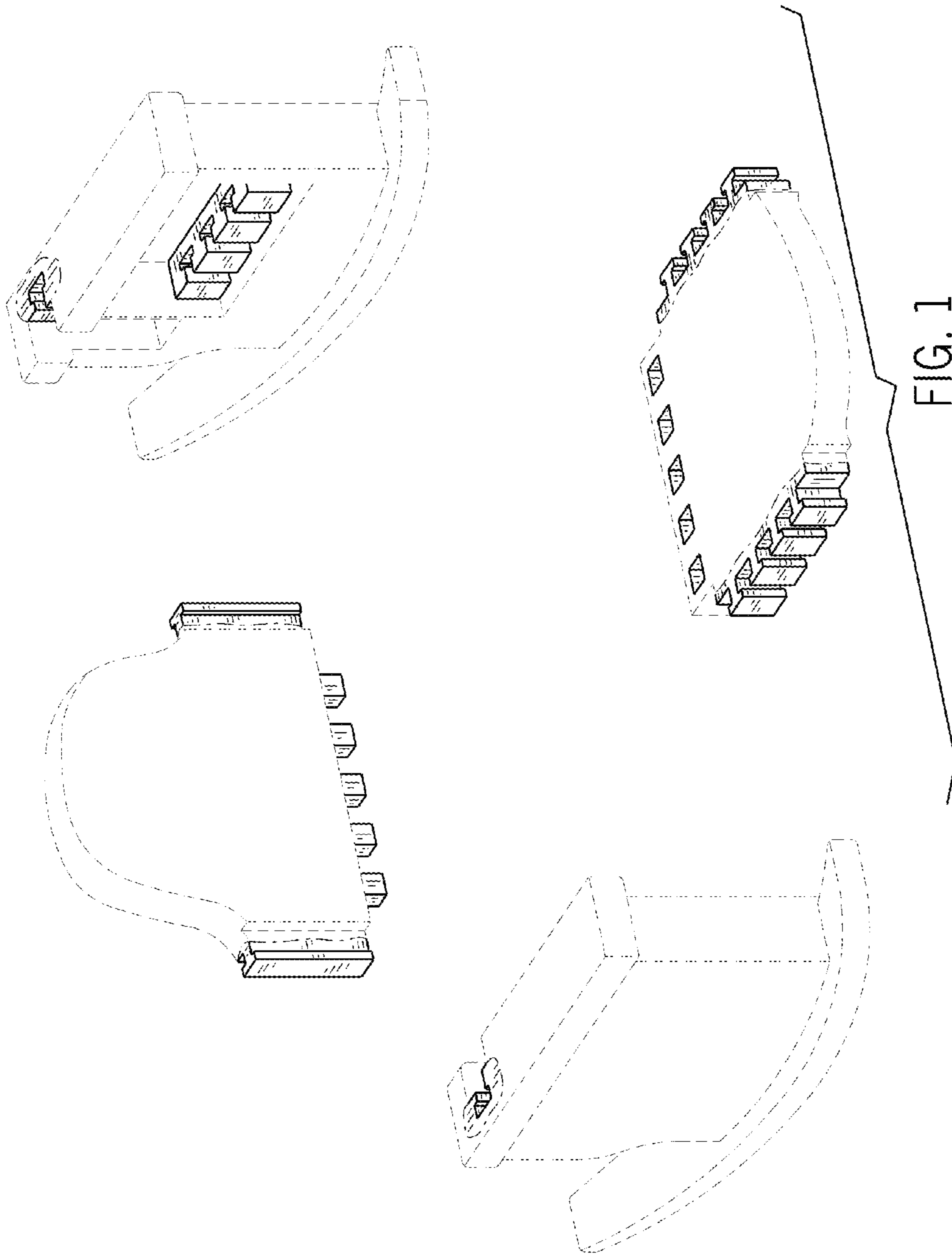
FIG. 1 is a front, left side exploded perspective view of a set of chair components;

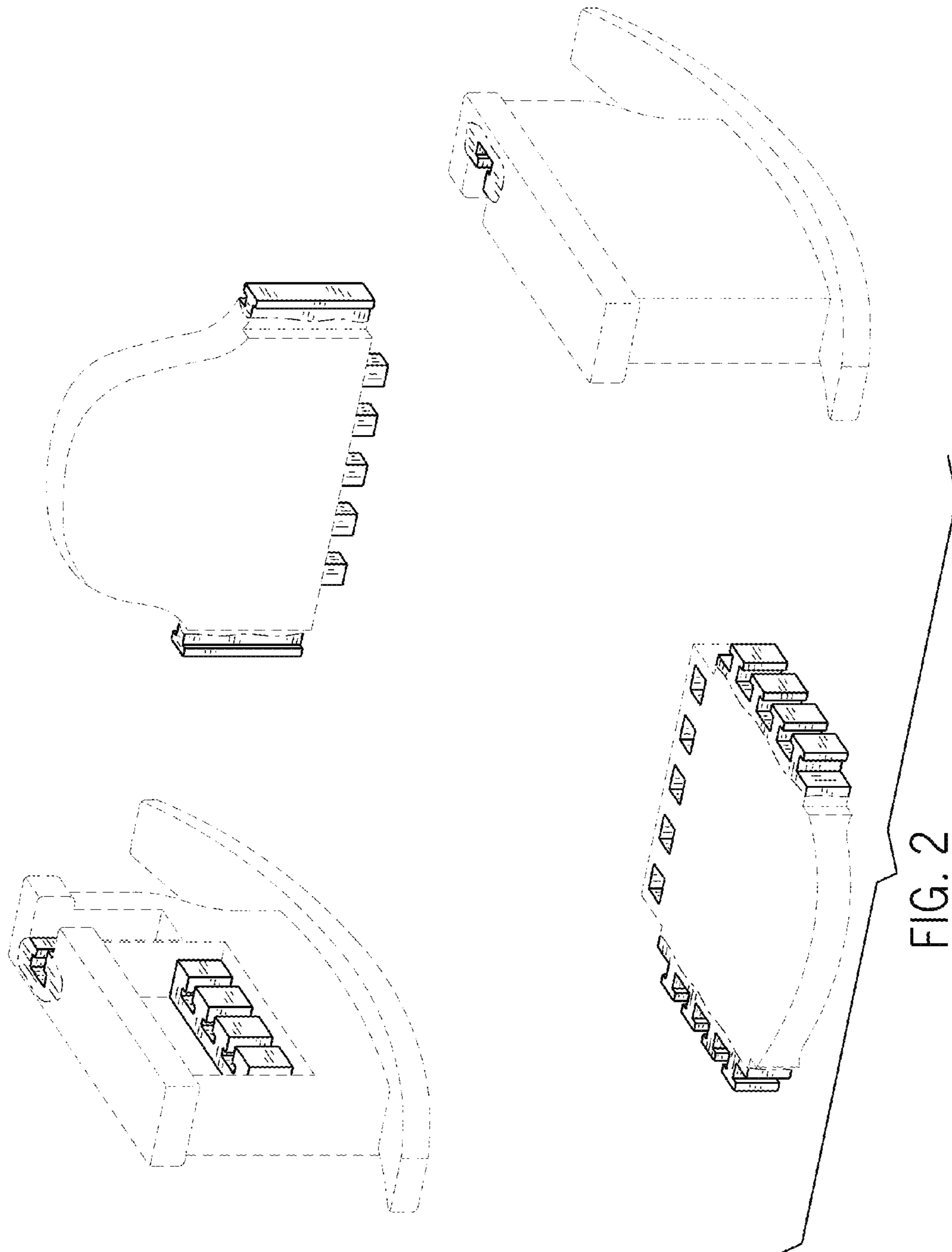

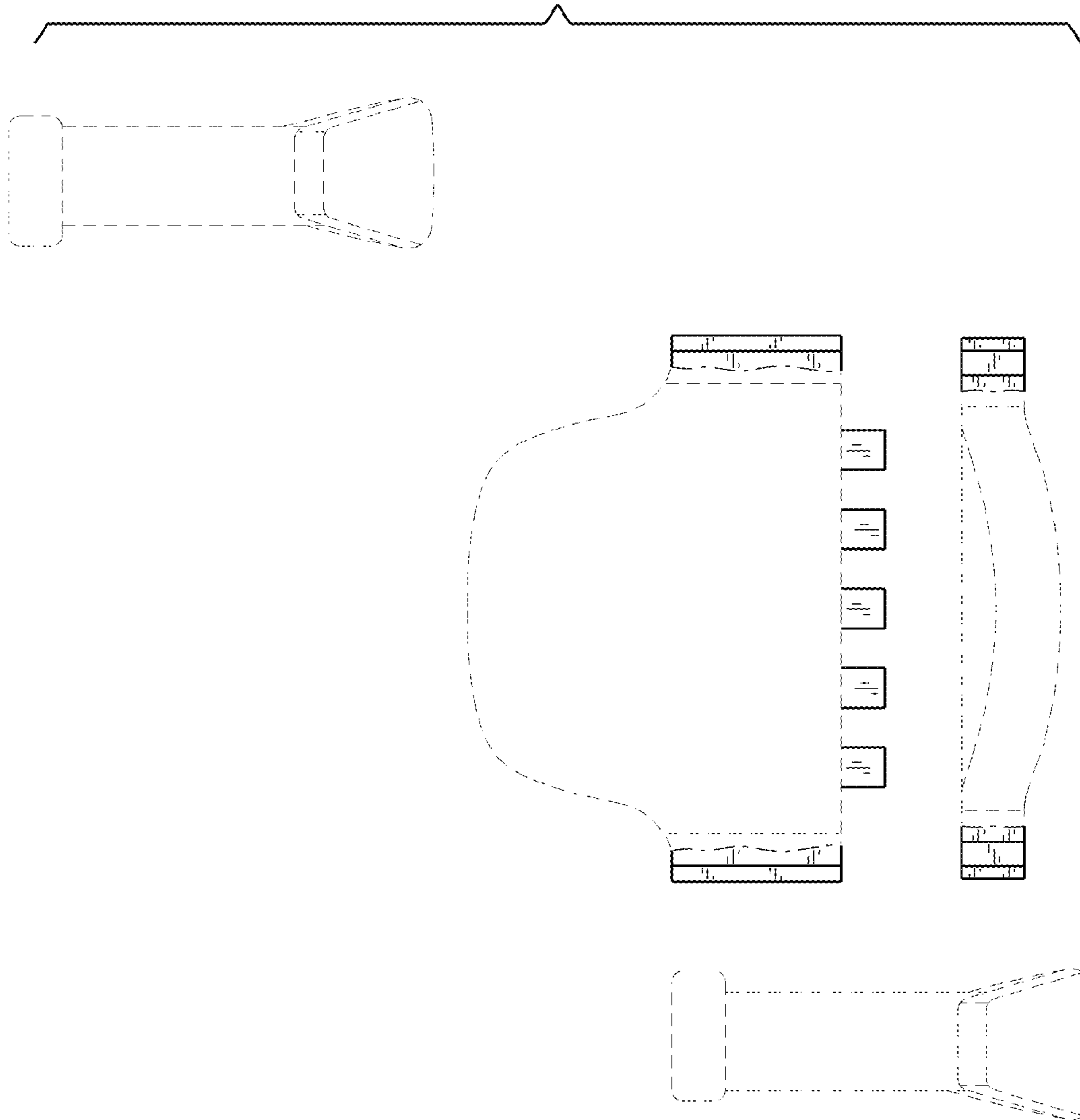
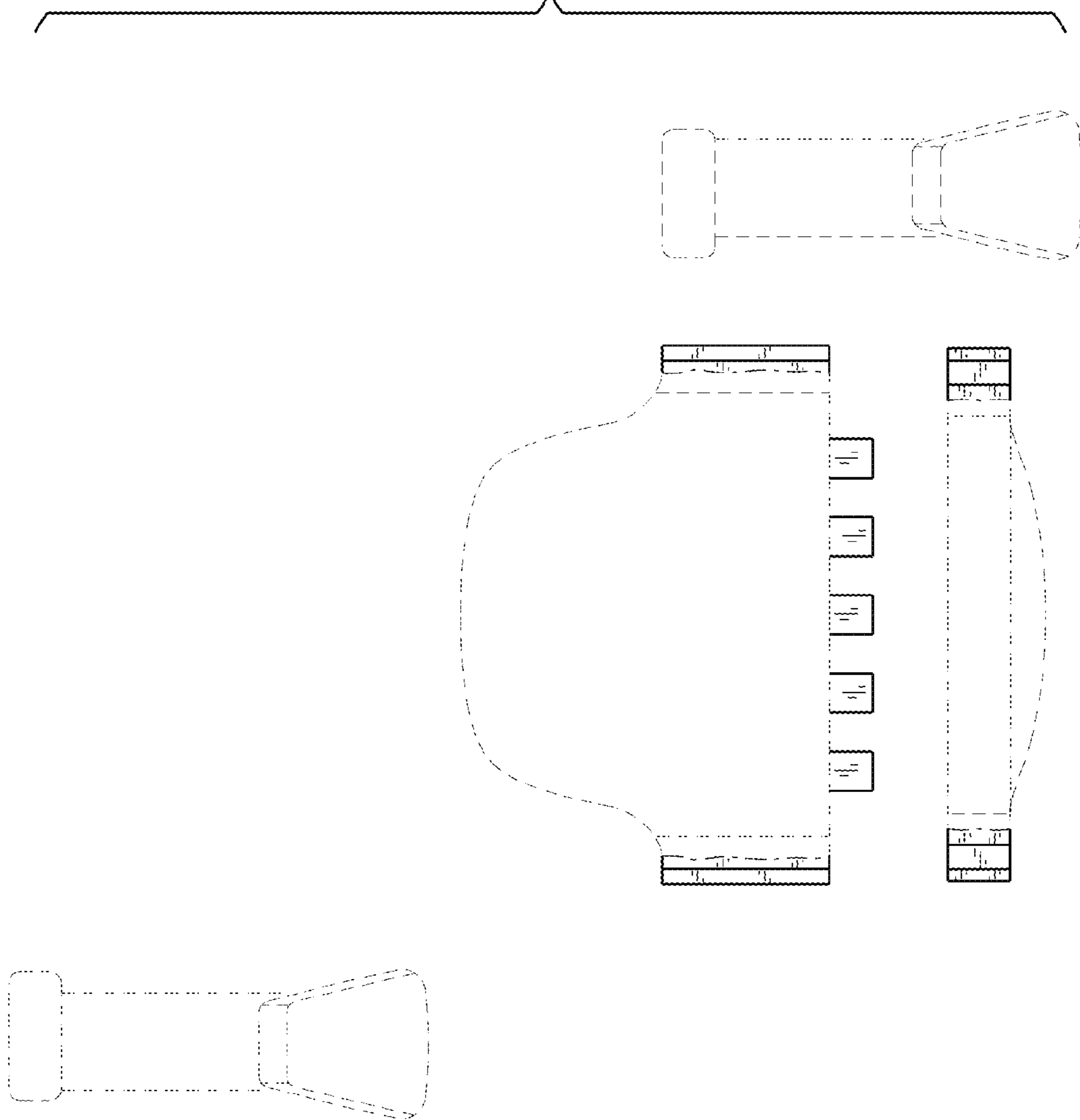

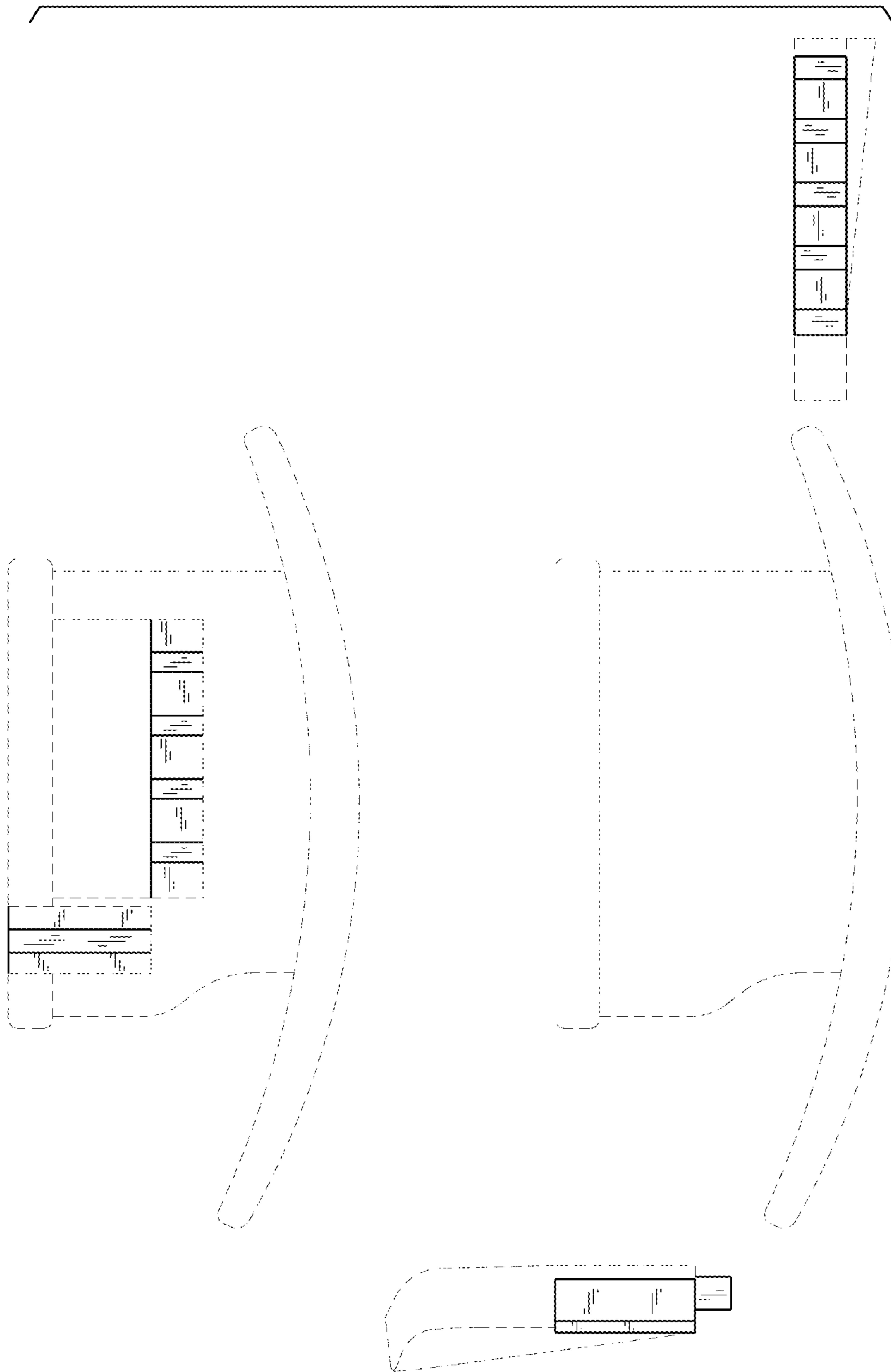
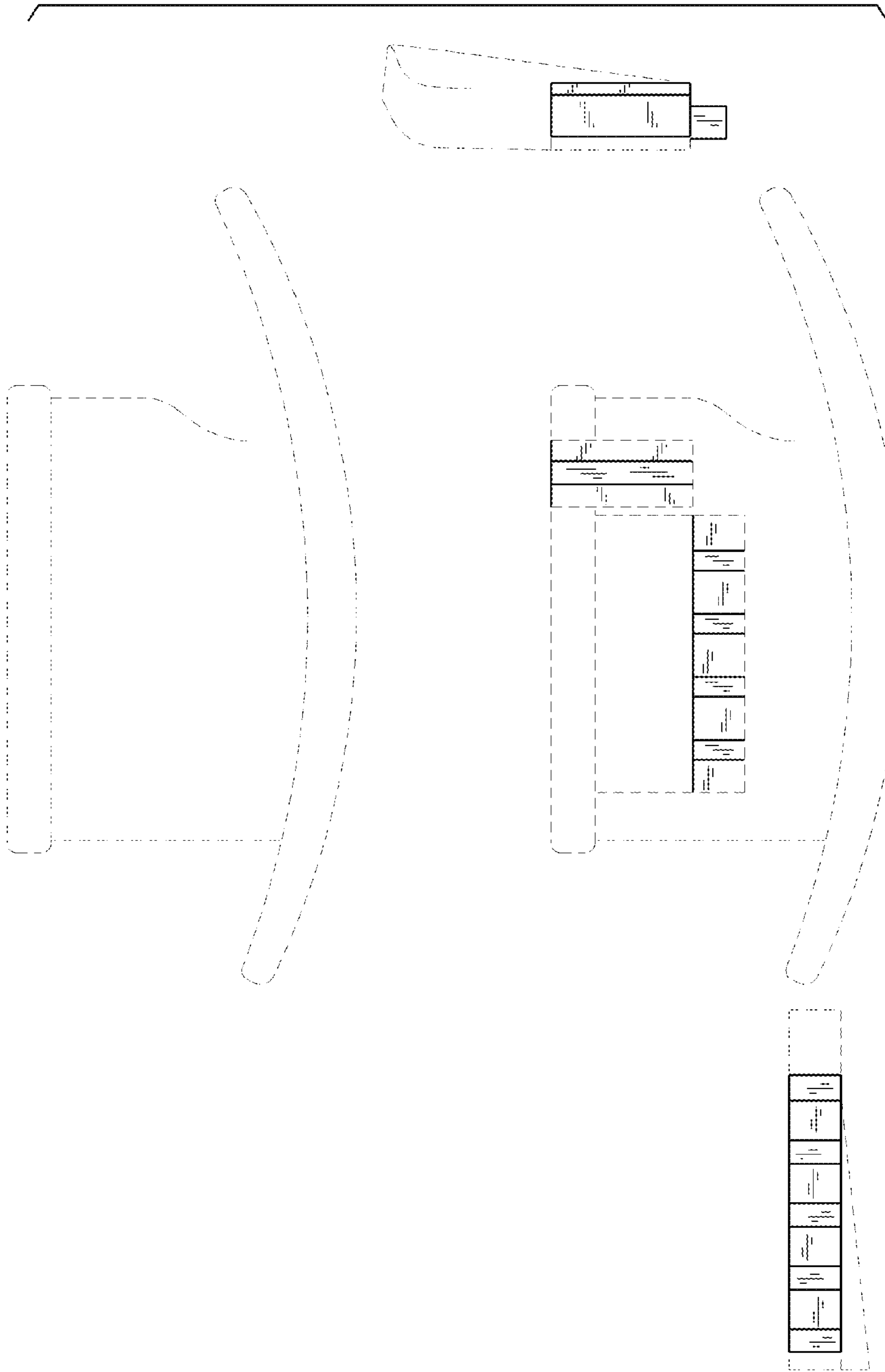

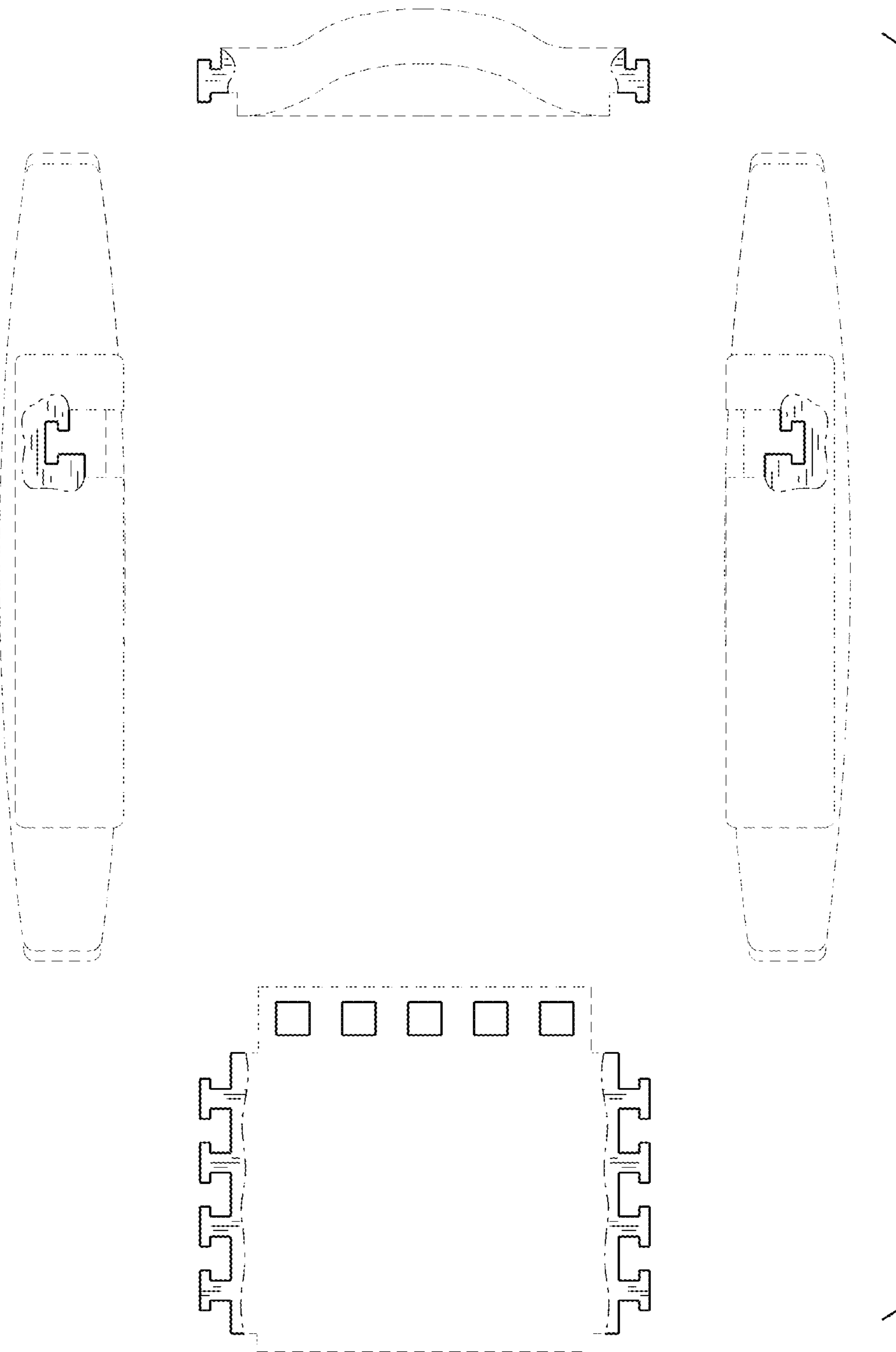

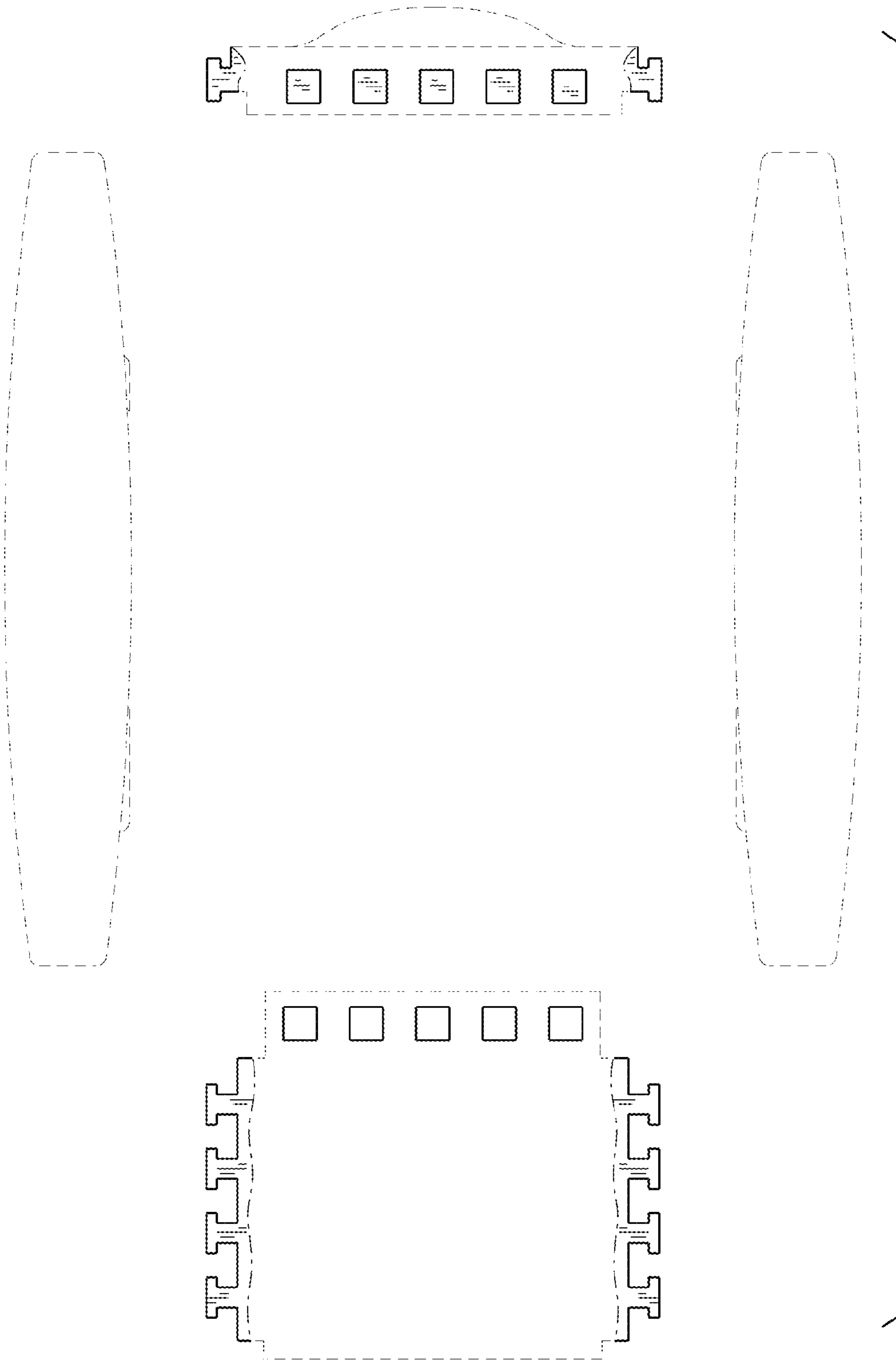
