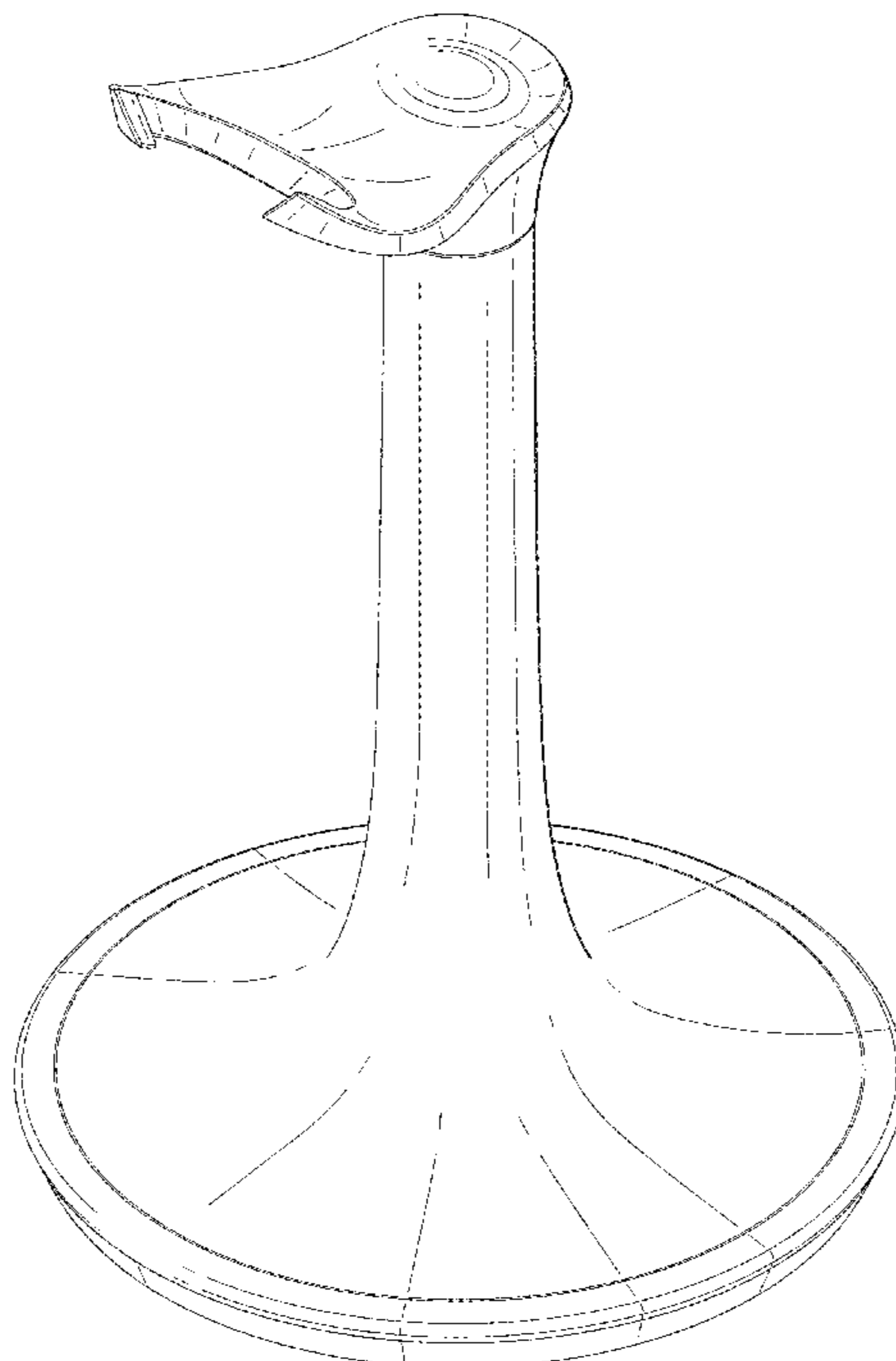

The ornamental design for a stand for a shaving razor, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a stand for a shaving razor of the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof;

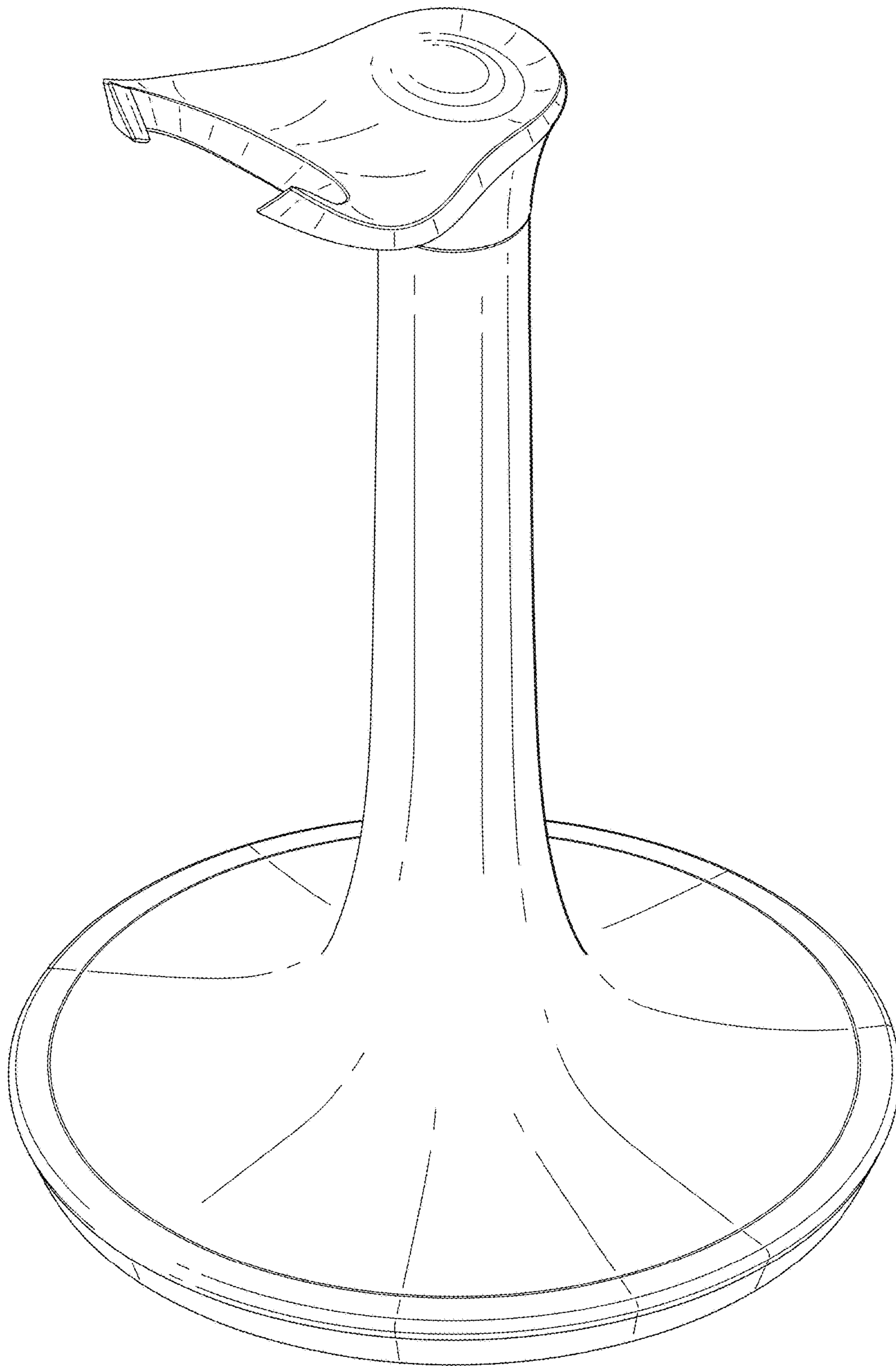

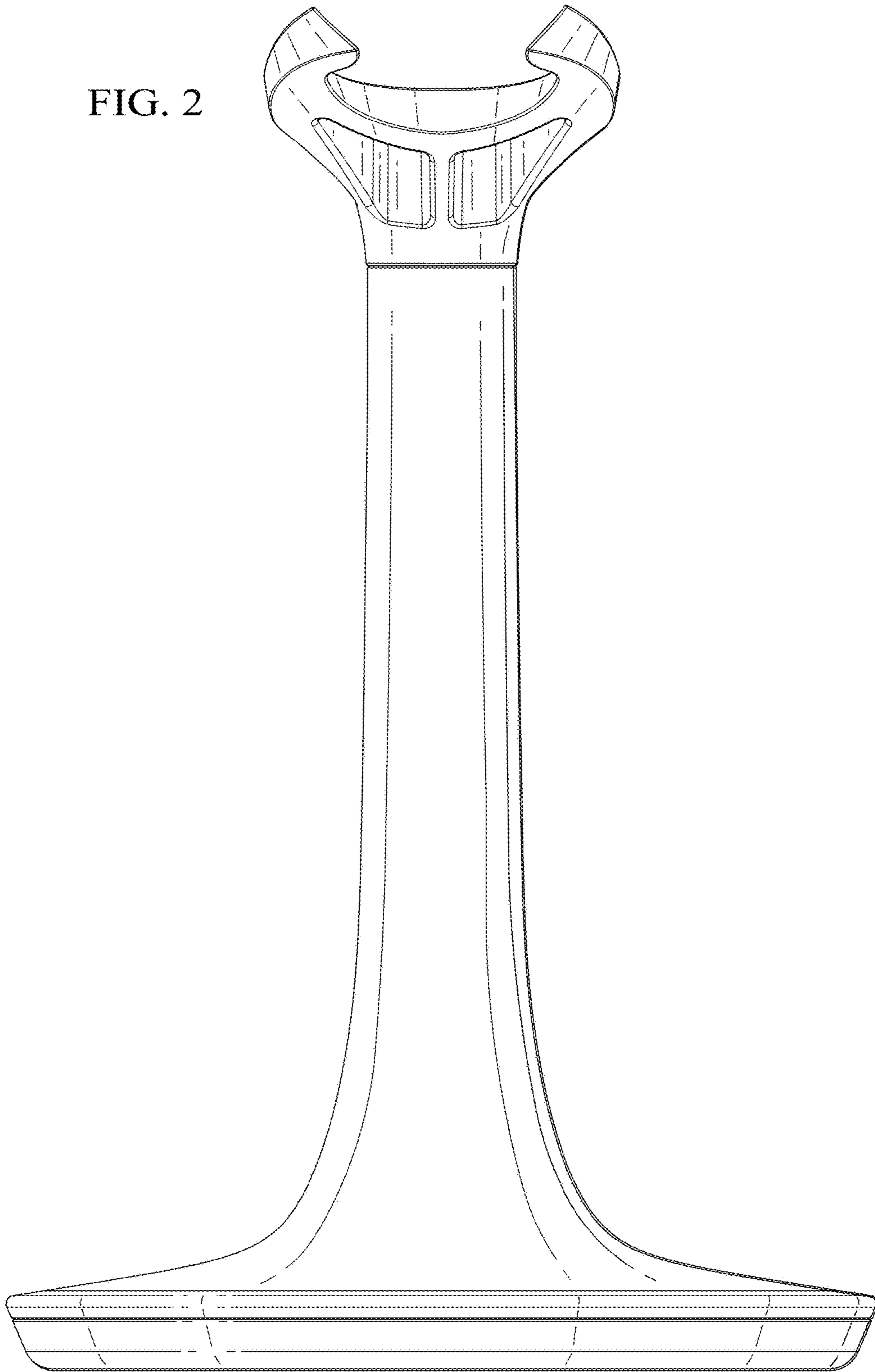

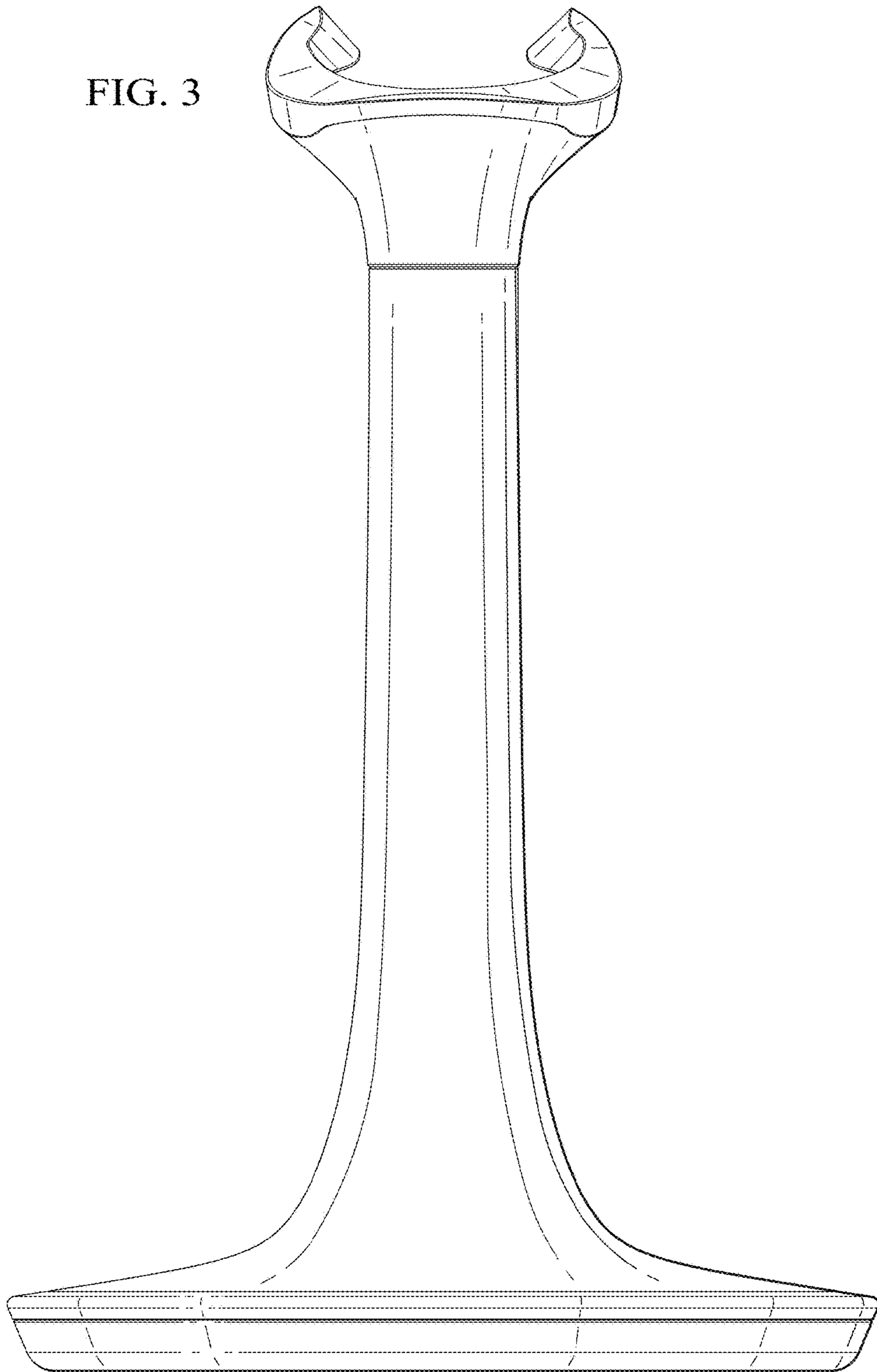
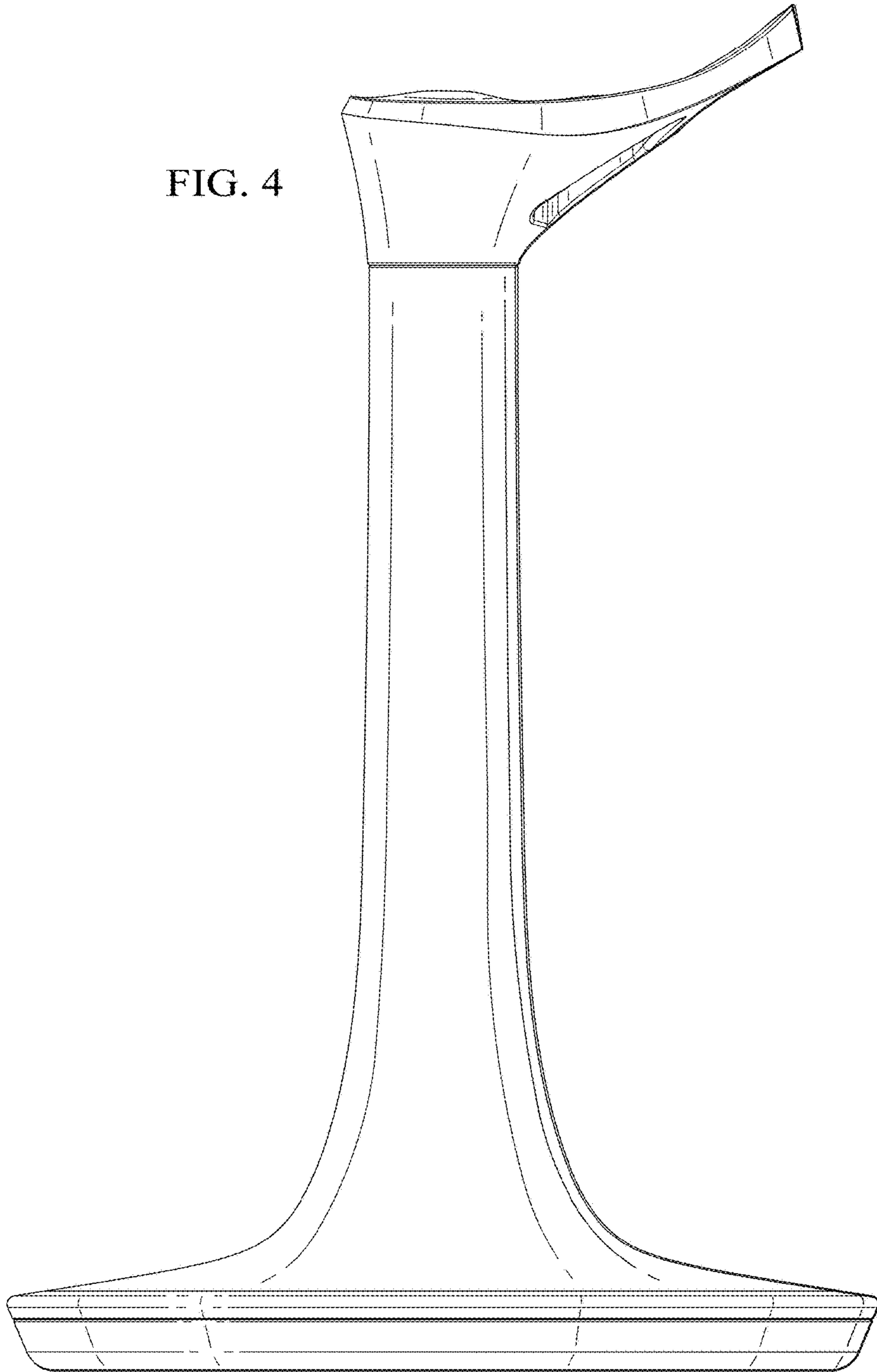

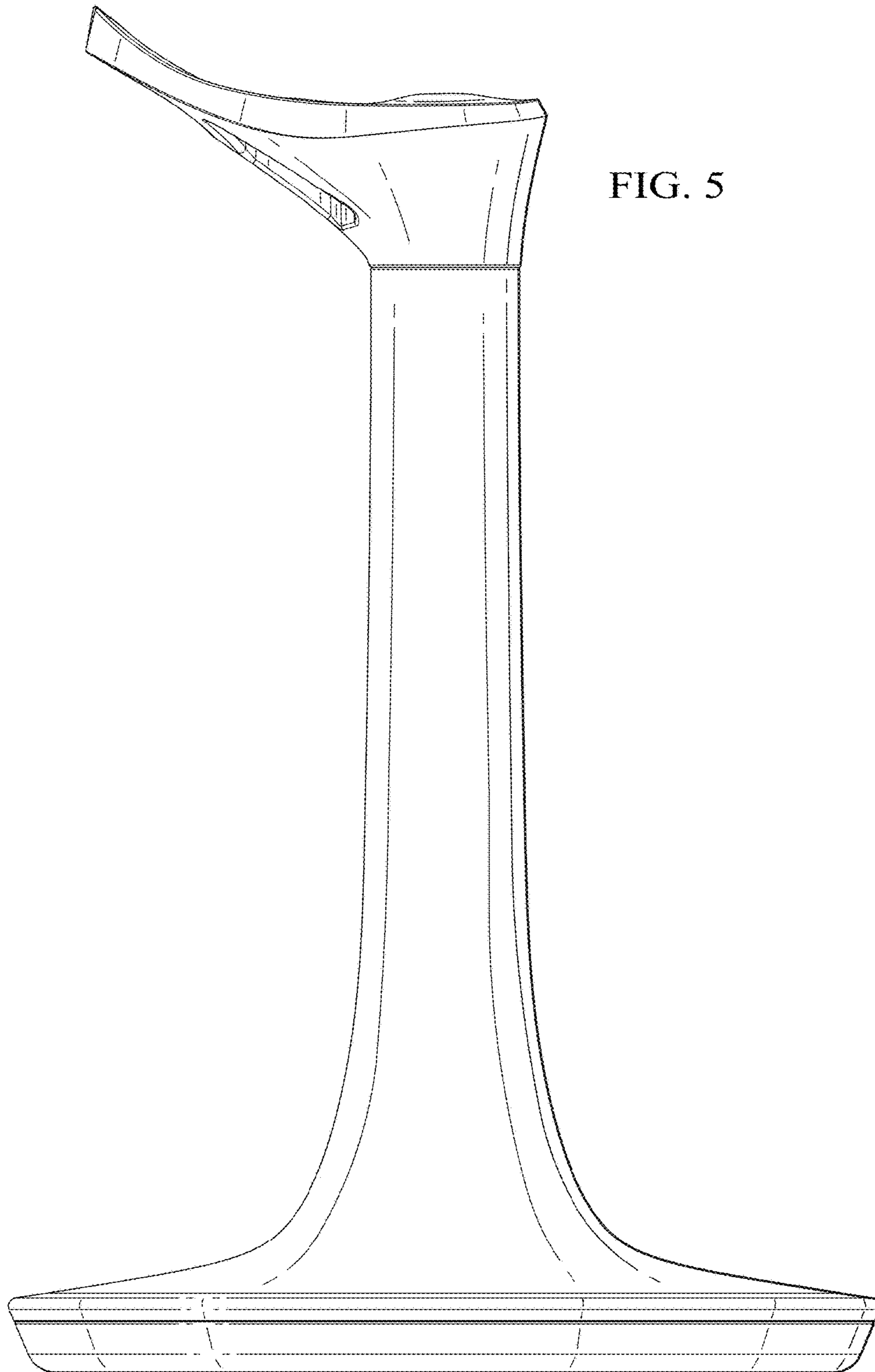

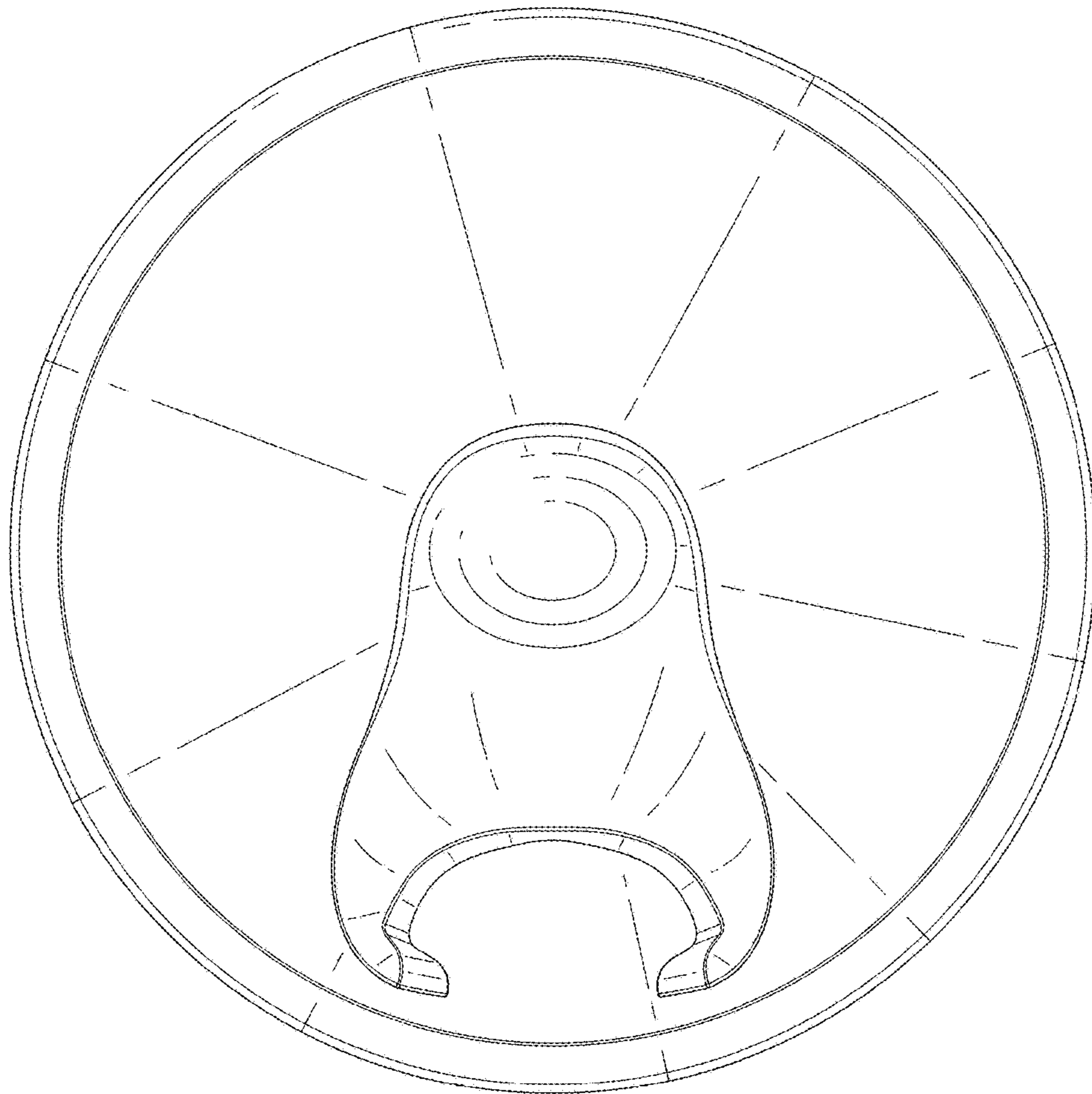

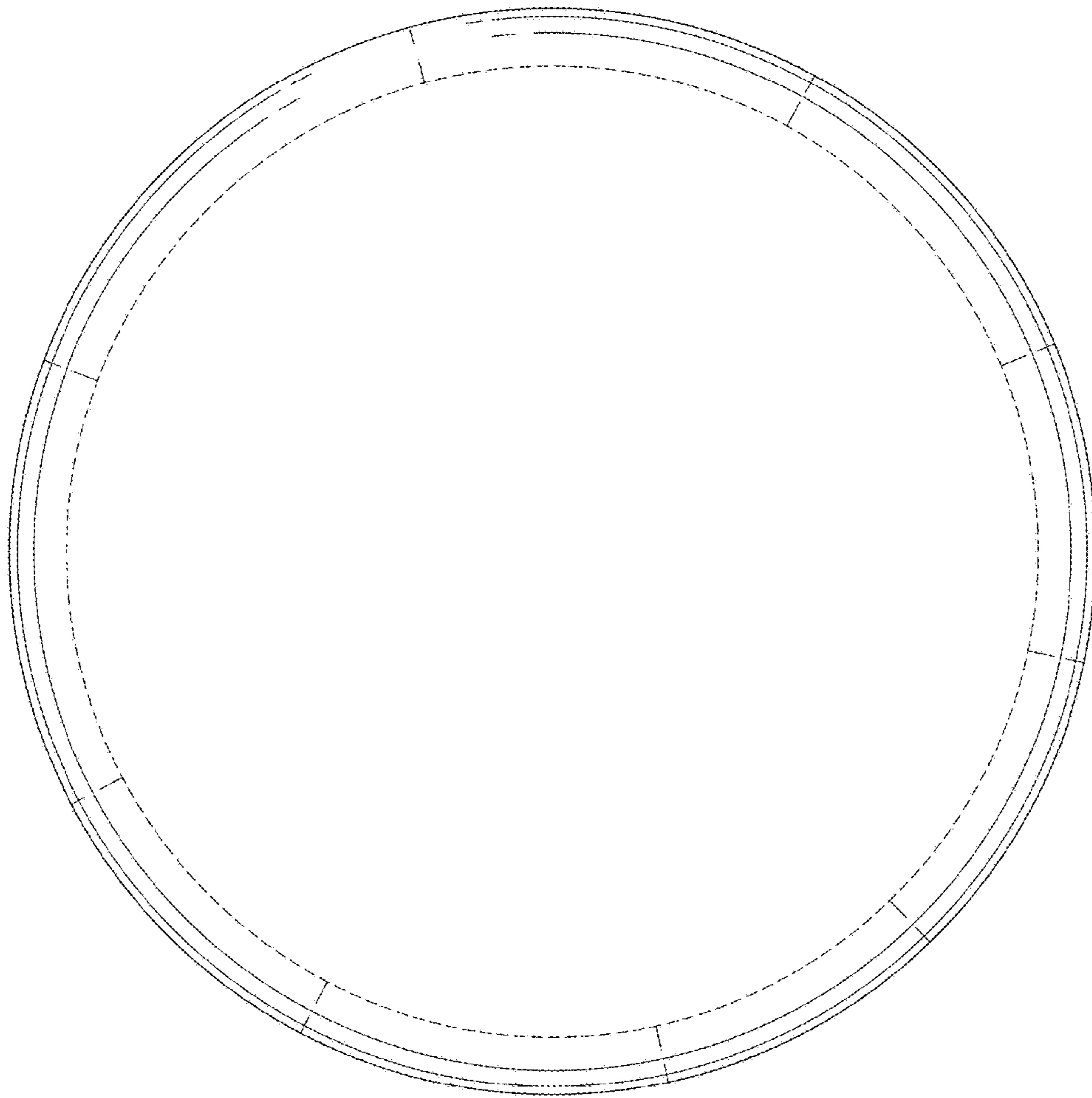

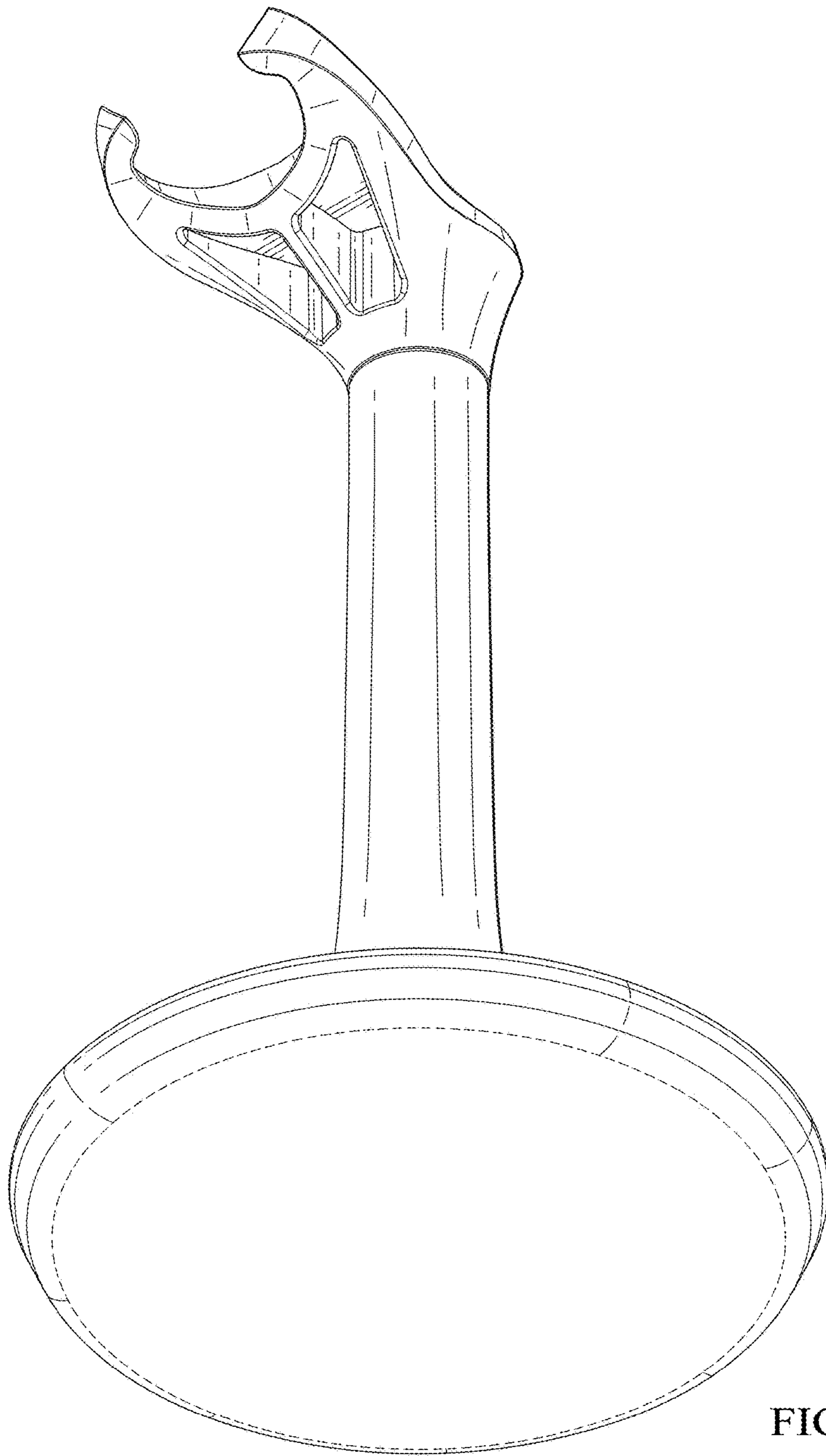
