(57) **CLAIM**

The ornamental design for a hand towel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hand worn towel, from a substantially front view. The dashed line proximate to a bottom side of the hand worn towel corresponds to the opening of the hand worn towel.

FIG. 2 is a front view of FIG. 1. The dashed line proximate to a bottom side of the hand worn towel corresponds to the opening of the hand worn towel.

FIG. 3 is a back view of FIG. 1.

FIG. 4 is a right-side view of FIG. 1.

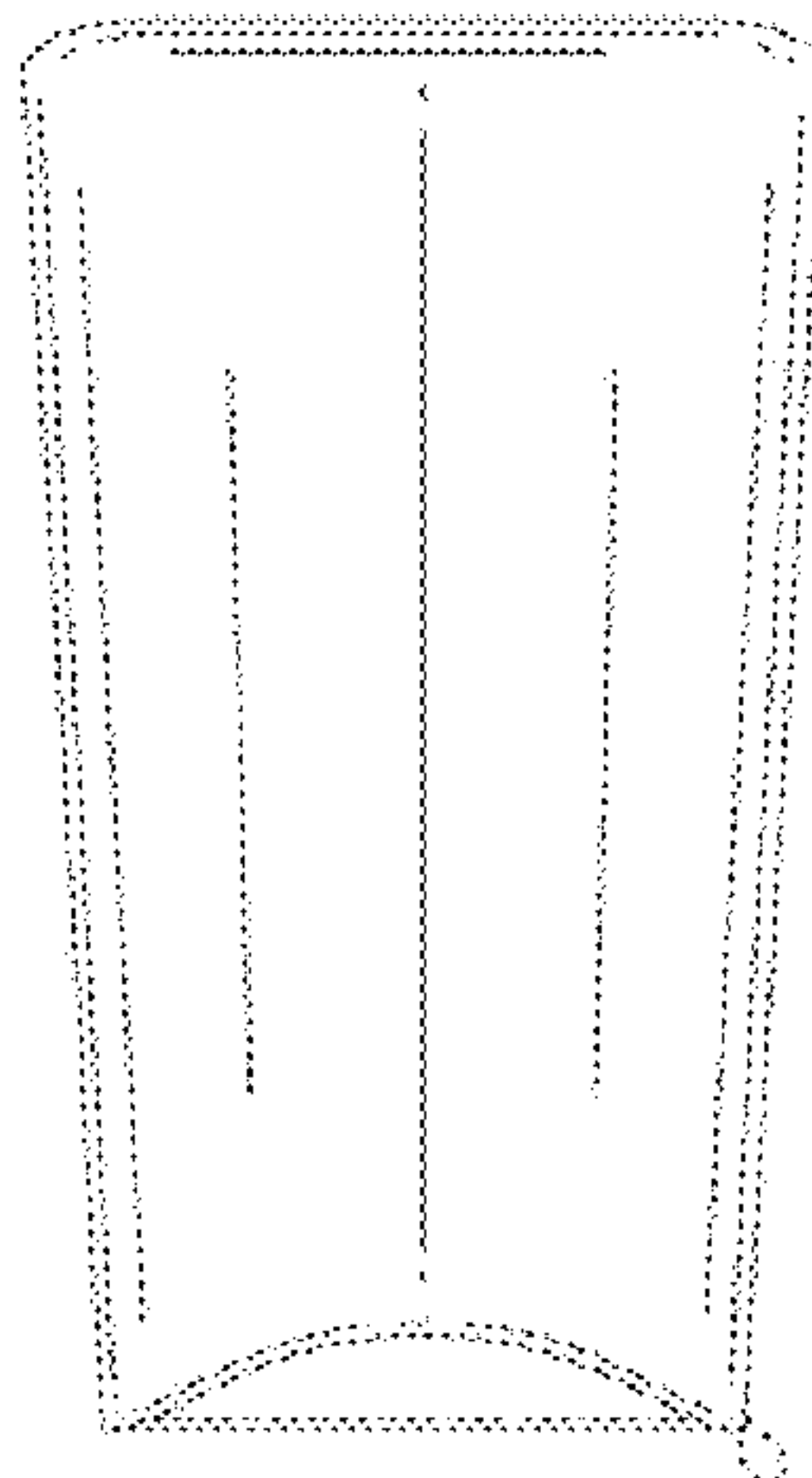
FIG. 5 is a left-side view of FIG. 1.

FIG. 6 is a top plan view of FIG. 1; and,

FIG. 7 is a bottom plan view of FIG. 1, The dashed line within the ovular bottom side bottom side corresponds to the opening of the hand worn towel.

The broken lines in the drawings illustrate portions of the hand worn towel that form no part of the claimed design. The claimed design extends to the broken the boundaries but does not include the broken line boundaries or the area within the boundaries.

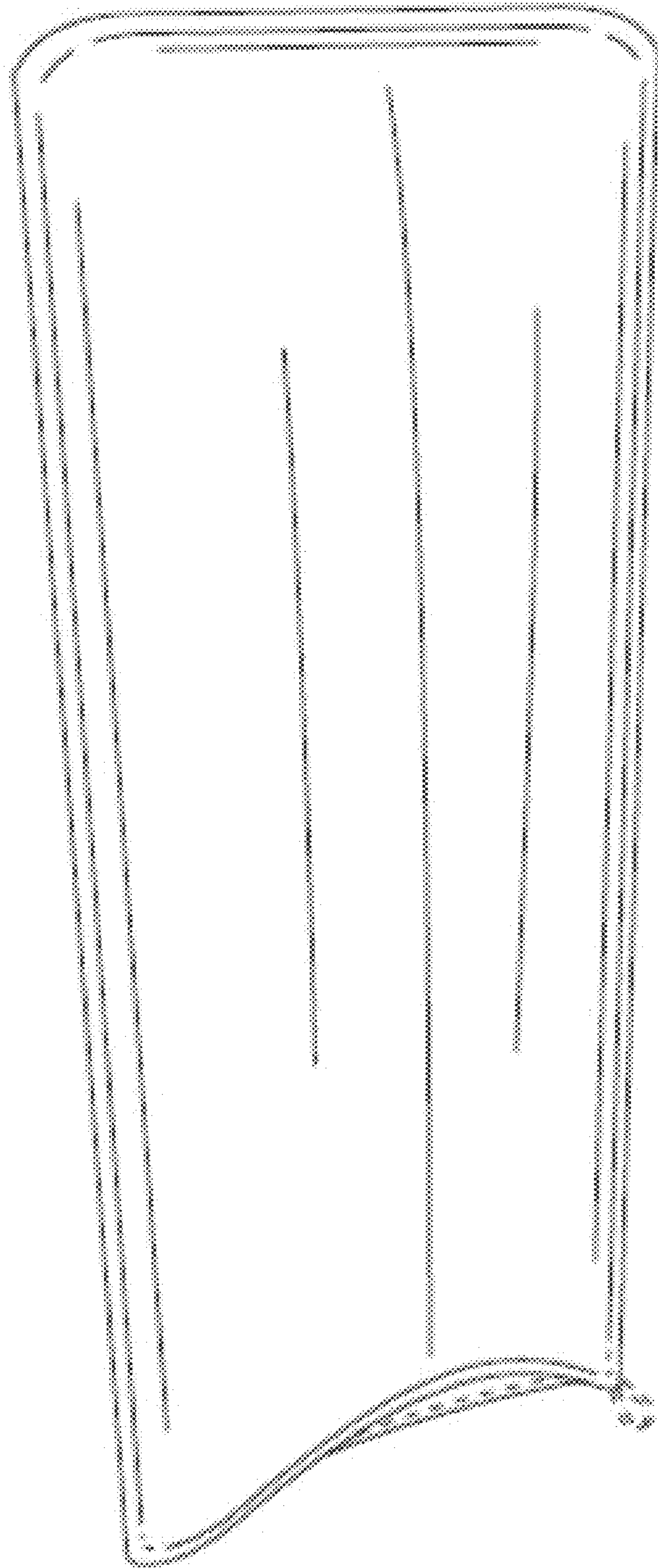

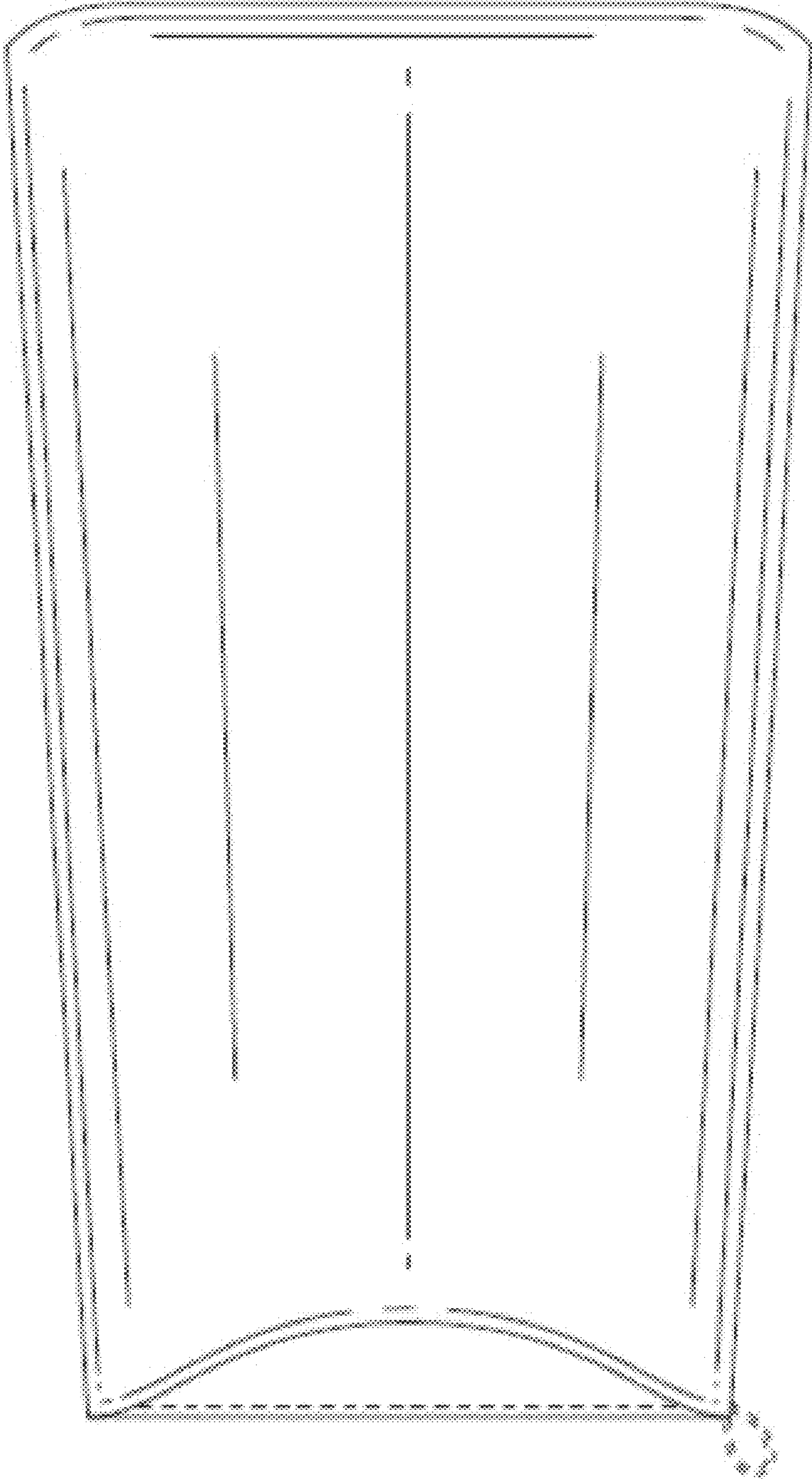

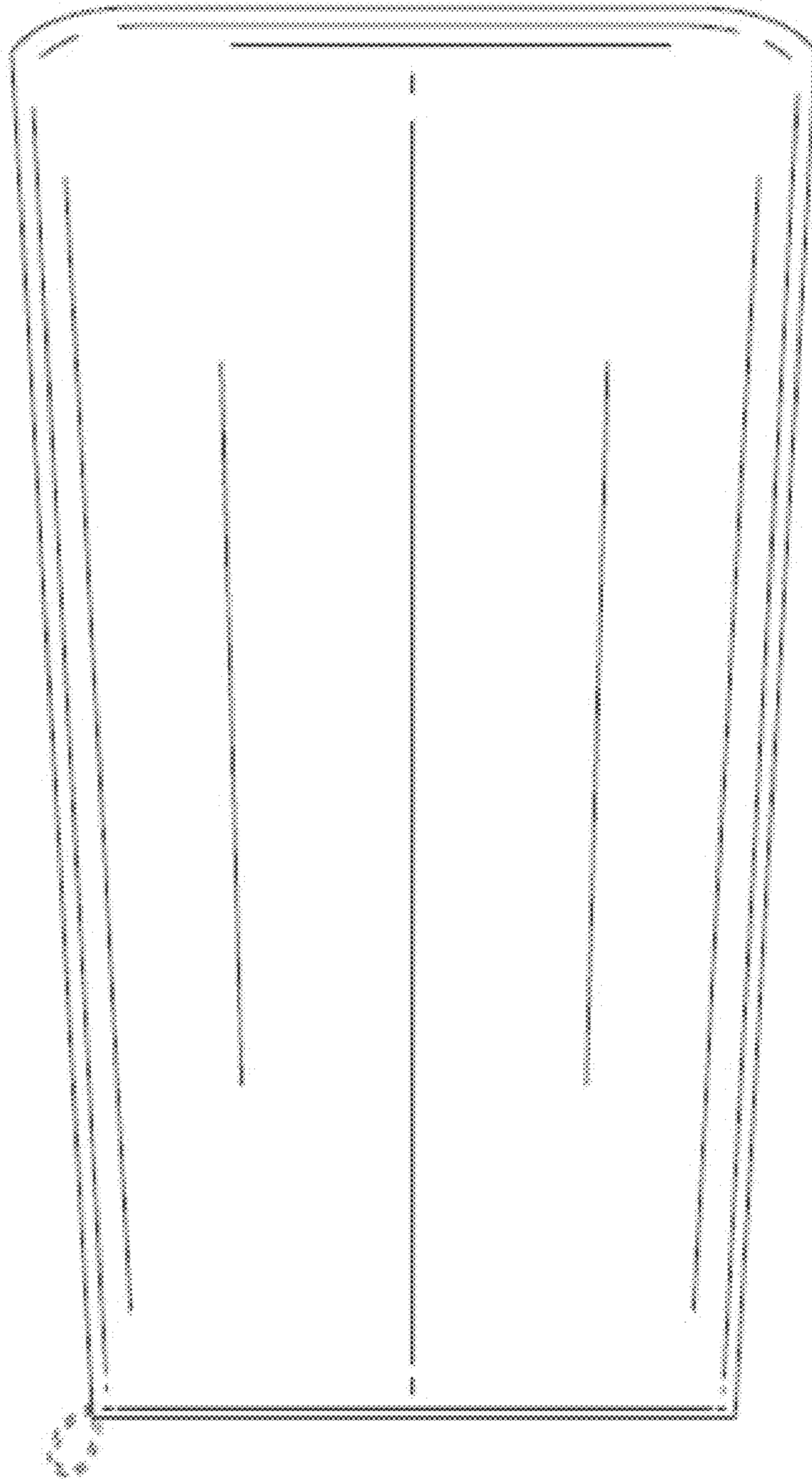

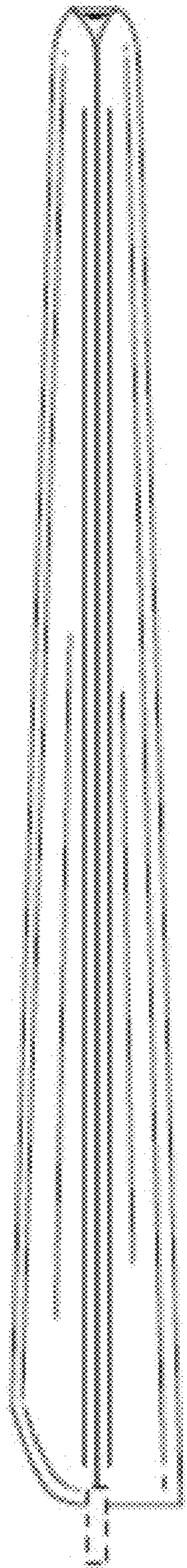

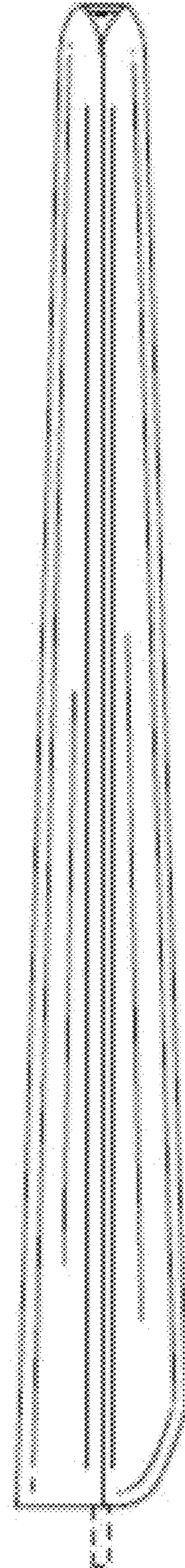

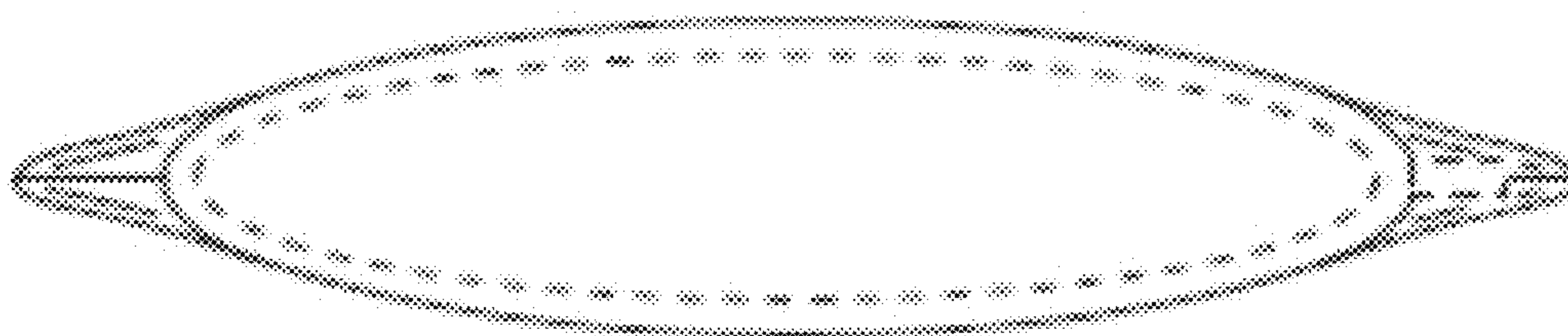
