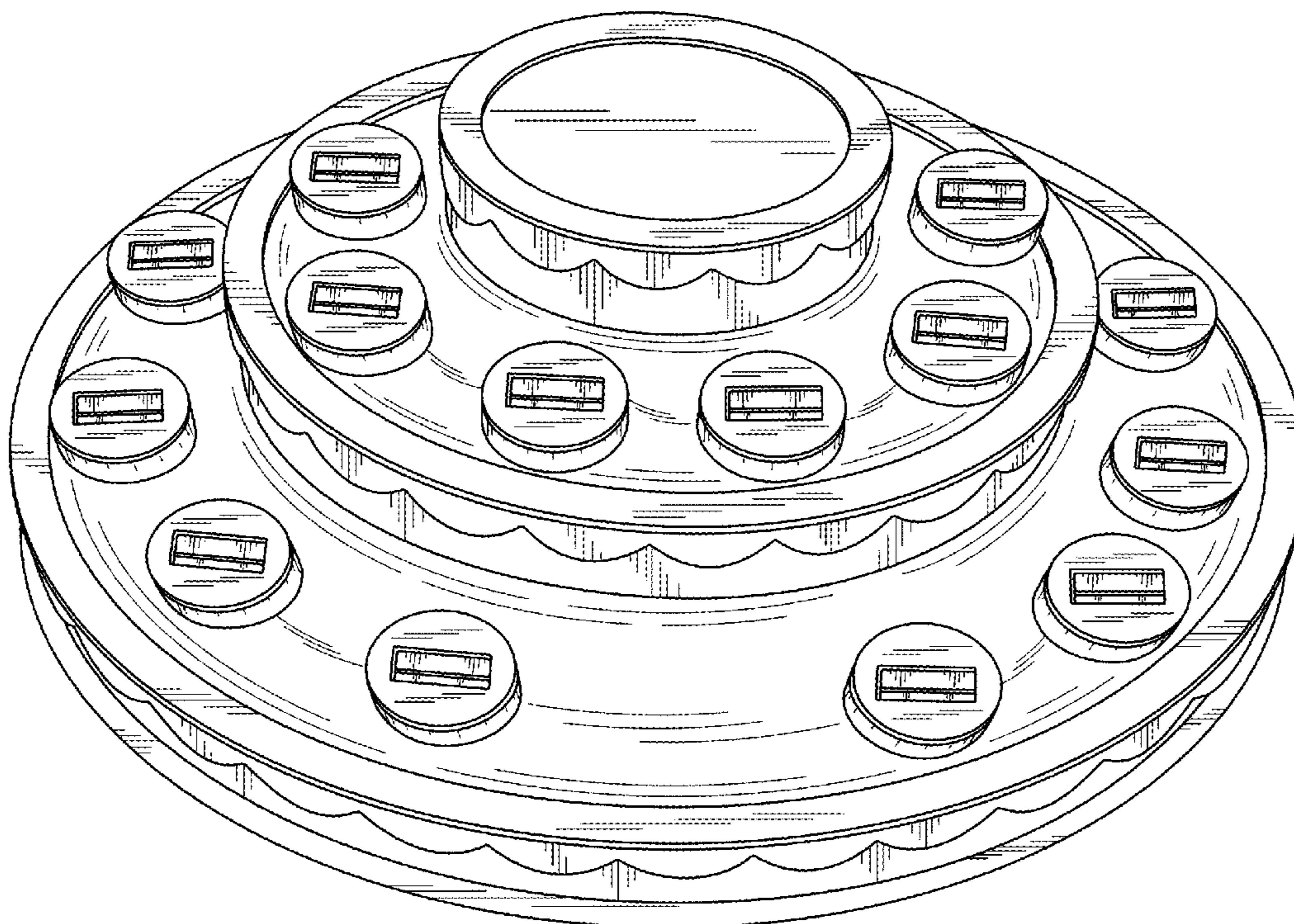
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top-front perspective view of the jewelry display, showing my new design;

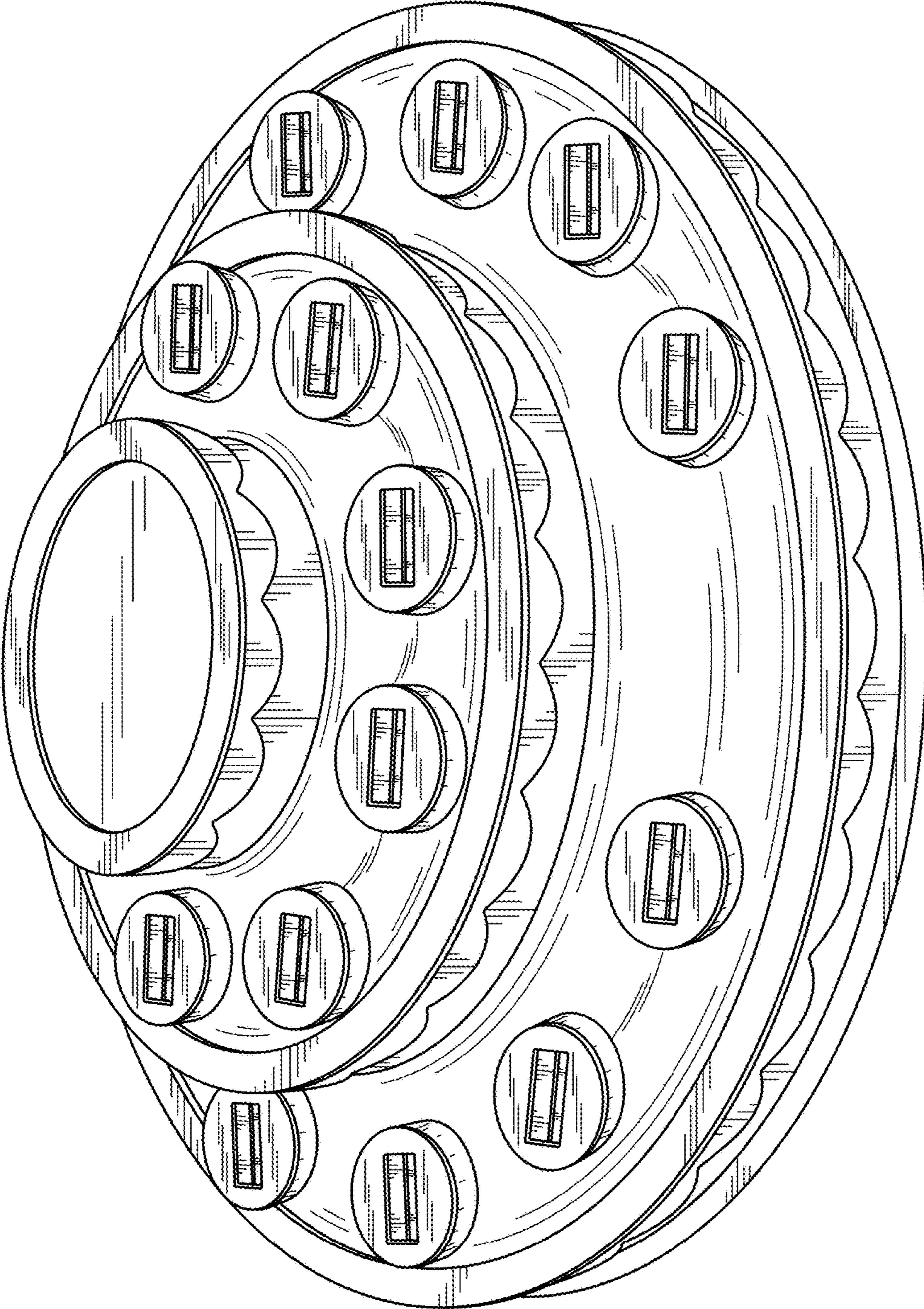

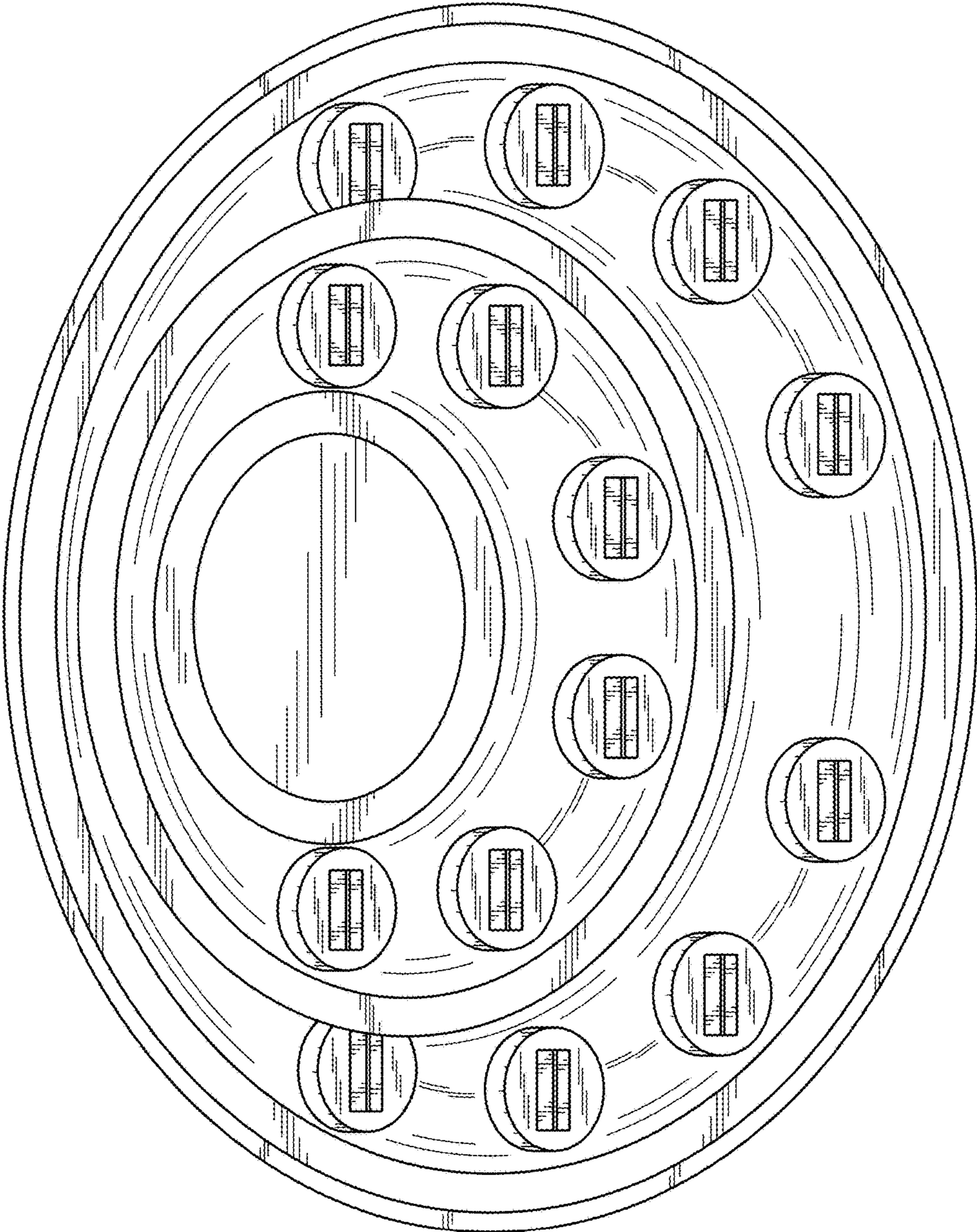

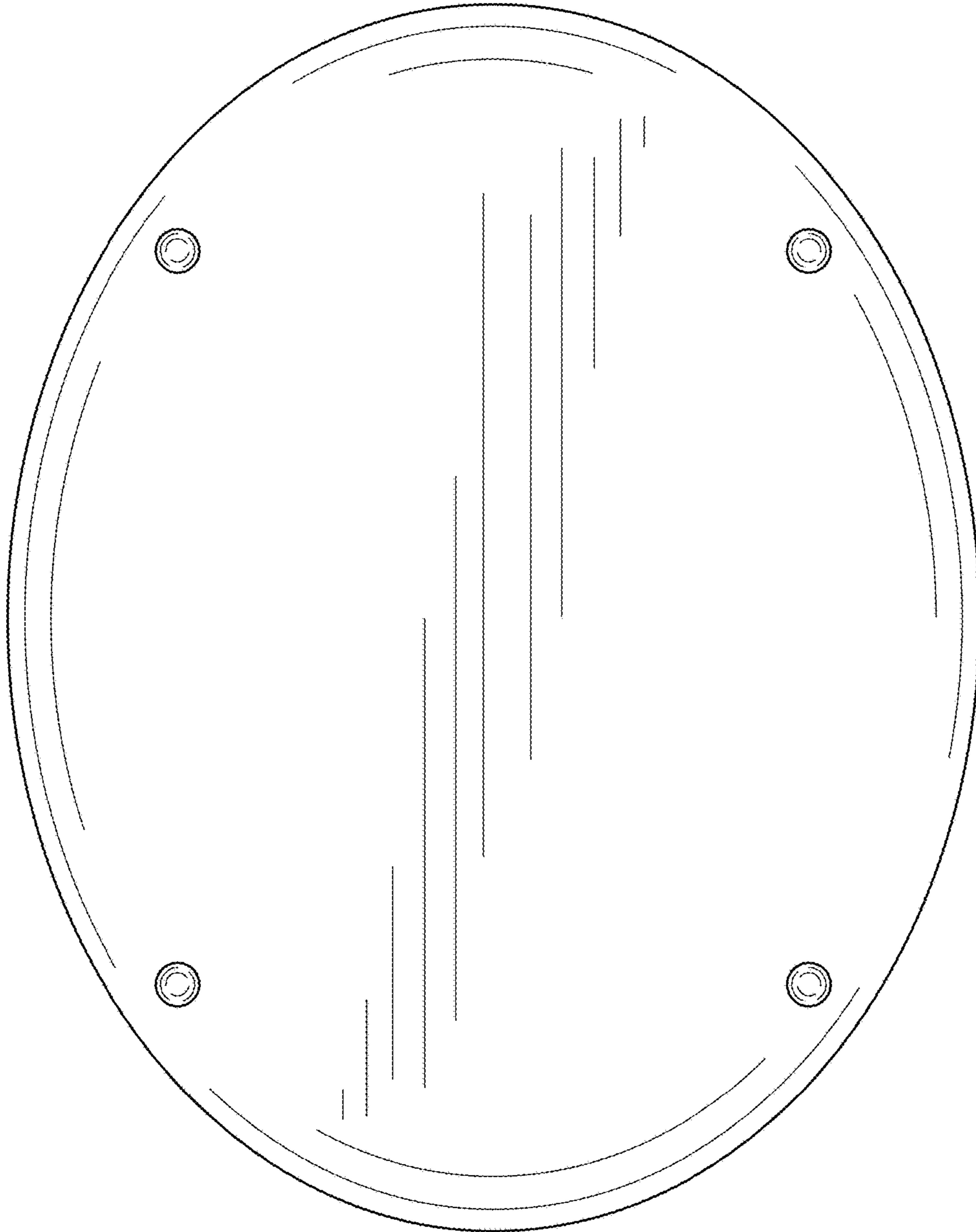

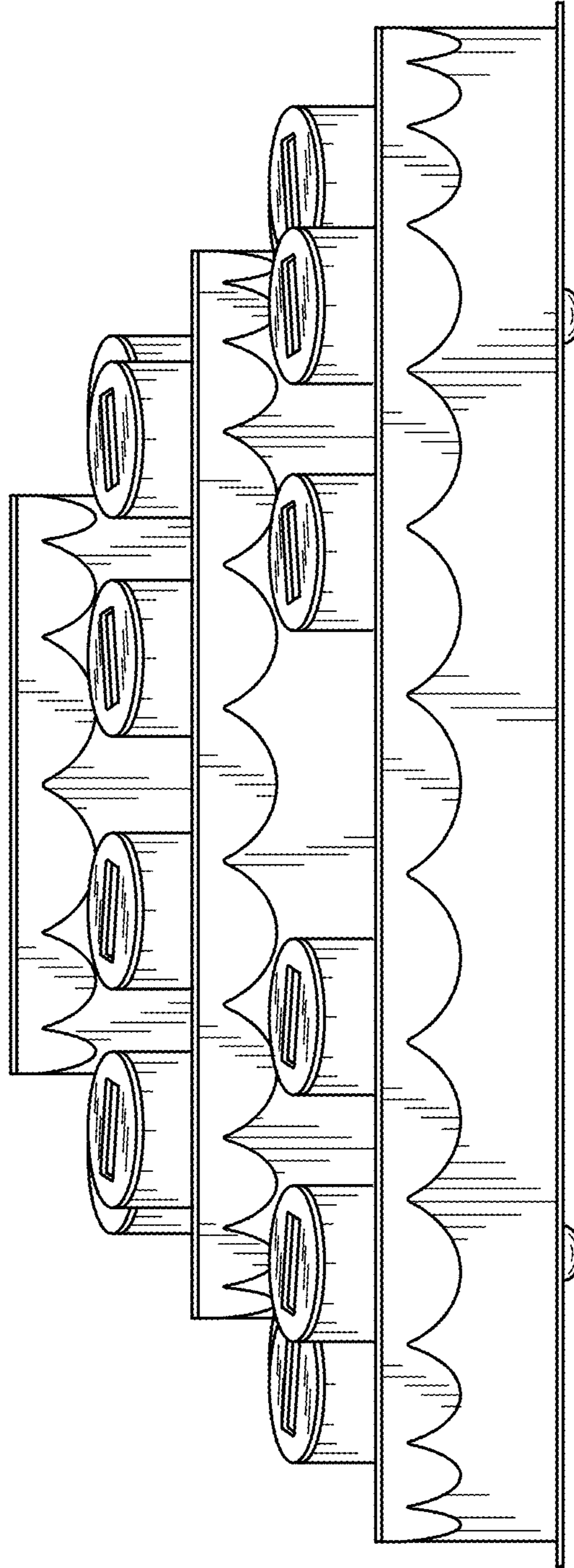

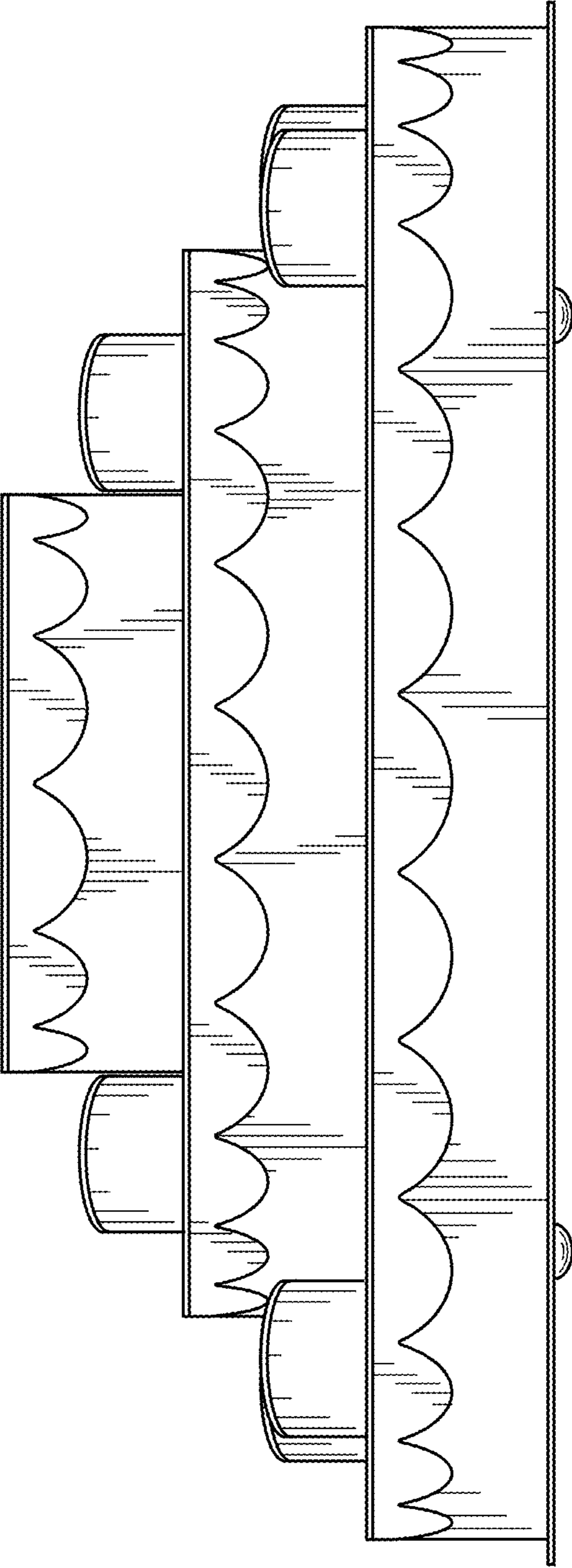

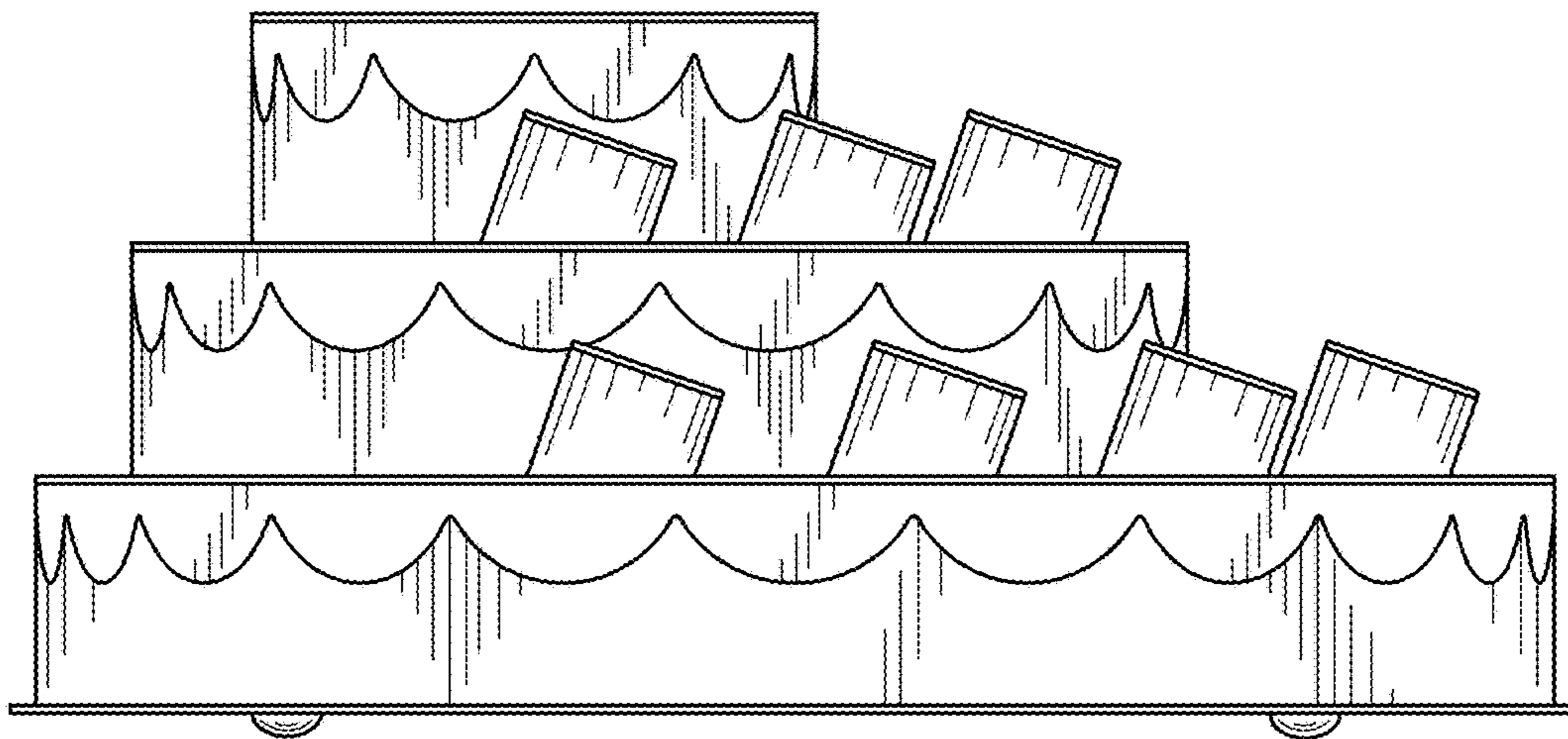

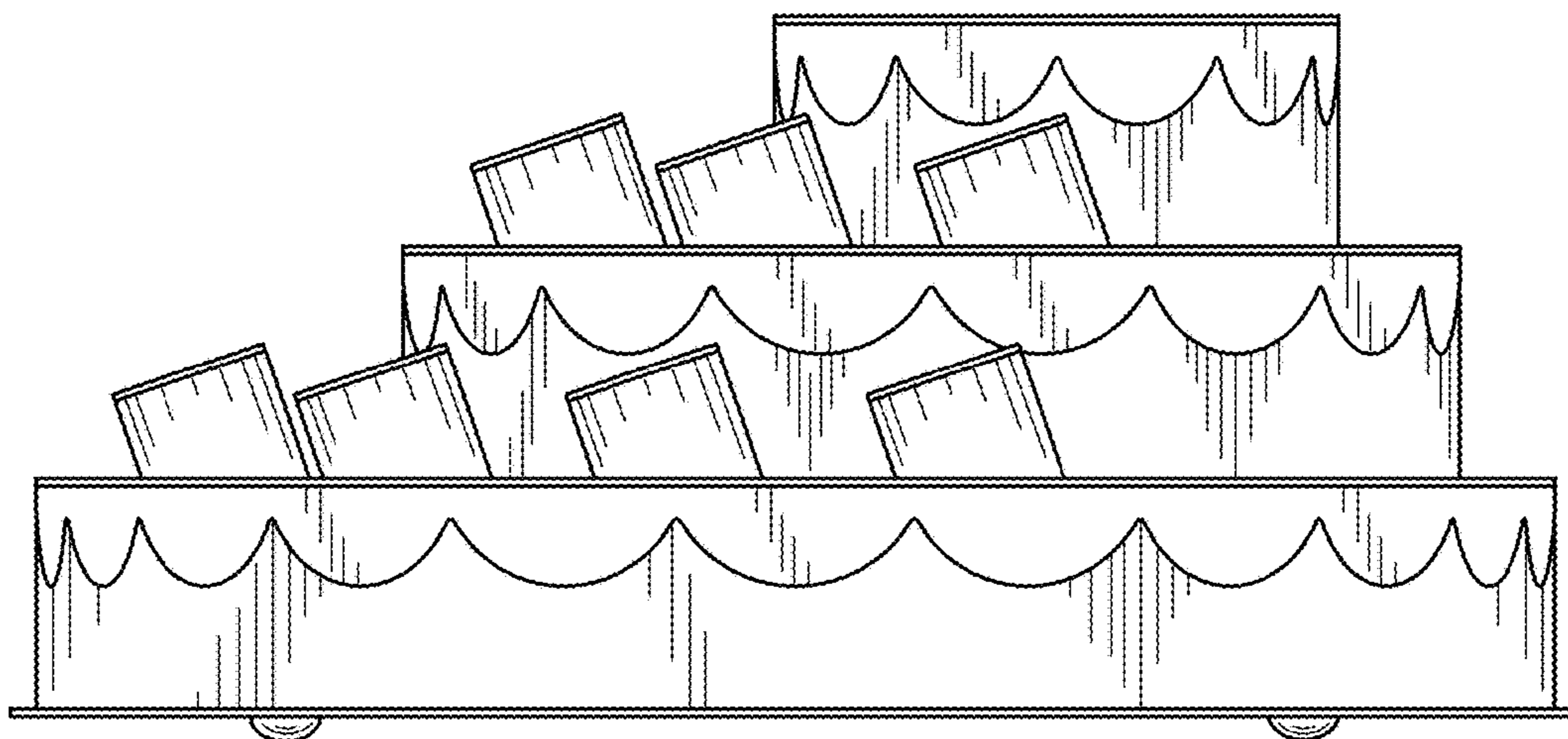
