FIG. 1 is a perspective view of a table showing my new design;

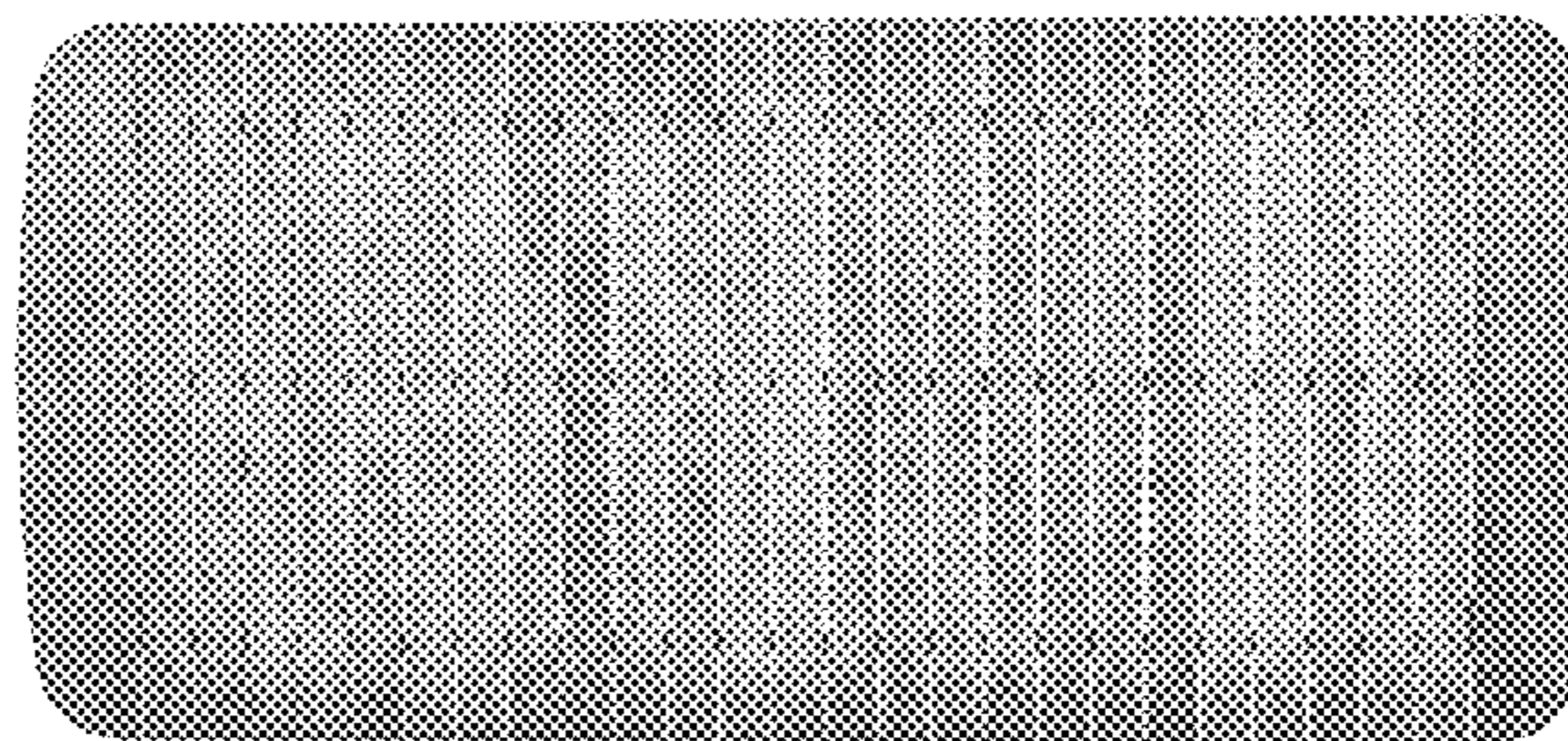
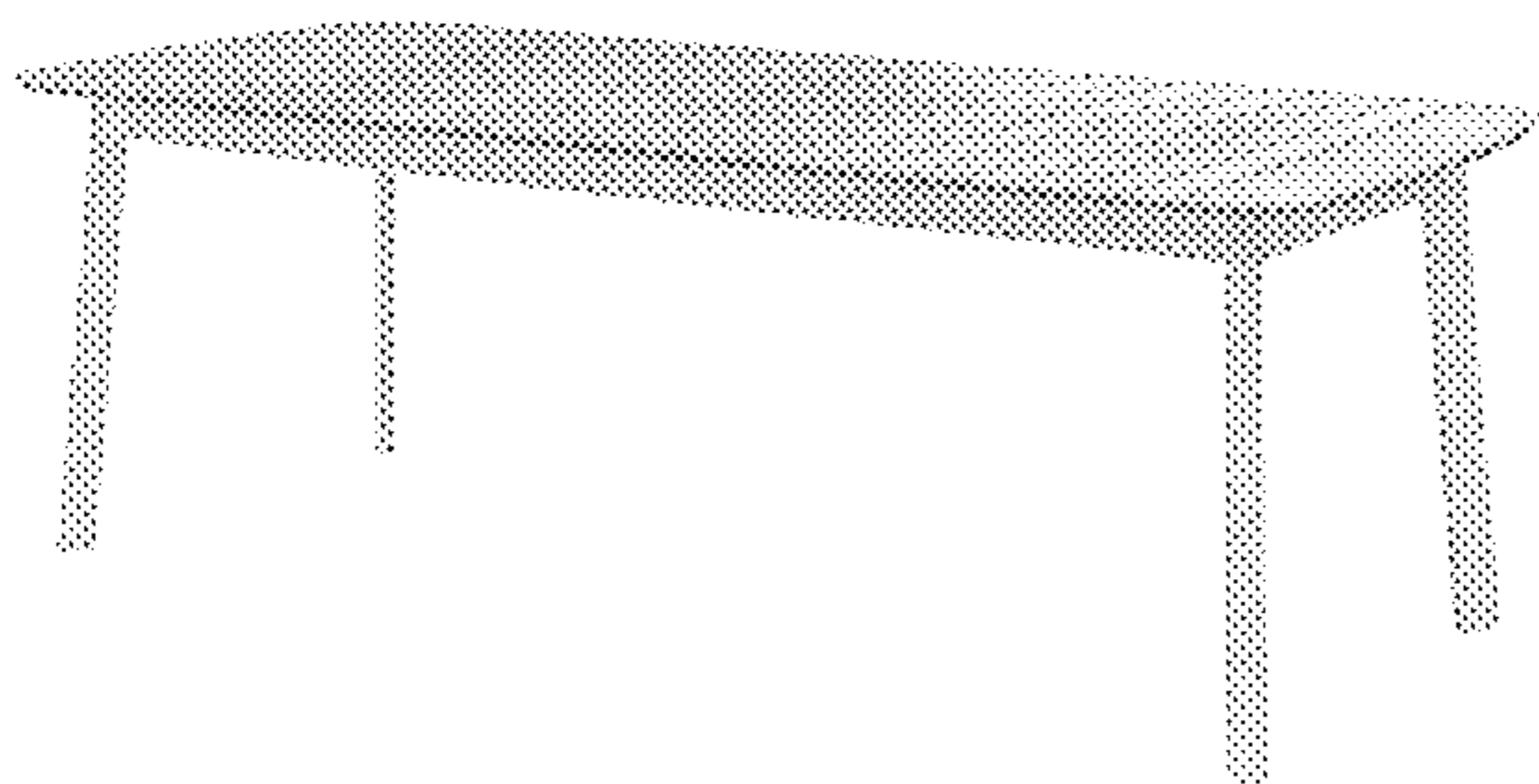
FIG. 2 is a front elevational view thereof, the rear elevation being a mirror image;

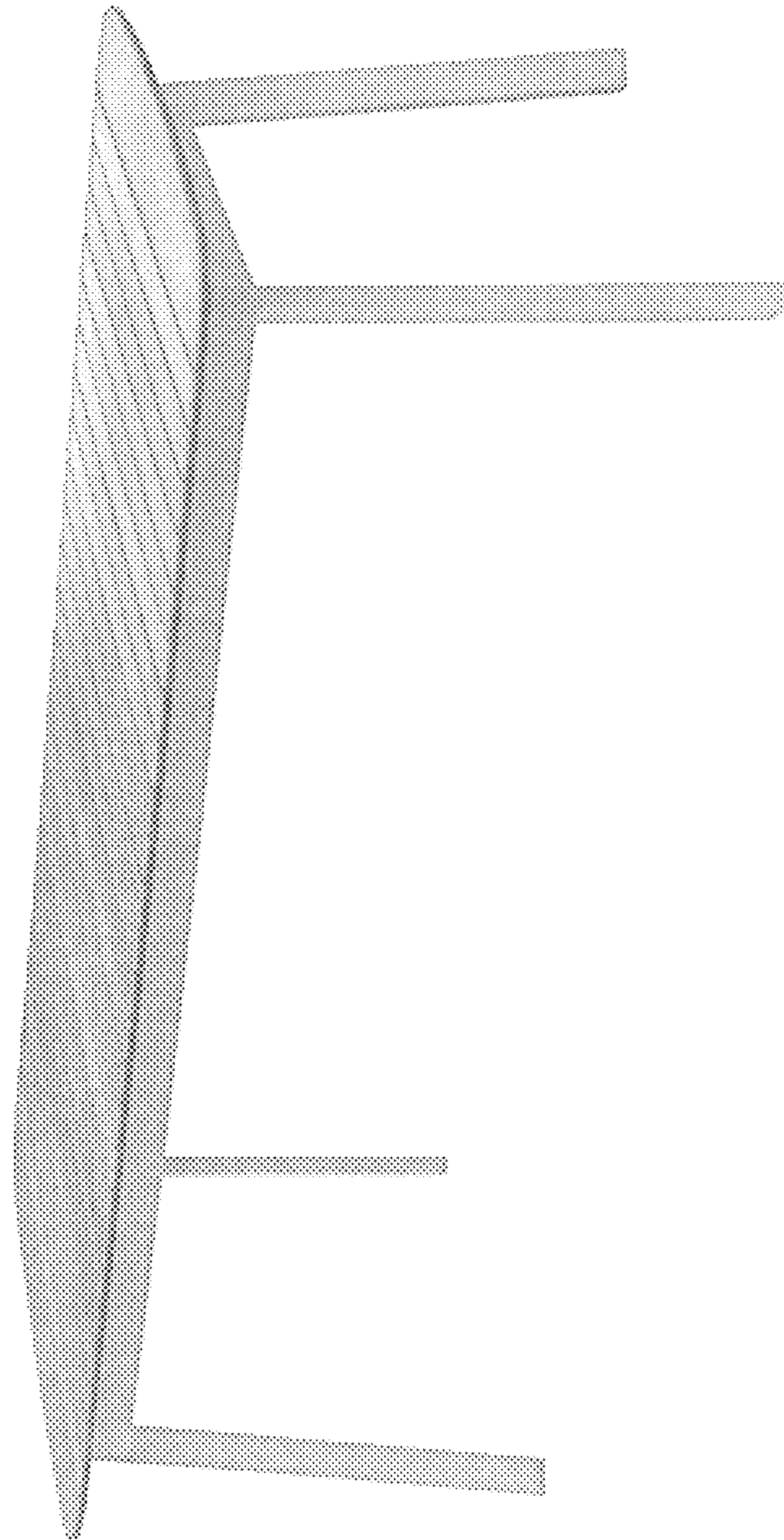

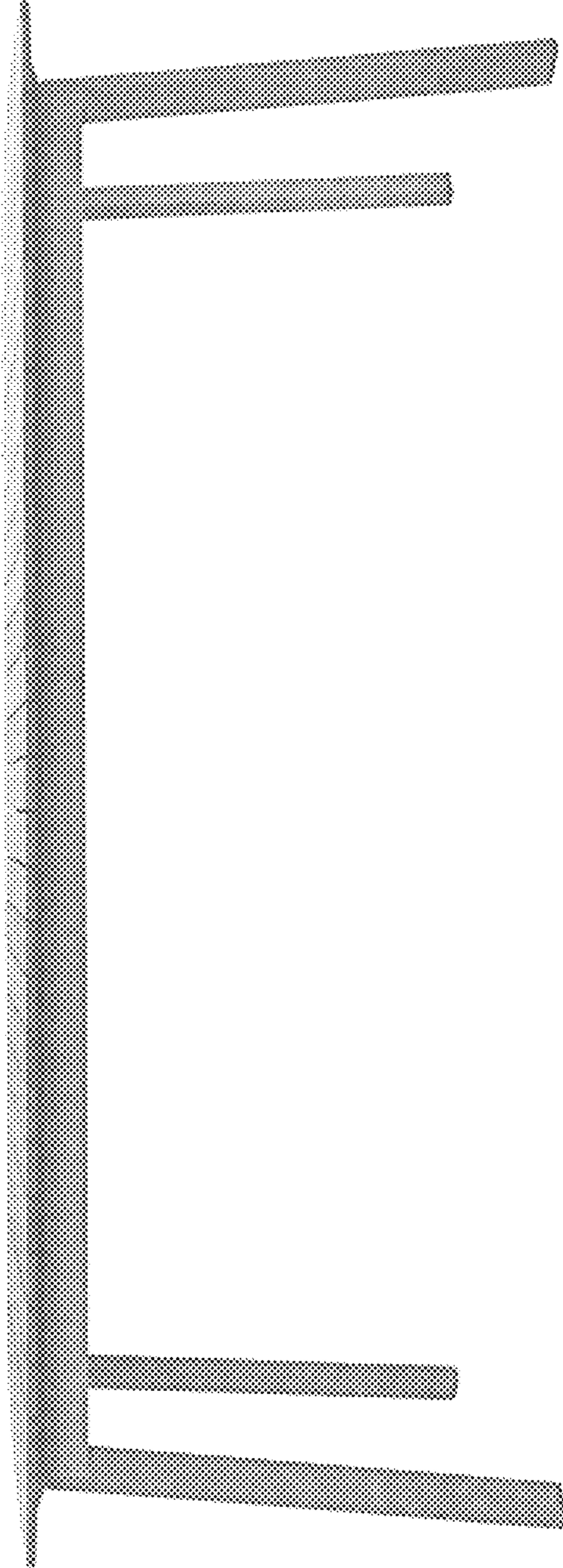

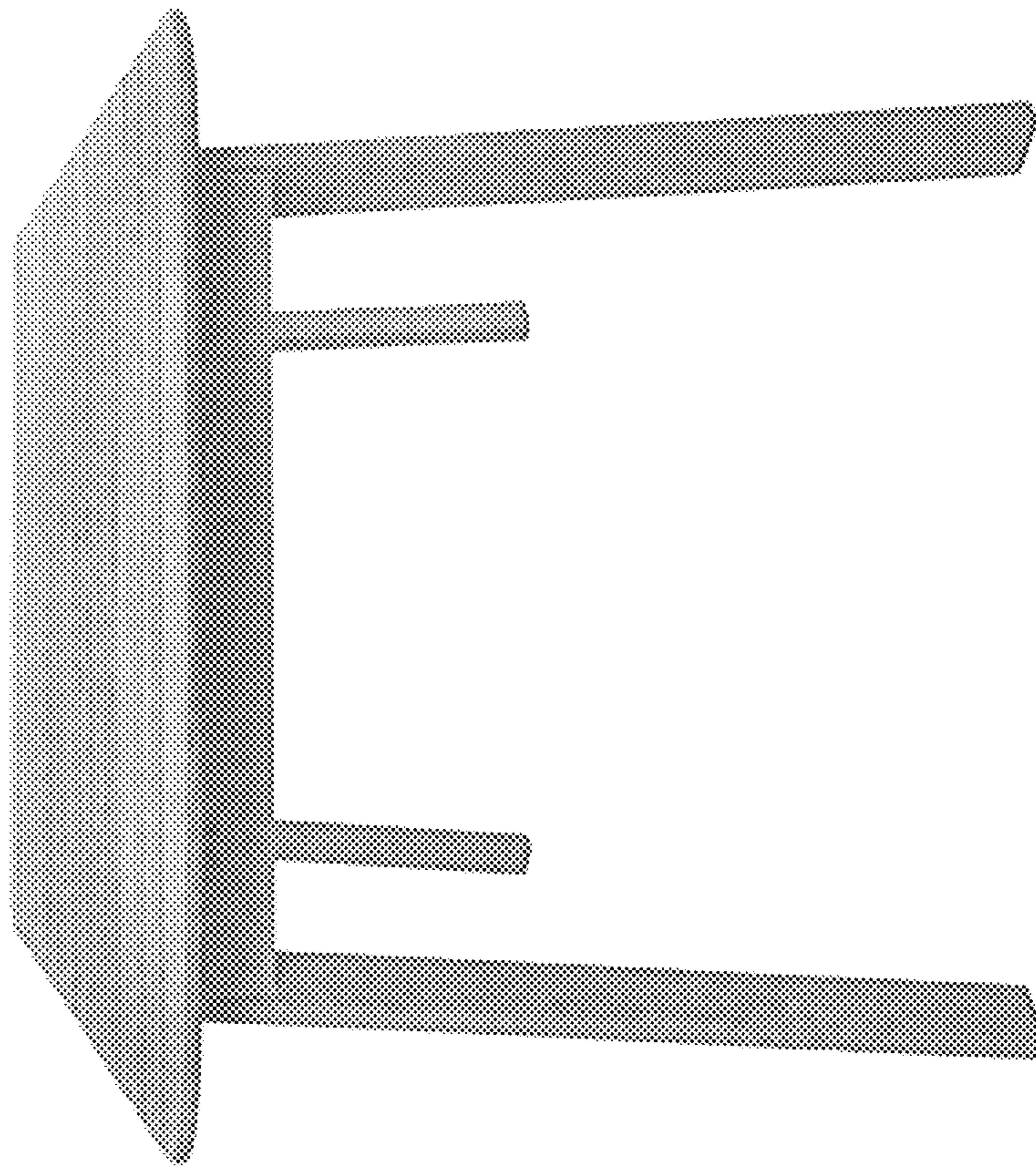

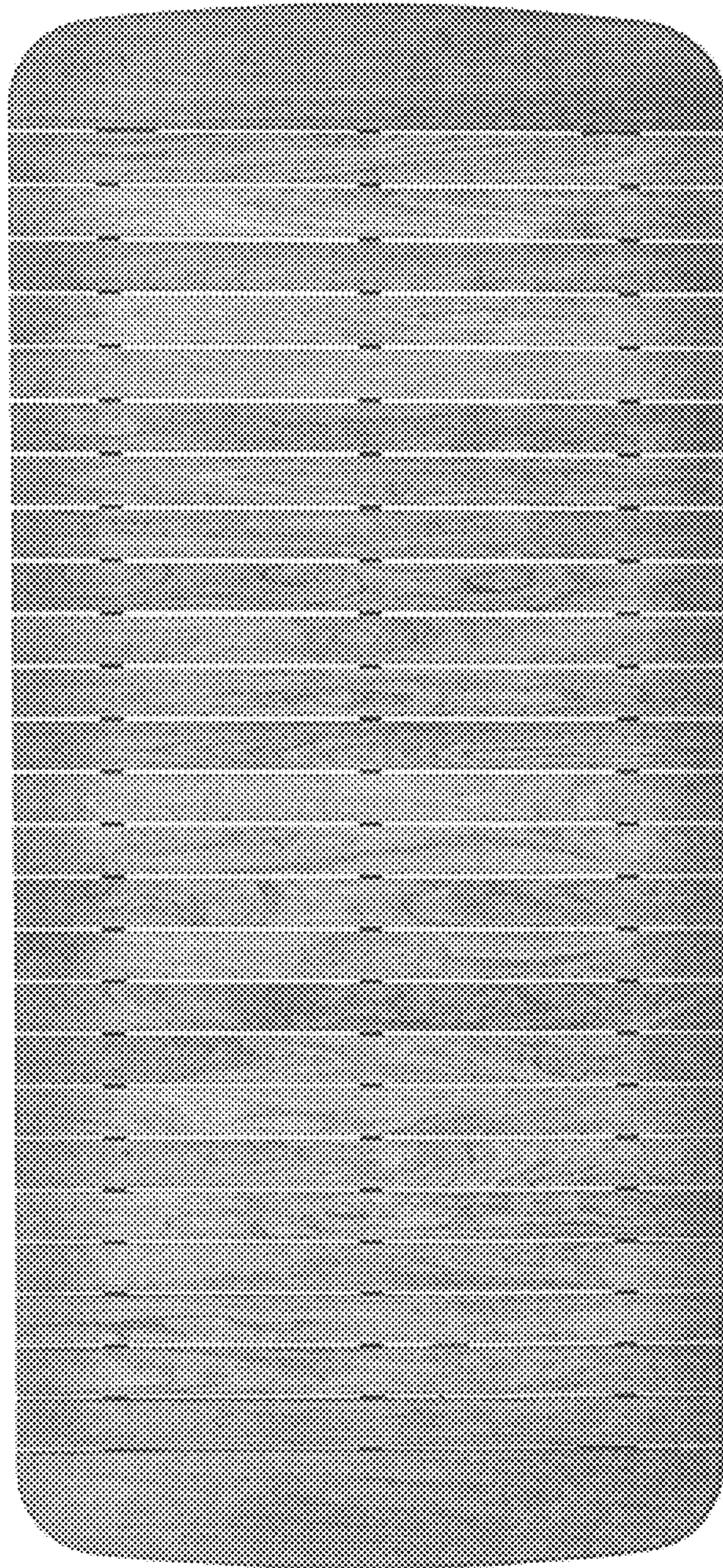

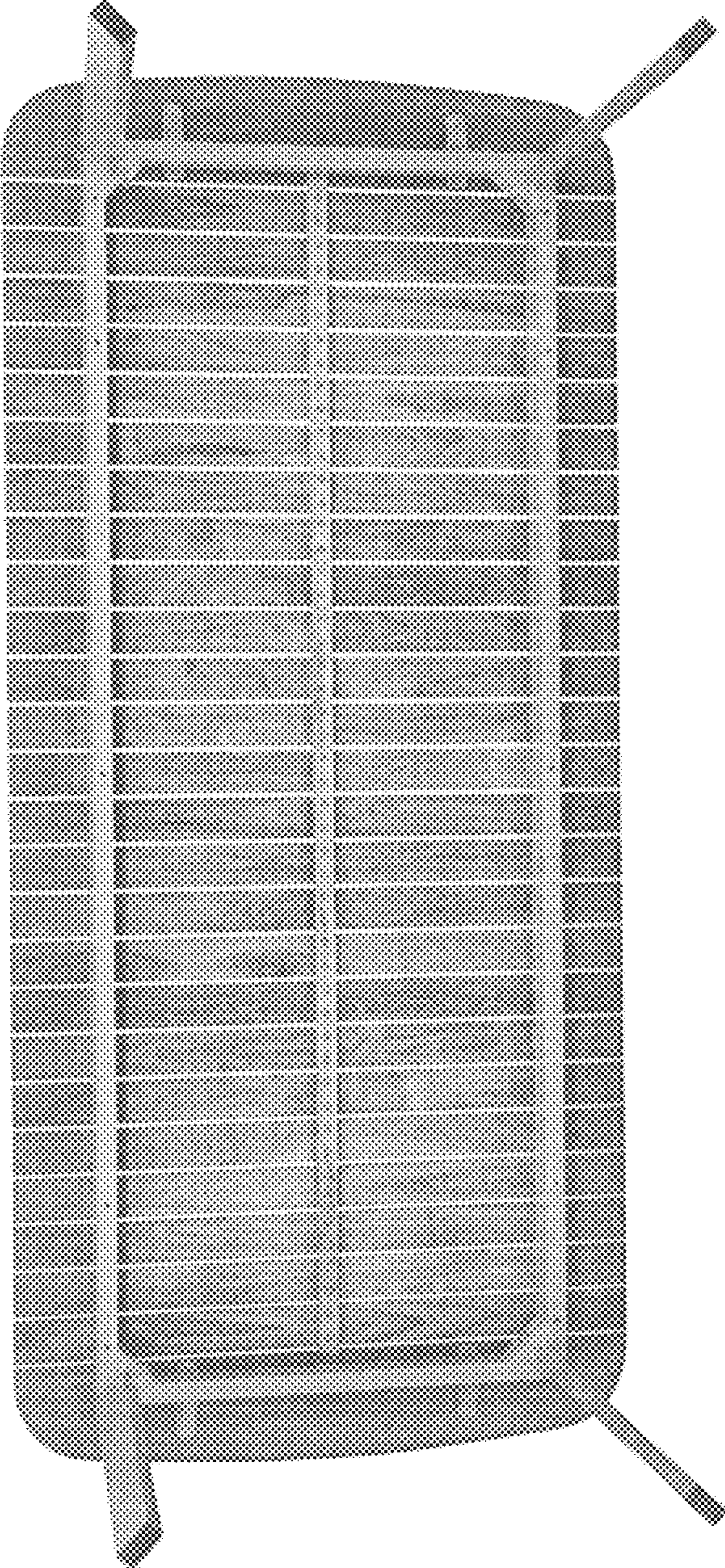
