FIG. 4 is a top end view thereof;

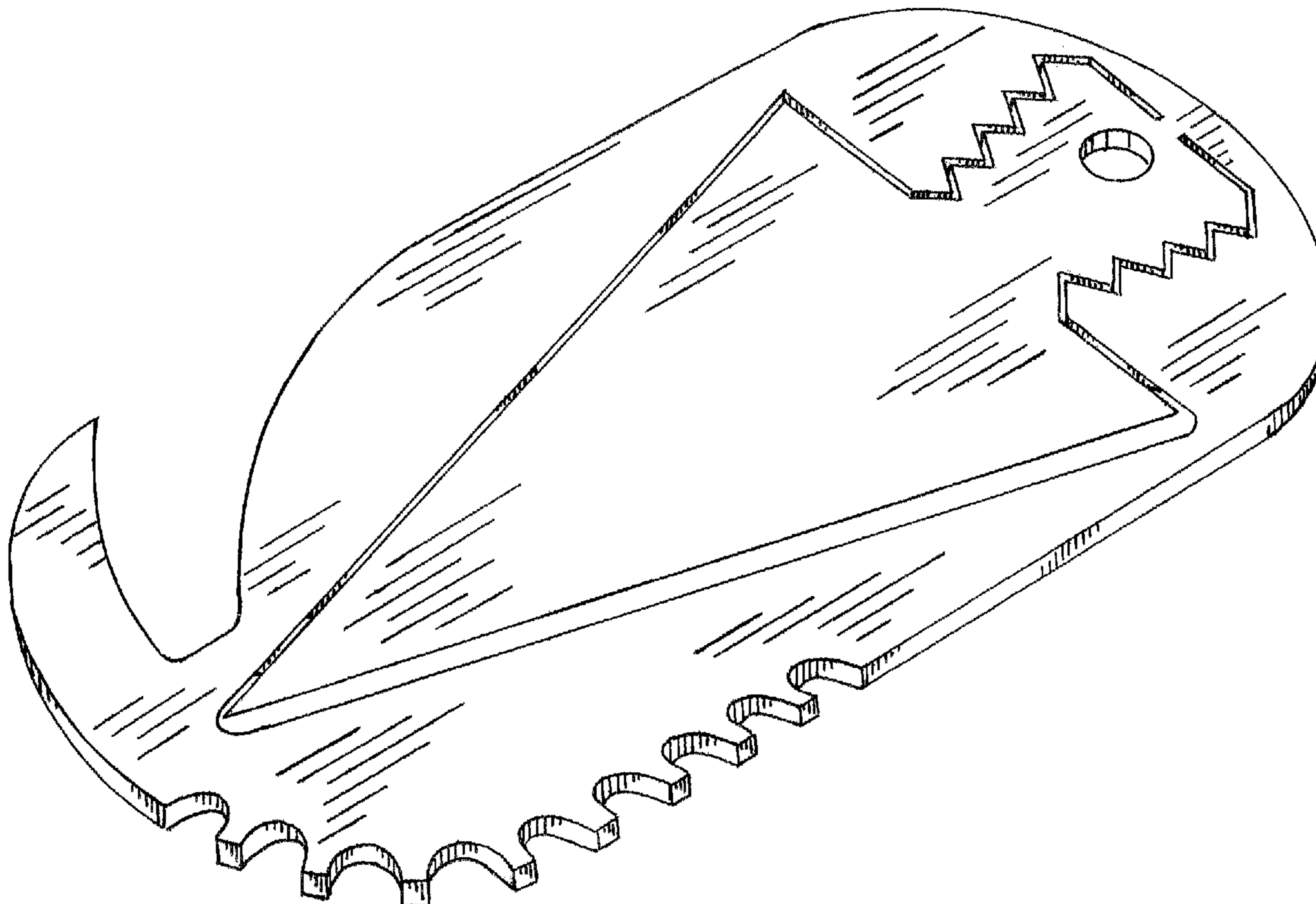
FIG. 5 is a bottom end view thereof;

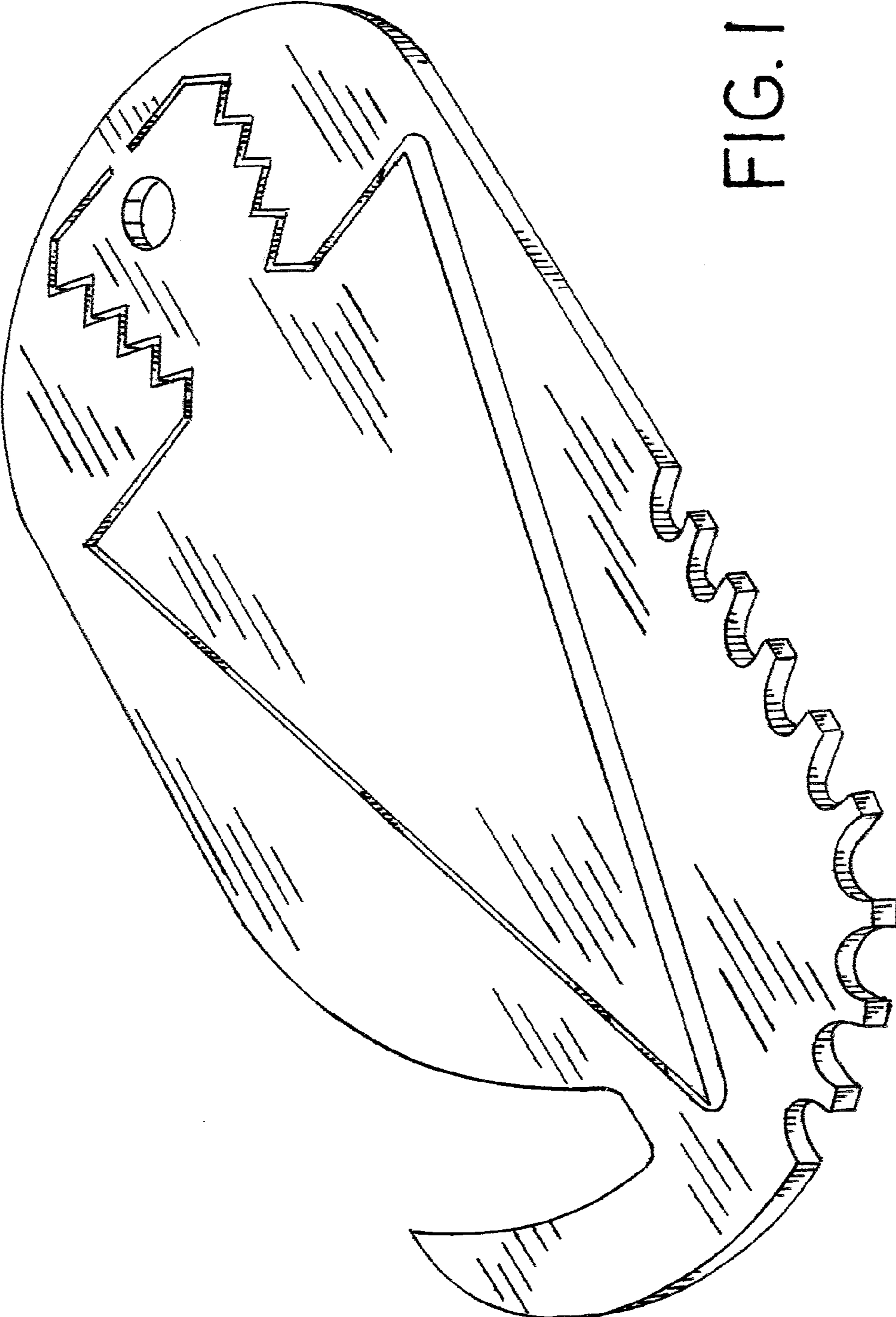

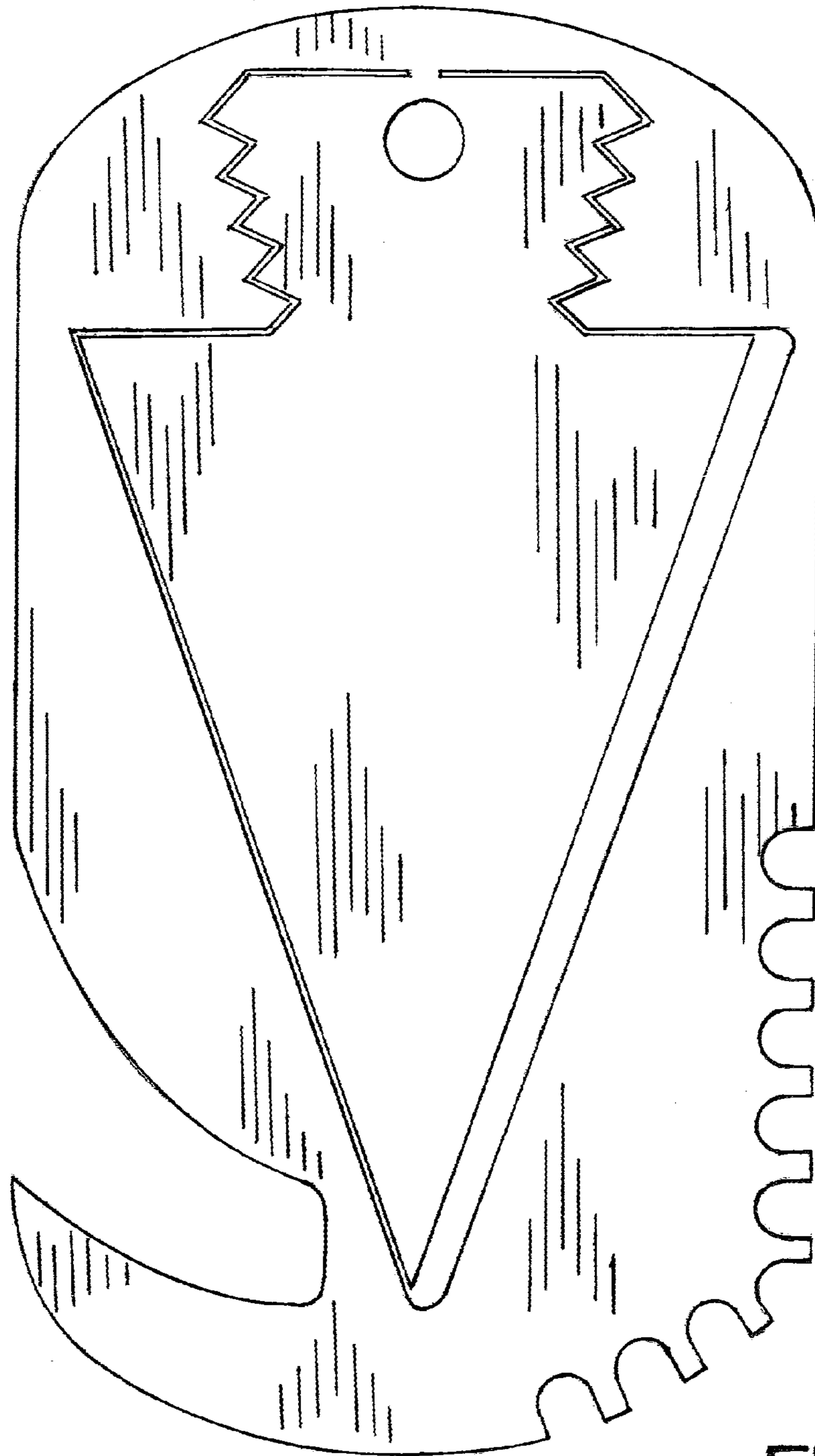

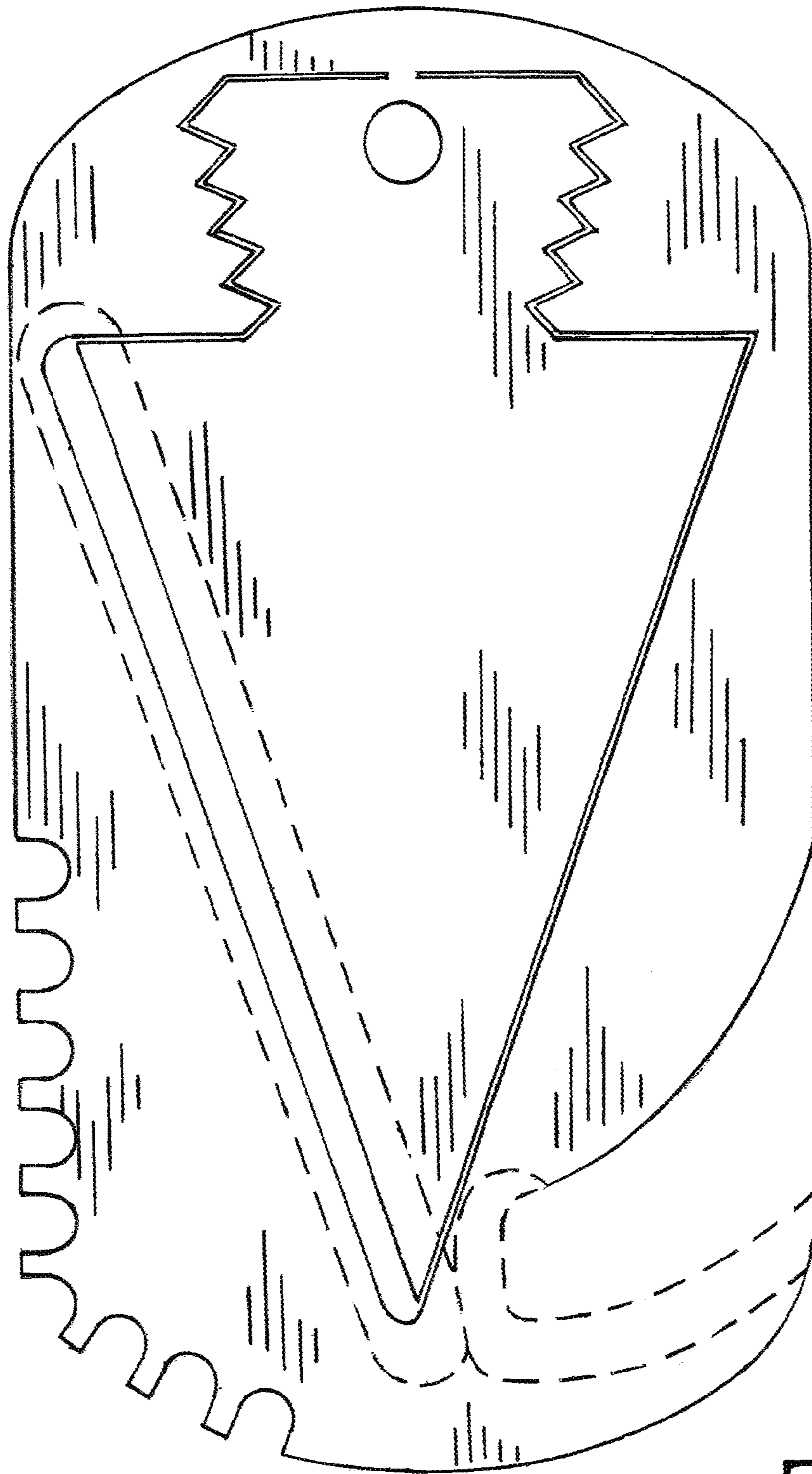

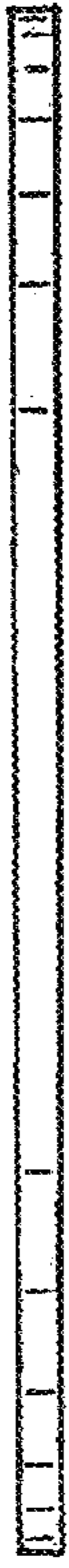

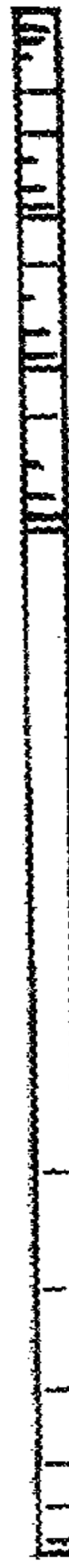
