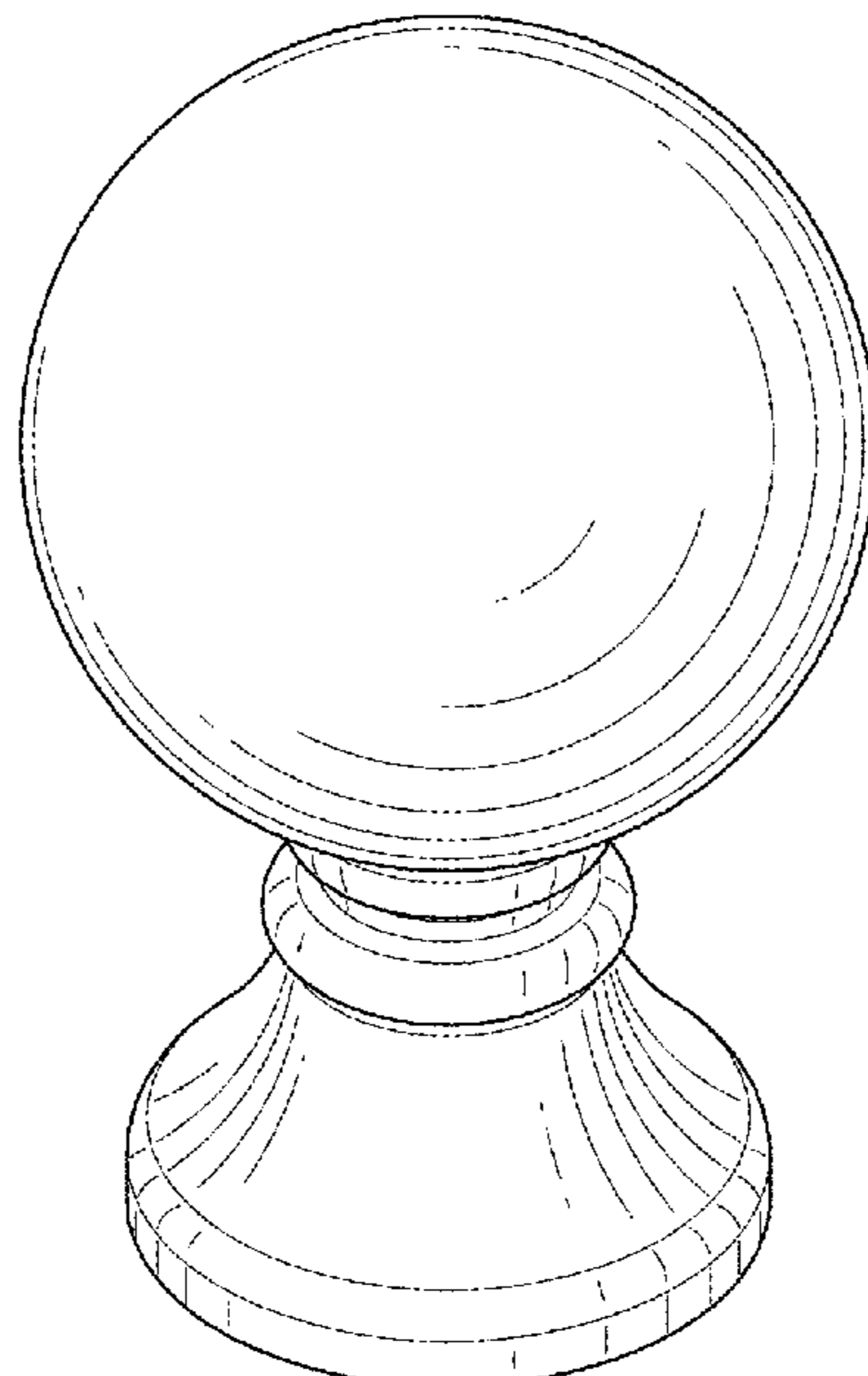
The ornamental design for a cabinet knob, as shown and described.

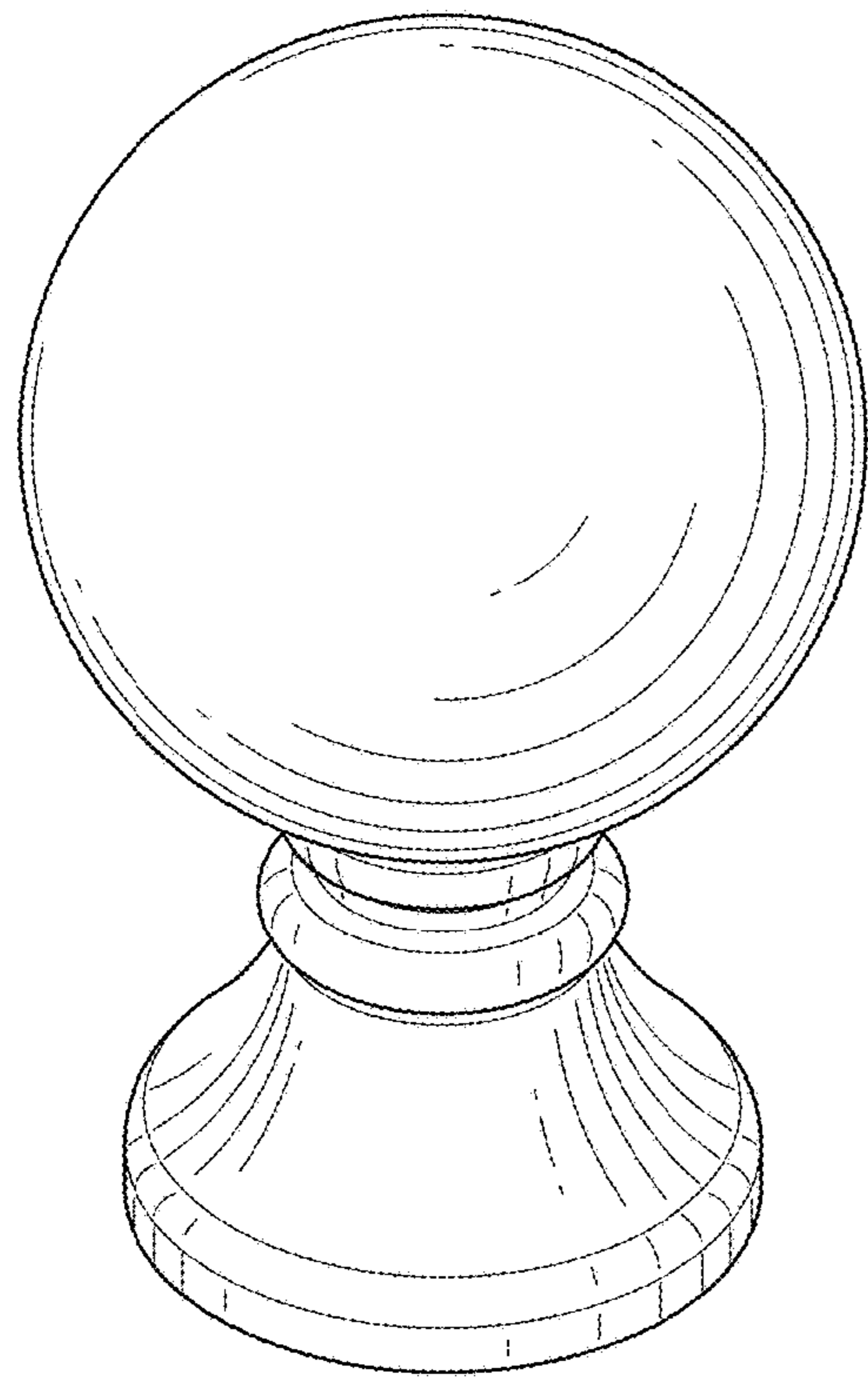

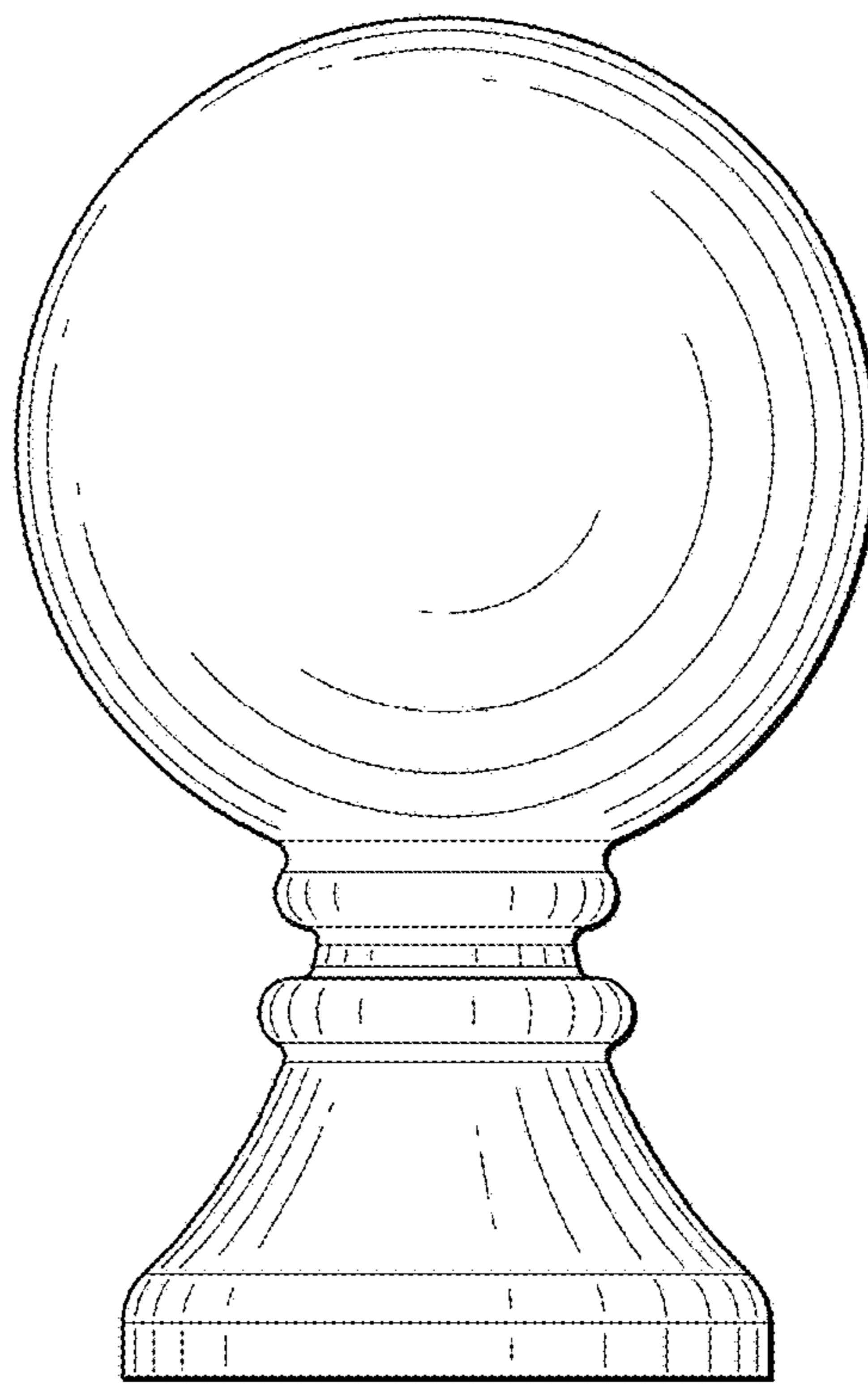

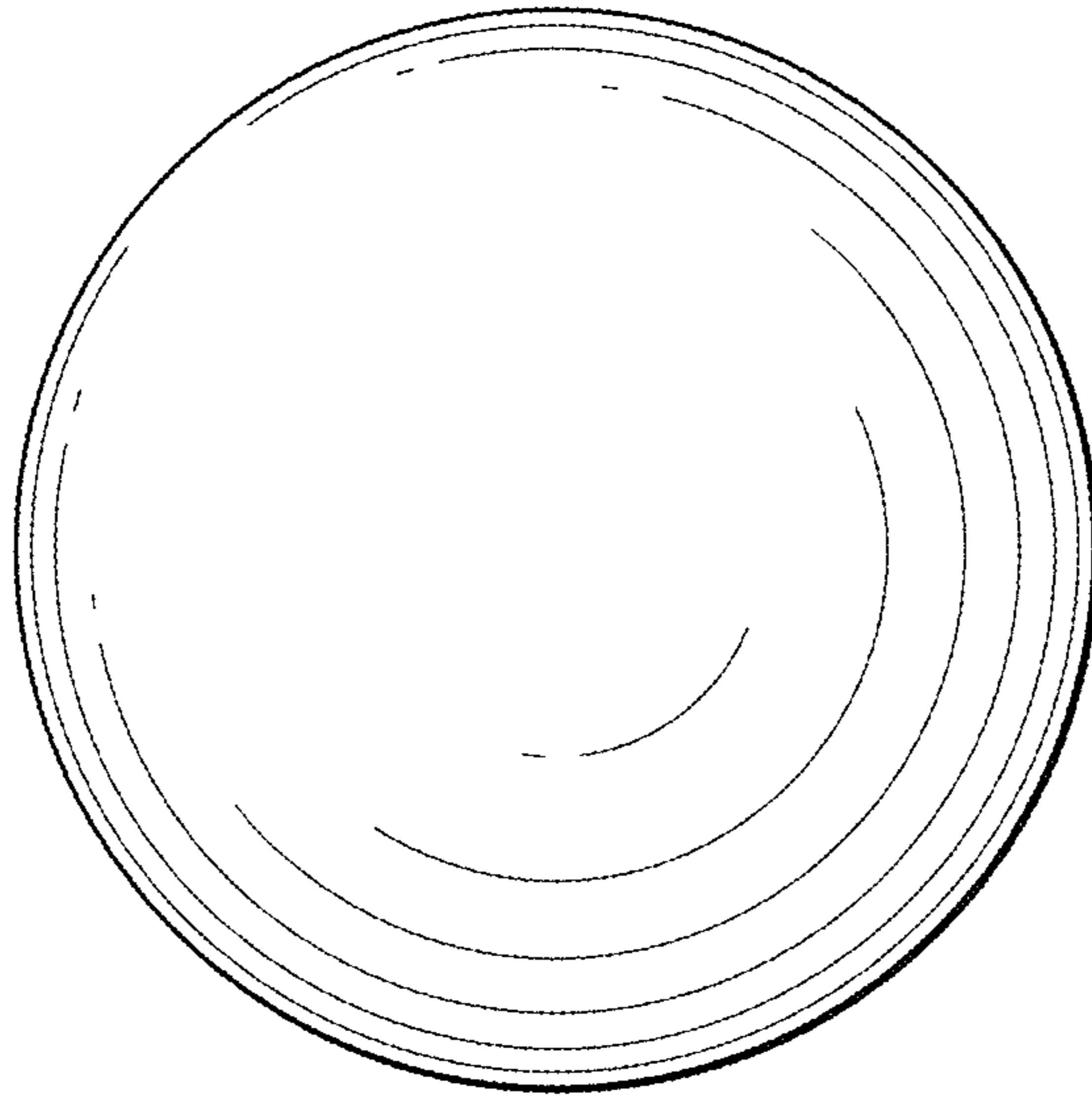

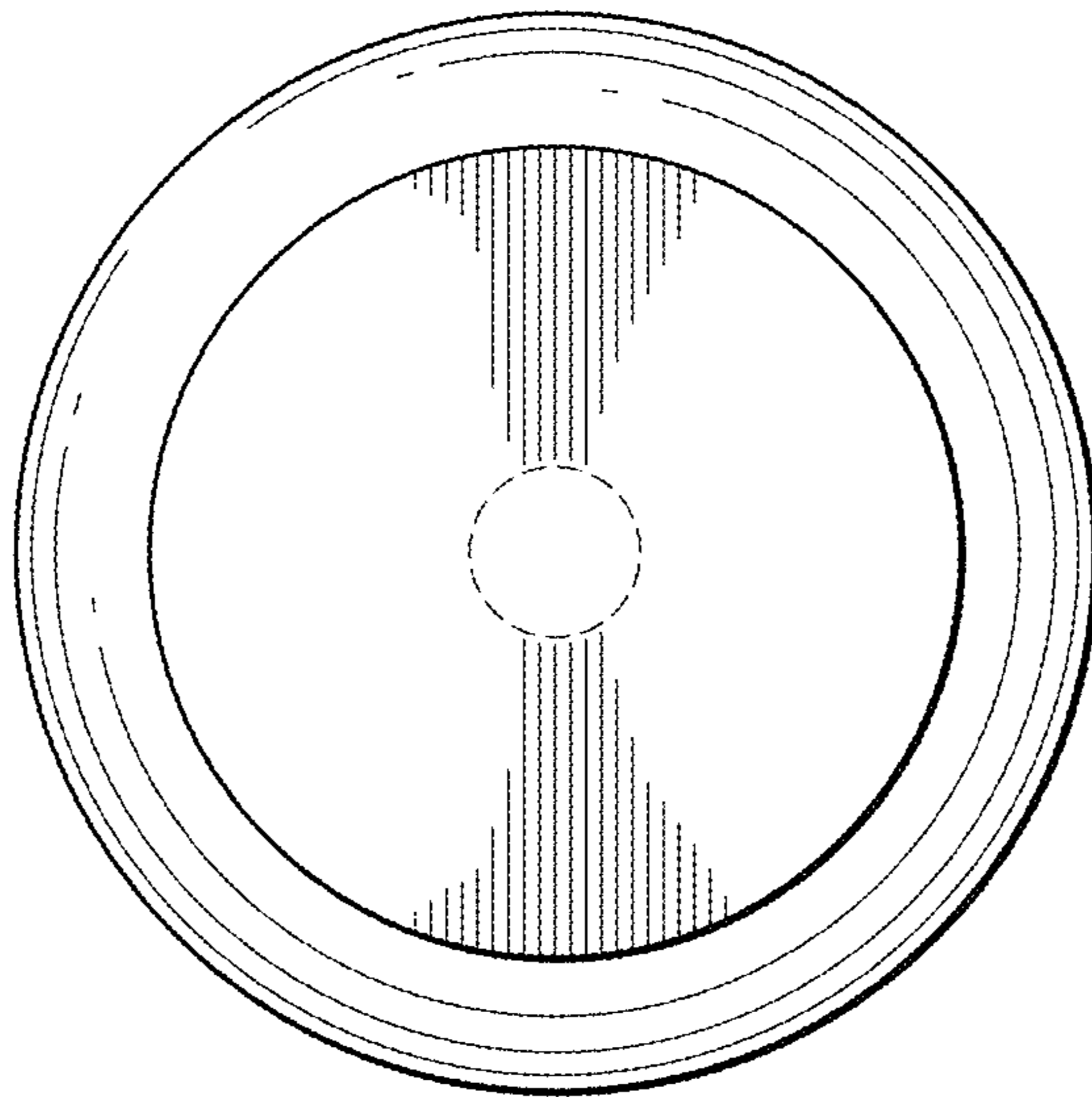
