An ornamental design for a vehicle roof rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a roof rack embodying the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left elevation view thereof;

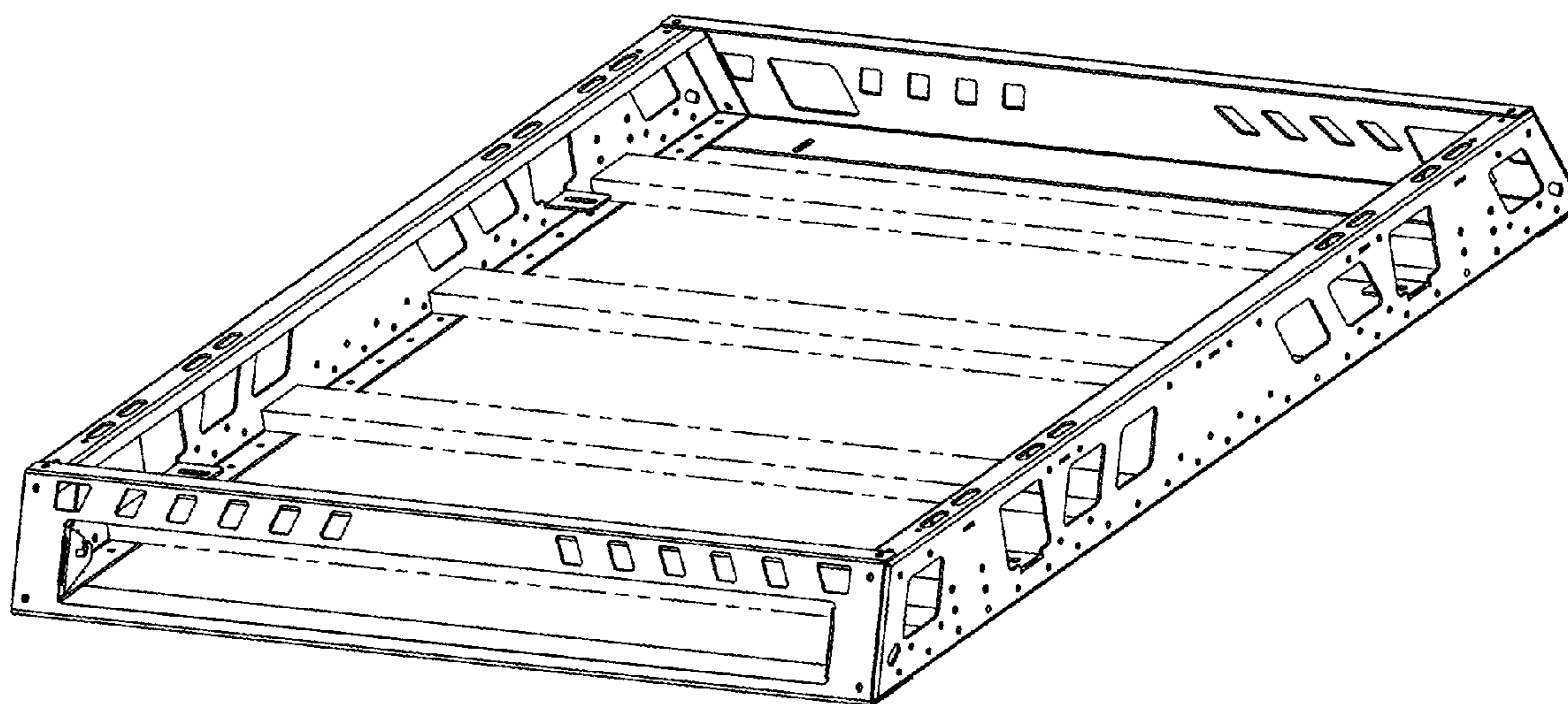
FIG. 5 is a top plan view thereof; and,

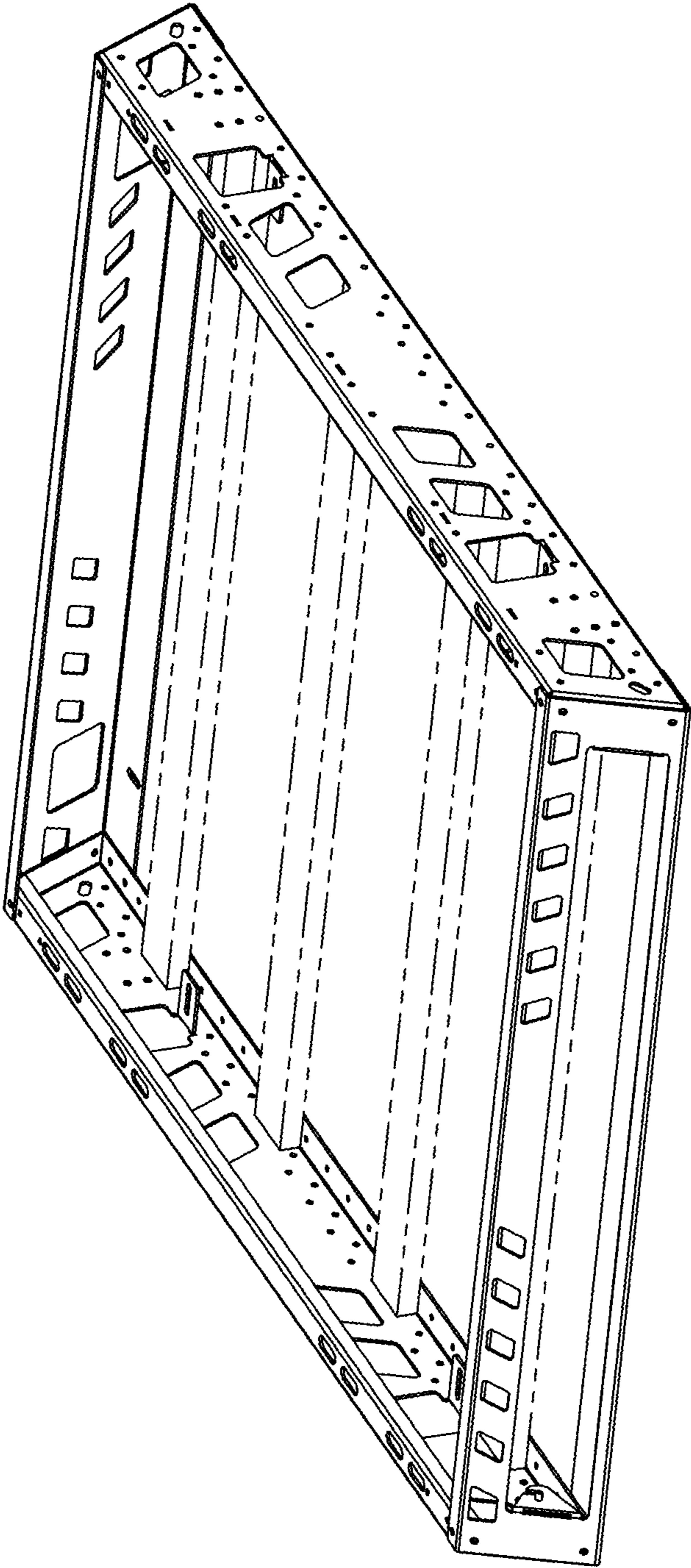

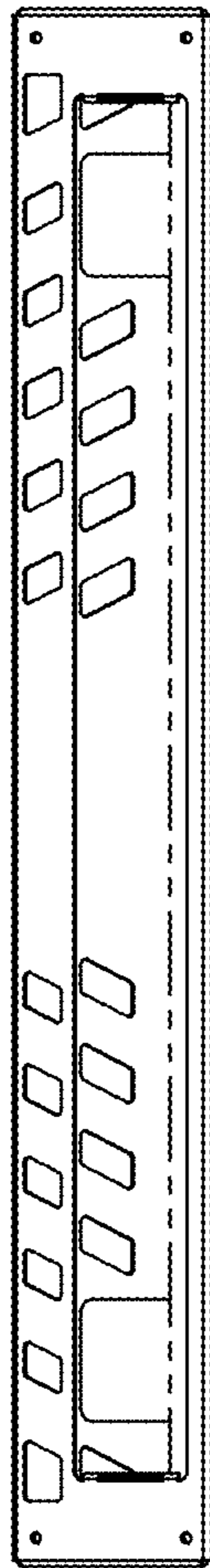

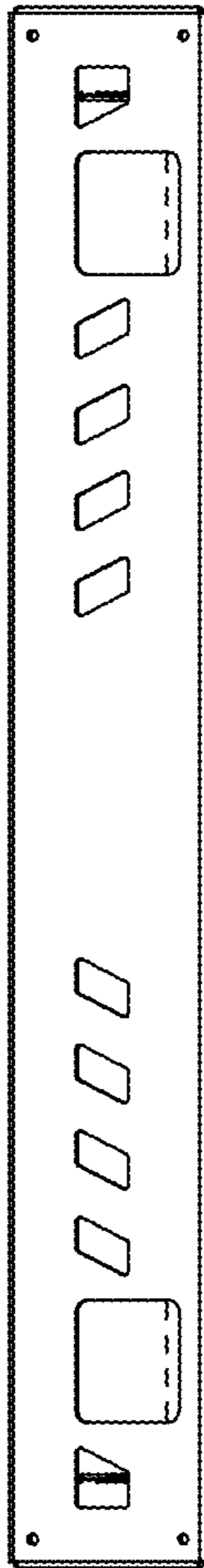

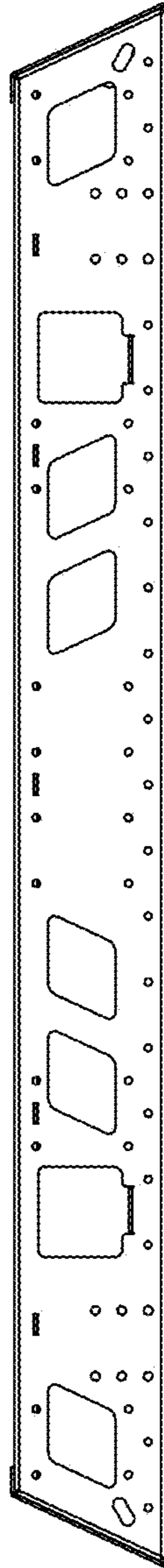

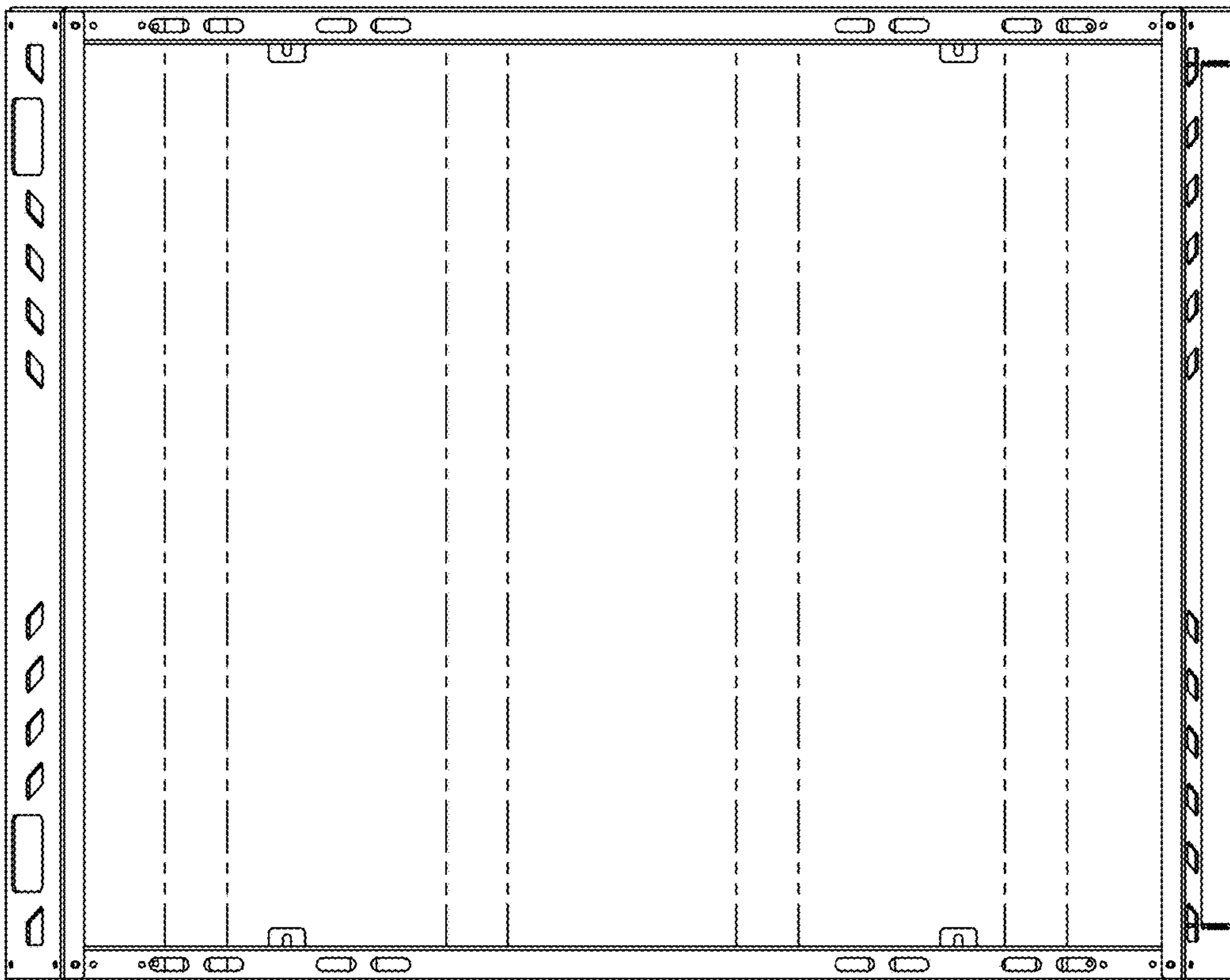

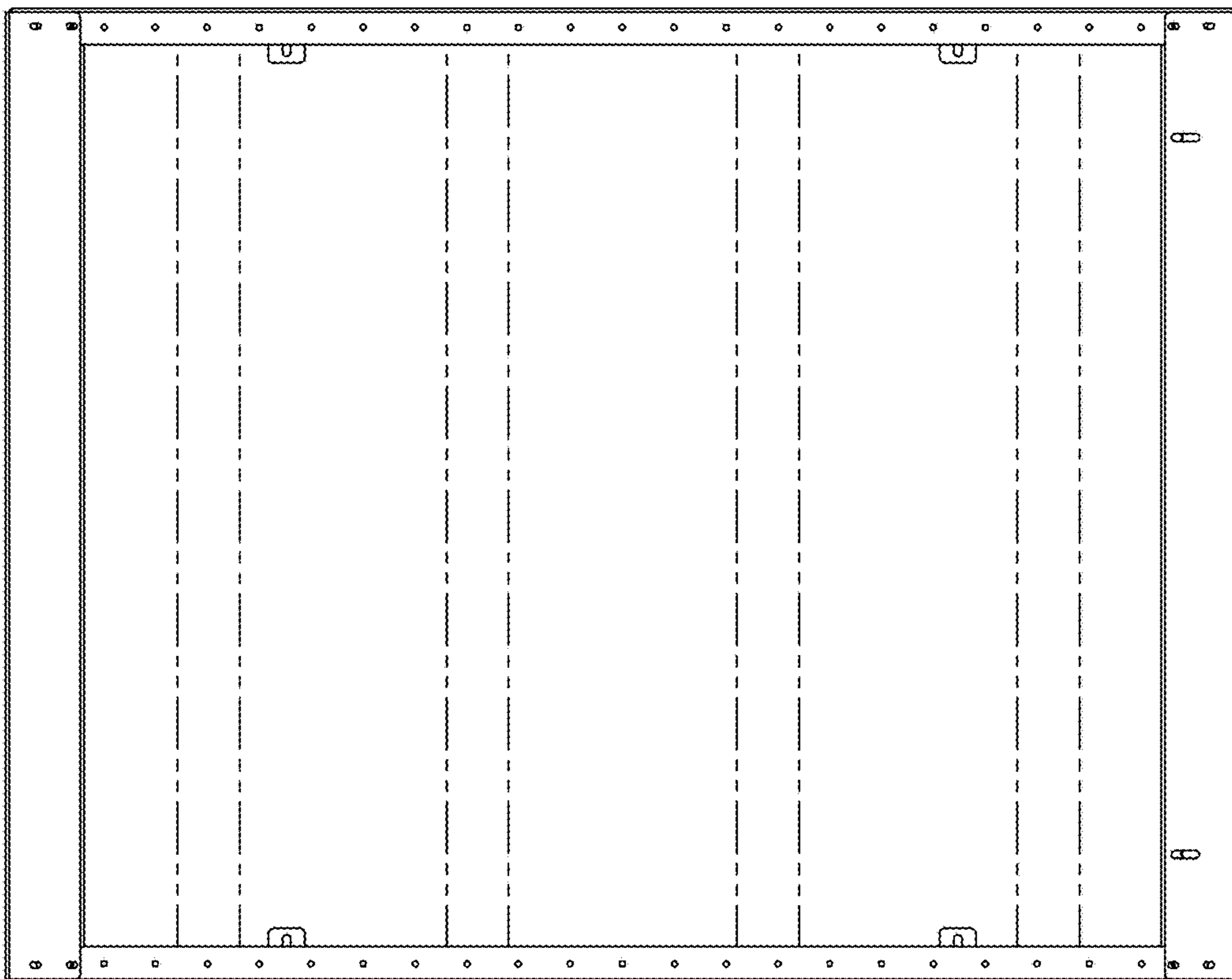
