DESCRIPTION

FIG. 17 is a bottom view in an opened state thereof;

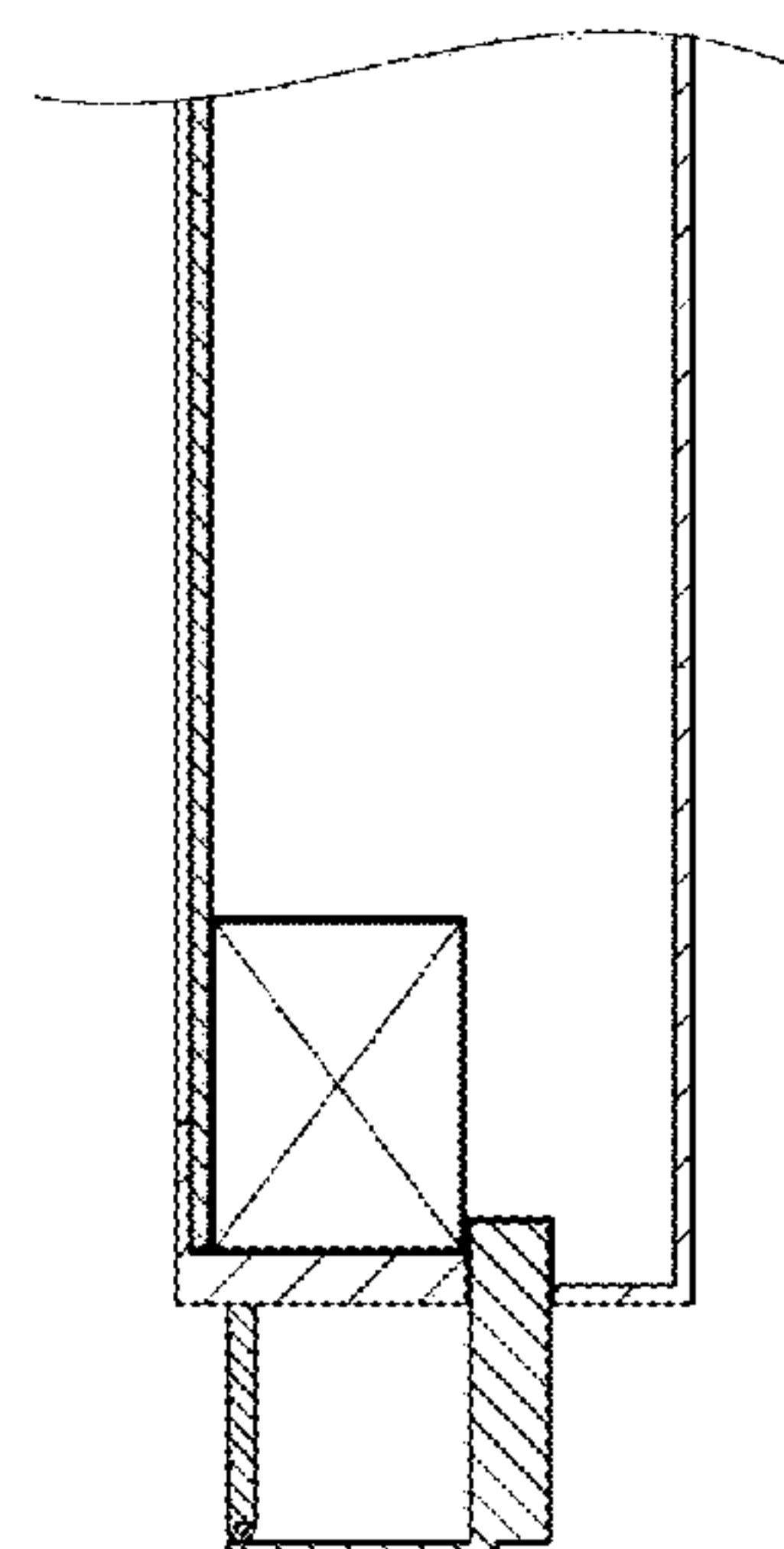
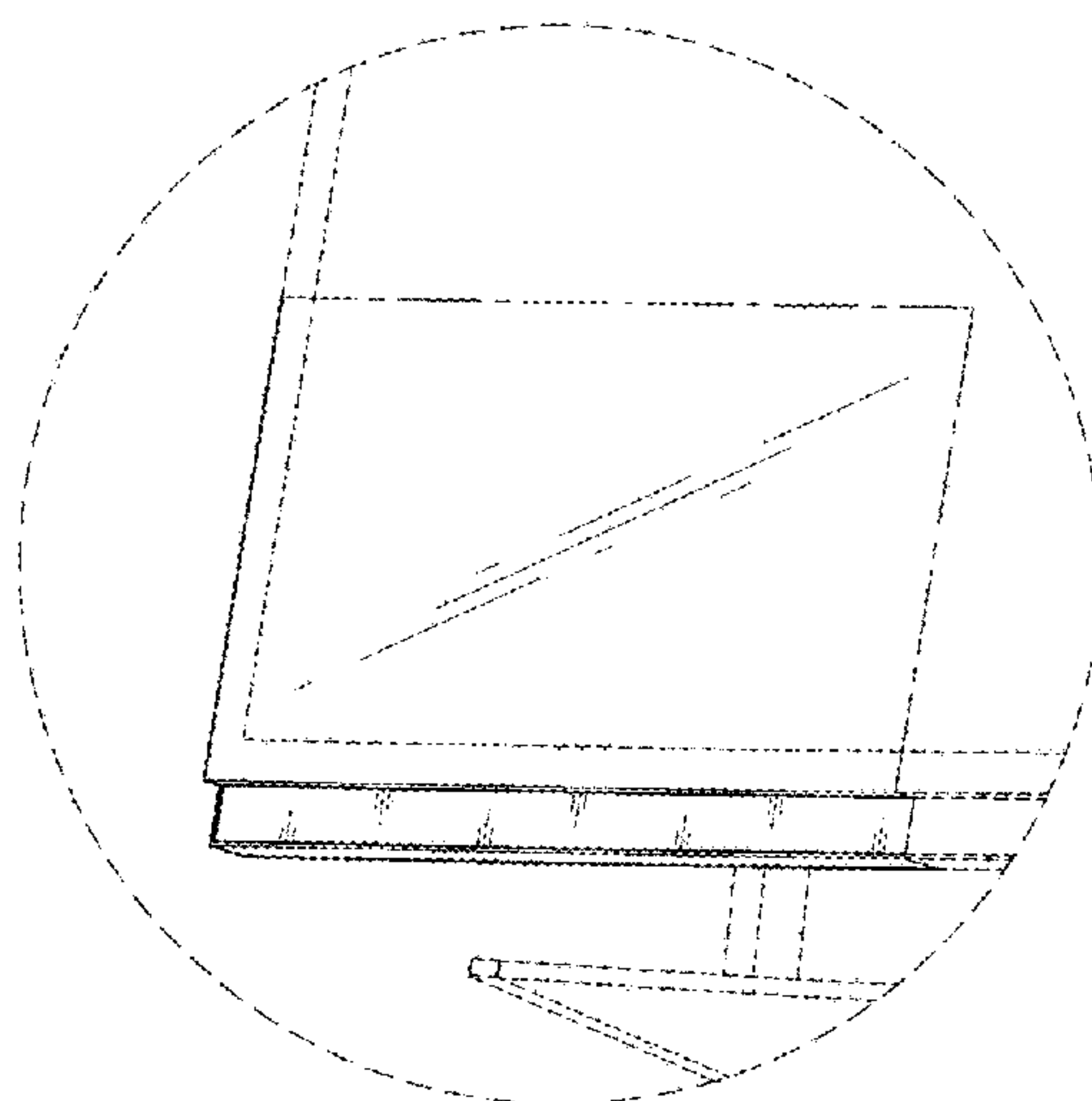
FIG. 18 is a front, right side, bottom perspective view thereof;

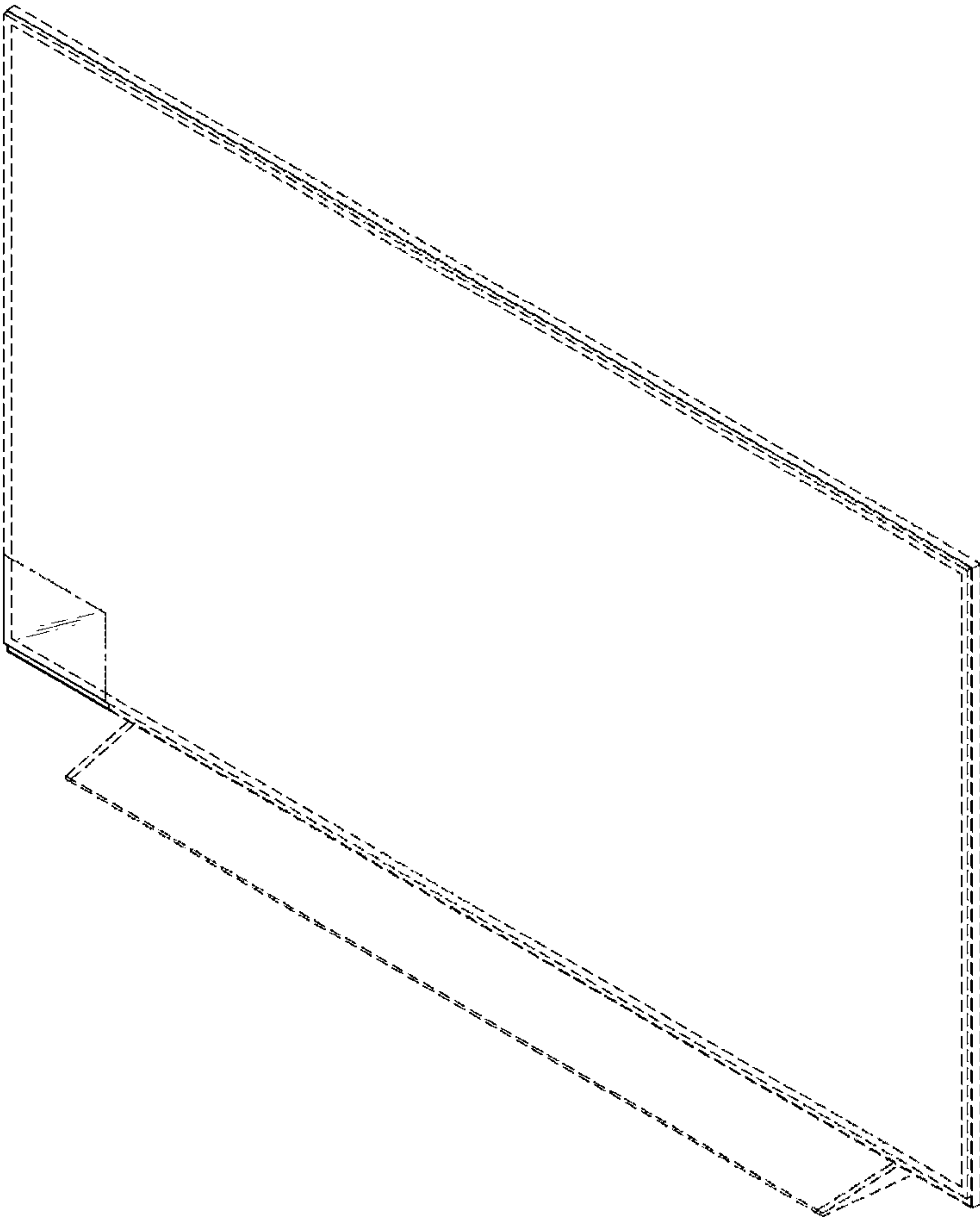

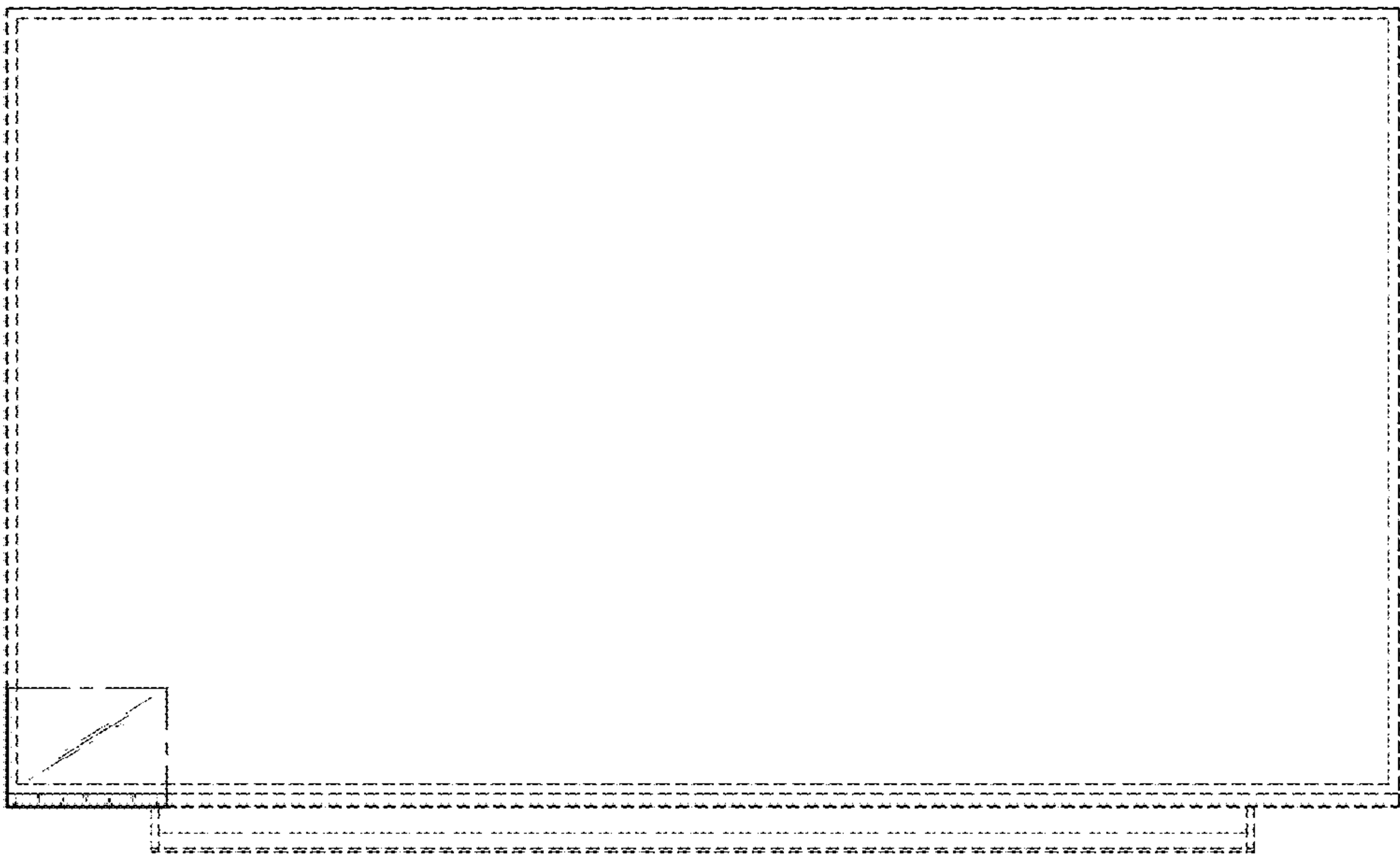

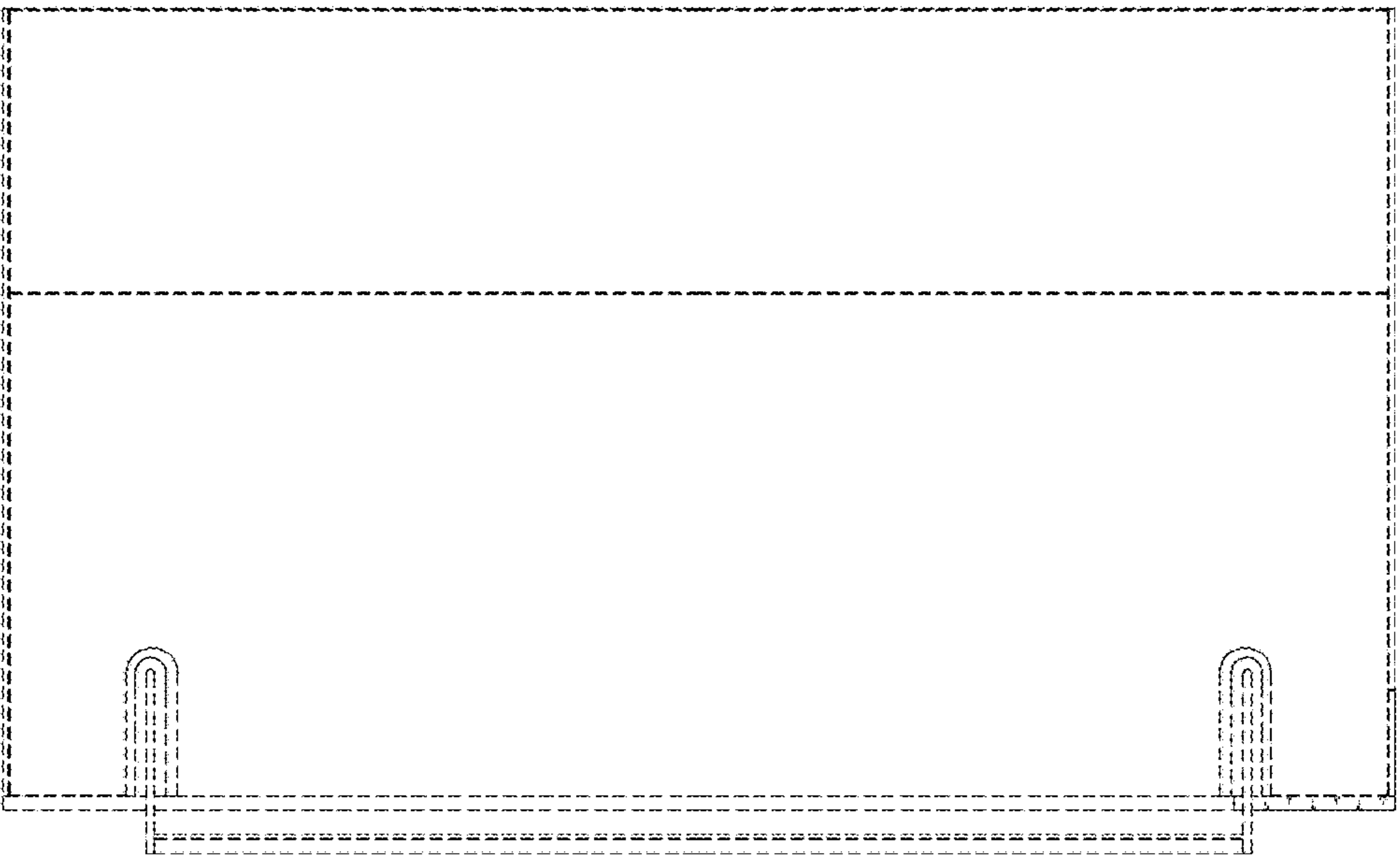

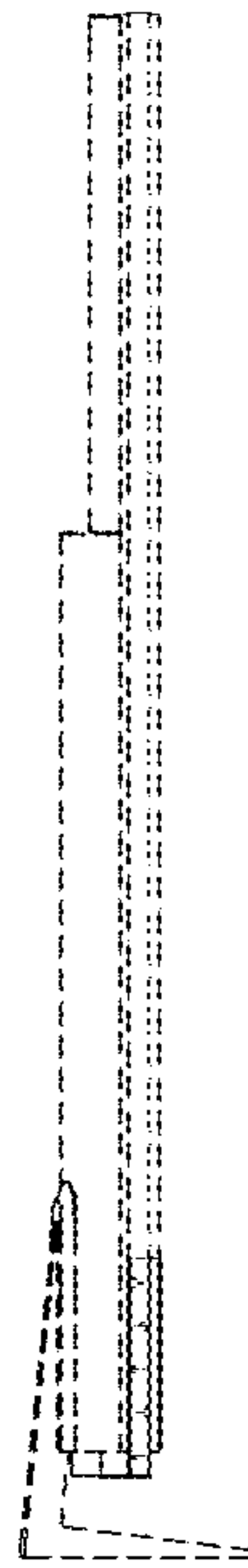

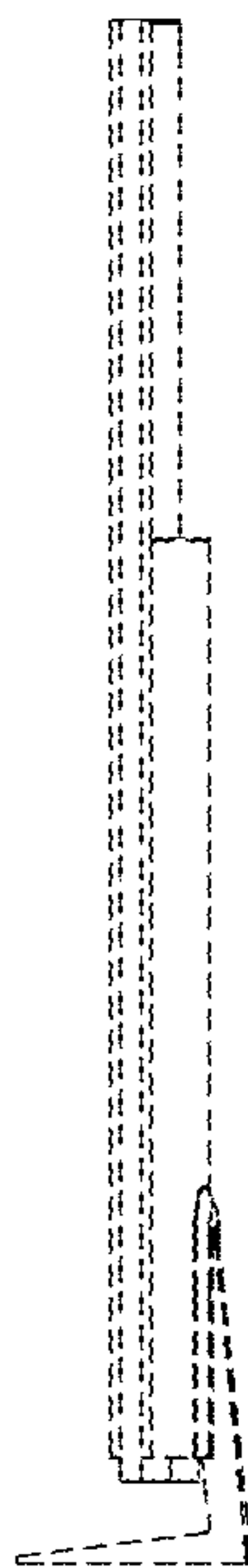

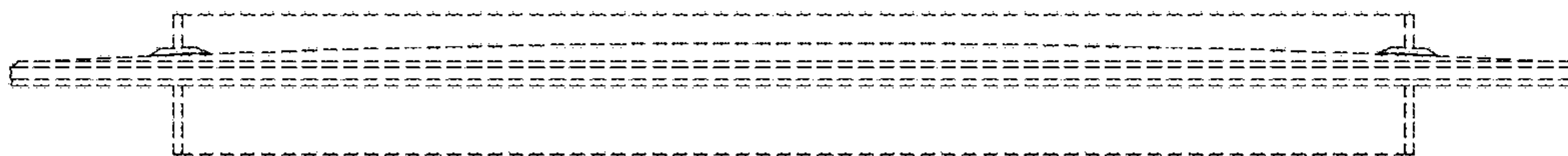

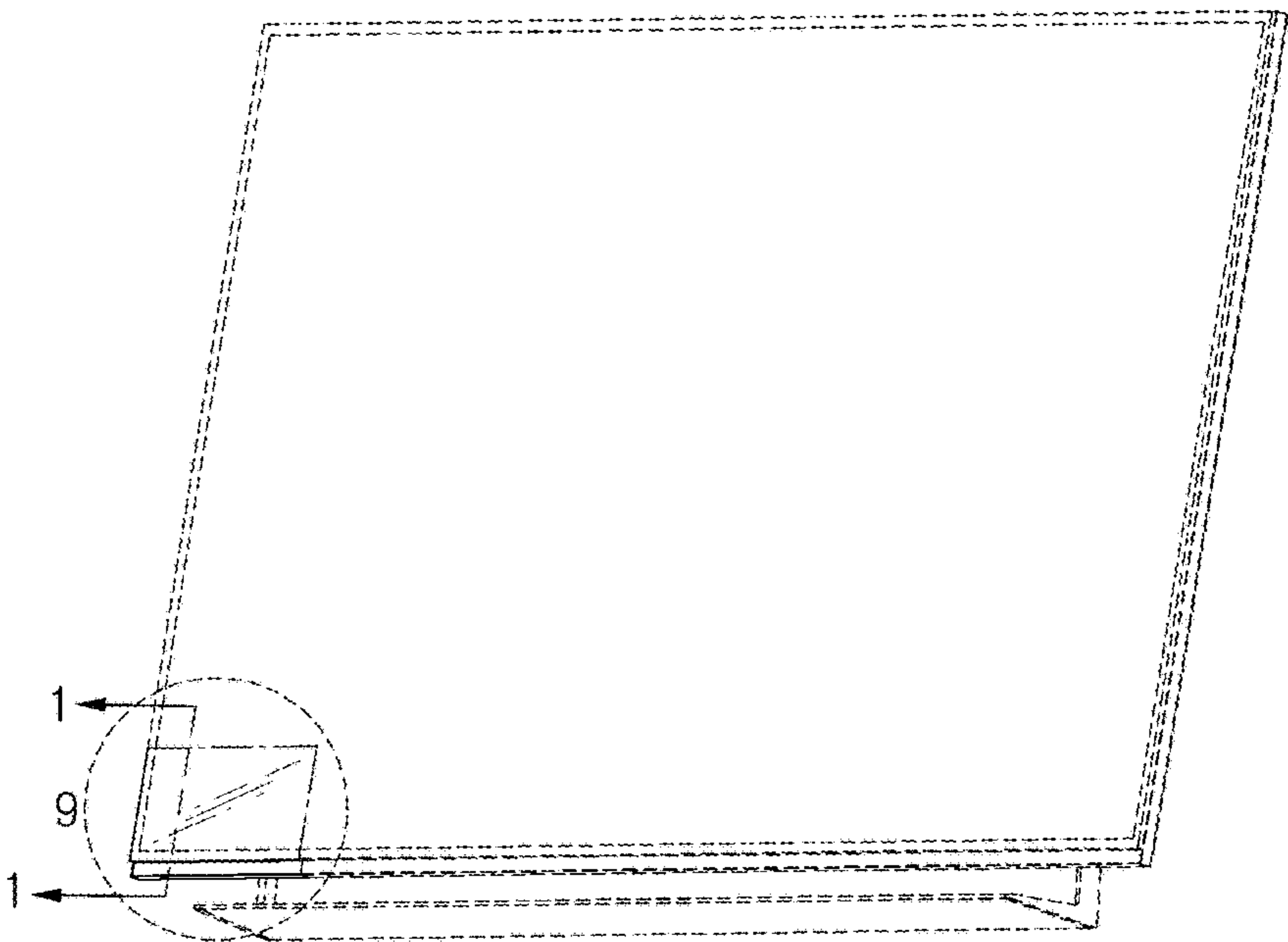

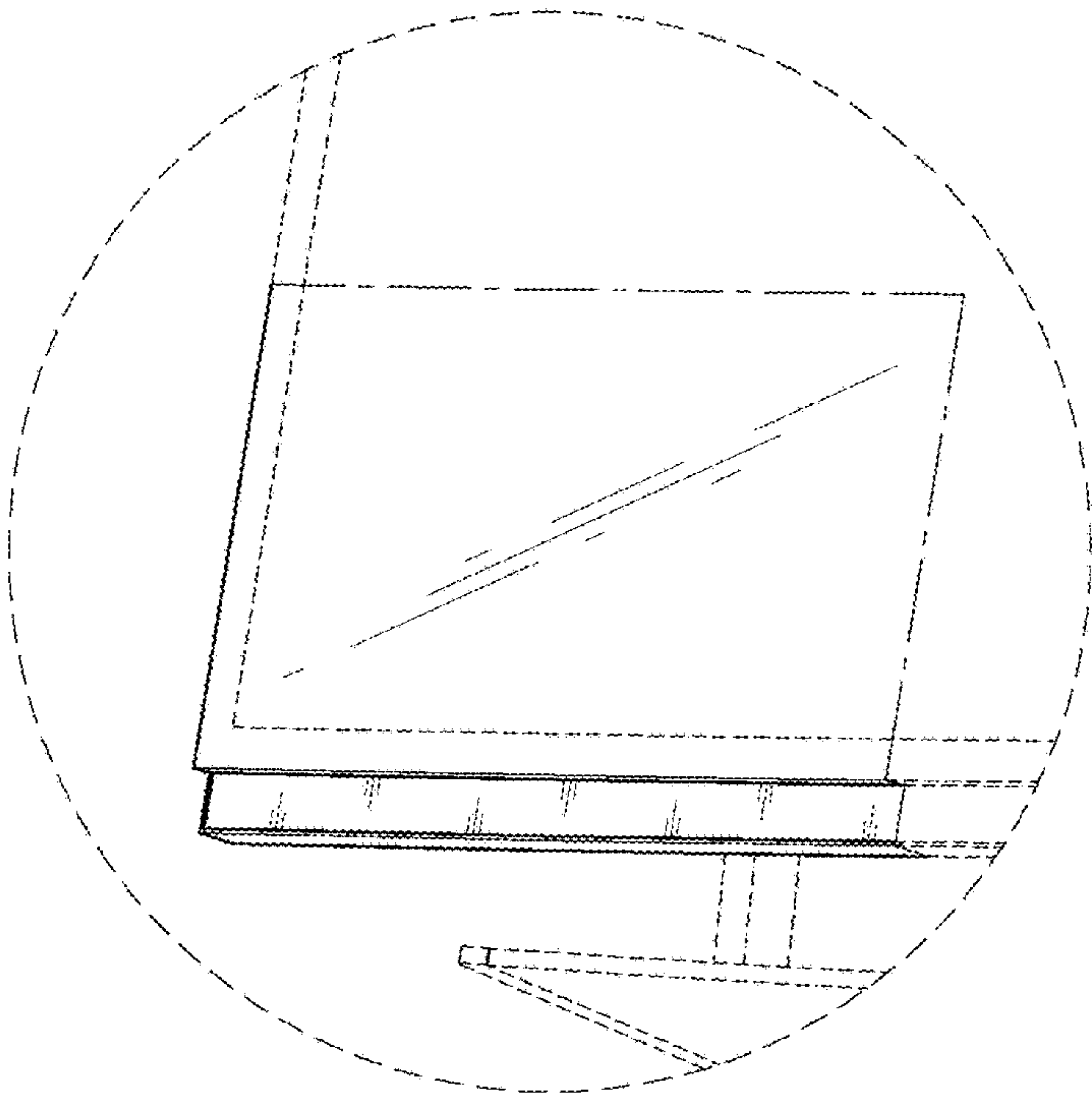

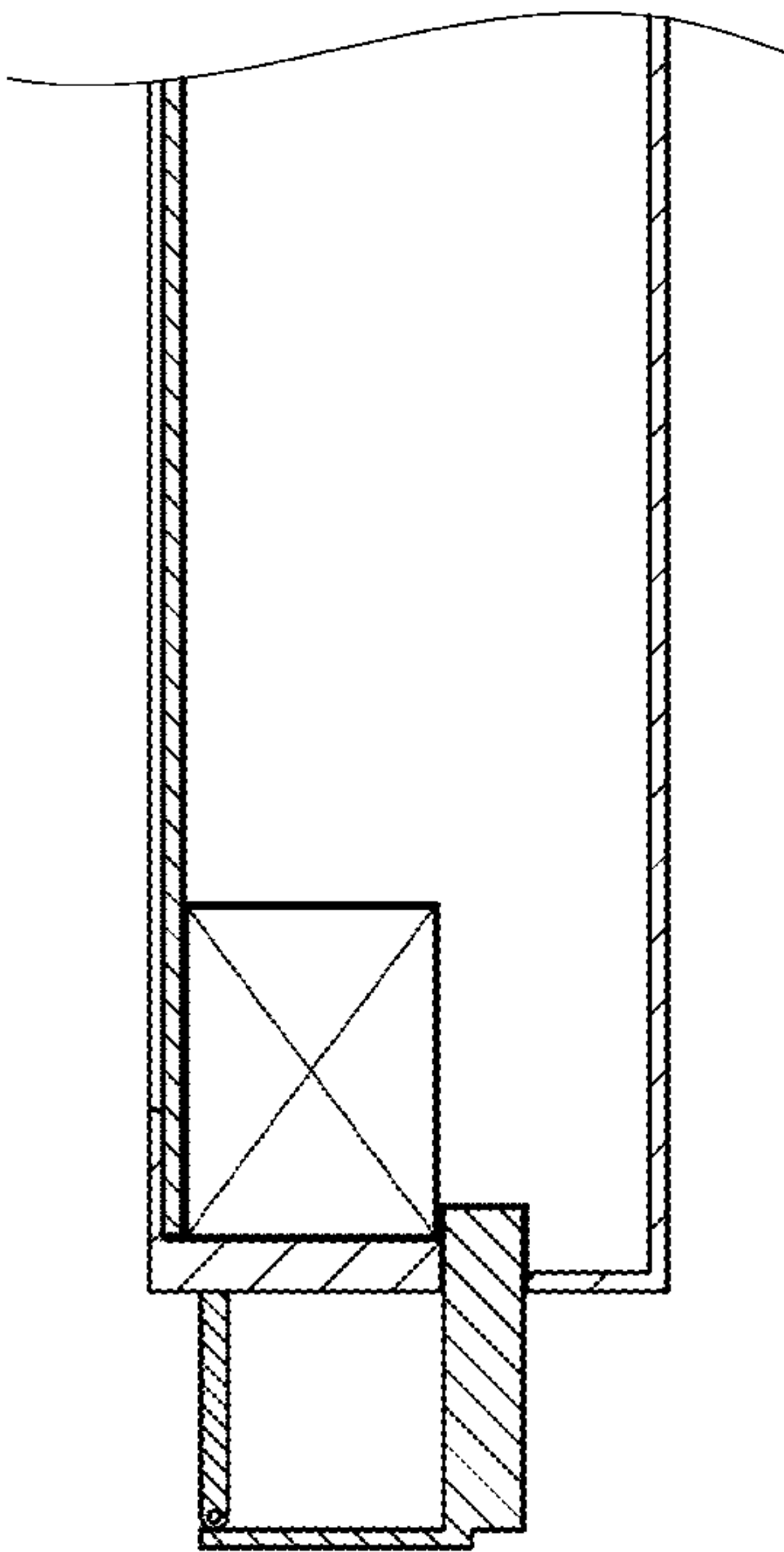

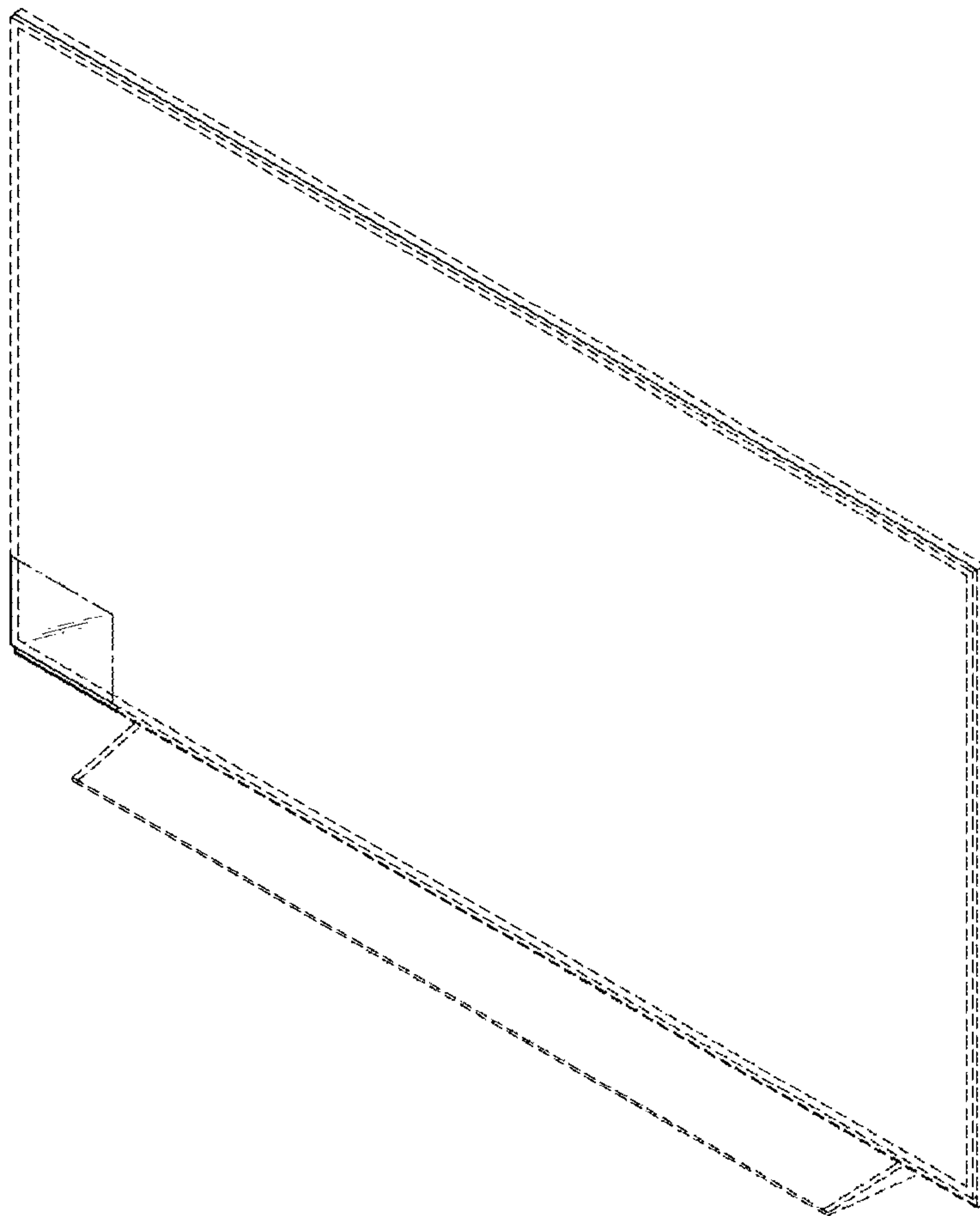

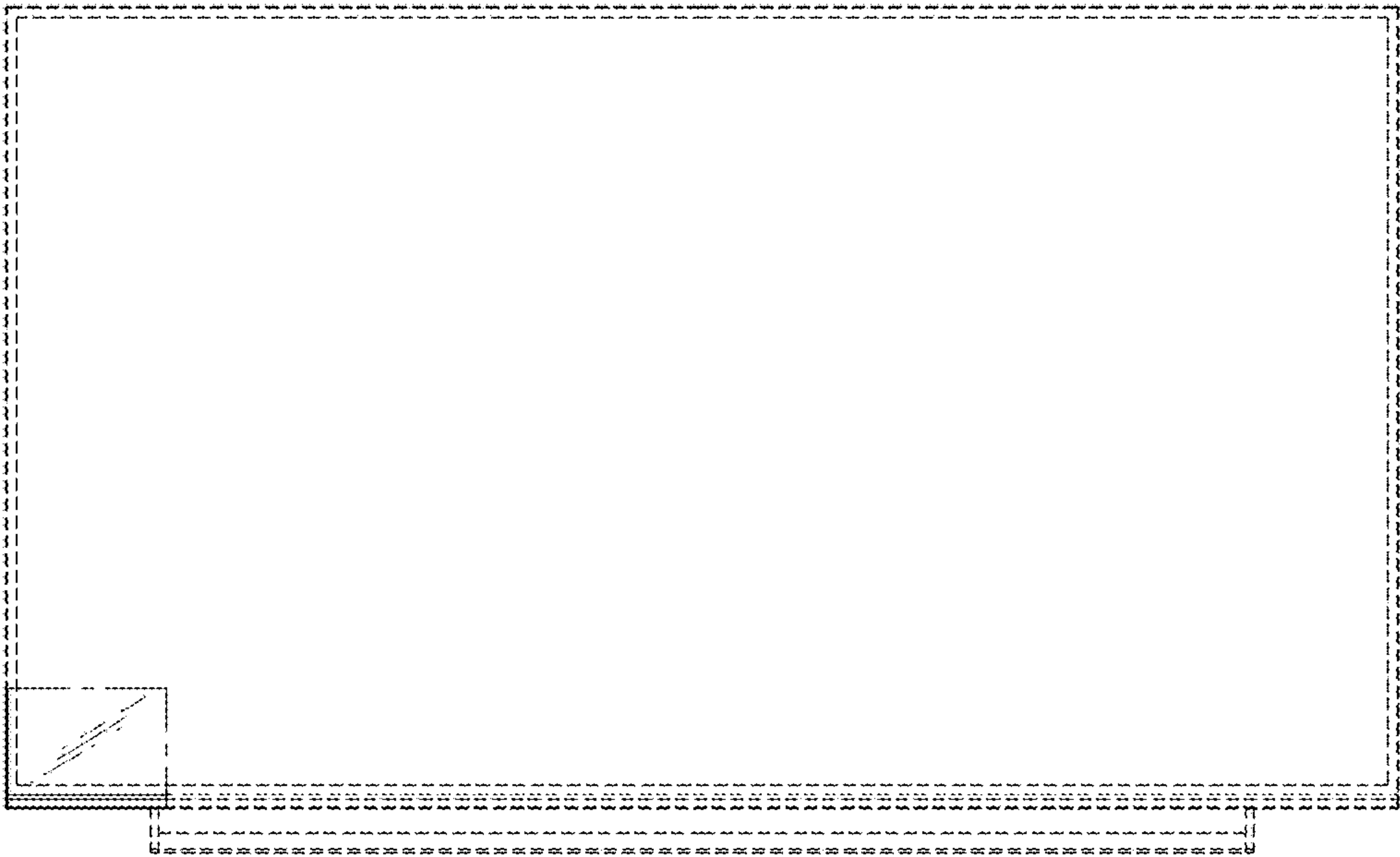

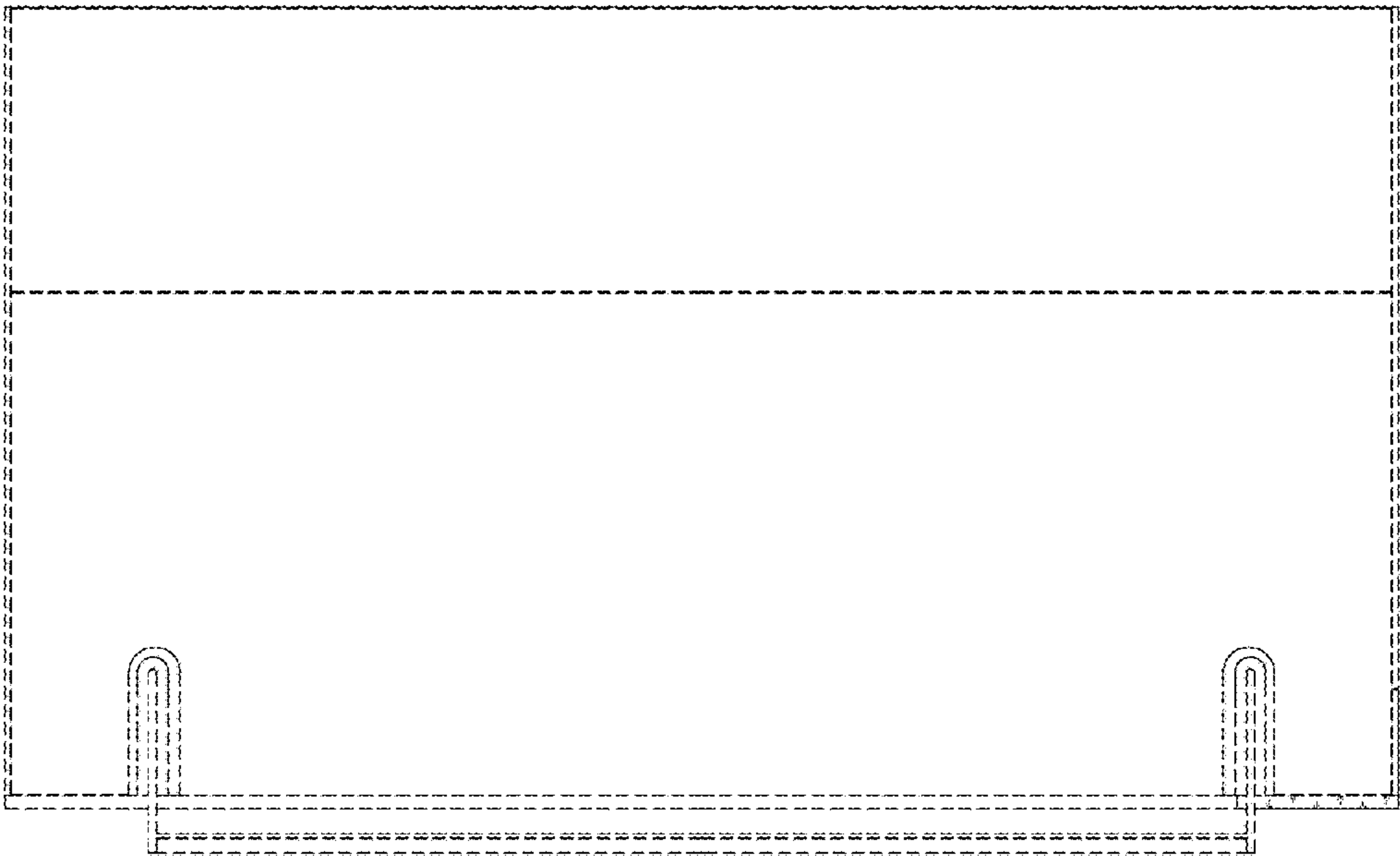

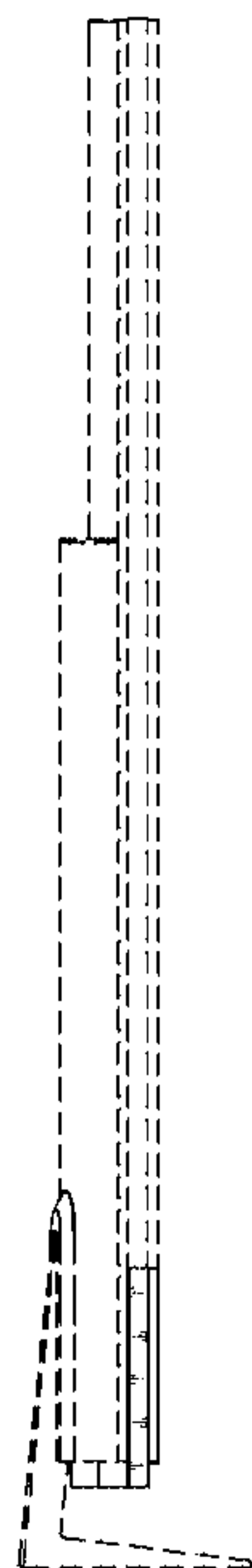

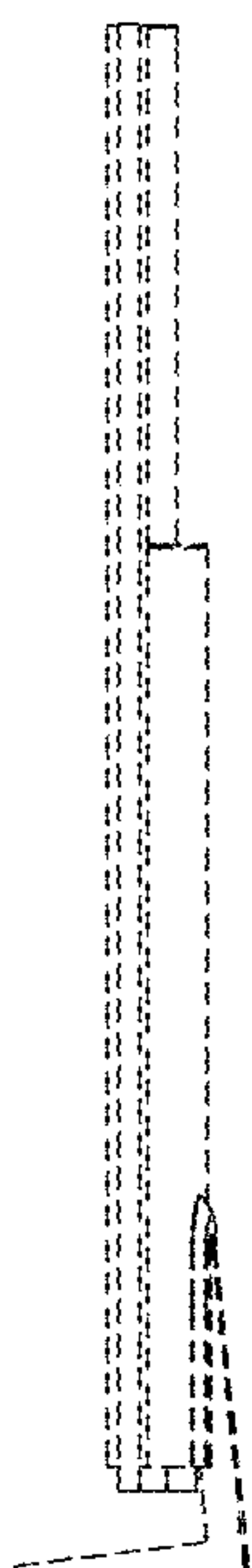

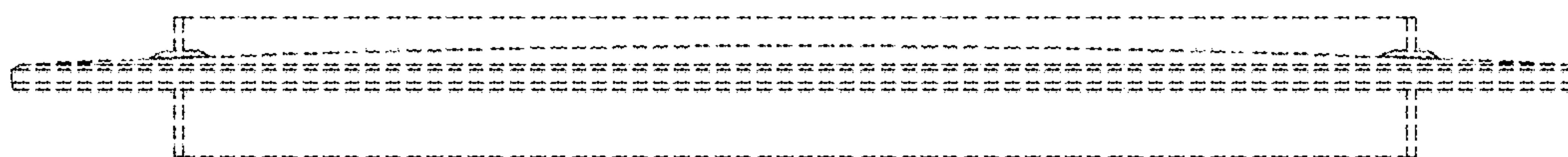

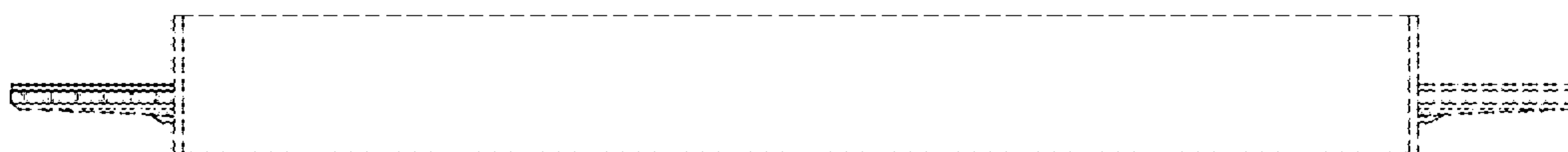

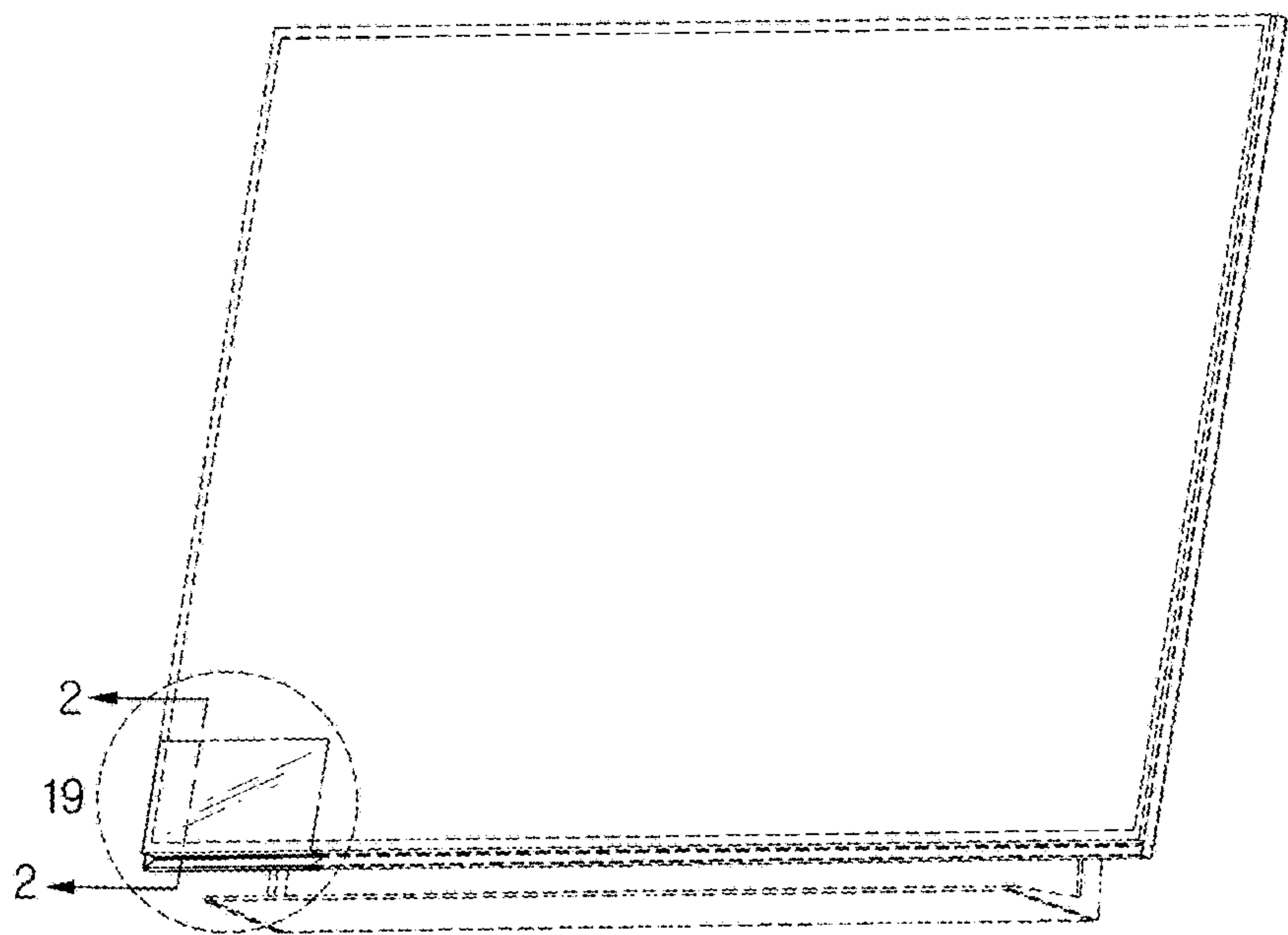

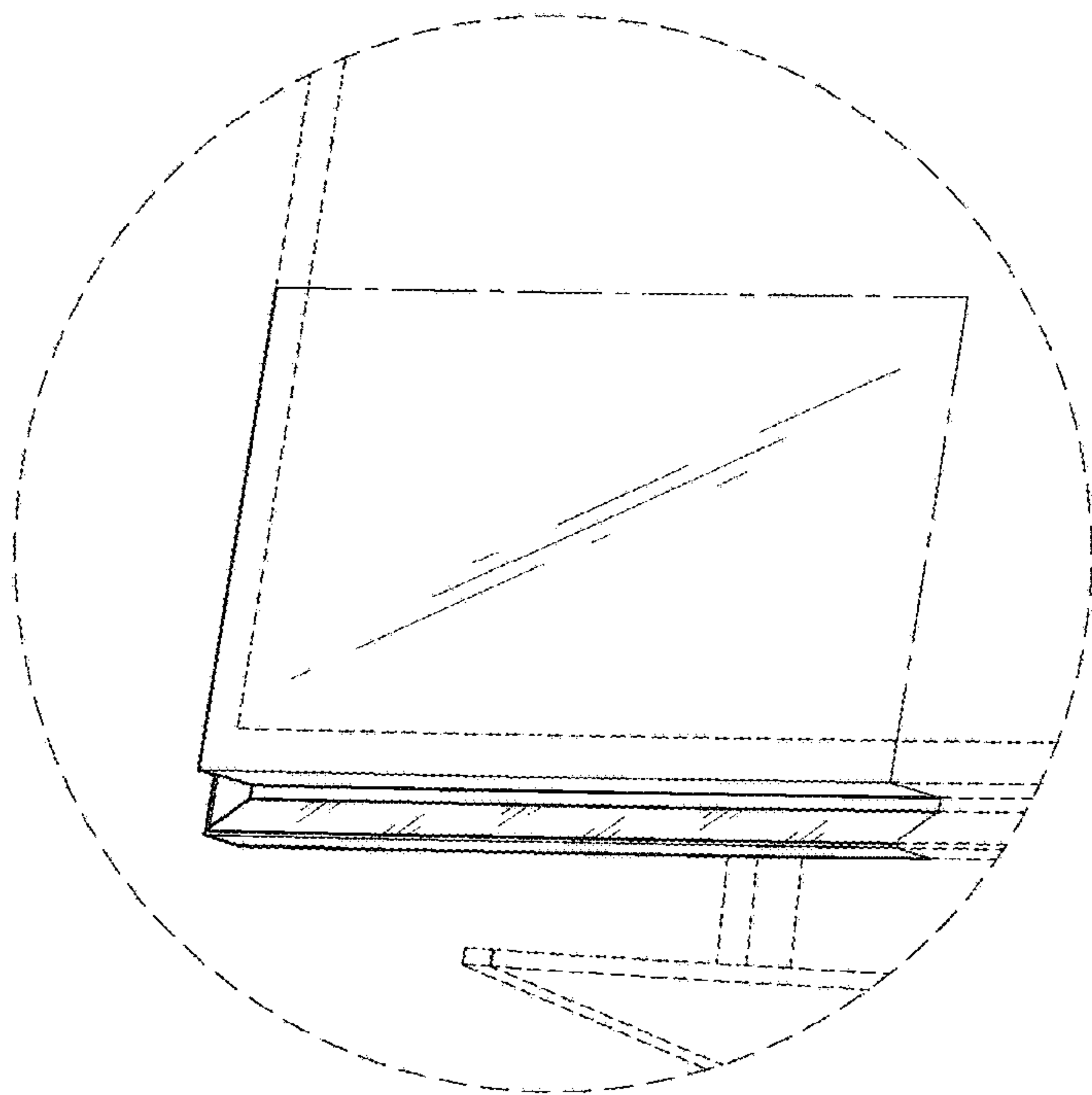
