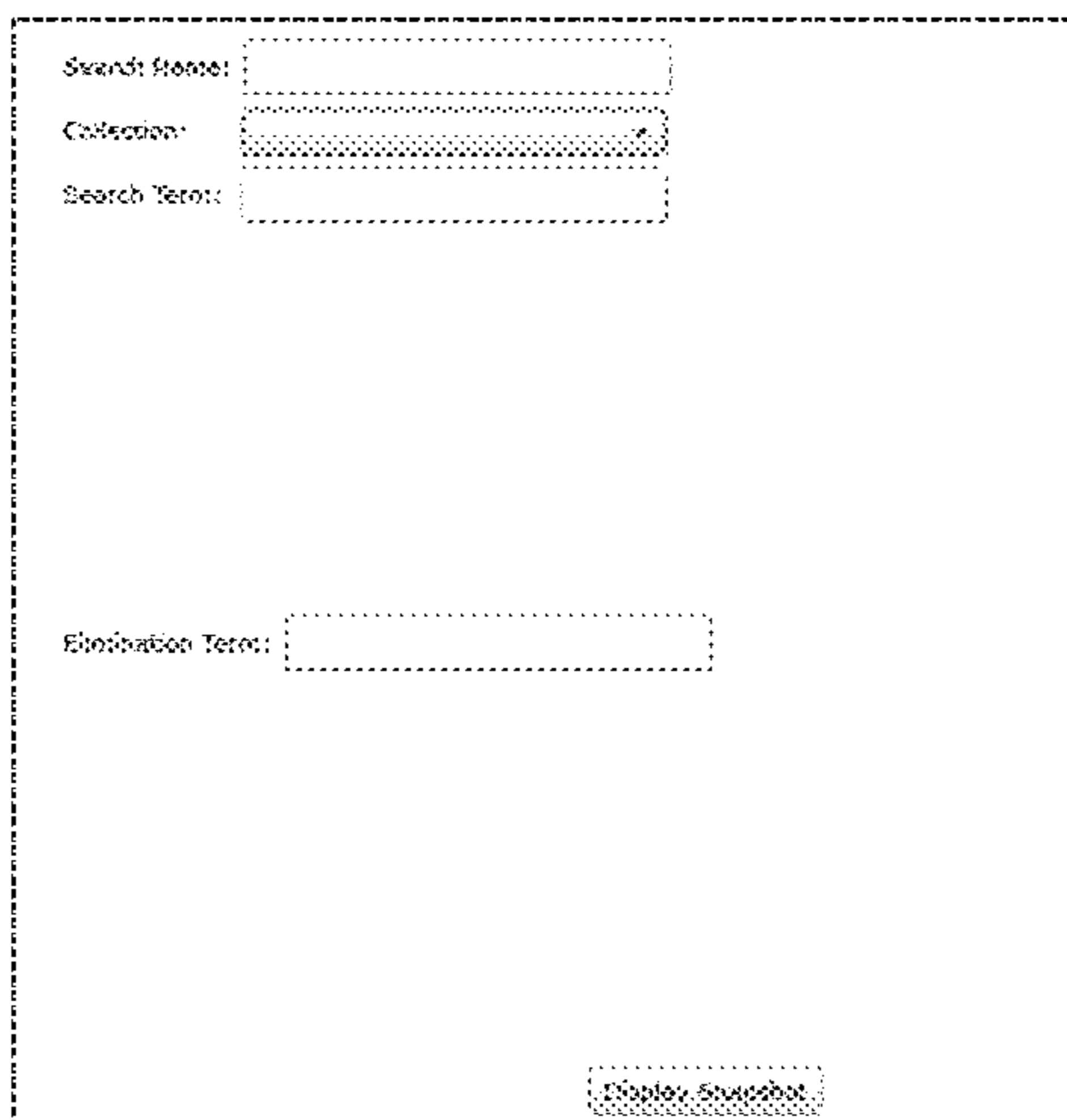
The ornamental design for a display screen with graphical user interface for a document management system, as shown and described.
