(57) **CLAIM**

We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen or portions thereof with graphical user interface, showing our new design.

The outermost evenly-spaced broken lines illustrate a display screen and forms no part of the claimed design. The remaining evenly spaced broken lines, including text, numbers and icons, illustrate portions of the graphical user interface and forms no part of the claimed design. The dot dash lines illustrate a boundary line and forms no part of the claimed design.
