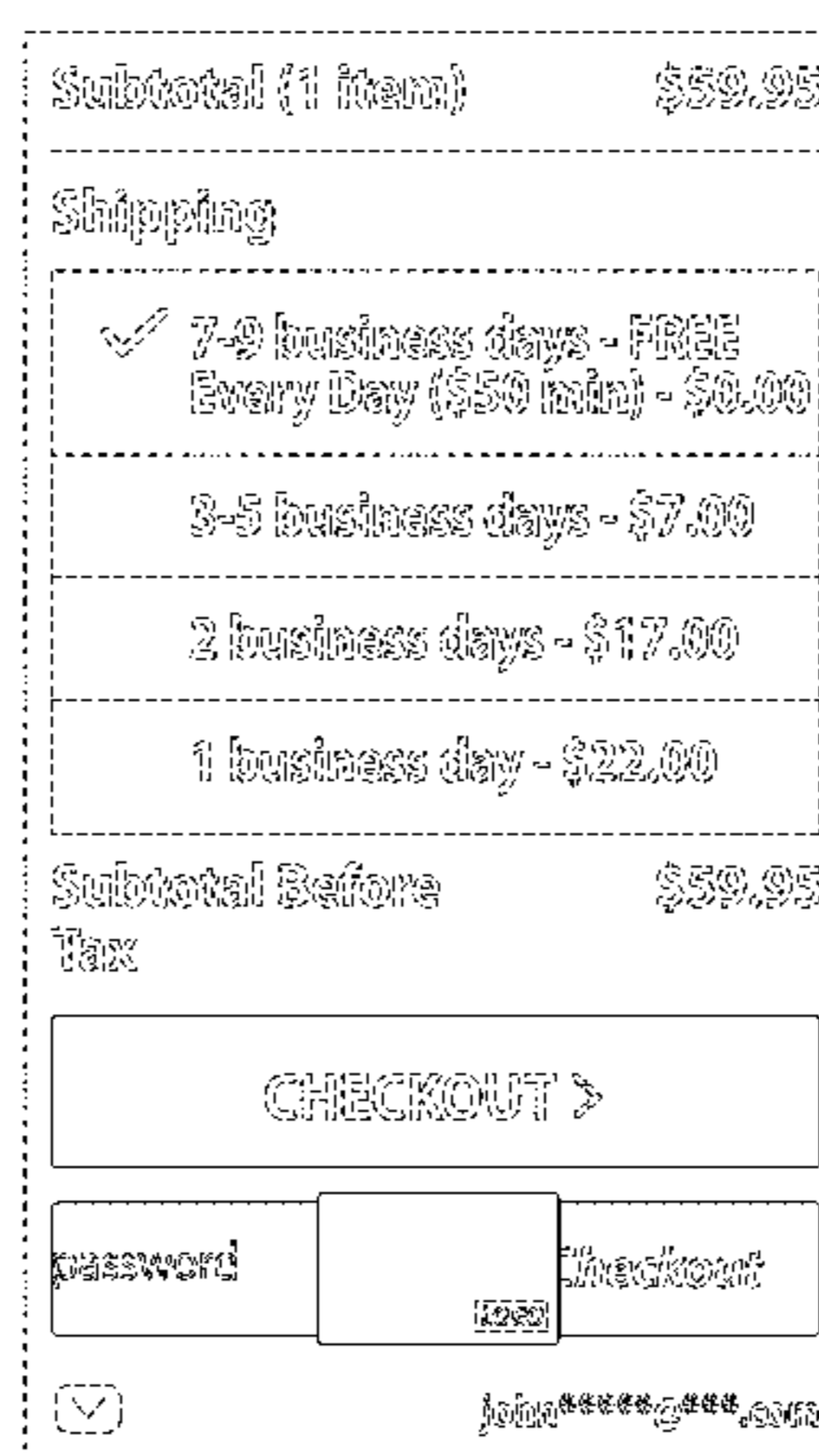
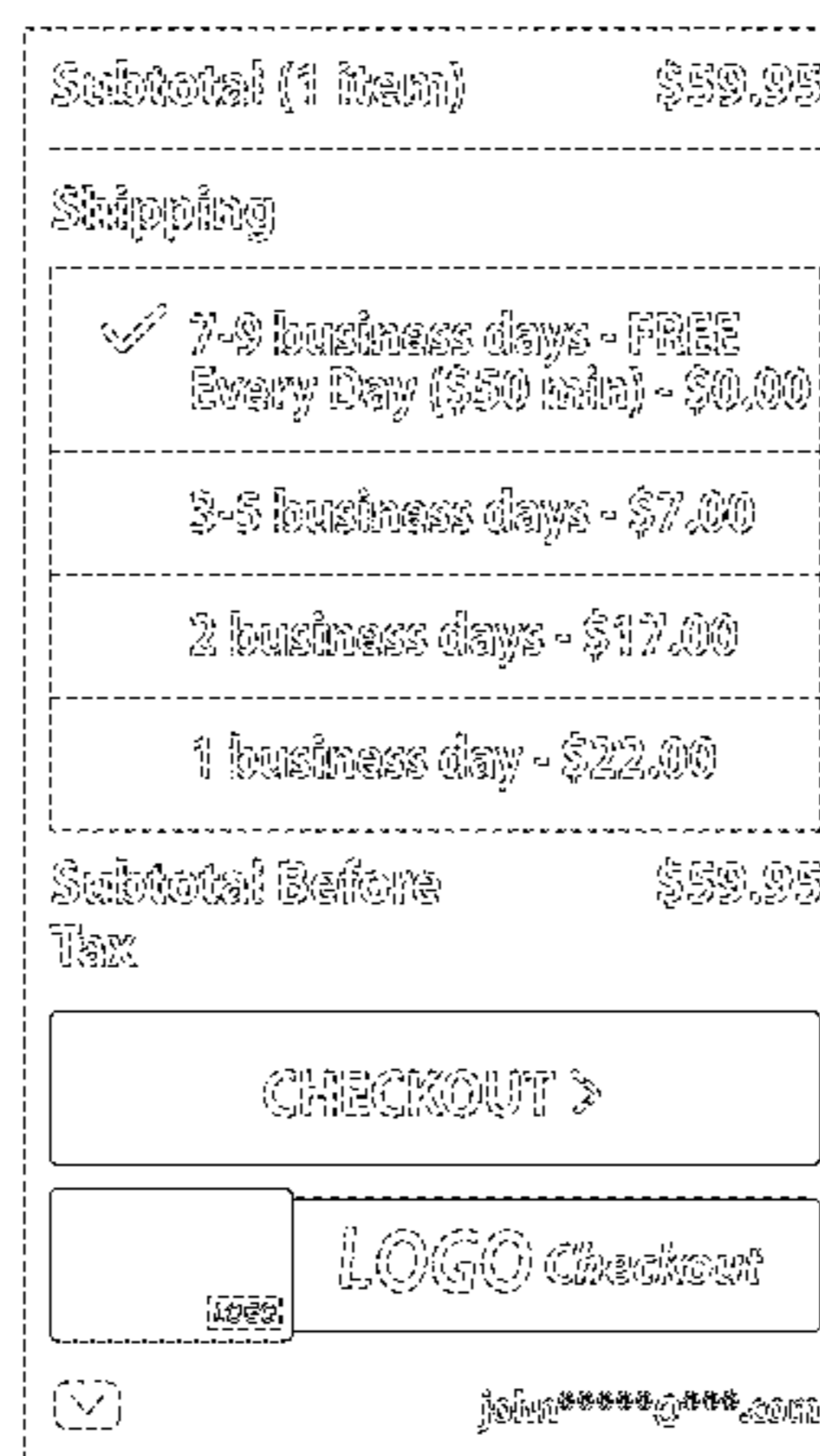
(57) **CLAIM**
The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 shows a first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design; FIG. 2 shows a second image thereof; FIG. 3 shows a third image thereof; FIG. 4 shows a fourth image thereof; FIG. 5 shows a portion of the claim as illustrated in FIG. 3 in the context of different environment; FIG. 6 shows a portion of the claim as illustrated in FIG. 4 in the context of different environment; FIG. 7 shows a first image in another sequence for a display screen or portion thereof with animated graphical user interface showing our new design in the context of yet another different environment; FIG. 8 shows a second image thereof; FIG. 9 shows a third image thereof; FIG. 10 shows a fourth image thereof; FIG. 11 shows a portion of the claim as illustrated in FIG. 9 in the context of still another different environment; and, FIG. 12 shows a portion of the claim as illustrated in FIG. 10 in the context of still another different environment. The broken lines, showing a display screen and portions of the graphical user interface, form no part of the claimed design.

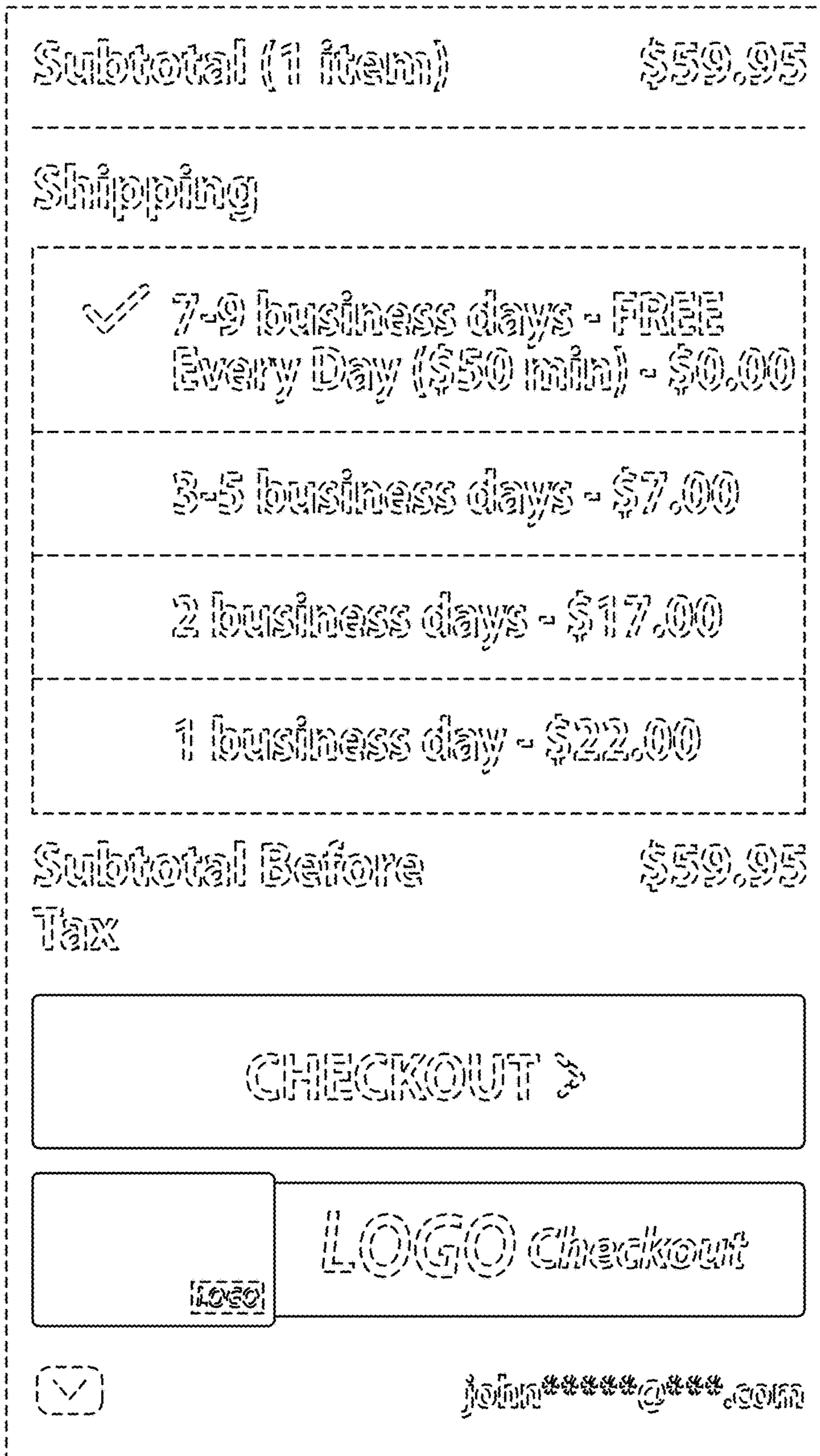









