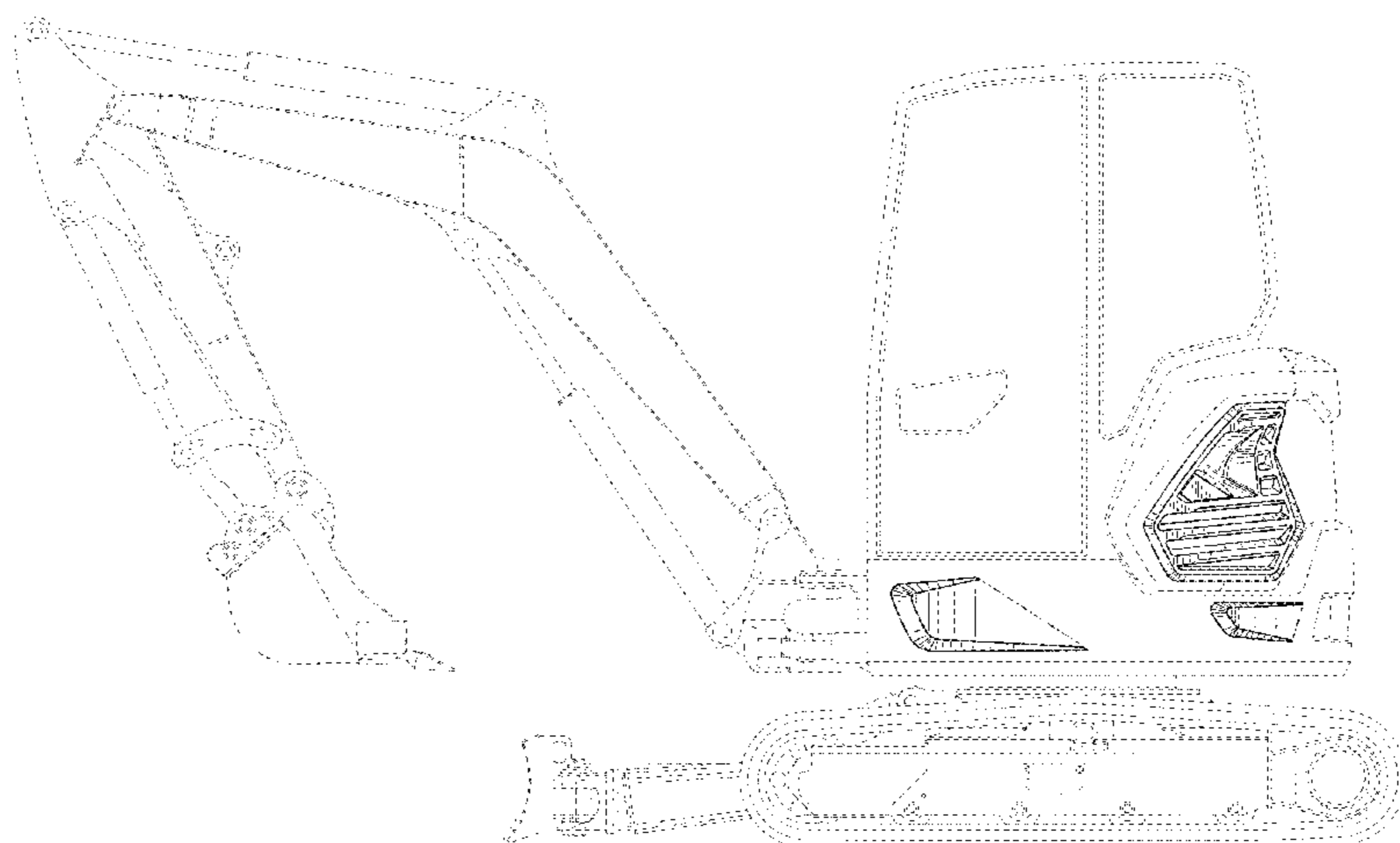
(57) **CLAIM**

We claim the ornamental design for an engine housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an engine housing embodying aspects of the invention.
 FIG. 2 is a right side view of the engine housing.
 FIG. 3 is a left side view of the engine housing.
 FIG. 4 is a front view of the engine housing with environment removed for the purpose of illustration.
 FIG. 5 is a rear view of the engine housing; and,
 FIG. 6 is a top view of the engine housing.
 The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design. The bottom view is not visible during ordinary use.

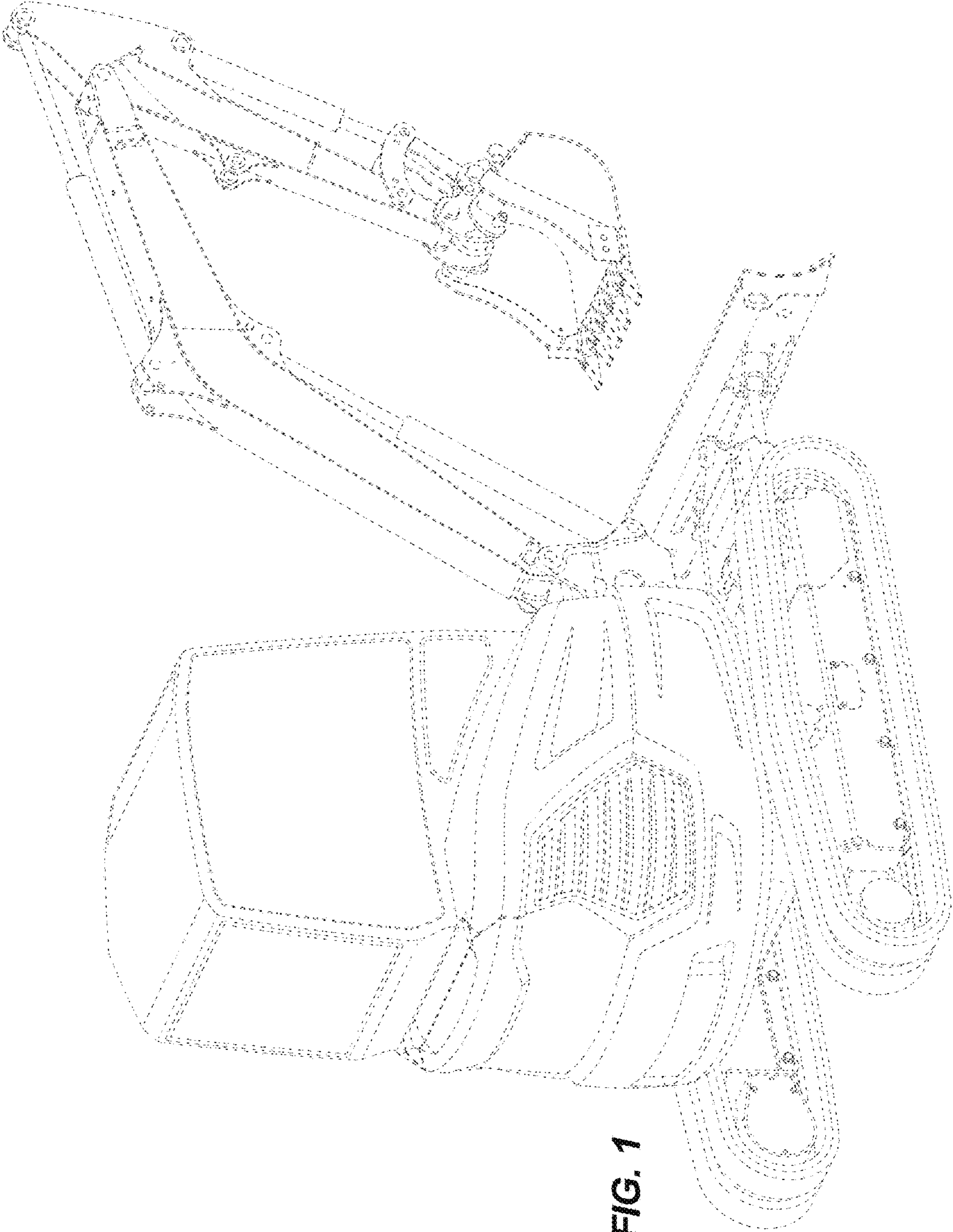

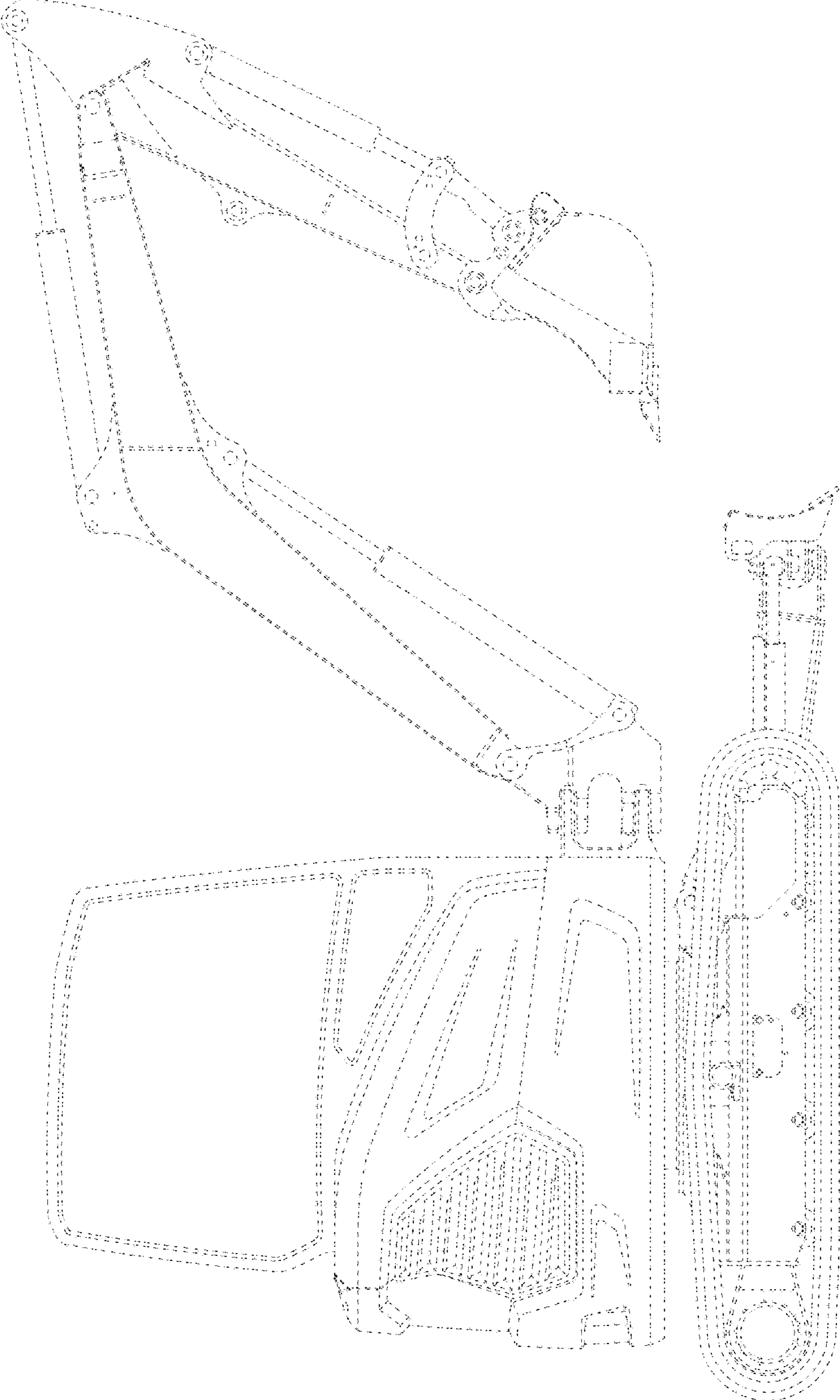

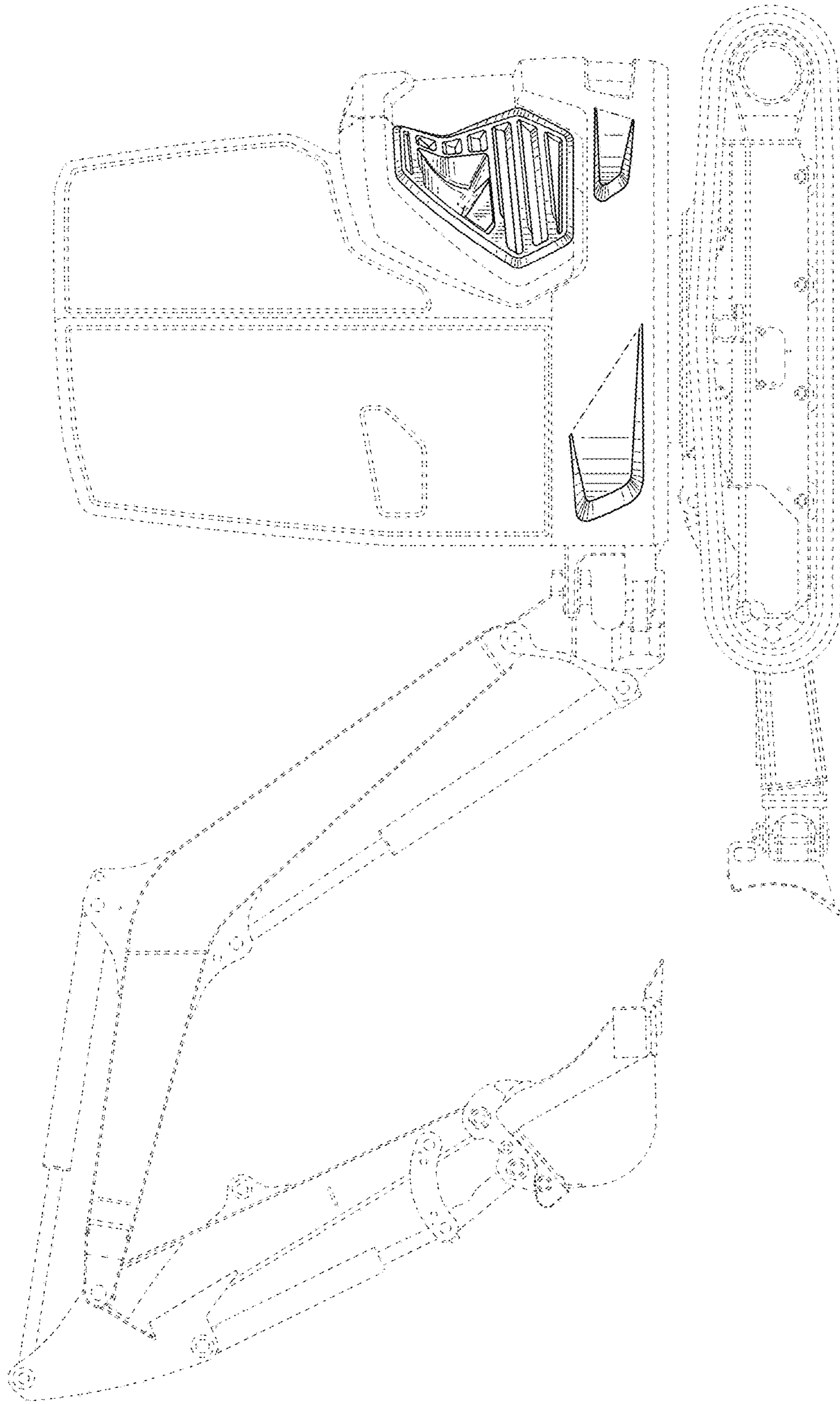

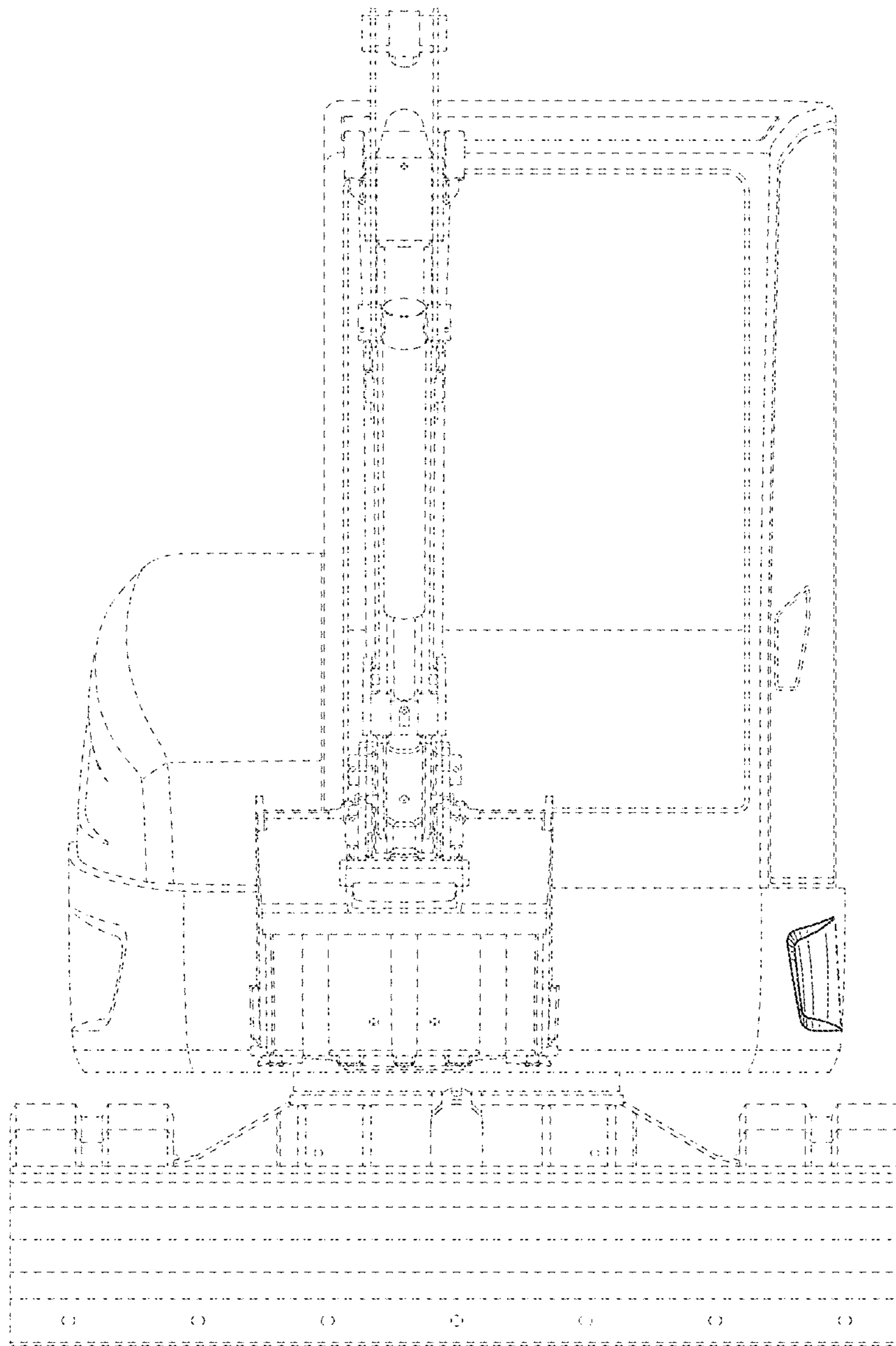

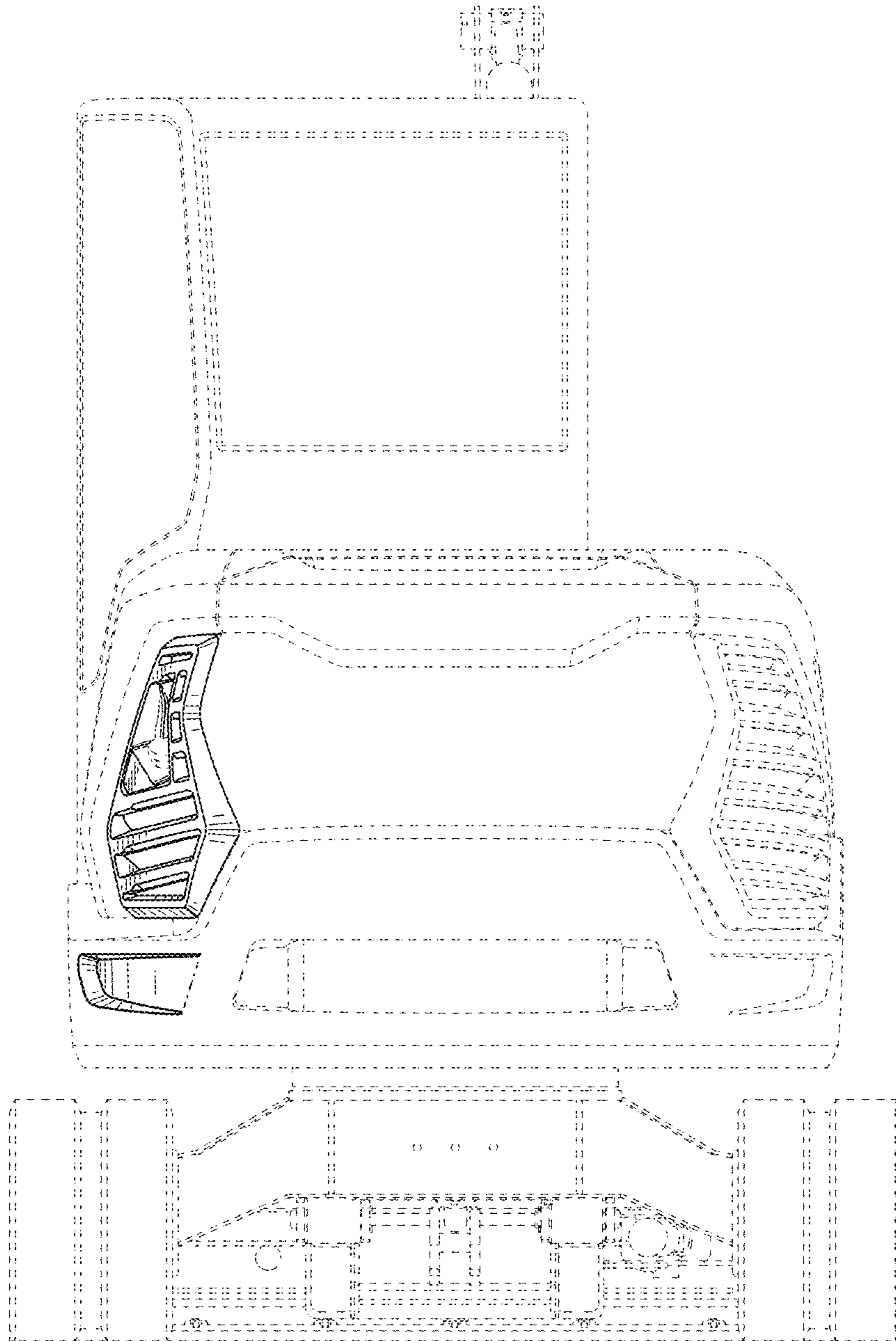

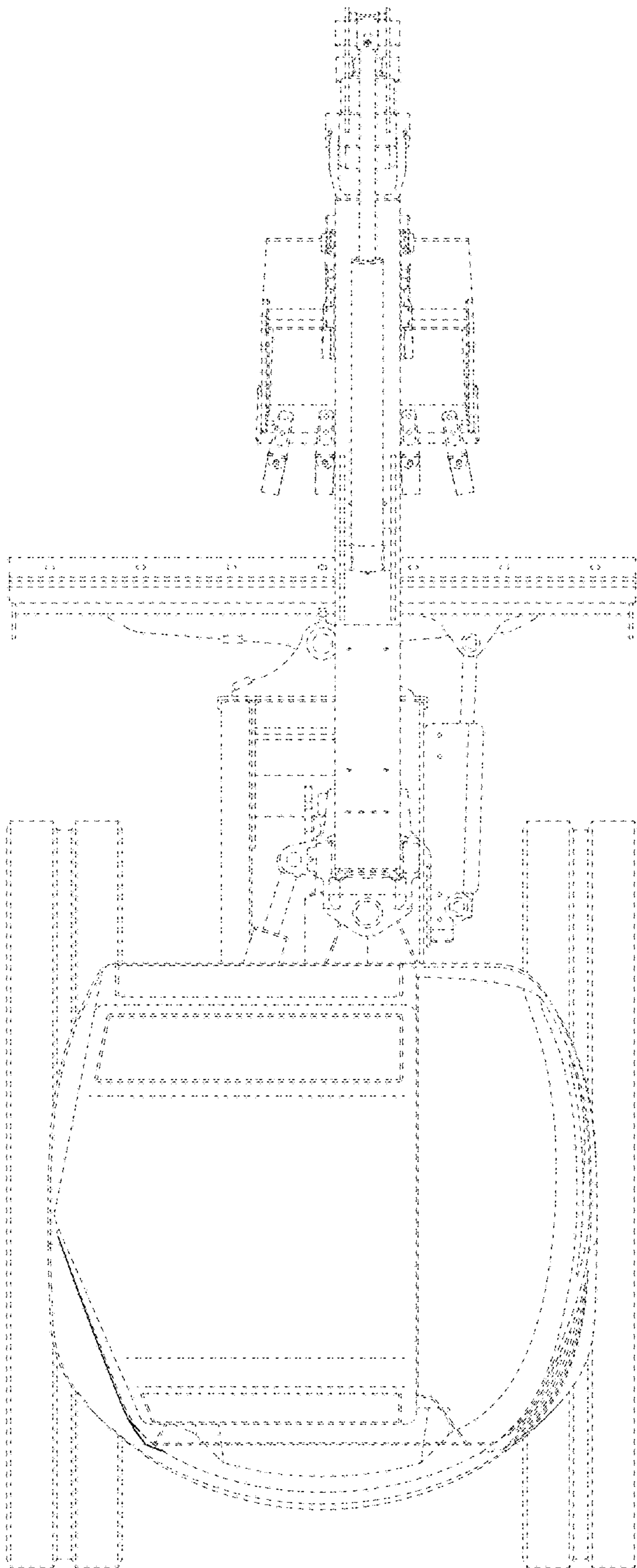
