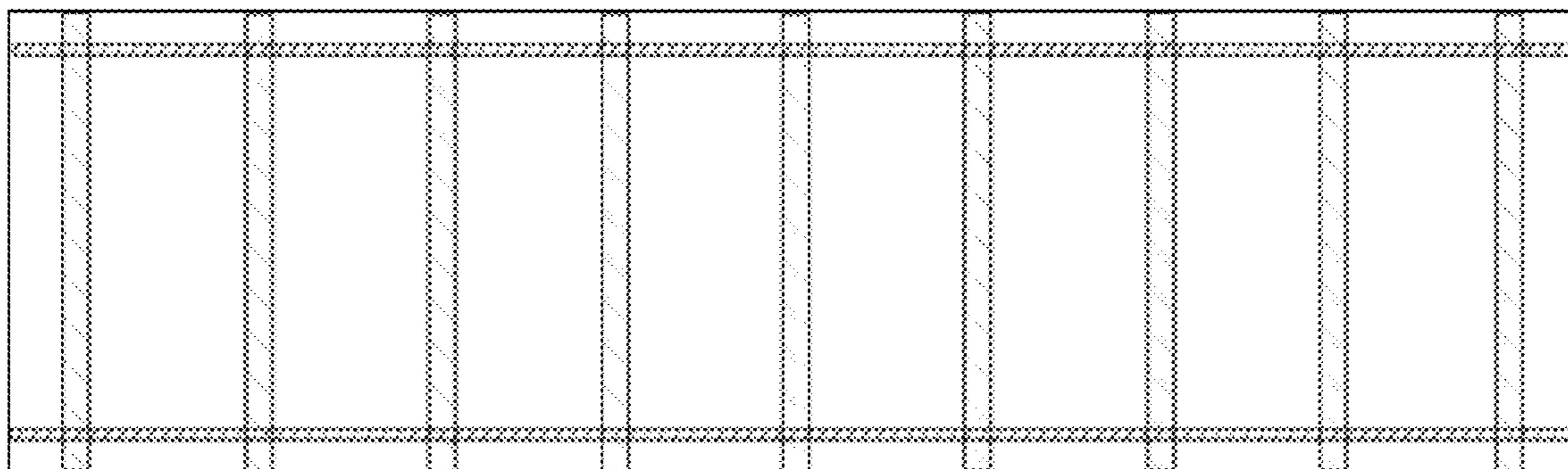
(57) **CLAIM**

The ornamental design for an adhesive tape, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an embodiment of a section of an adhesive tape showing the claimed design;  
FIG. 2 is a back view thereof;  
FIG. 3 is a top view thereof, which is a mirror image to a bottom view; and,

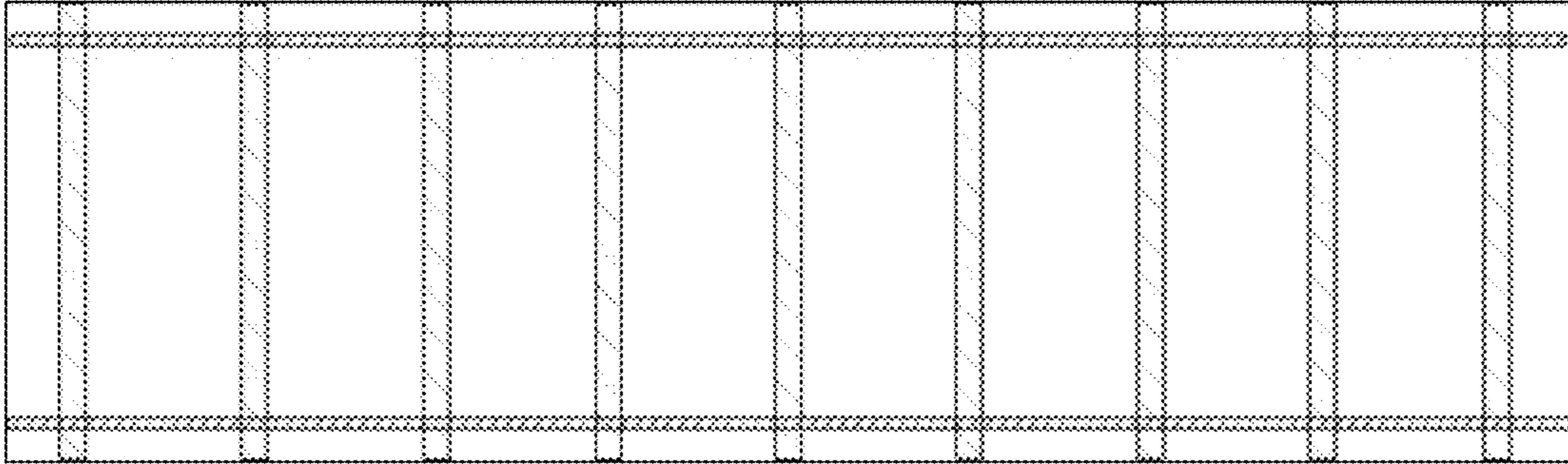

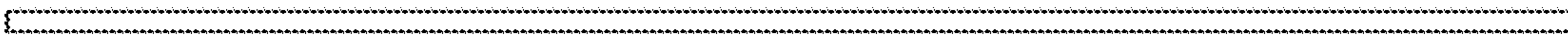
