DESCRIPTION

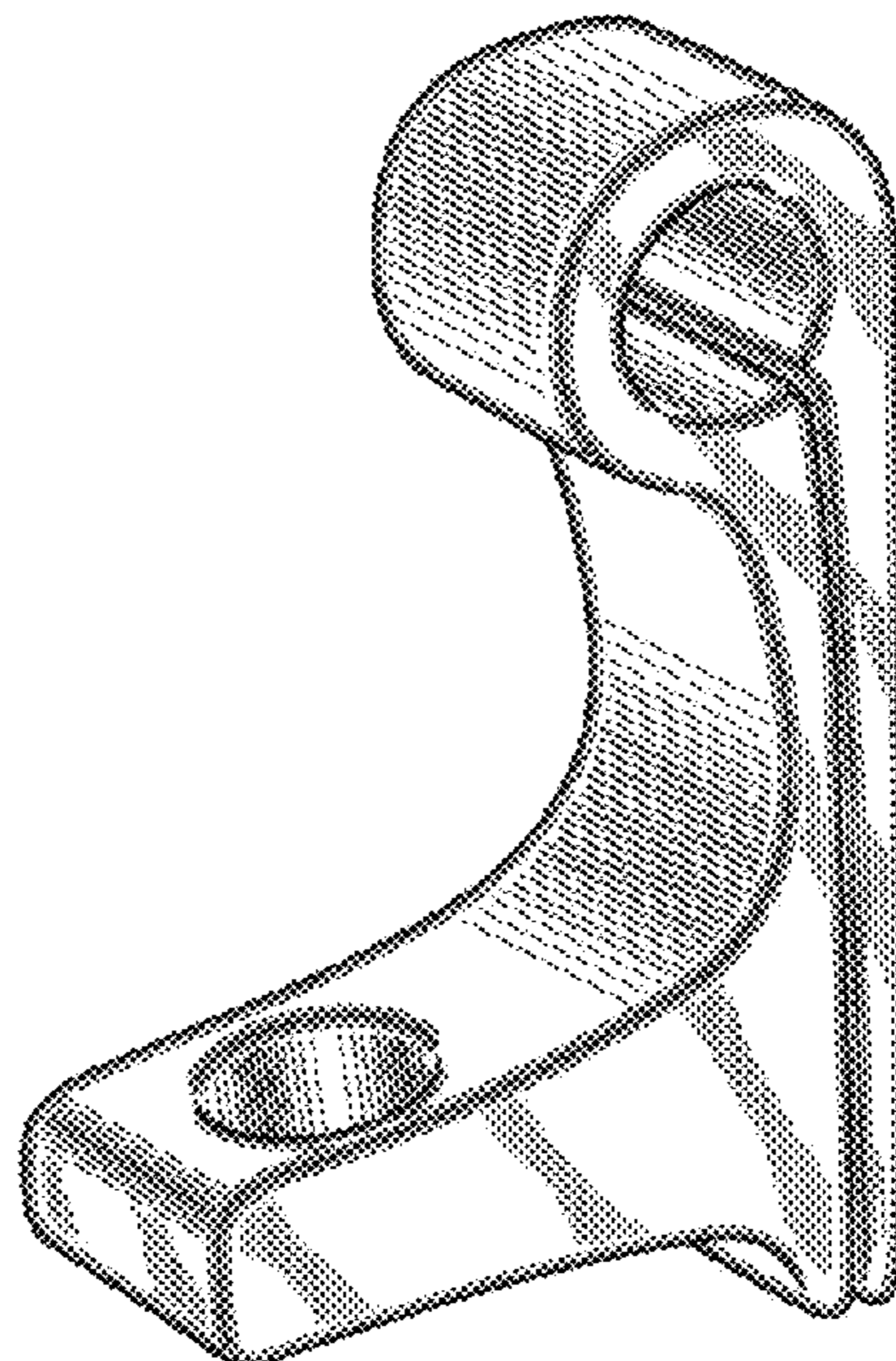
FIG. 1 is a first perspective view of a catheter bag clip showing my new design.

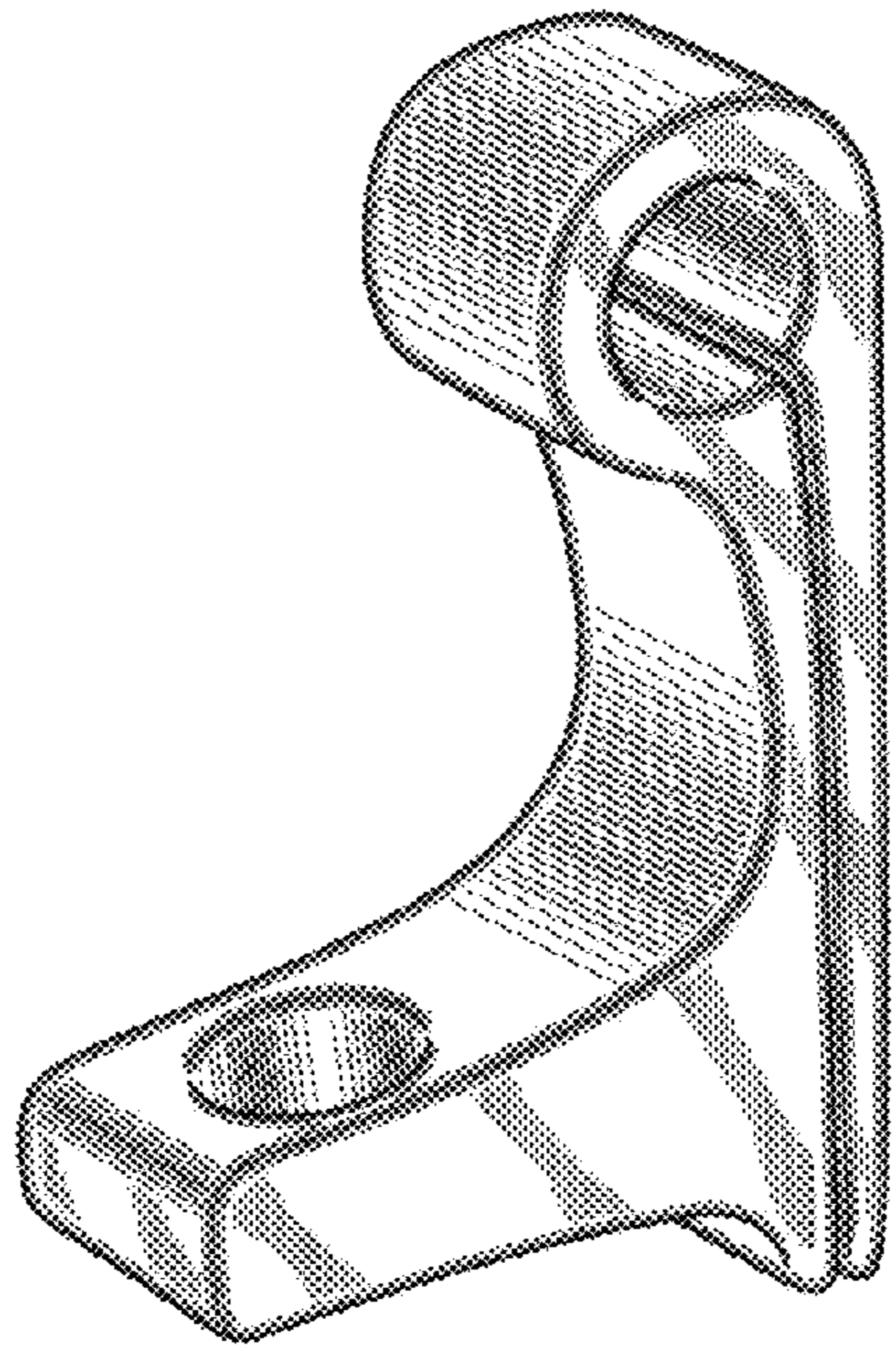

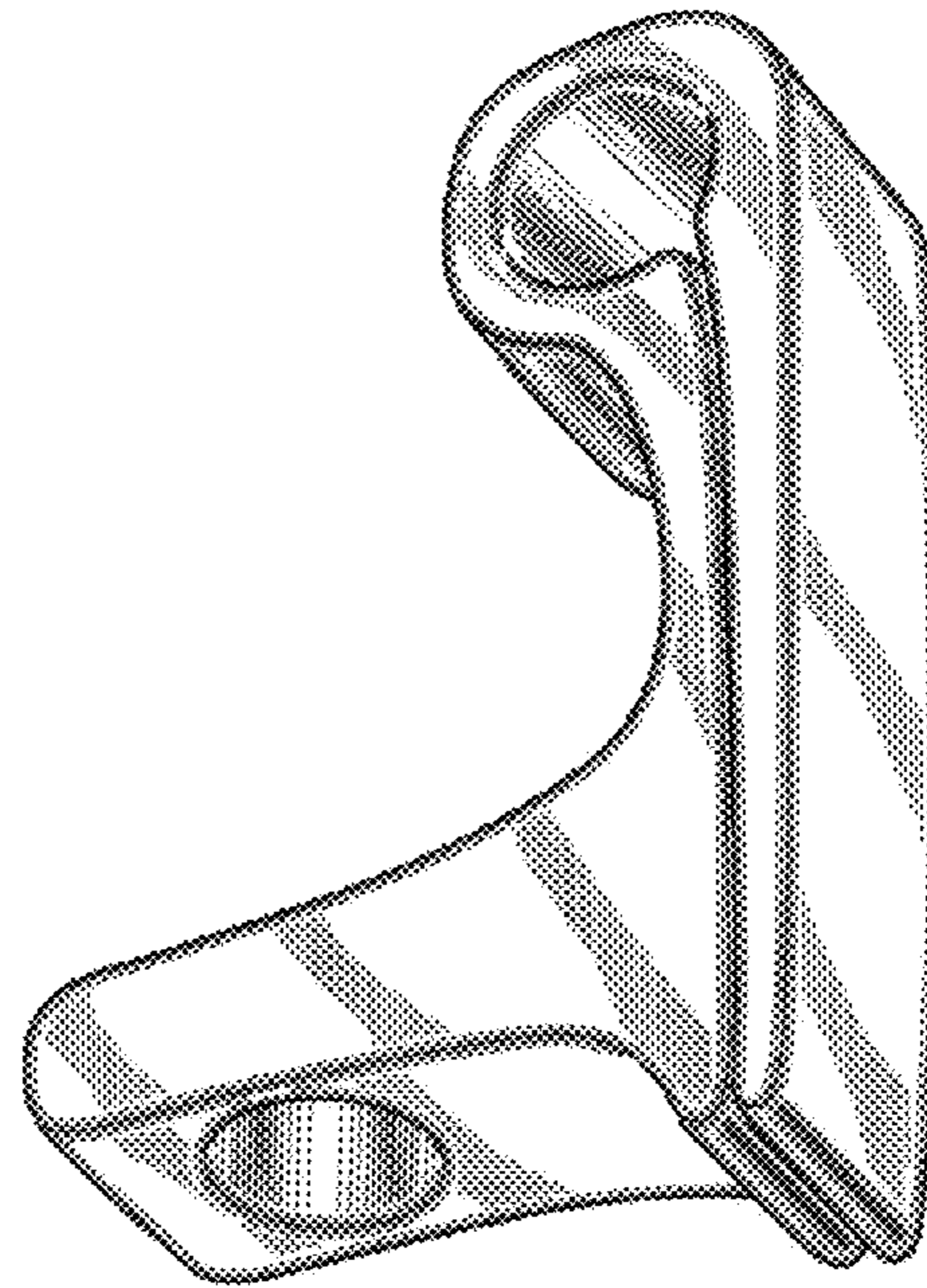

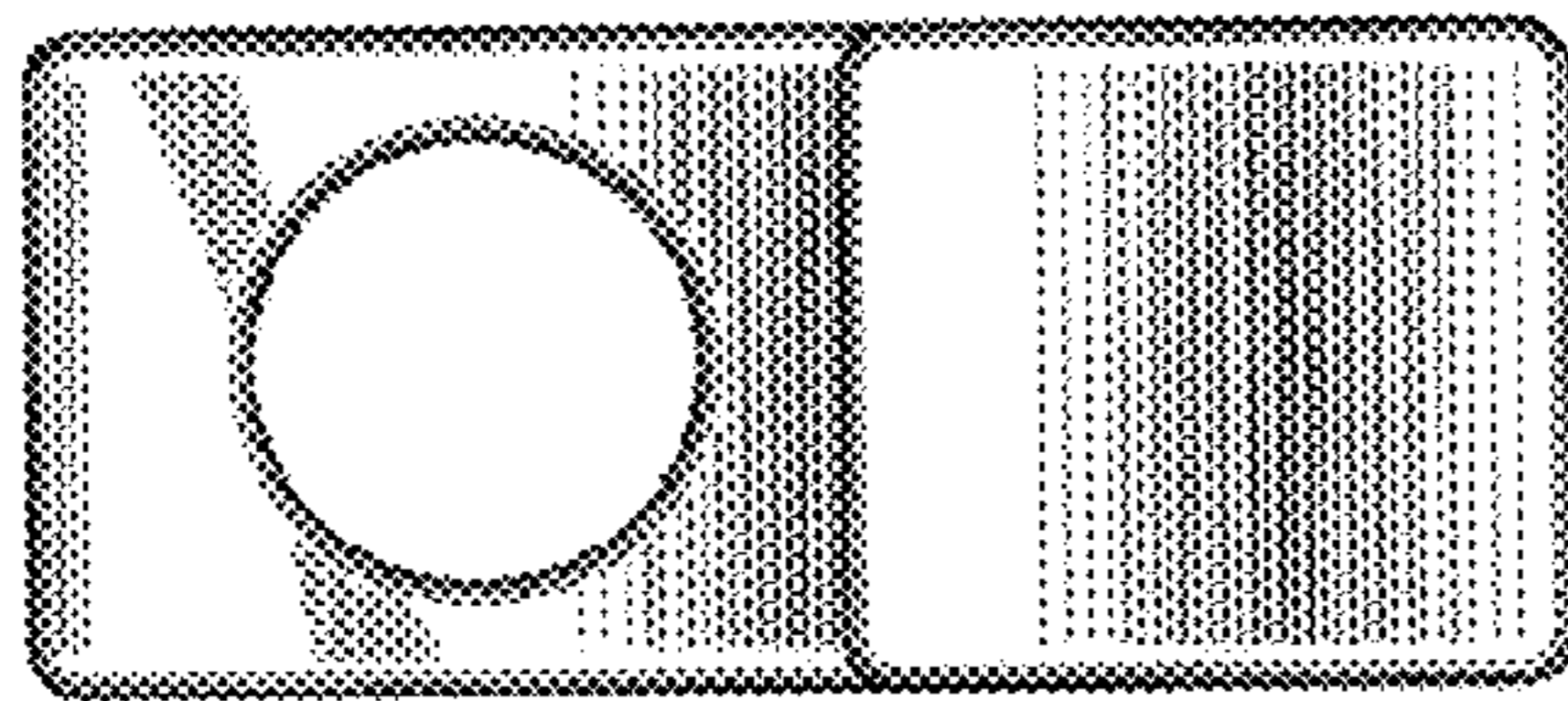

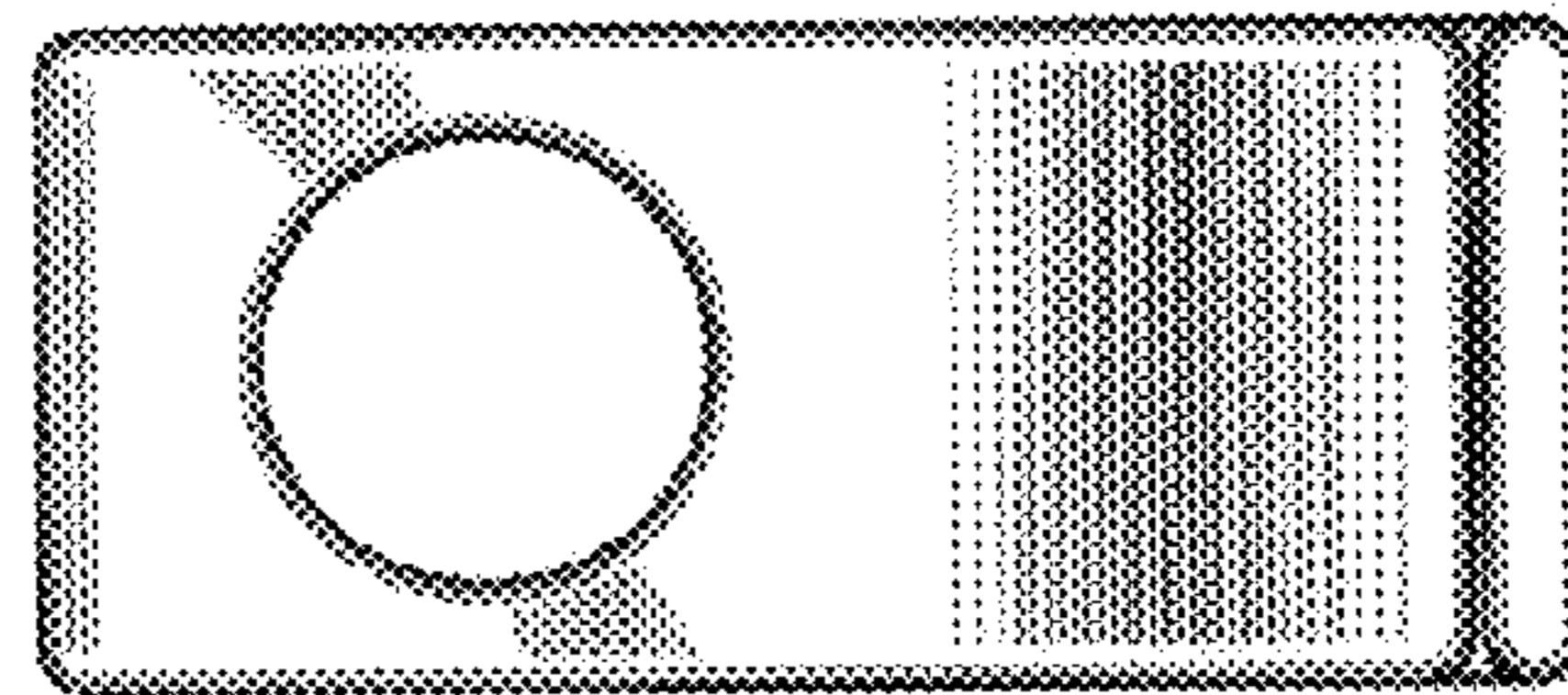

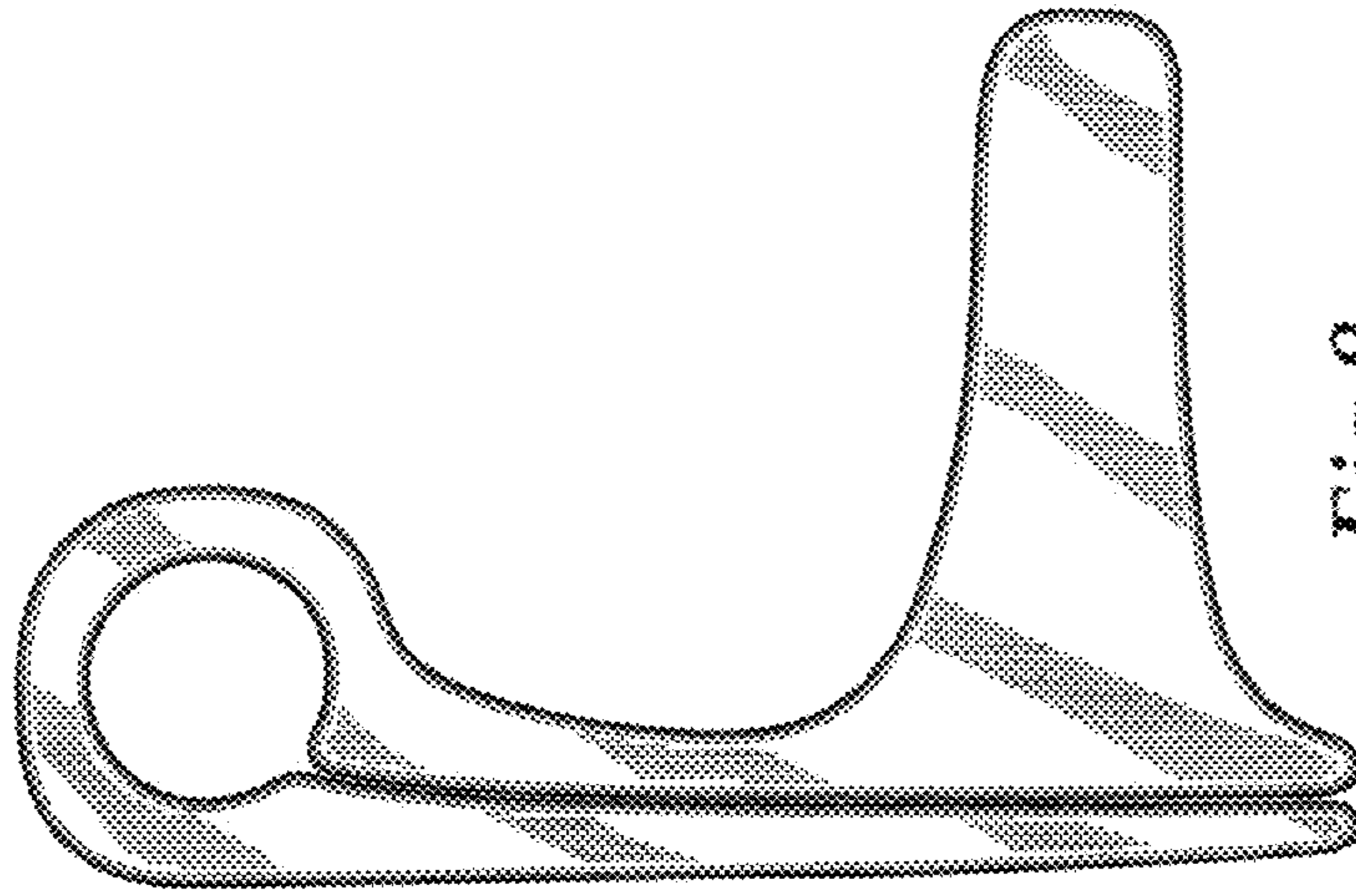

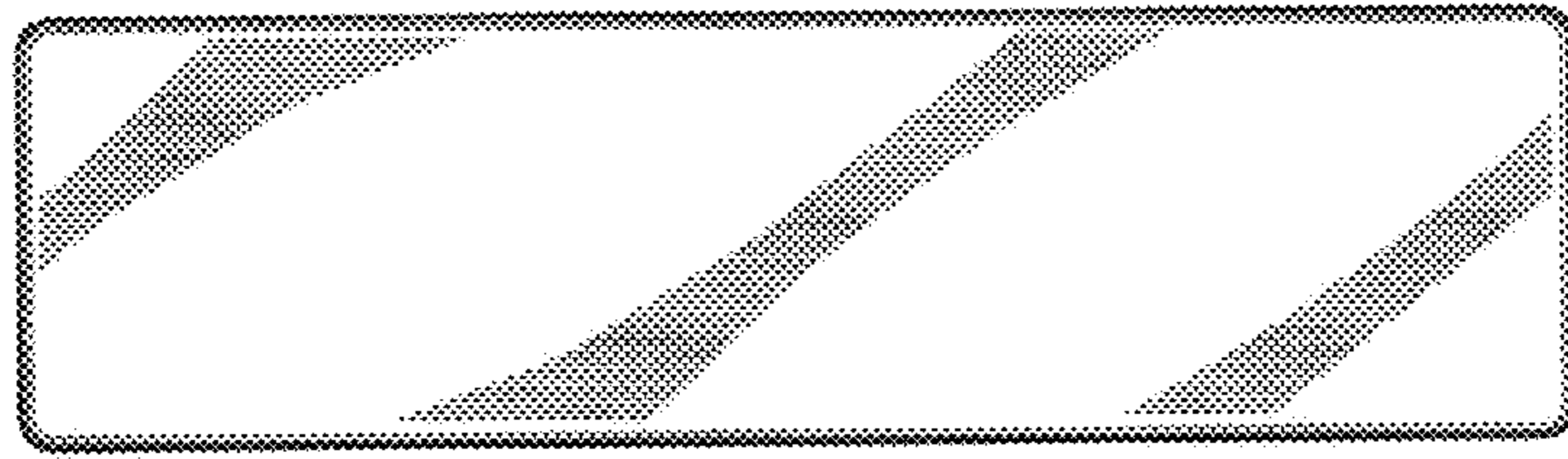

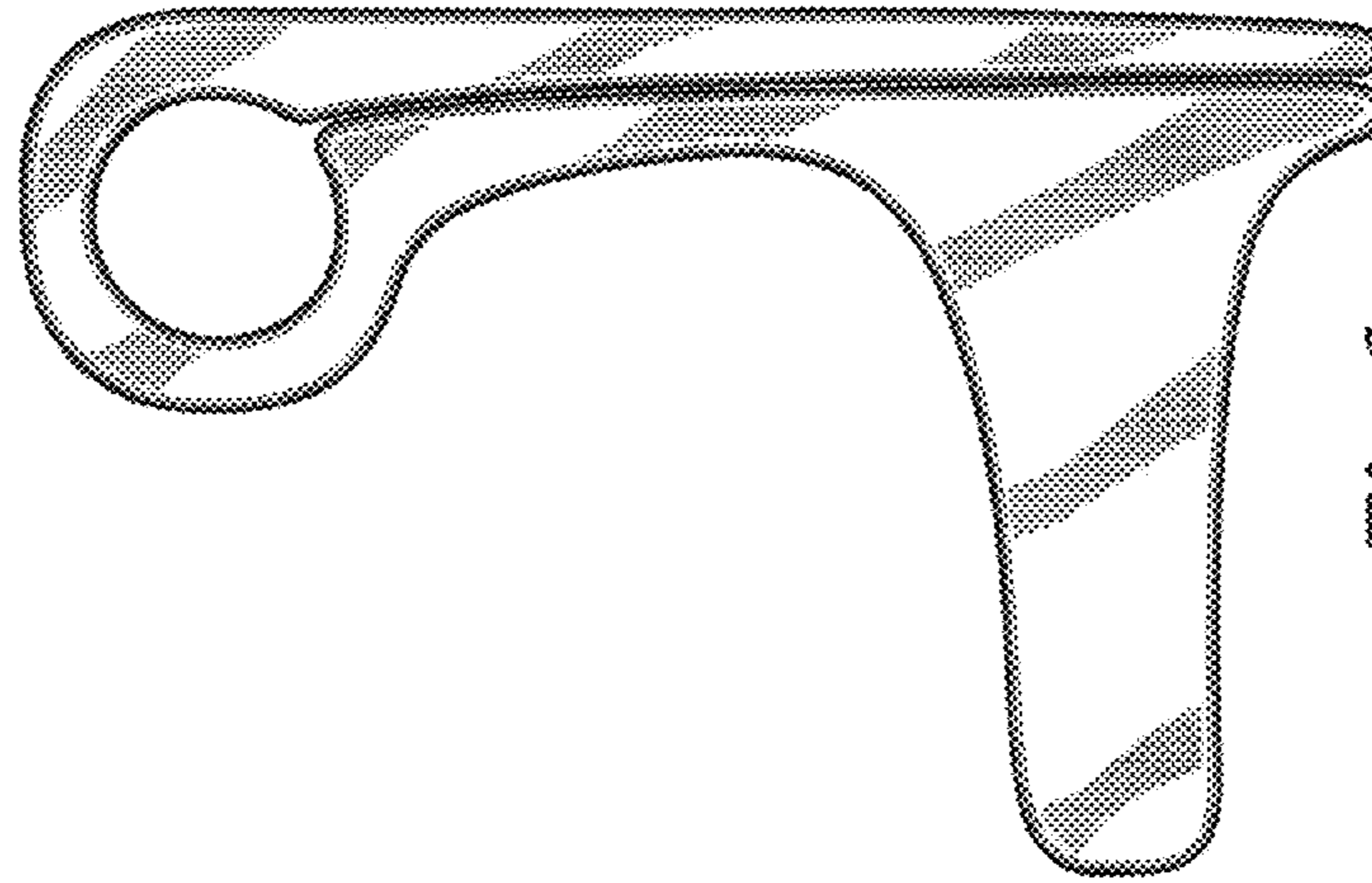

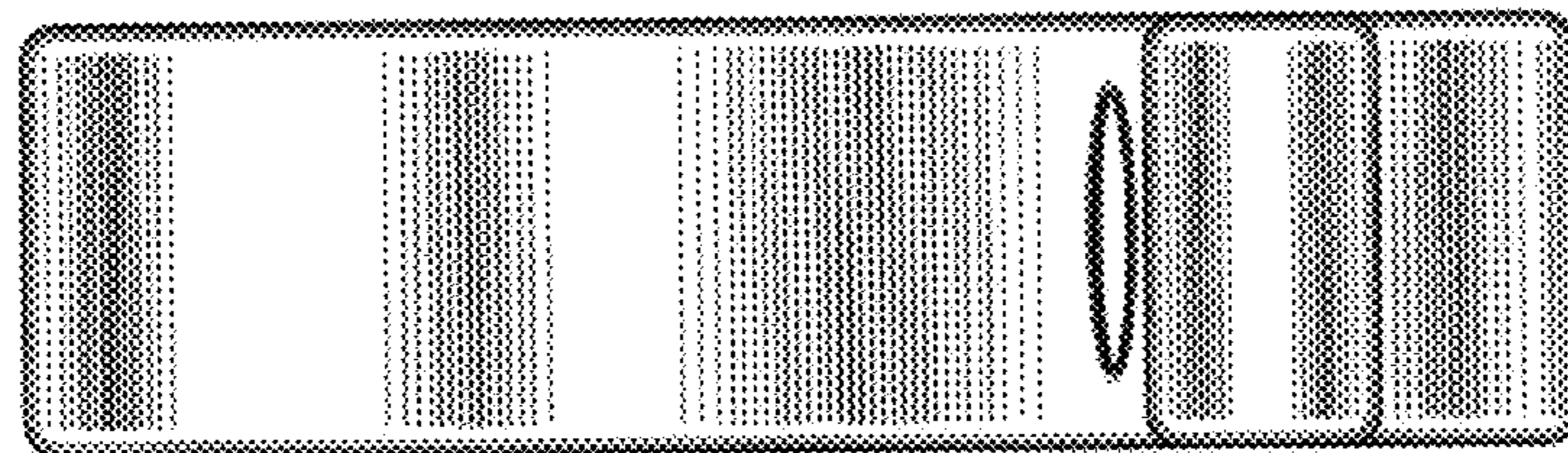
