**DESCRIPTION**

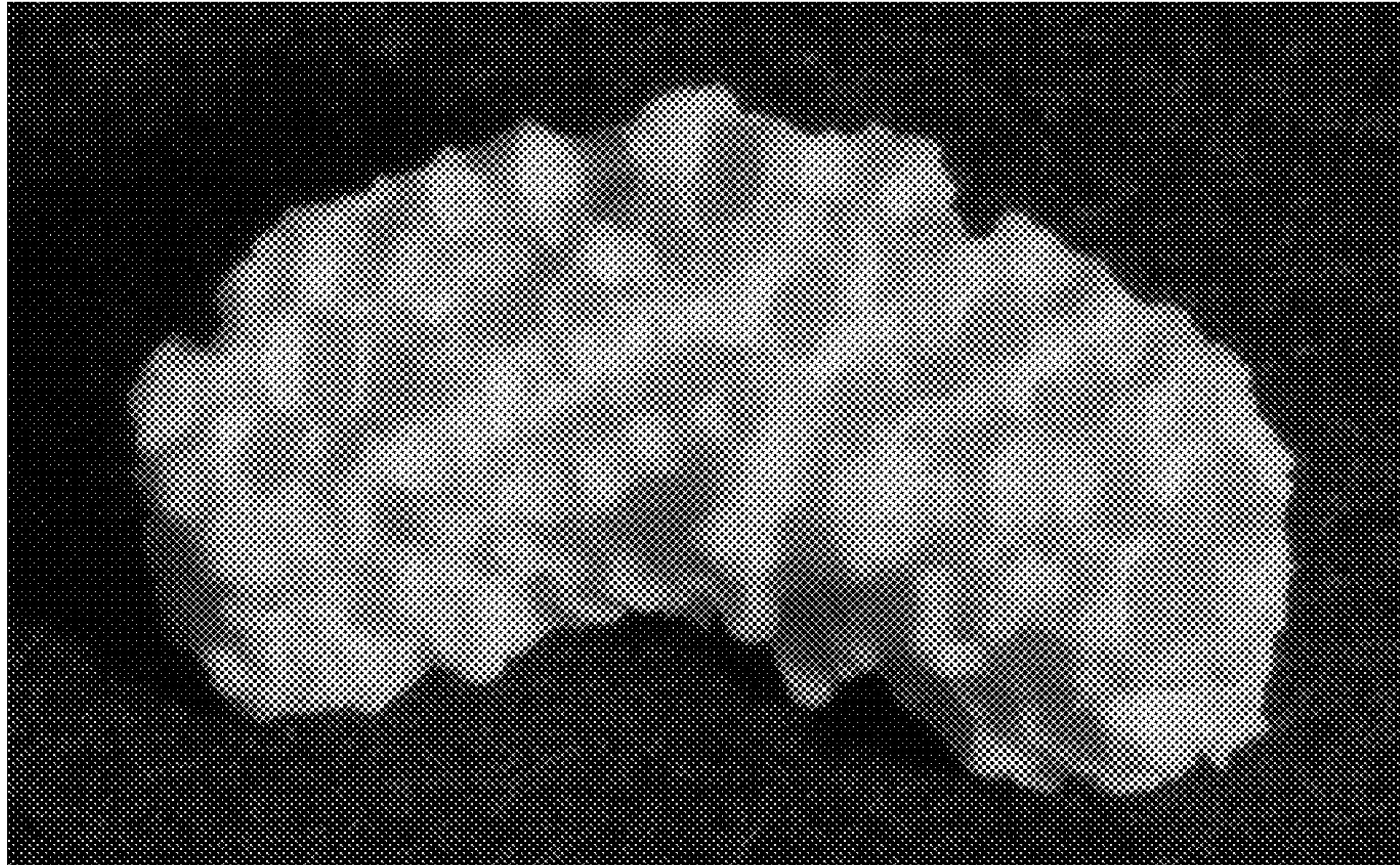

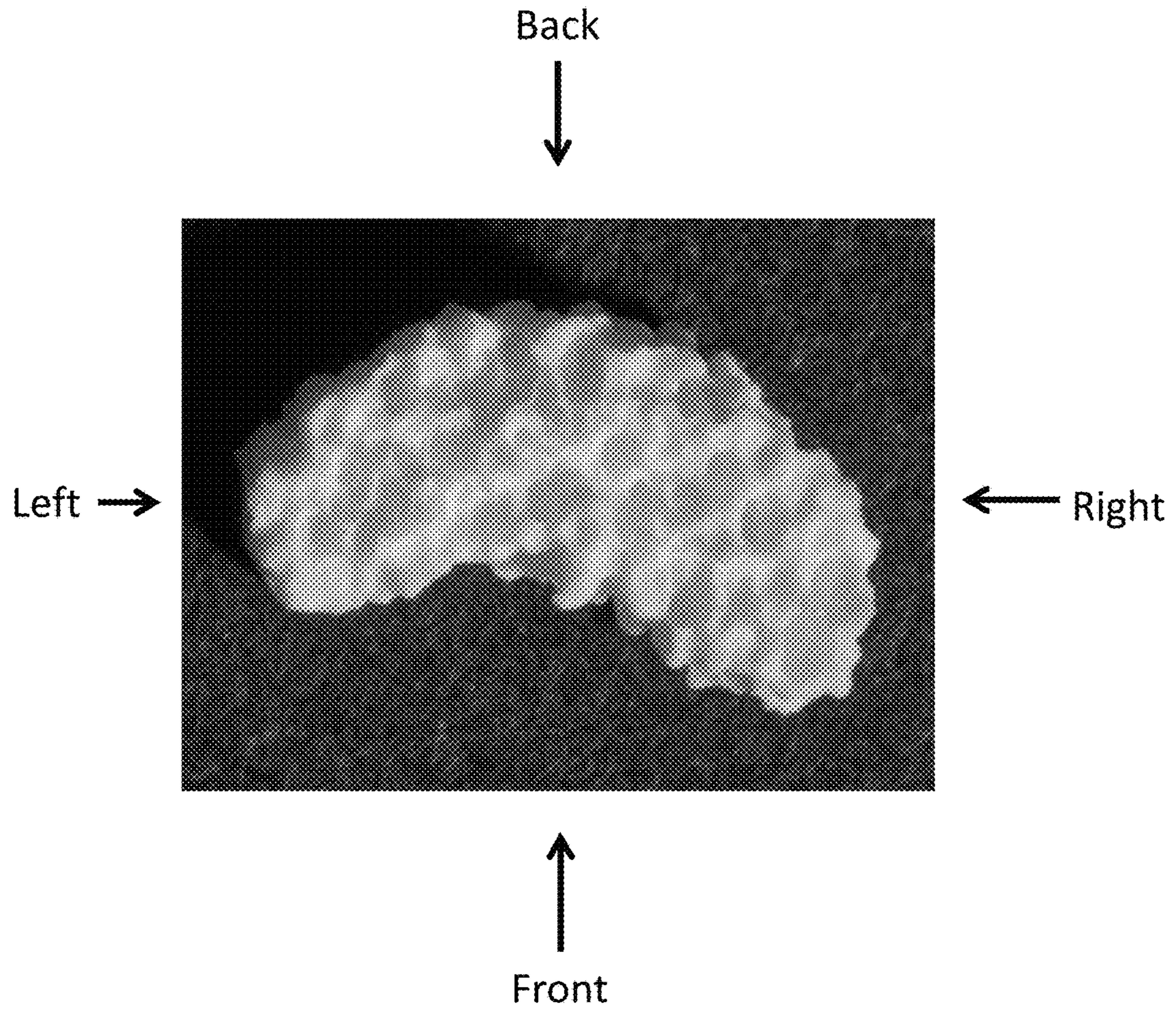

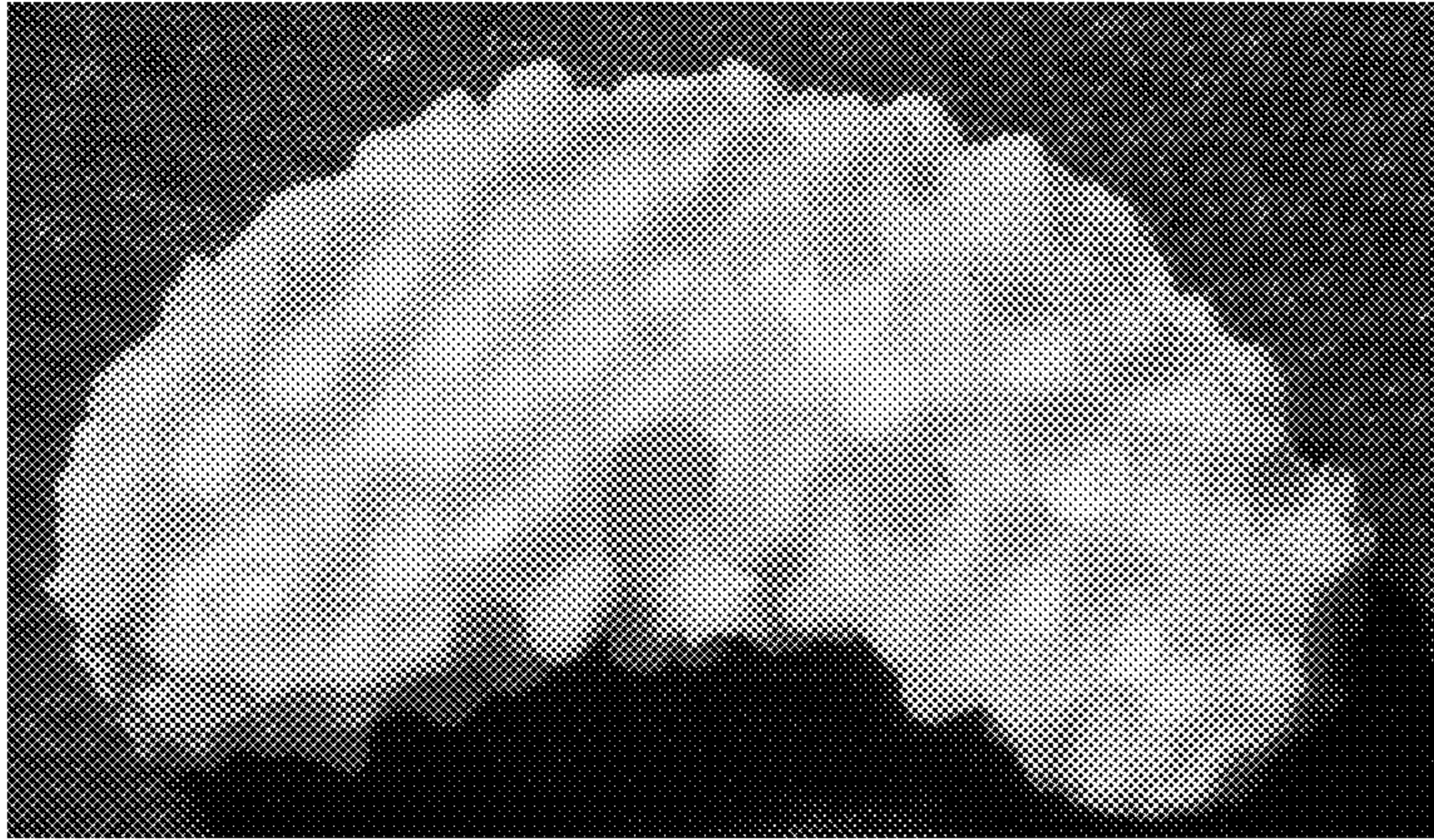

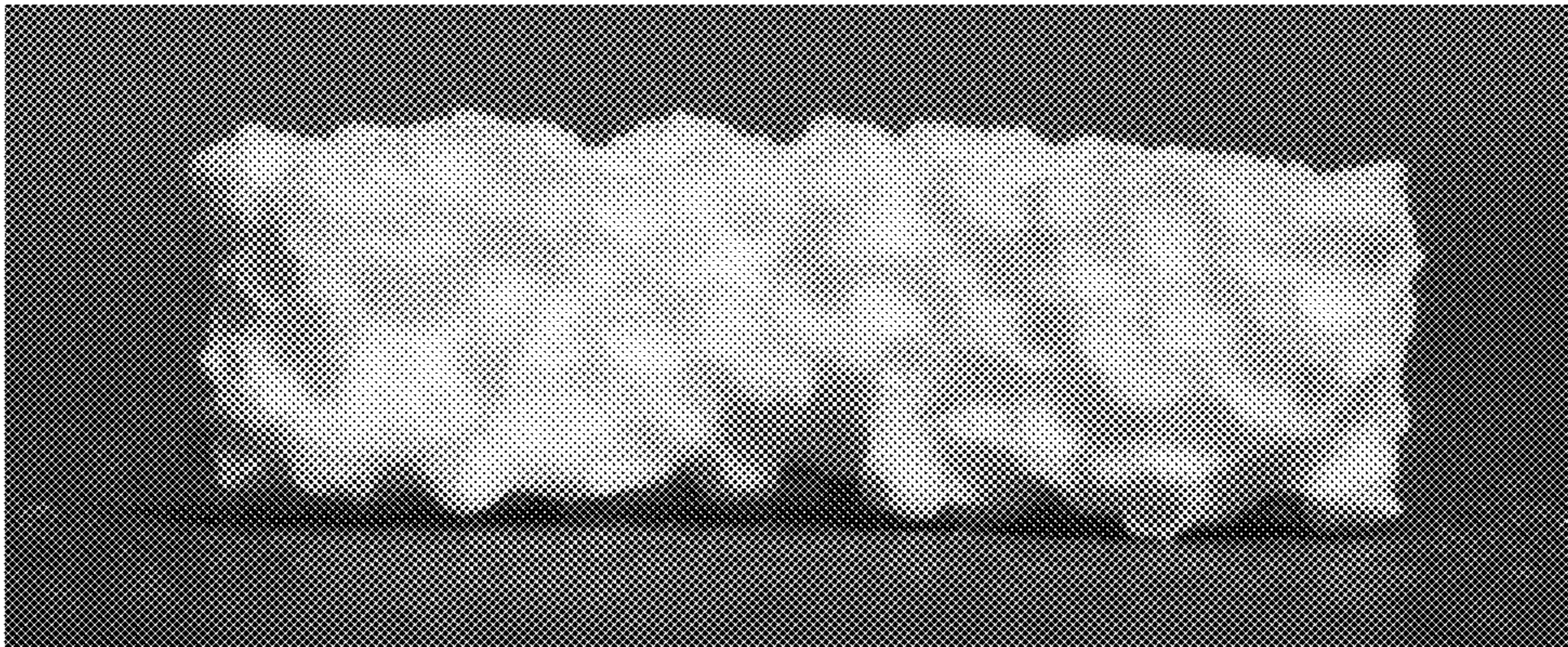
Top view

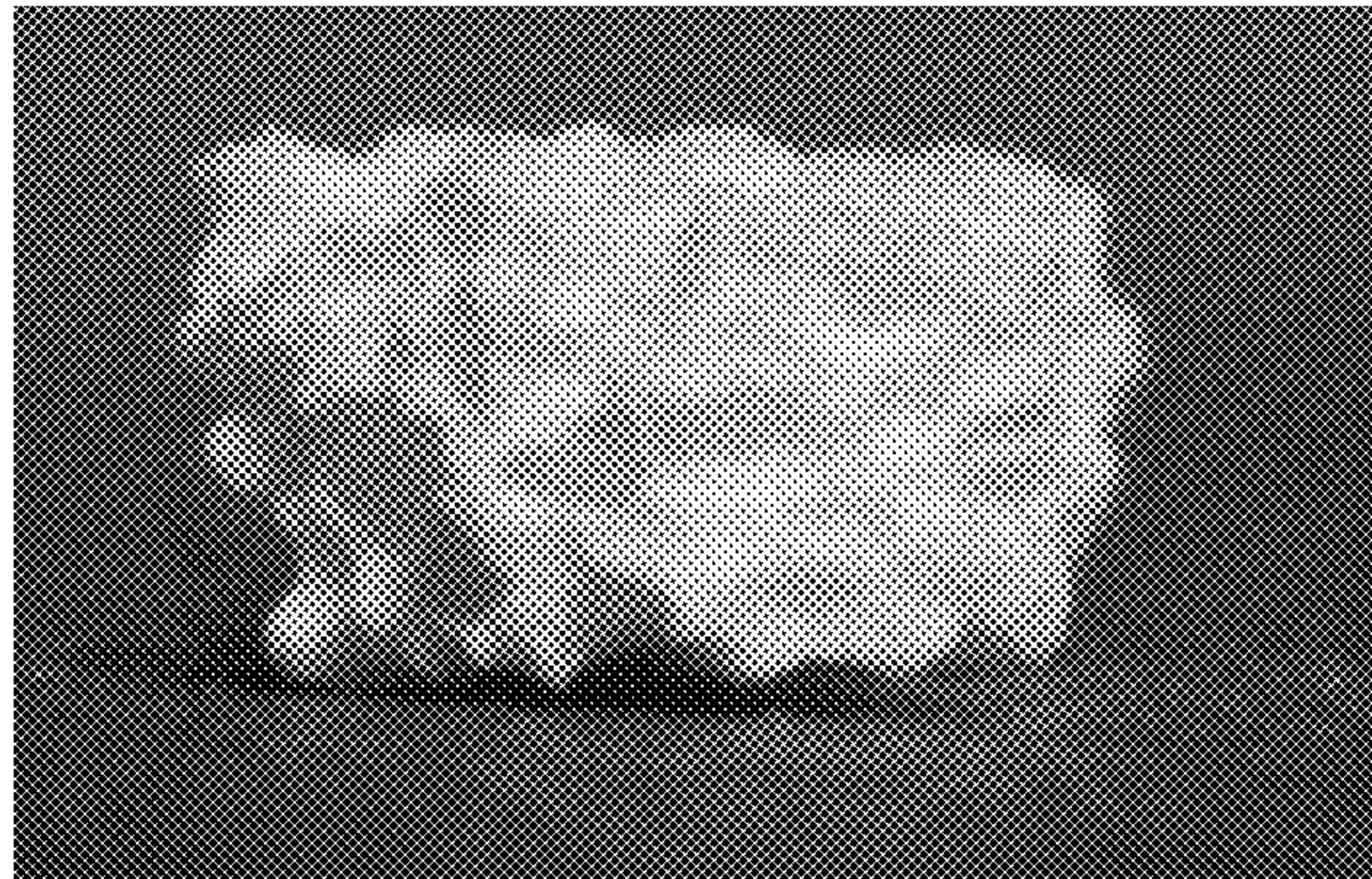

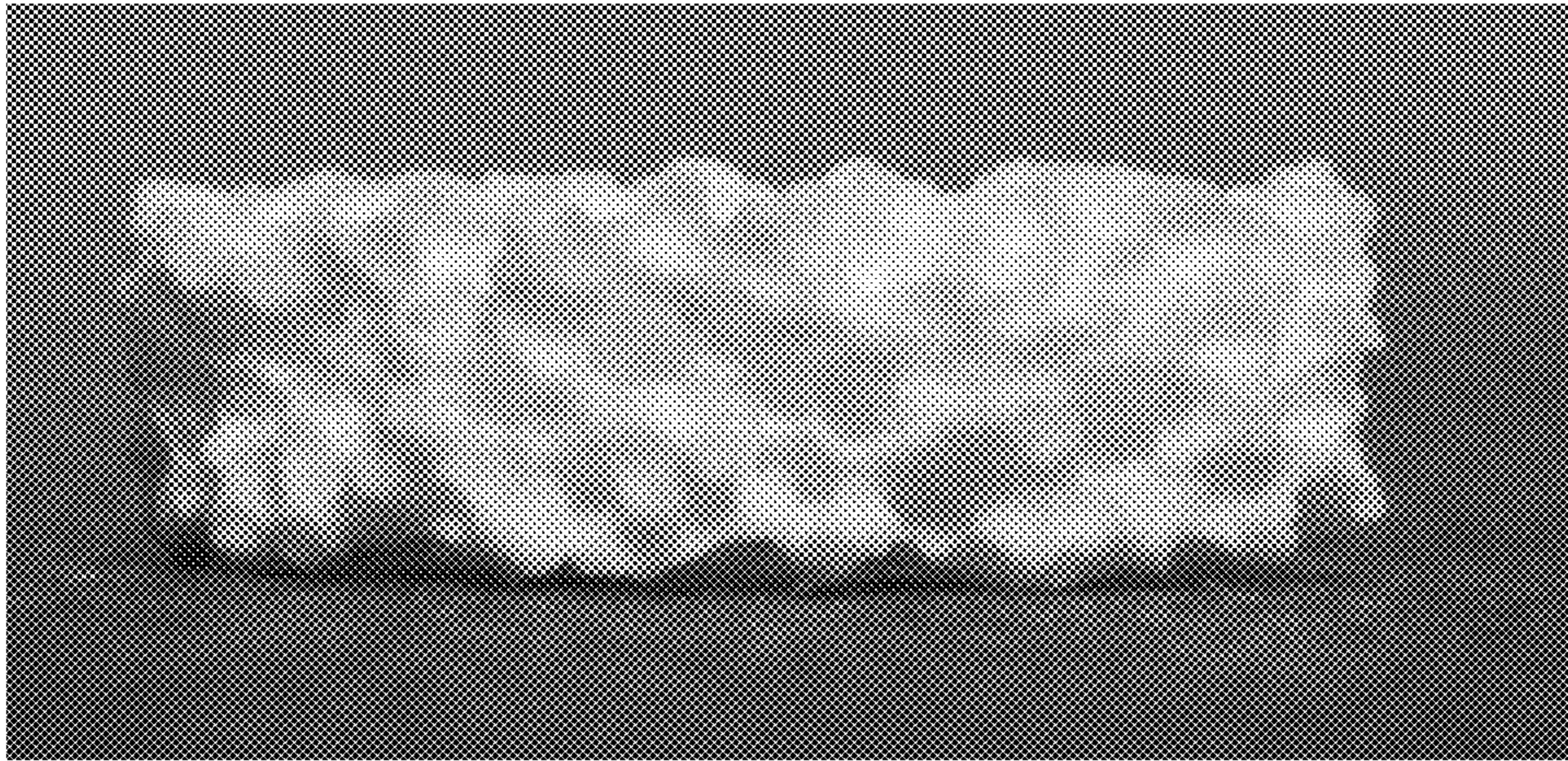

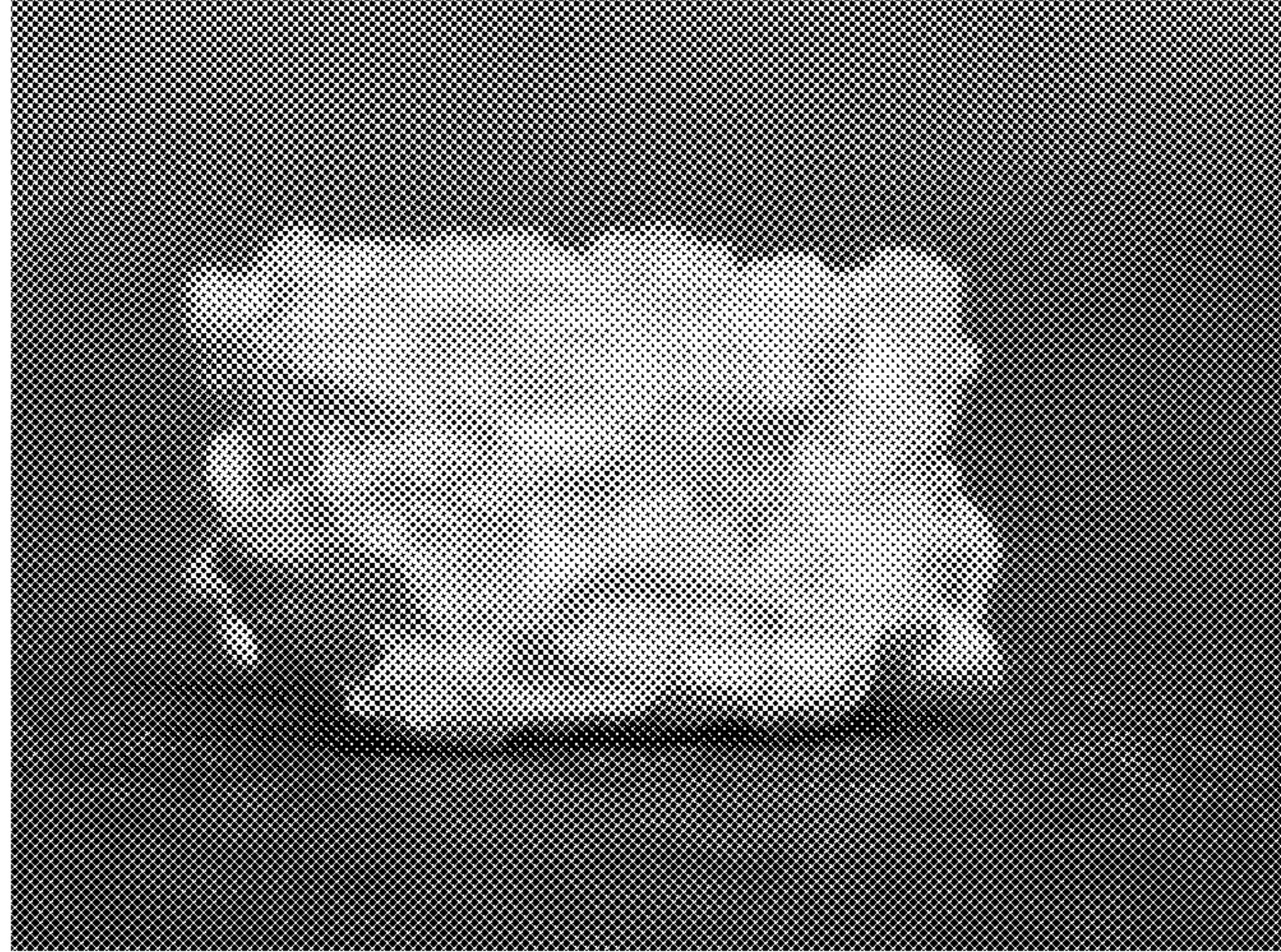
