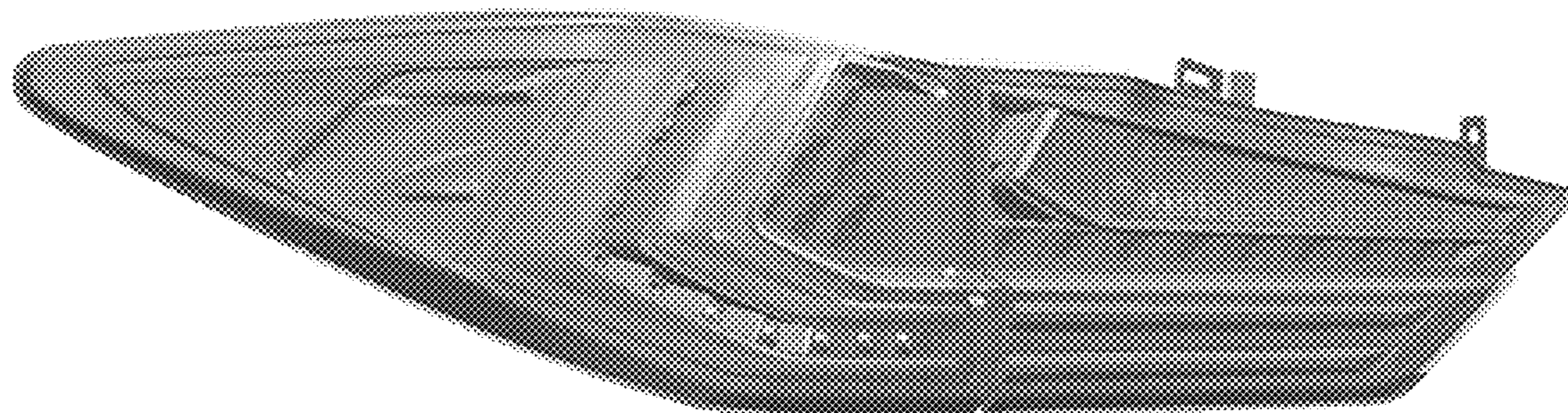
(57) **CLAIM**

The ornamental design for a rear combination lamp for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rear combination lamp for a motor vehicle showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear perspective view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom view thereof. Our design includes a mirror image of the embodiment depicted.

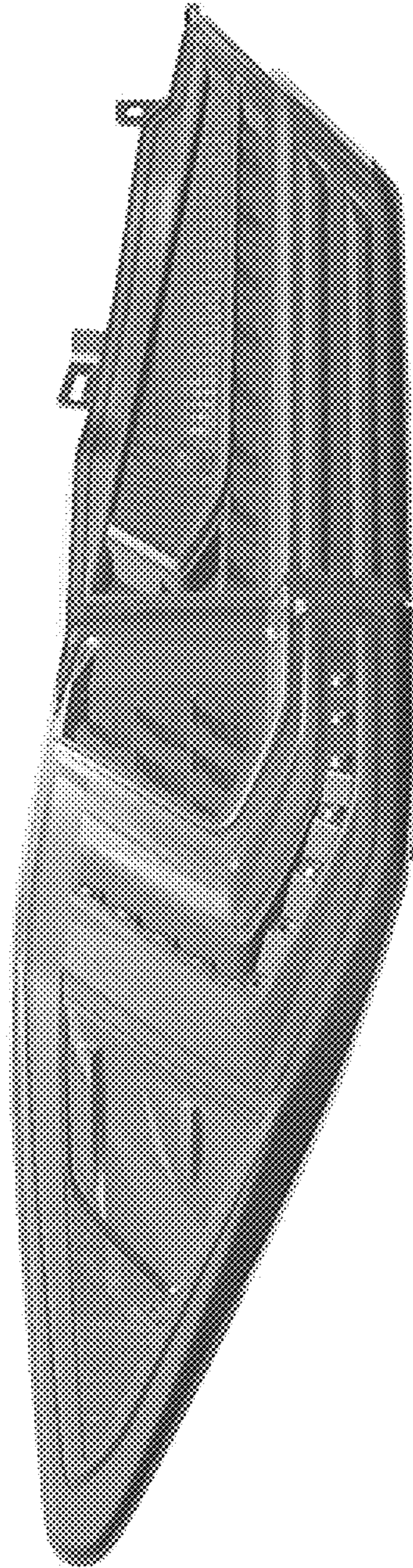

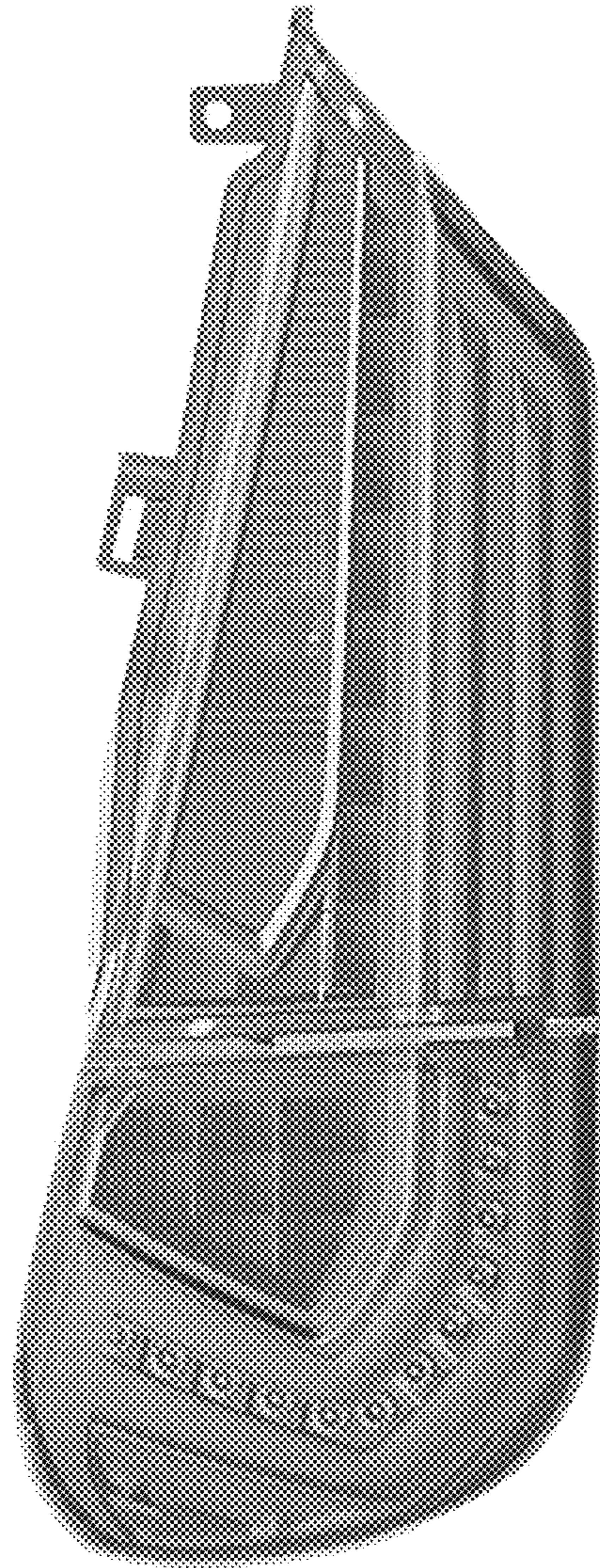

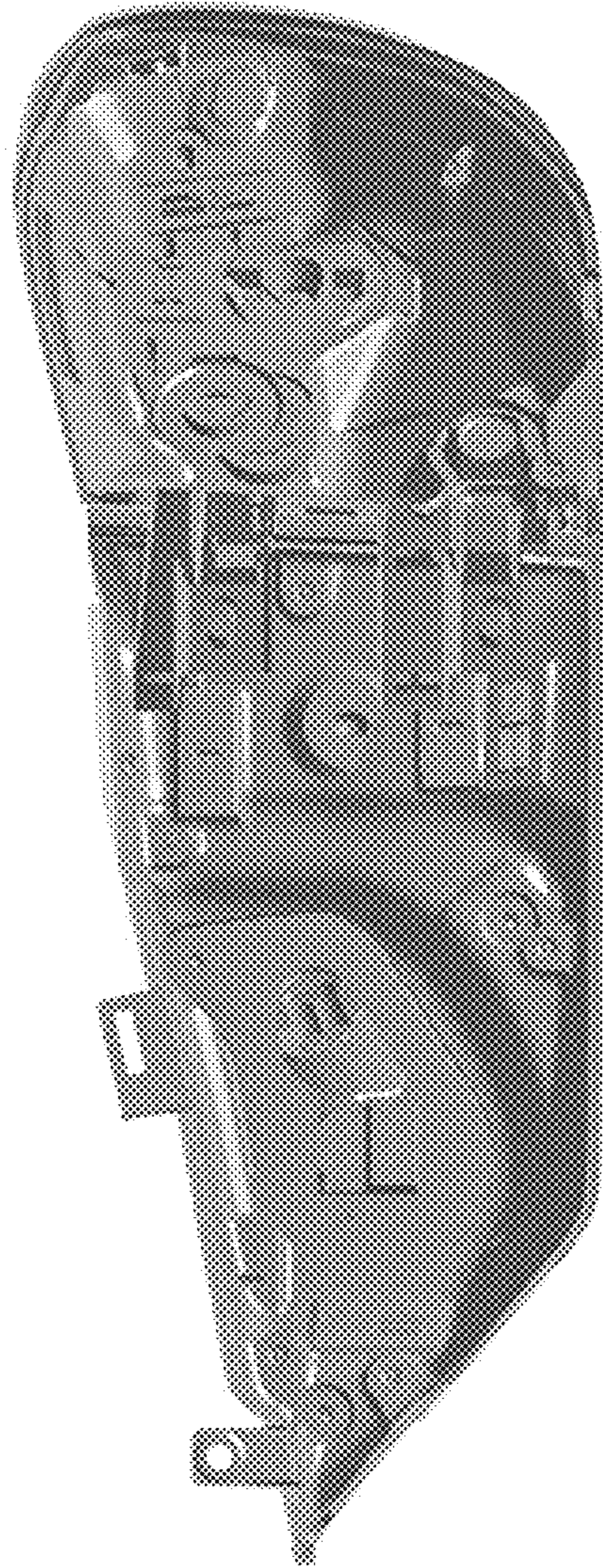

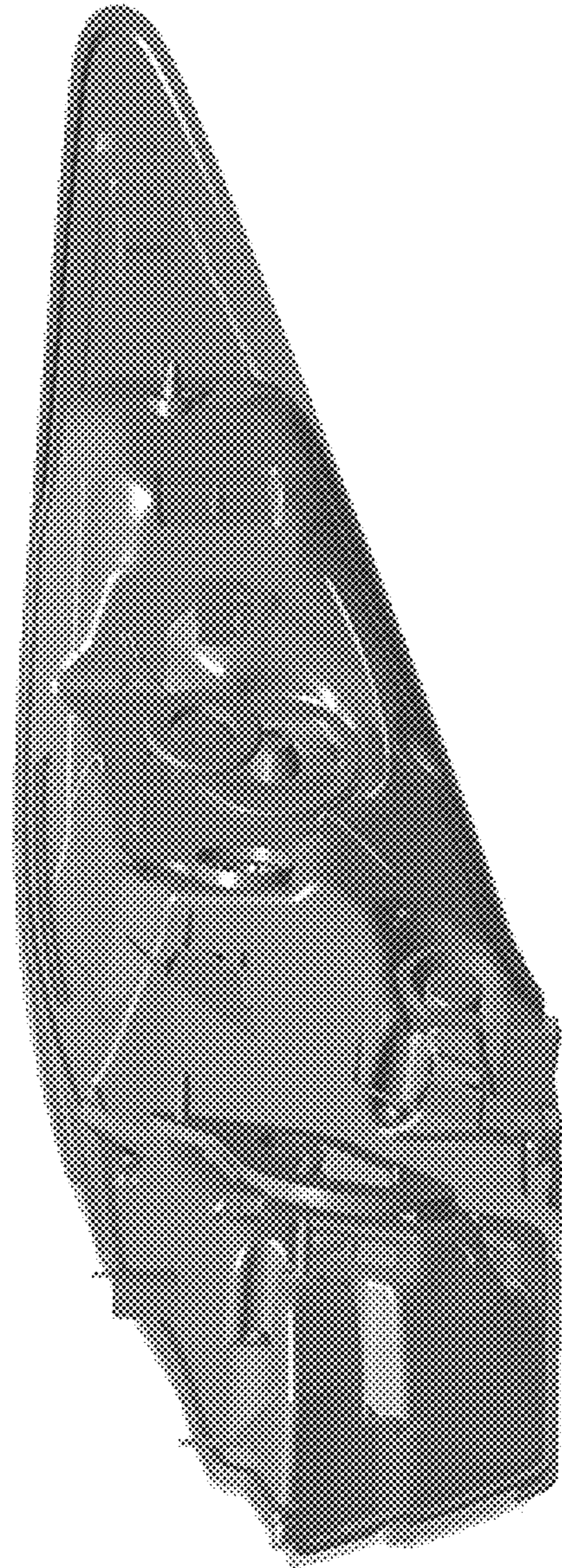

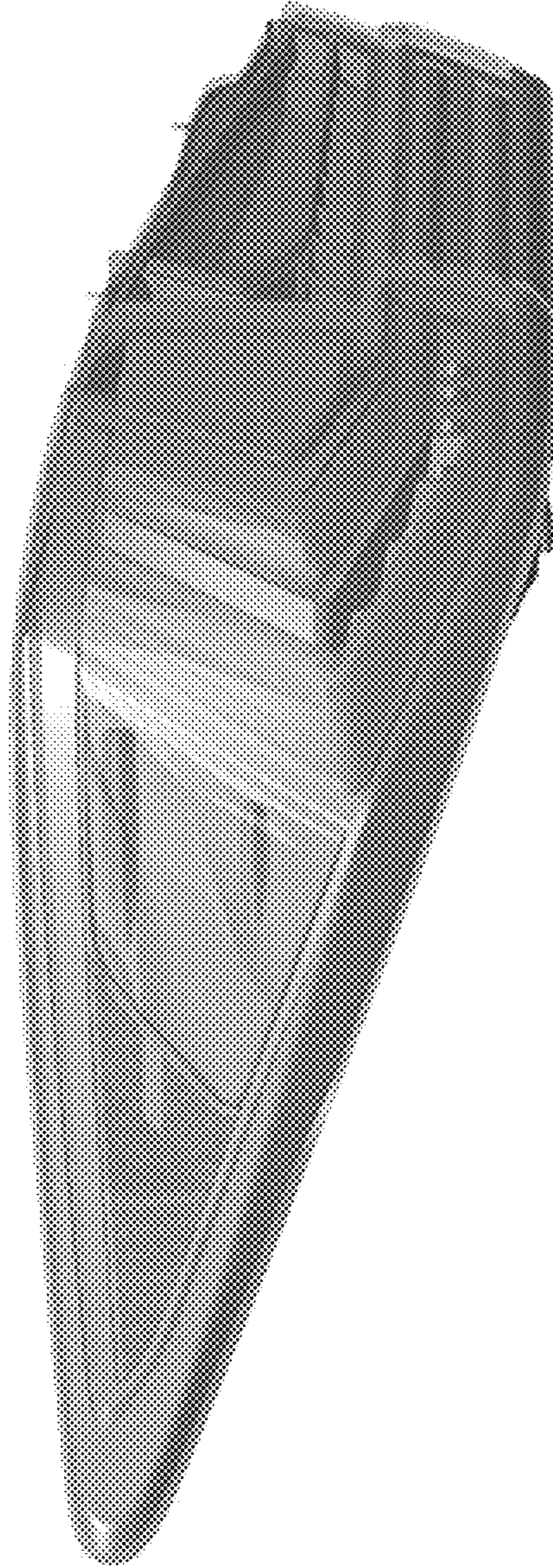

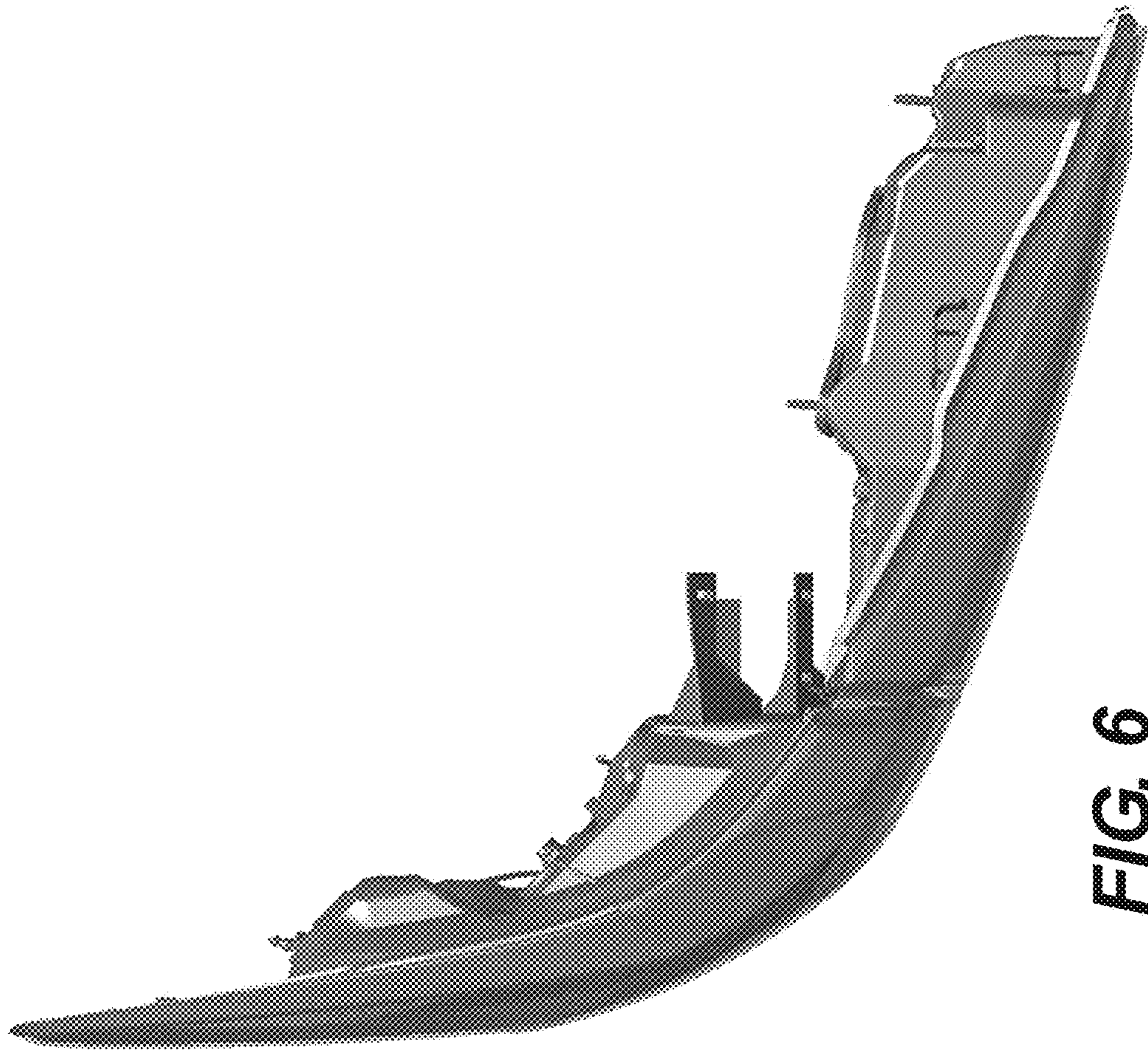

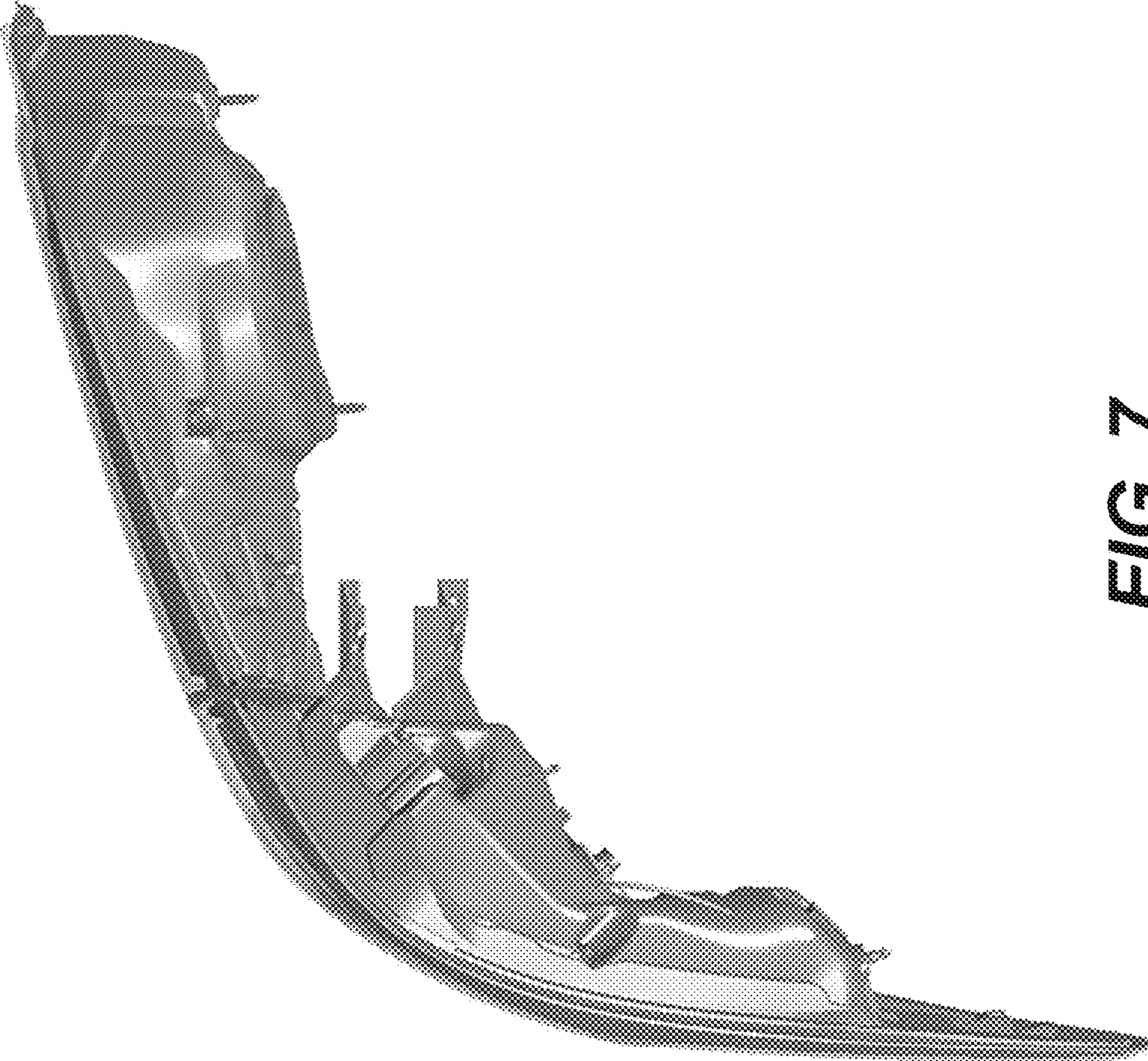
