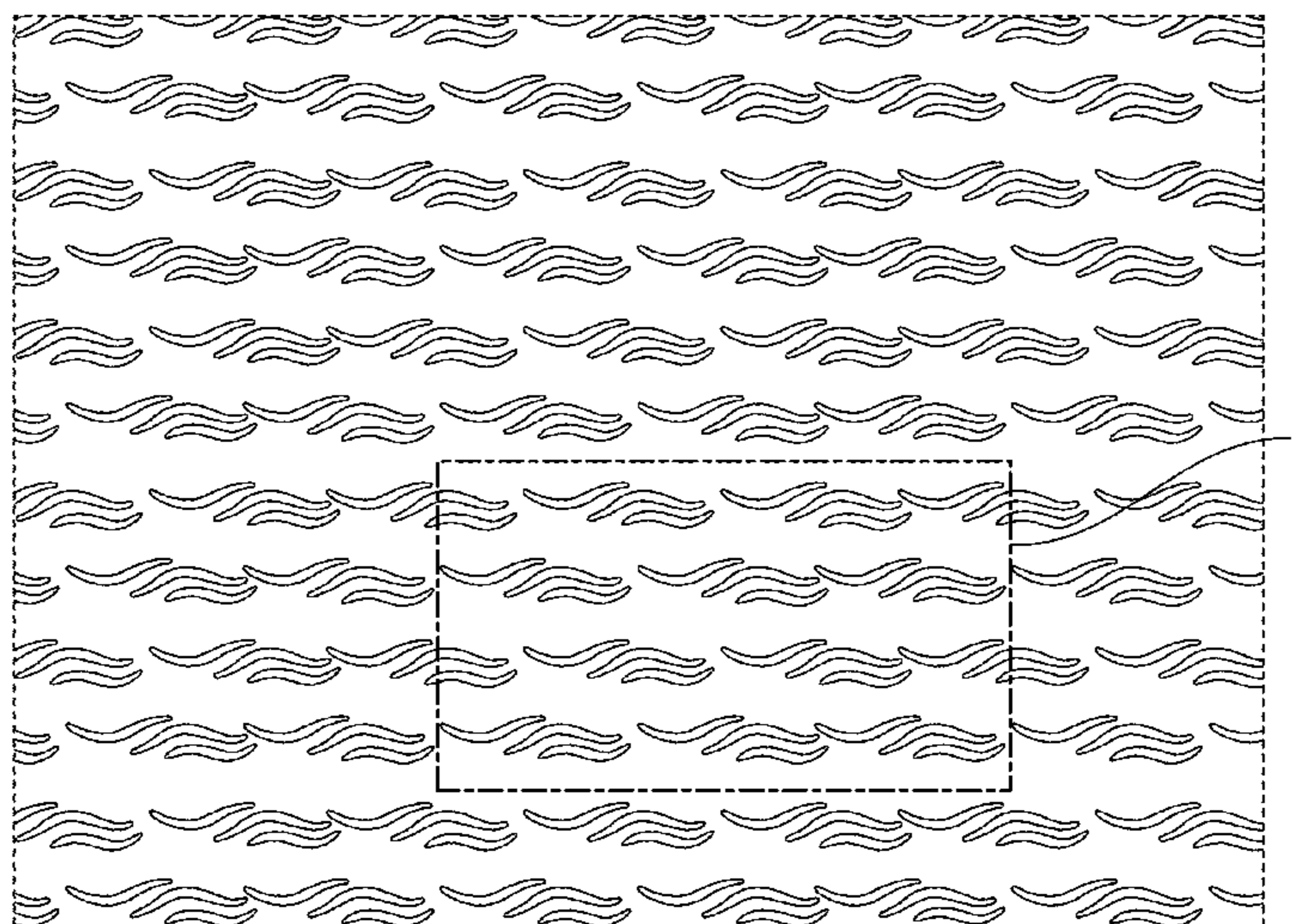
(57) **CLAIM**

The ornamental design for a nonwoven fabric with surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a nonwoven fabric with surface pattern; and,
FIG. 2 is an enlarged detail view of area 2 circumscribed by dot dash dot broken lines within FIG. 1.
The broken line surrounding FIG. 1 depicts the boundaries of the claim and forms no part thereof. The dot dash dot broken line within FIG. 1 and surrounding FIG. 2 depicts the boundaries of the detail area and forms no part of the claimed design.

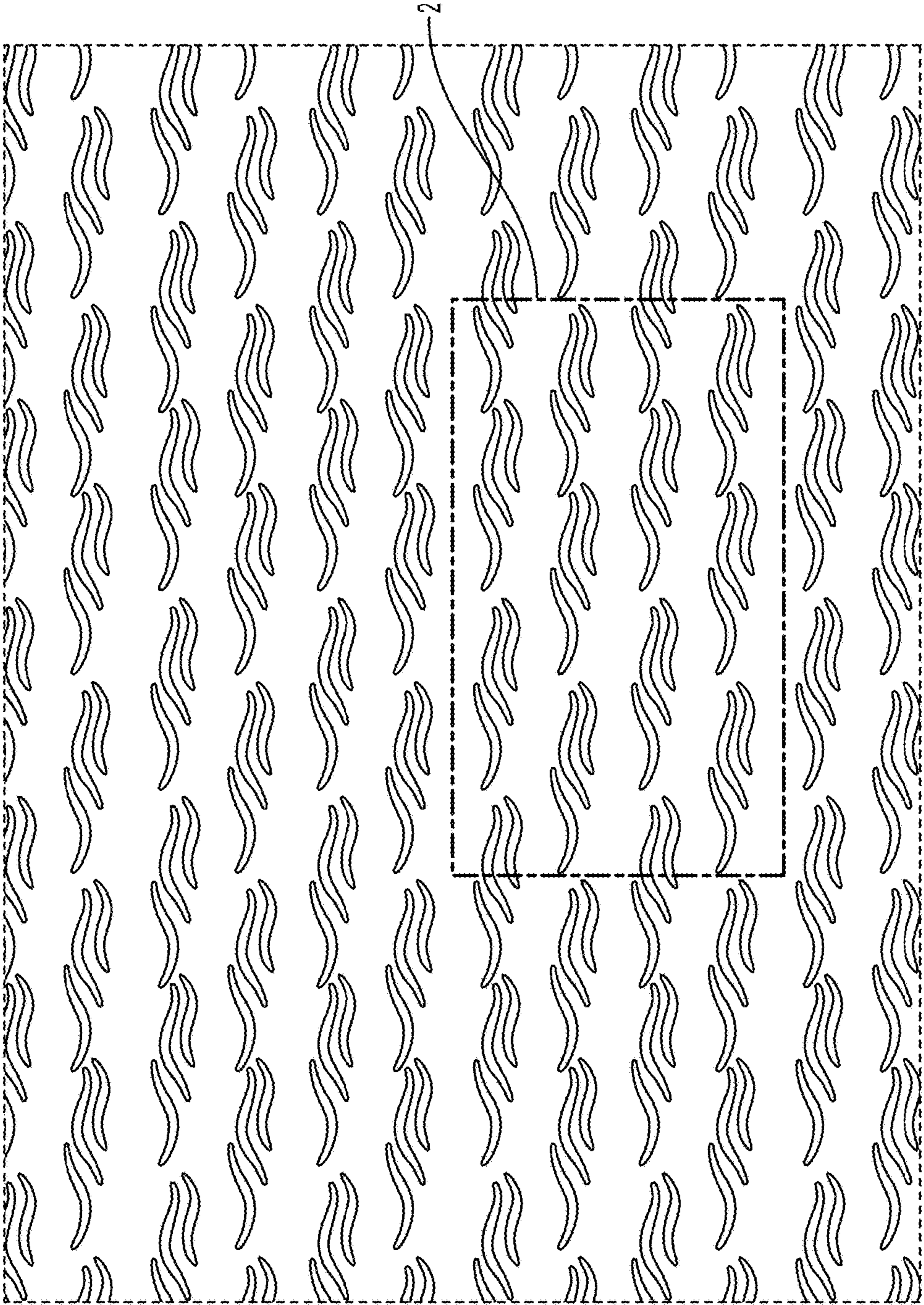

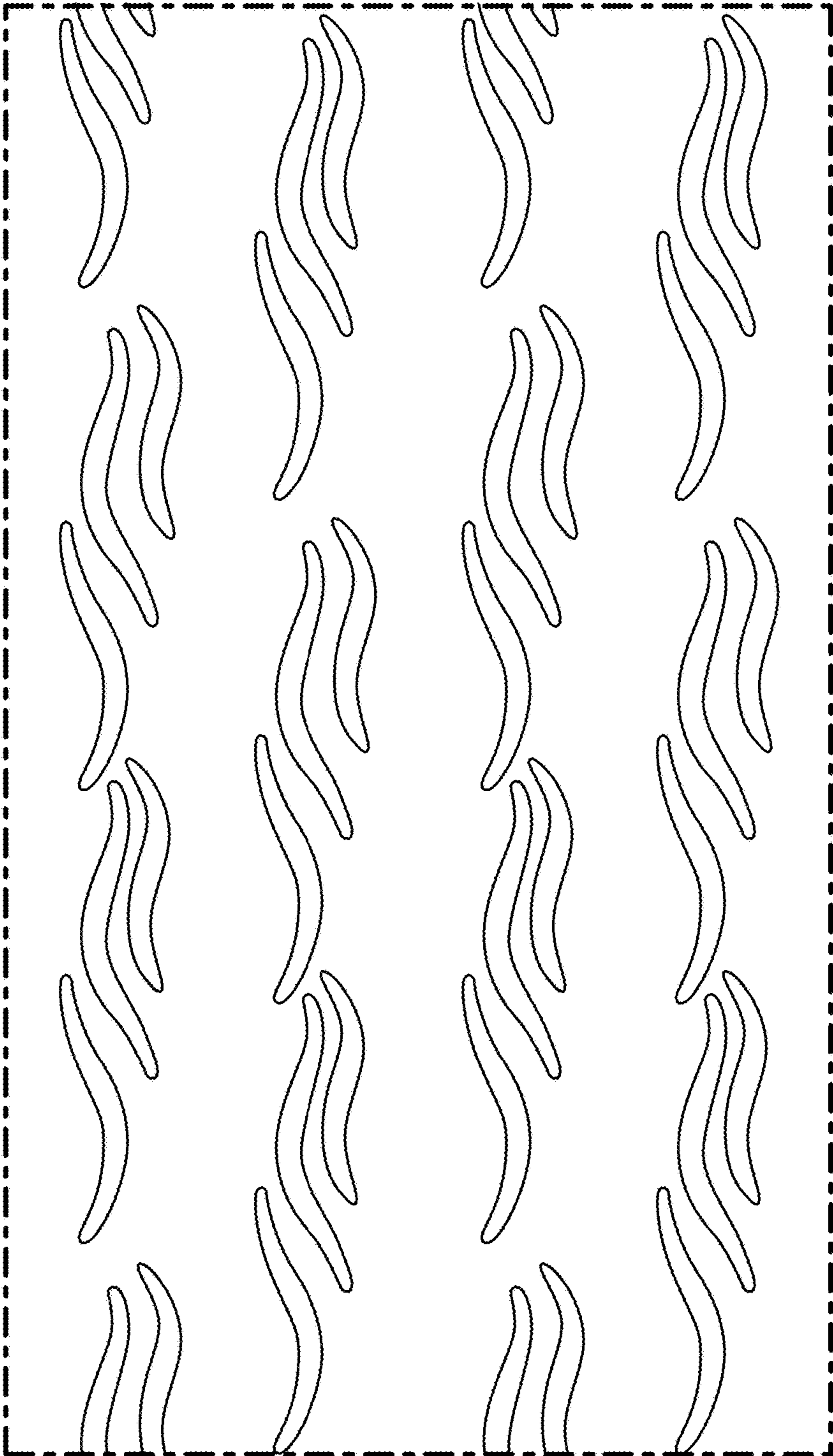
