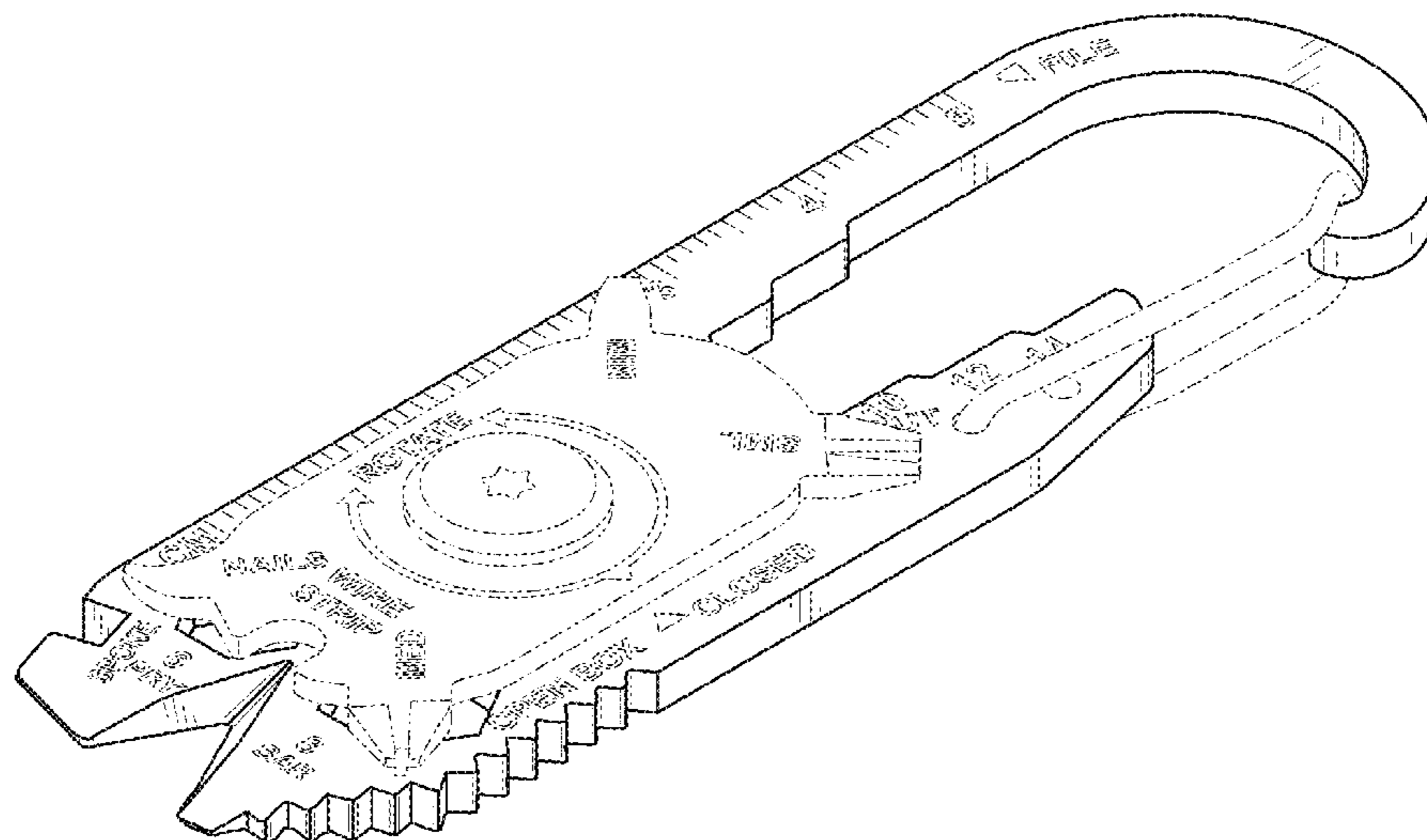

DESCRIPTION

FIG. 1 is an elevated, perspective view of the hand tool in accordance with the invention;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side view of FIG. 2;
FIG. 4 is another side view of the invention as shown in FIG. 1;
FIG. 5 is an opposite side view of FIG. 4;
FIG. 6 is a top view of the invention; and,

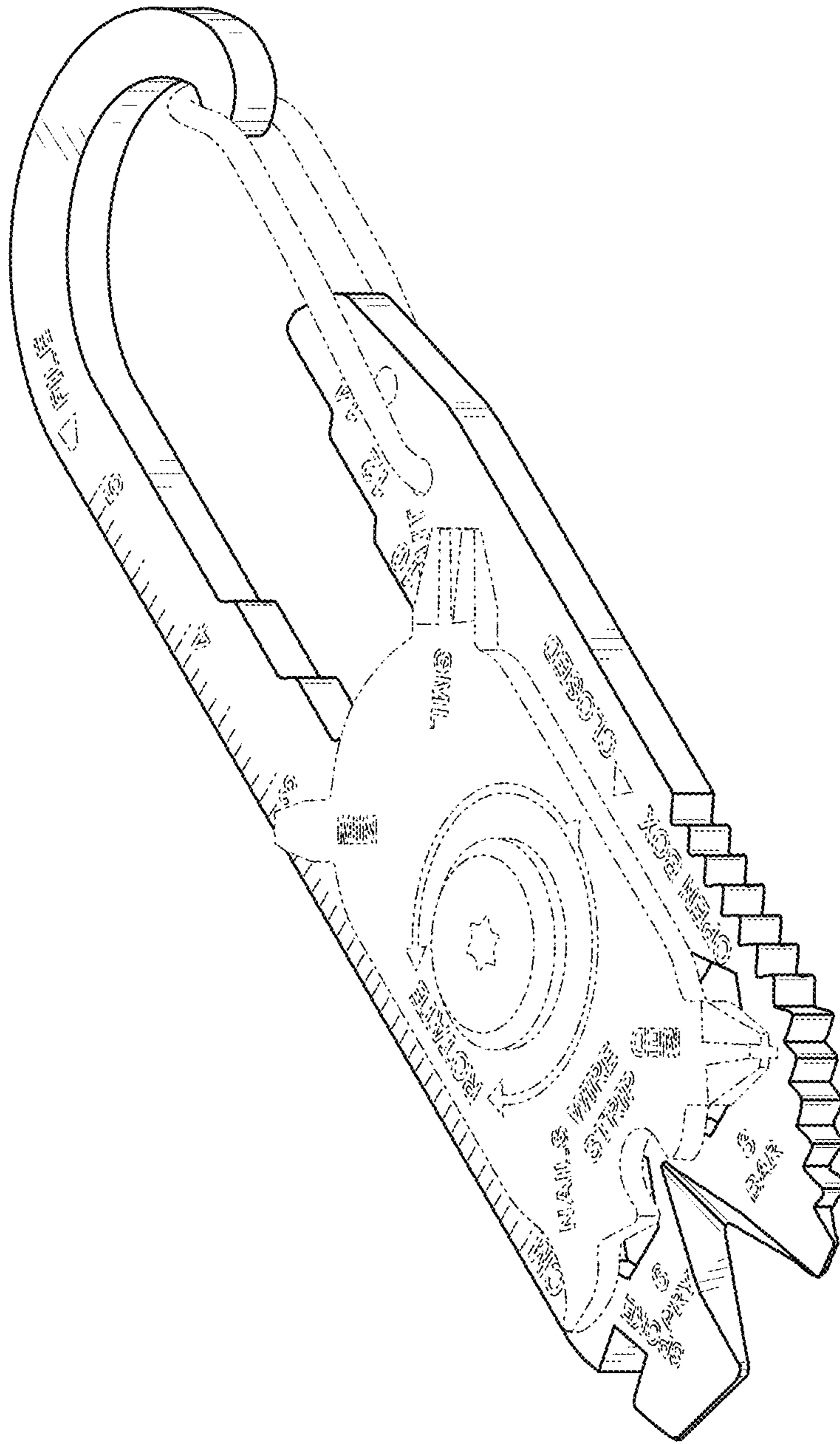

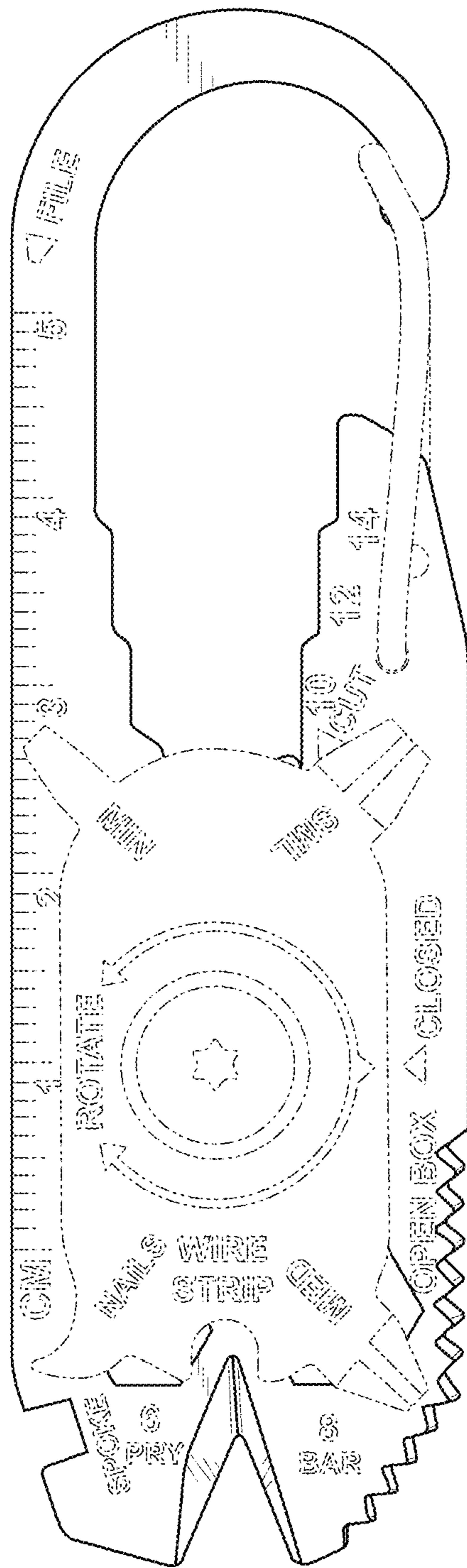

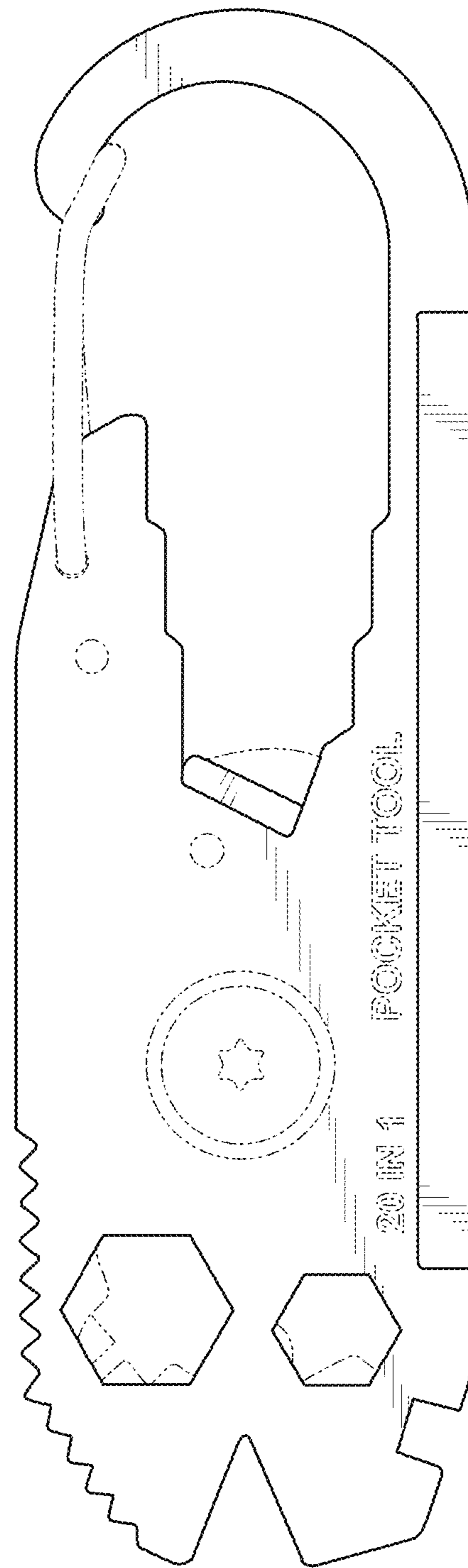

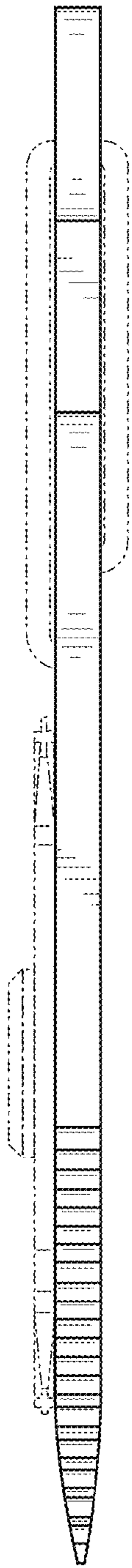

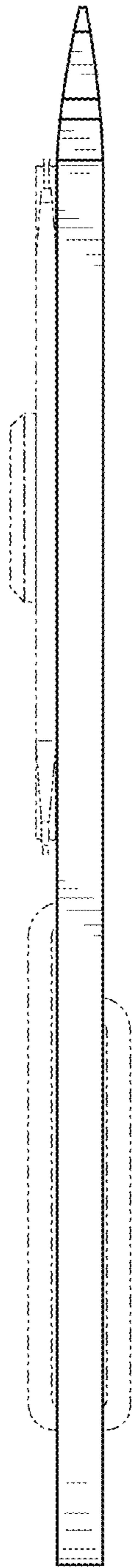

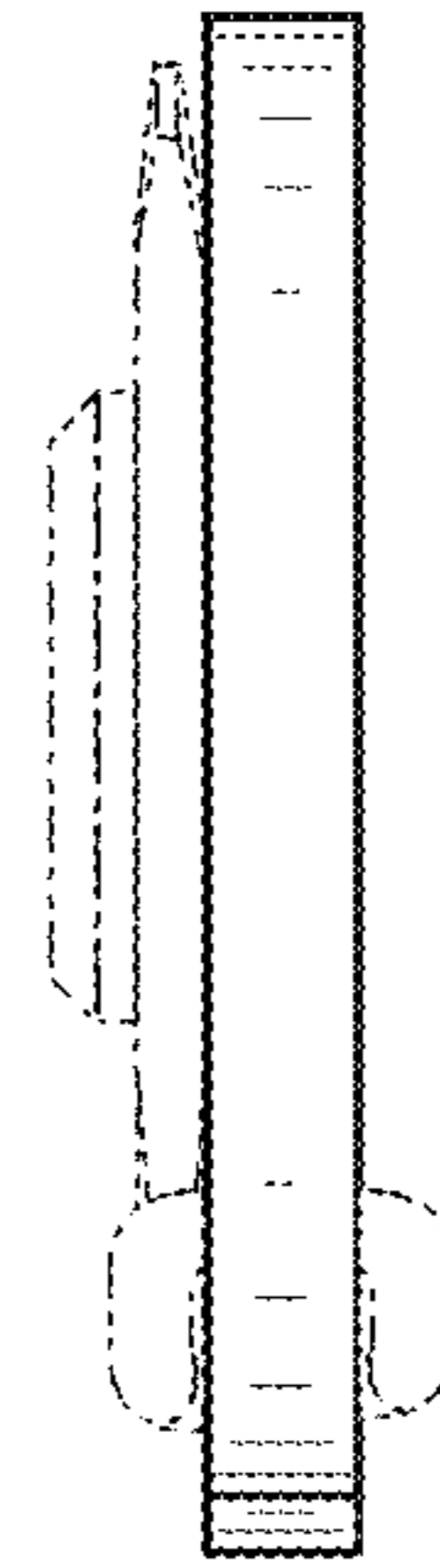

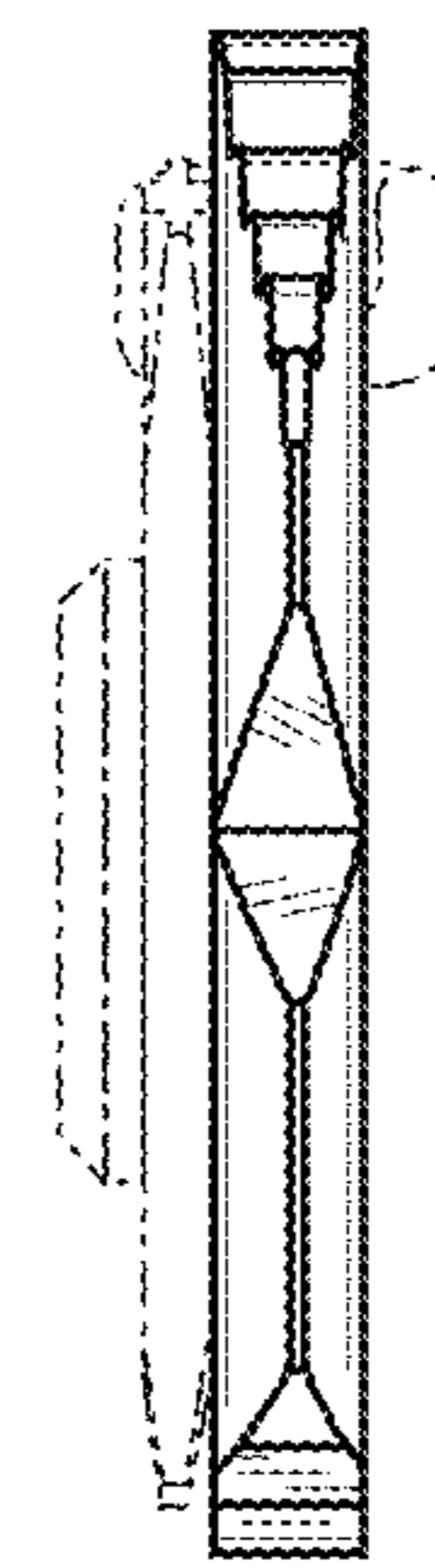
