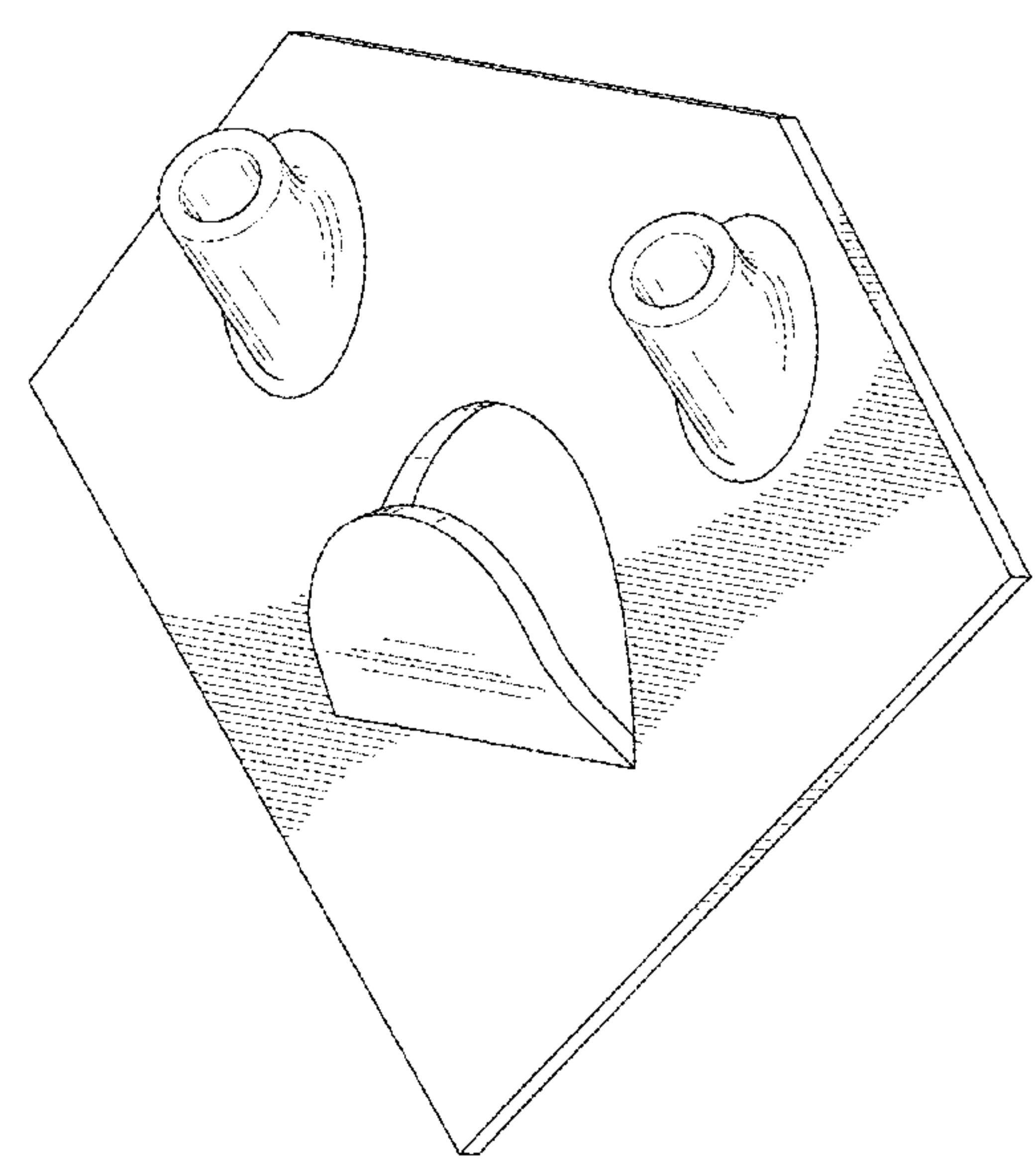
(57) **CLAIM**

The ornamental design for a wall hanger, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective of a wall hanger according to the invention;
FIG. 2 is a front elevation of the wall hanger of FIG. 1;
FIG. 3 is a rear elevation of the wall hanger of FIG. 1;
FIG. 4 is a right side elevation of the wall hanger of FIG. 1;
FIG. 5 is a left side elevation of the wall hanger of FIG. 1;
FIG. 6 is a top plan view of the wall hanger of FIG. 1; and
FIG. 7 is a bottom plan view of the wall hanger of FIG. 1.

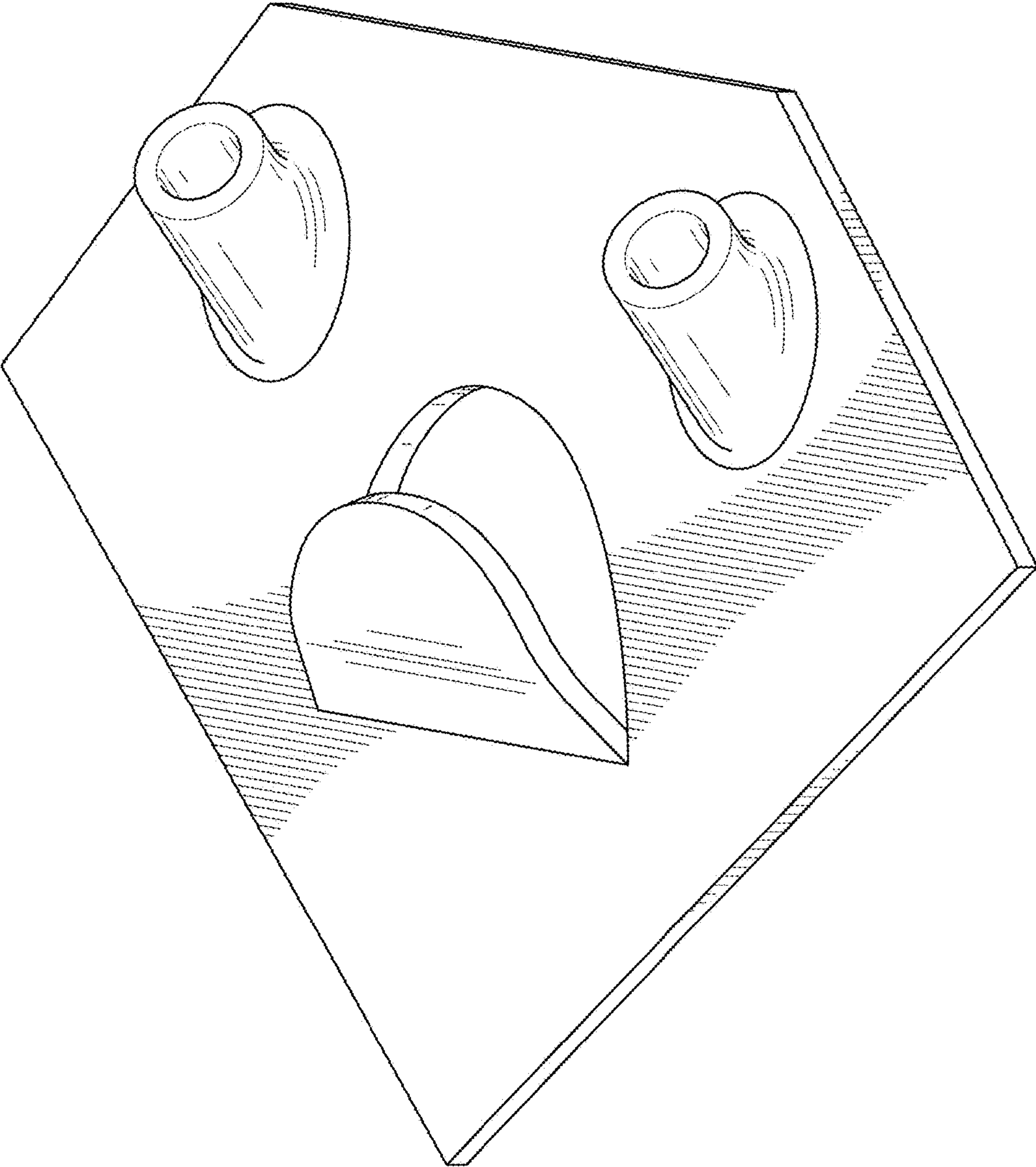

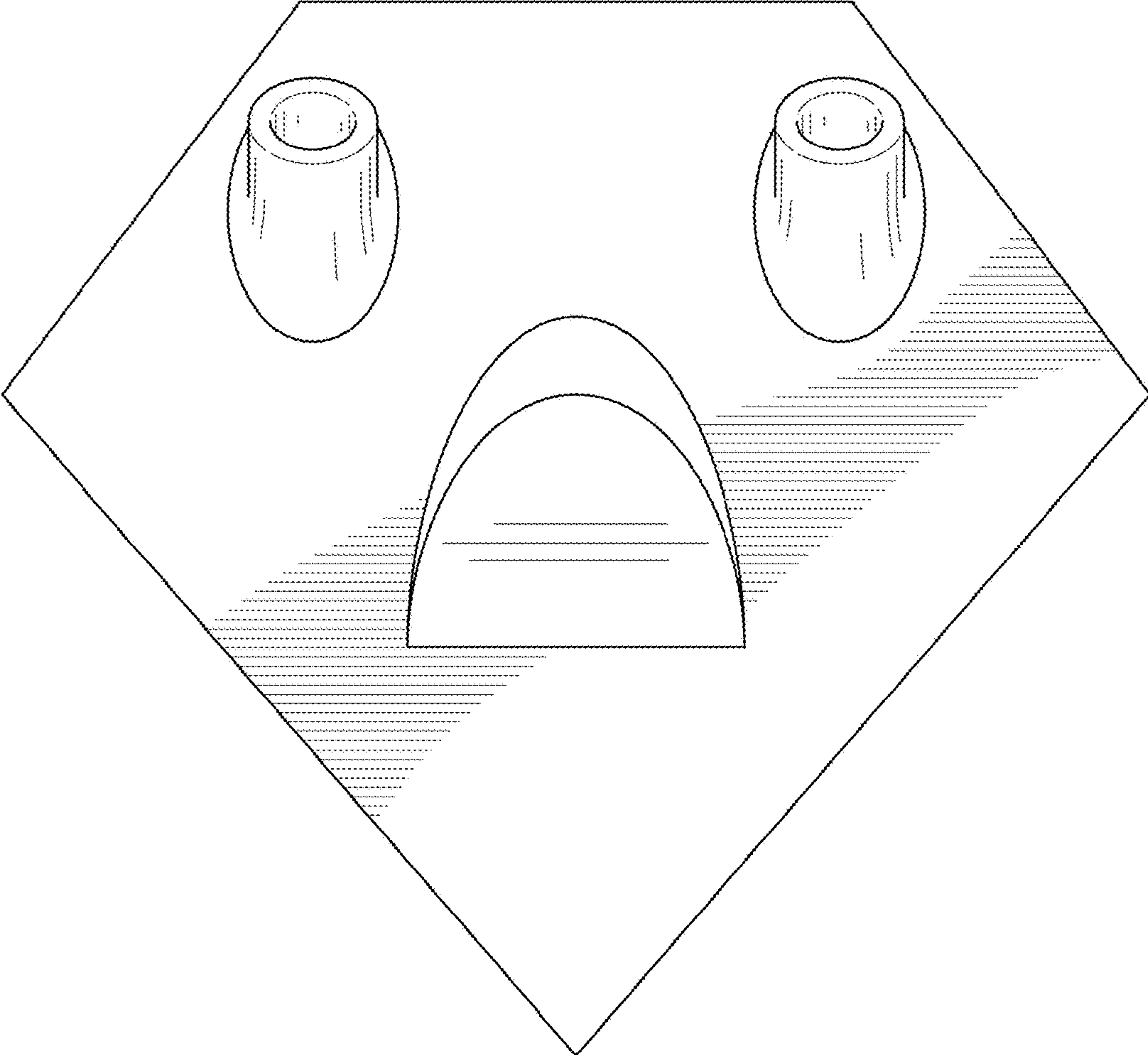

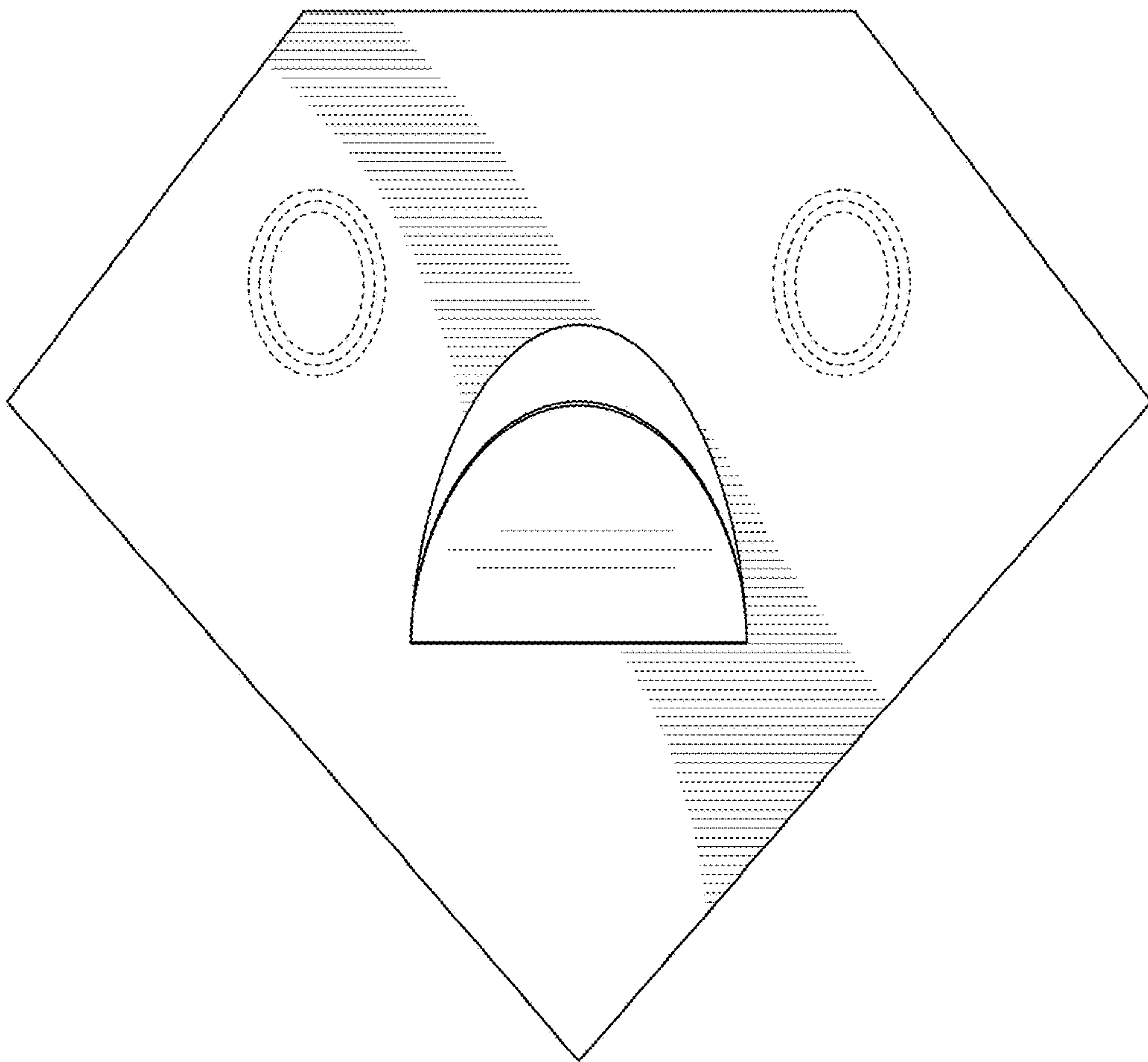

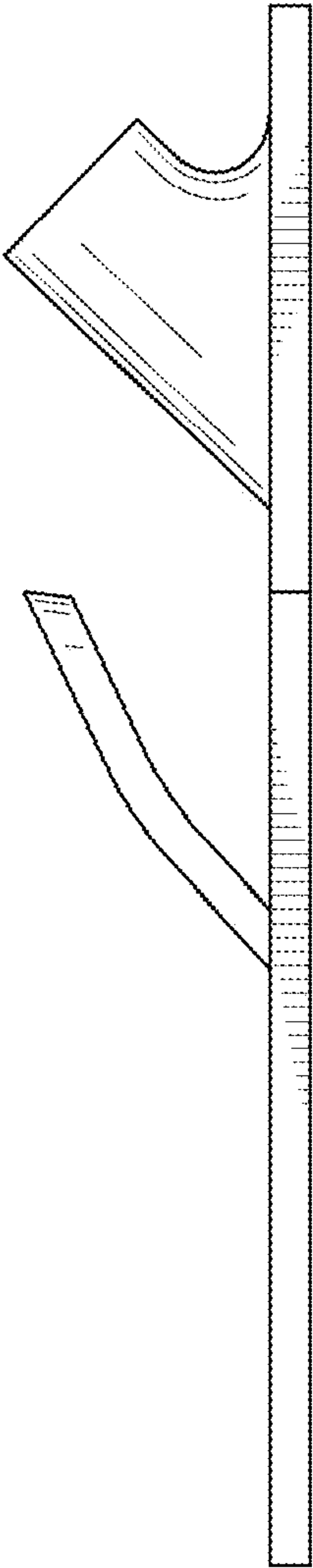

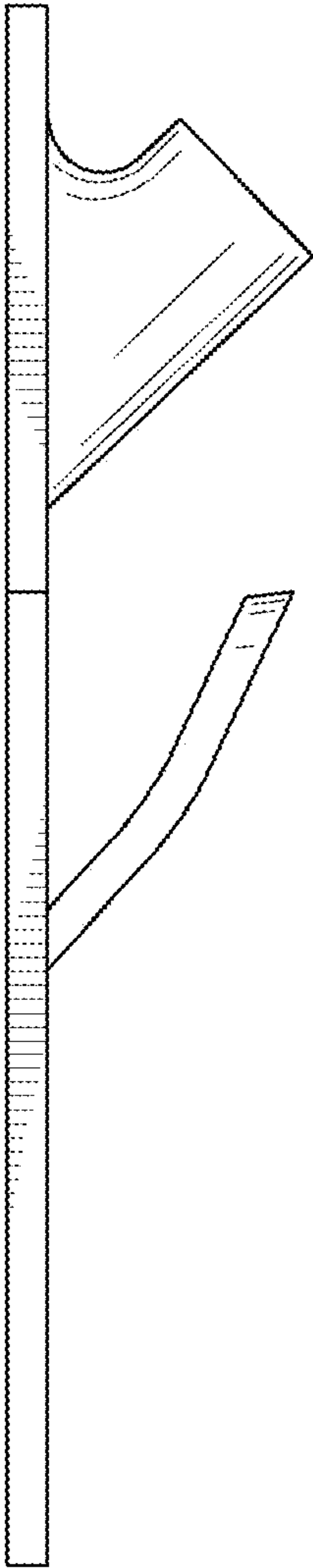

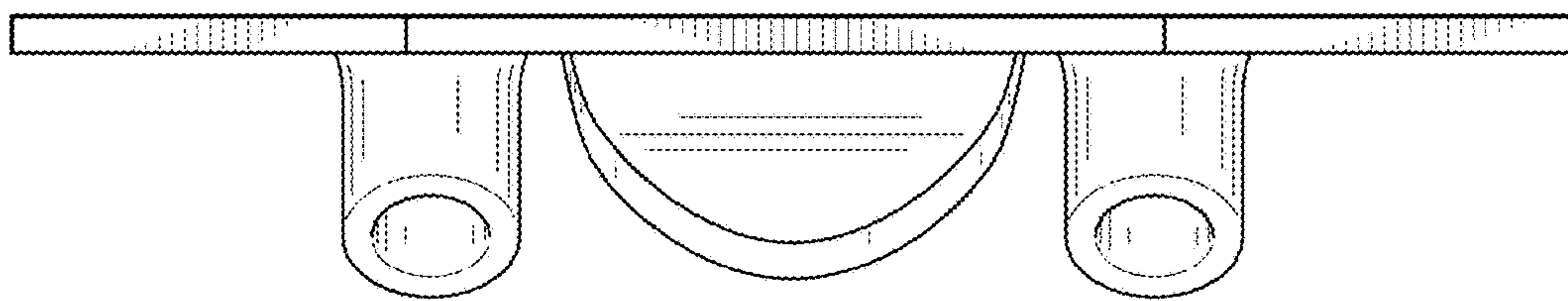

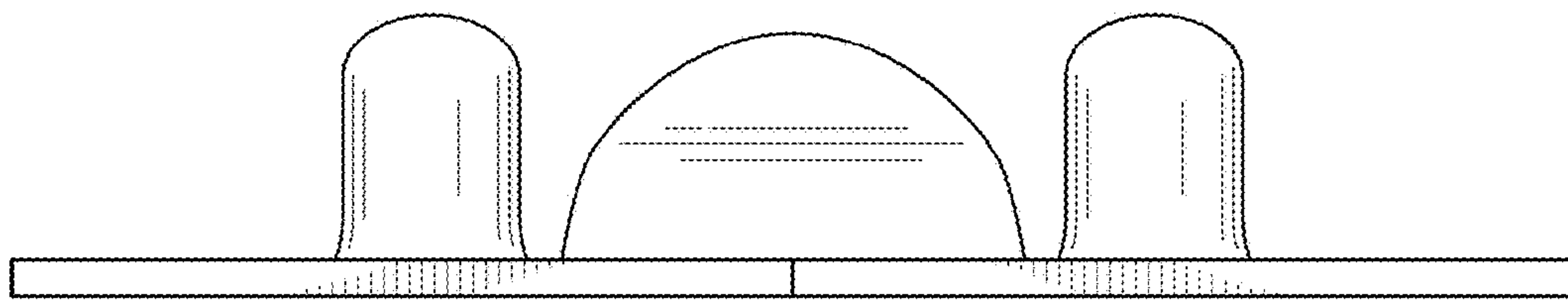
