We claim the ornamental design for a bottle, as shown and described.

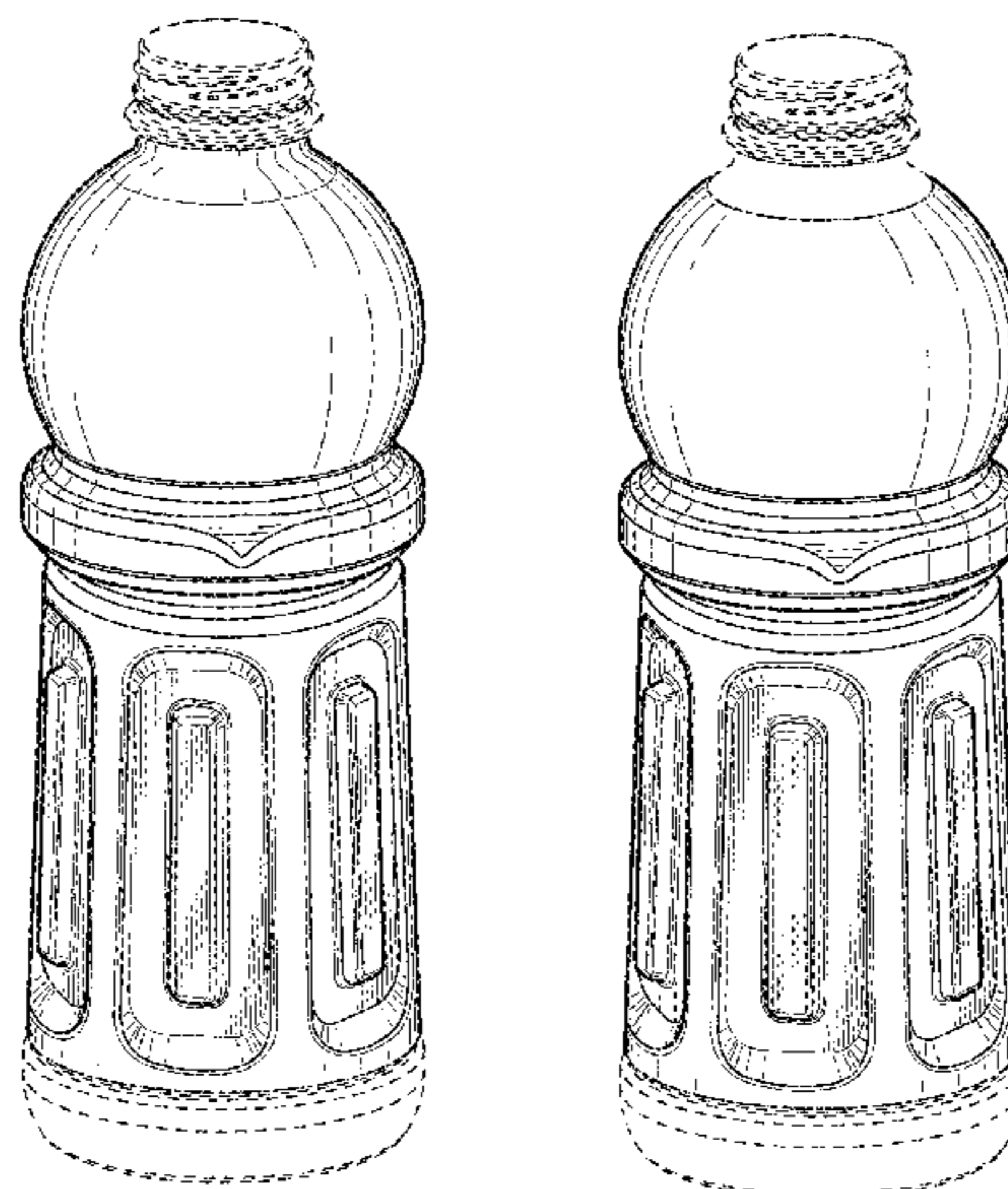
**DESCRIPTION**

FIG. 1 is a top, back, and left side perspective view of a first embodiment of a bottle in accordance with our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a back elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a top, back, and left side perspective view of a second embodiment of the bottle in accordance with our new design; FIG. 9 is a right side elevational view thereof; FIG. 10 is a left side elevational view thereof; FIG. 11 is a front elevational view thereof; FIG. 12 is a back elevational view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The dash-dash-dash-dash type broken lines shown in the drawings are included for the purpose of illustrating portions of the bottle that form no part of the claimed design.

The dot-dash-dot-dash type broken lines shown in the drawings define the top and bottom boundaries of the claimed design.

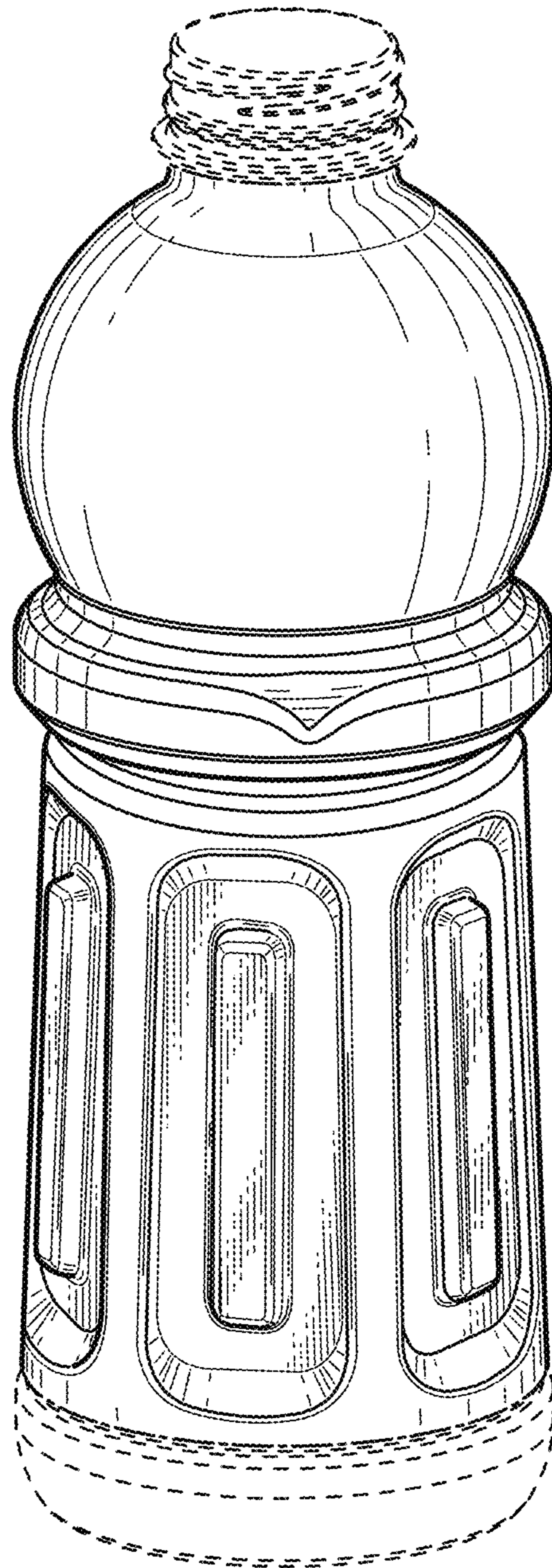

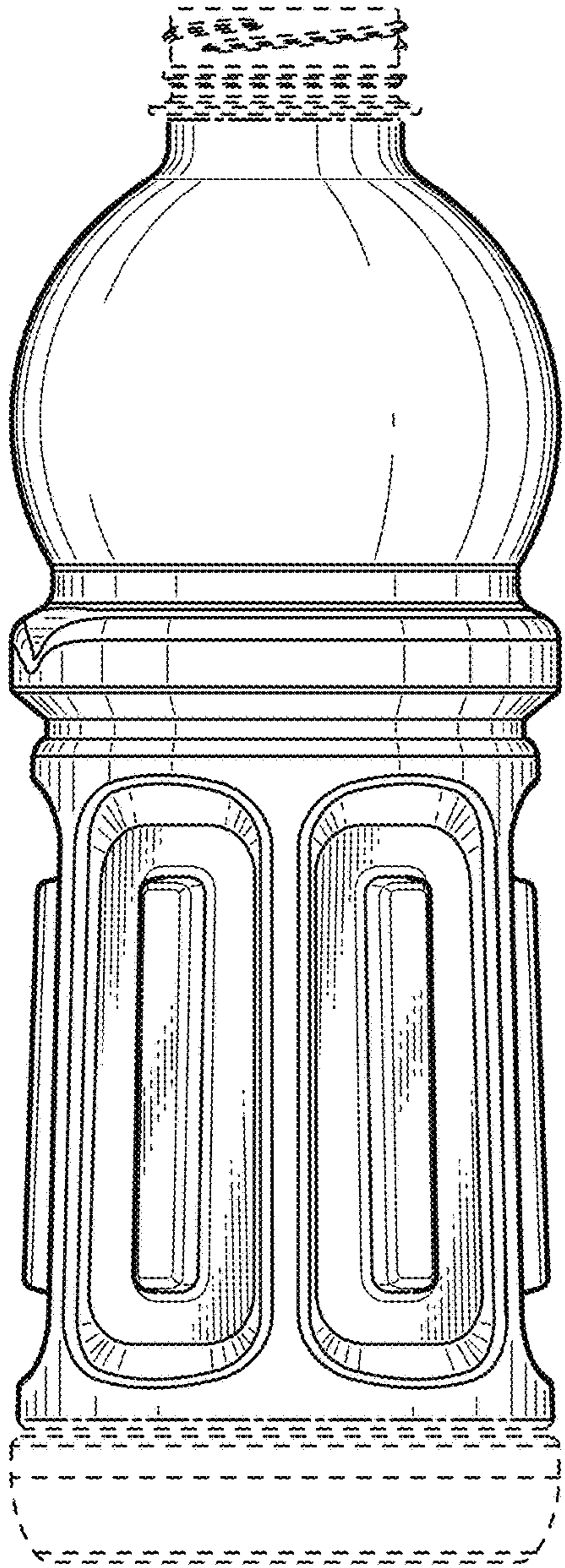

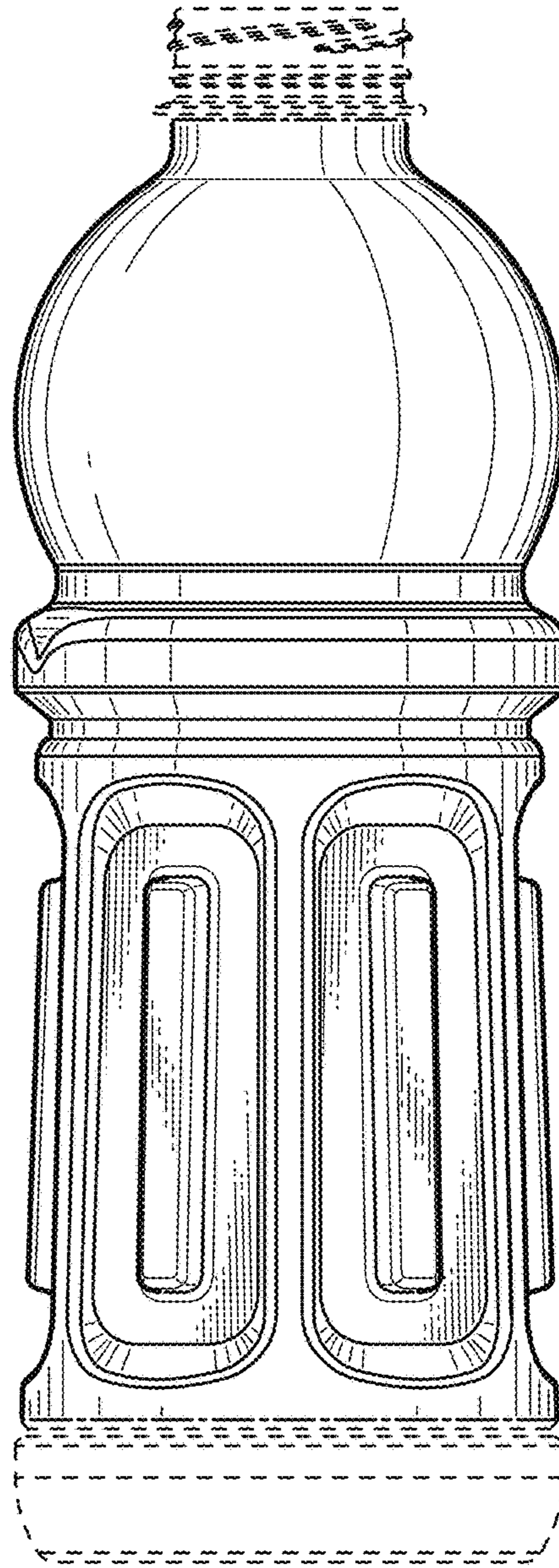

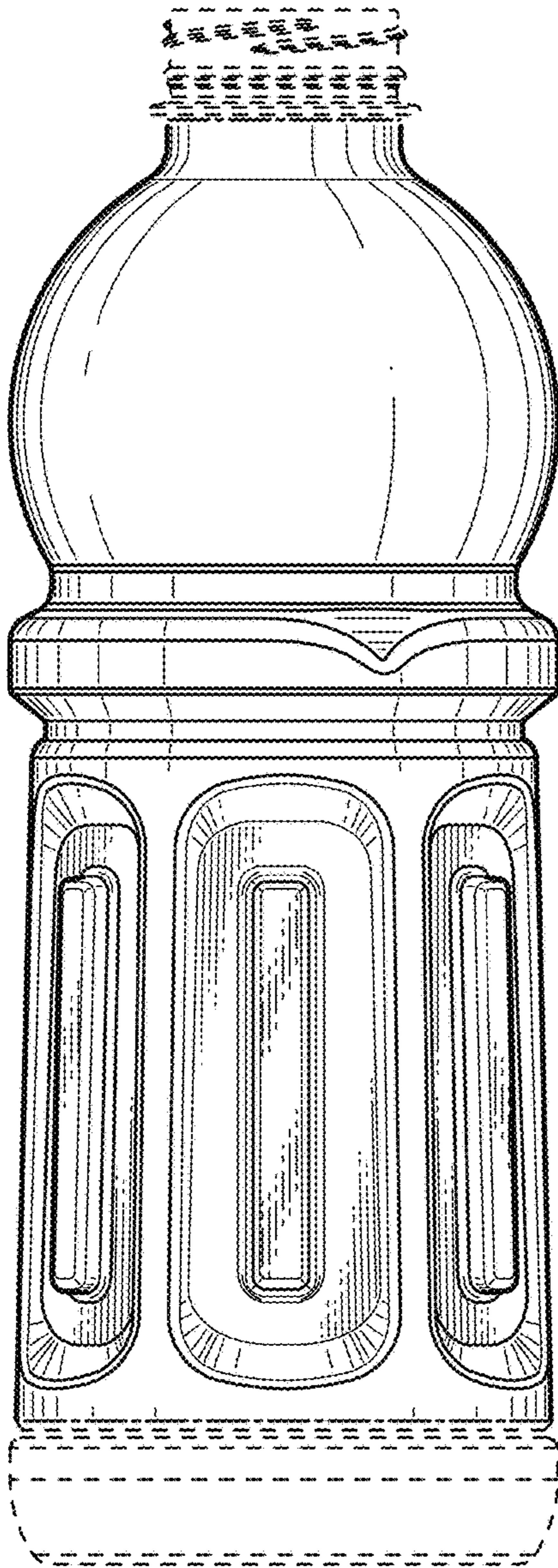

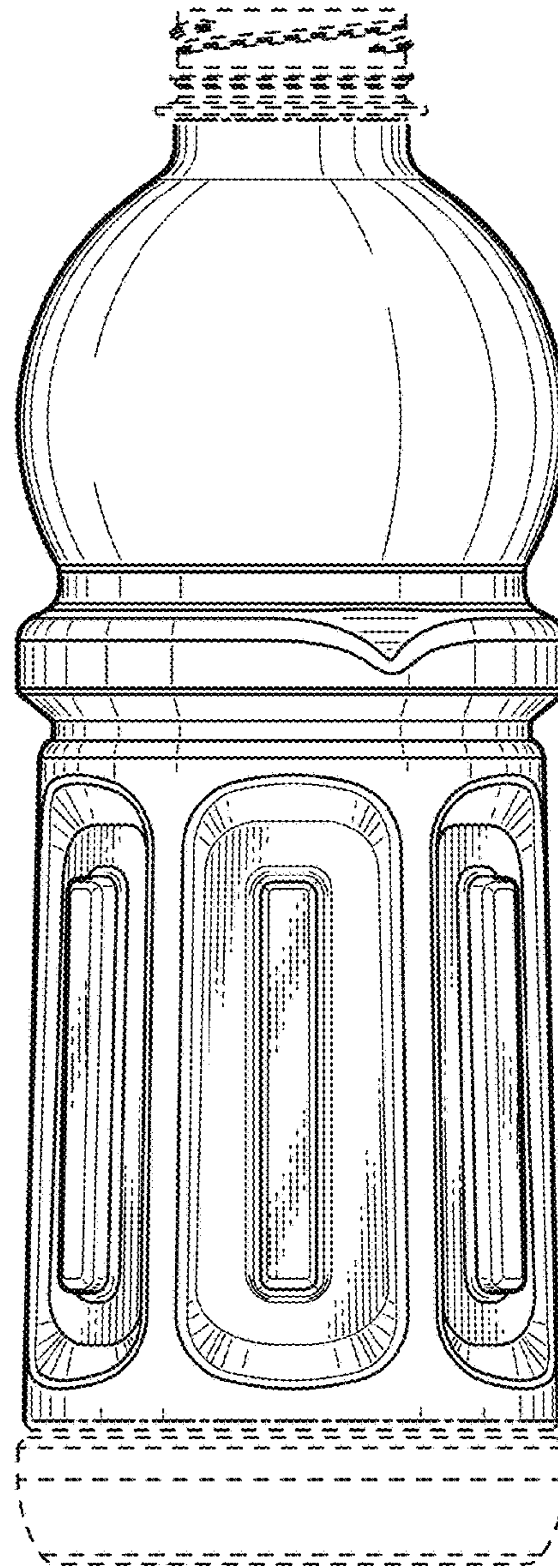

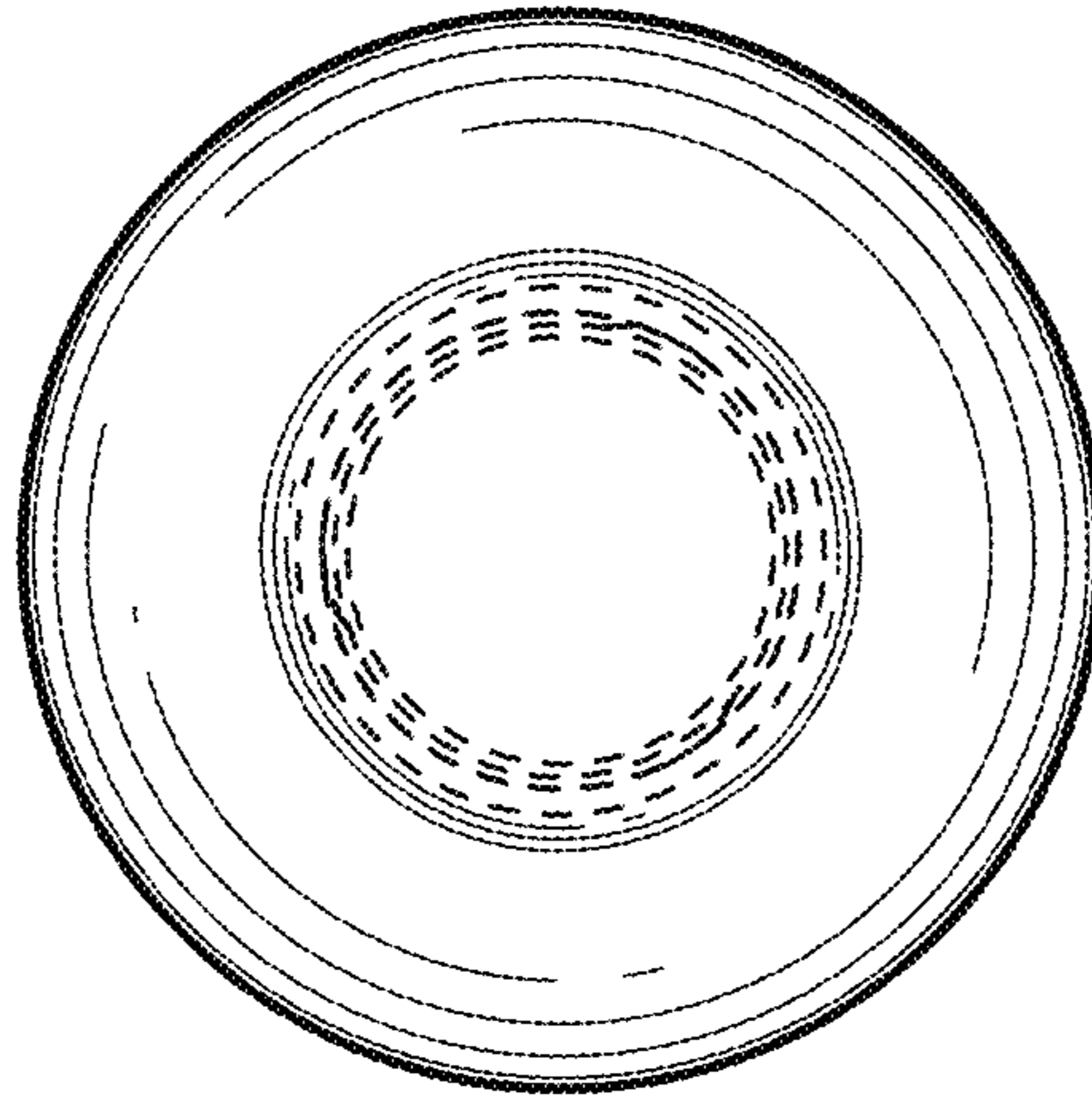

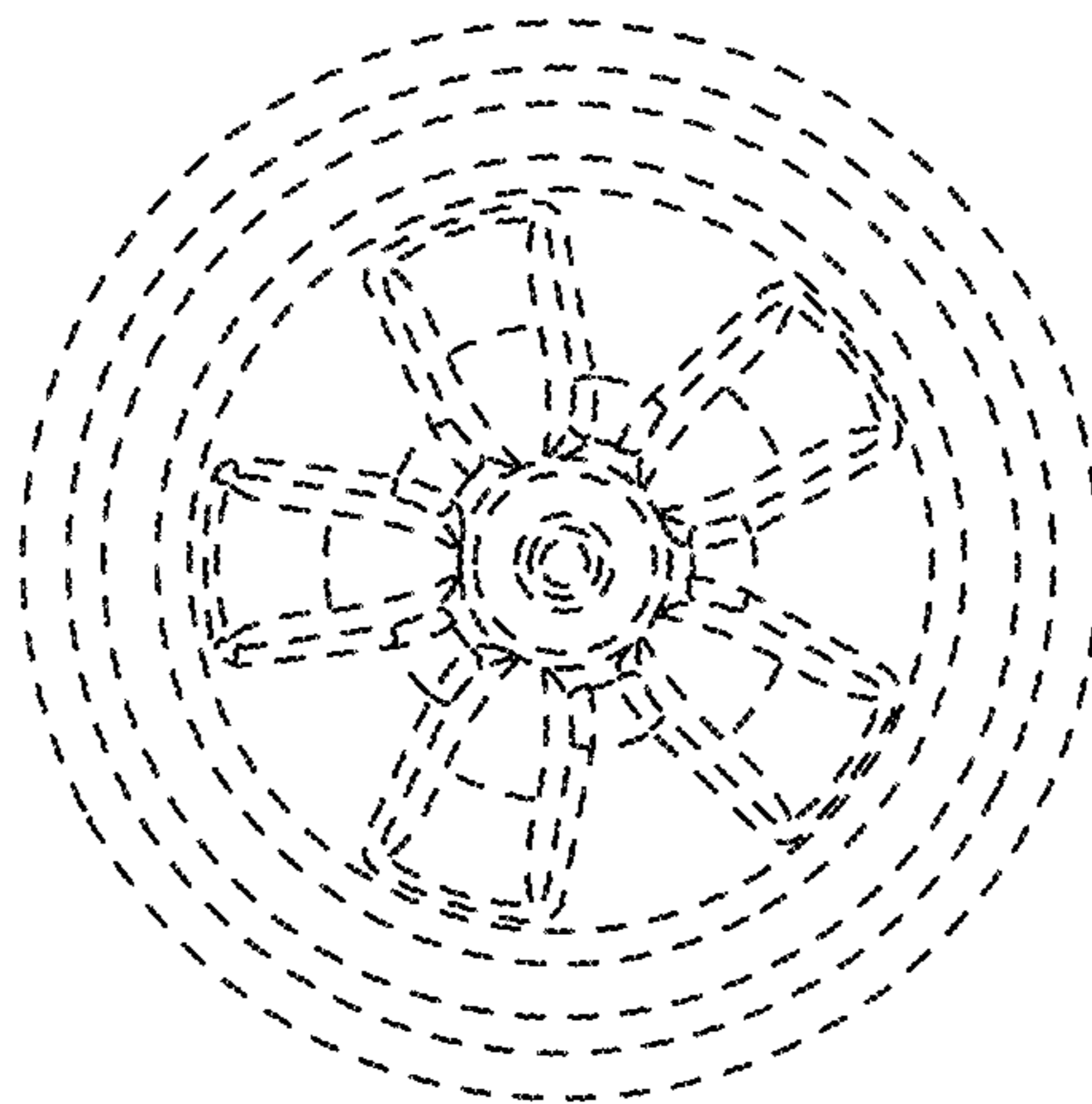

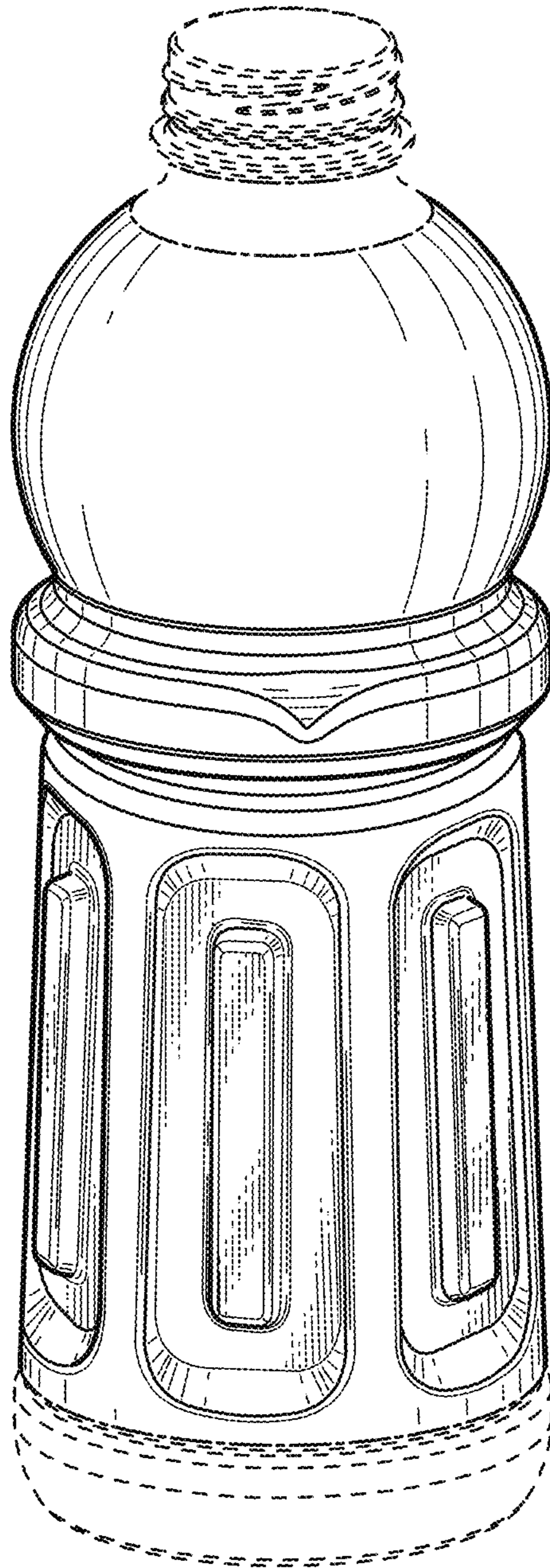

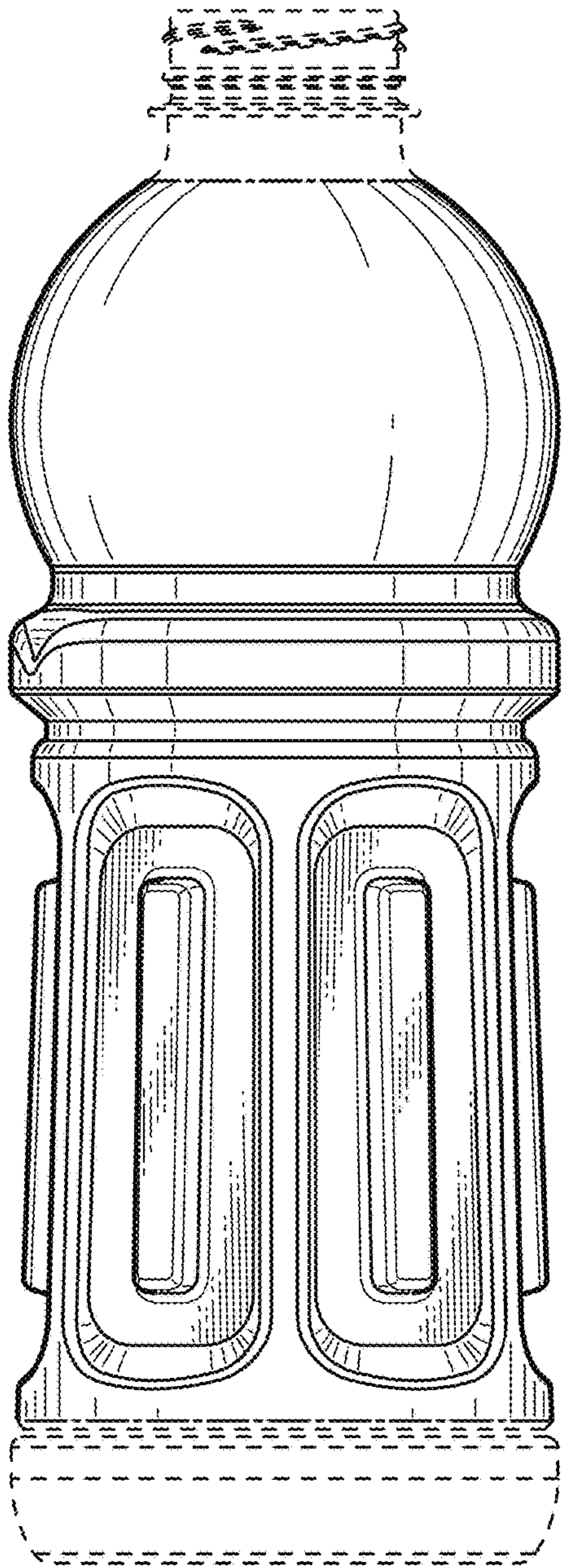

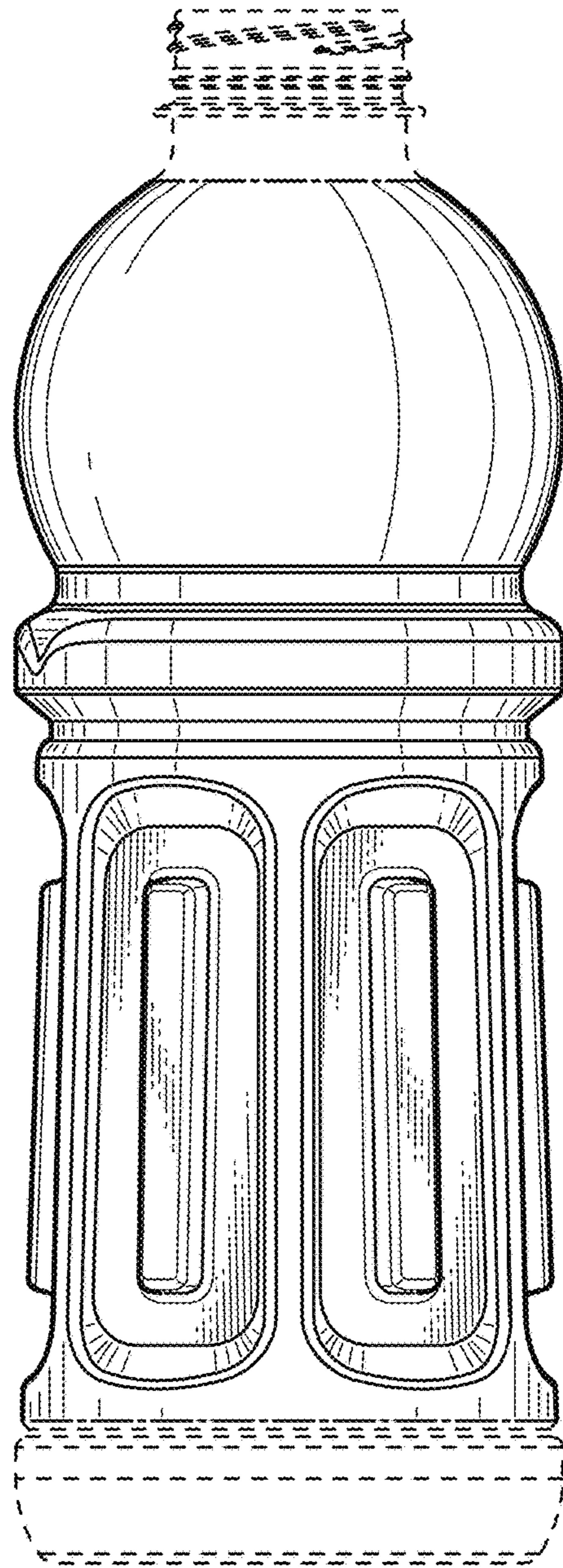

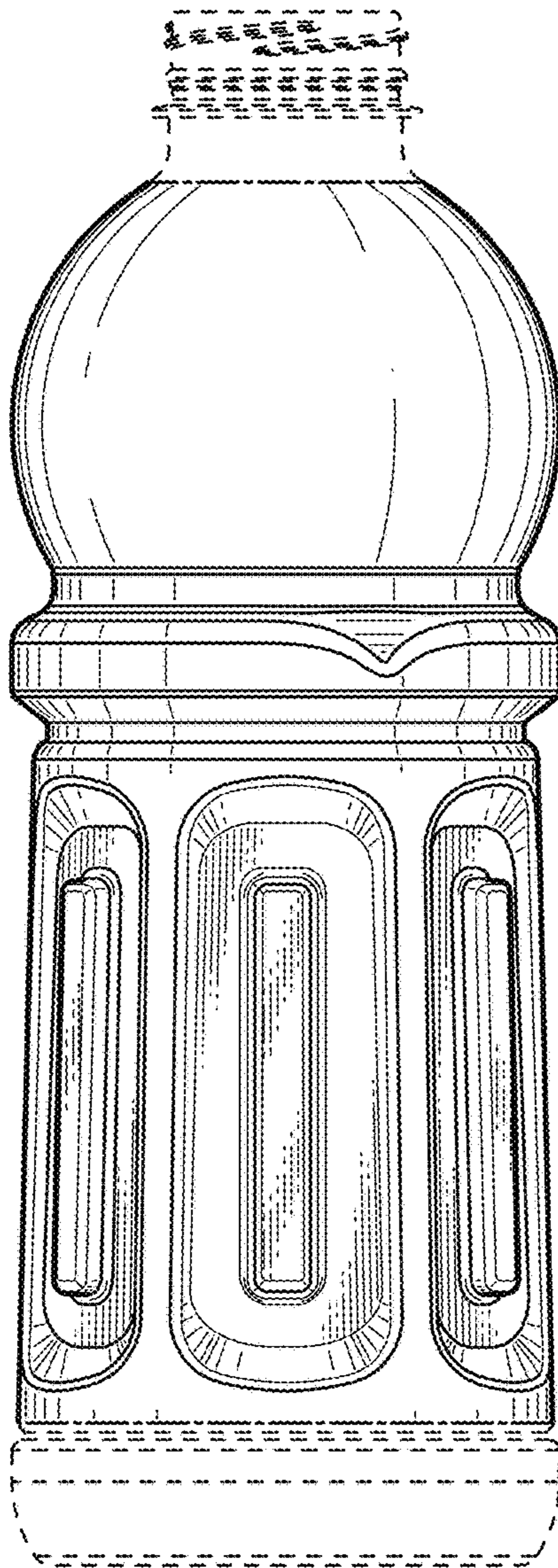

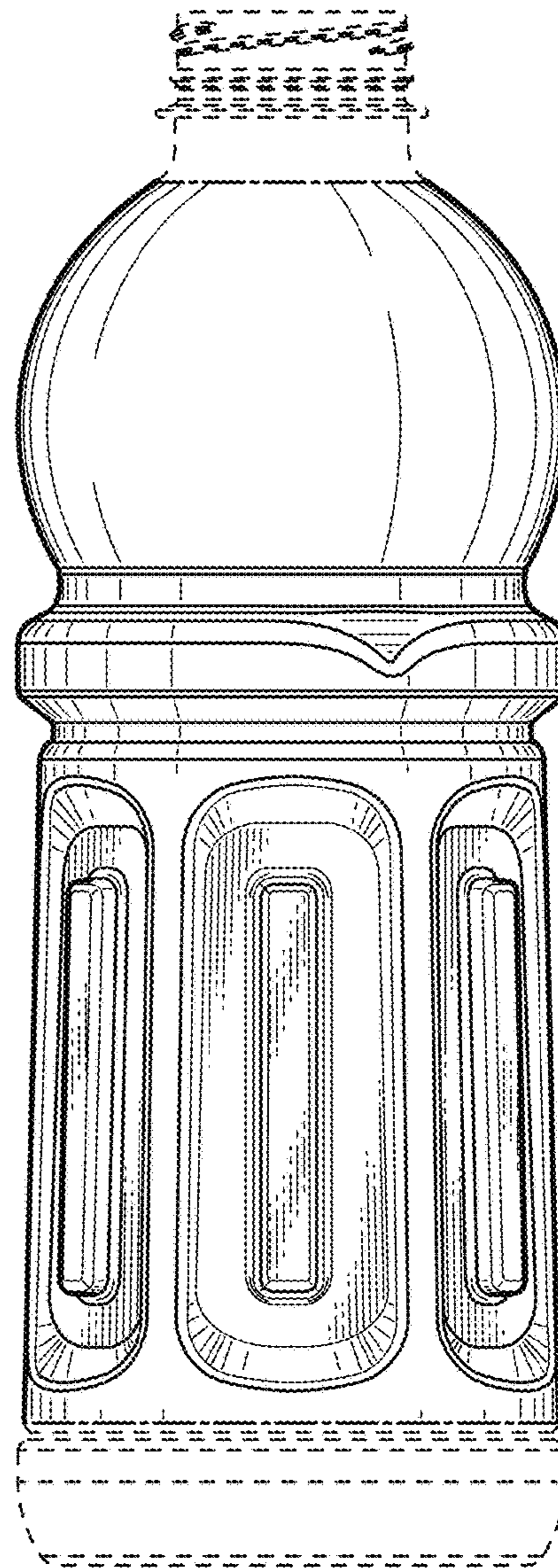
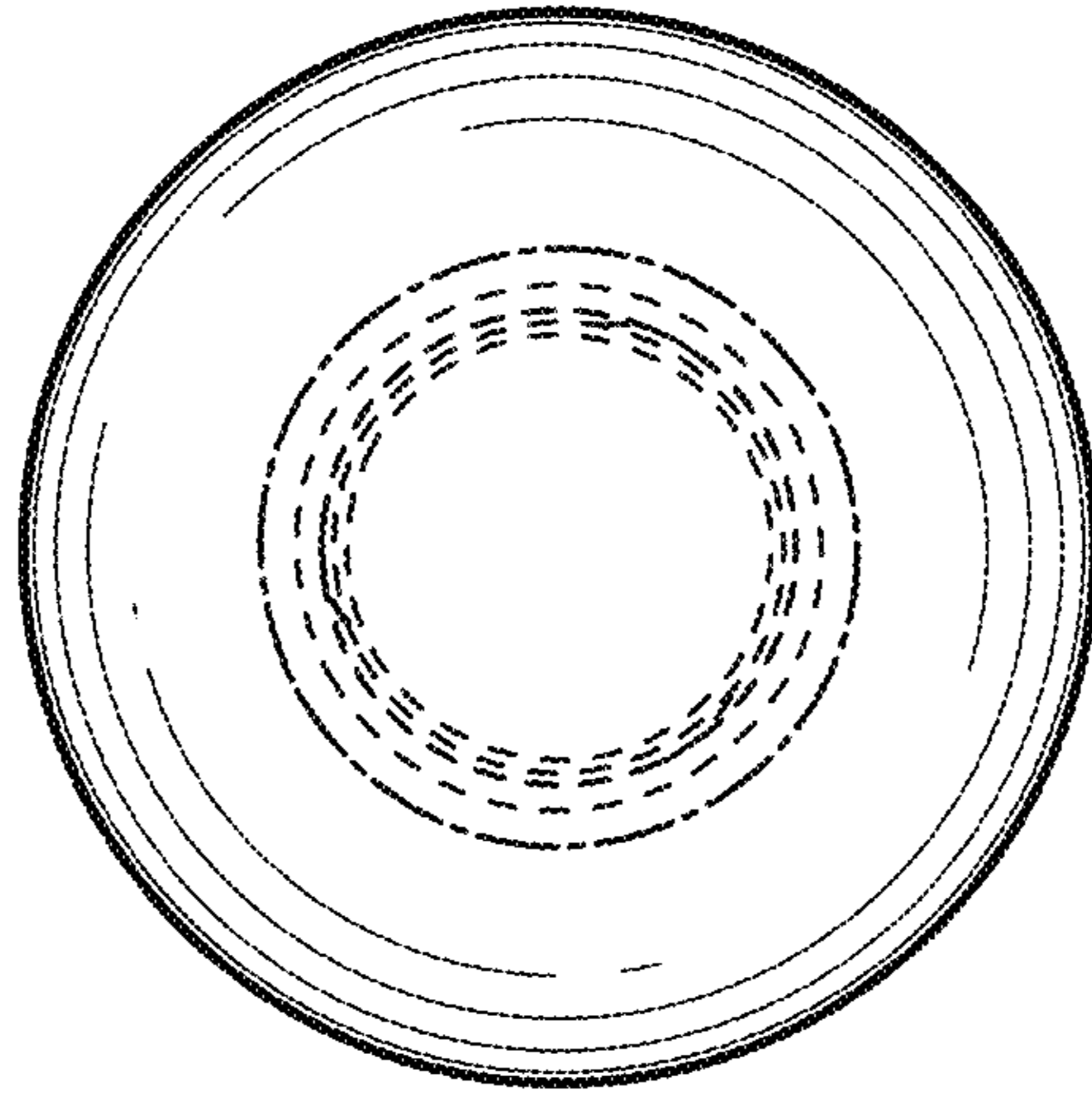
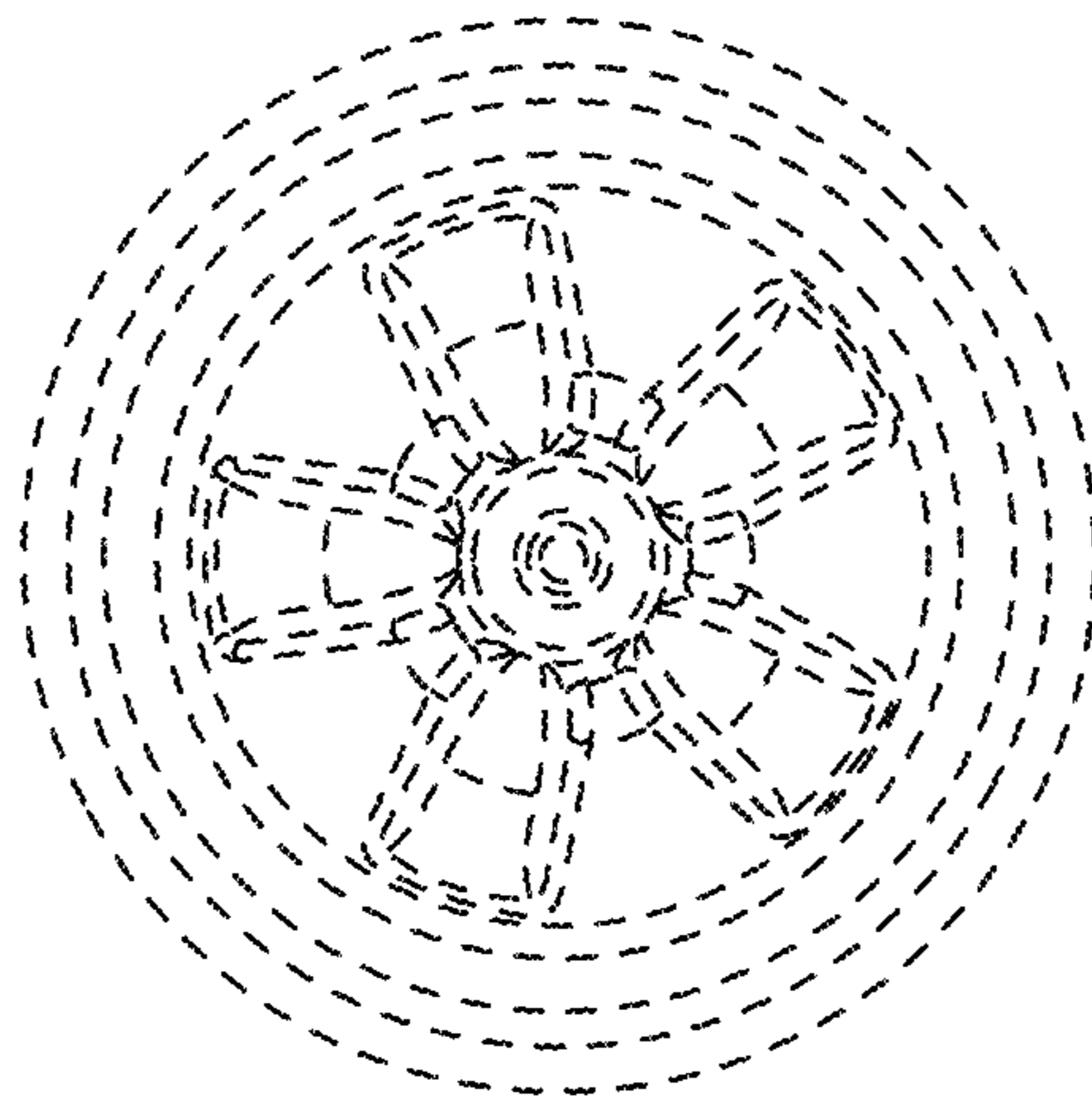
