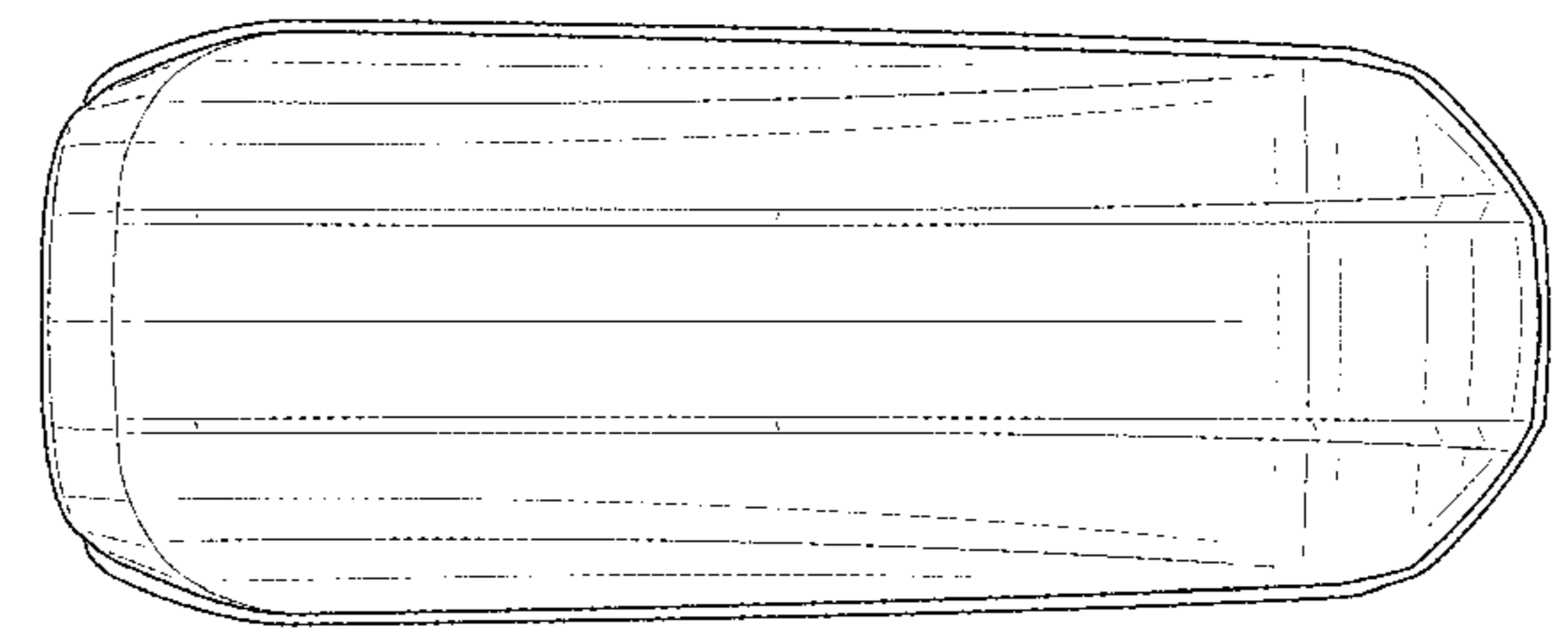
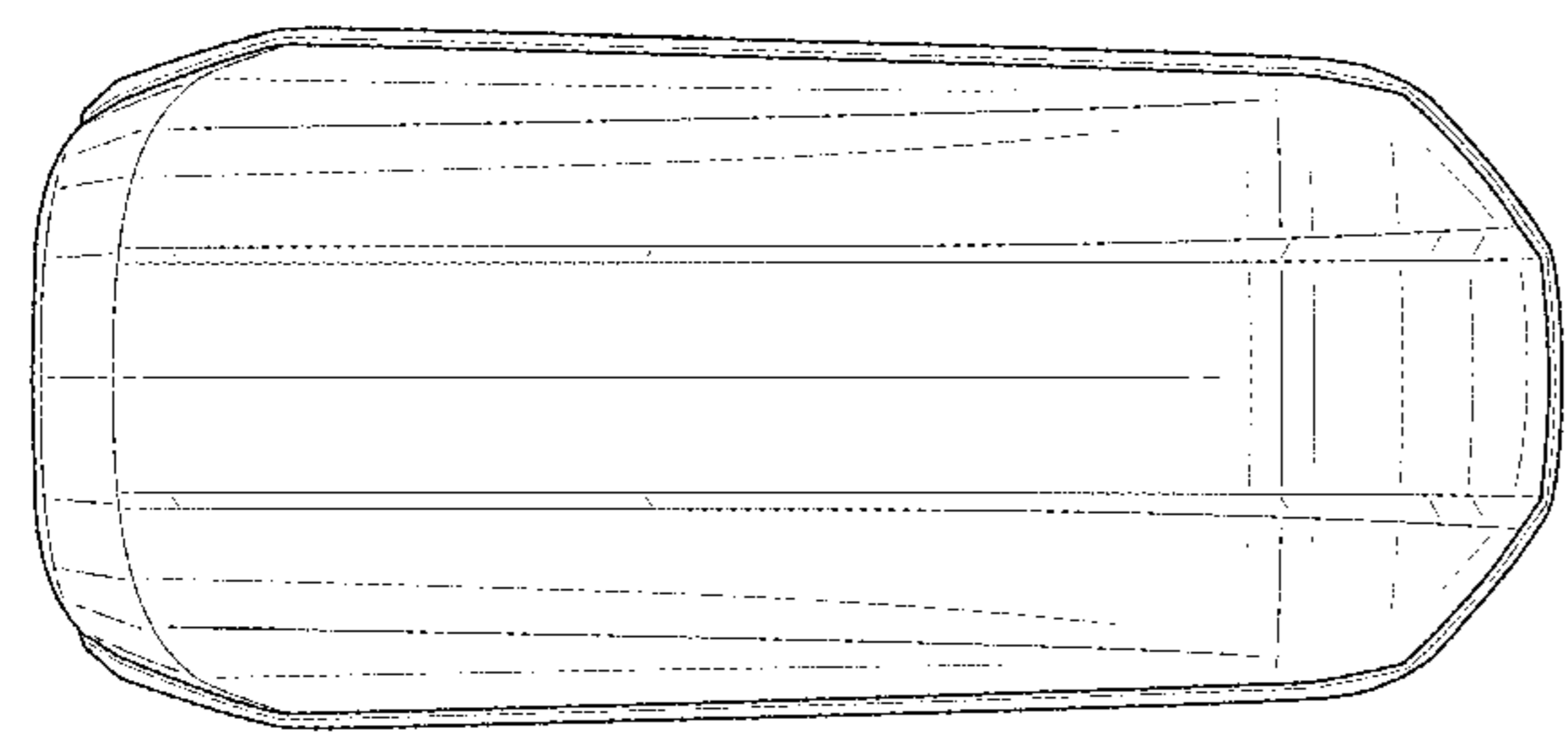
(57) **CLAIM**

The ornamental design for a vehicle top carrier, as shown and described.

DESCRIPTION

FIG. 1 is an upper, front, and left-side perspective view of a first embodiment of a vehicle top carrier showing the new design;
 FIG. 2 is a lower, rear, and right-side perspective view thereof;
 FIG. 3 is a plan view thereof;
 FIG. 4 is a right side elevational view thereof, the left side elevational view is a mirror image of the right side elevational view, and is not shown;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front elevational view thereof;
 FIG. 7 is a rear elevational view thereof;
 FIG. 8 is an upper, front, and left-side perspective view of a second embodiment of a vehicle top carrier showing the new design;
 FIG. 9 is a lower, rear, and right-side perspective view thereof;
 FIG. 10 is a plan view thereof;
 FIG. 11 is a right side elevational view thereof, the left side elevational view is a mirror image of the right side elevational view, and is not shown;
 FIG. 12 is a bottom view thereof;
 FIG. 13 is a front elevational view thereof; and,
 FIG. 14 is a rear elevational view thereof.

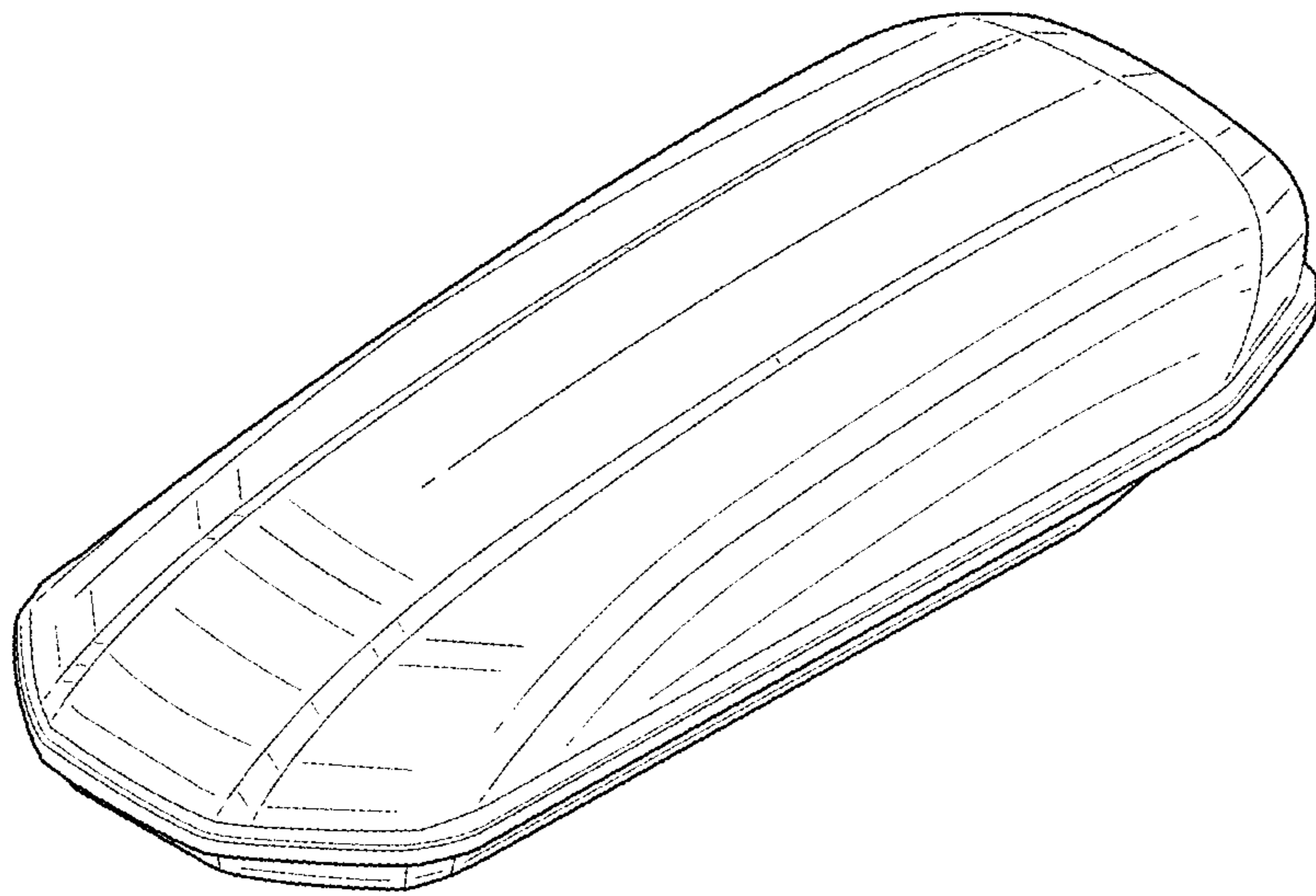

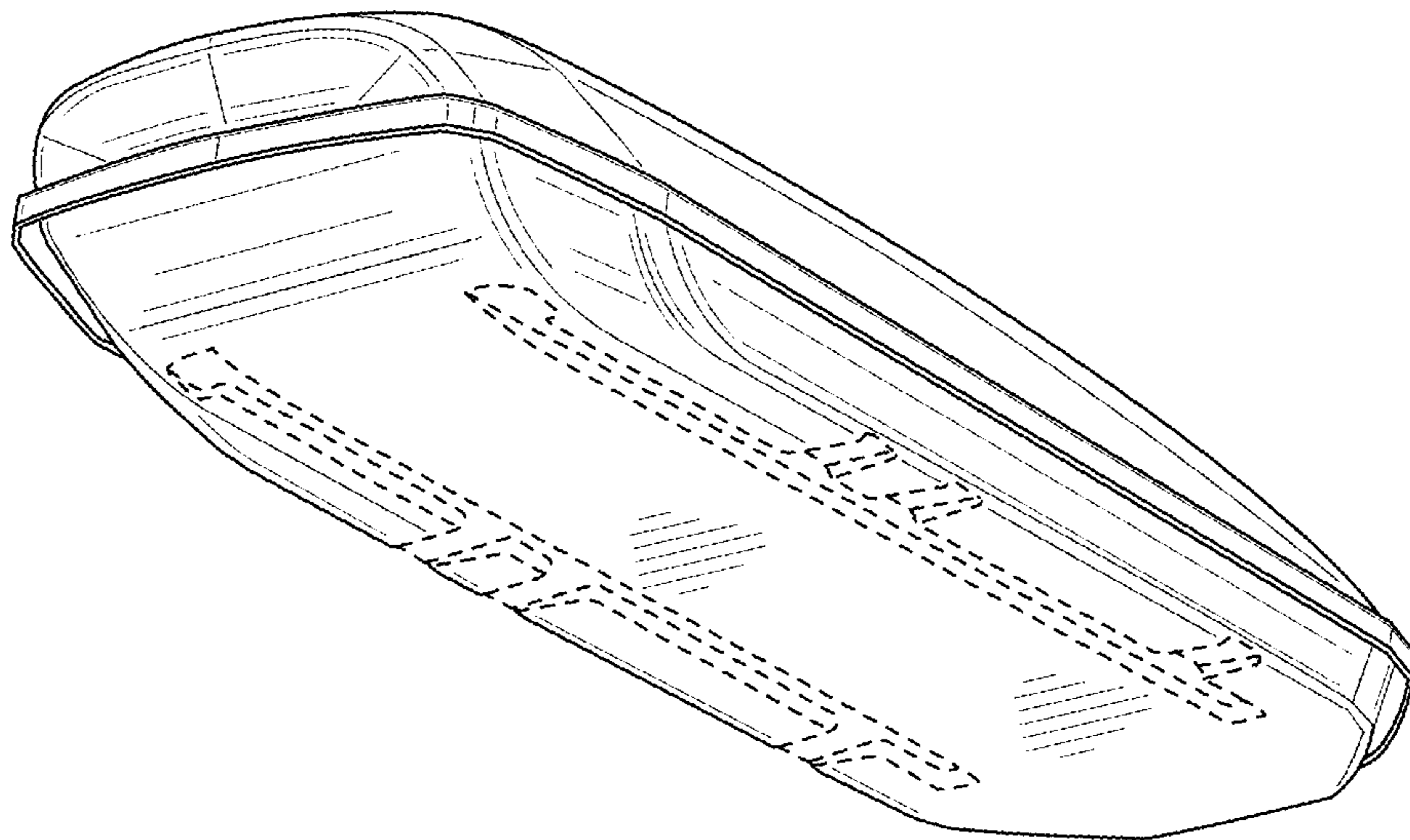

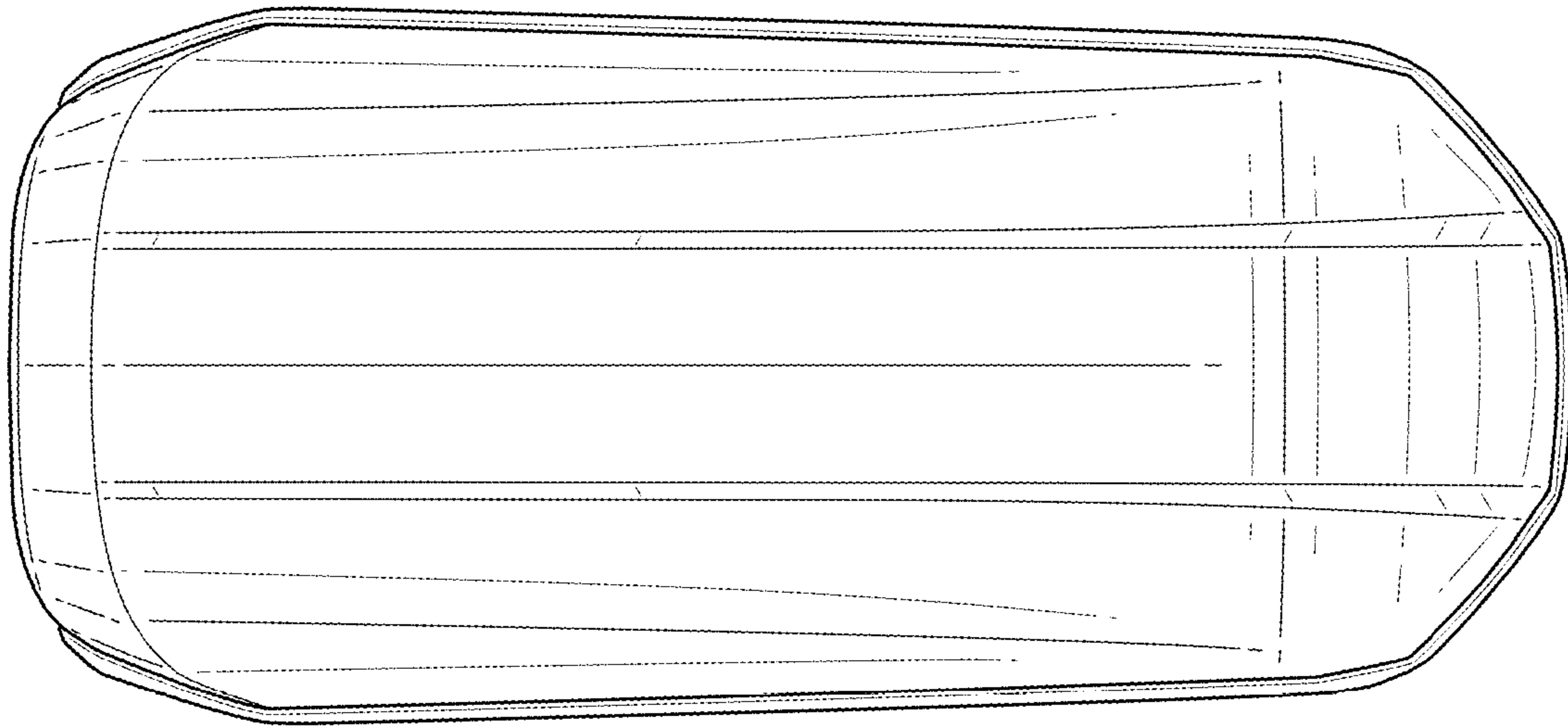

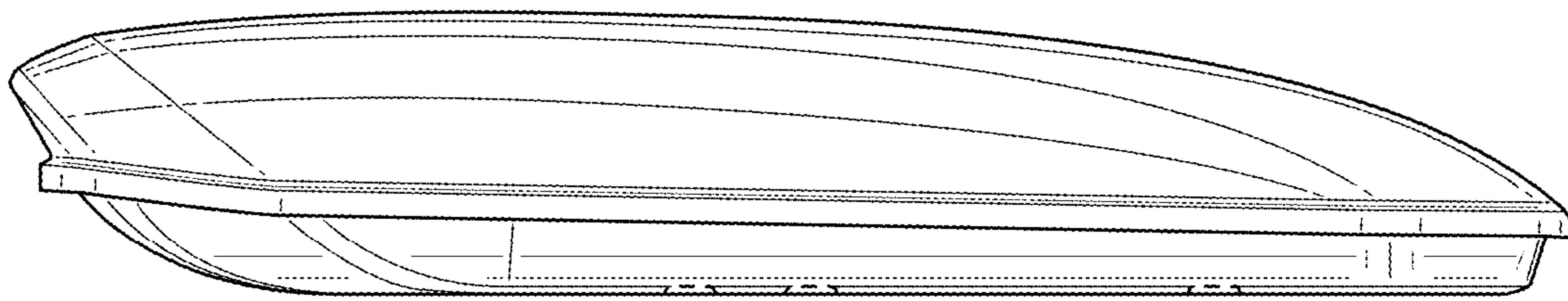

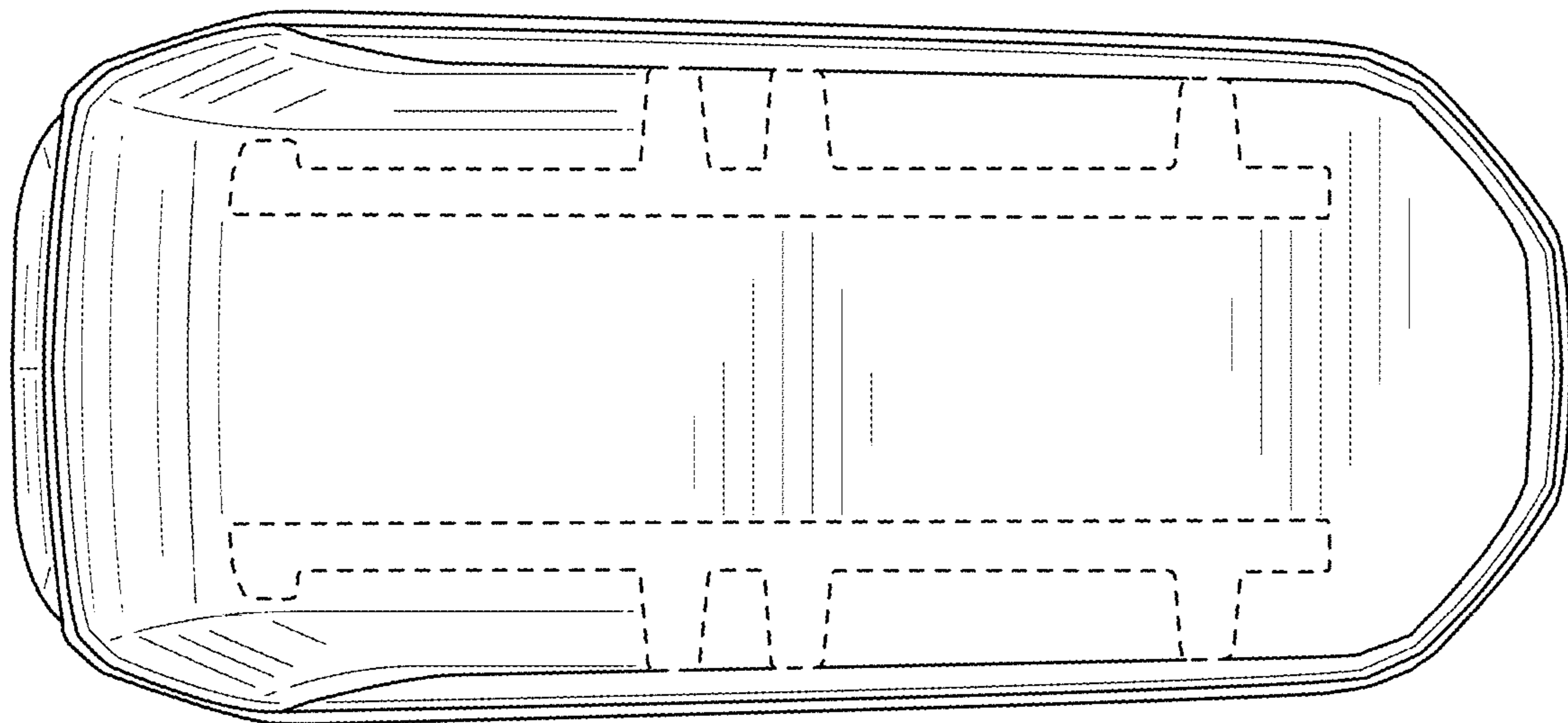

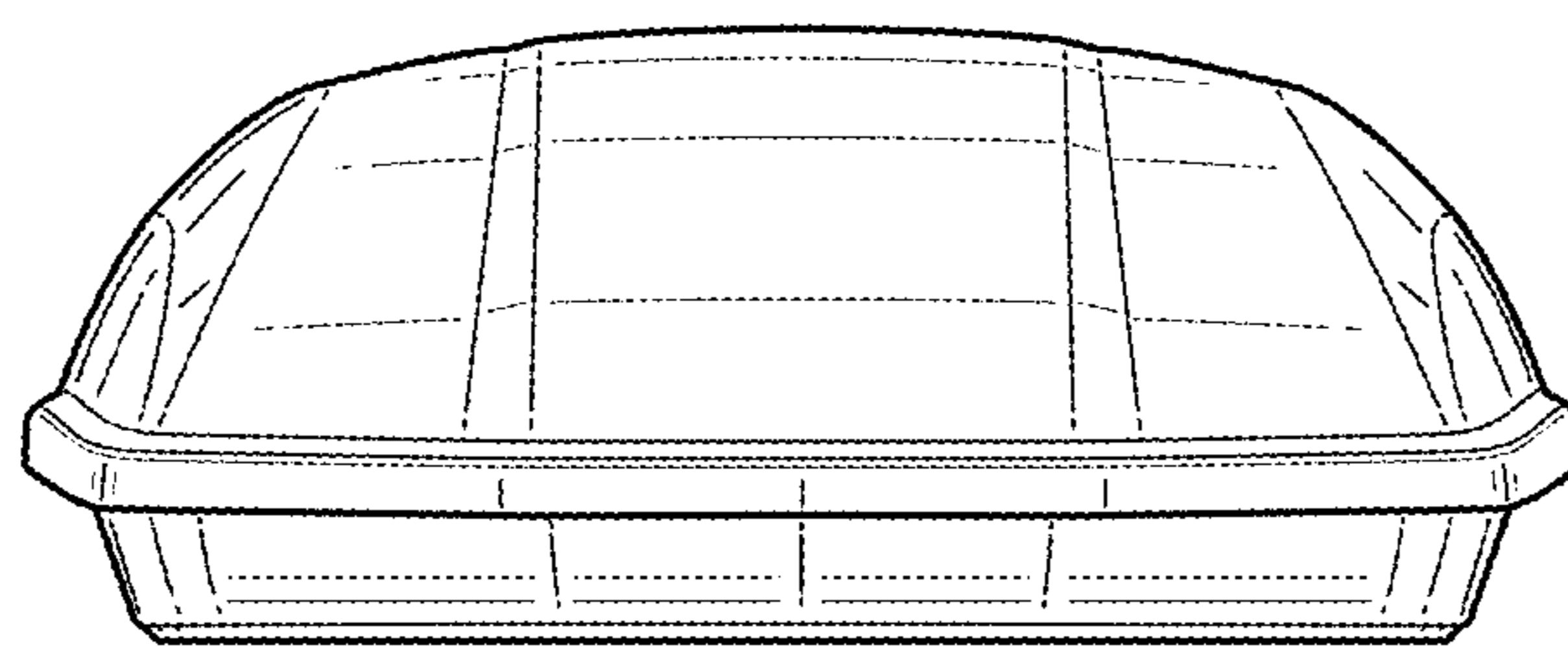

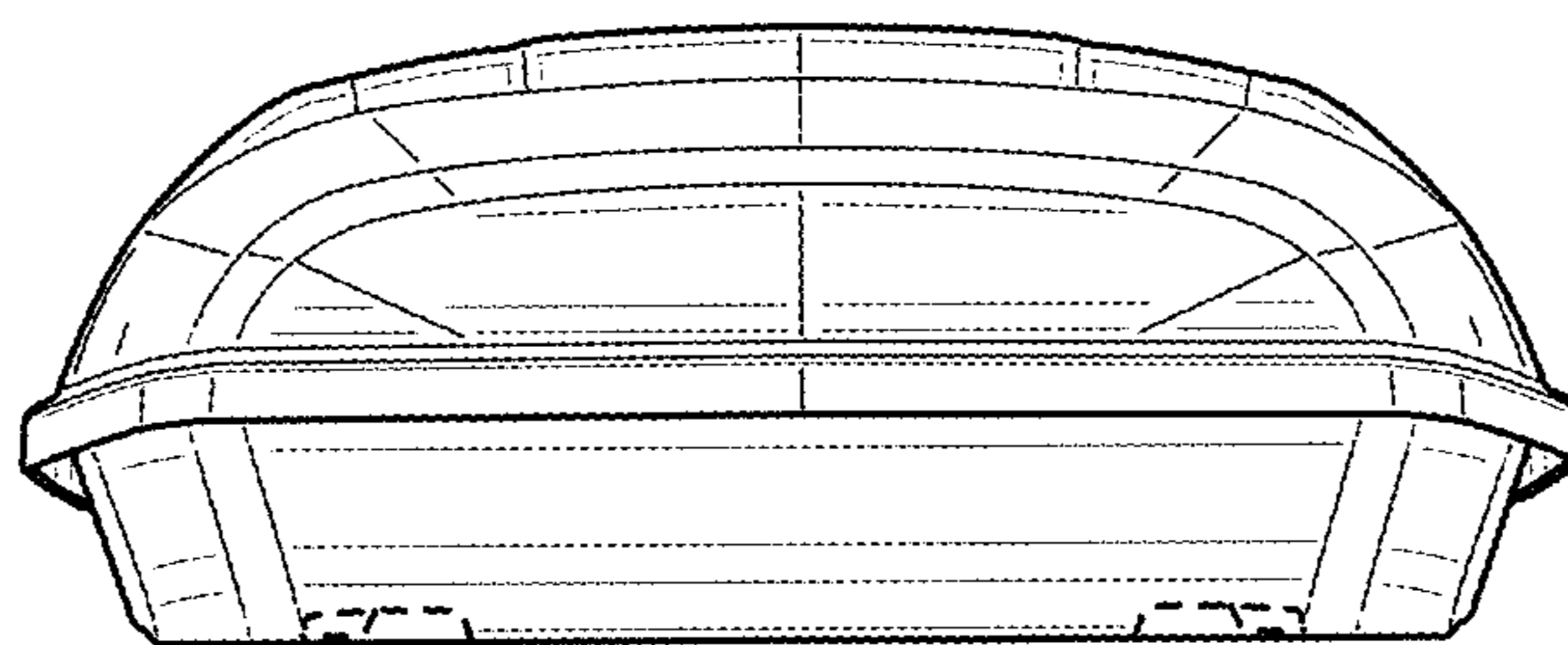

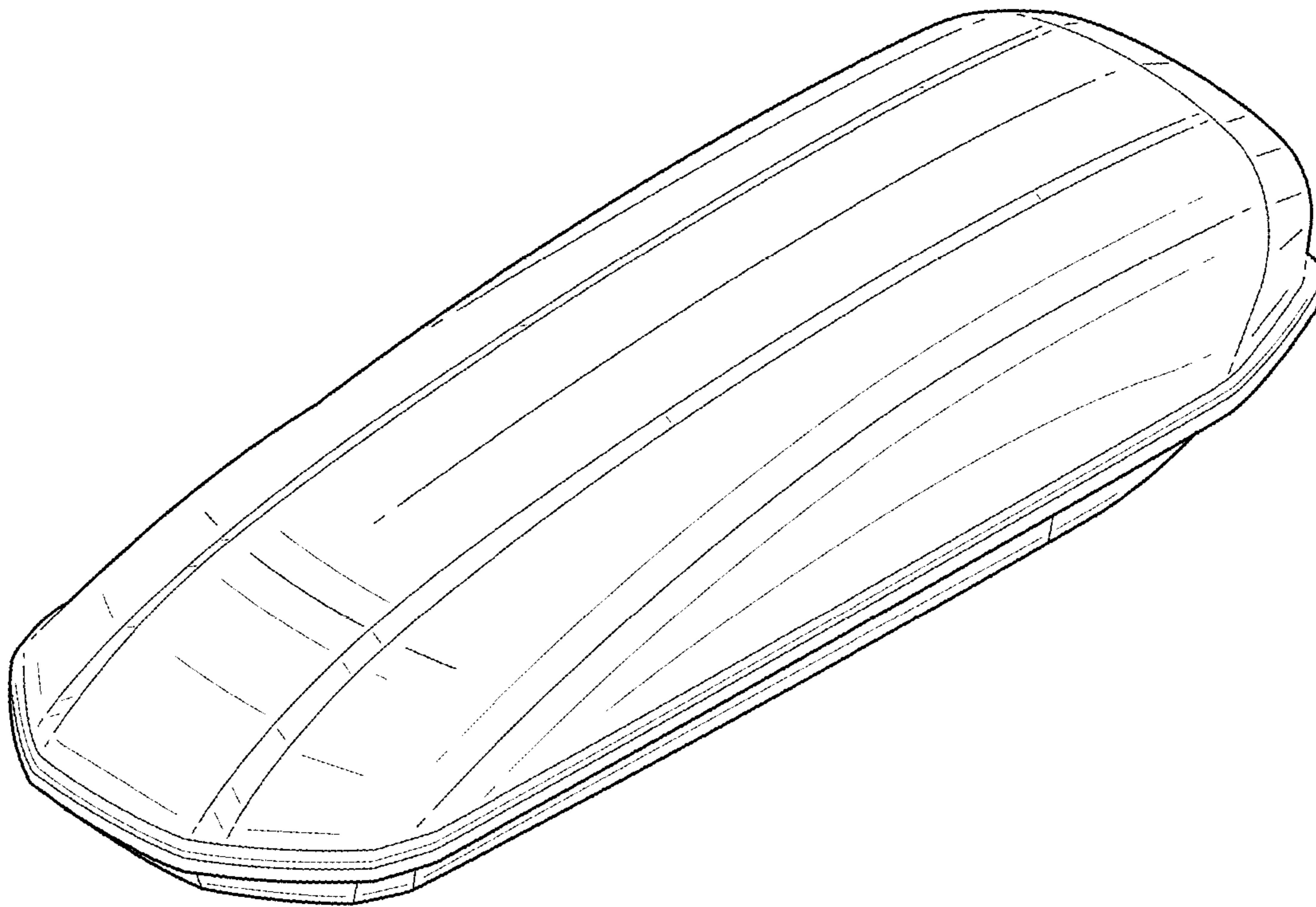

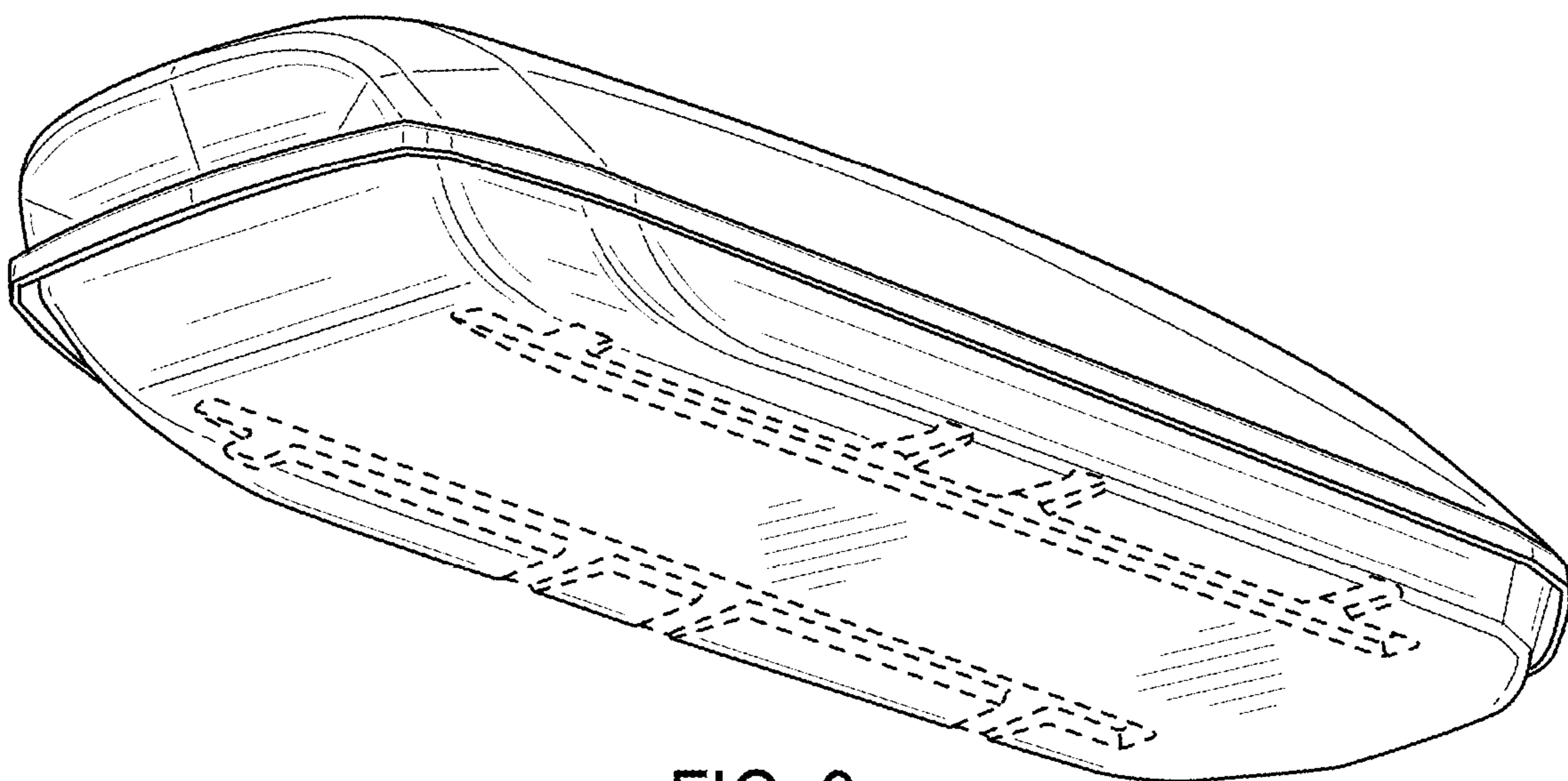

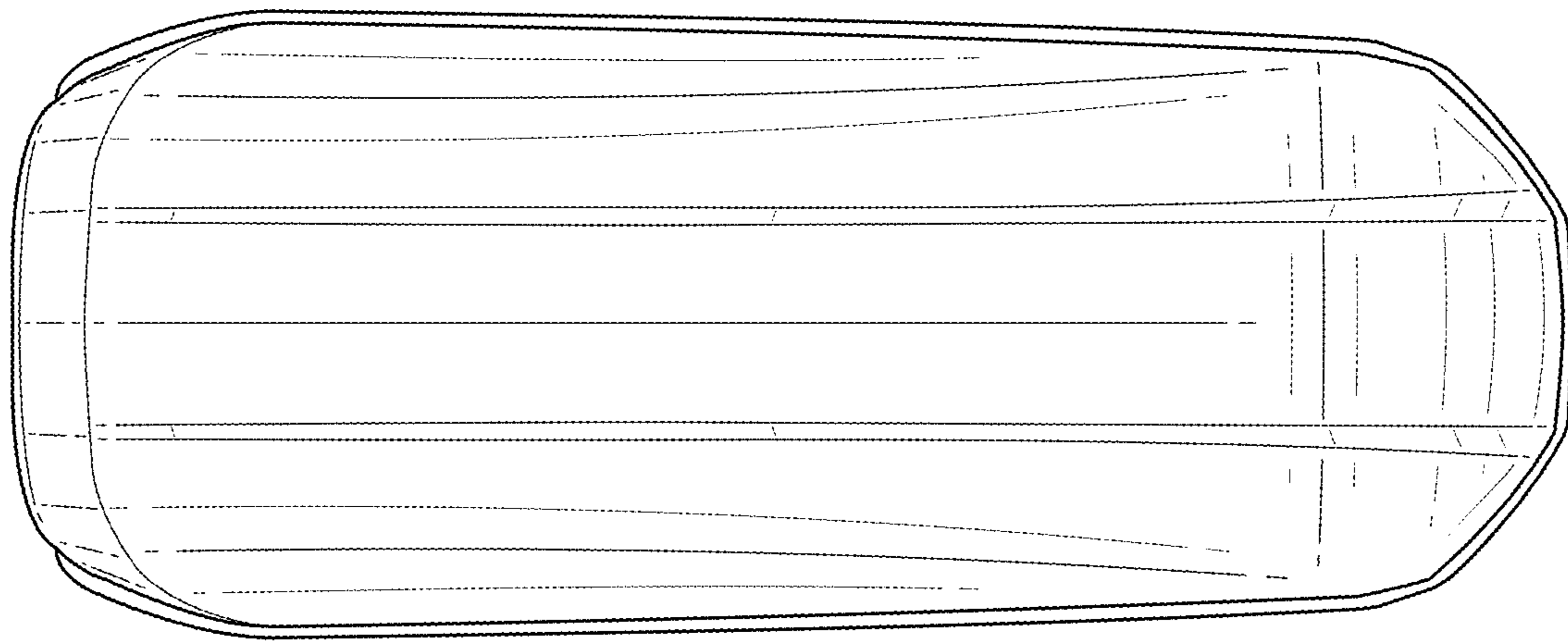

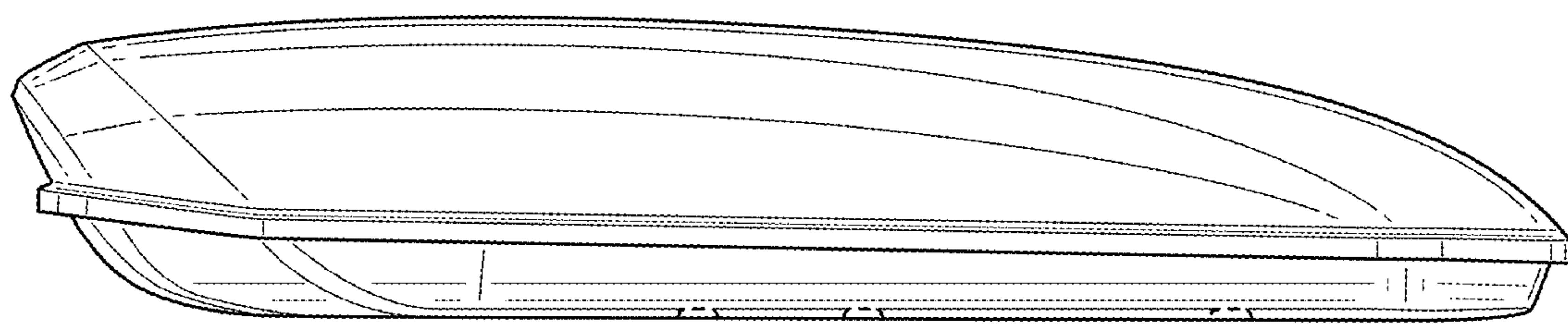

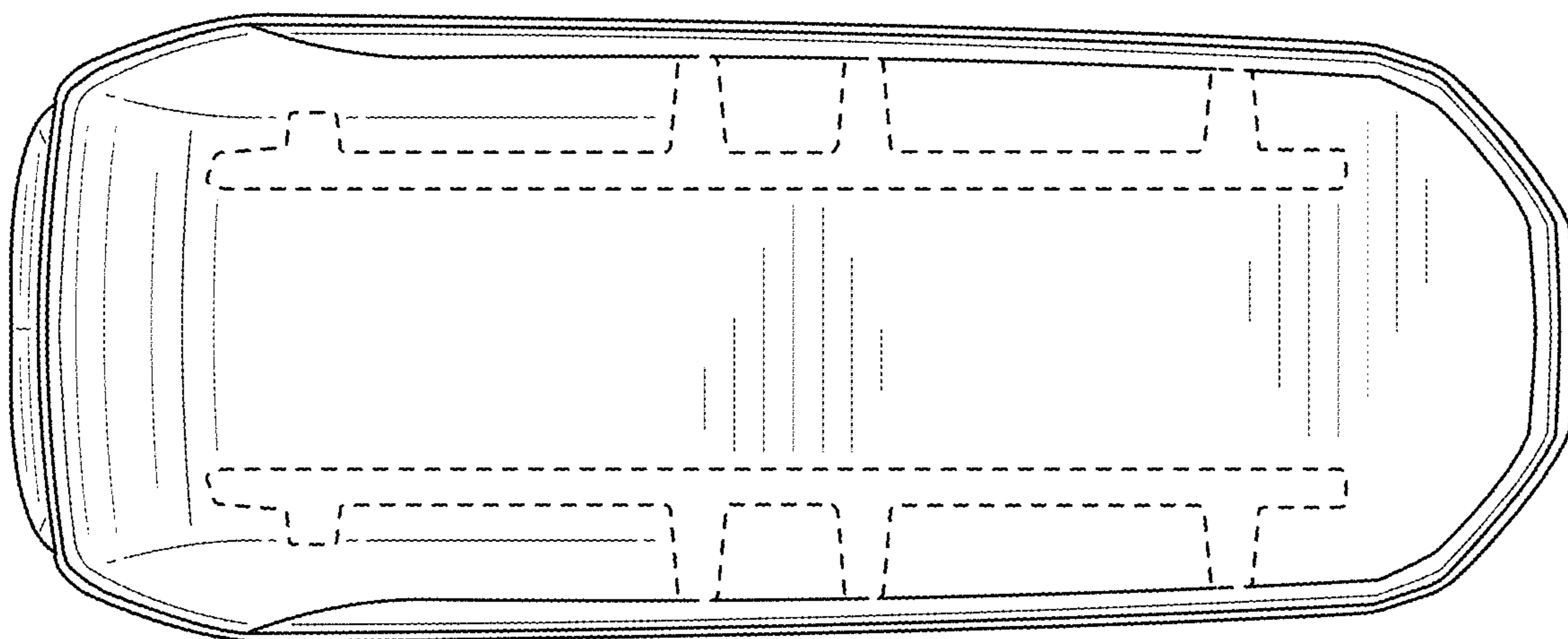

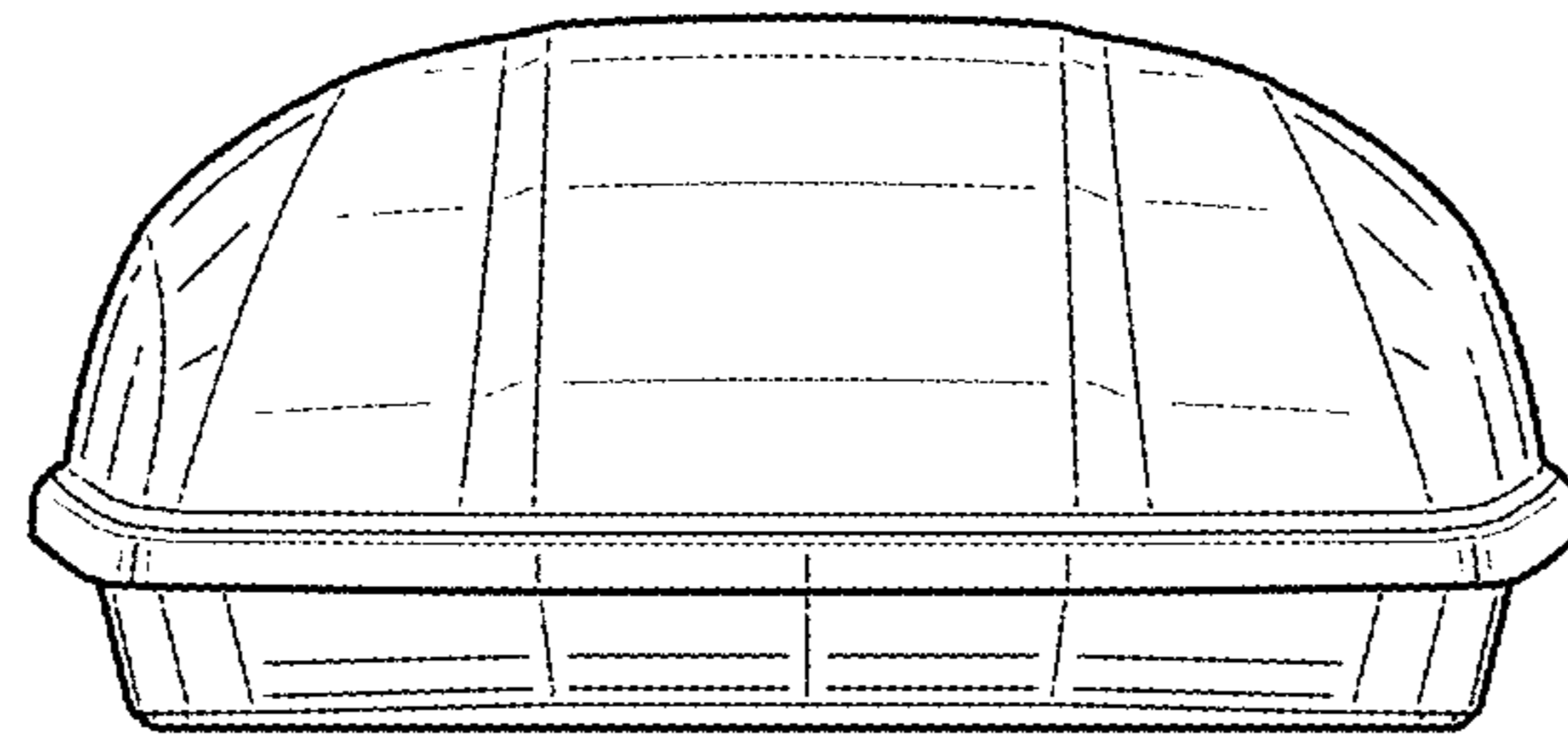

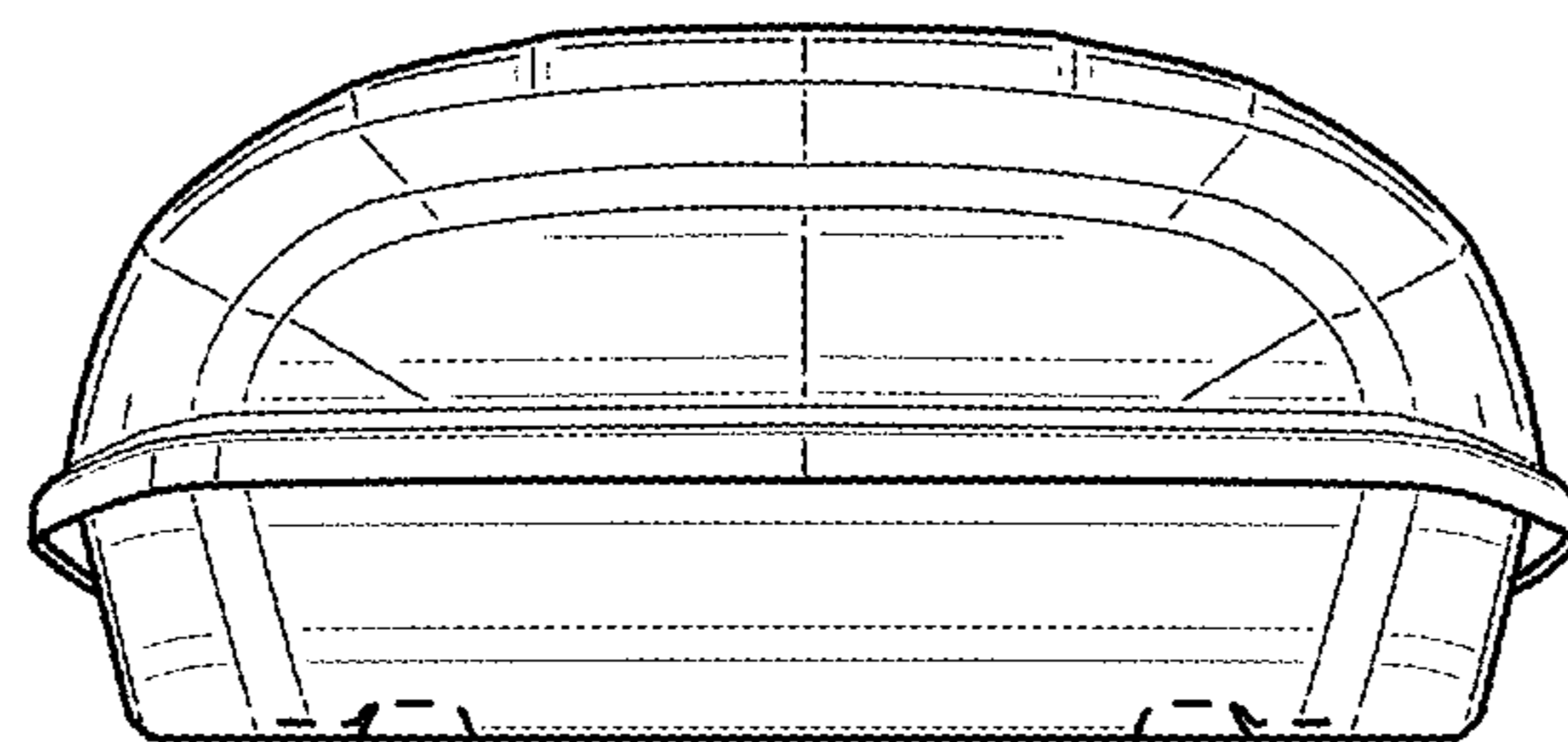
