The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of a tire showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side view thereof, the right side view being the mirror image thereof; and,
