(57) **CLAIM**

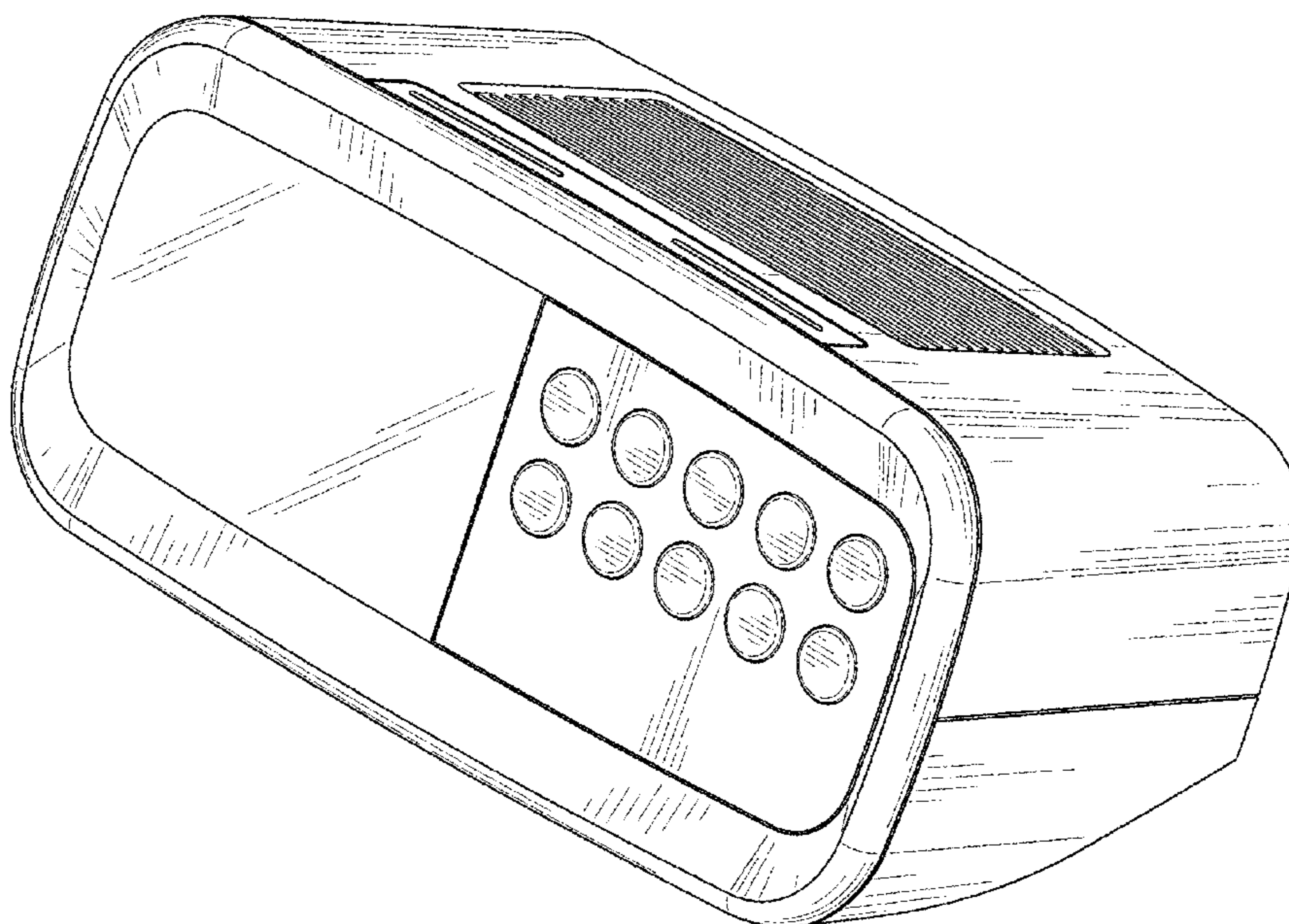
The ornamental design for a clock radio with USB charging, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a clock radio with USB charging showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof, the opposite side view being a mirror image;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is a cross-sectional view thereof along line 7-7 in FIG. 5.

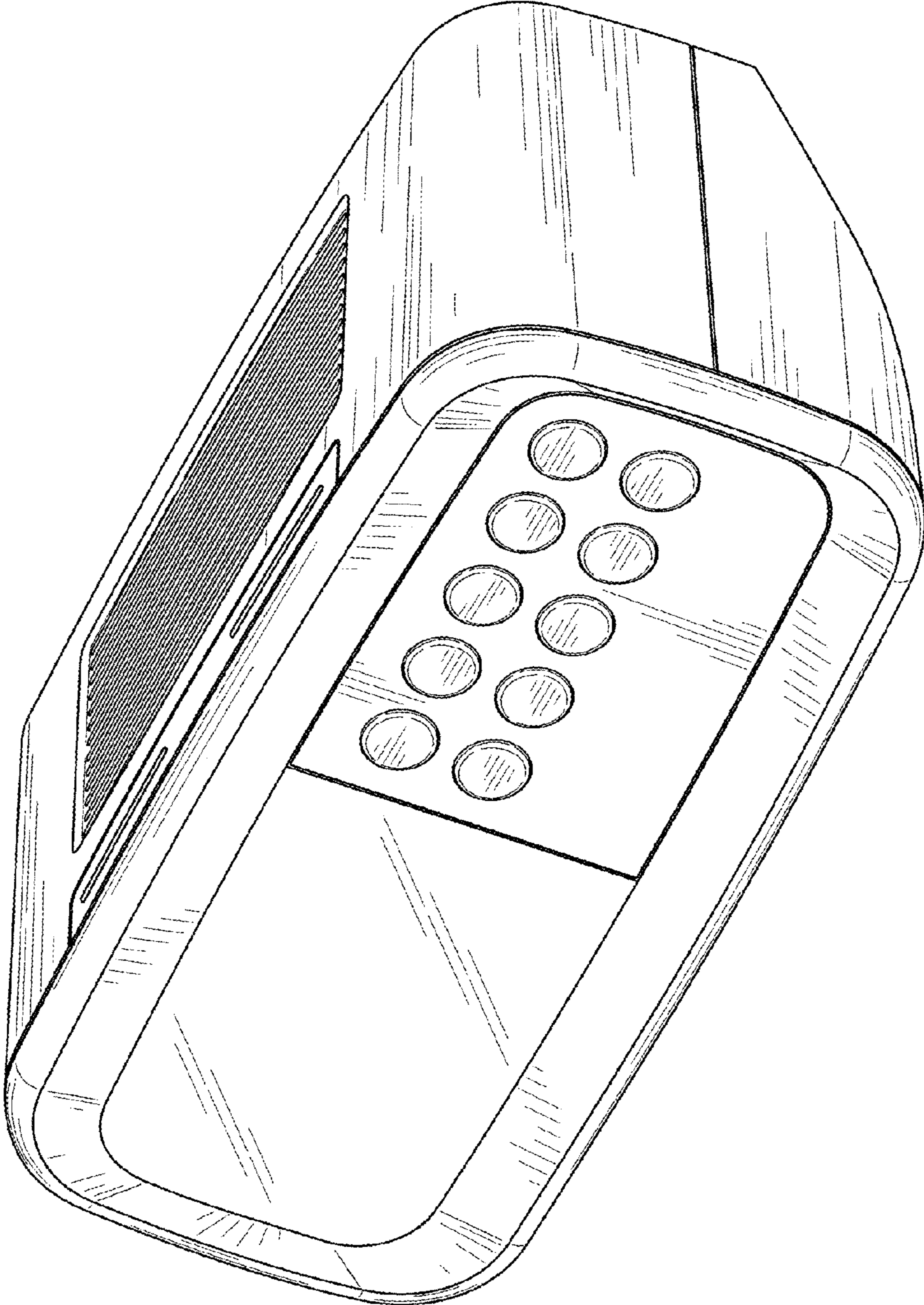

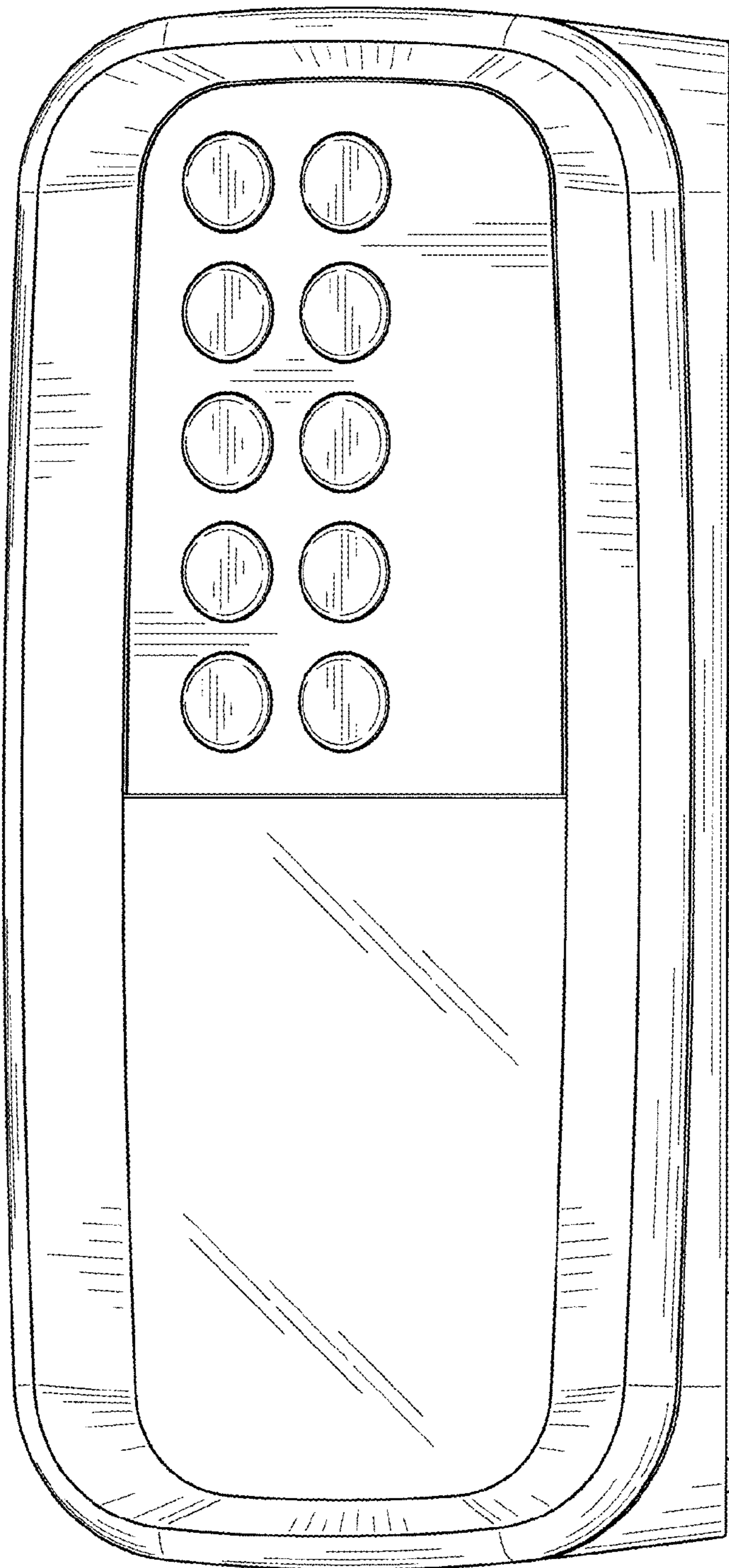

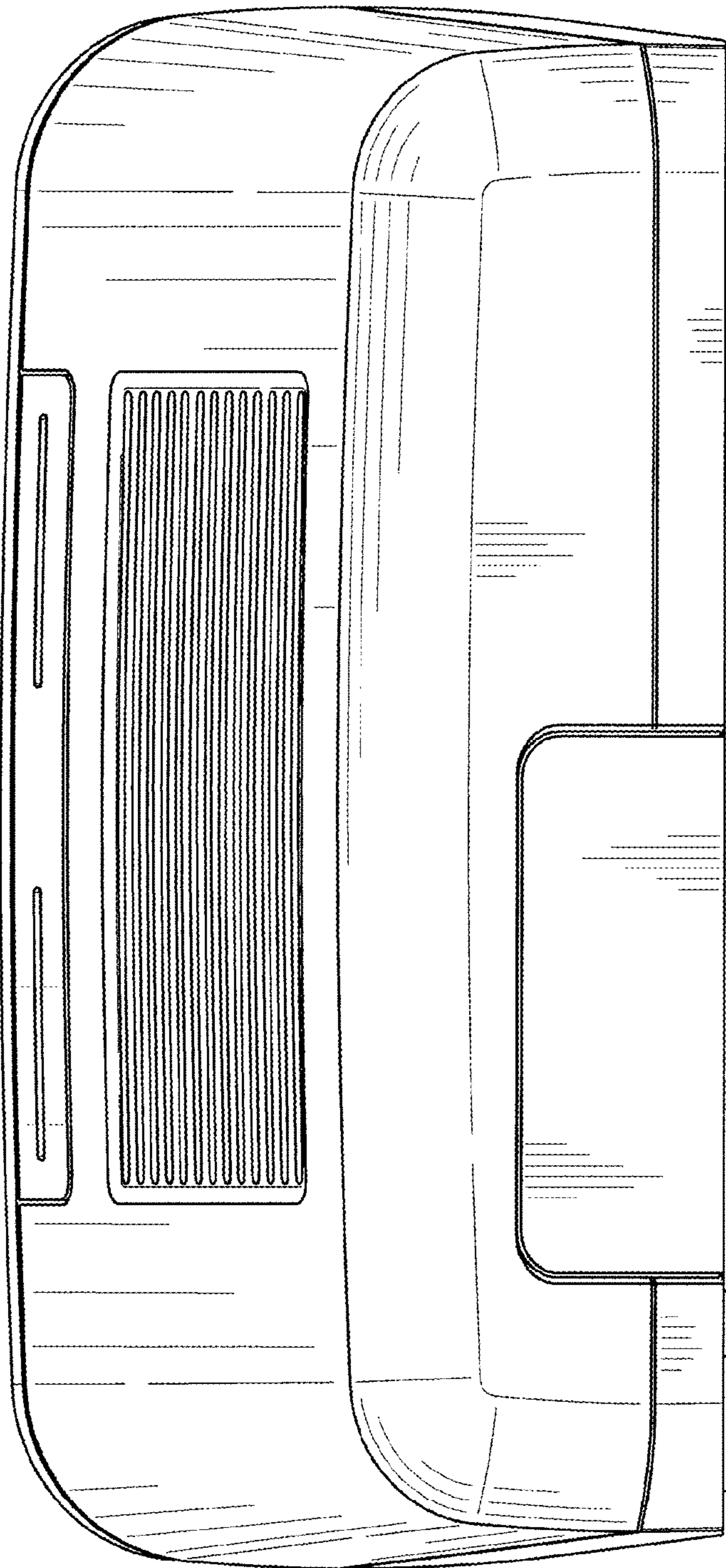

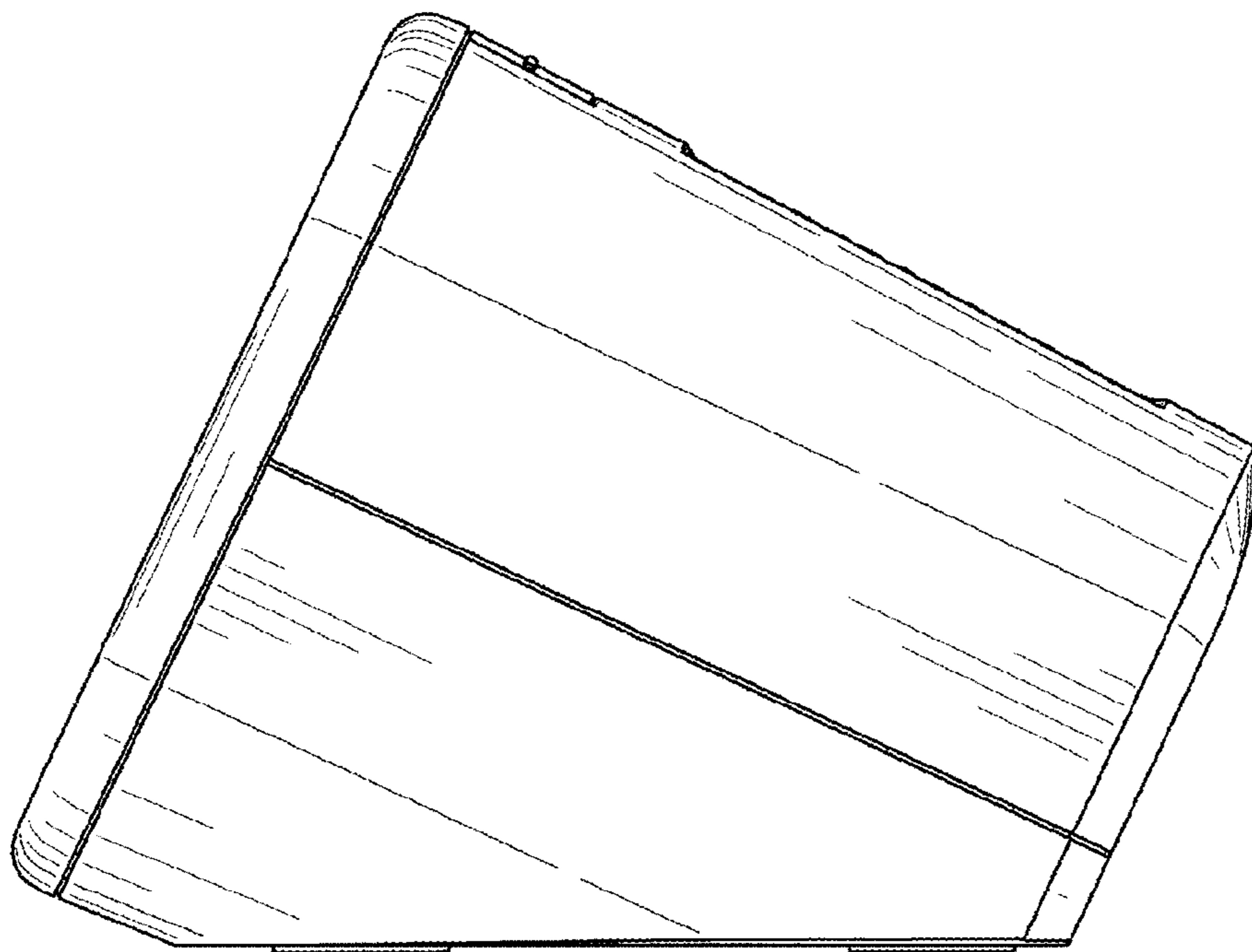

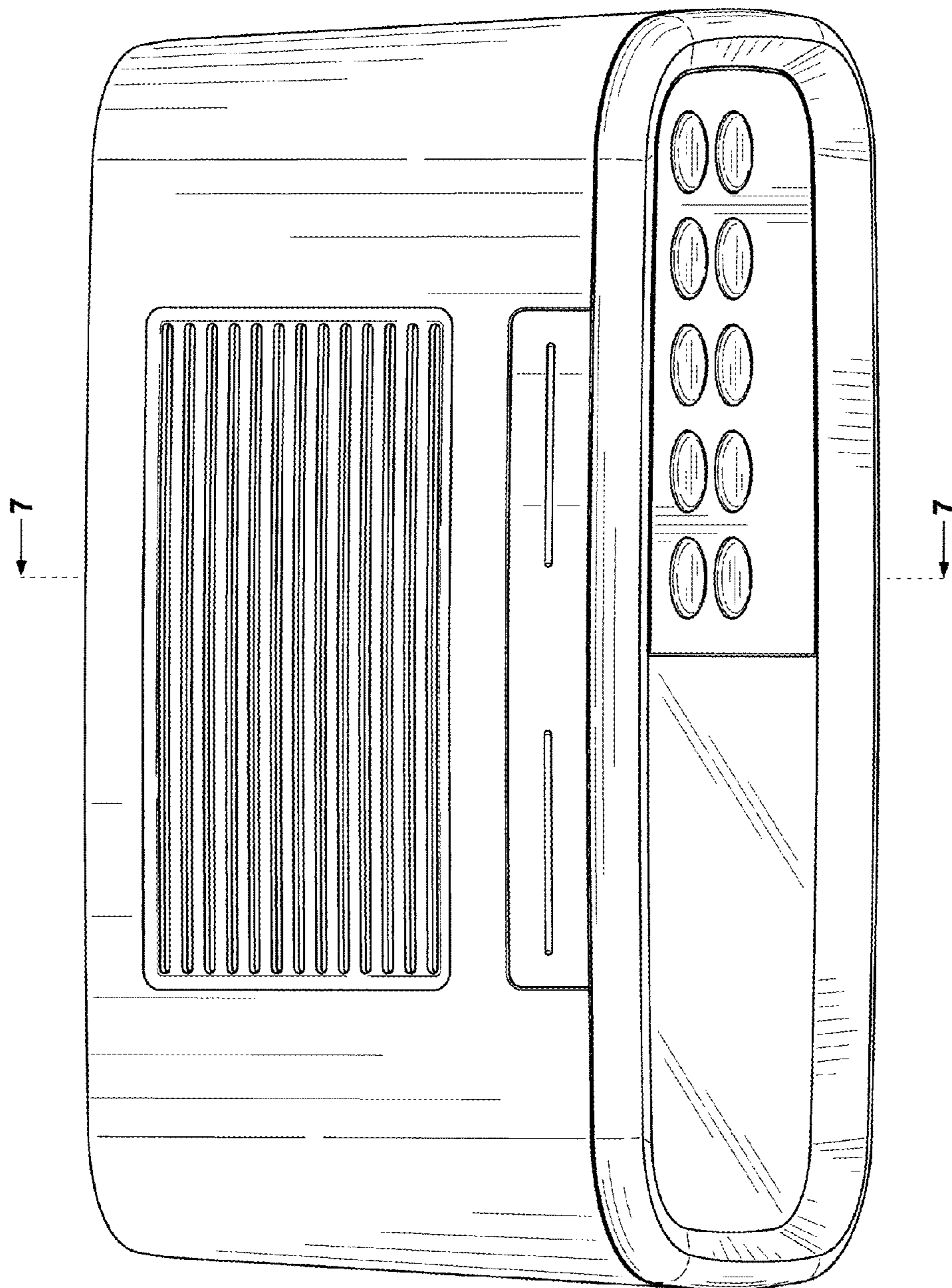

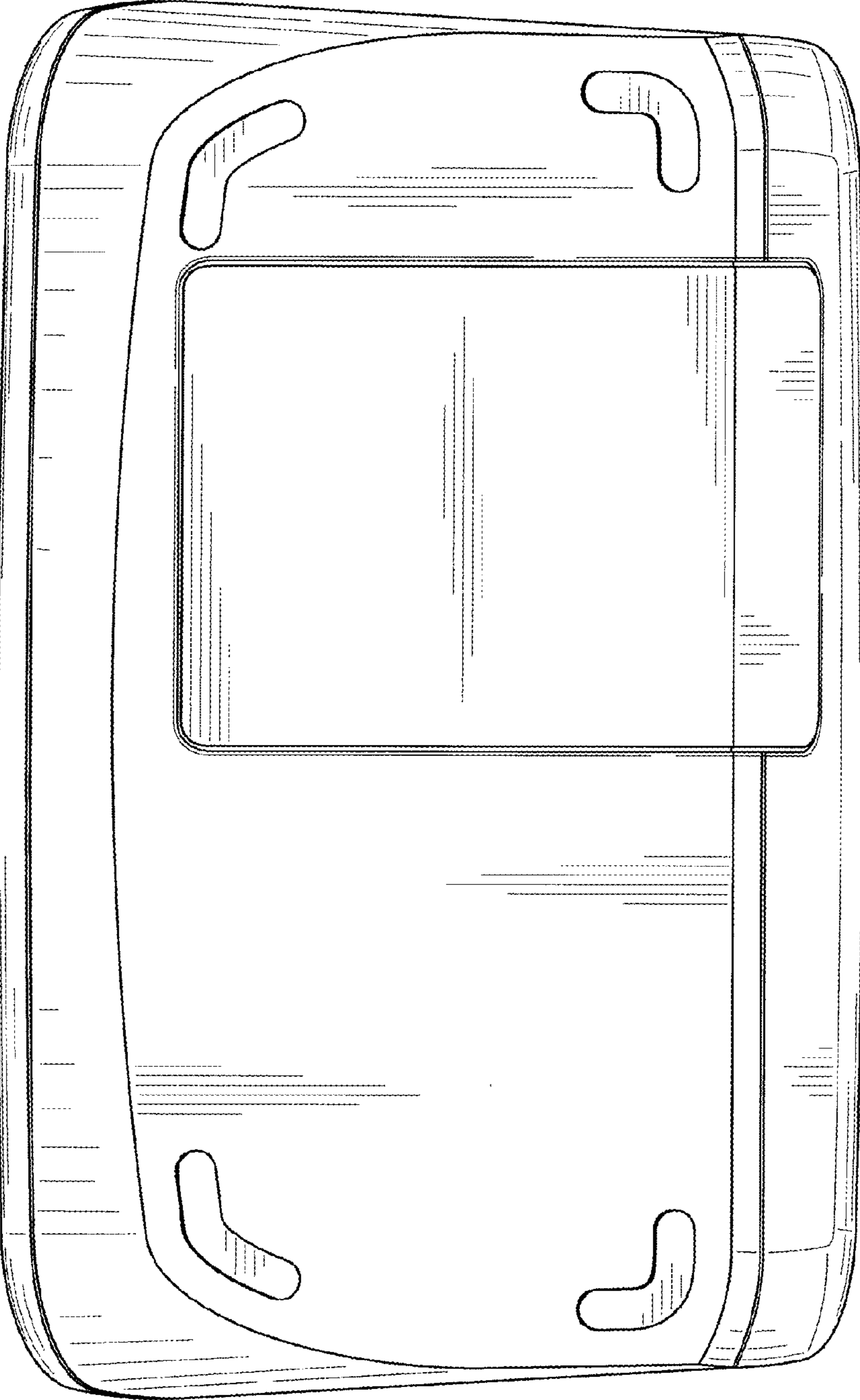

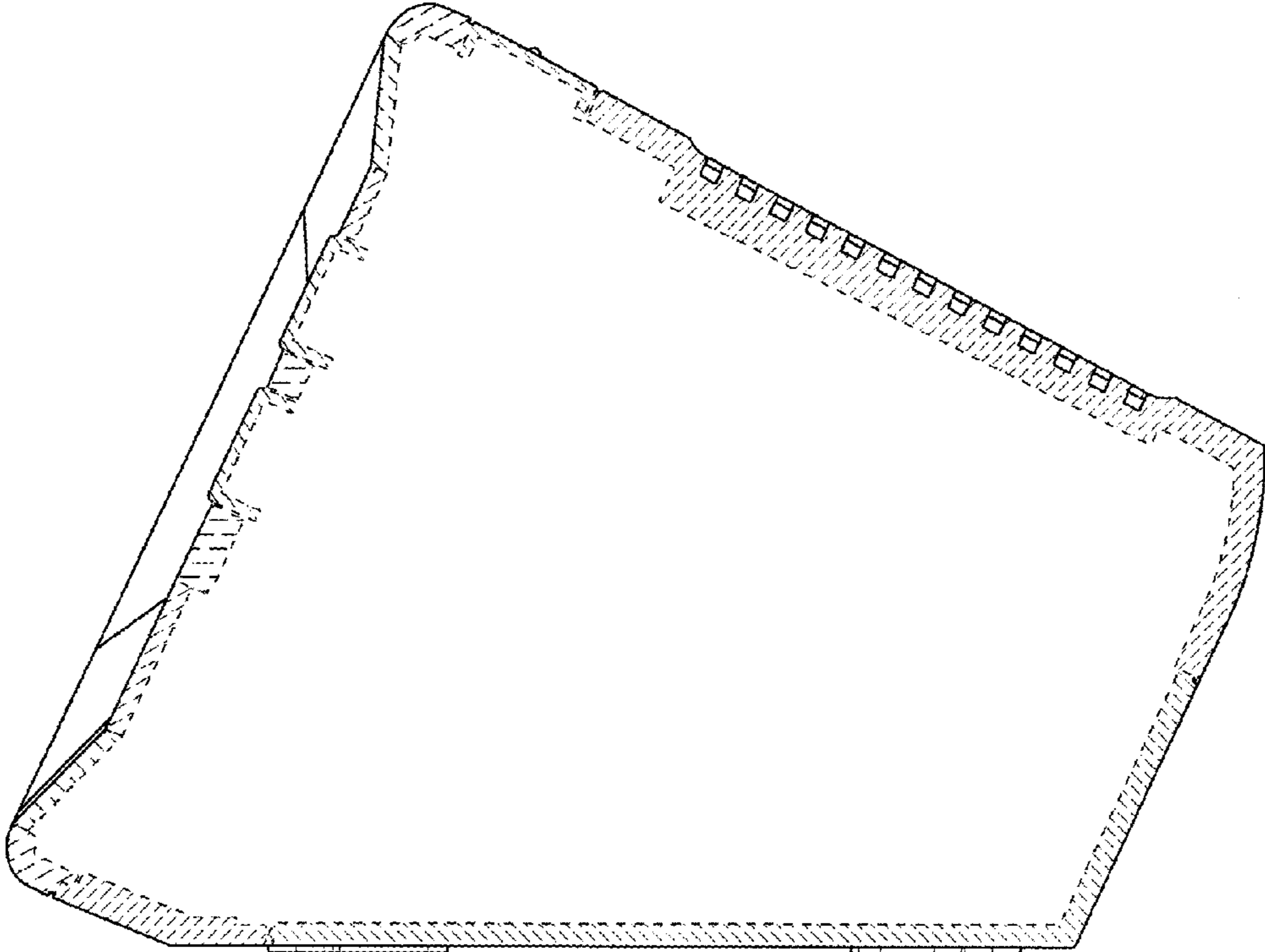
