FIG. 1 is a front view of a first image of a display screen portion with animated graphical user interface showing our new design;

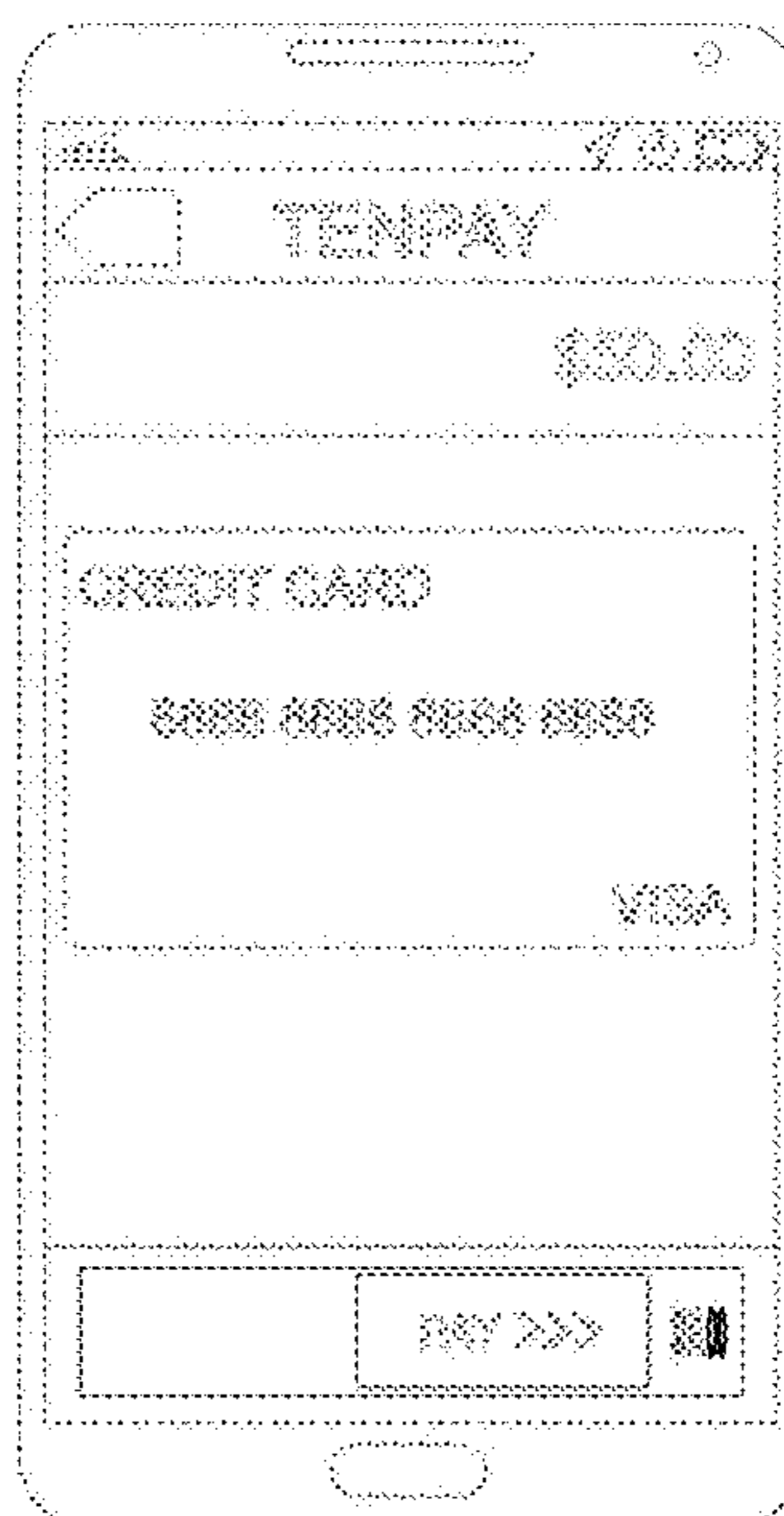
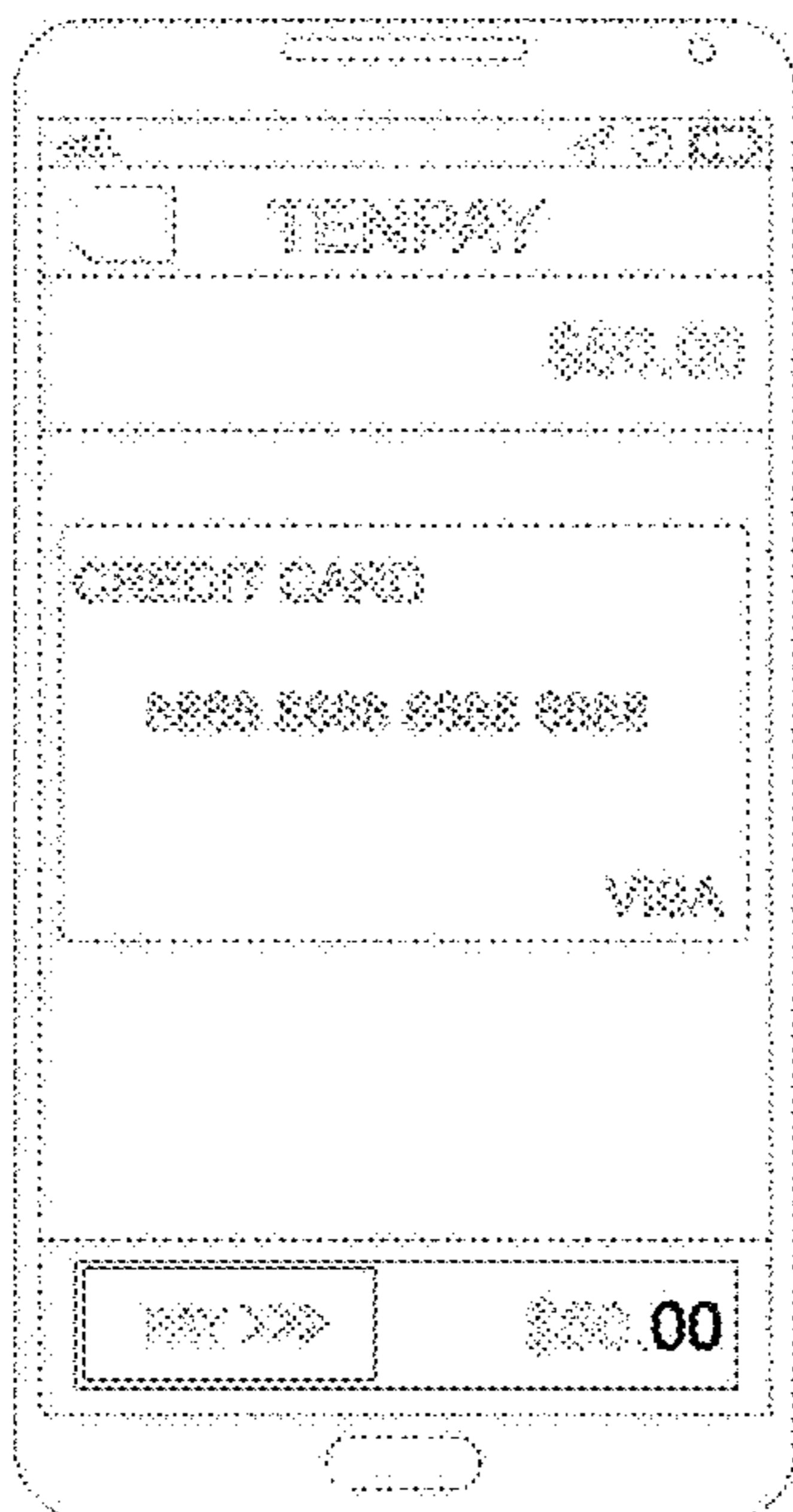
FIG. 2 is a front view of a second image thereof;

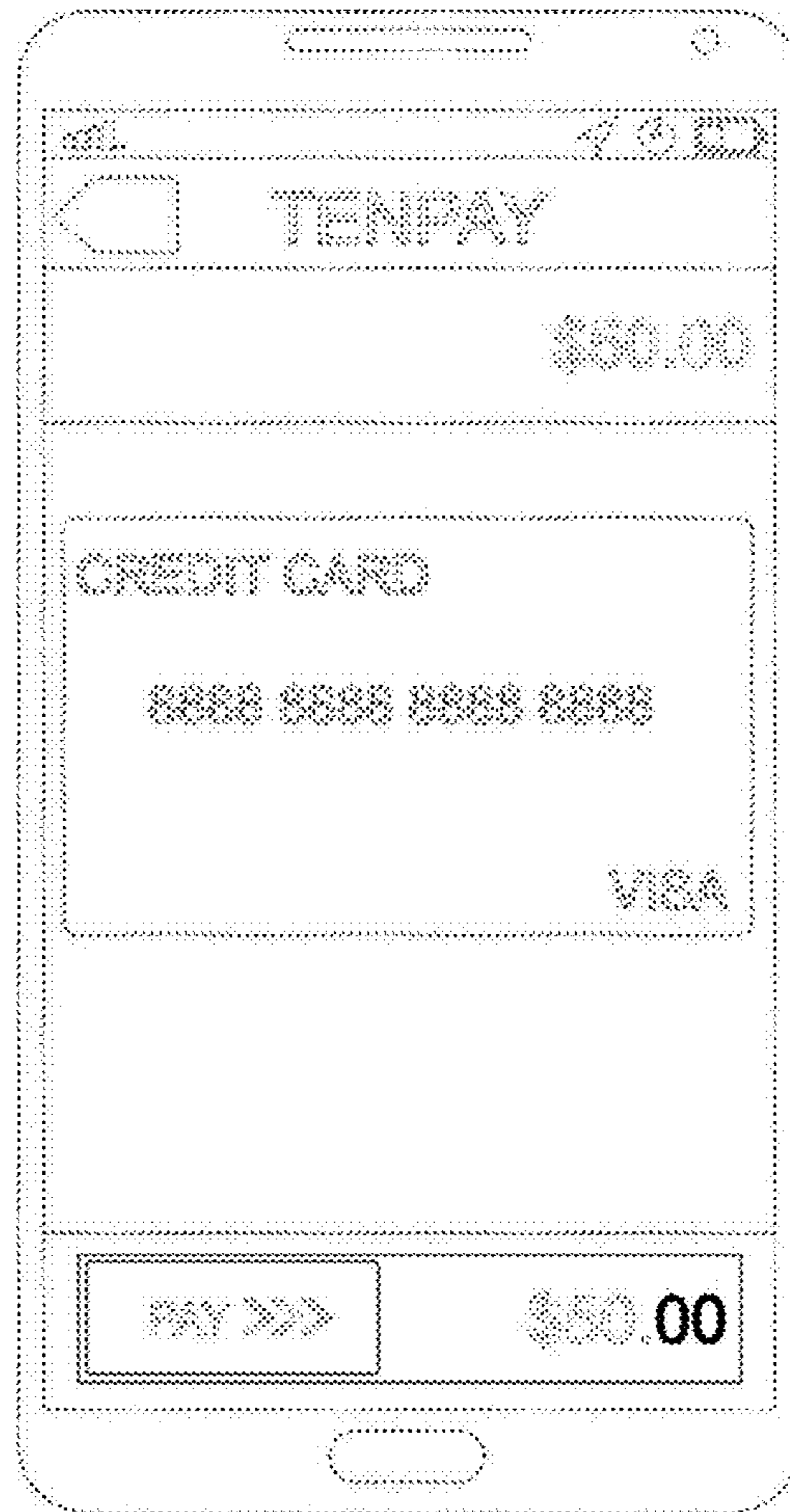

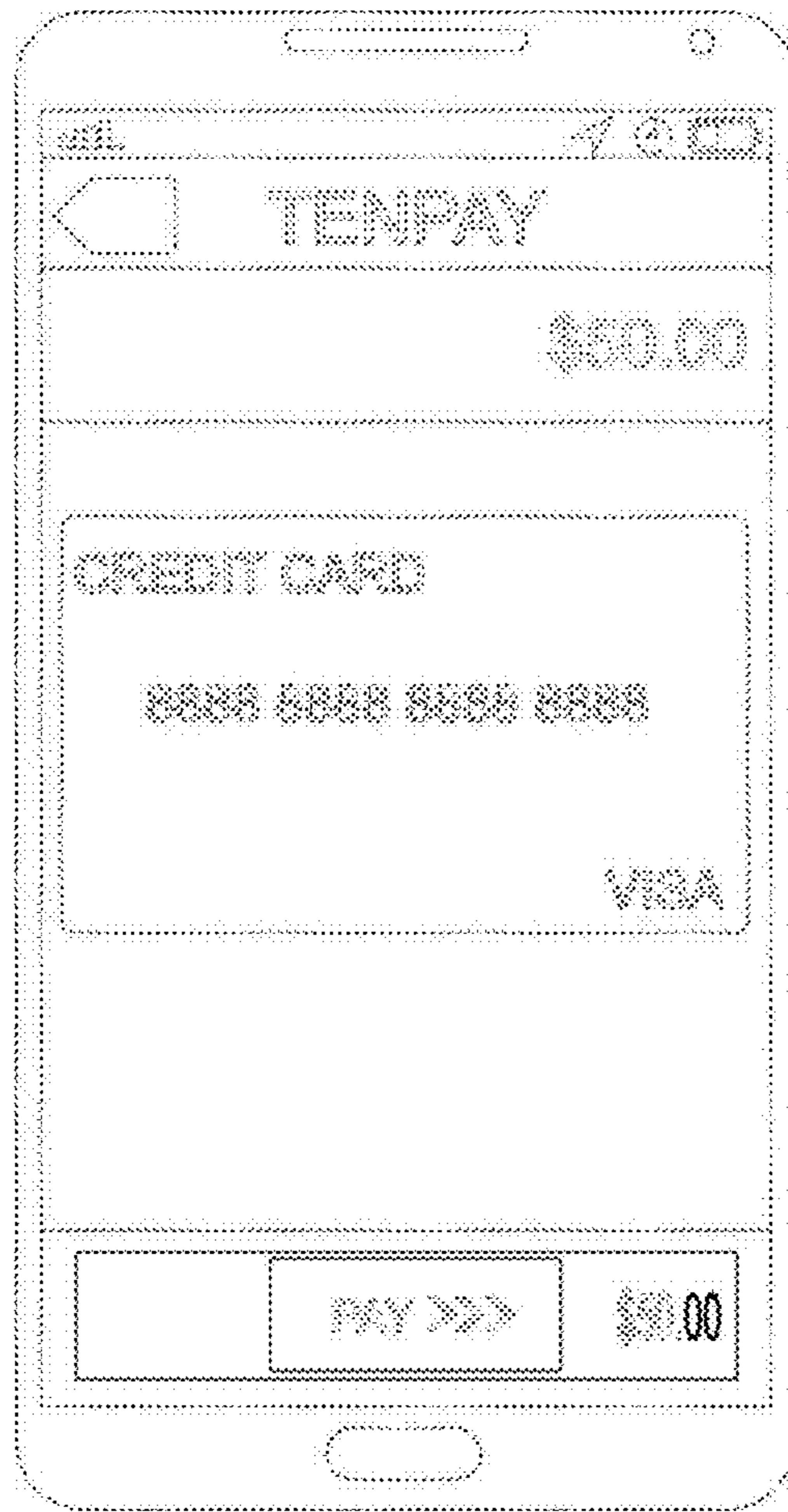

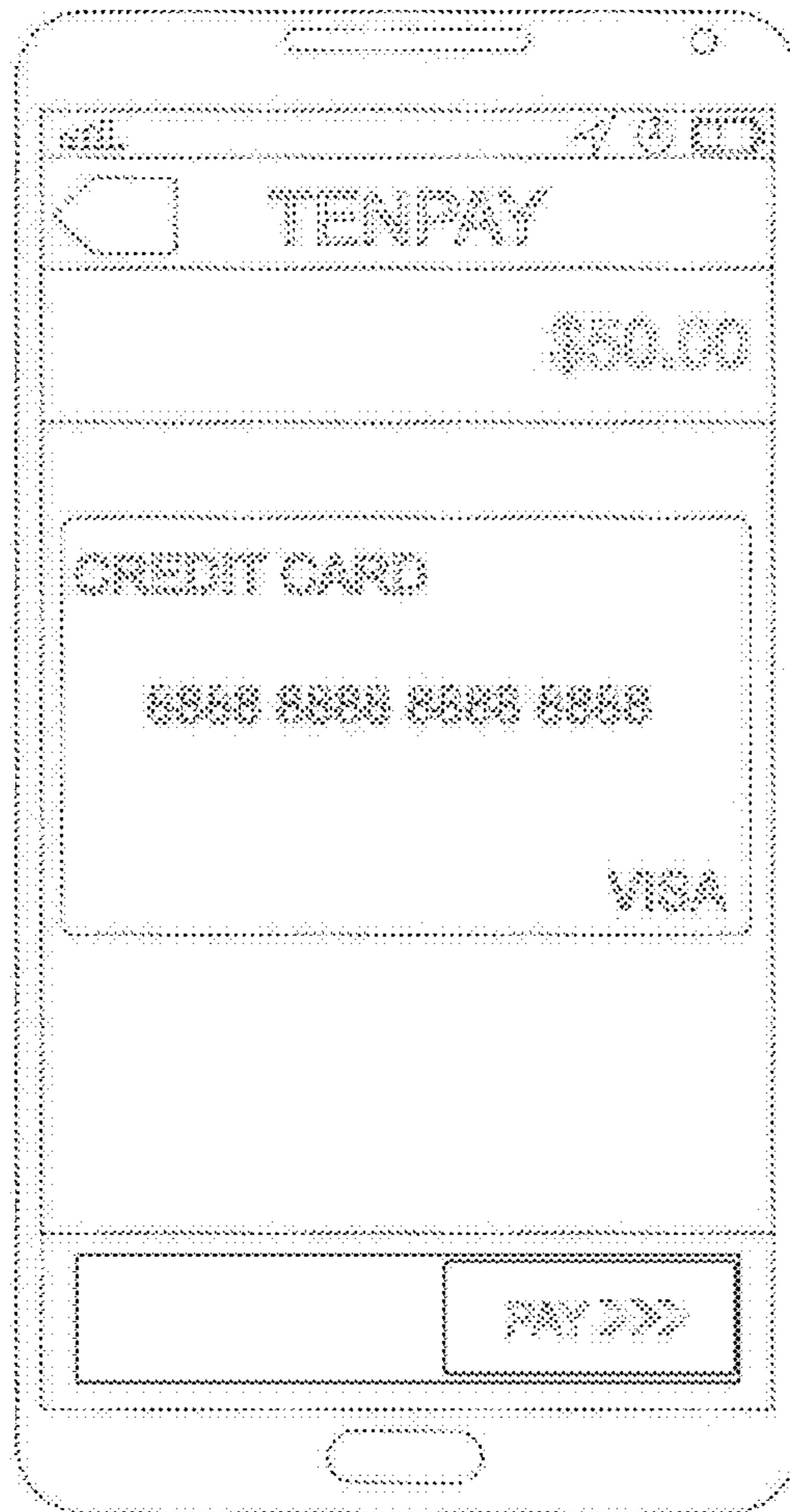
