FIG. 1 is a front view of a display screen or portion thereof with graphical user interface;

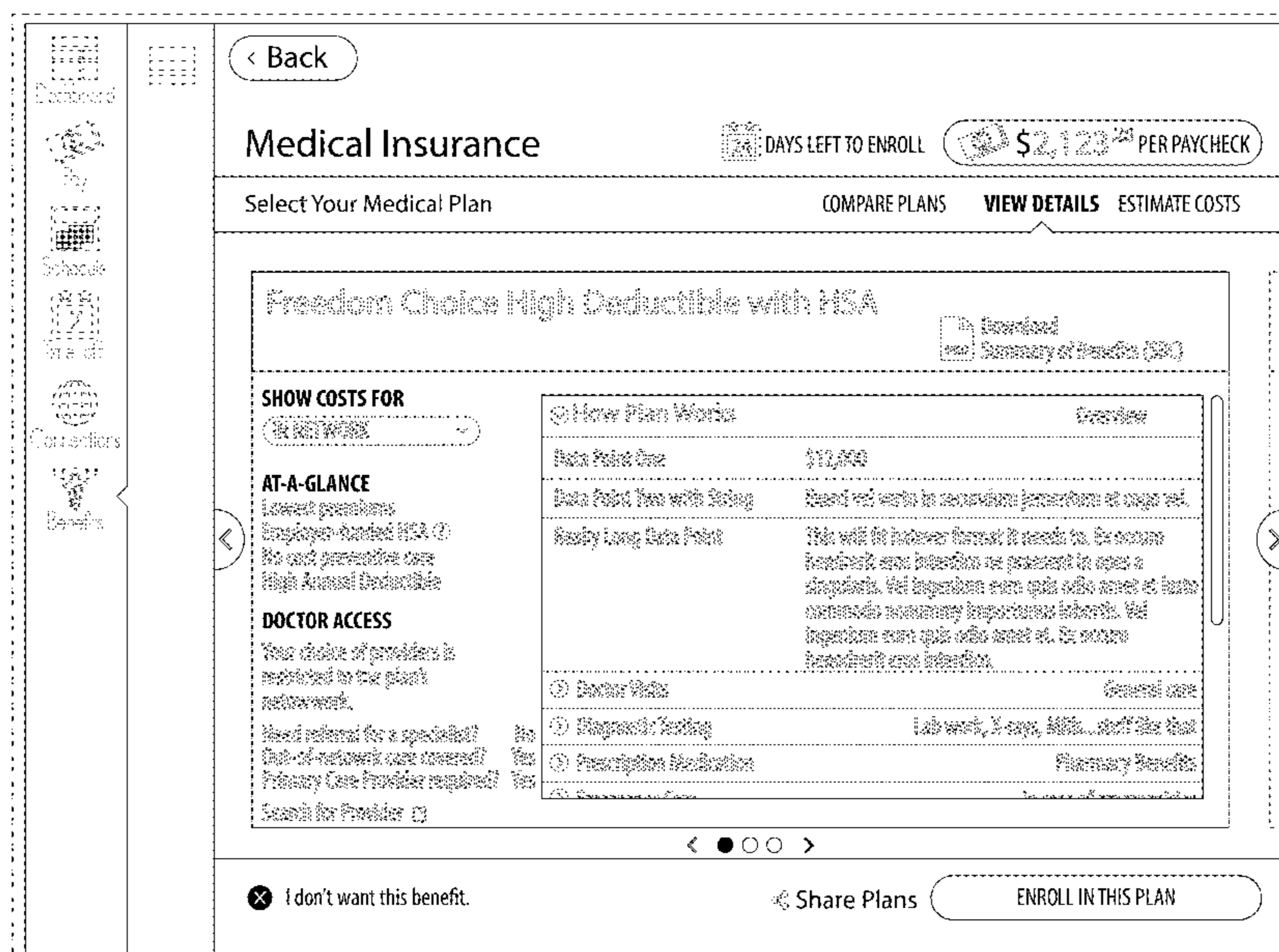
FIG. 2 is a front view of another embodiment of the display screen or portion thereof with graphical user interface;

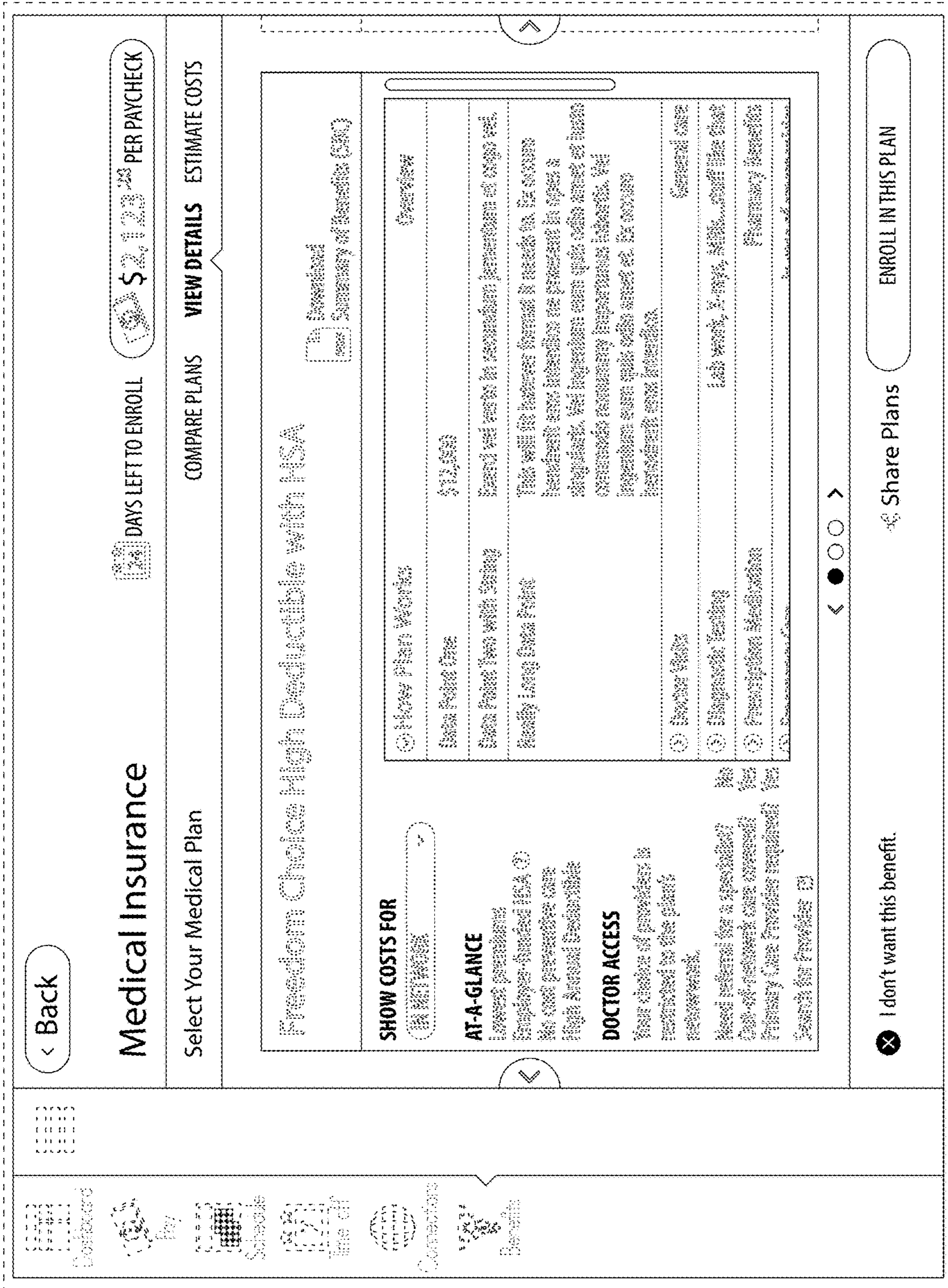

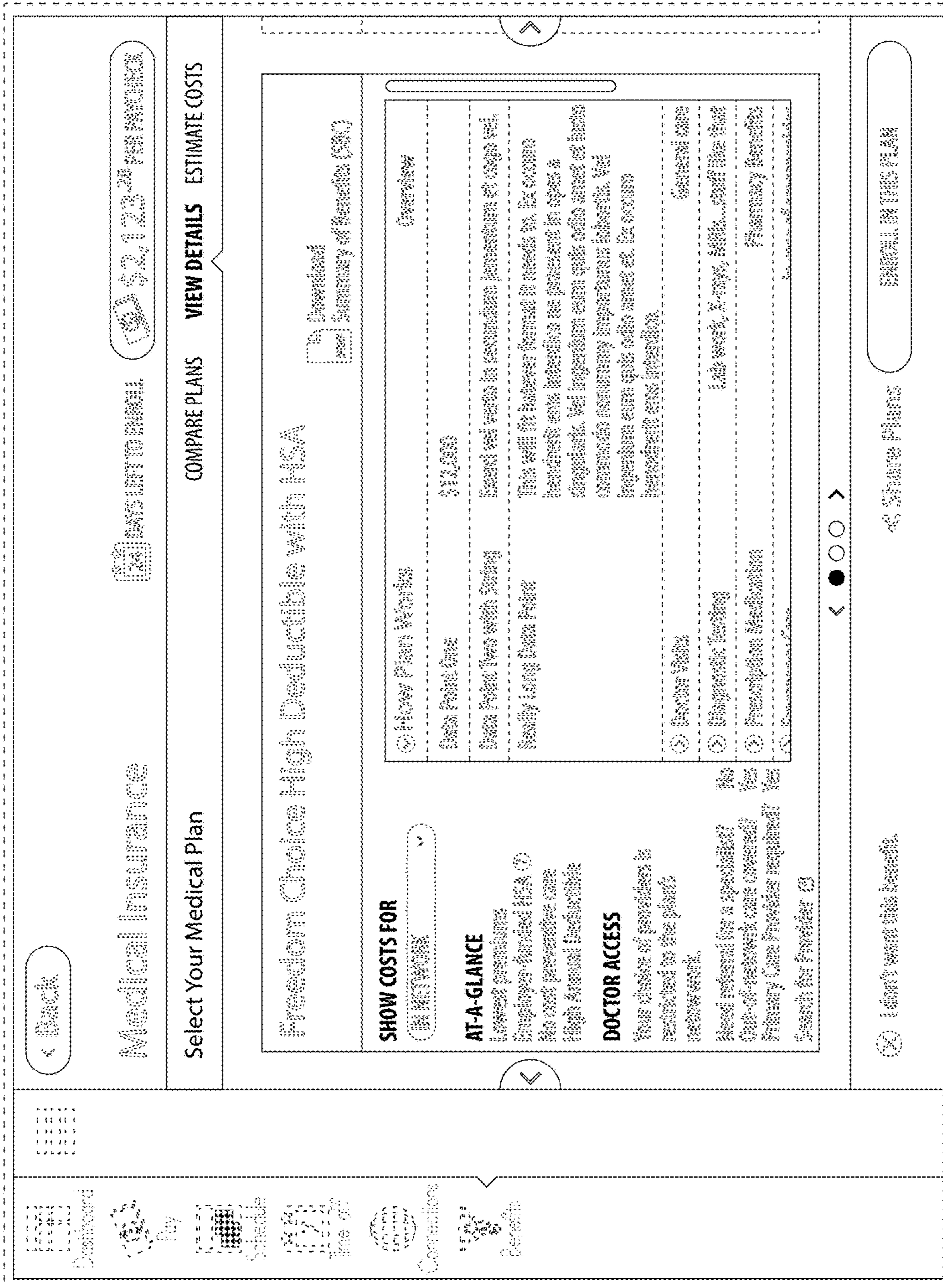

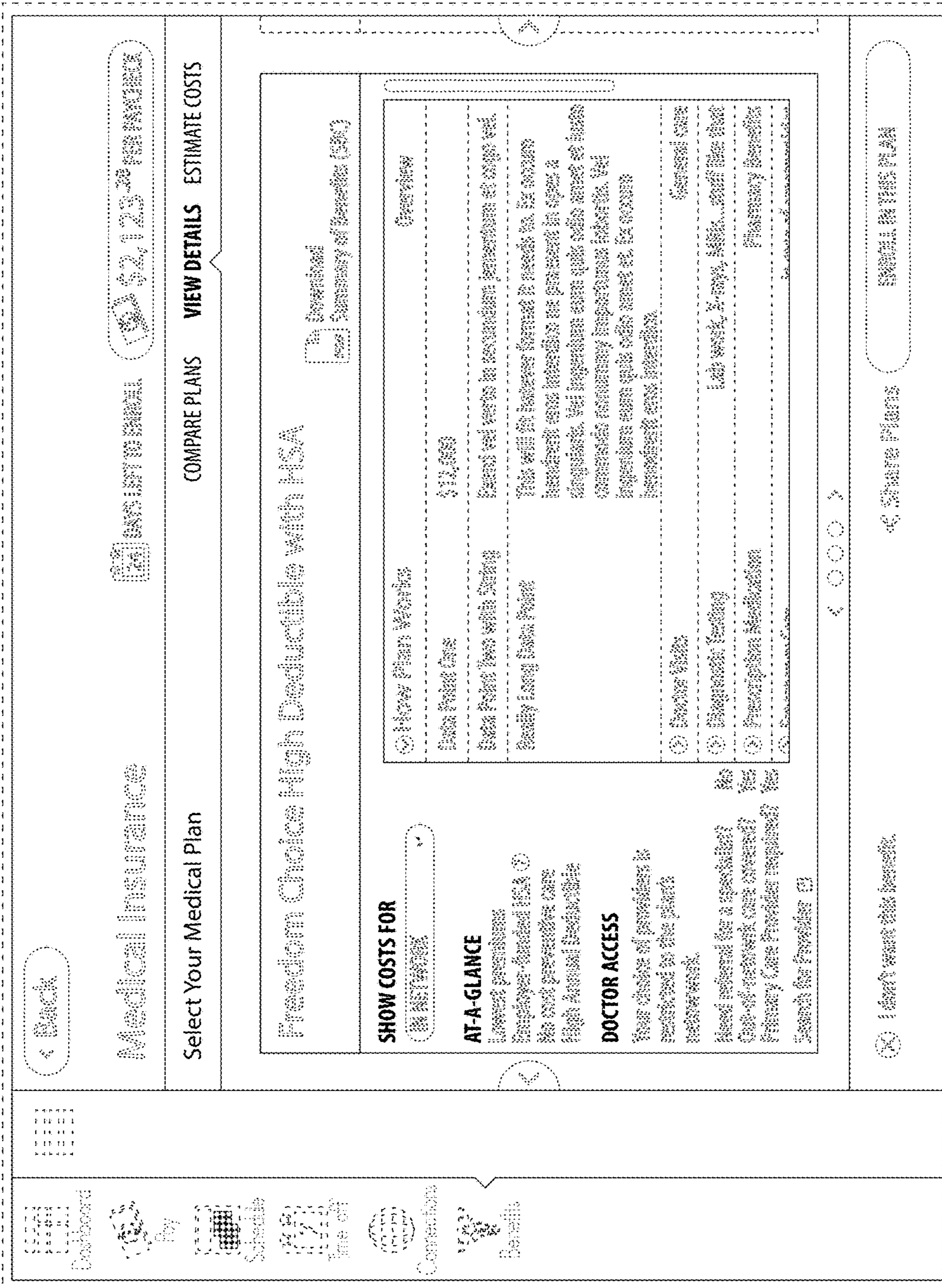

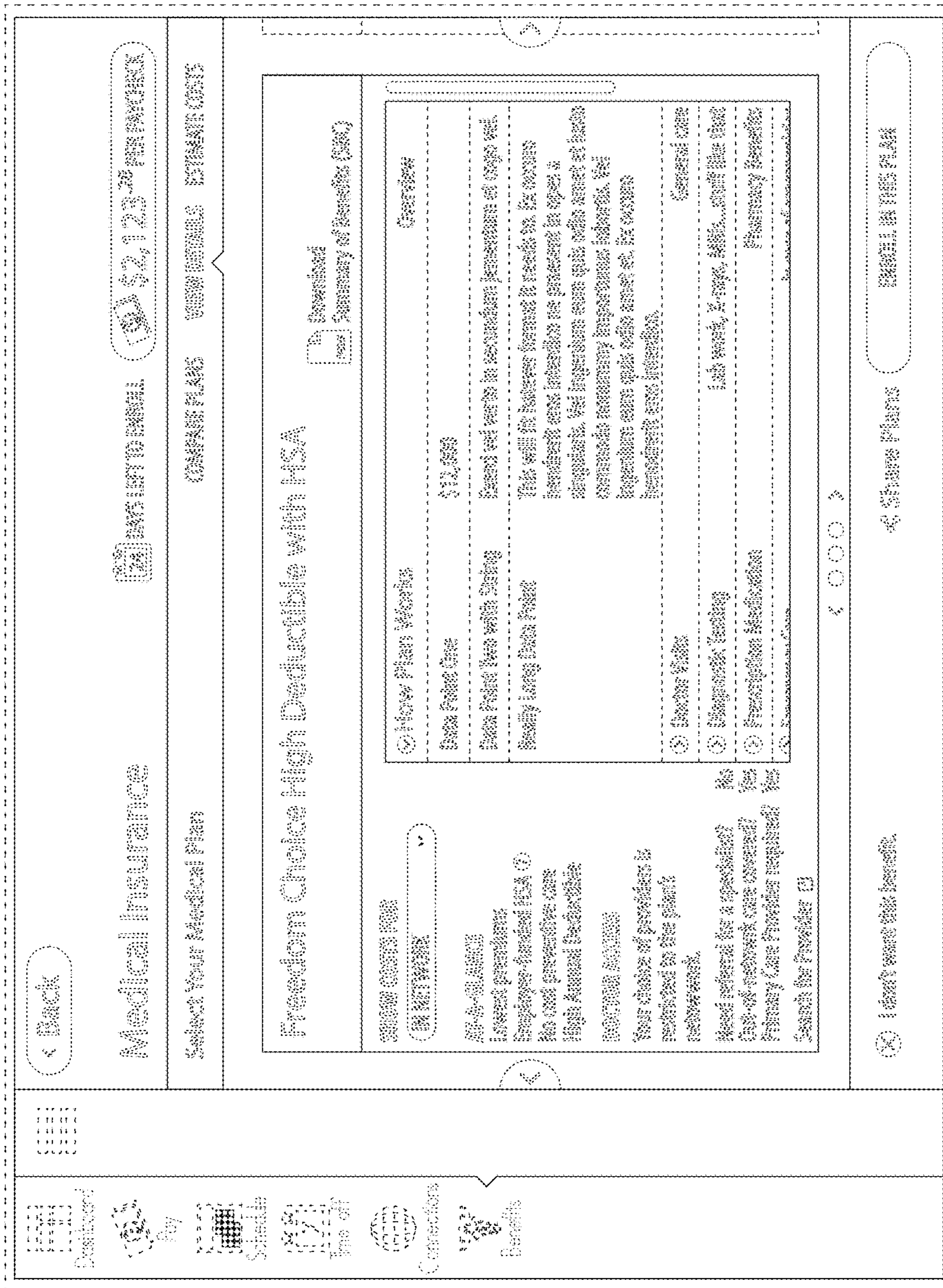
