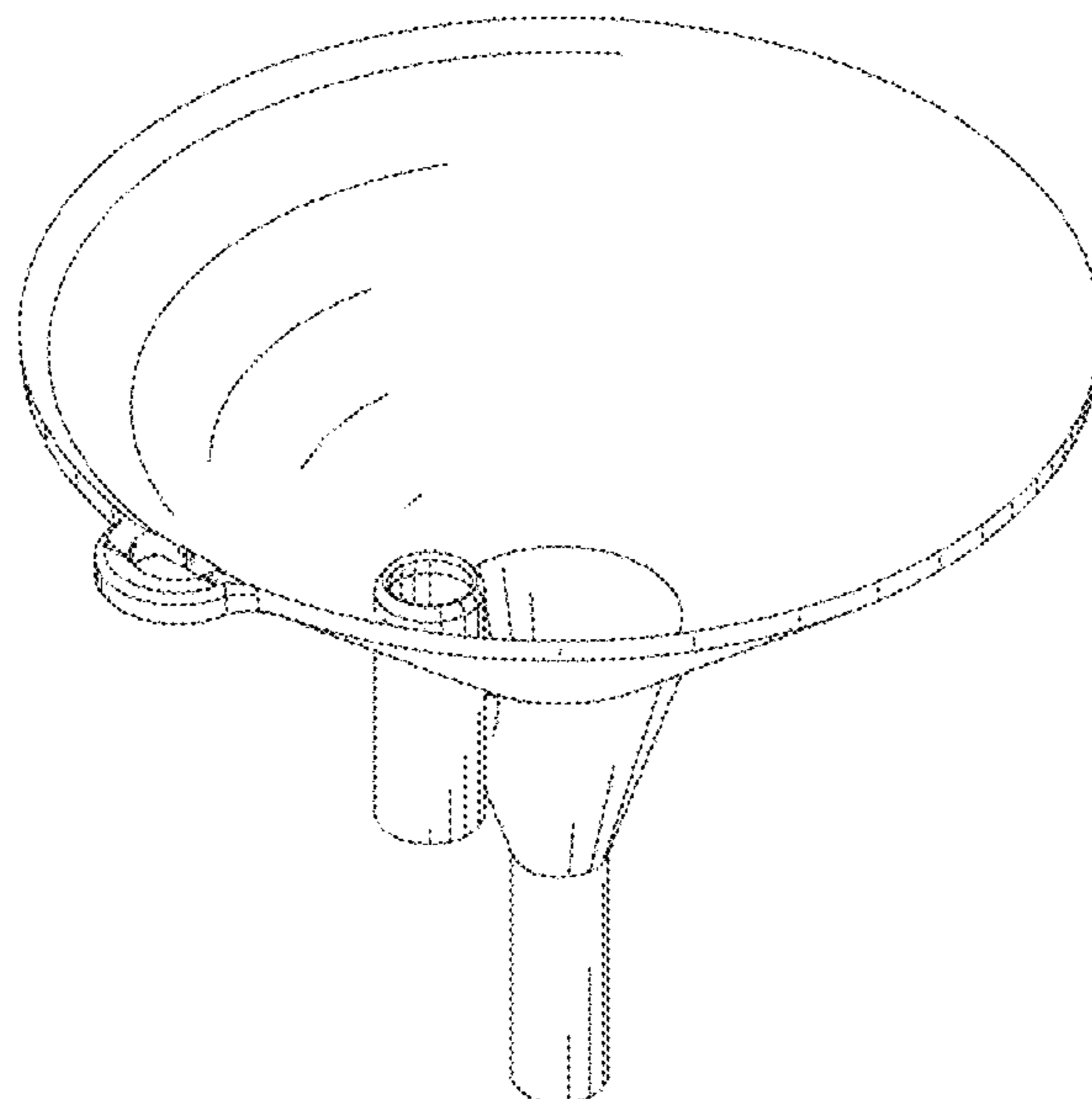
(57) **CLAIM**

The ornamental design for a oil recycle funnel for an oil filler, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an oil recycle funnel for an oil filler showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a back elevational view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

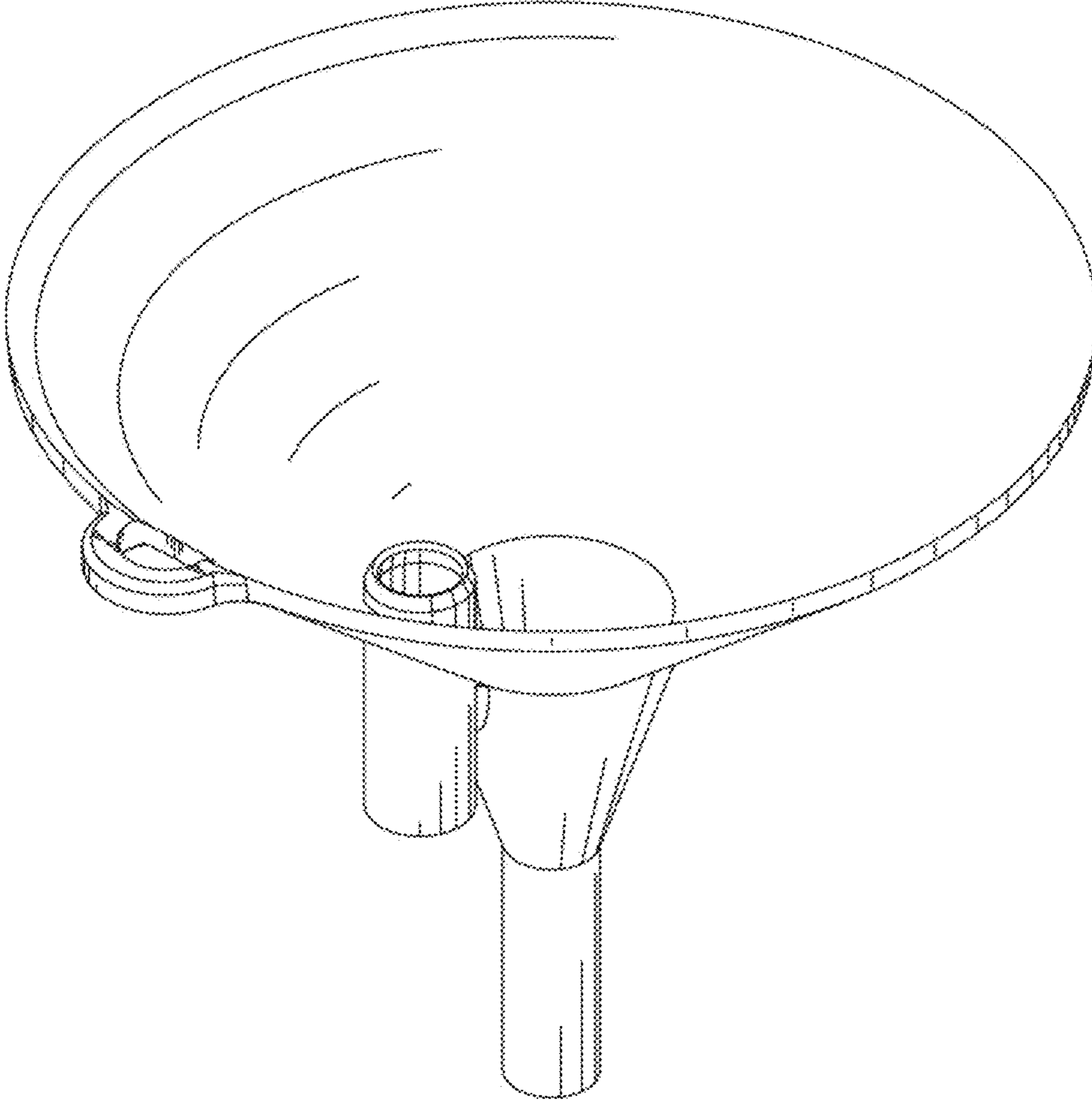

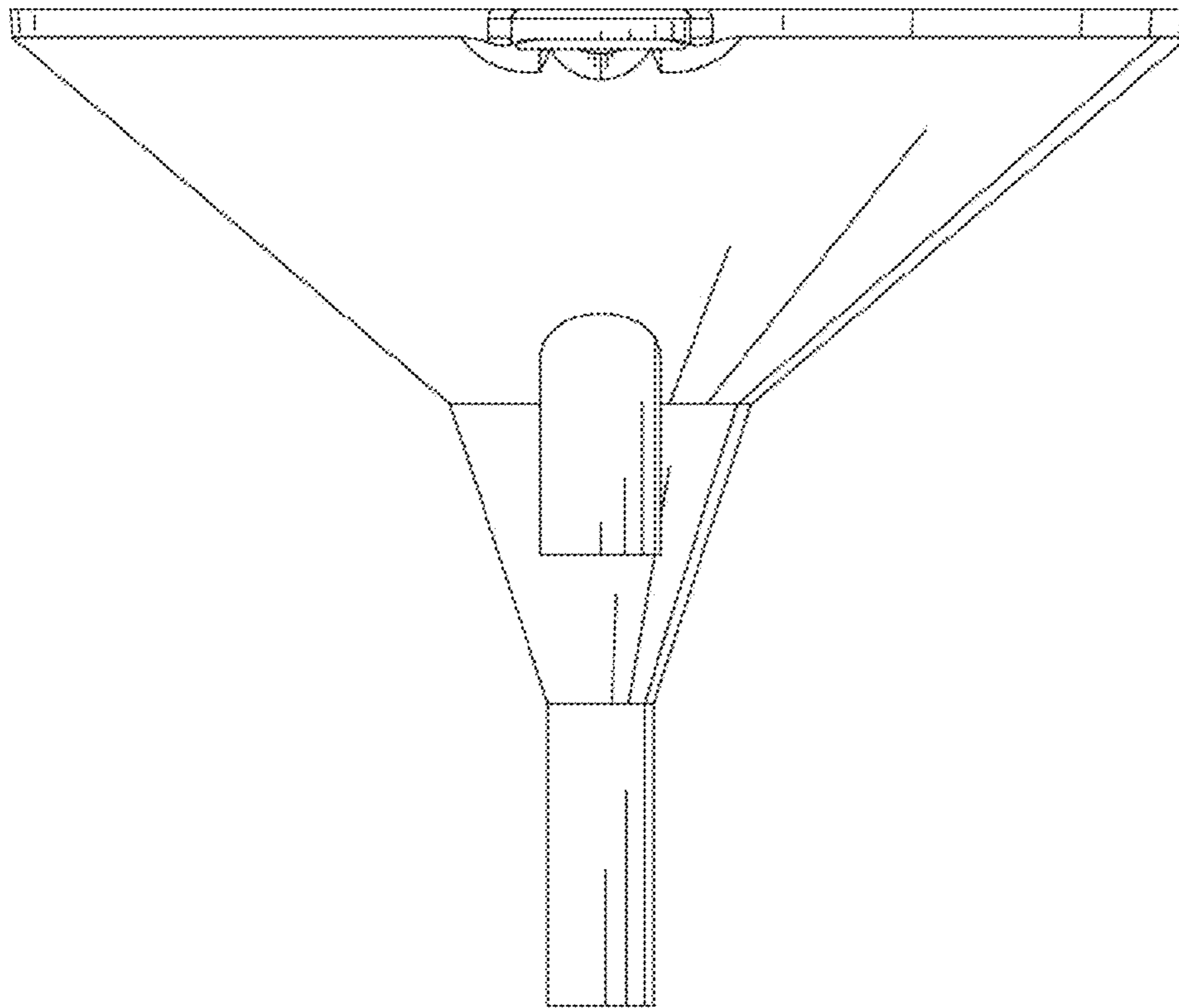

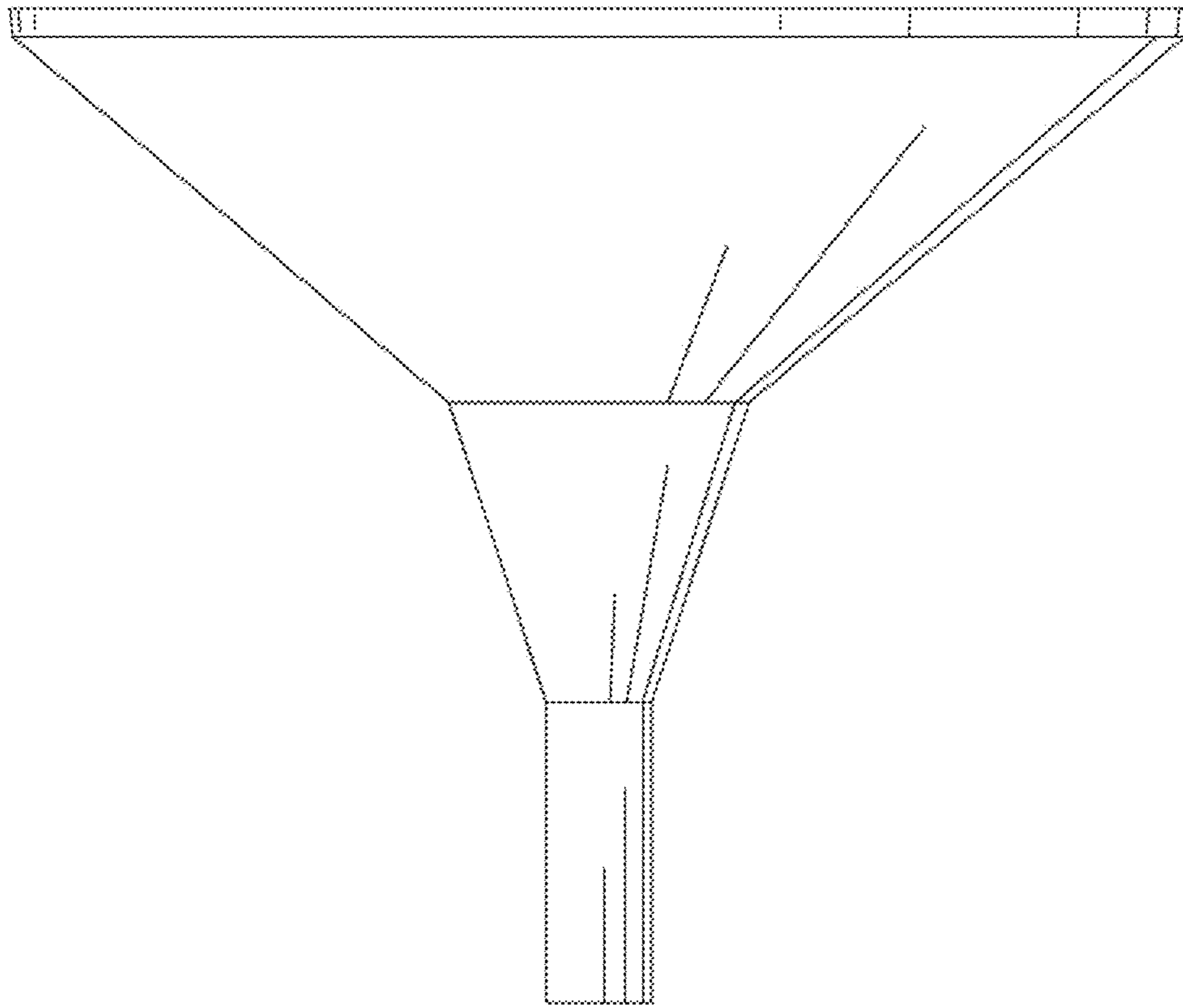

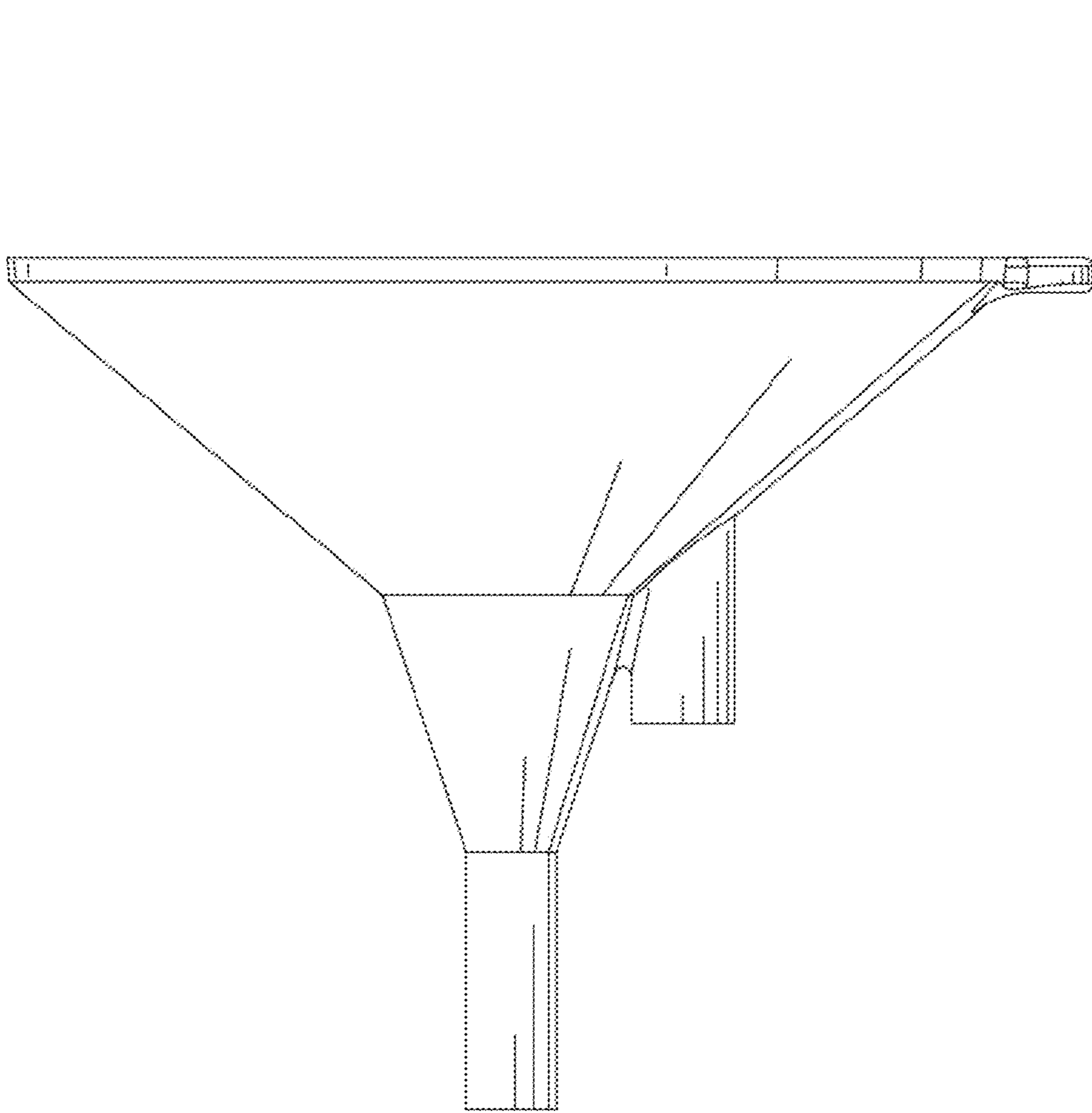

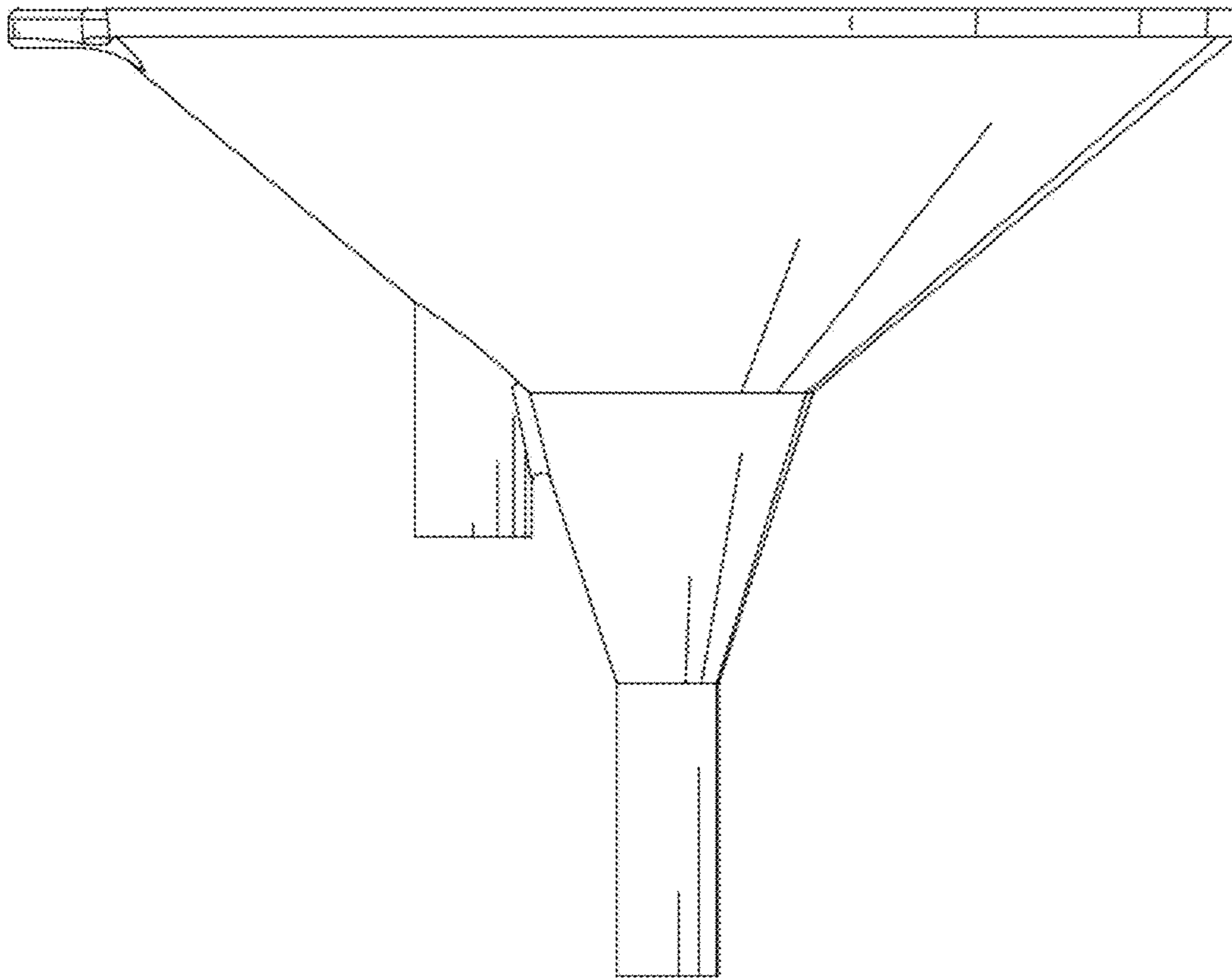

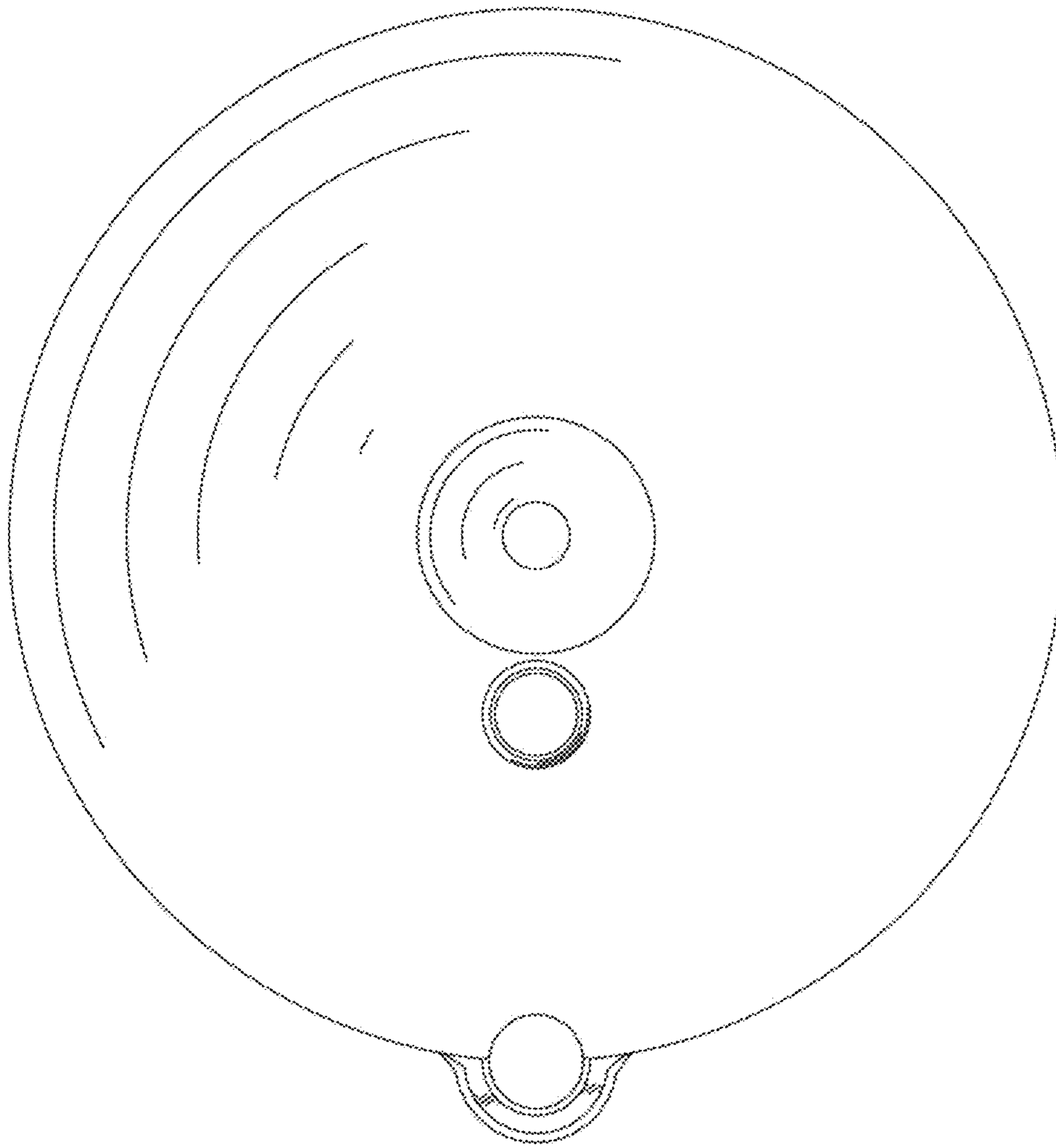

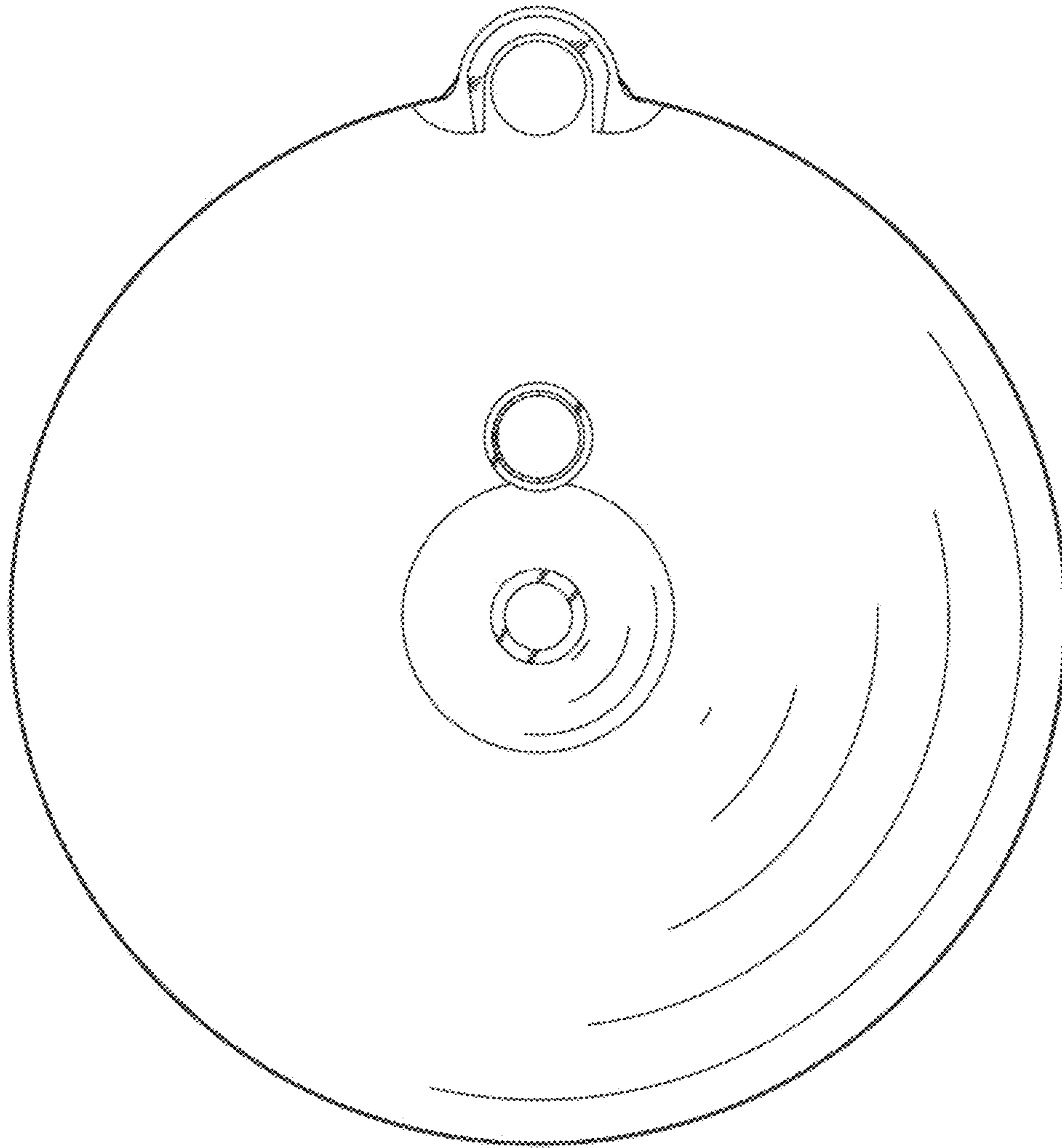
