The ornamental design for a label sheet, as shown and described.

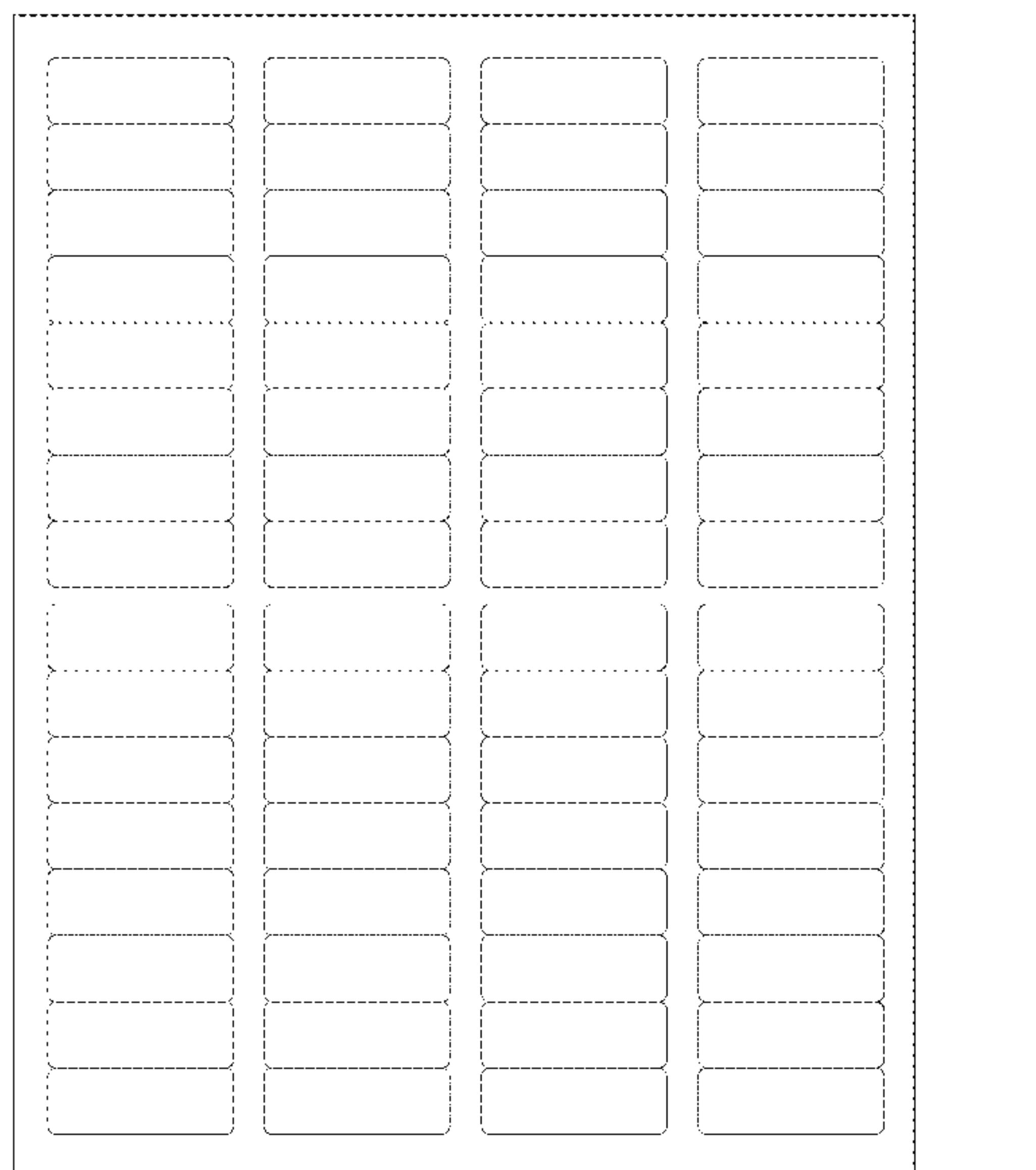
DESCRIPTION

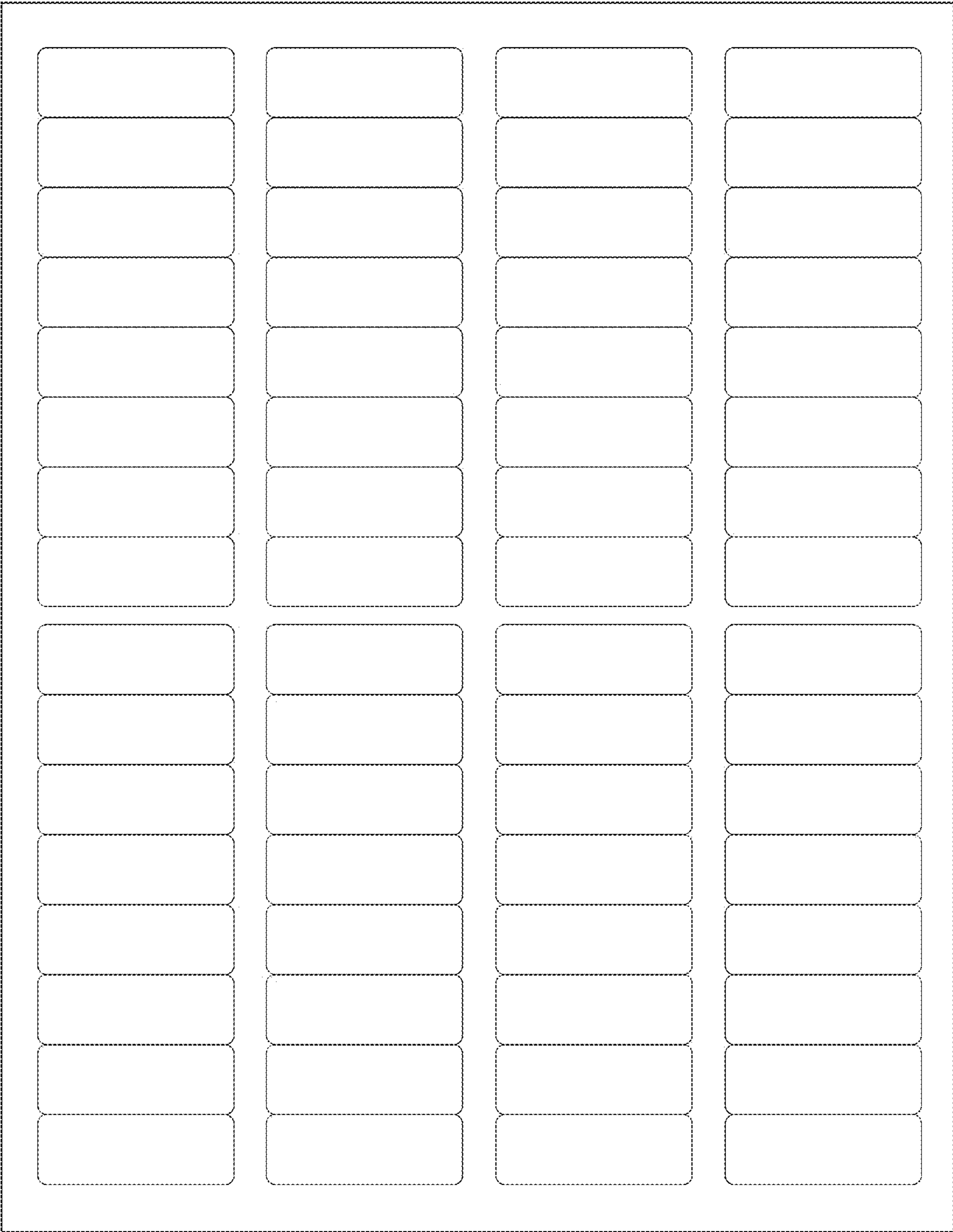

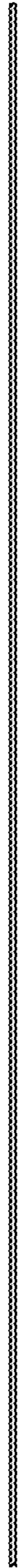

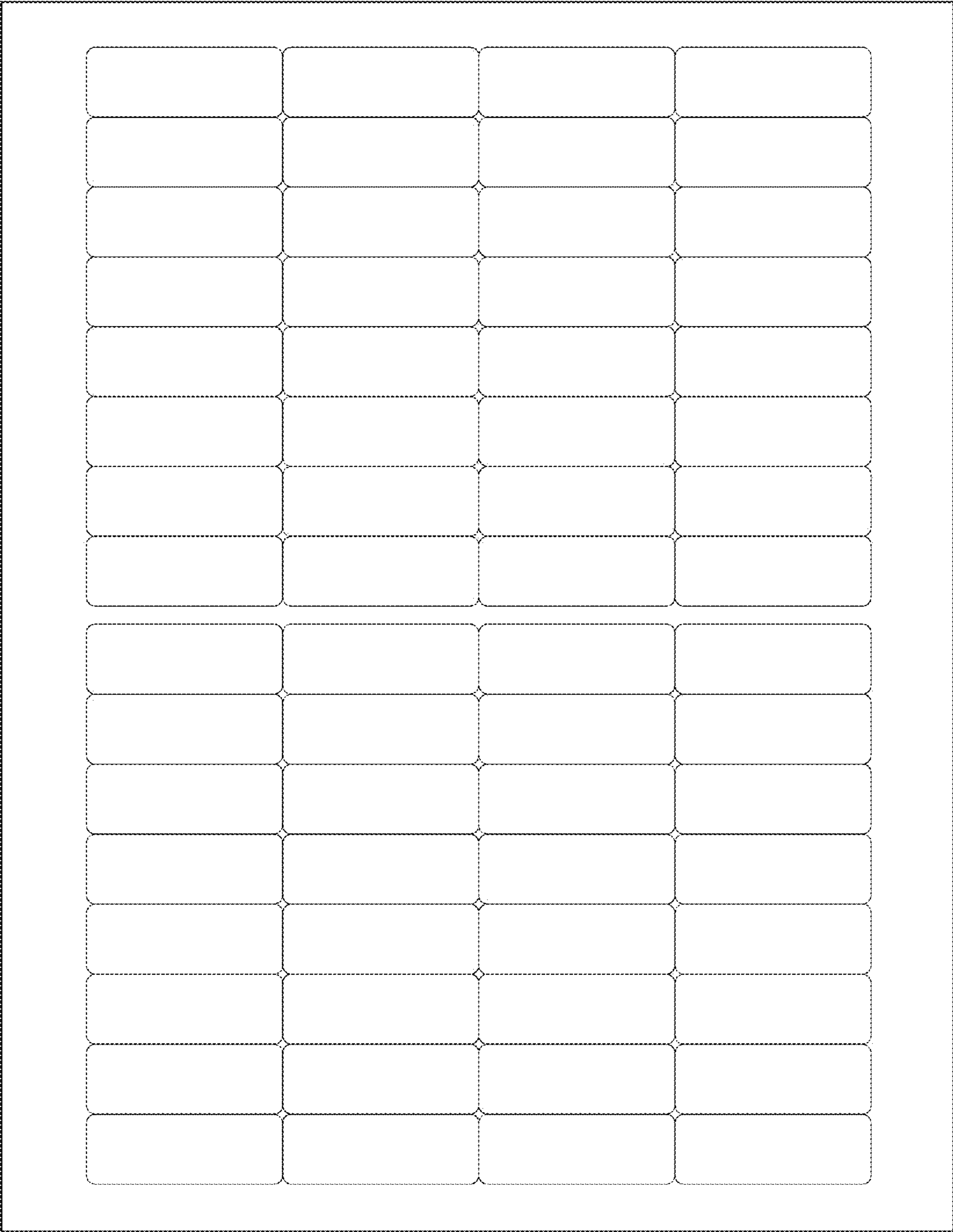

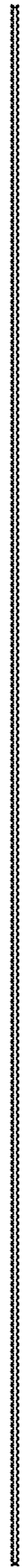
