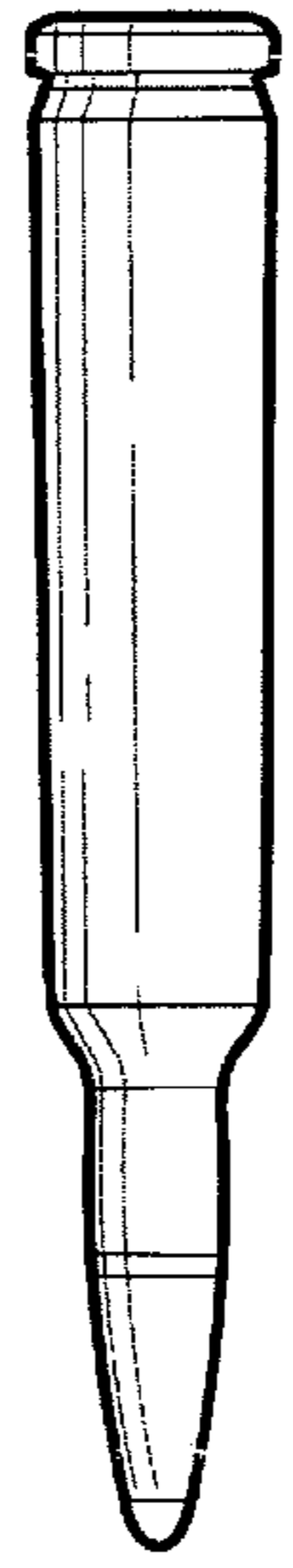

**DESCRIPTION**

FIG. 1 is a top perspective view of a golf tee showing my new design;

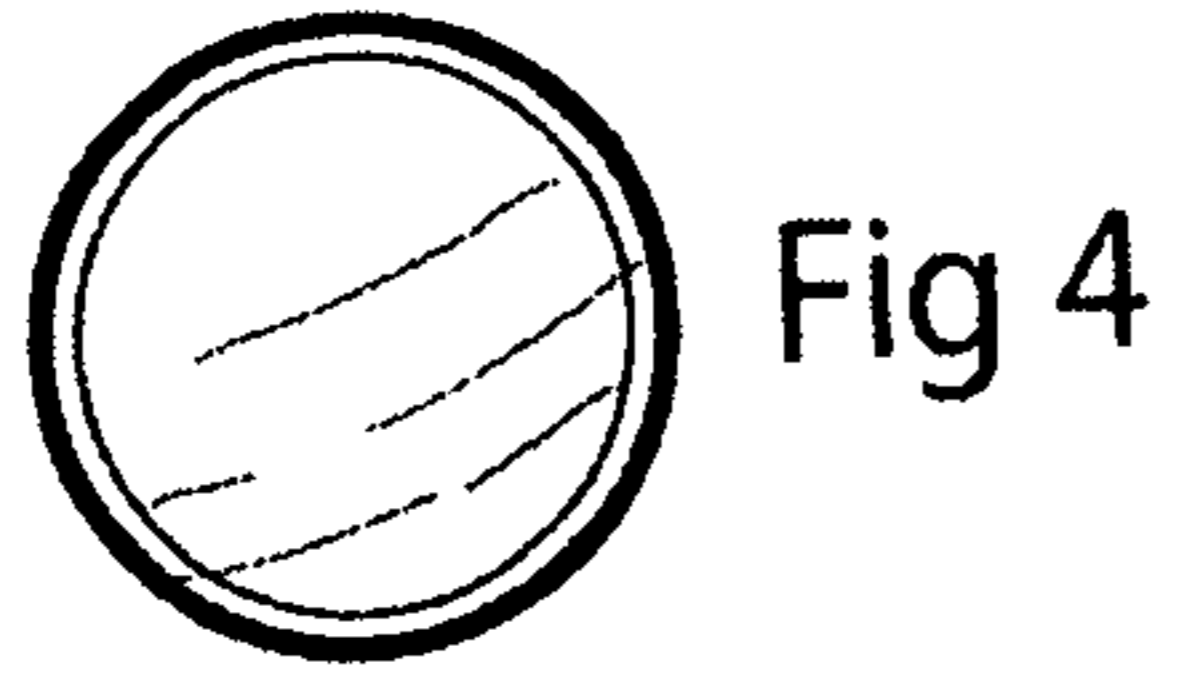

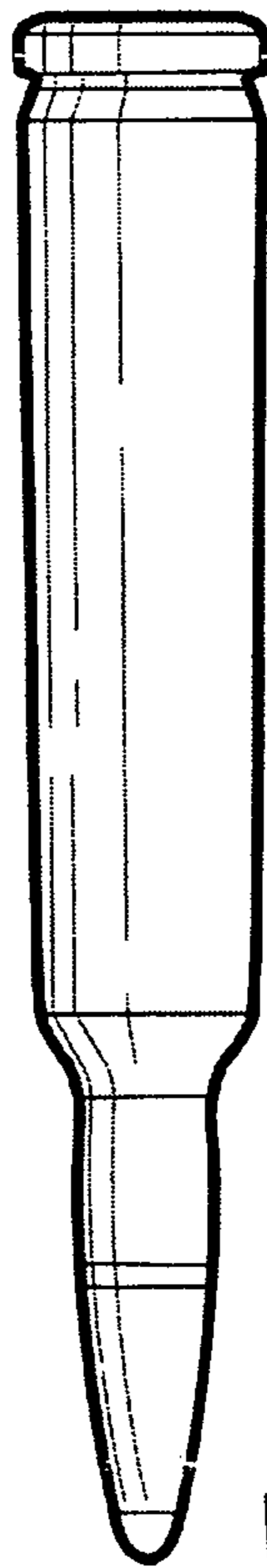

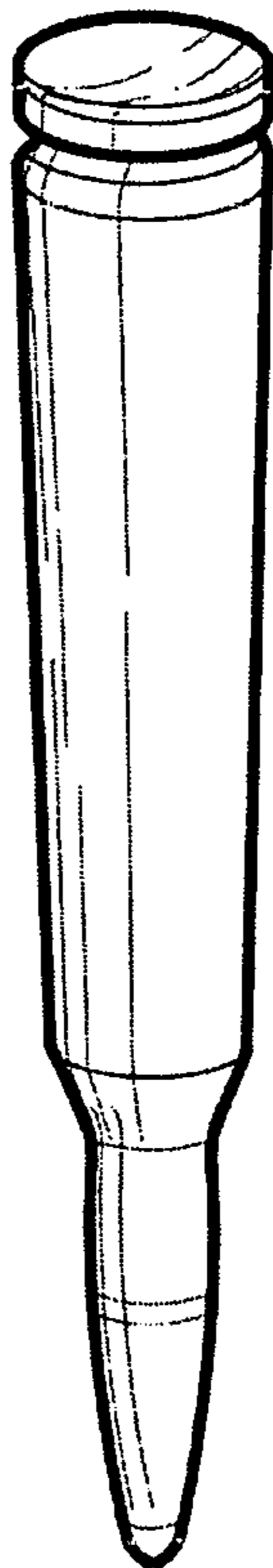

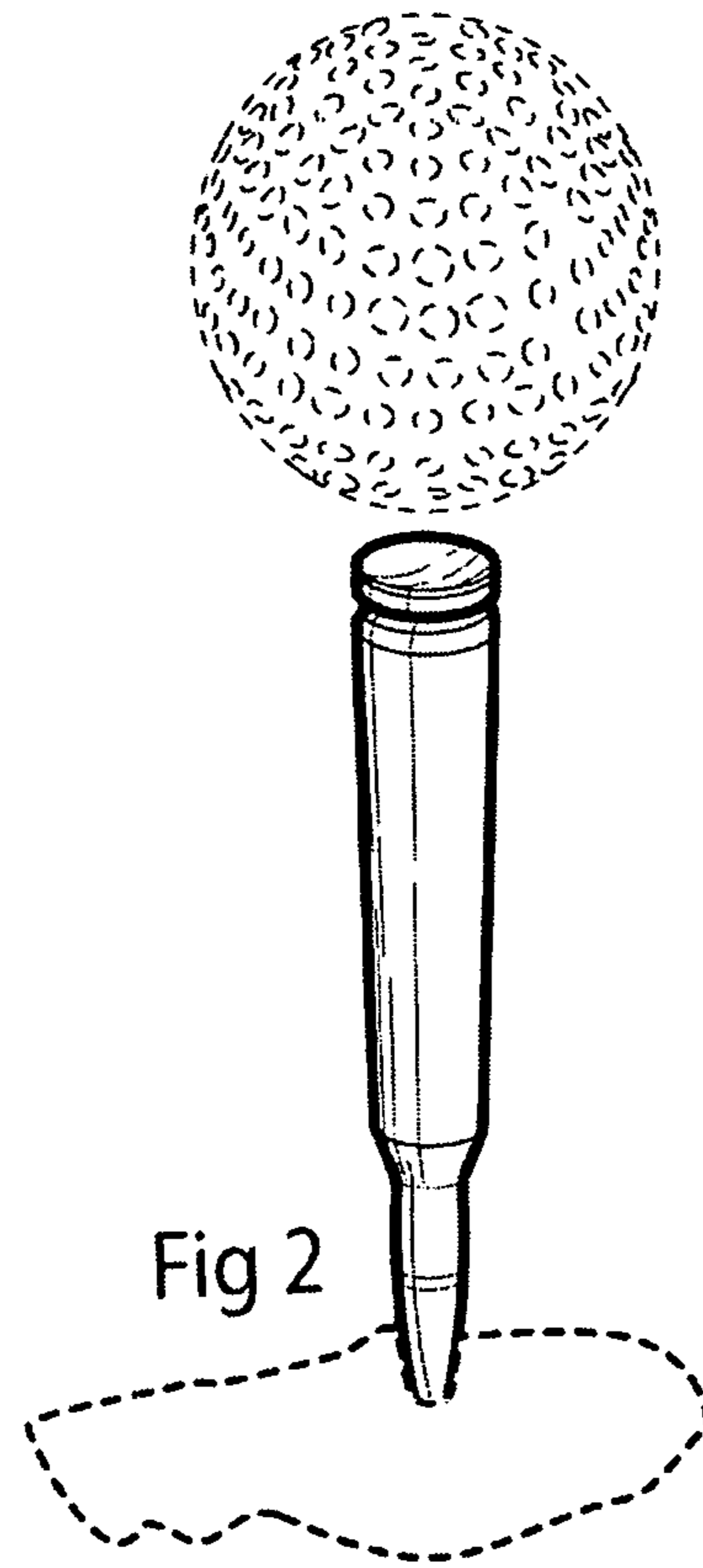
