(57) **CLAIM**

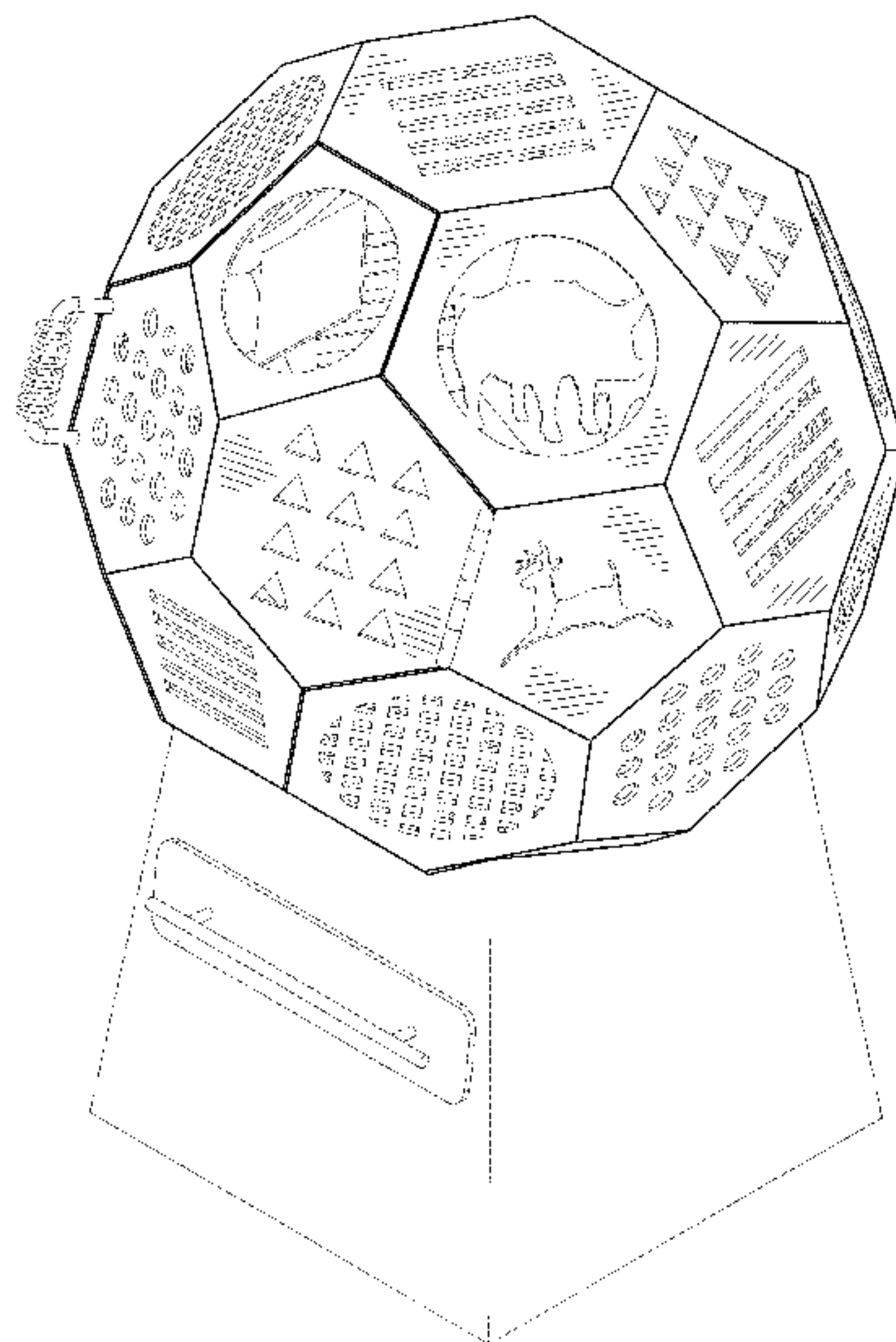
The ornamental design for fire ball, as shown and described.

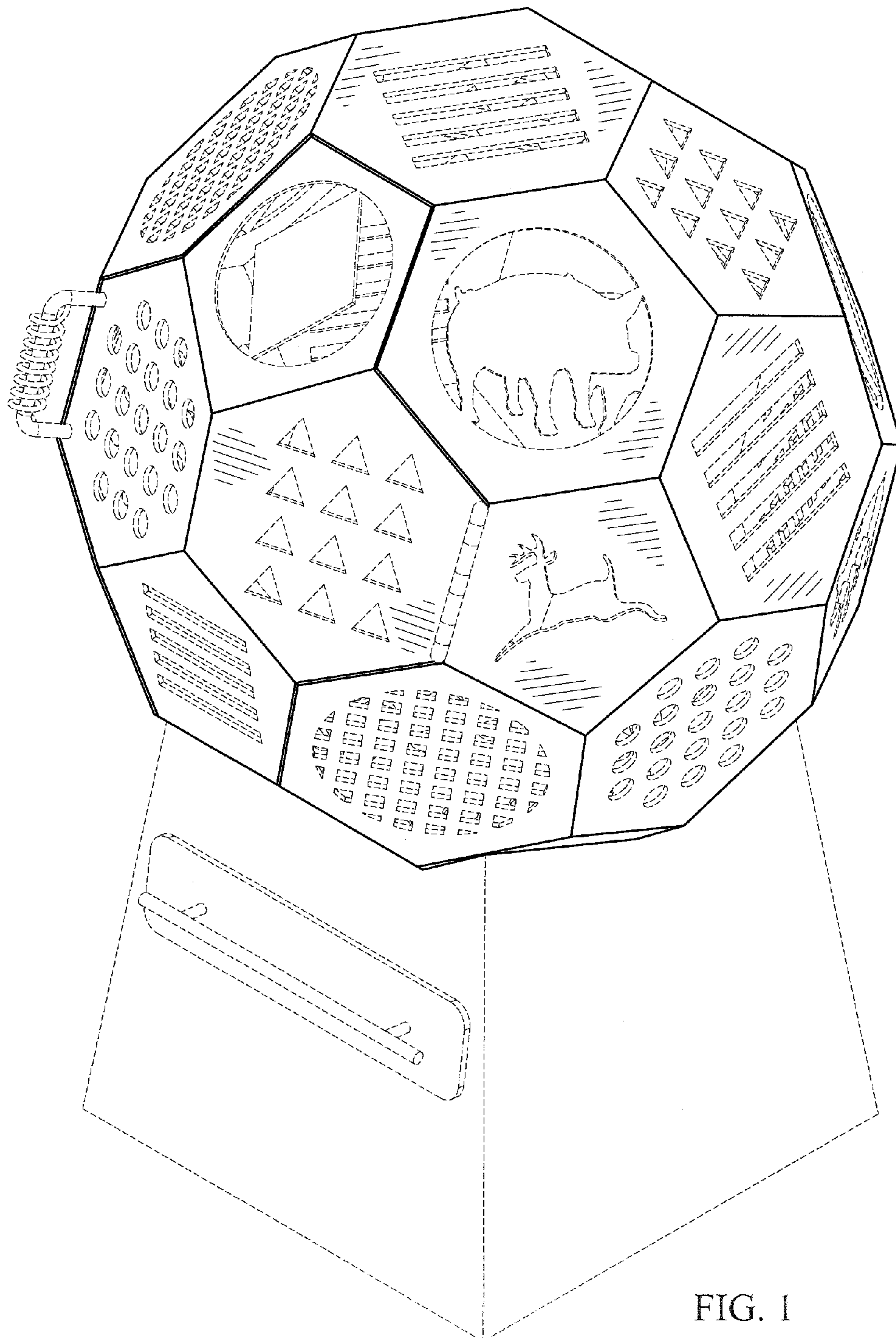
DESCRIPTION

FIG. 1 is a perspective view of the fire ball, with the top and multiple sides shown, showing my new design;
FIG. 2 is a perspective view of the fire ball, with the bottom and multiple sides shown;
FIG. 3 is a top plan view of the fire ball;
FIG. 4 is a bottom plan view of the fire ball;
FIG. 5 is a side view of the fire ball, which is identical to the other side which is parallel thereto;
FIG. 6 is a side view of the longer side of the fire ball, which is identical to the other side which is parallel thereto;
FIG. 7 is a rear view of the fire ball; and,
FIG. 8 is a front view of the fire ball.

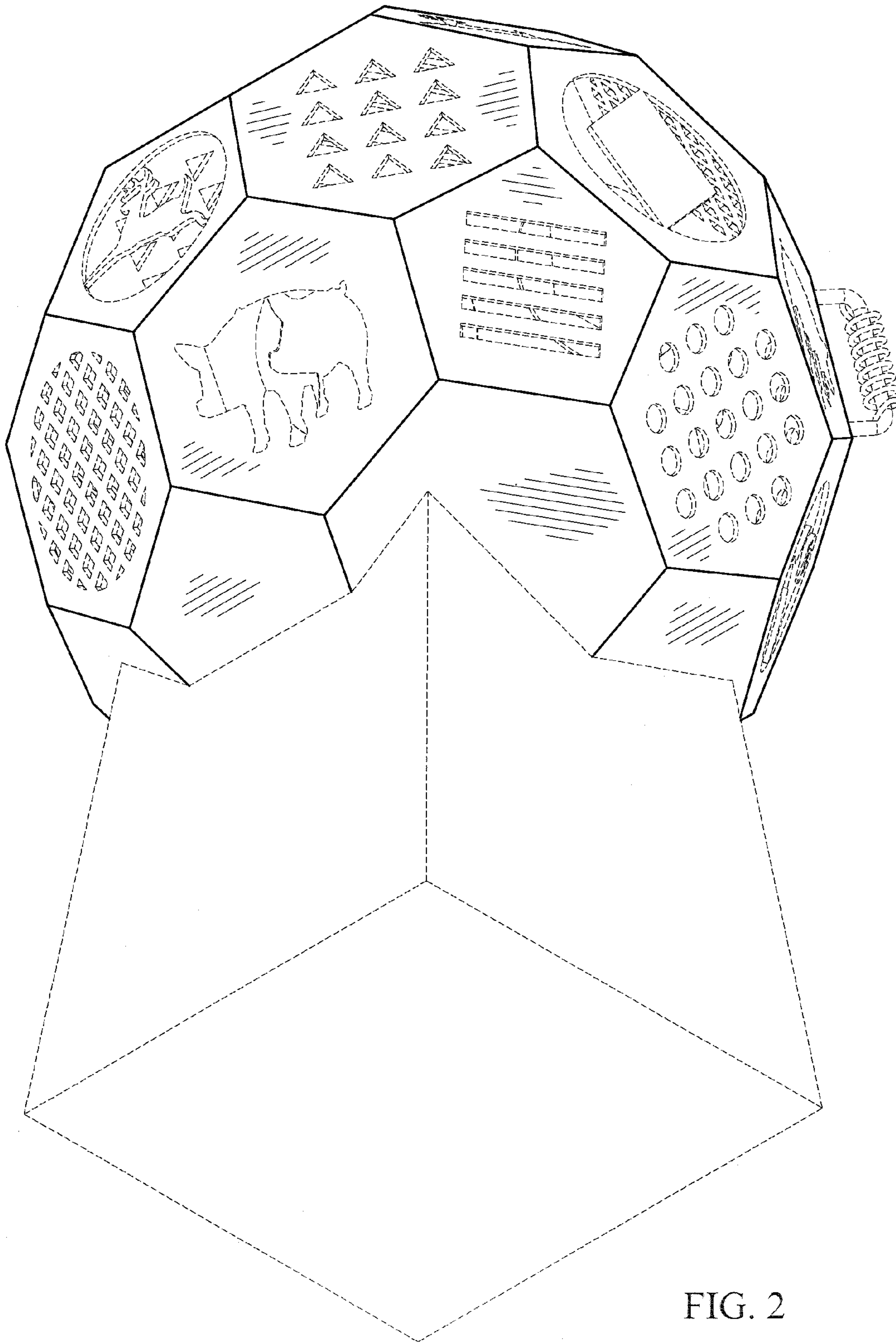

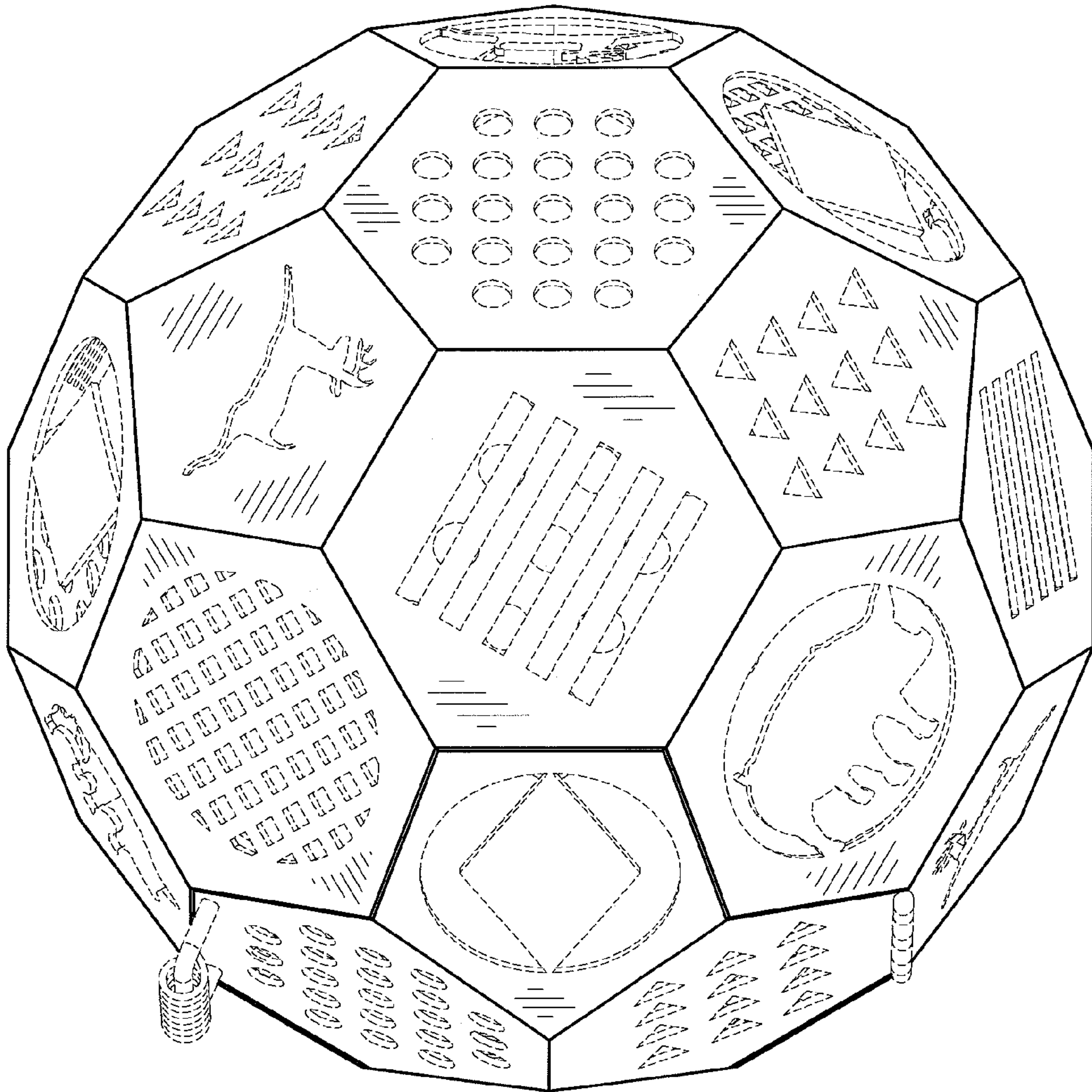

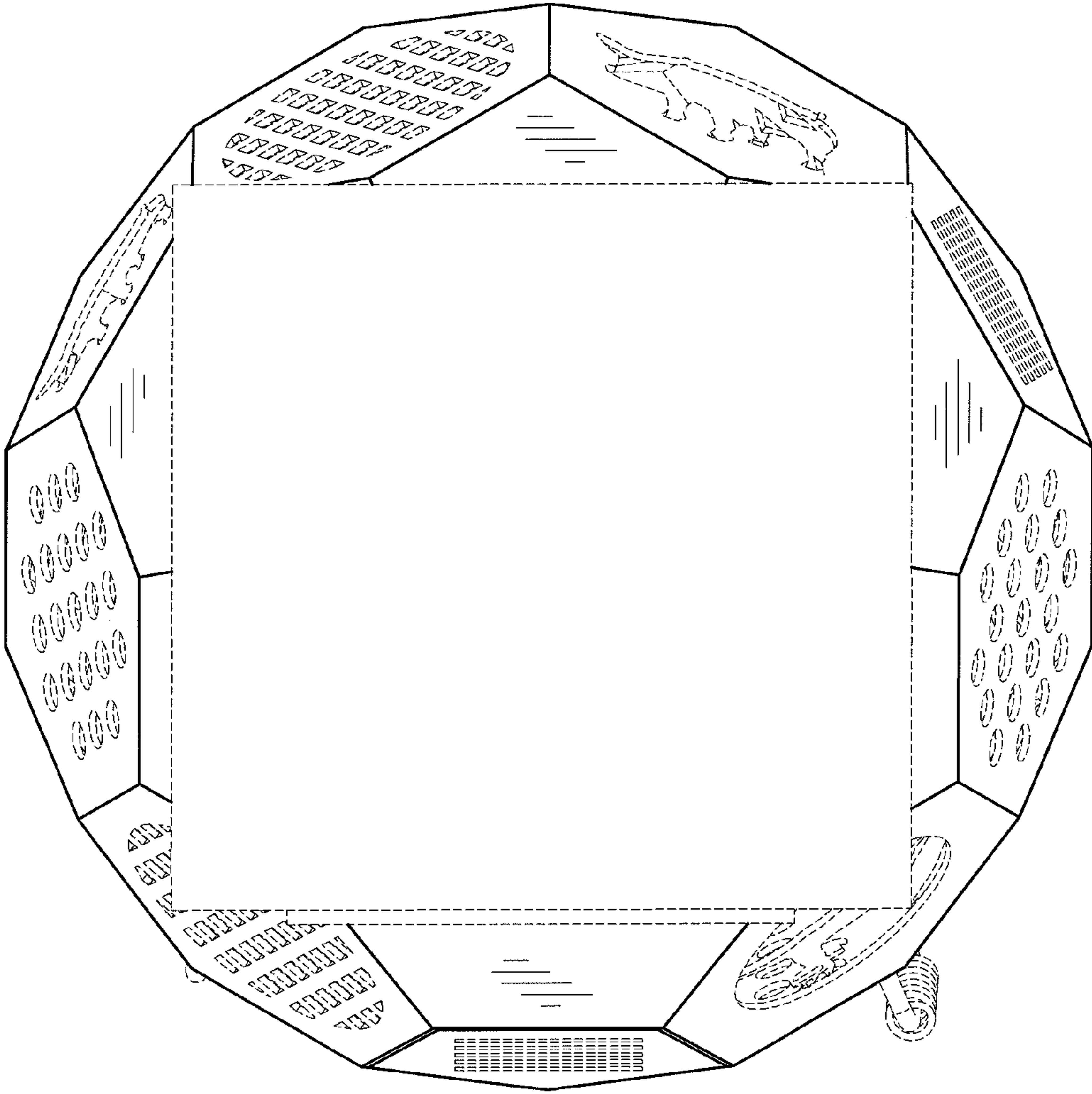

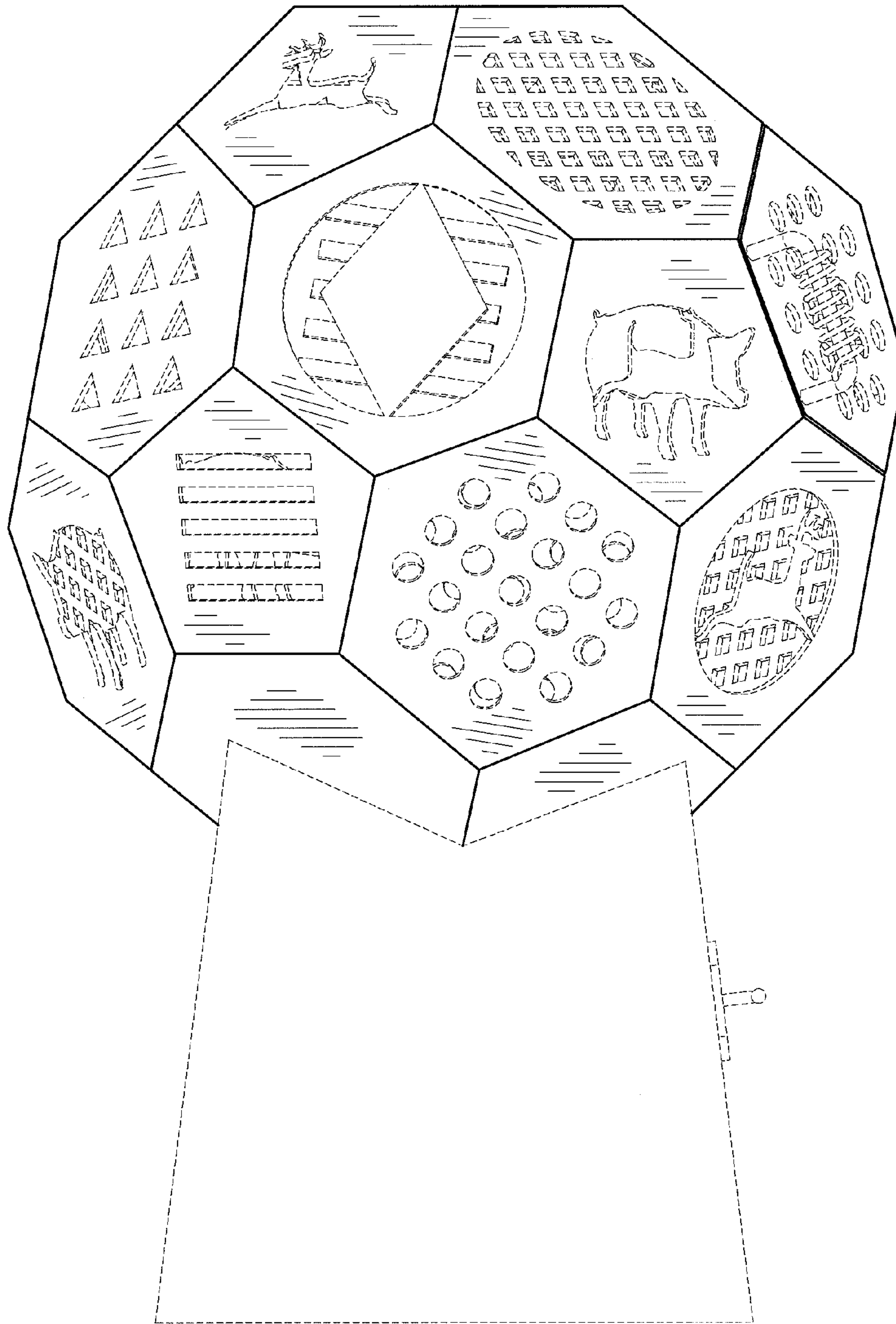

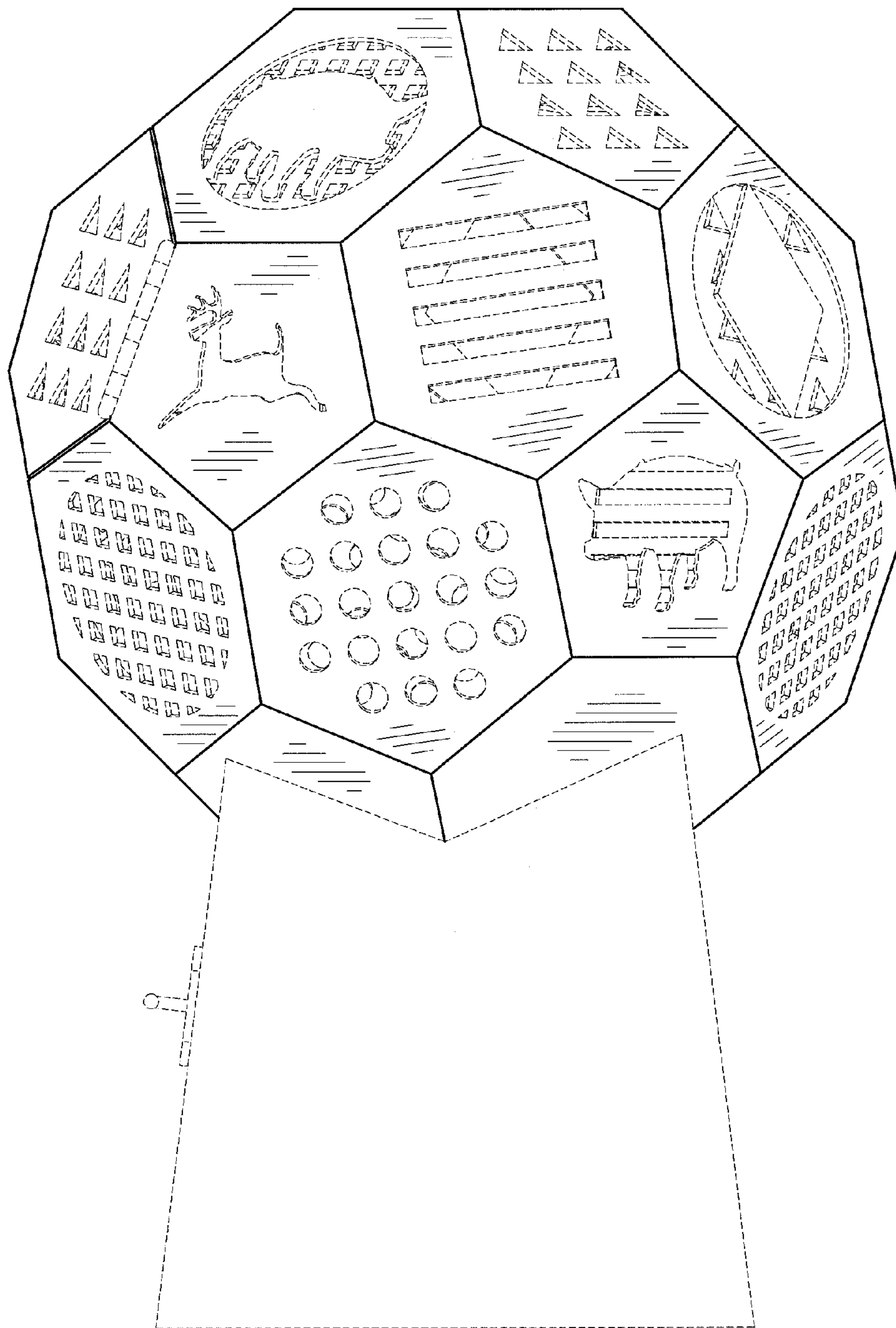

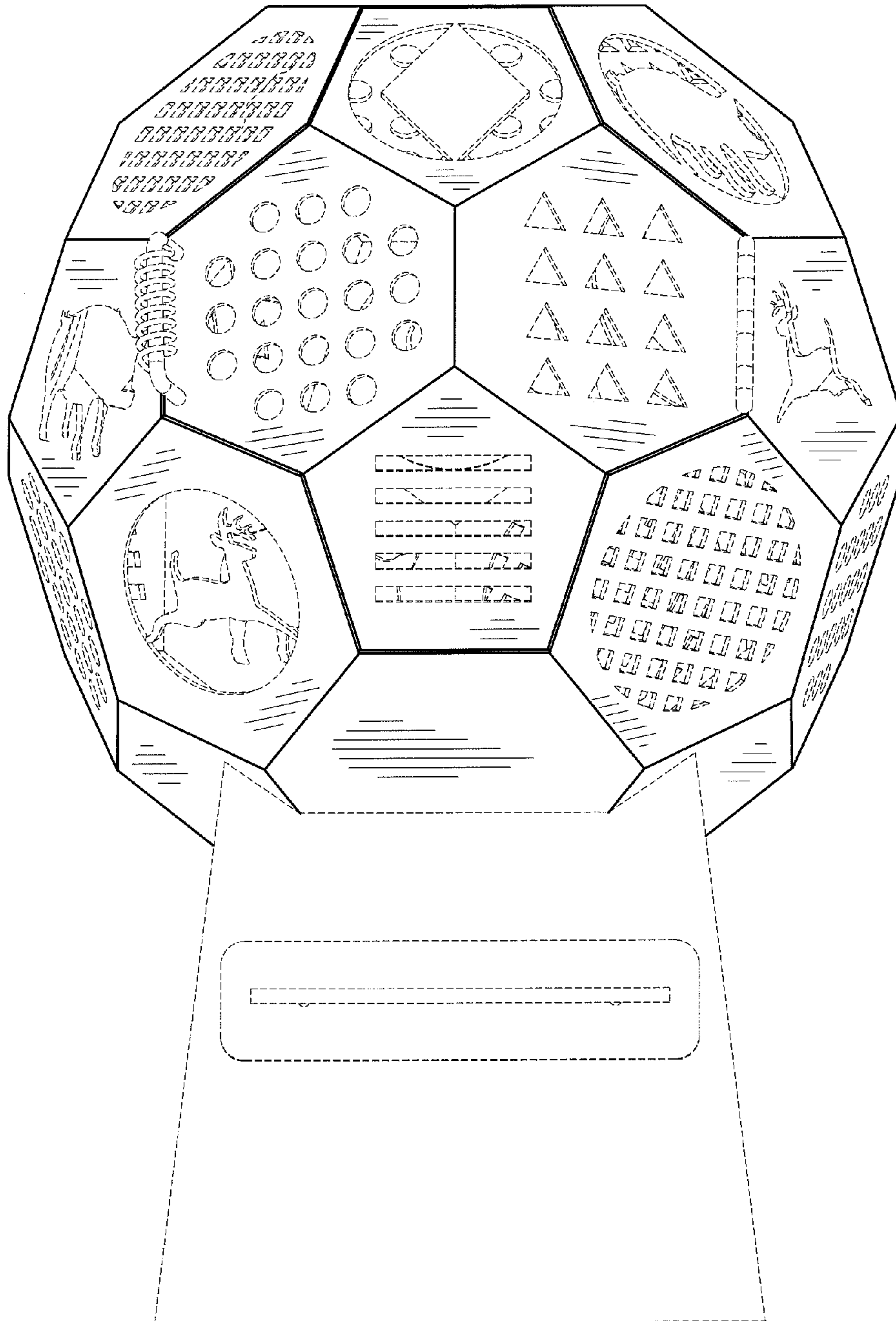

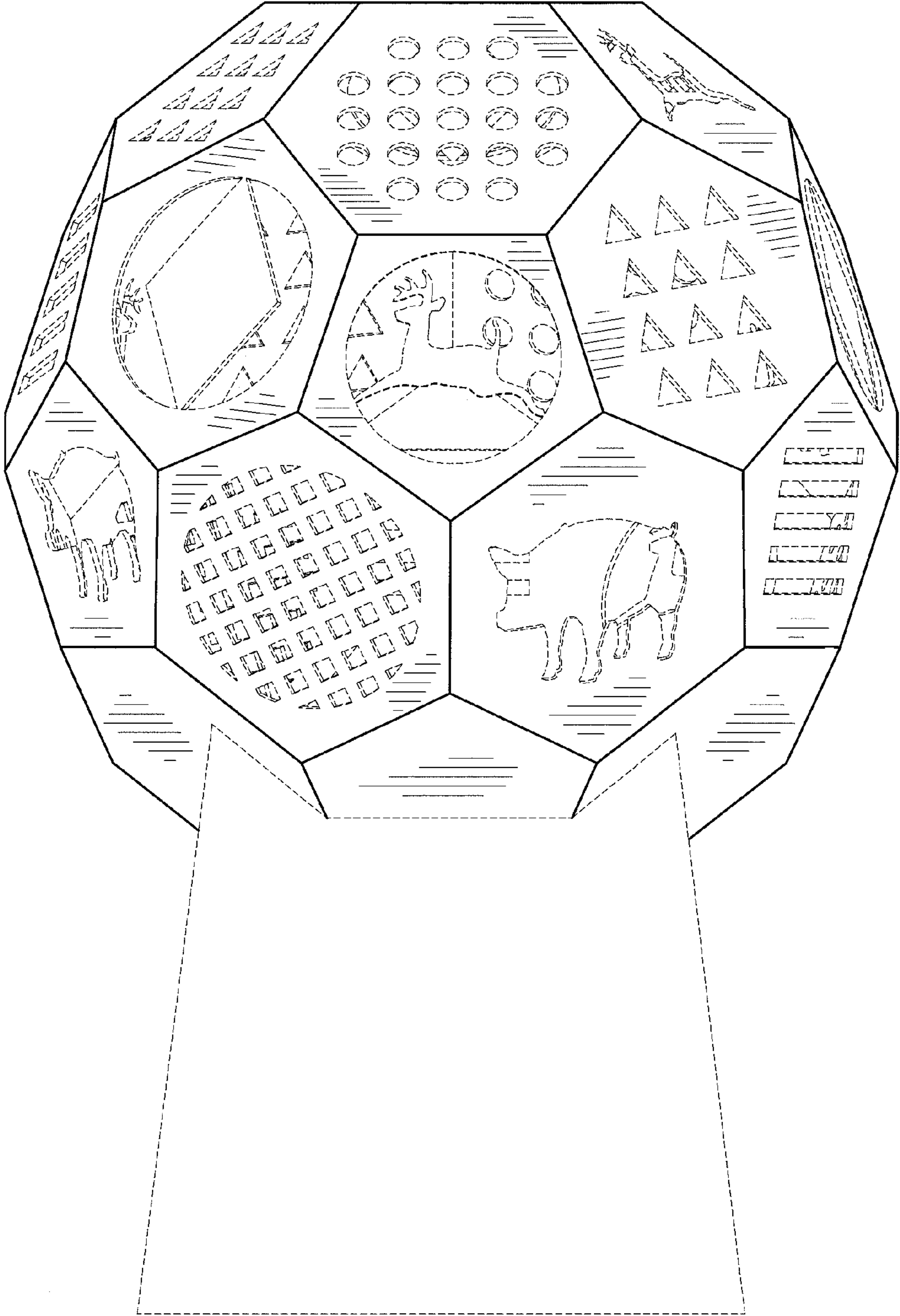
