I claim the ornamental design for a textured prophylactic, as shown and described.

**DESCRIPTION**

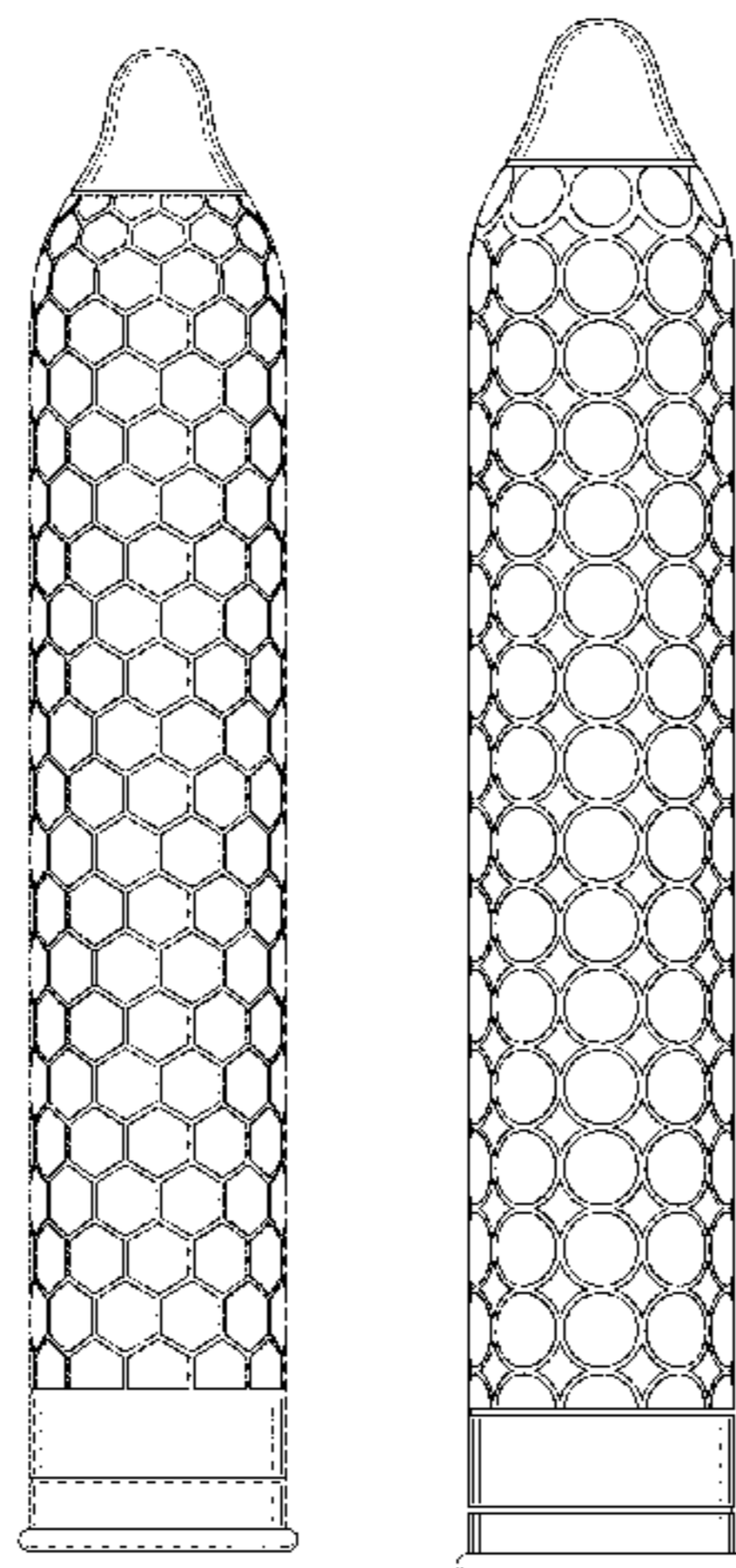

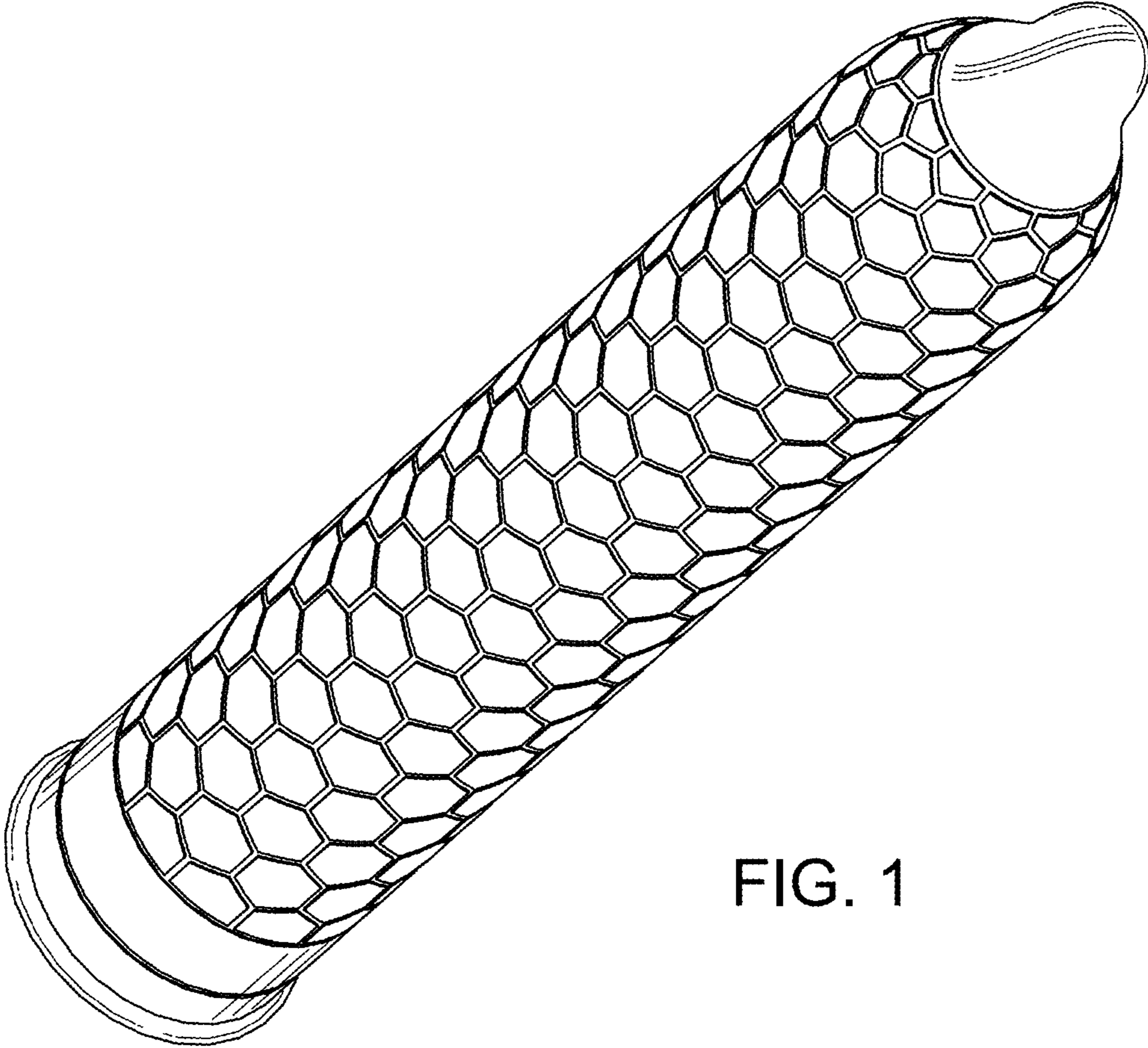

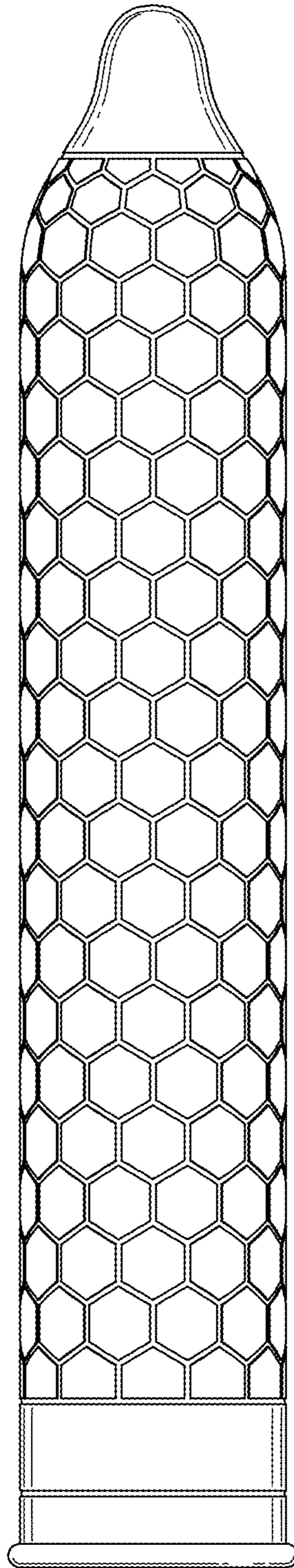

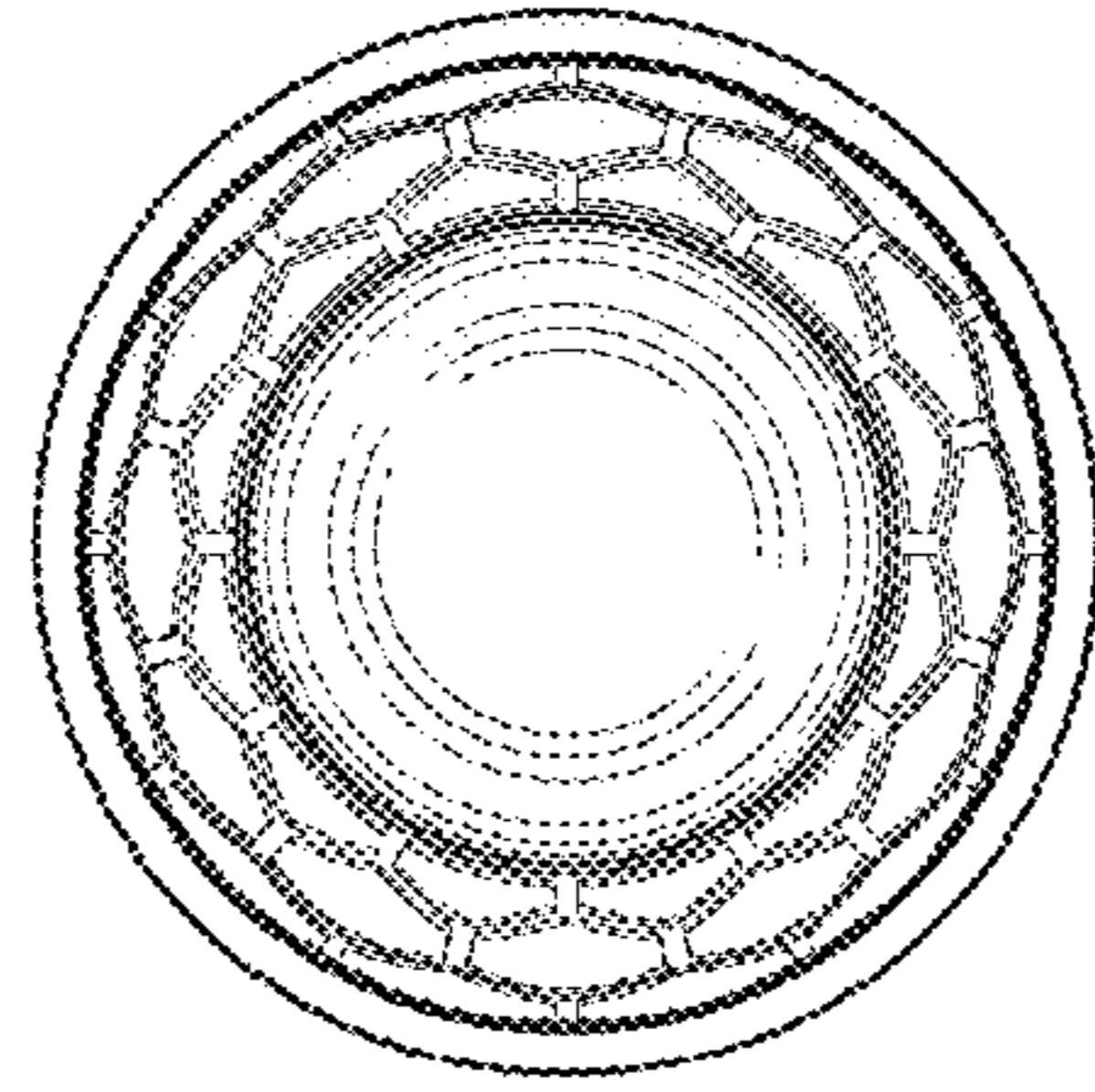

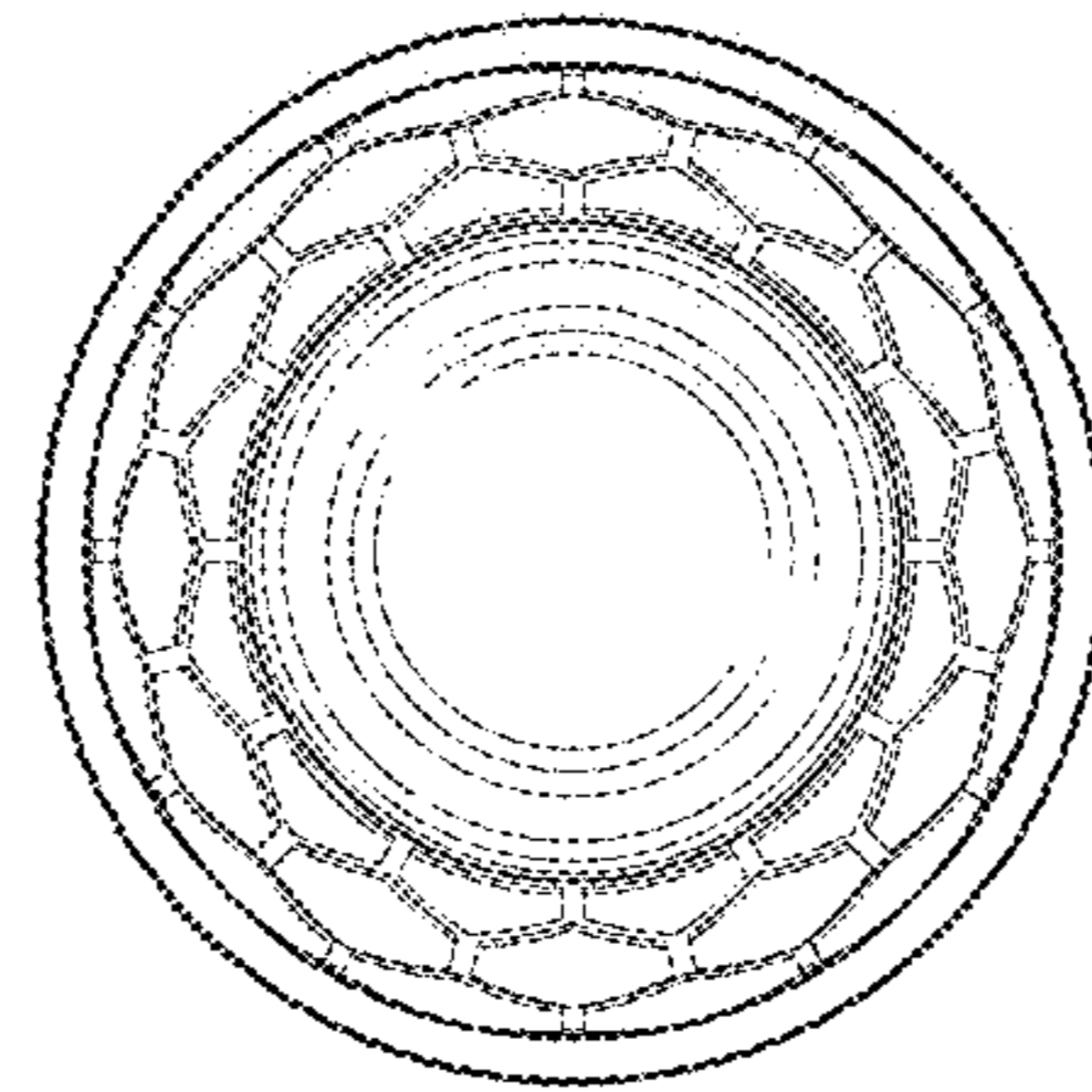

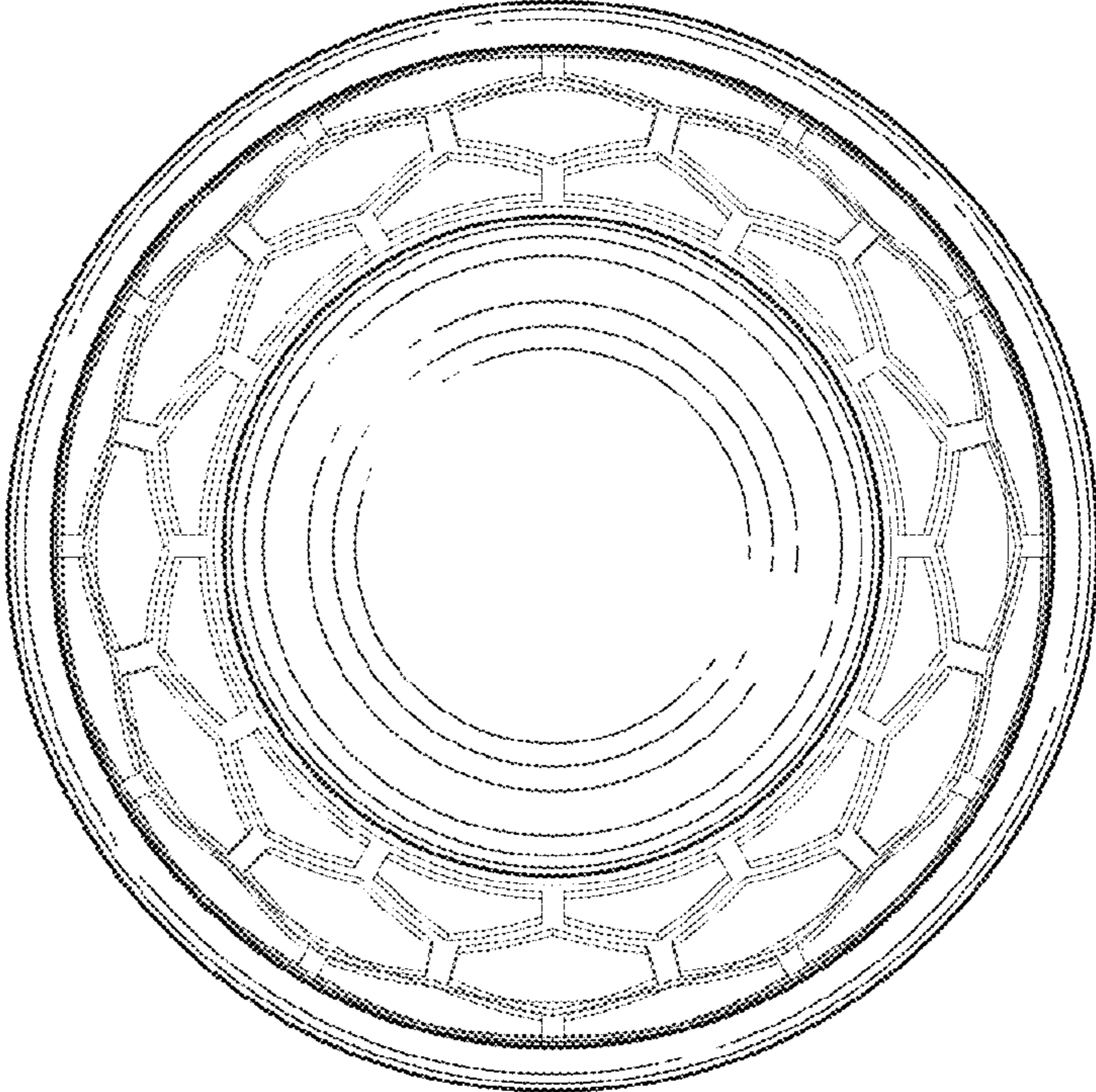

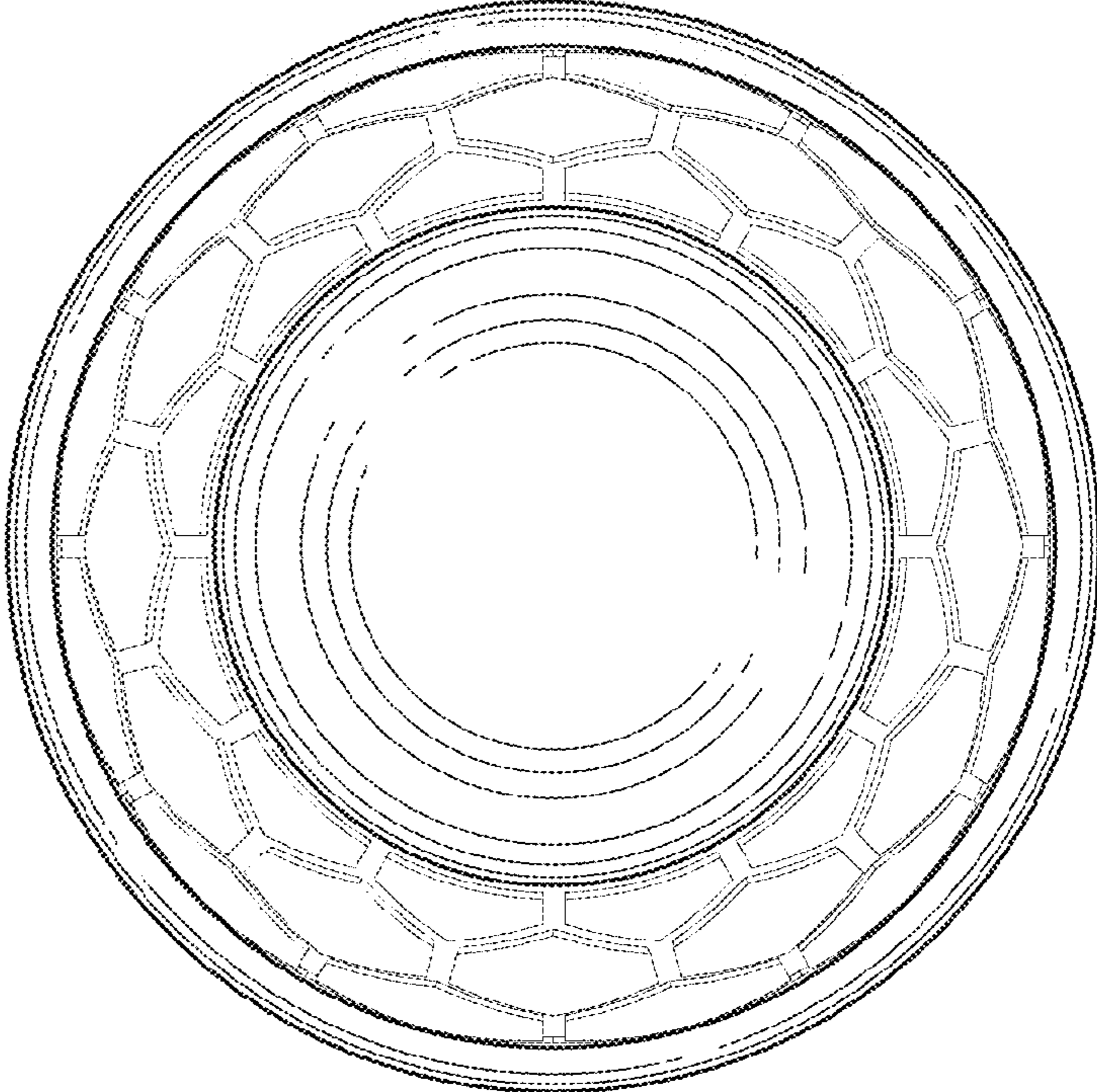

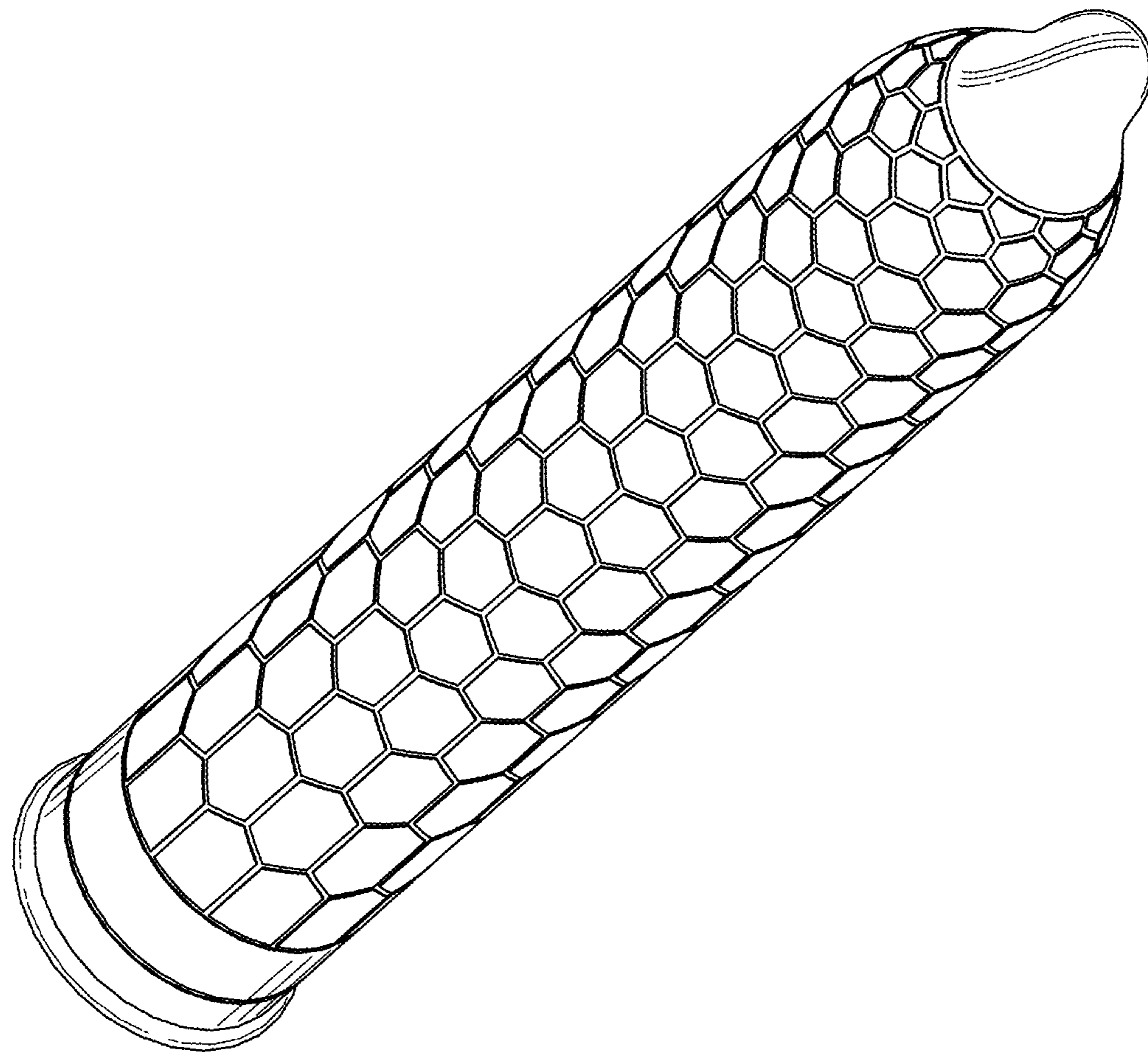

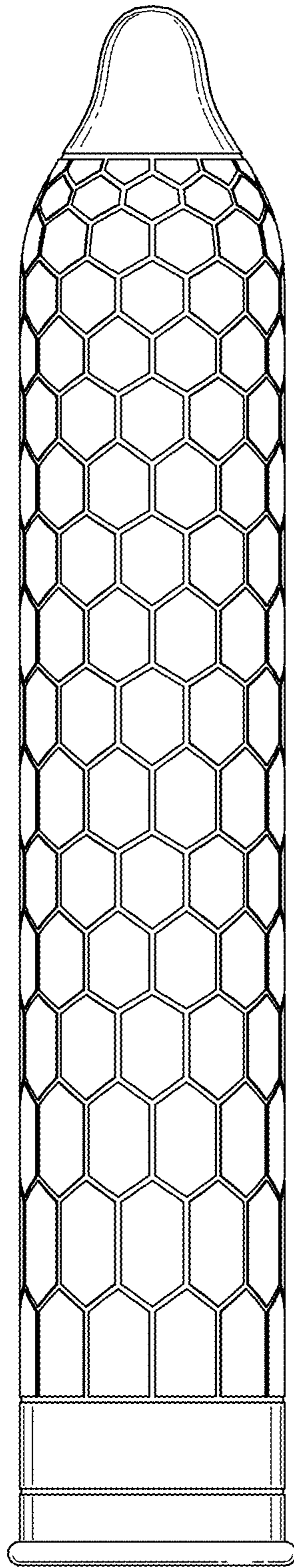

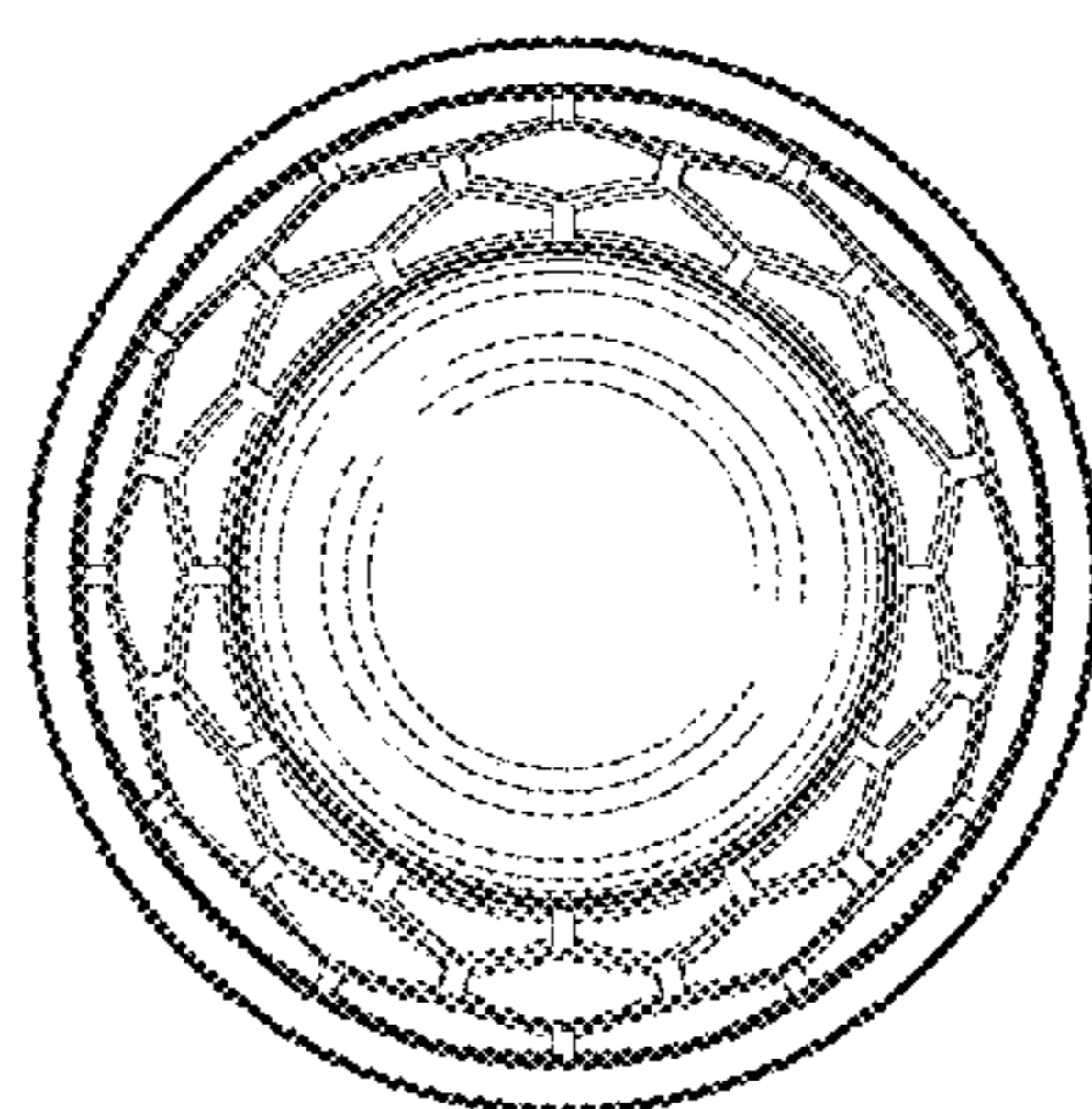

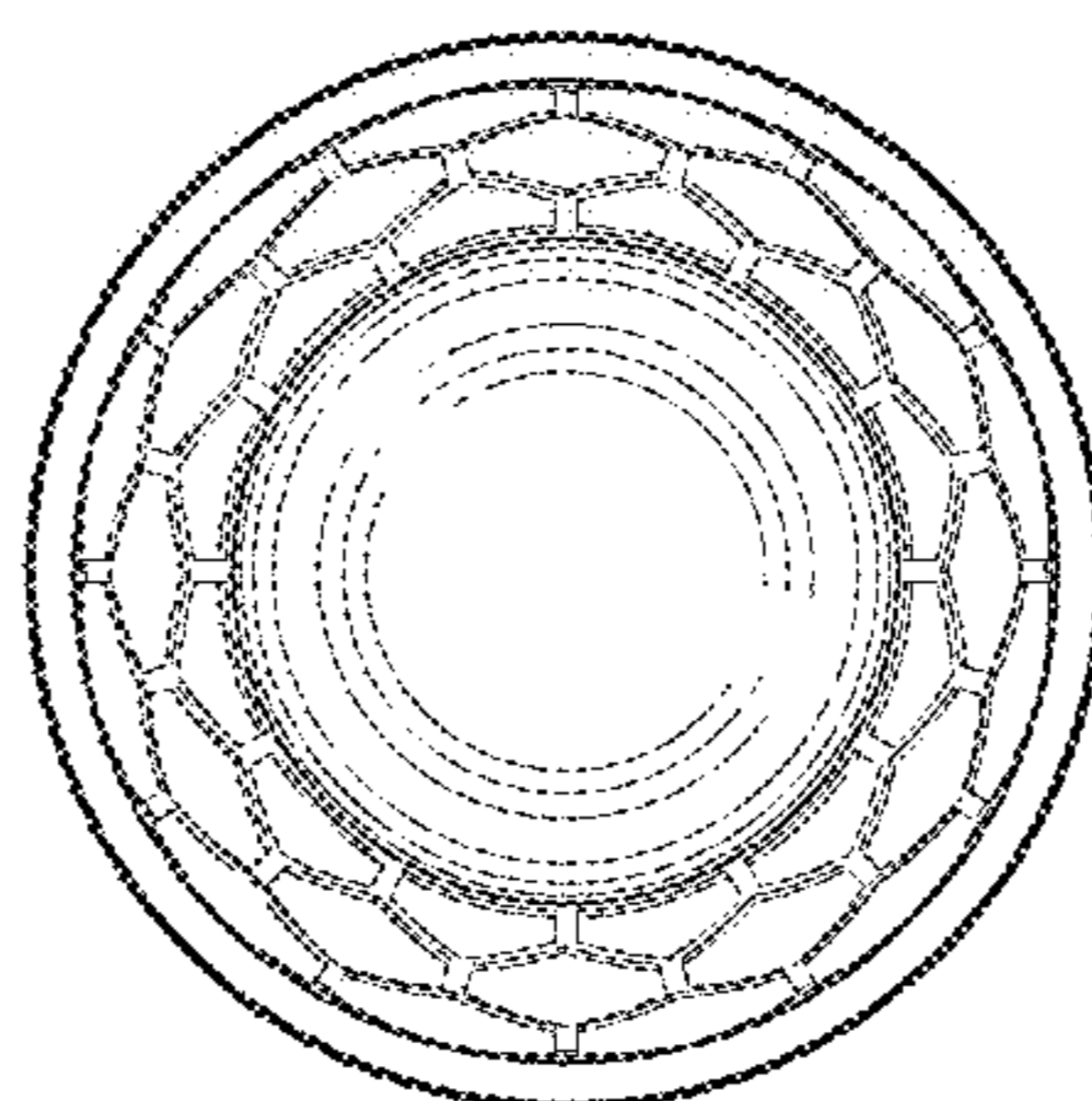

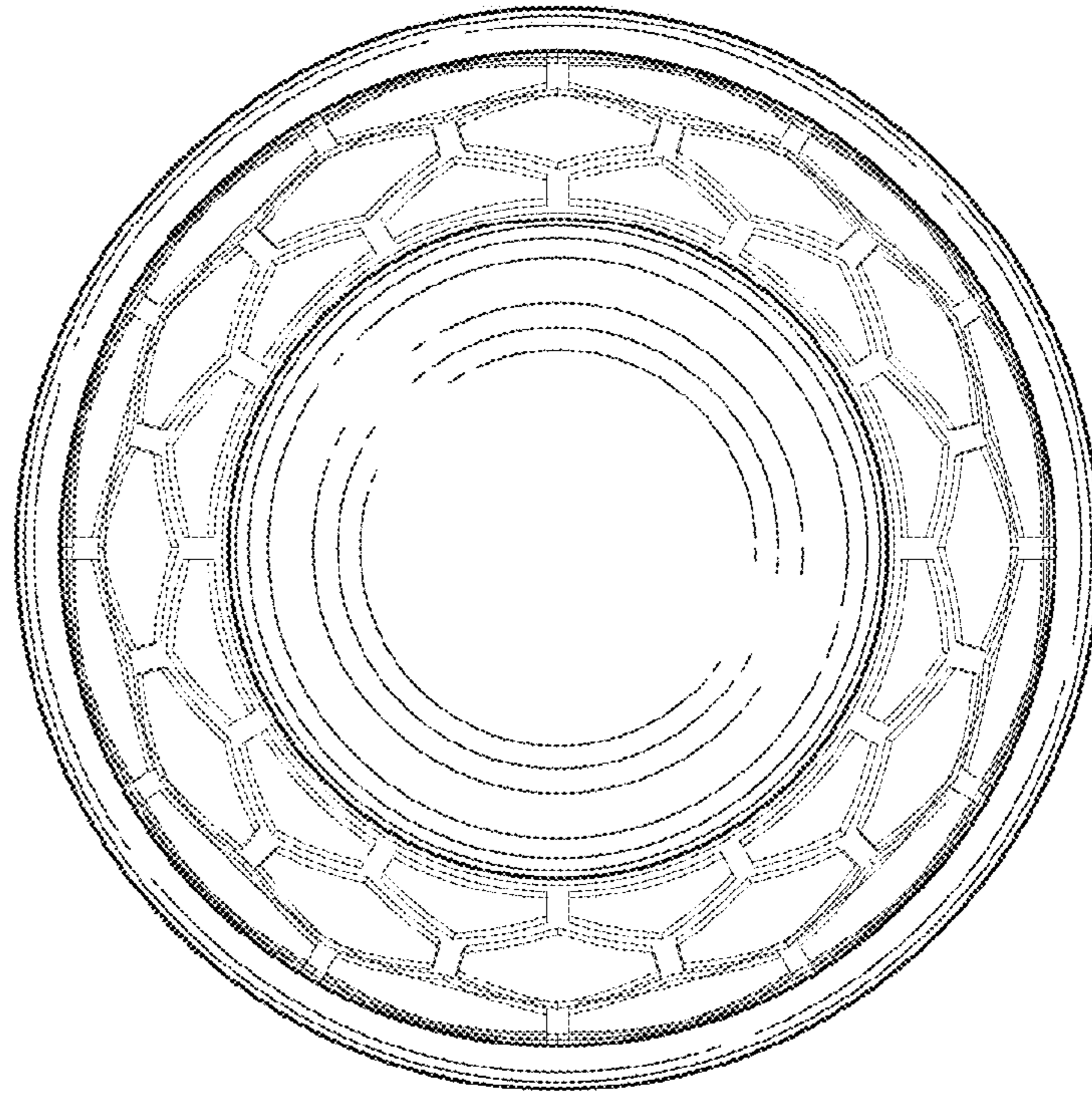

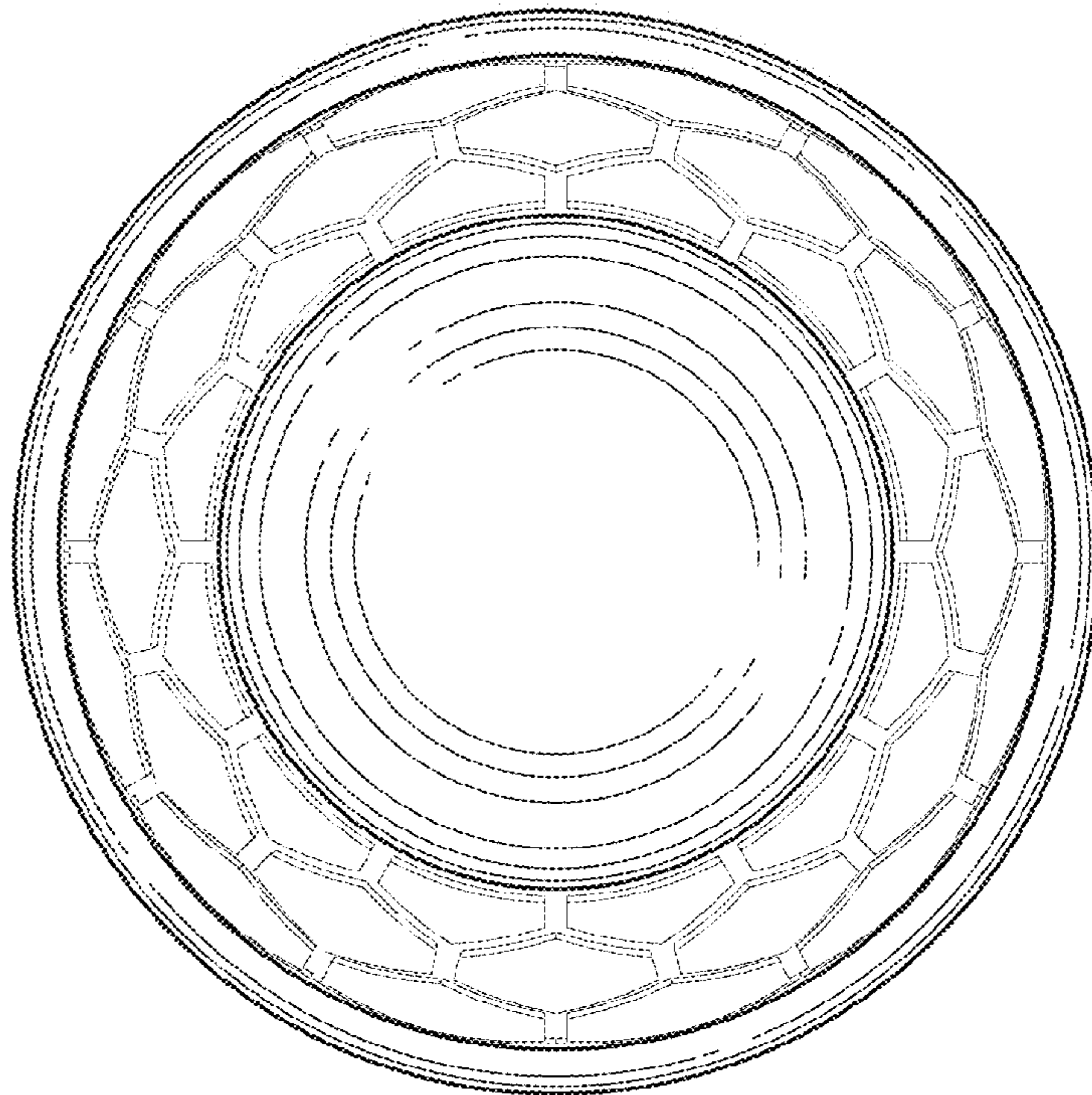

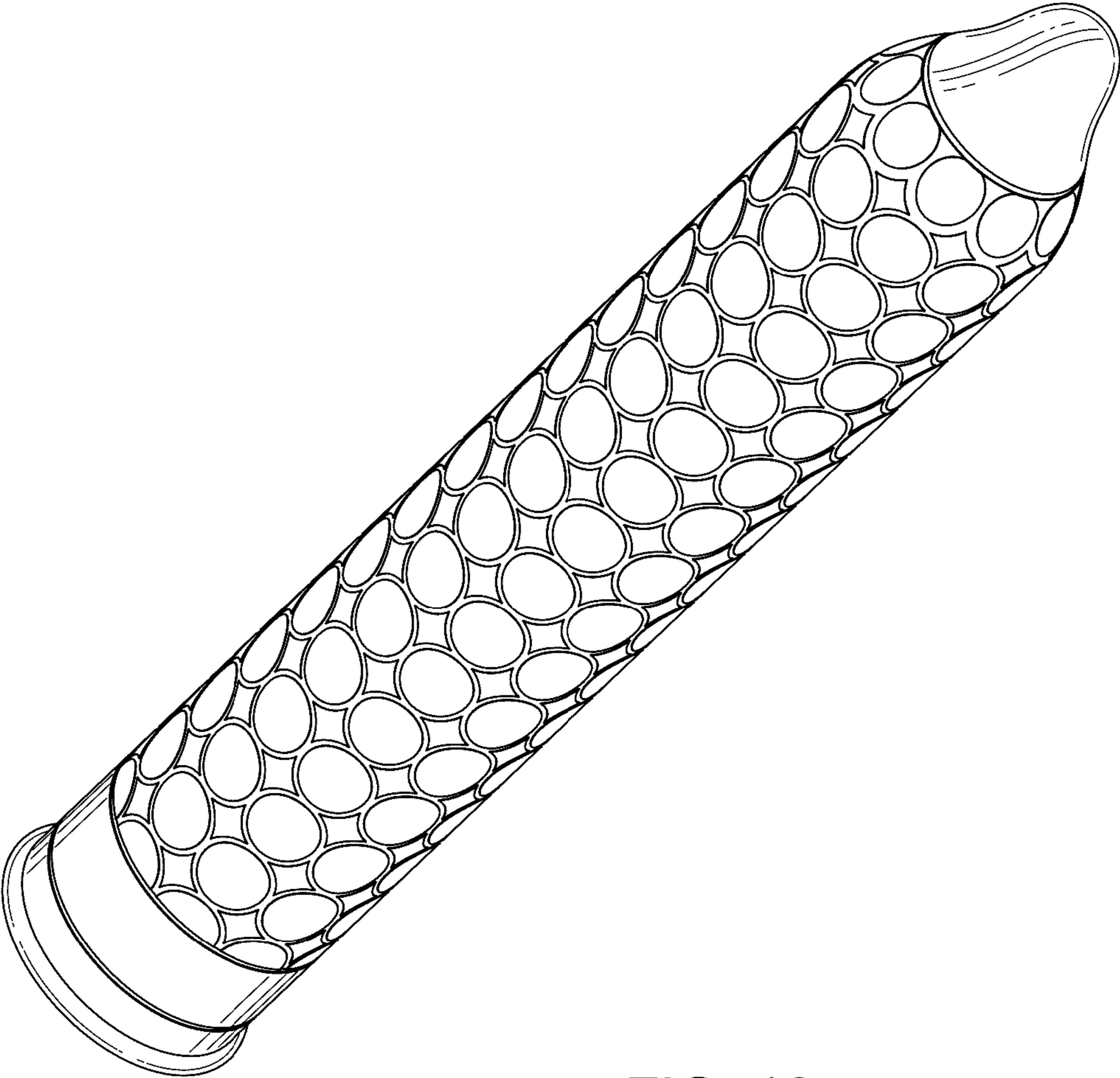

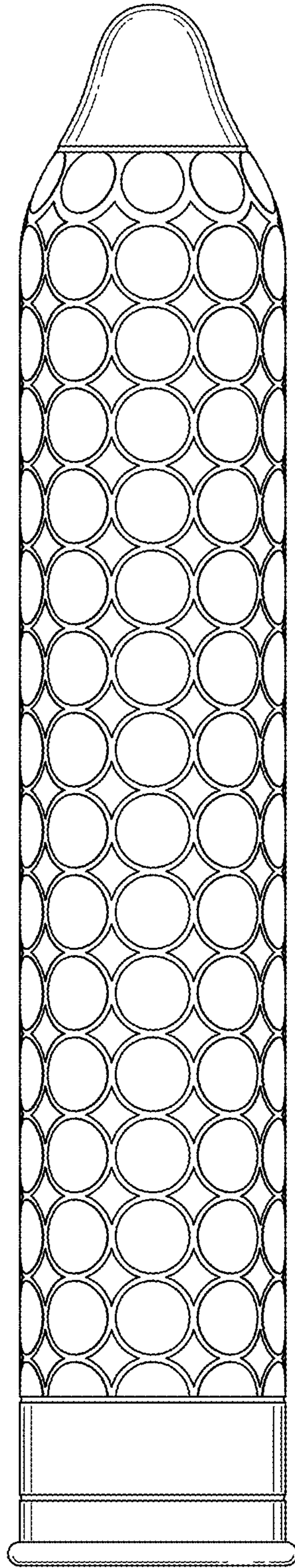

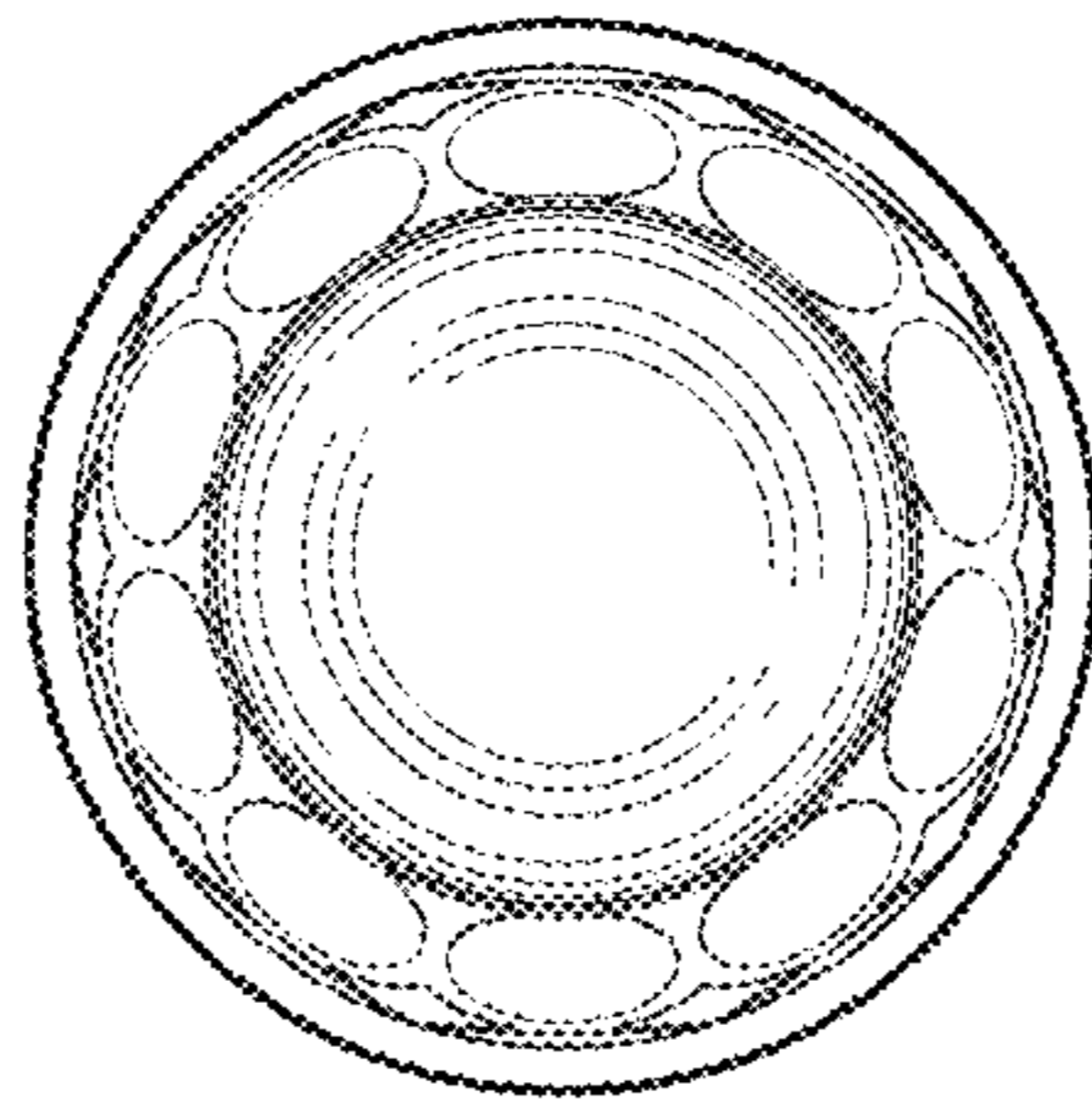

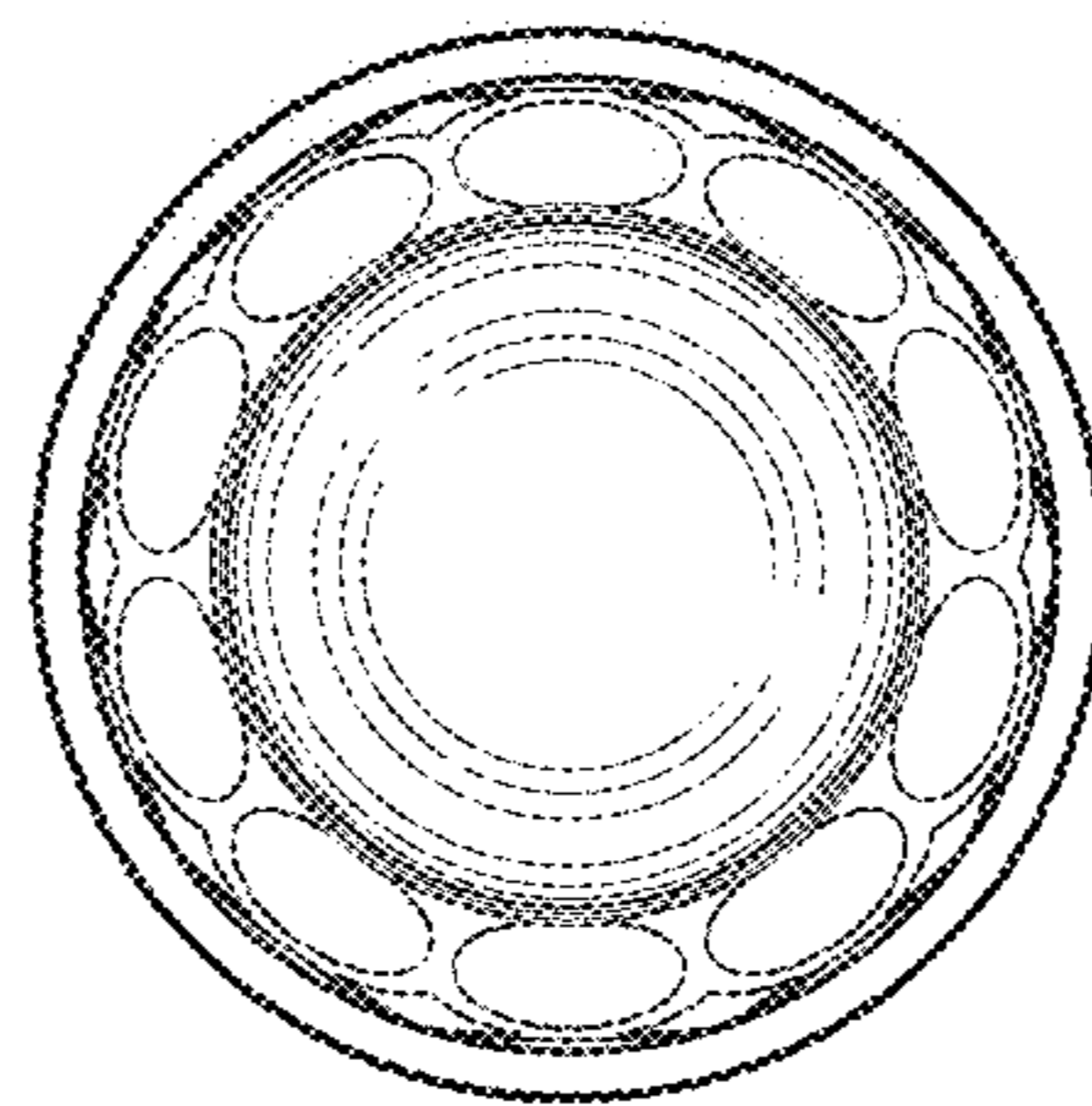

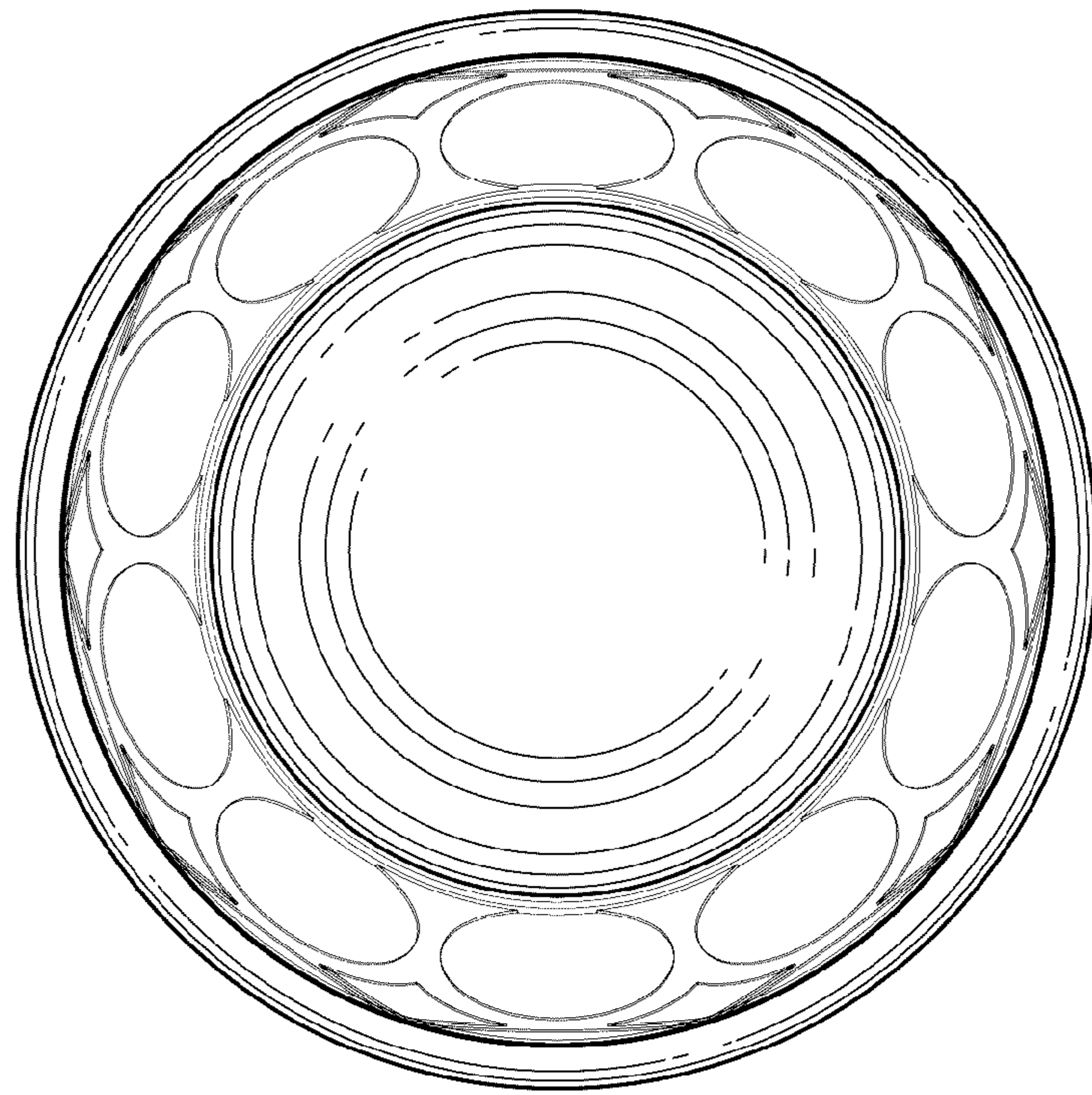

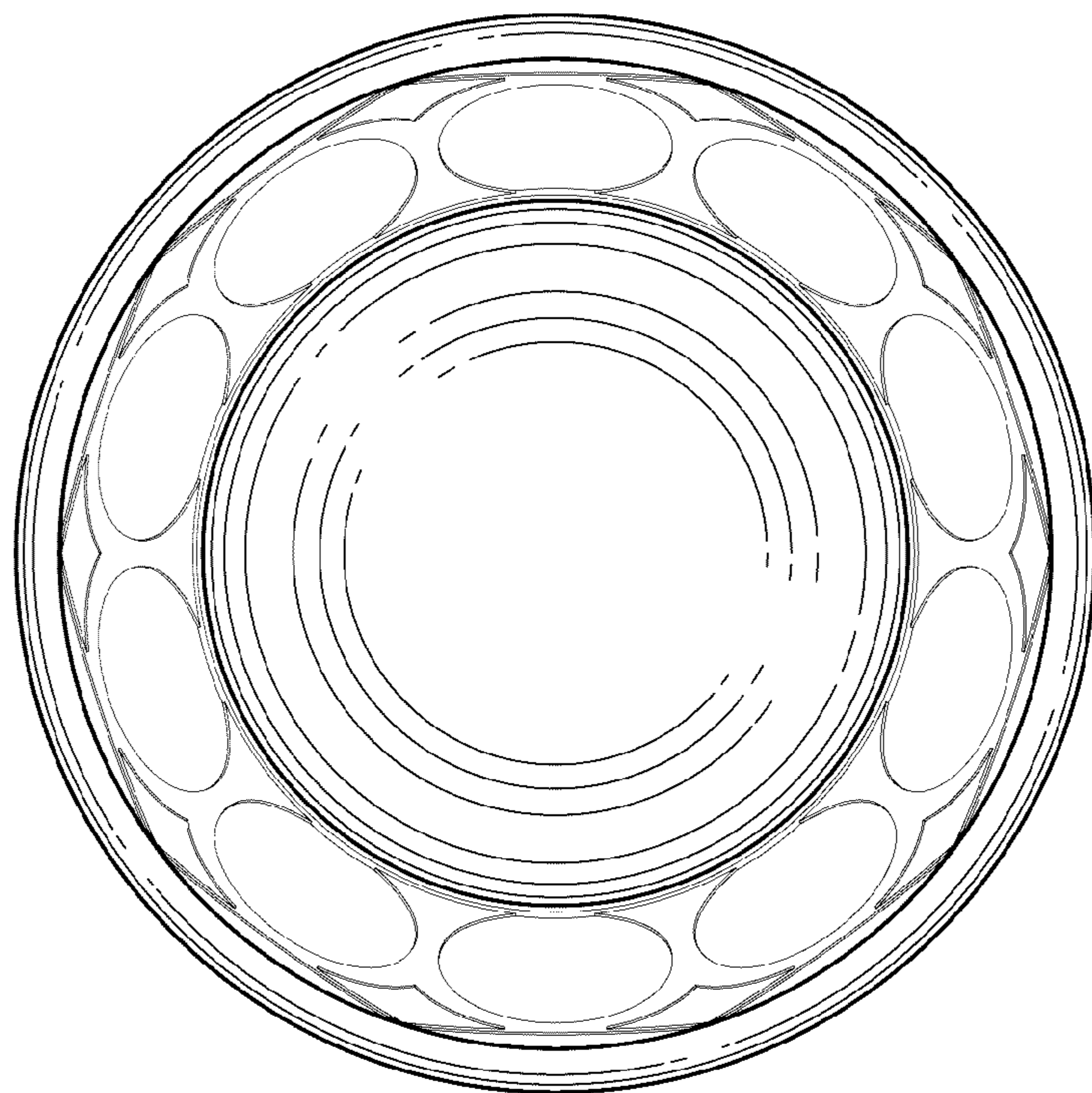

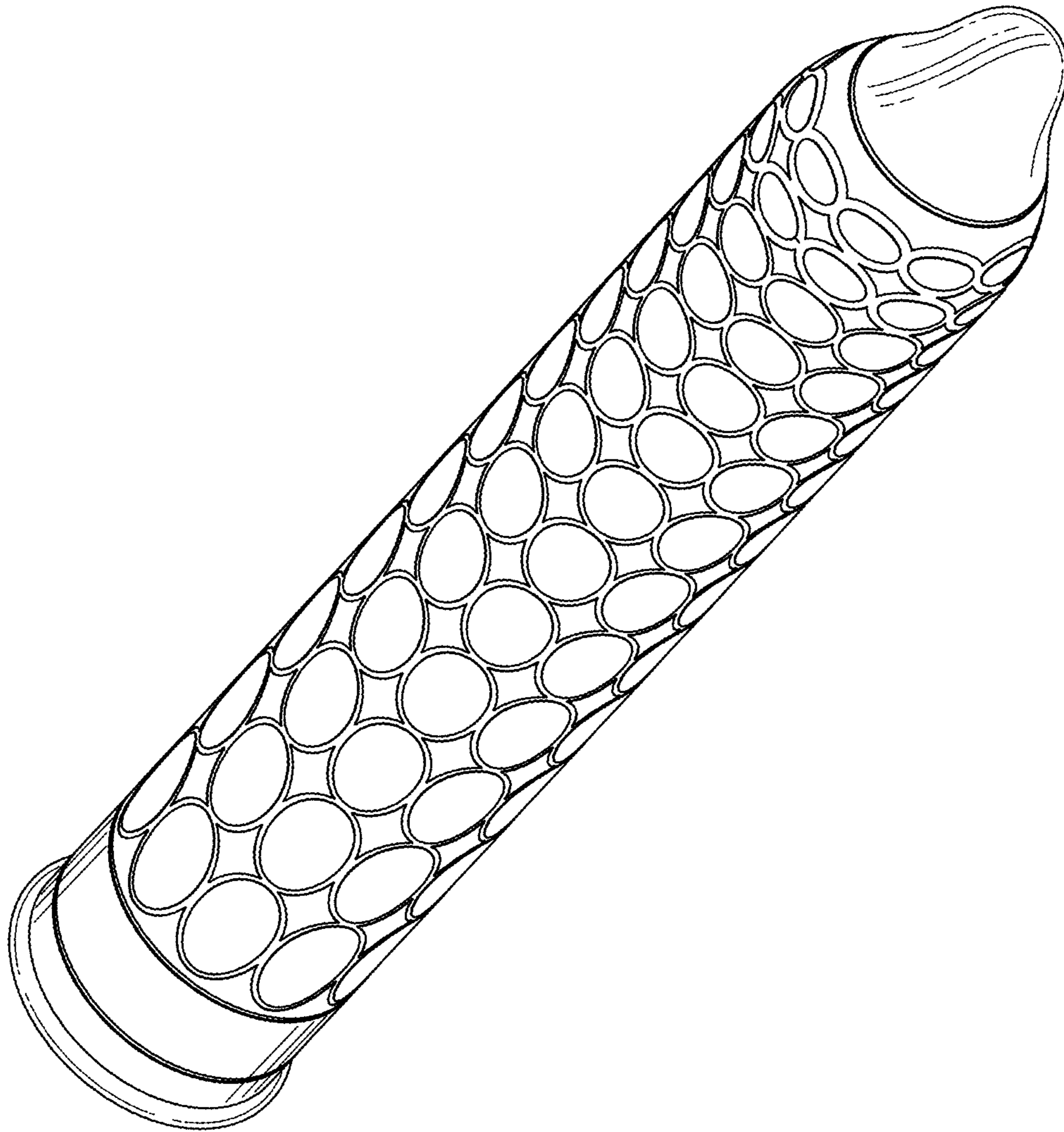

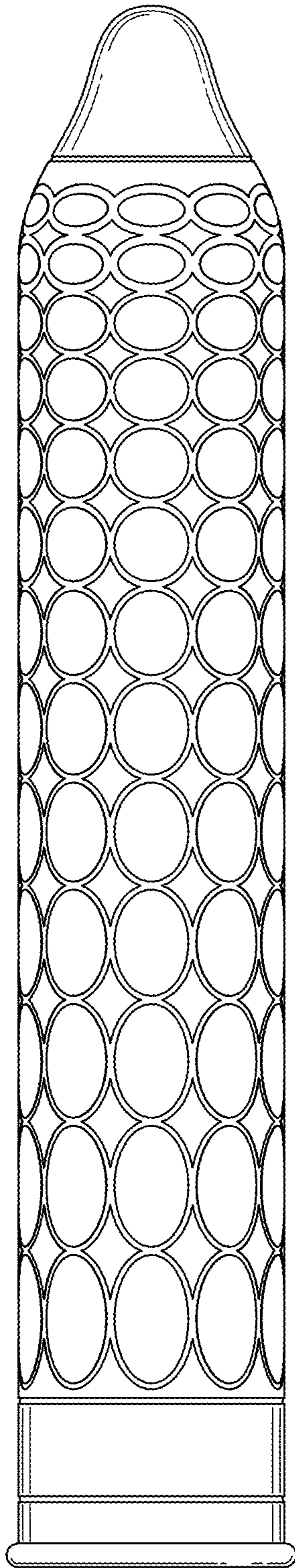

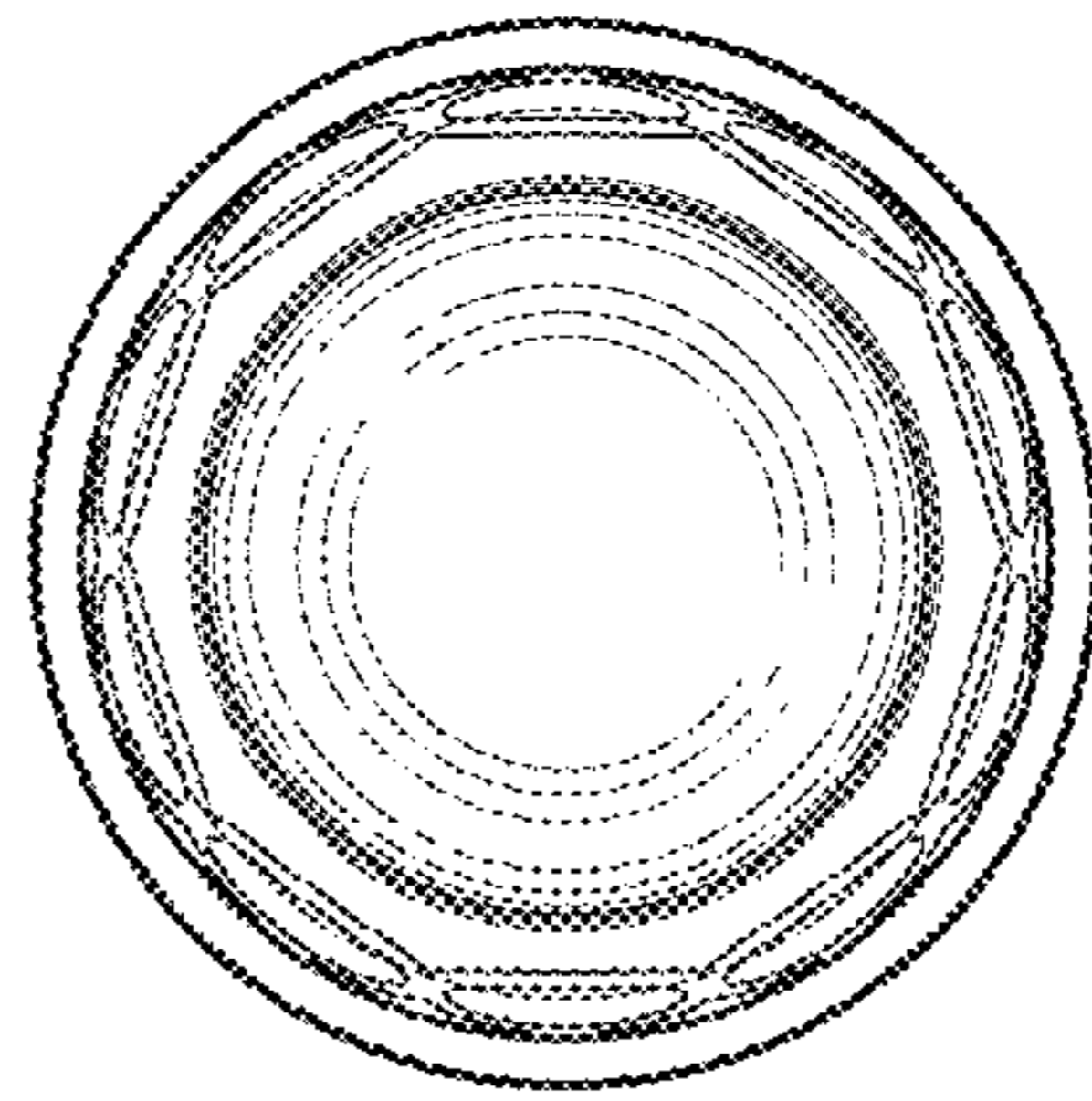

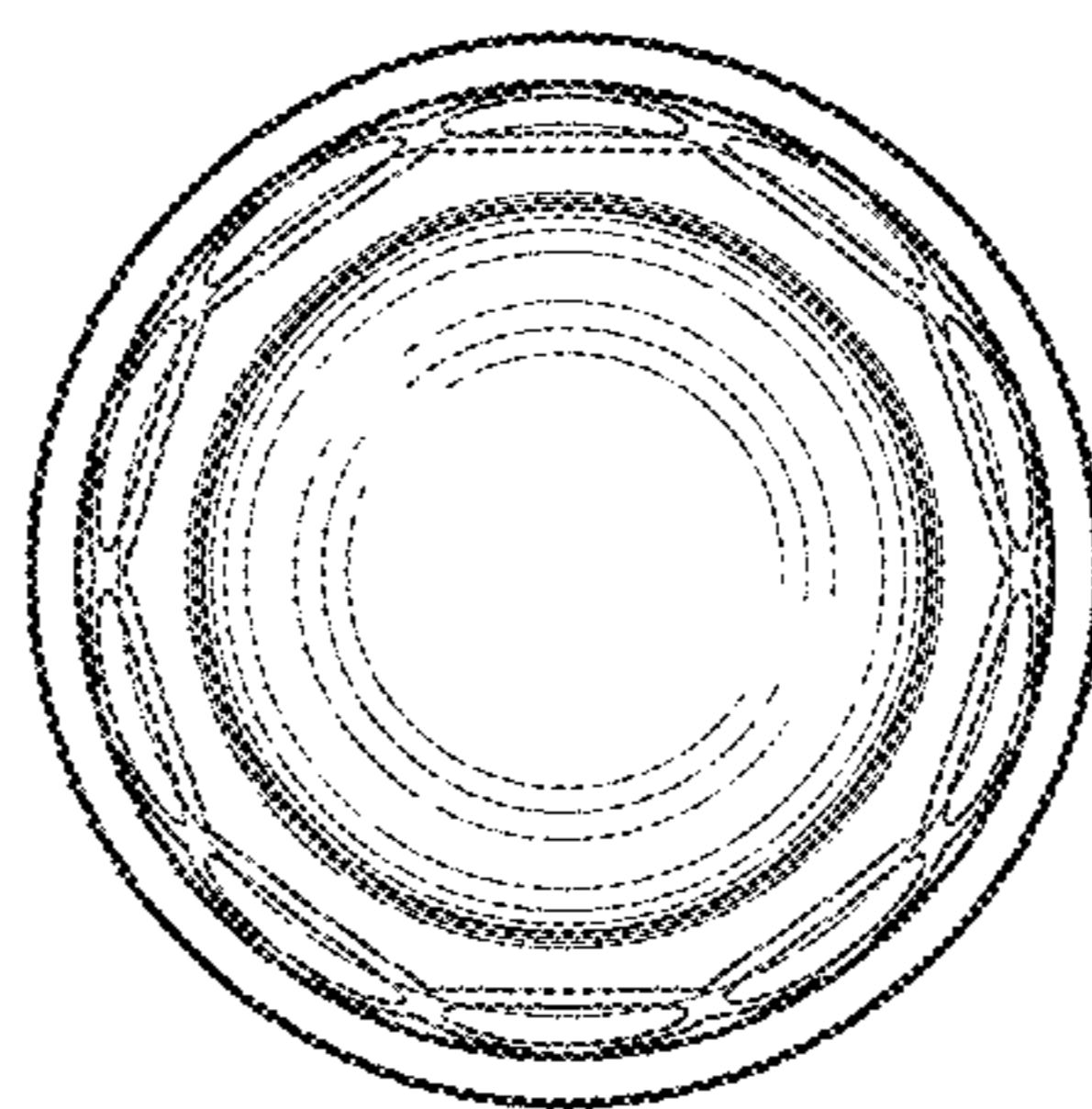

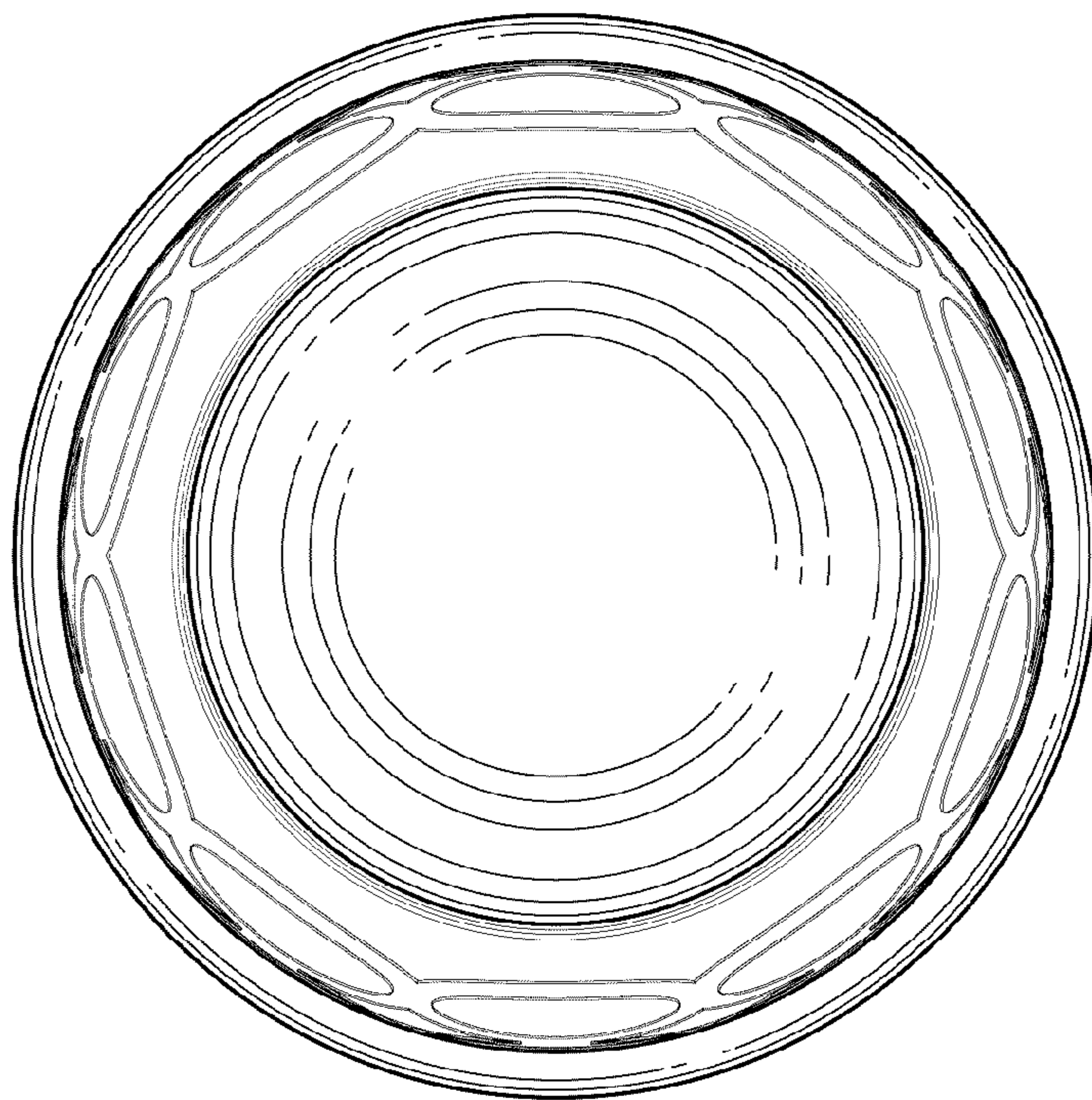

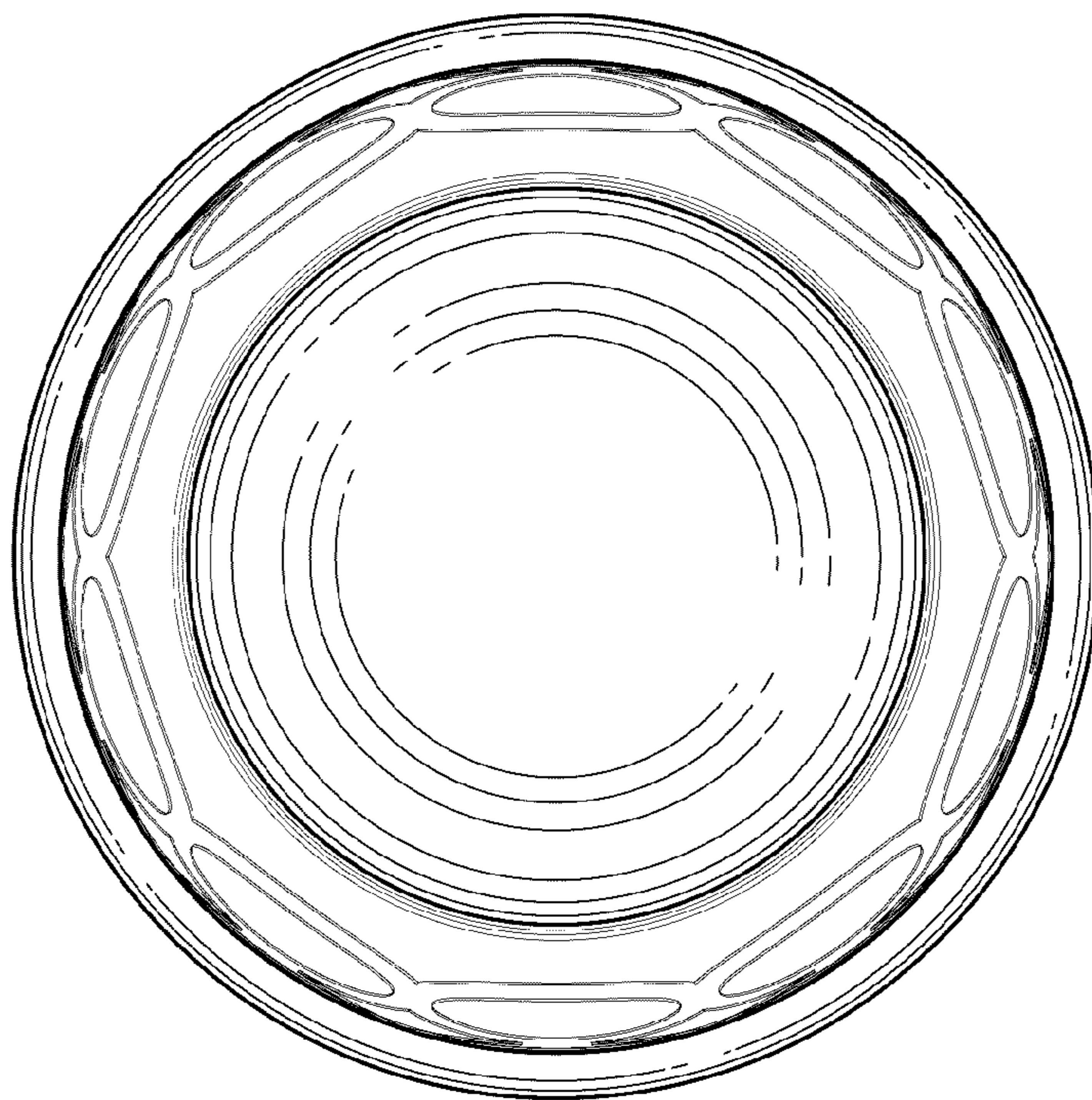
