FIG. 1.5 is a fourth front elevational rear left perspective view thereof;

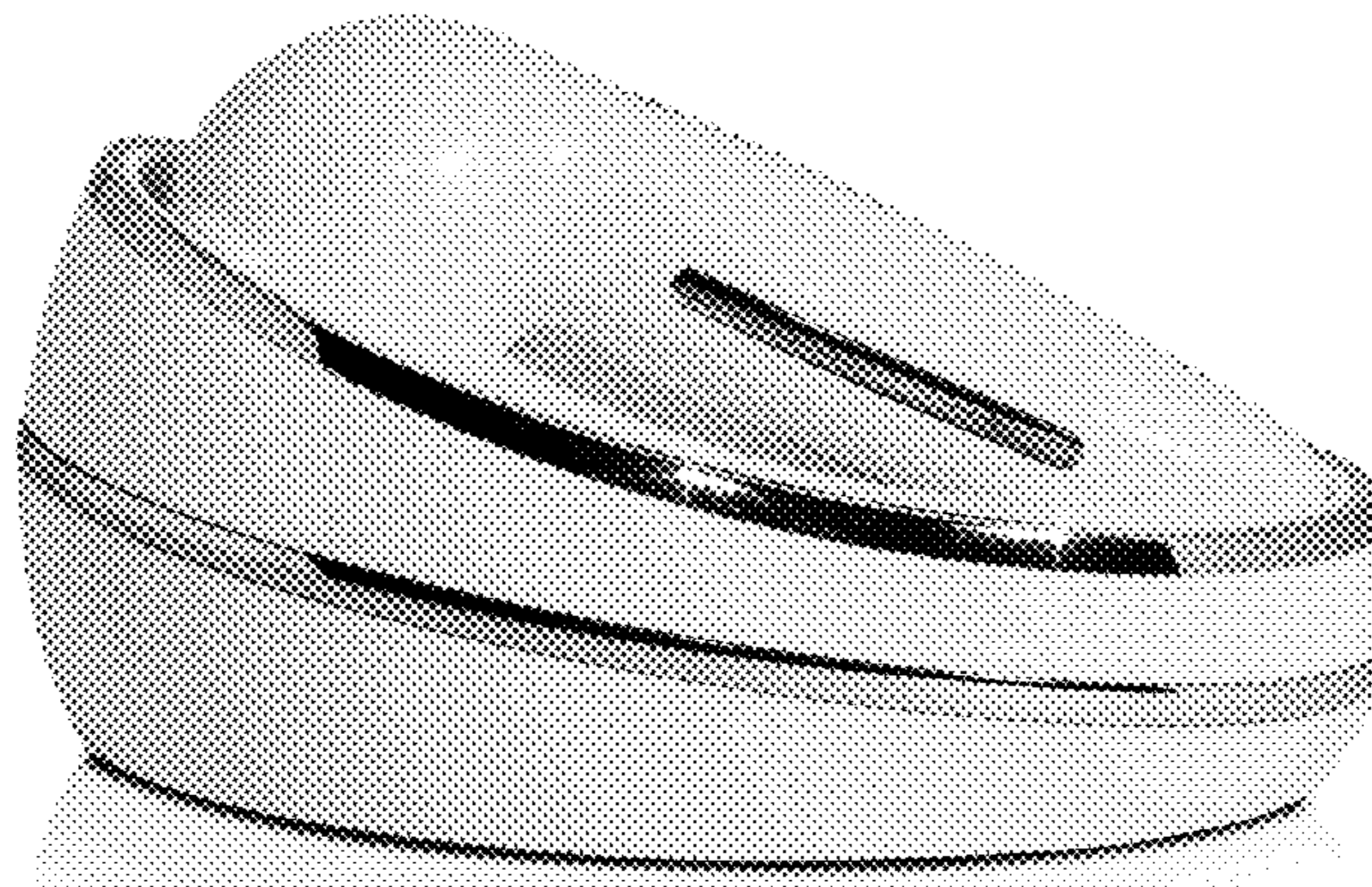
FIG. 1.6 is a rear right side perspective view thereof;

FIG. 1.7 is a front right side perspective view thereof.

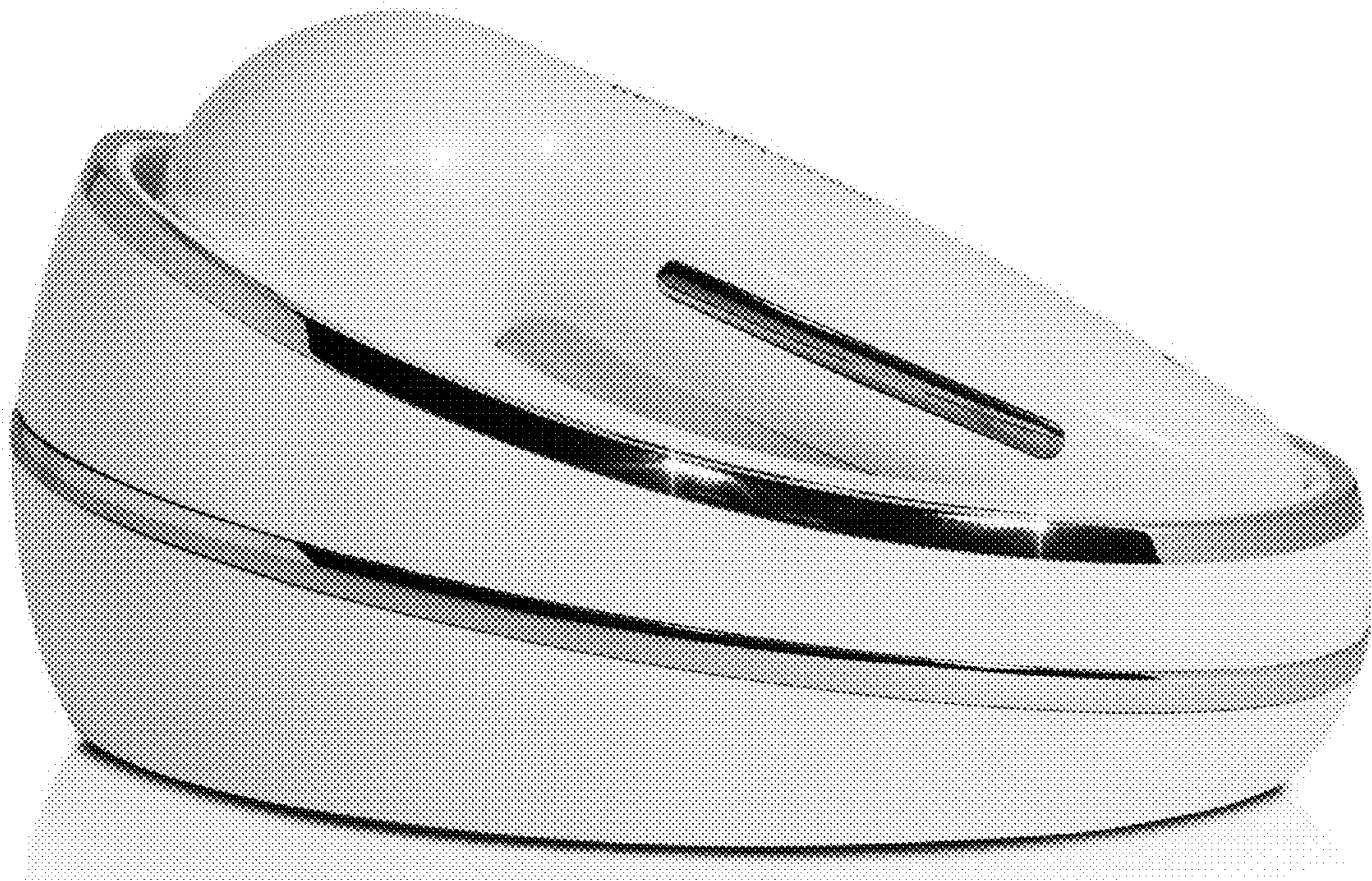
FIG. 1.8 is a rear right side perspective view thereof.
