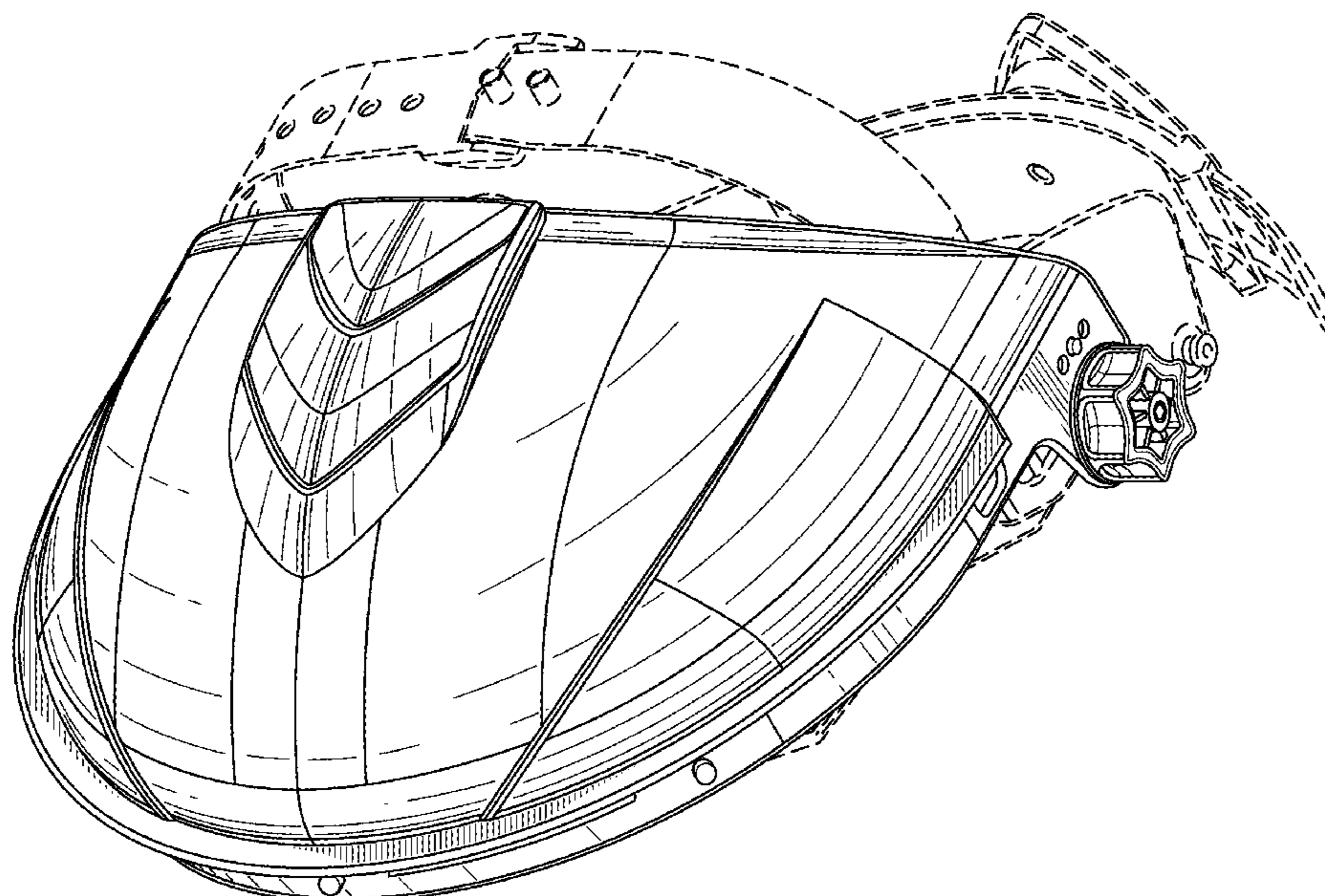
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a safety visor according to the present invention;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof; and,

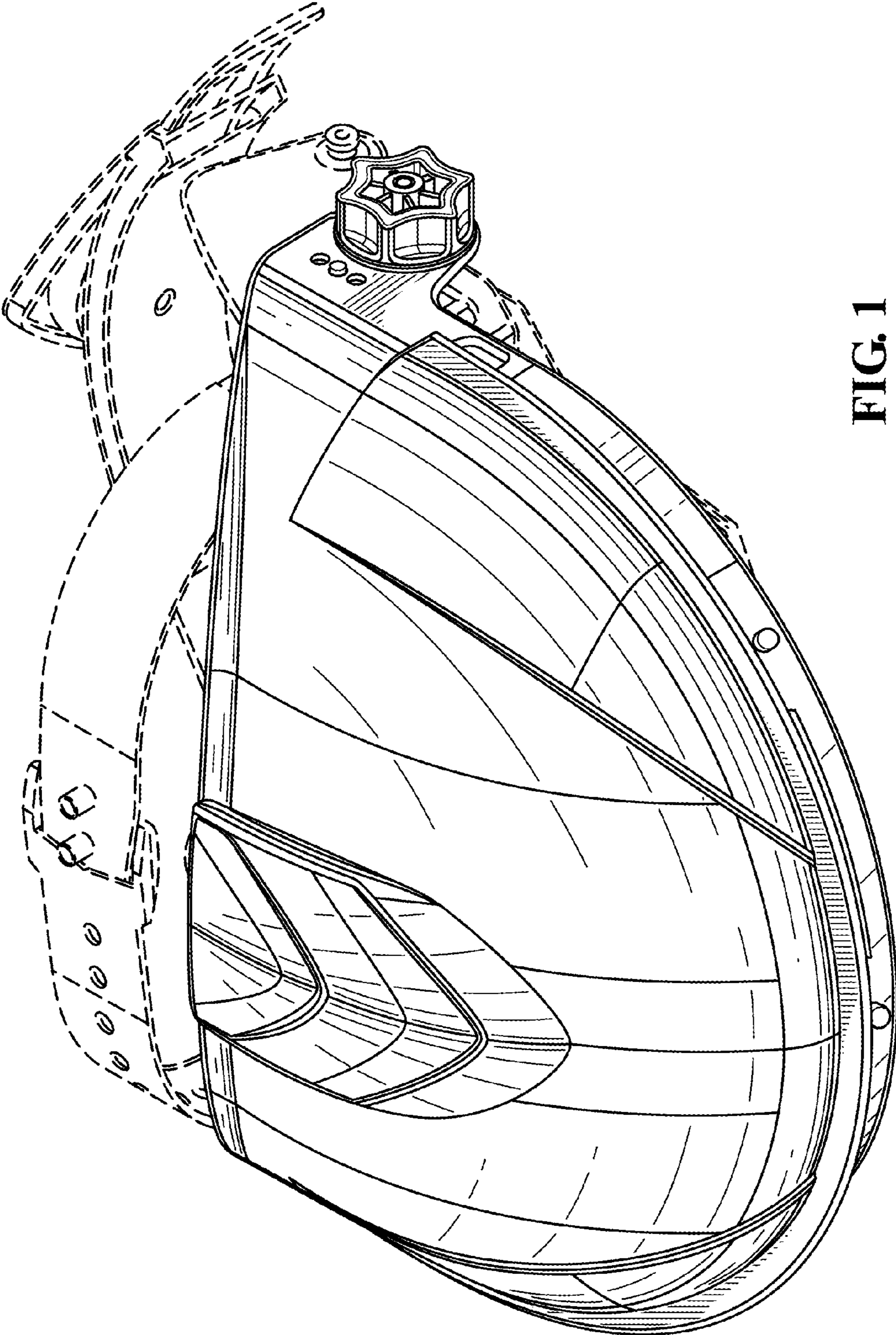

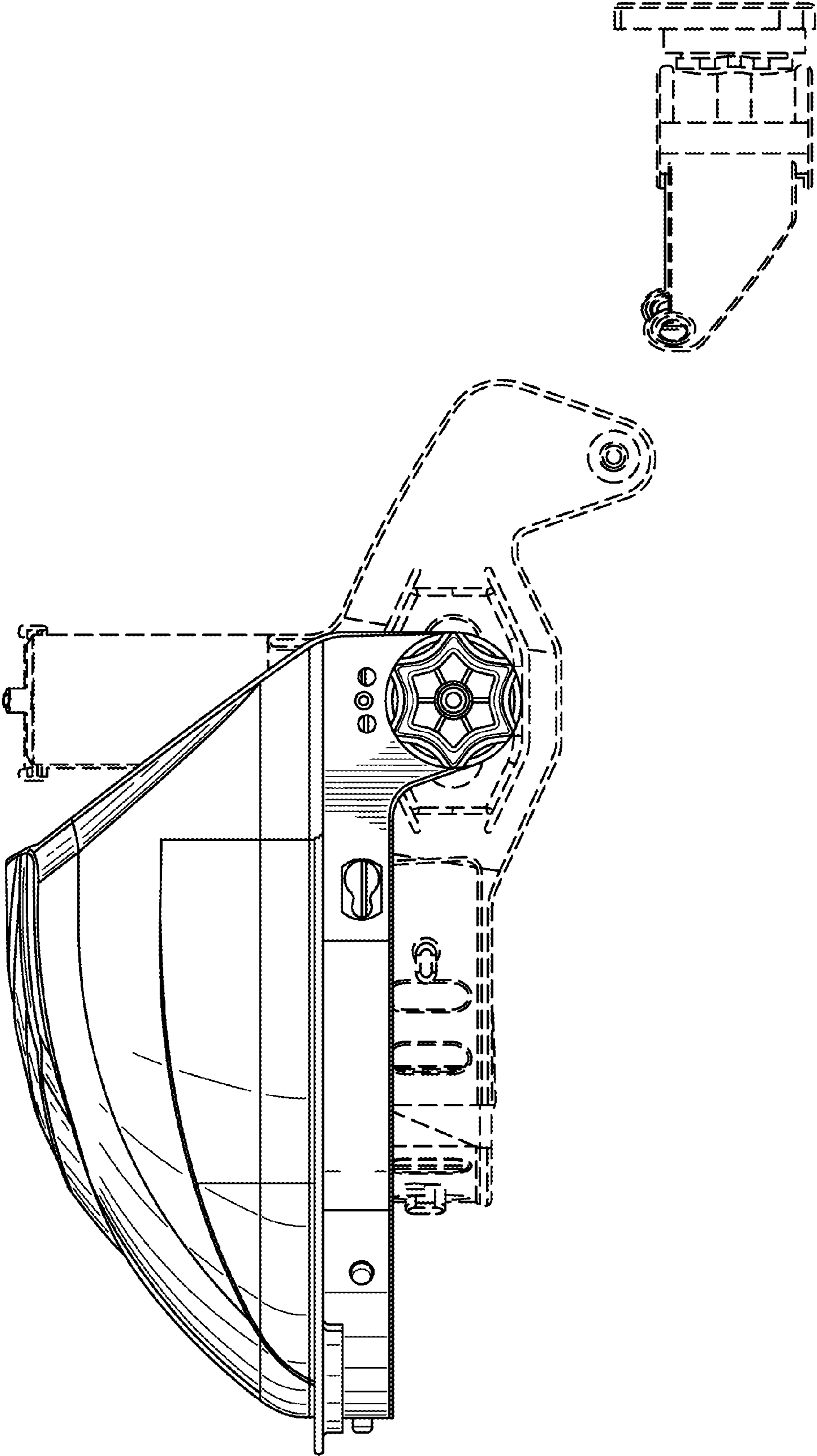

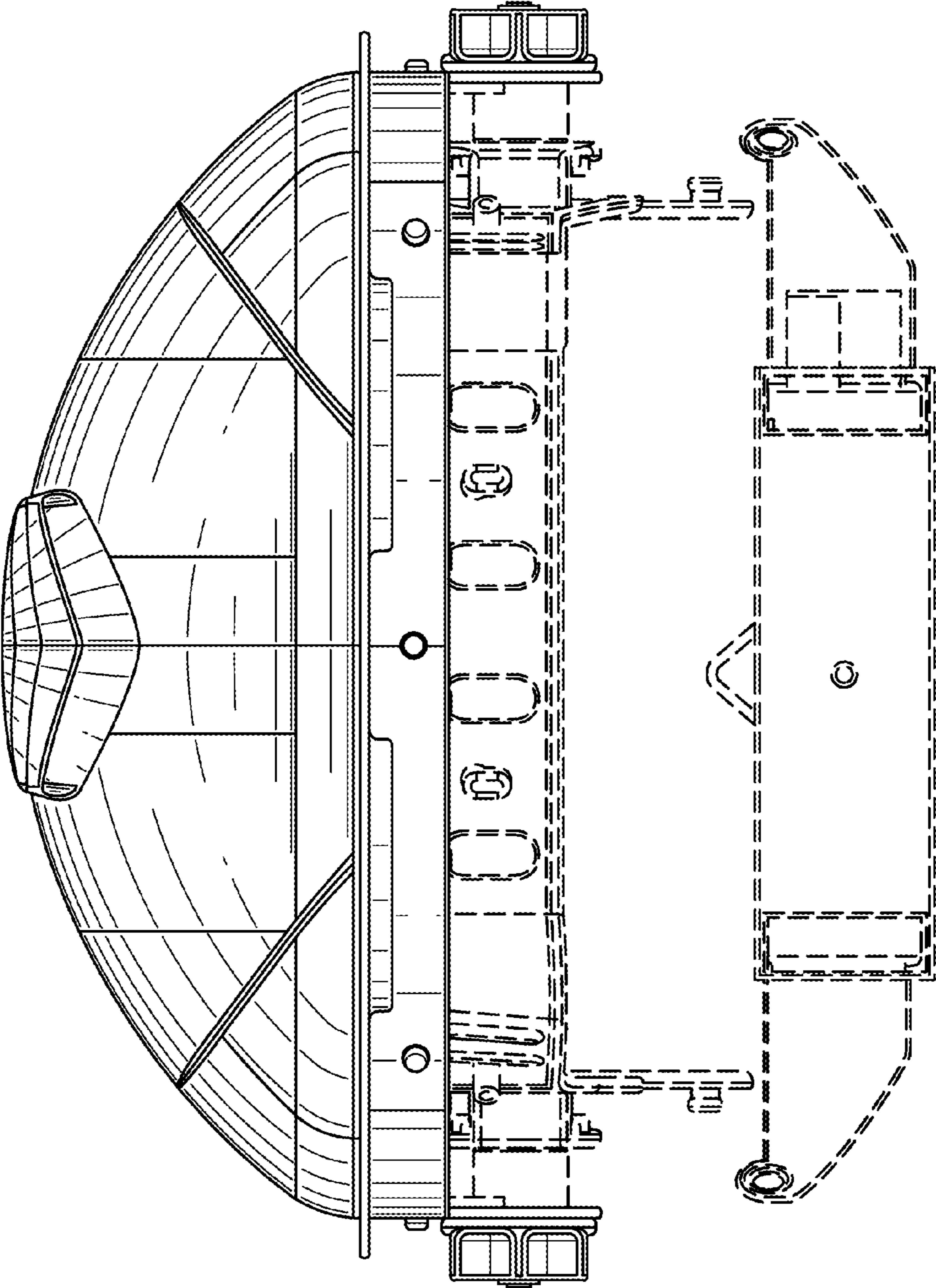

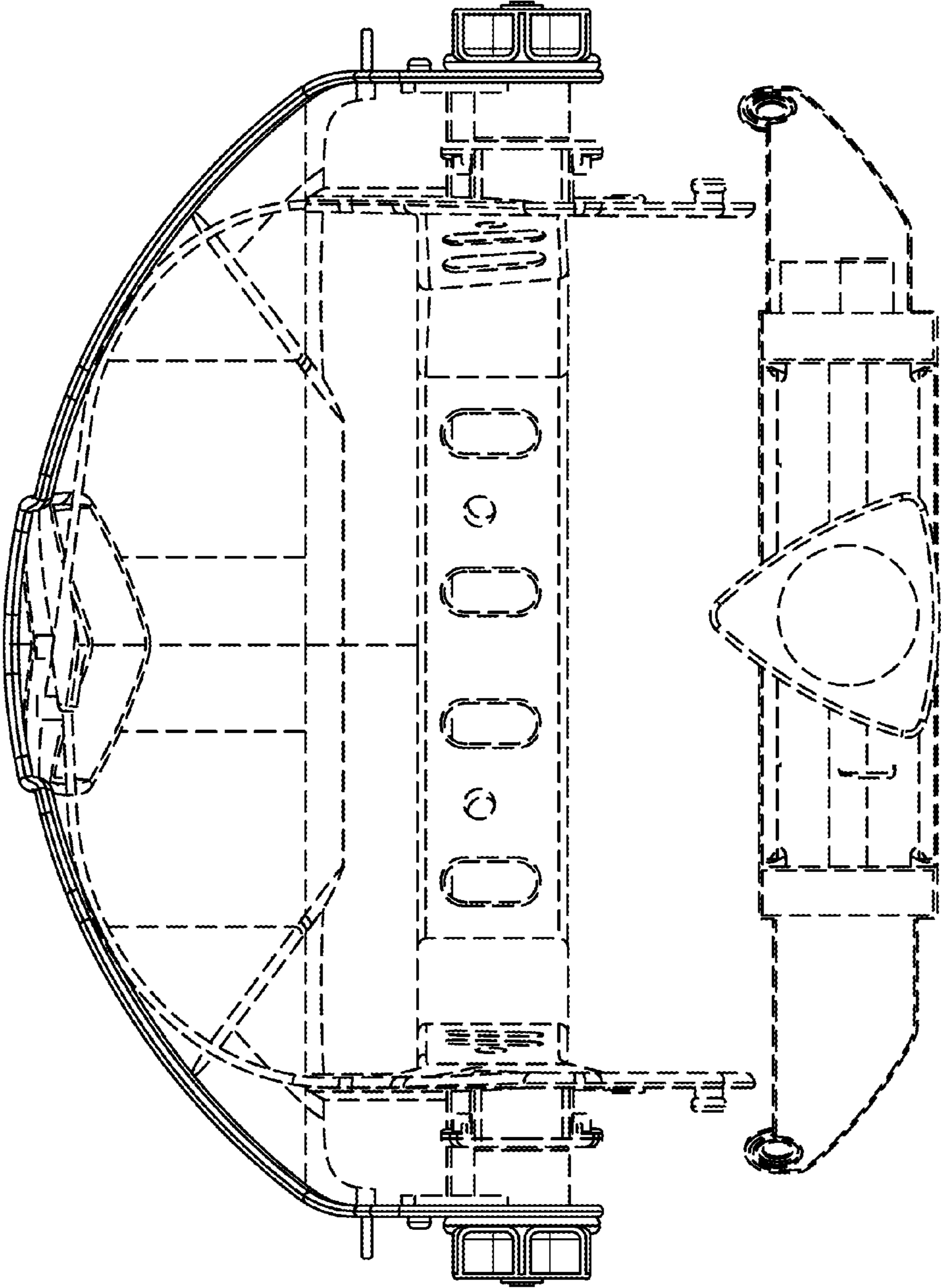

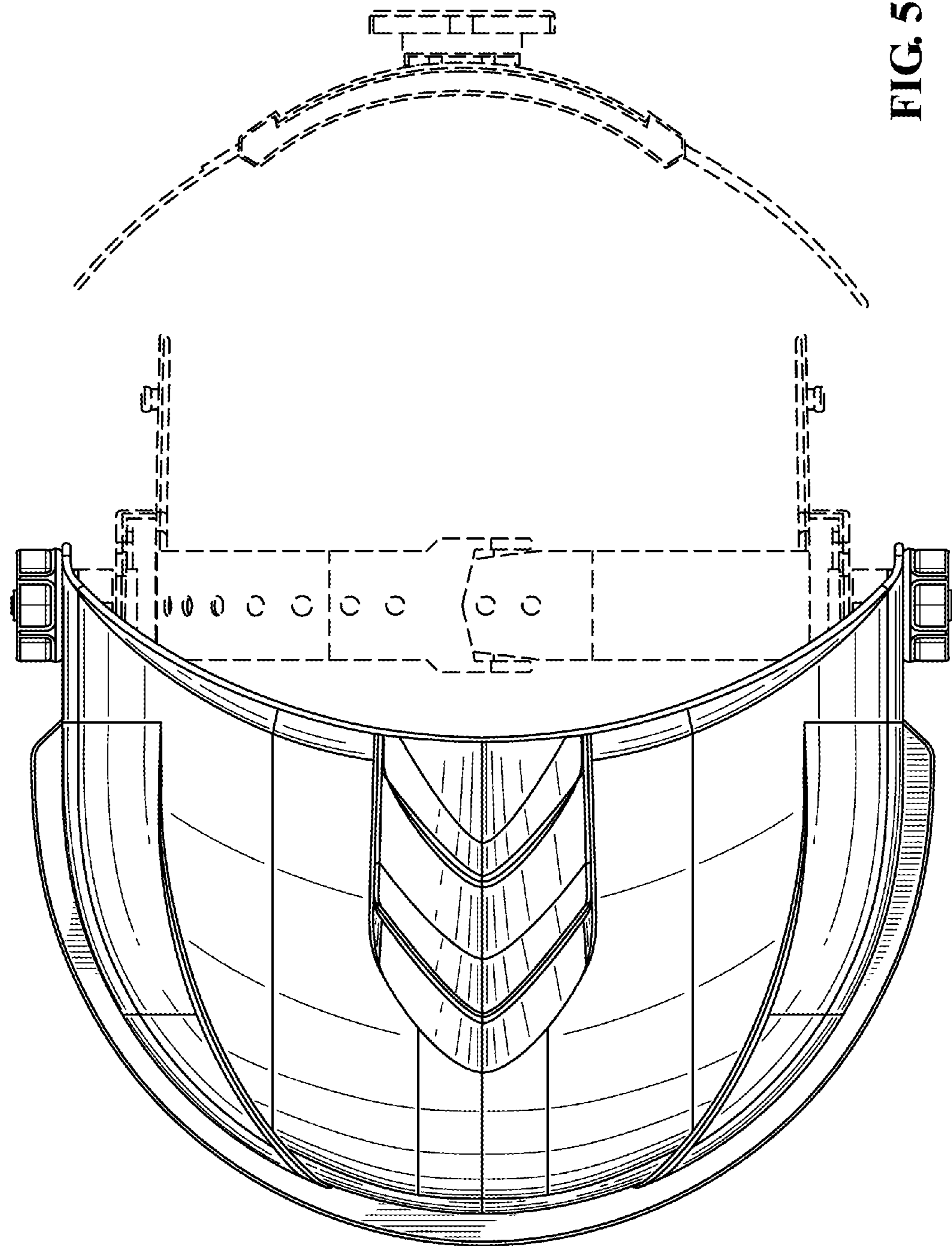

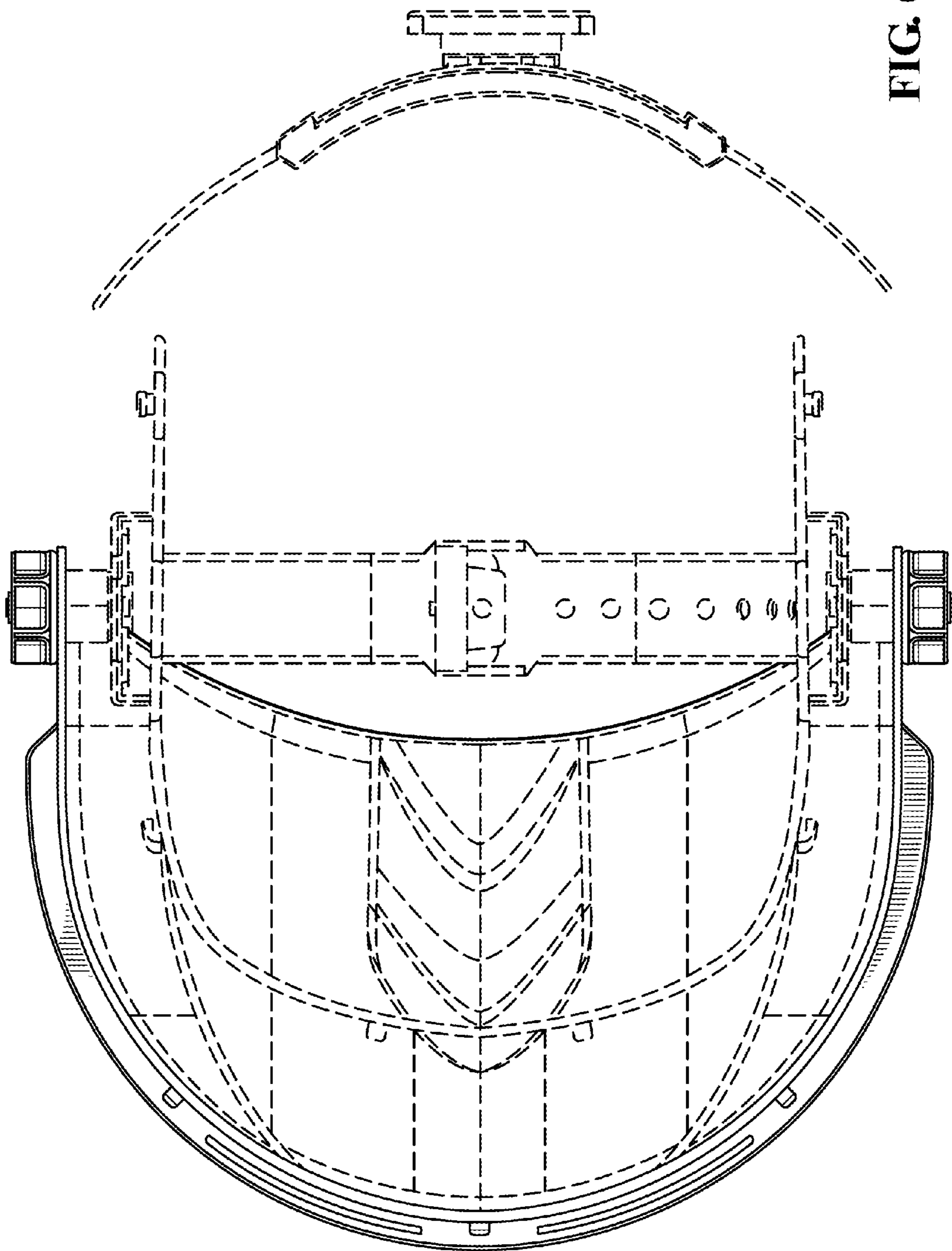
