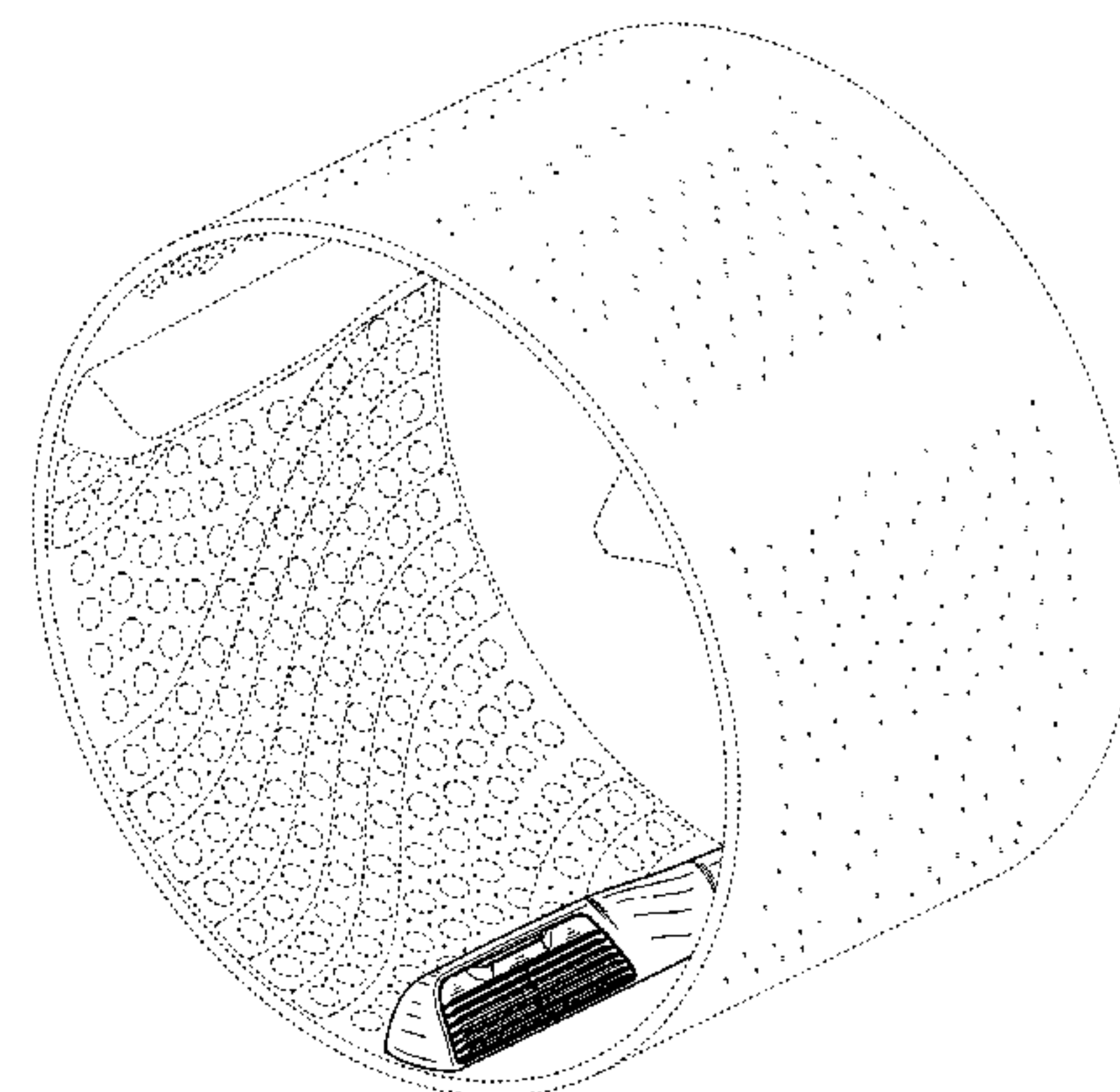
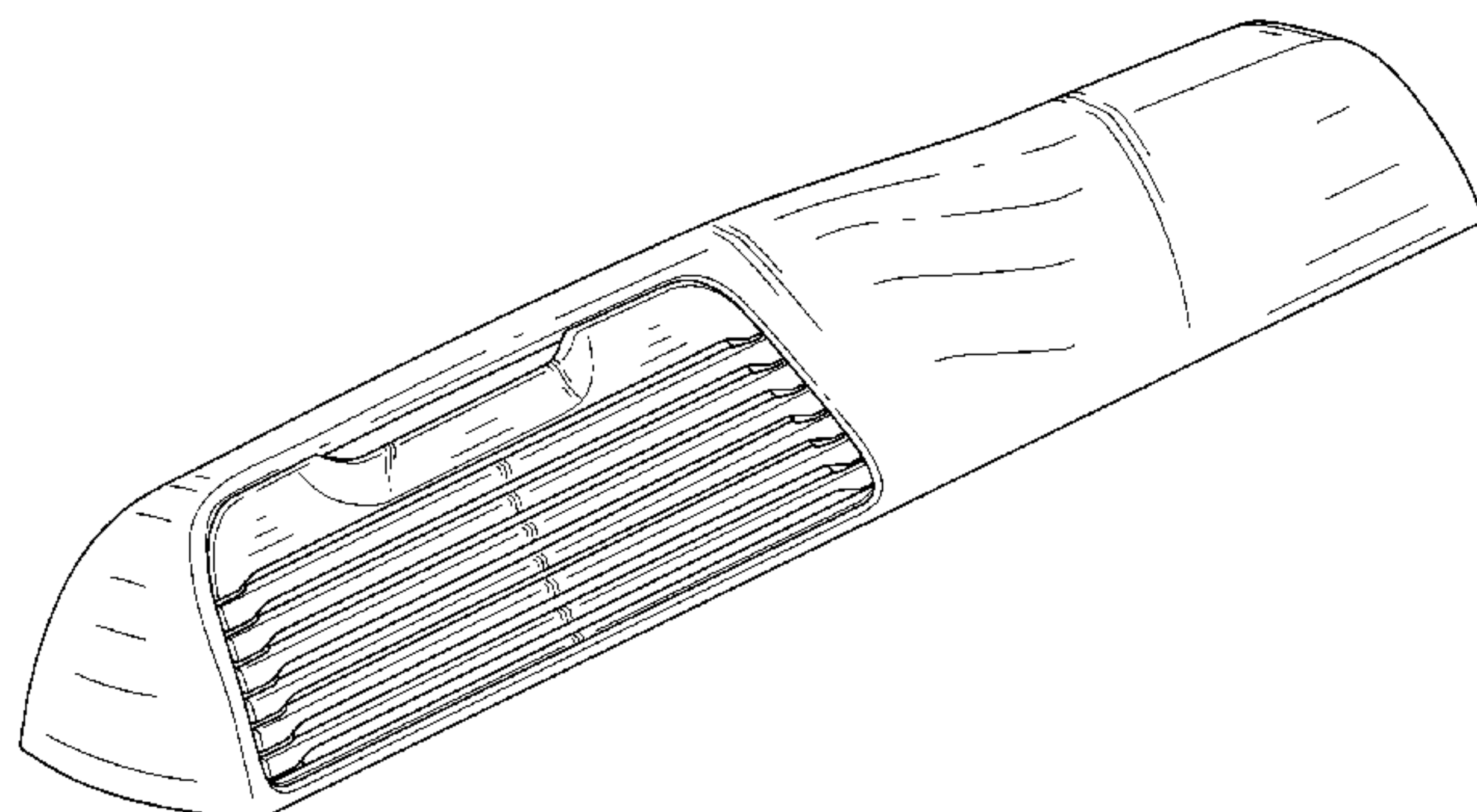
The ornamental design for a drum lifter for drum washing machine, as shown and described.

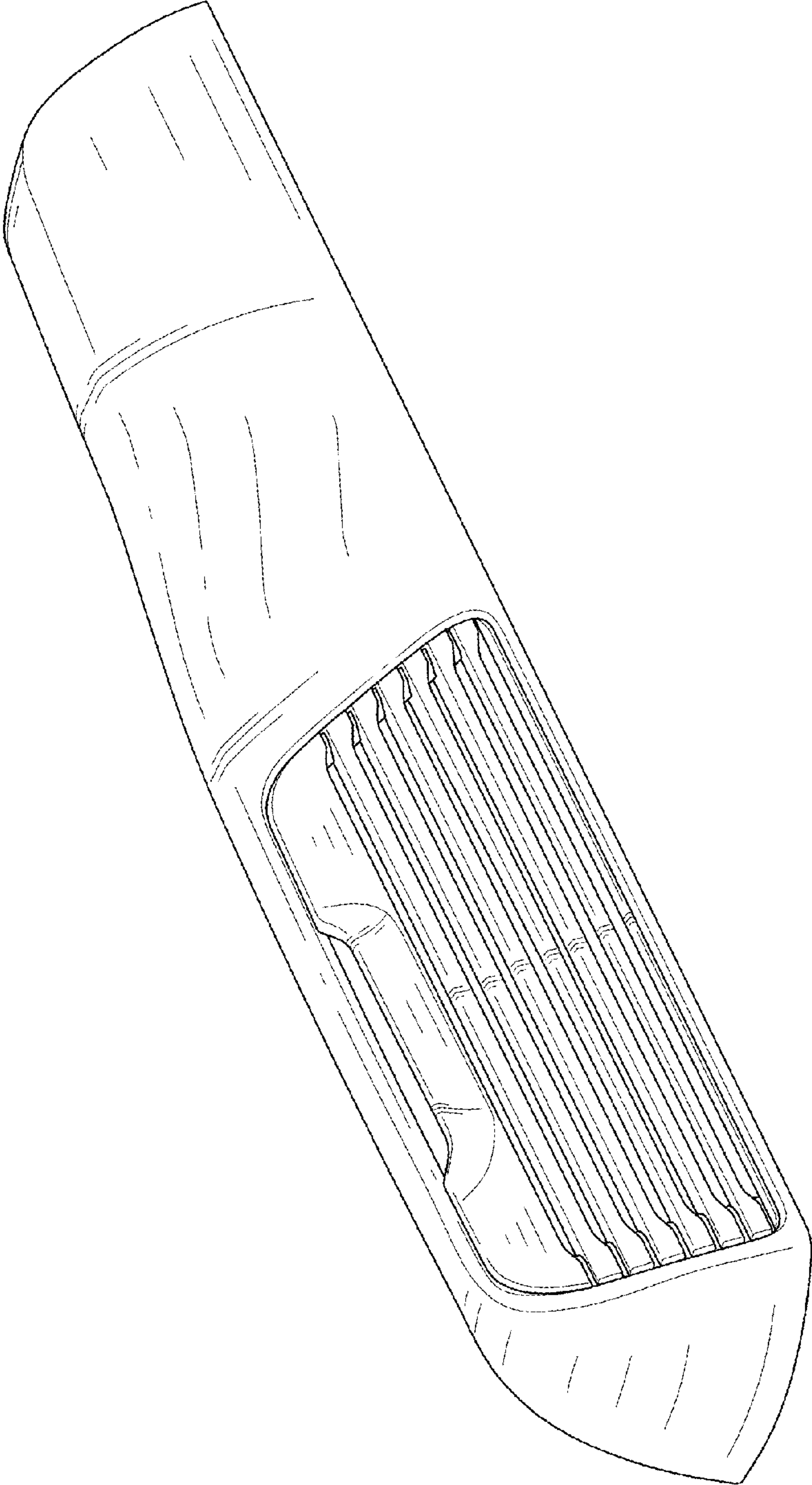

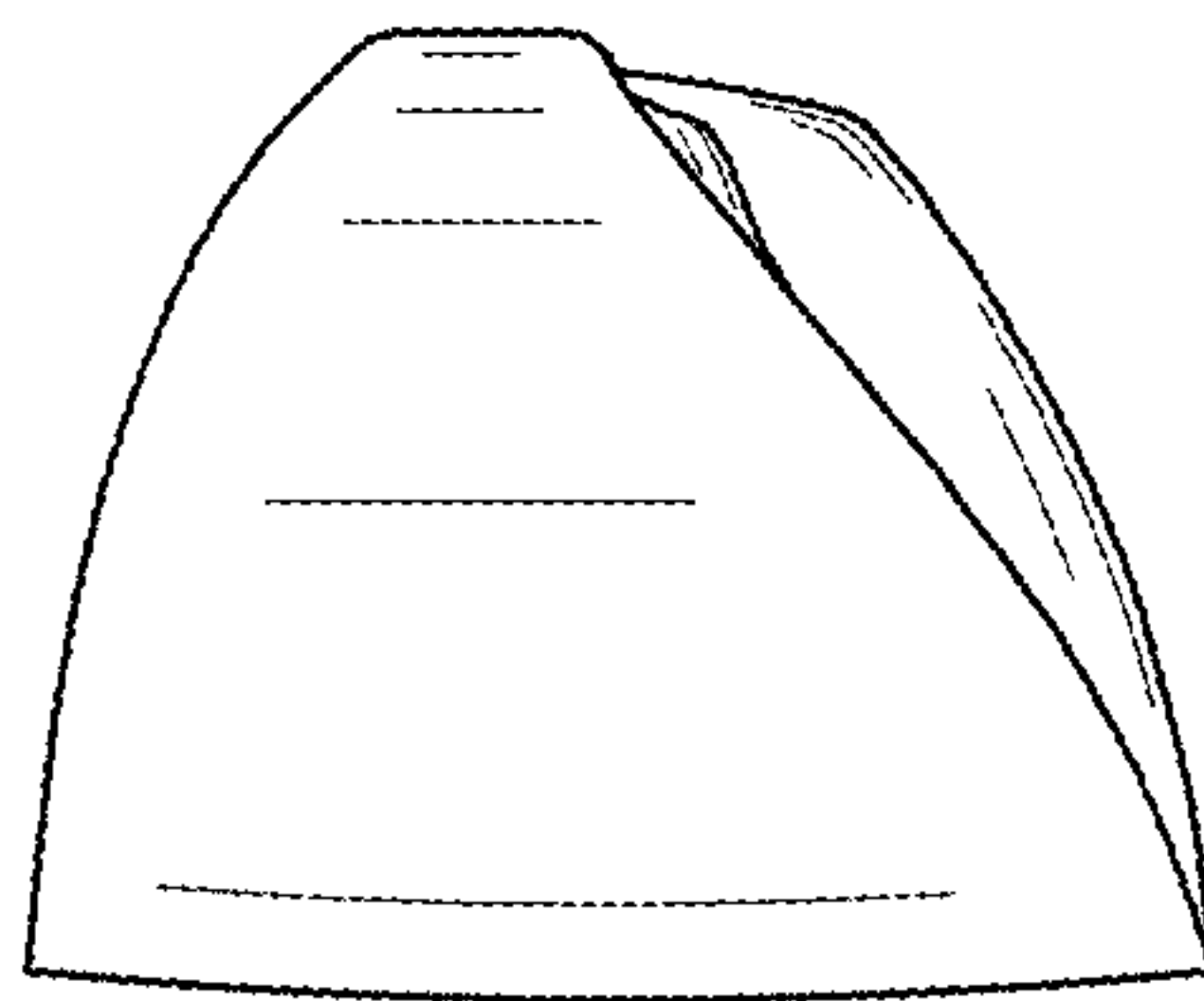

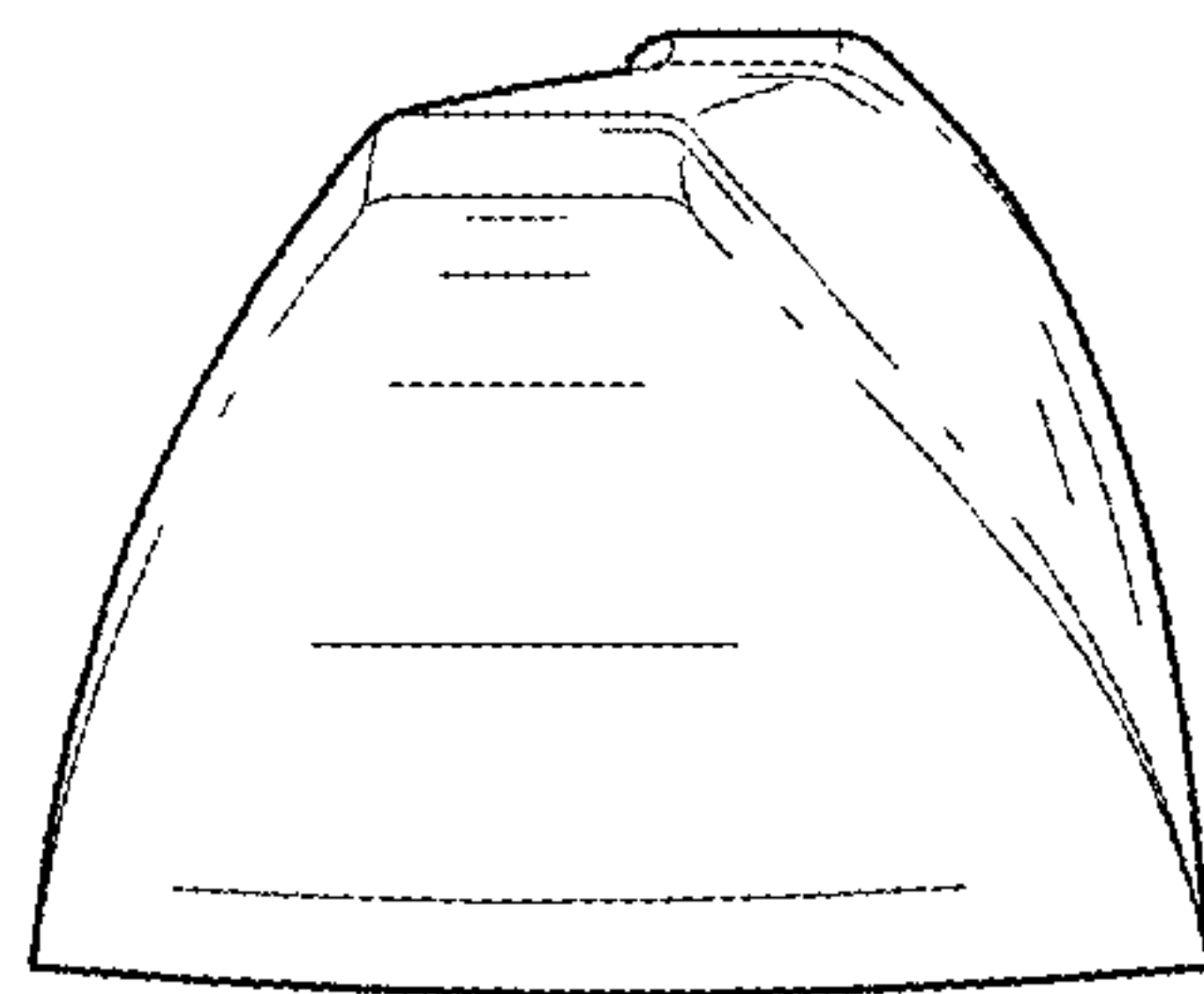

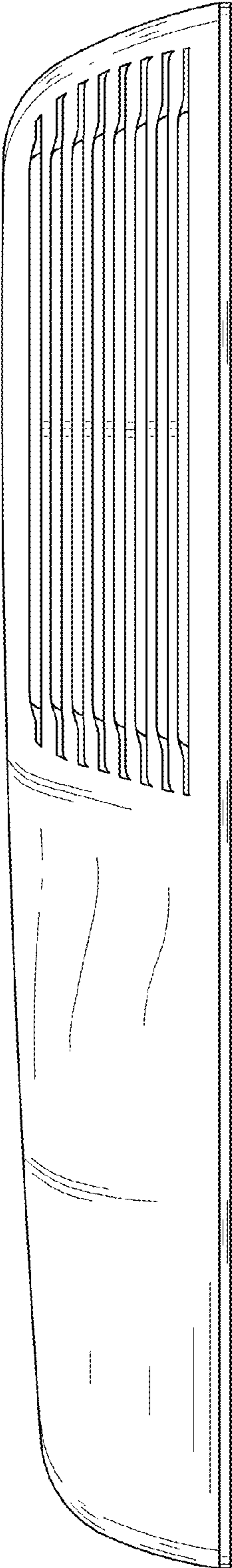

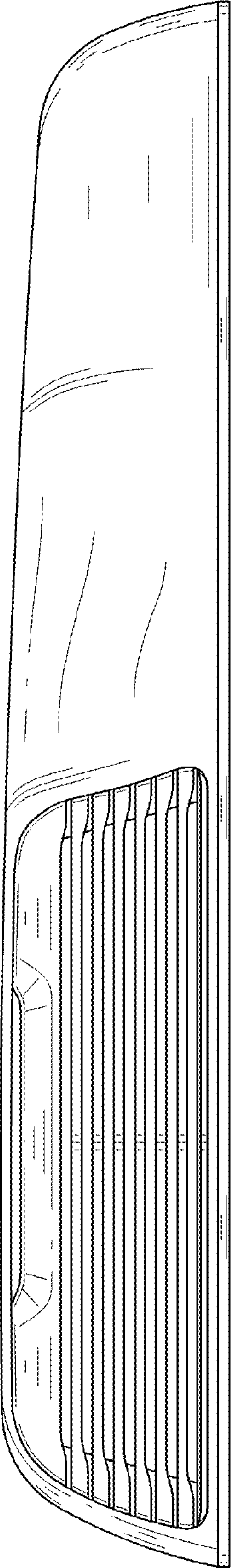

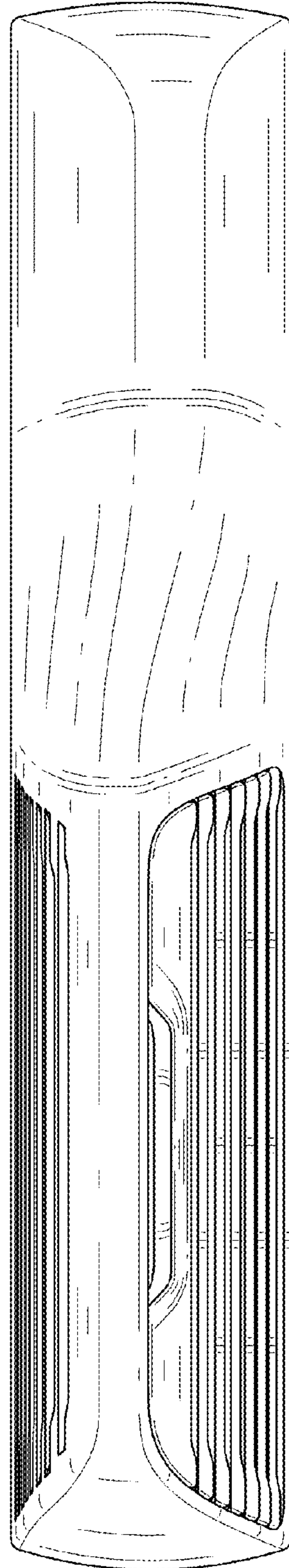

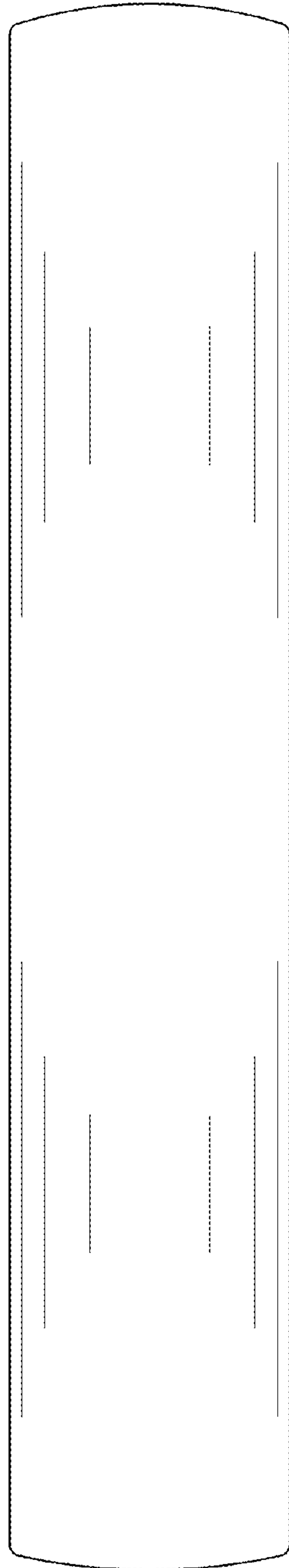
